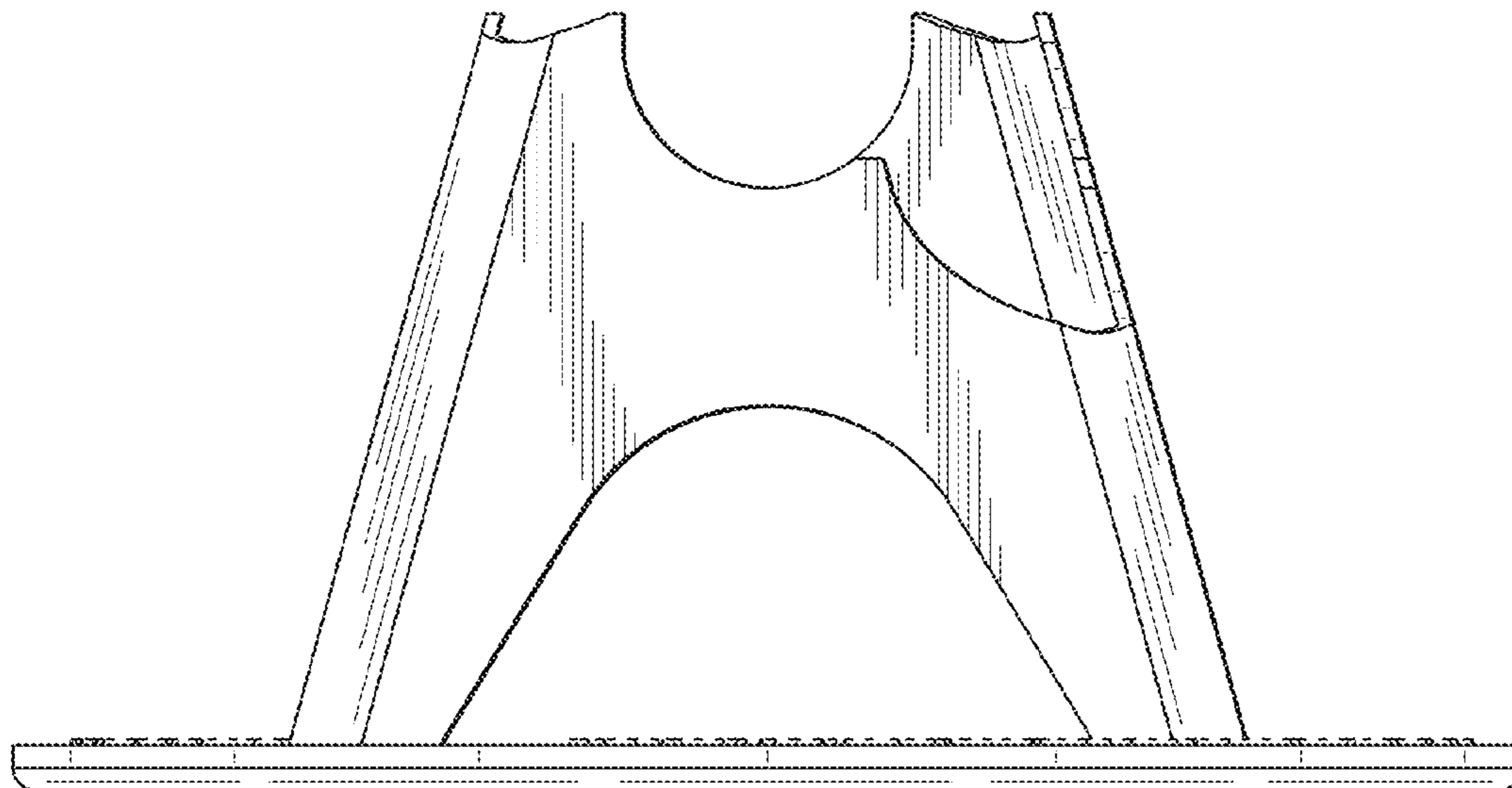
(57) **CLAIM**

We claim a new ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a chair according to the present invention;
FIG. 2 is a rear elevational view of the chair of FIG. 1;
FIG. 3 is a right side elevational view of the chair of FIG. 1;
FIG. 4 is a left side elevational view of the chair of FIG. 1;
FIG. 5 is a top plan view of the chair of FIG. 1; and,
FIG. 6 is a bottom plan view of the chair of FIG. 1.
The broken line showing of the text is included for the purpose of illustrating a portion of the chair and forms no part of the claimed design.

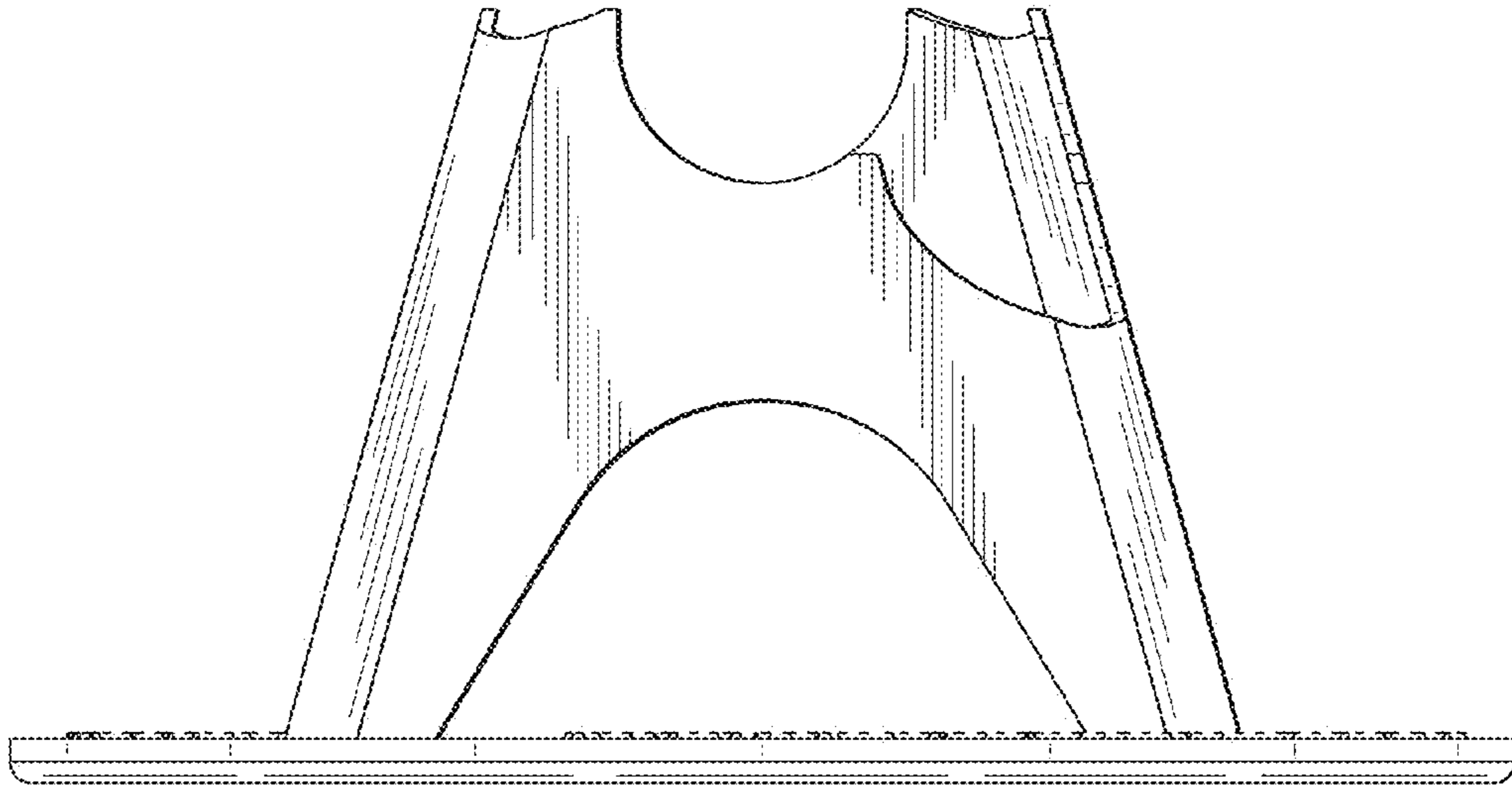

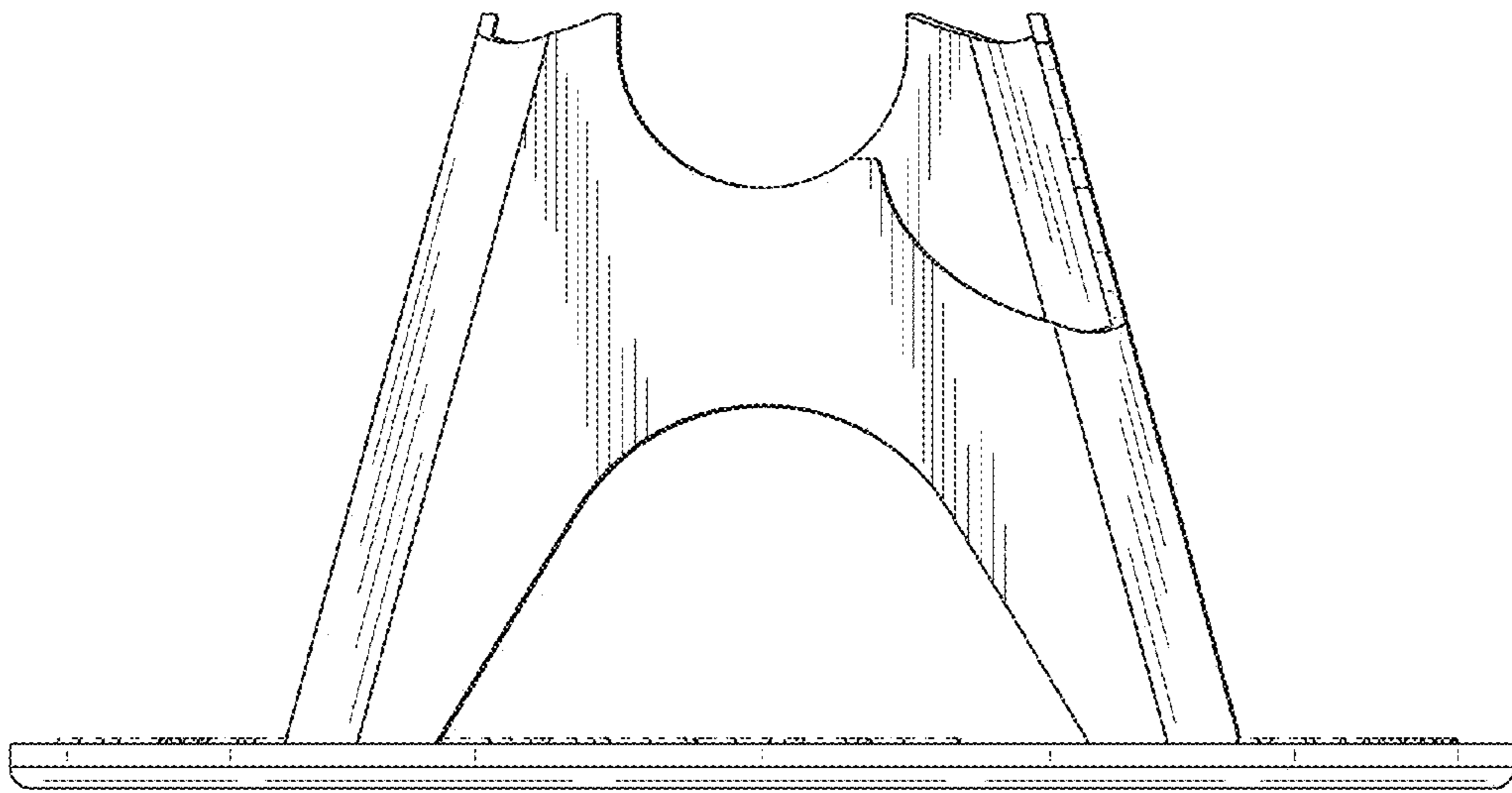

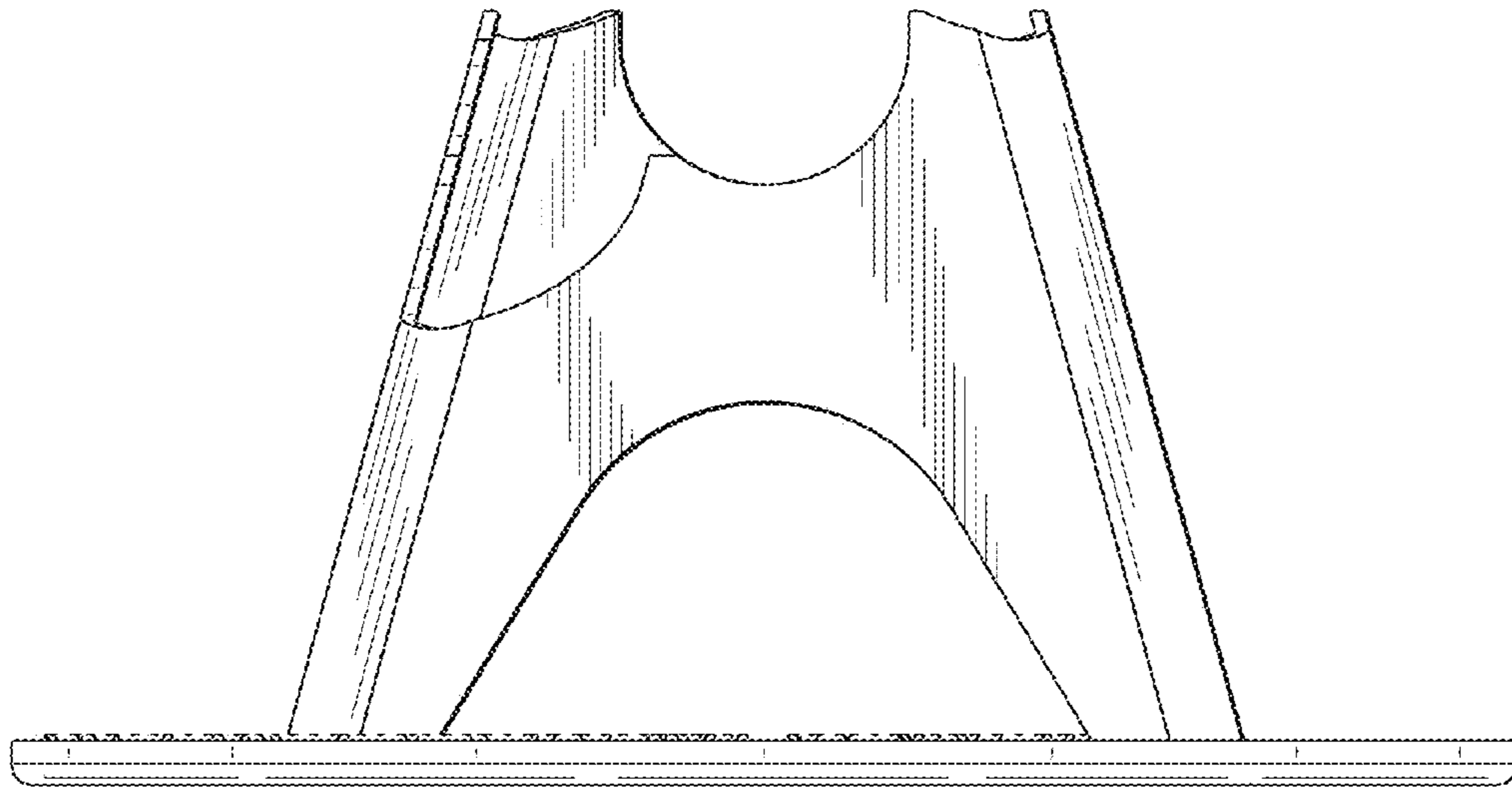

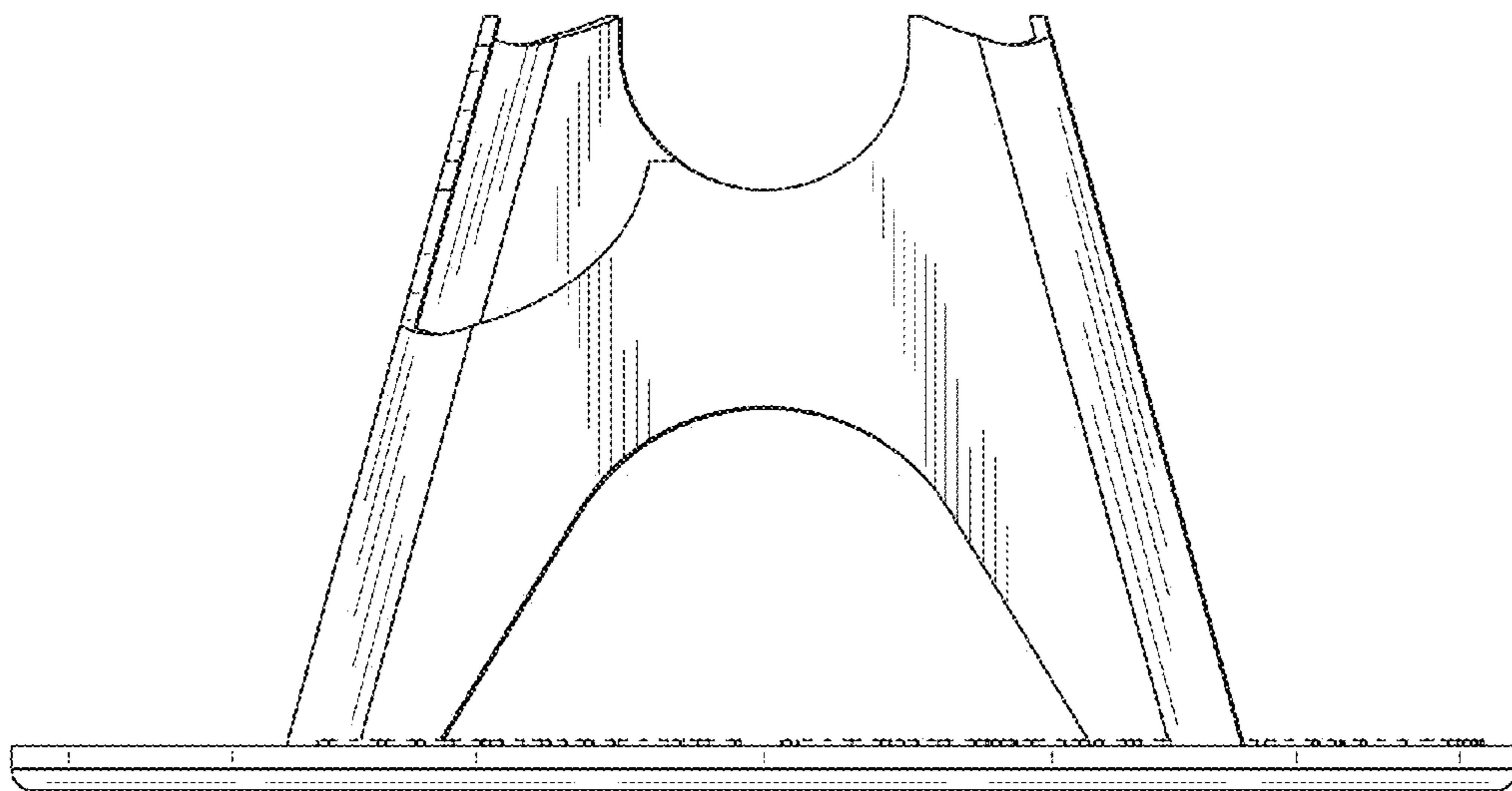

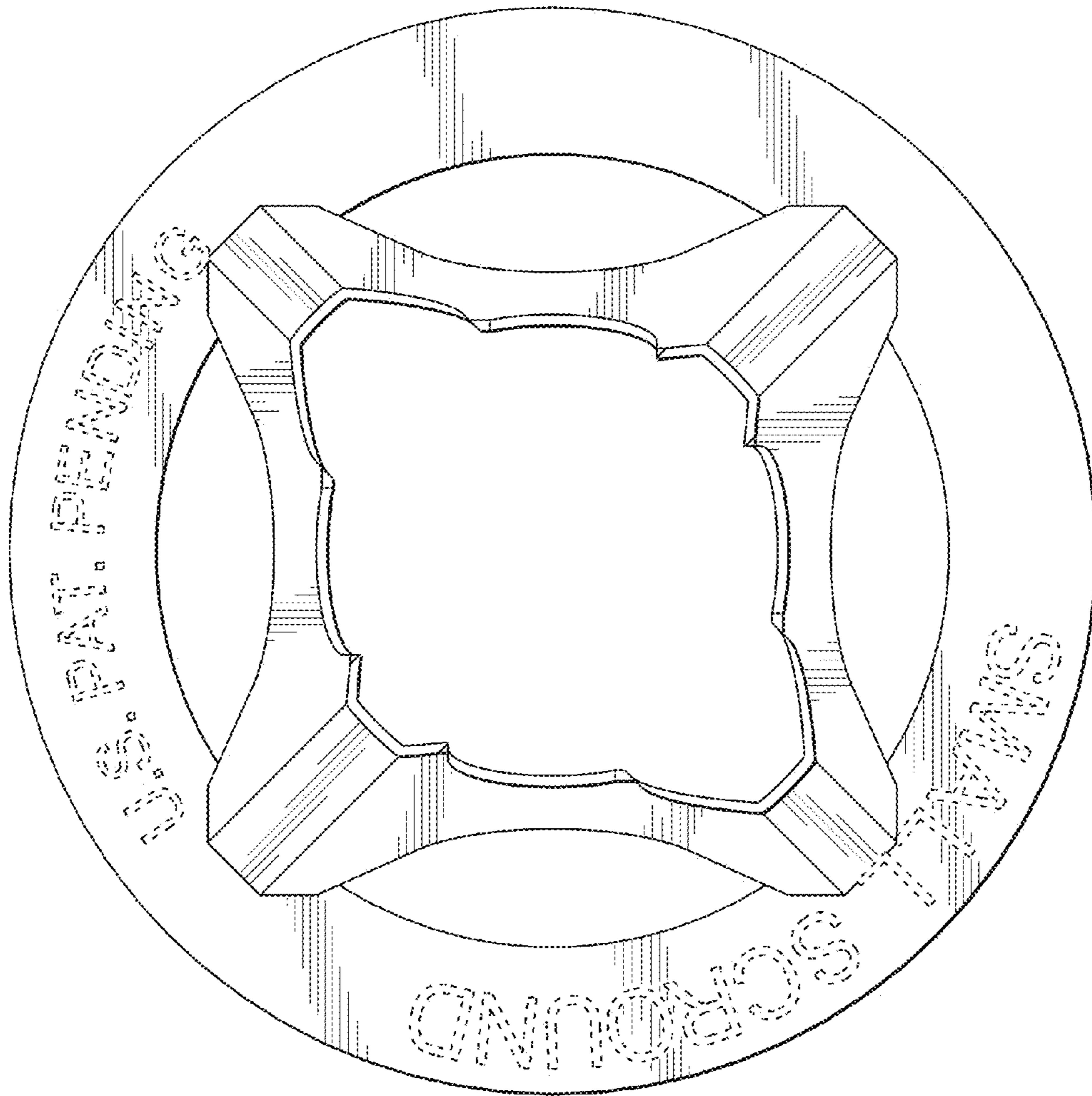

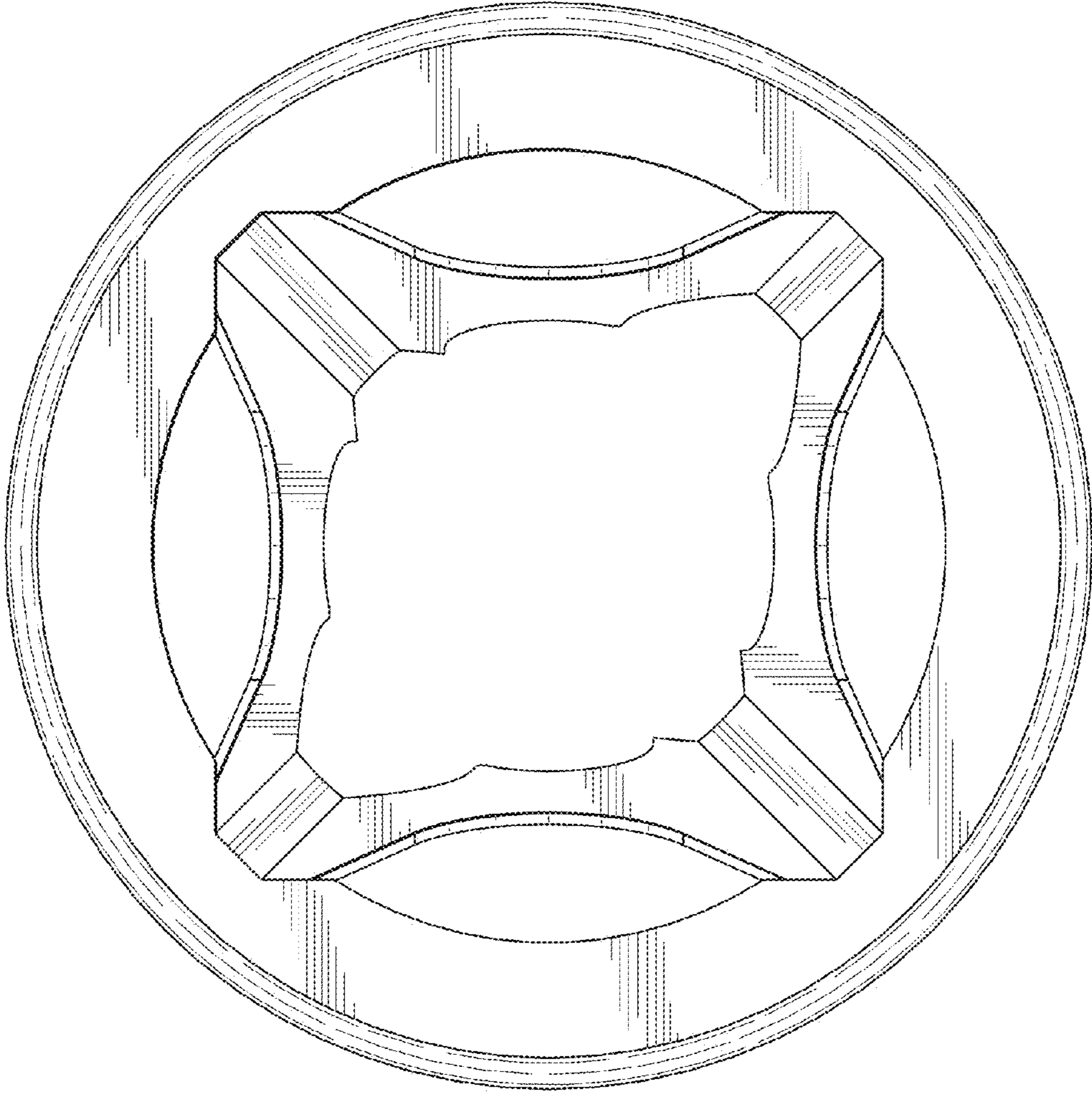
