(57) **CLAIM**

The ornamental design for a slide slot bracket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front, below of a first embodiment of a slide slot bracket showing my new design. FIG. 2 is a perspective view from the rear, above of the slide slot bracket of FIG. 1.

FIG. 3 is a front orthogonal view of the slide slot bracket of FIG. 1.

FIG. 4 is a right side orthogonal view of the slide slot bracket of FIG. 1; a left side orthogonal view of the slide slot bracket of FIG. 1 is the mirror image of FIG. 4.

FIG. 5 is a rear orthogonal view of the slide slot bracket of FIG. 1.

FIG. 6 is a top orthogonal view of the slide slot bracket of FIG. 1.

FIG. 7 is a bottom orthogonal view of the slide slot bracket of FIG. 1.

FIG. 8 is a perspective view of the first embodiment of slide slot bracket of FIG. 1 in a sneeze guard environment.

FIG. 9 is a perspective view of a second embodiment of a slide slot bracket showing my new design.

FIG. 10 is a perspective view from the rear, above of the slide slot bracket of FIG. 9.

FIG. 11 is a front orthogonal view of the slide slot bracket of FIG. 9.

FIG. 12 is a right side orthogonal view of the slide slot bracket of FIG. 9; a left side orthogonal view of the slide slot bracket of FIG. 9 is the mirror image of FIG. 12.

FIG. 13 is a rear orthogonal view of the slide slot bracket of FIG. 9.

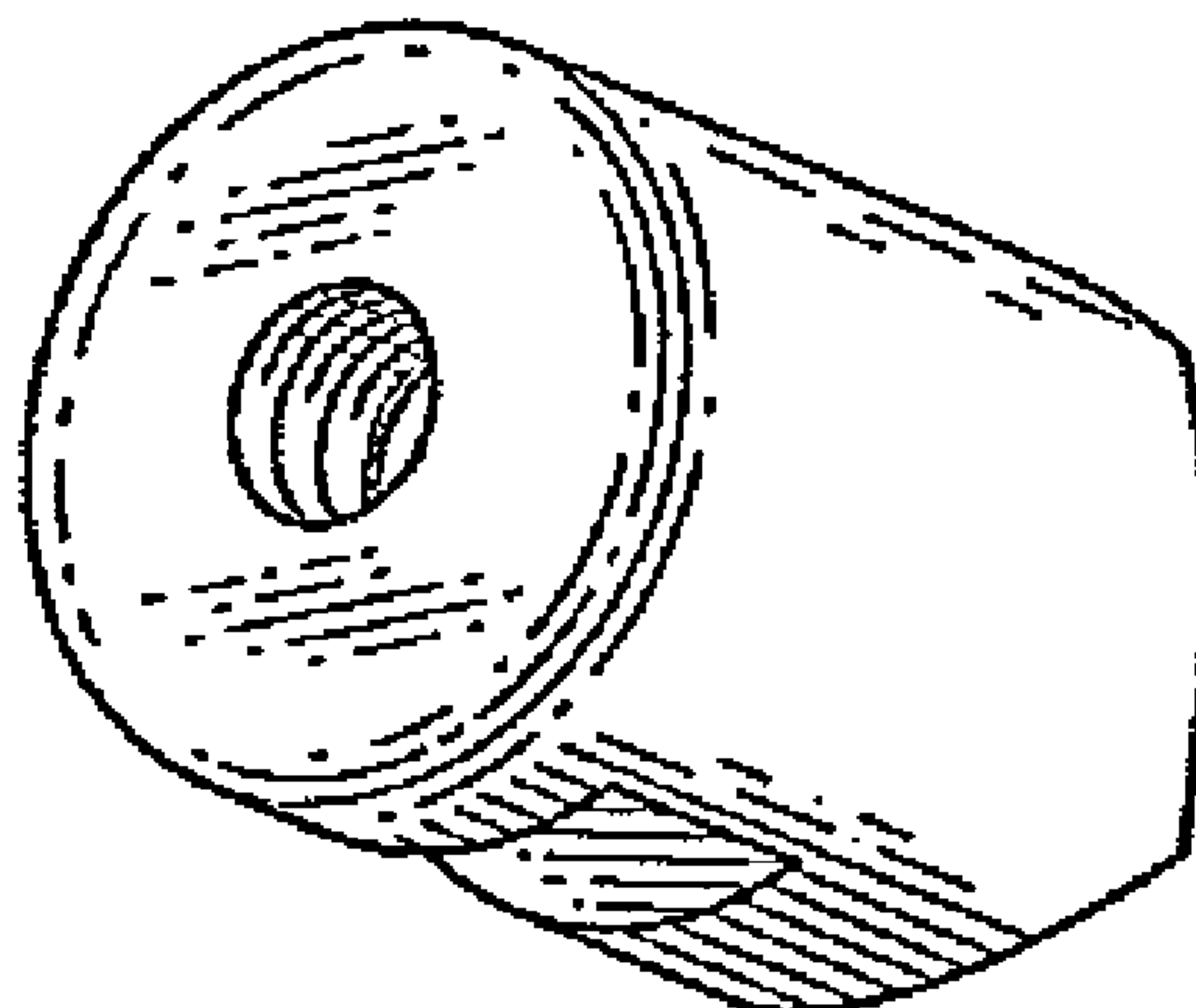
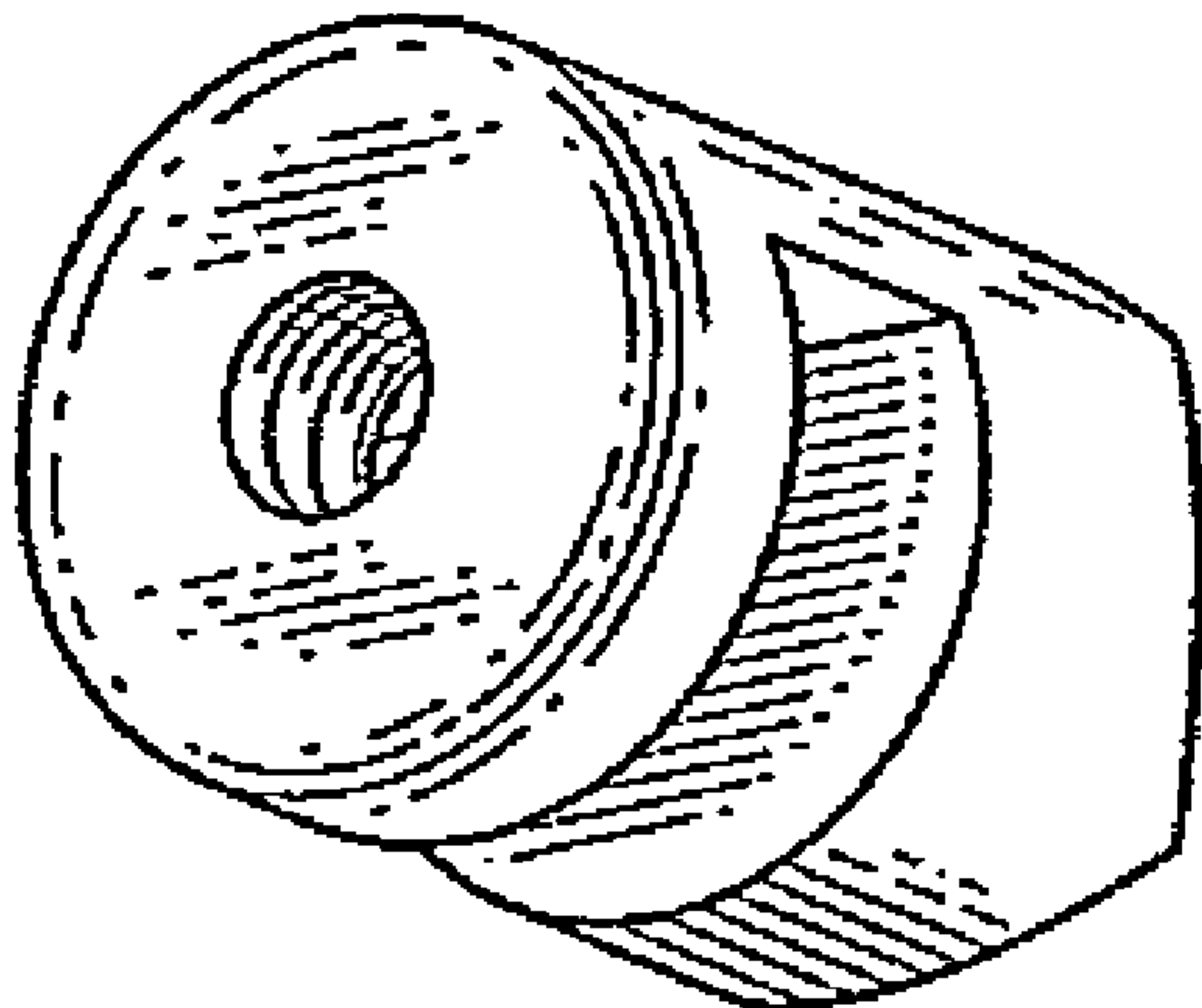
FIG. 14 is a top orthogonal view of the slide slot bracket of FIG. 9.

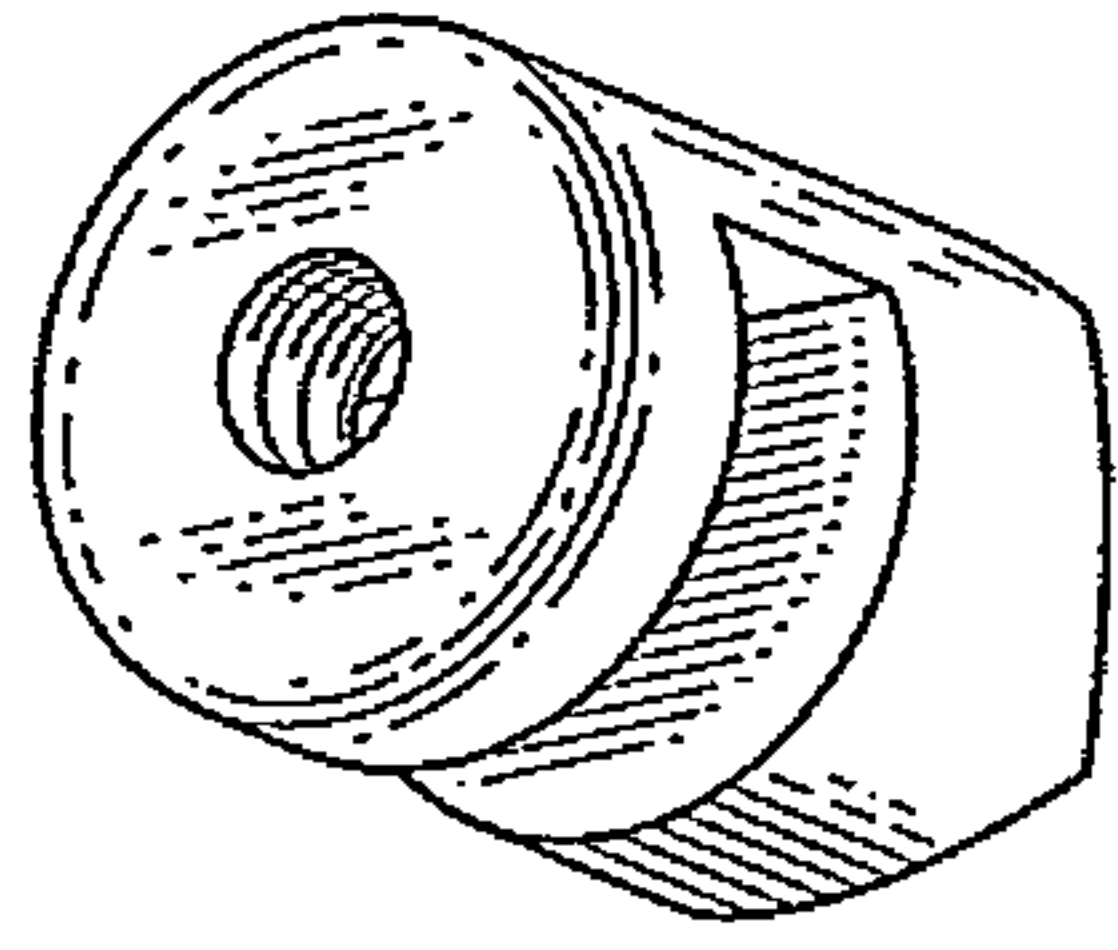

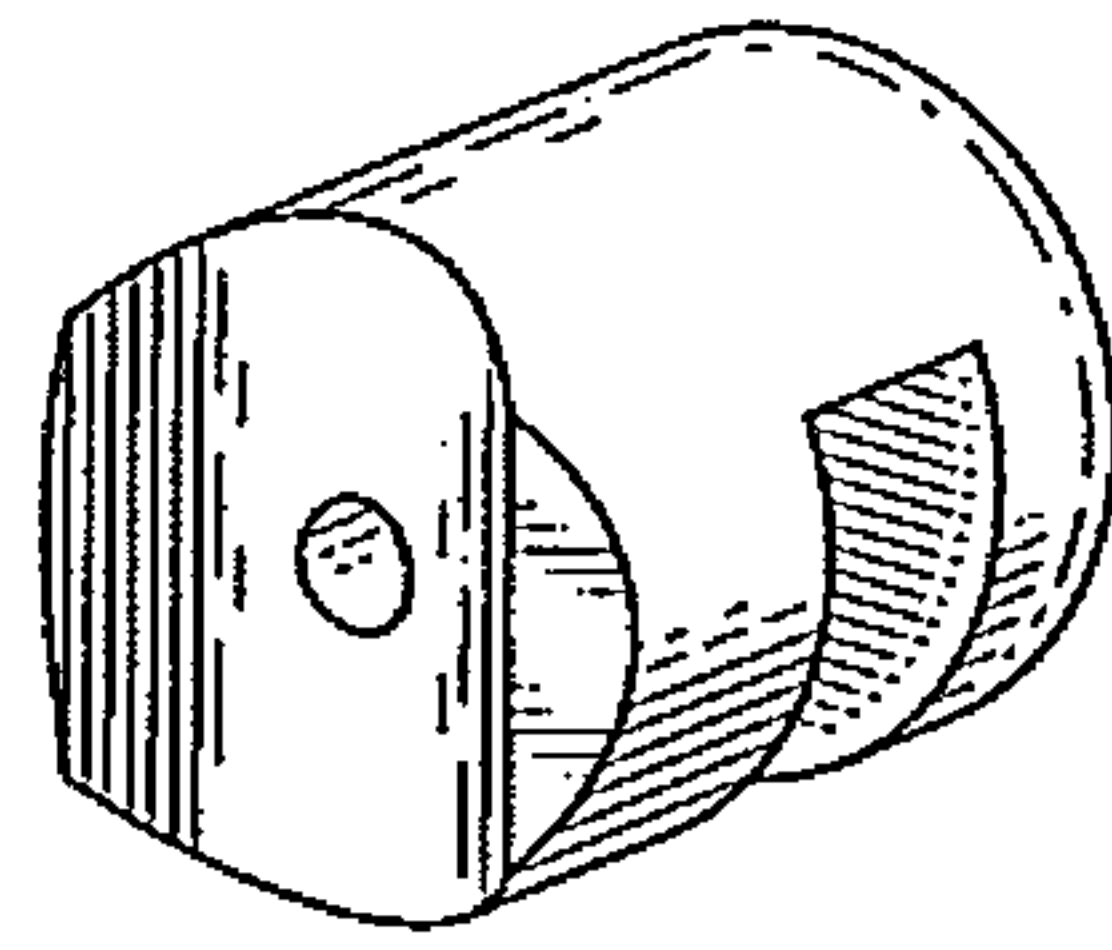

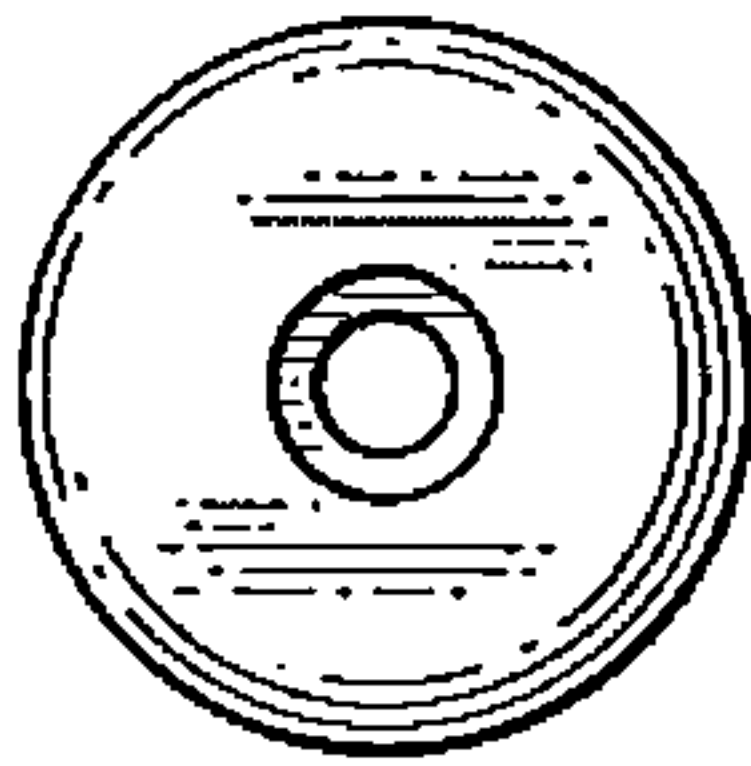

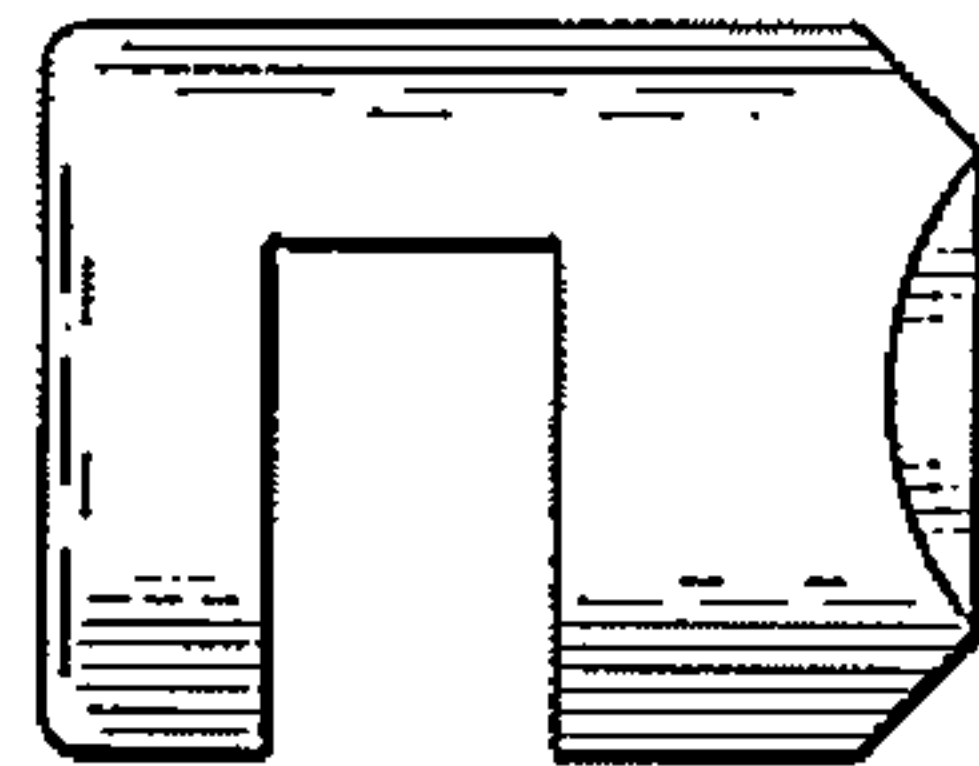

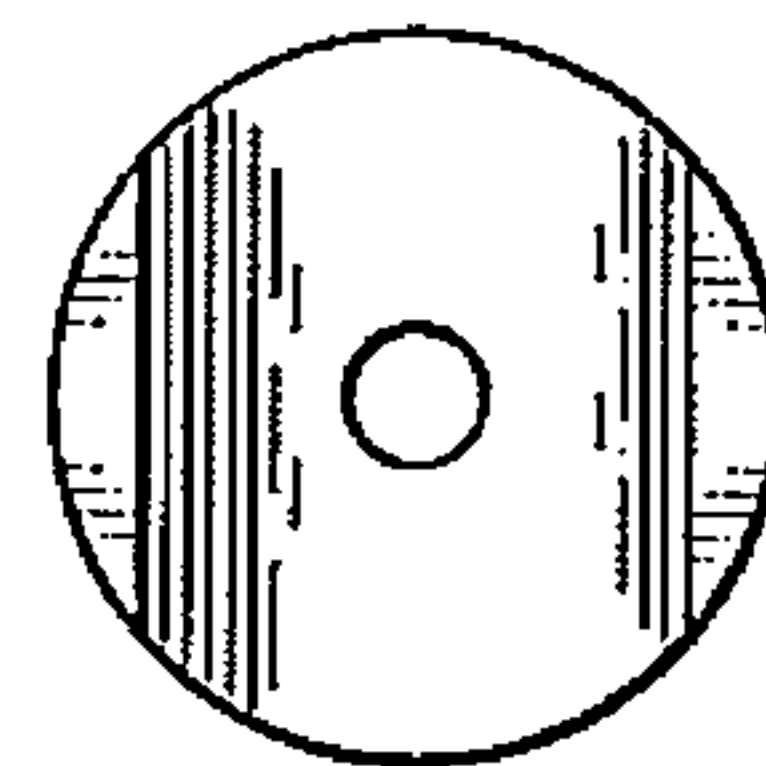

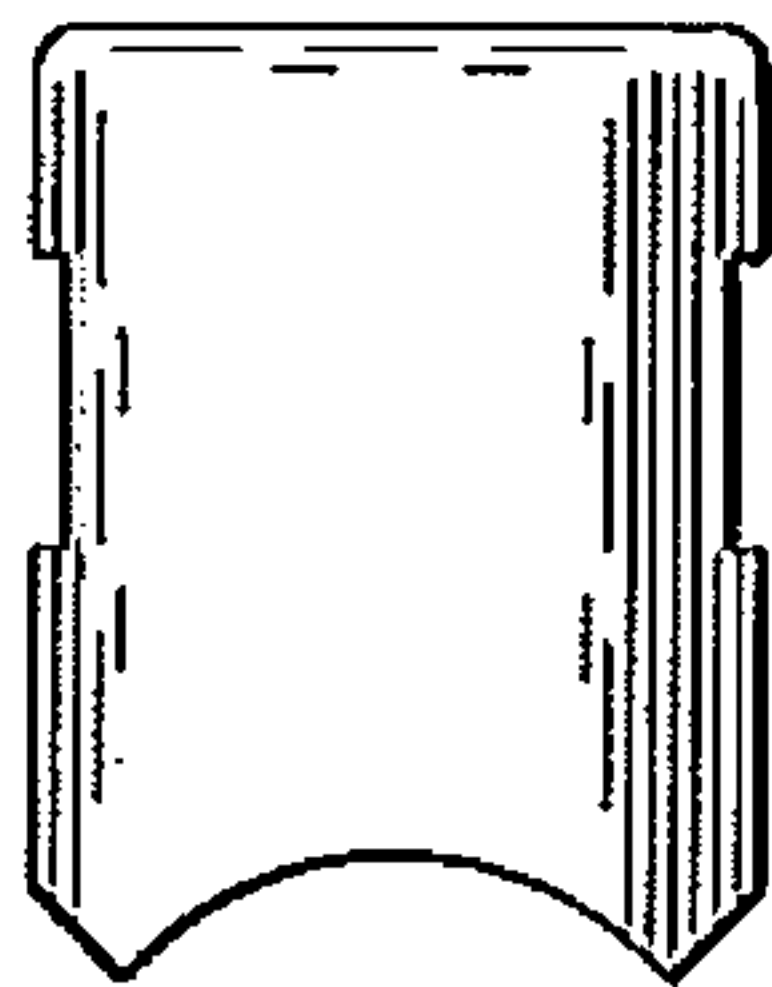

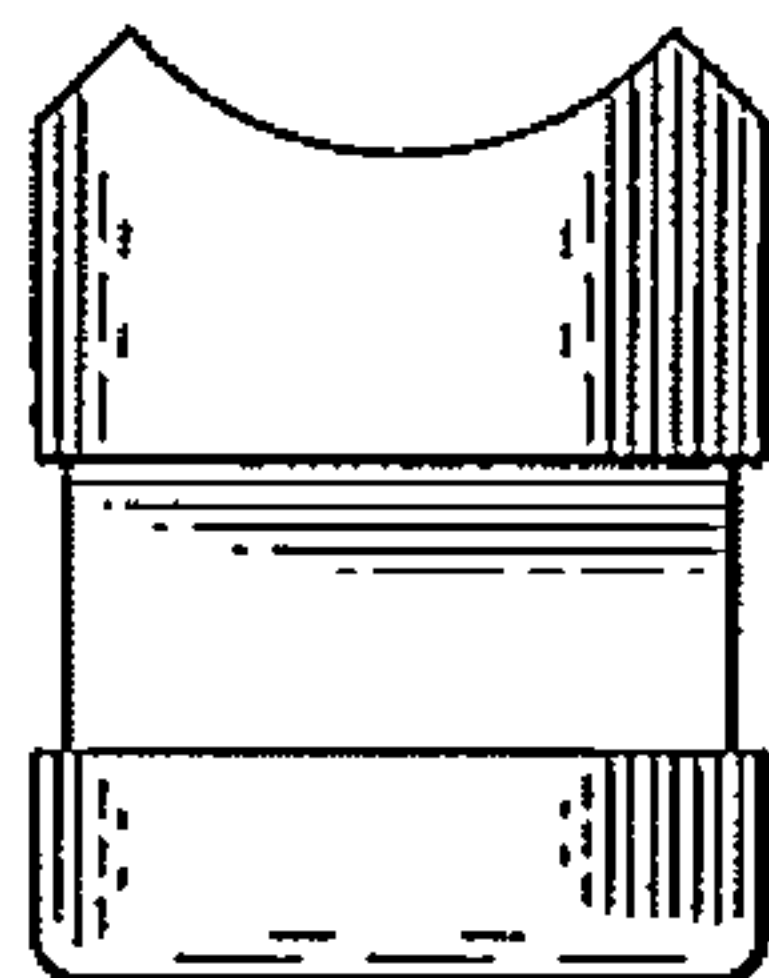

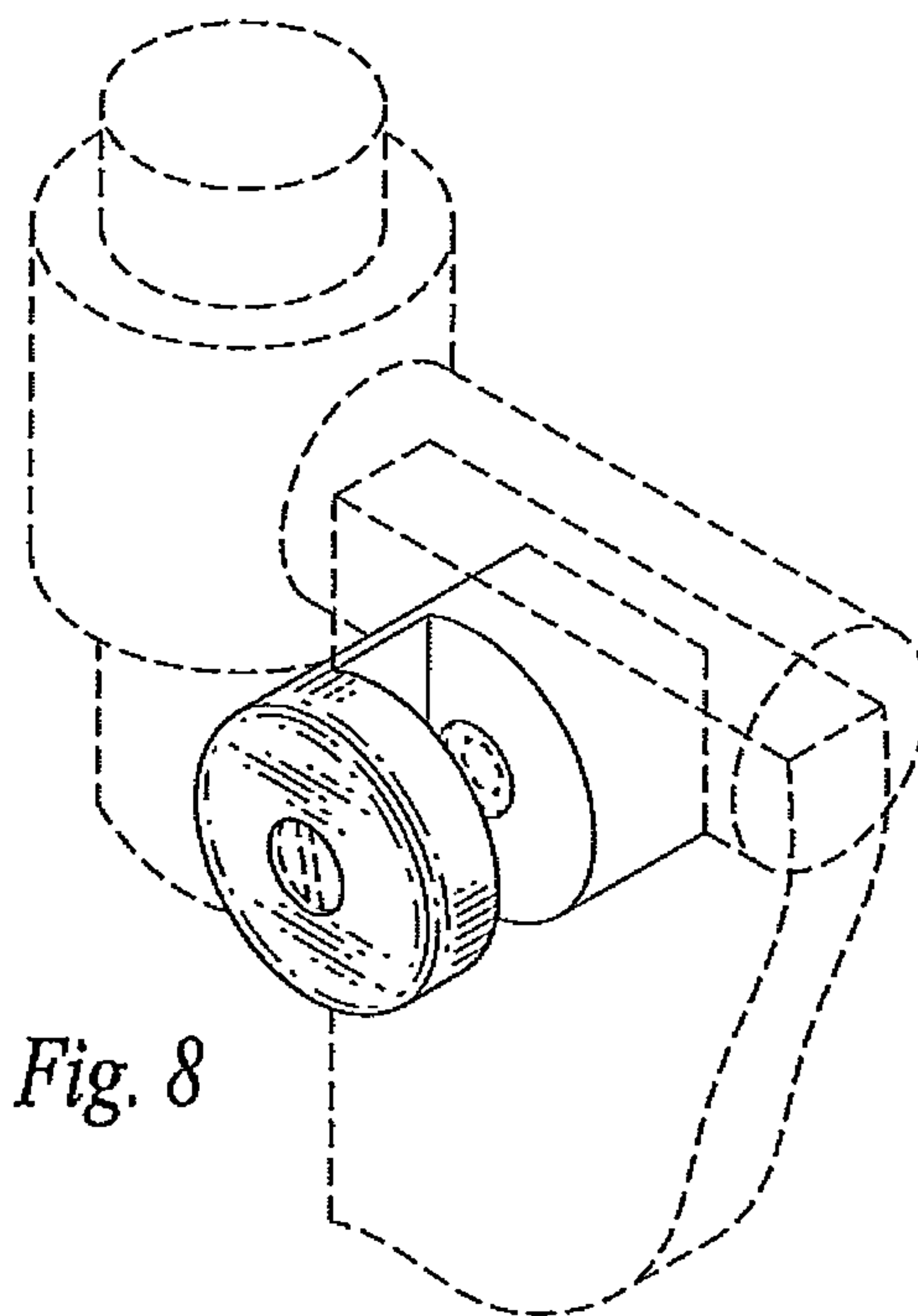

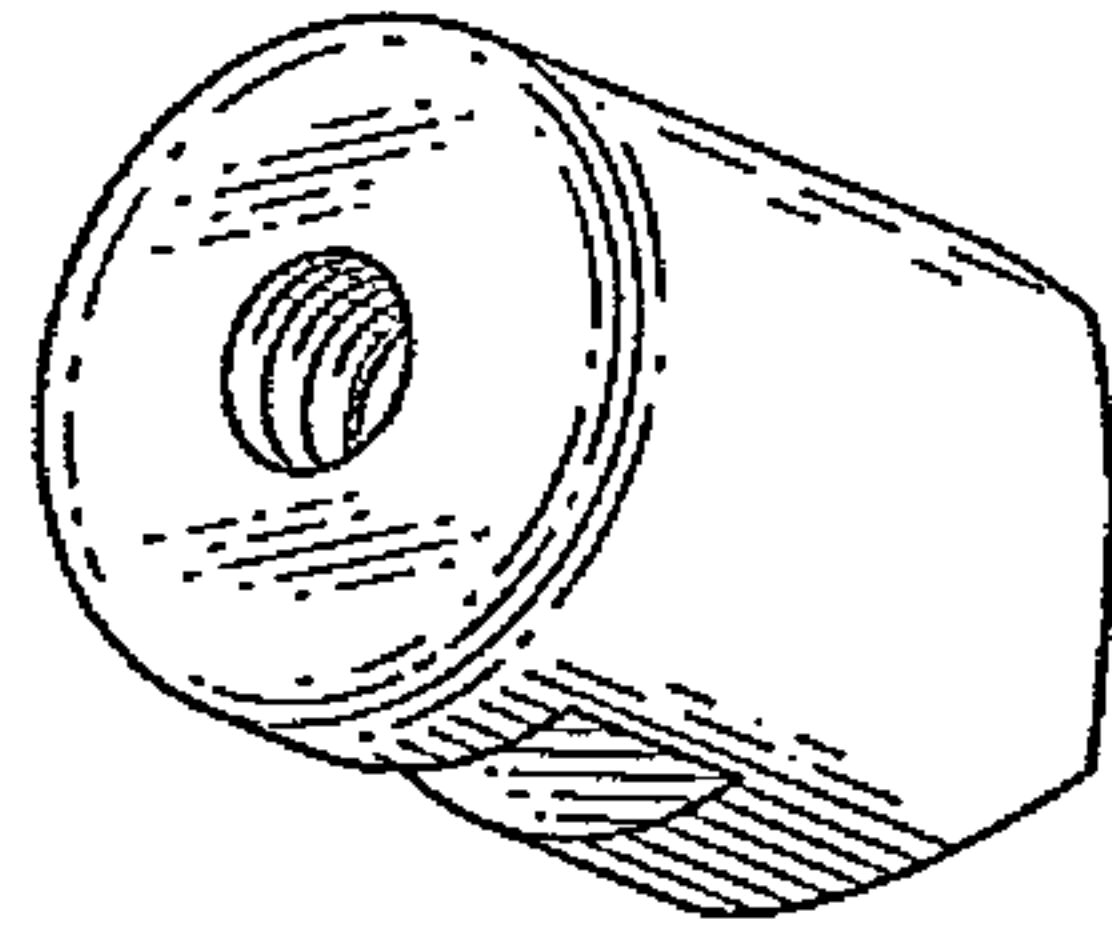

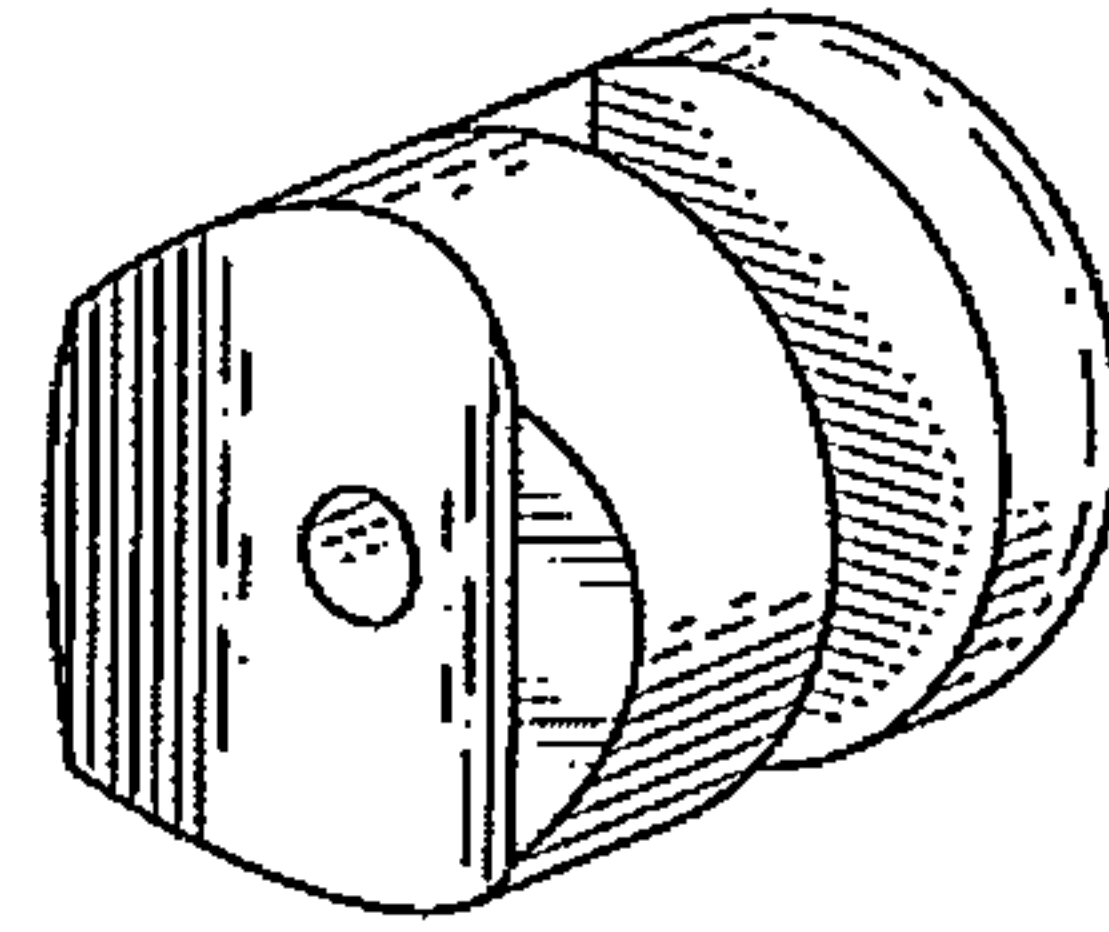

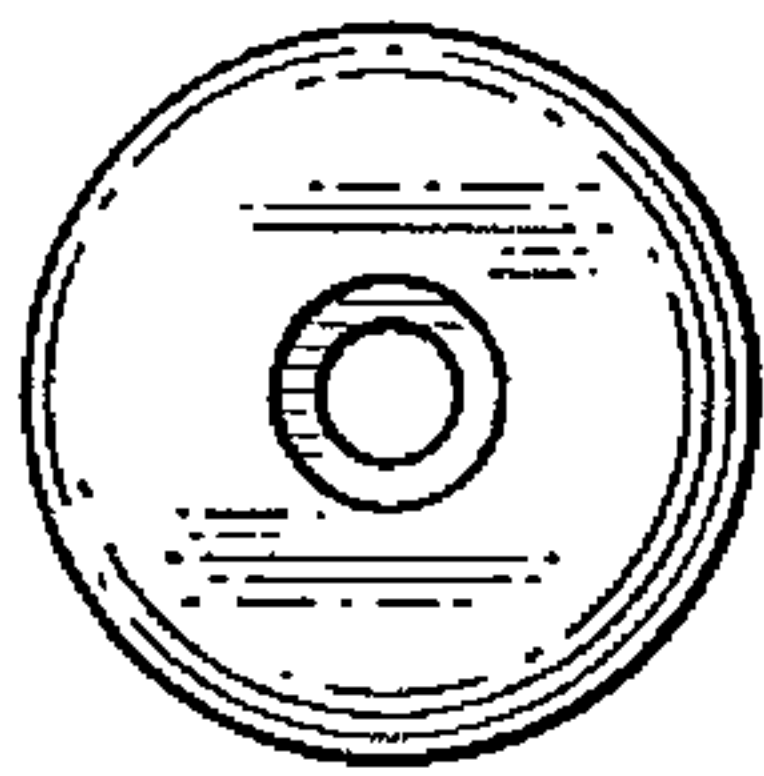

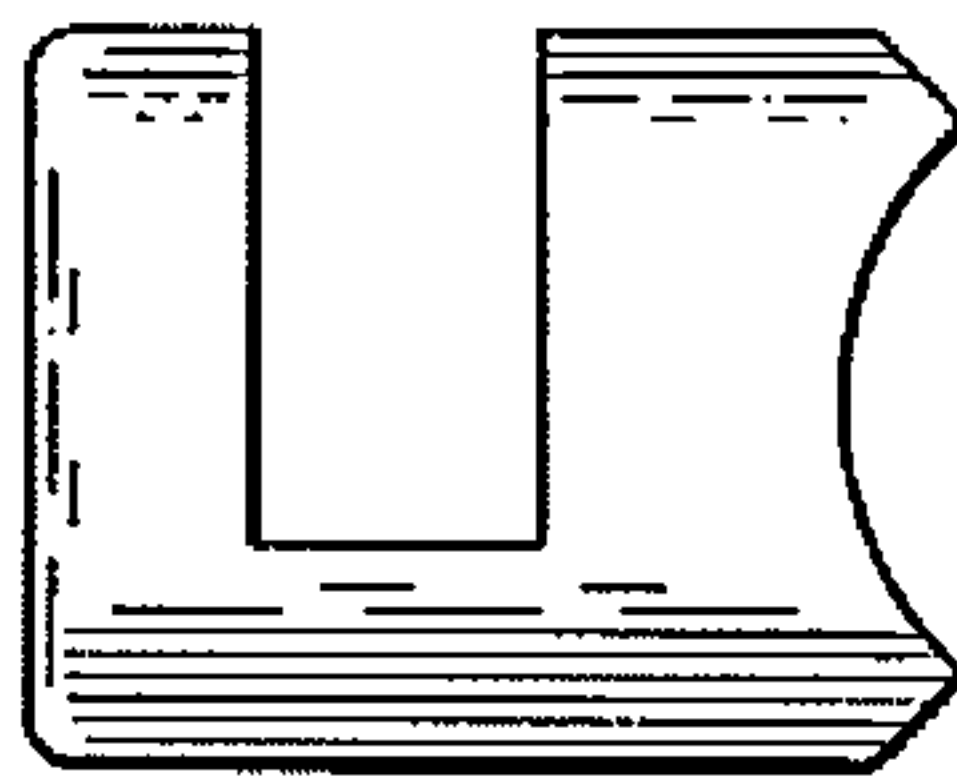

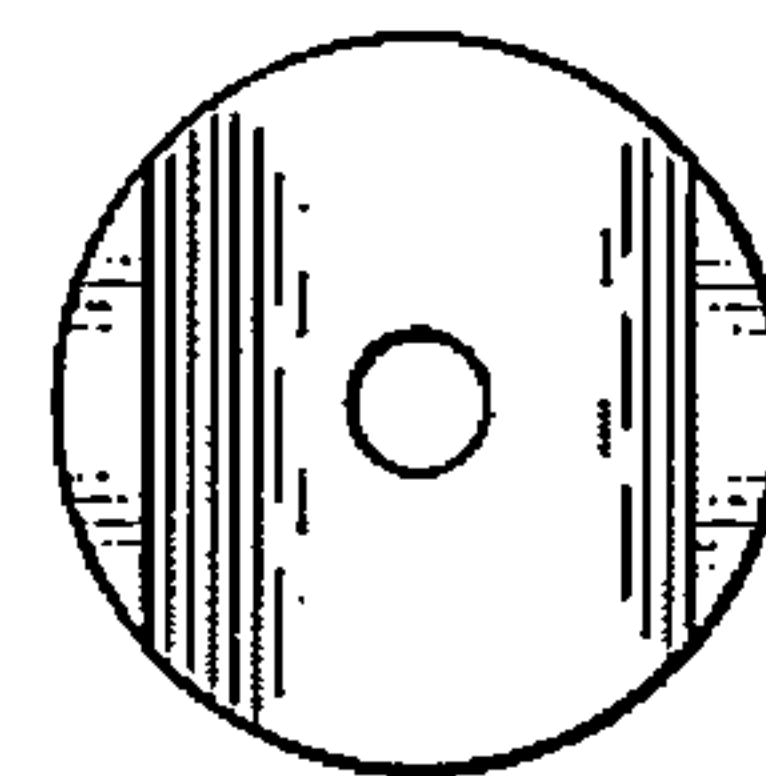

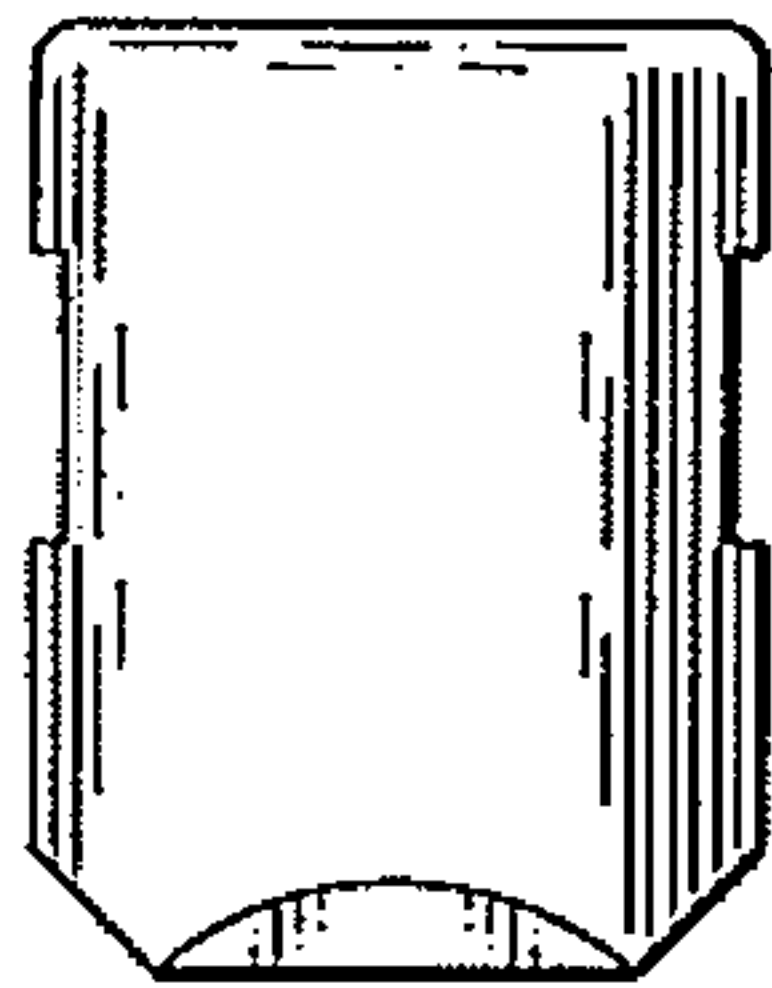

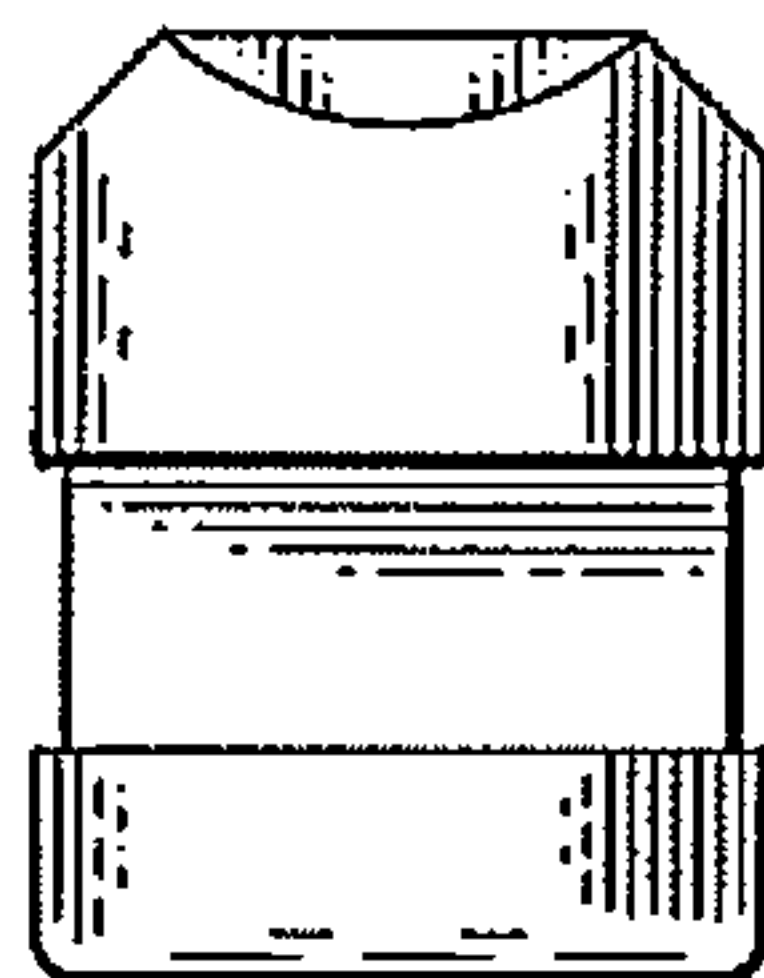

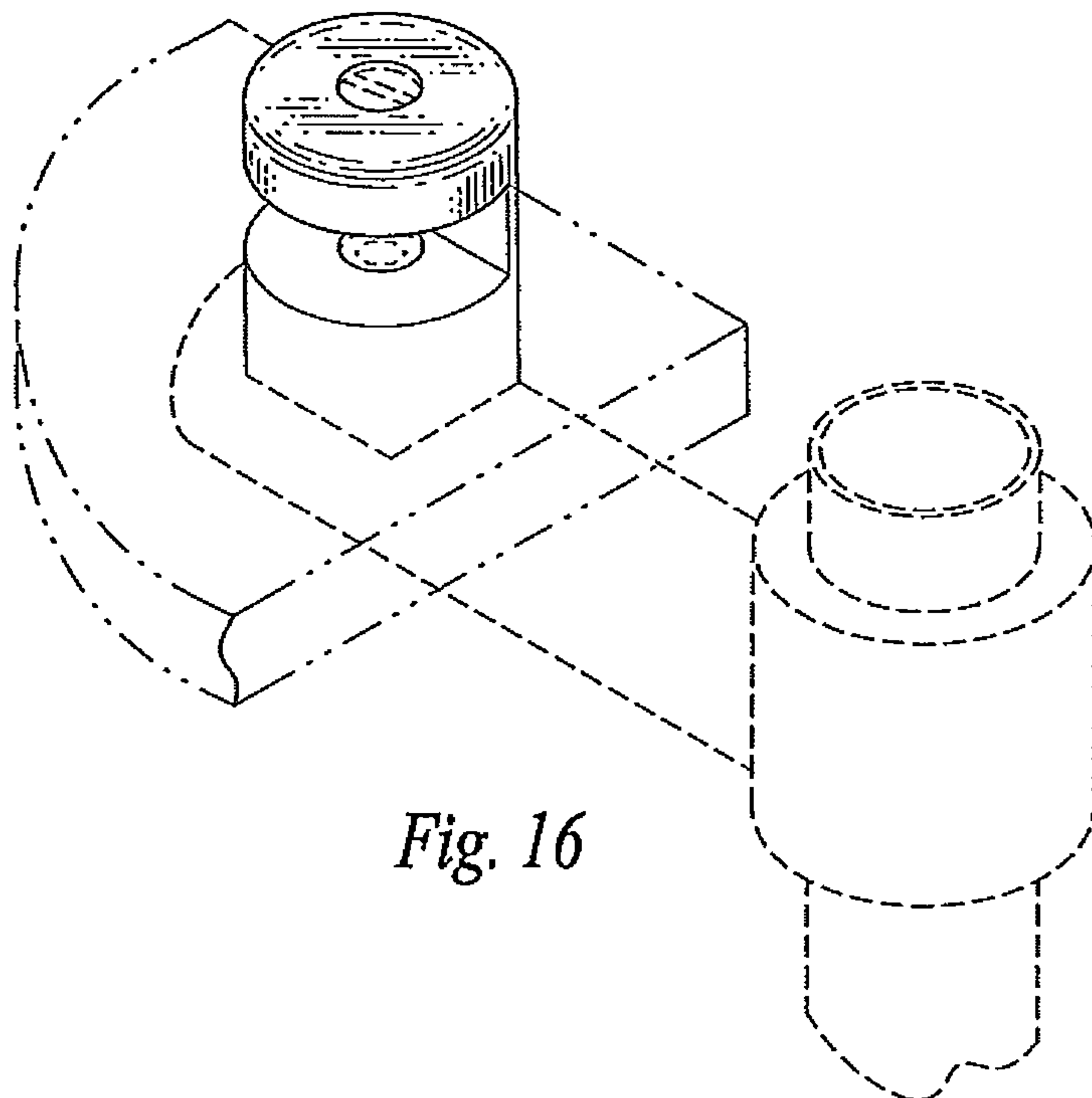
