(57) **CLAIM**

The ornamental design for a combined surface for a shipping box and shipping box, as shown and described.

**DESCRIPTION**

FIG. 1 is a view of a shipping box showing a first embodiment of the new design, wherein the portions of the drawings shown in broken lines, i.e., the broken line edges of the box, the rectangular border to the new design in broken lines, the “Skin Friendly” text in broken lines, and the broken line encircling the design, are for illustrative purposes only and form no part of the claimed design.

FIG. 2 is a front view of a shipping box of FIG. 1, wherein the portions of the drawings shown in broken lines, i.e., the broken line edges of the box, the rectangular border to the new design in broken lines, the “Skin Friendly” text in broken lines, and the broken line encircling the design, are for illustrative purposes only and form no part of the claimed design.

FIG. 3 is a rear view of the shipping box of FIG. 1, wherein the portions of the drawings shown in broken lines, i.e., the broken line edges of the box, are for illustrative purposes only and form no part of the claimed design.

FIG. 4 is a left side view of the shipping box of FIG. 1, wherein the portions of the drawings shown in broken lines, i.e., the broken line edges of the box, are for illustrative purposes only and form no part of the claimed design.

FIG. 5 is a right side view of the shipping box of FIG. 1, wherein the portions of the drawings shown in broken lines, i.e., the broken line edges of the box, are for illustrative purposes only and form no part of the claimed design.

FIG. 6 is a top view of the shipping box of FIG. 1, wherein the portions of the drawings shown in broken lines, i.e., the broken line edges of the box, are for illustrative purposes only and form no part of the claimed design.

FIG. 7 is a bottom view of the shipping box of FIG. 1, wherein the portions of the drawings shown in broken lines, i.e., the broken line edges of the box, are for illustrative purposes only and form no part of the claimed design; and,

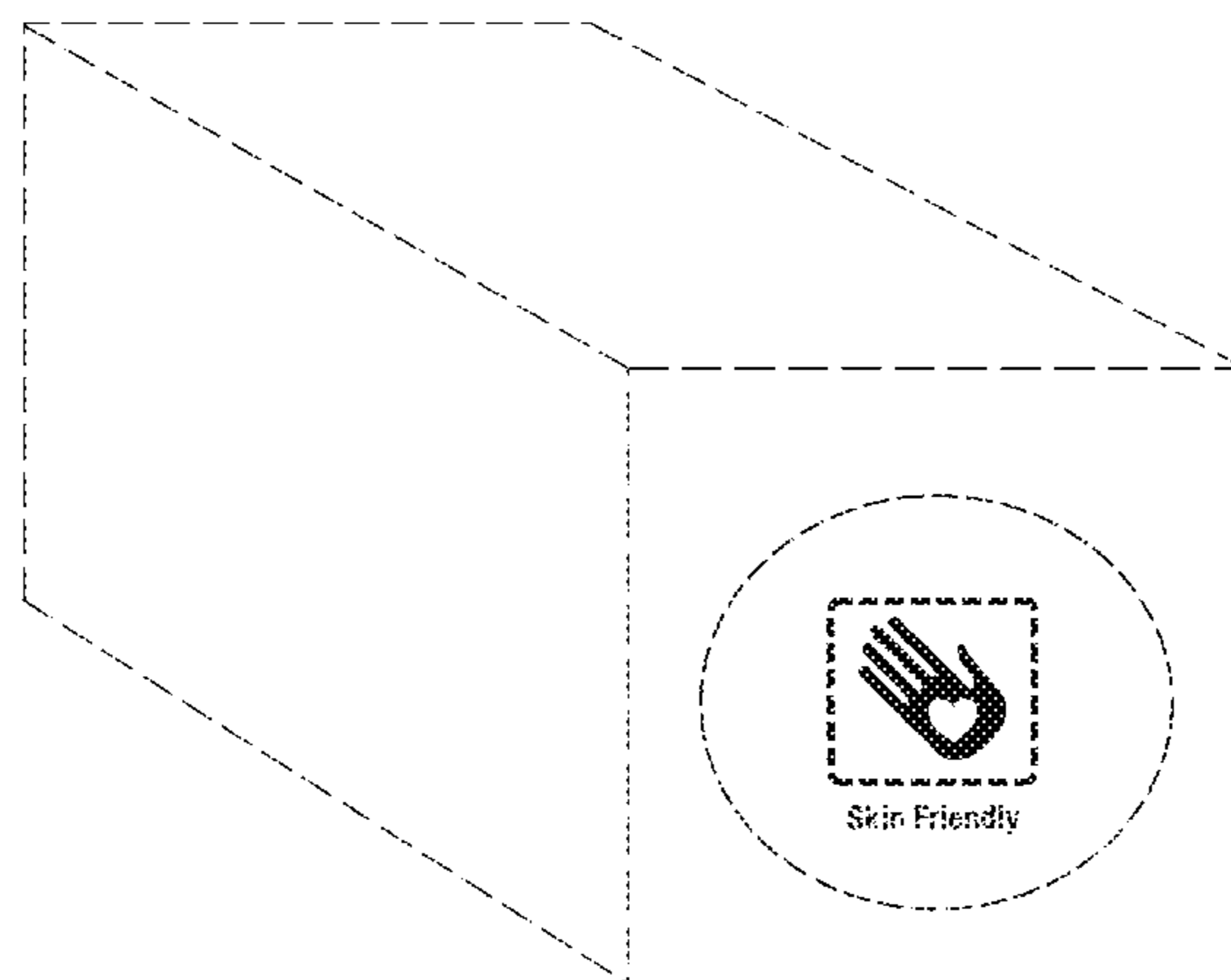

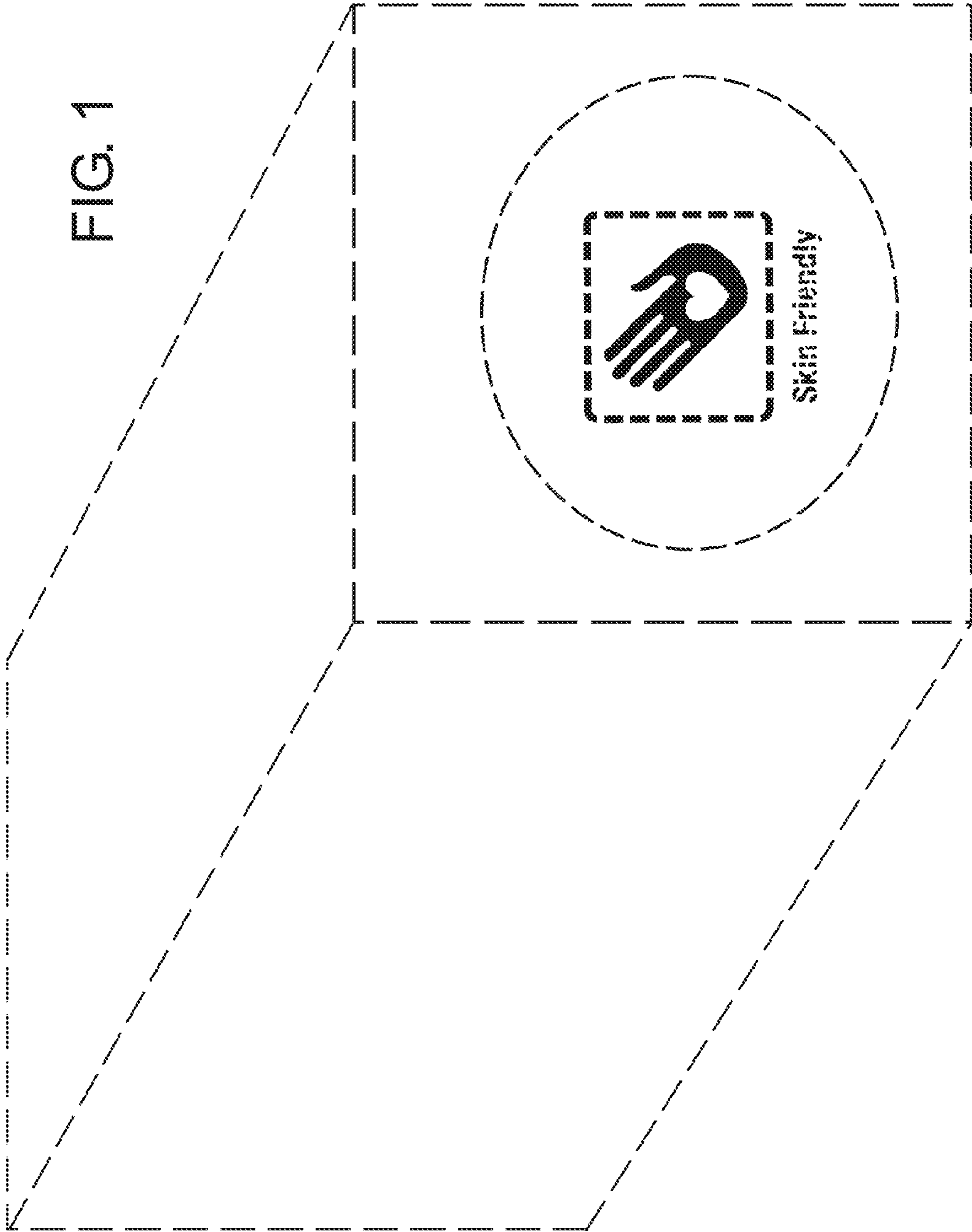
The scope of the claimed design is not limited to having the claimed design on any particular face or on any particular location on any particular face.

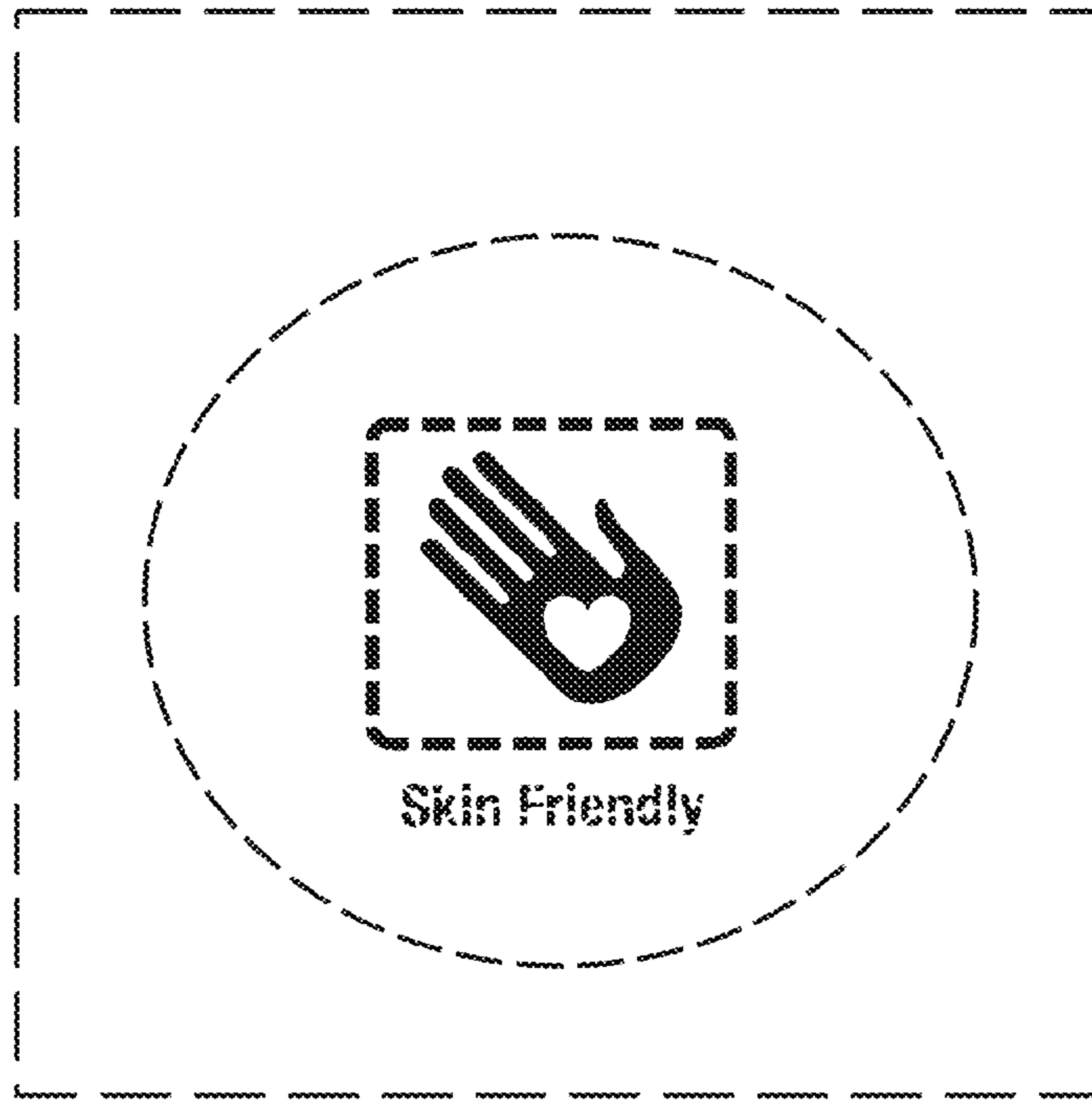

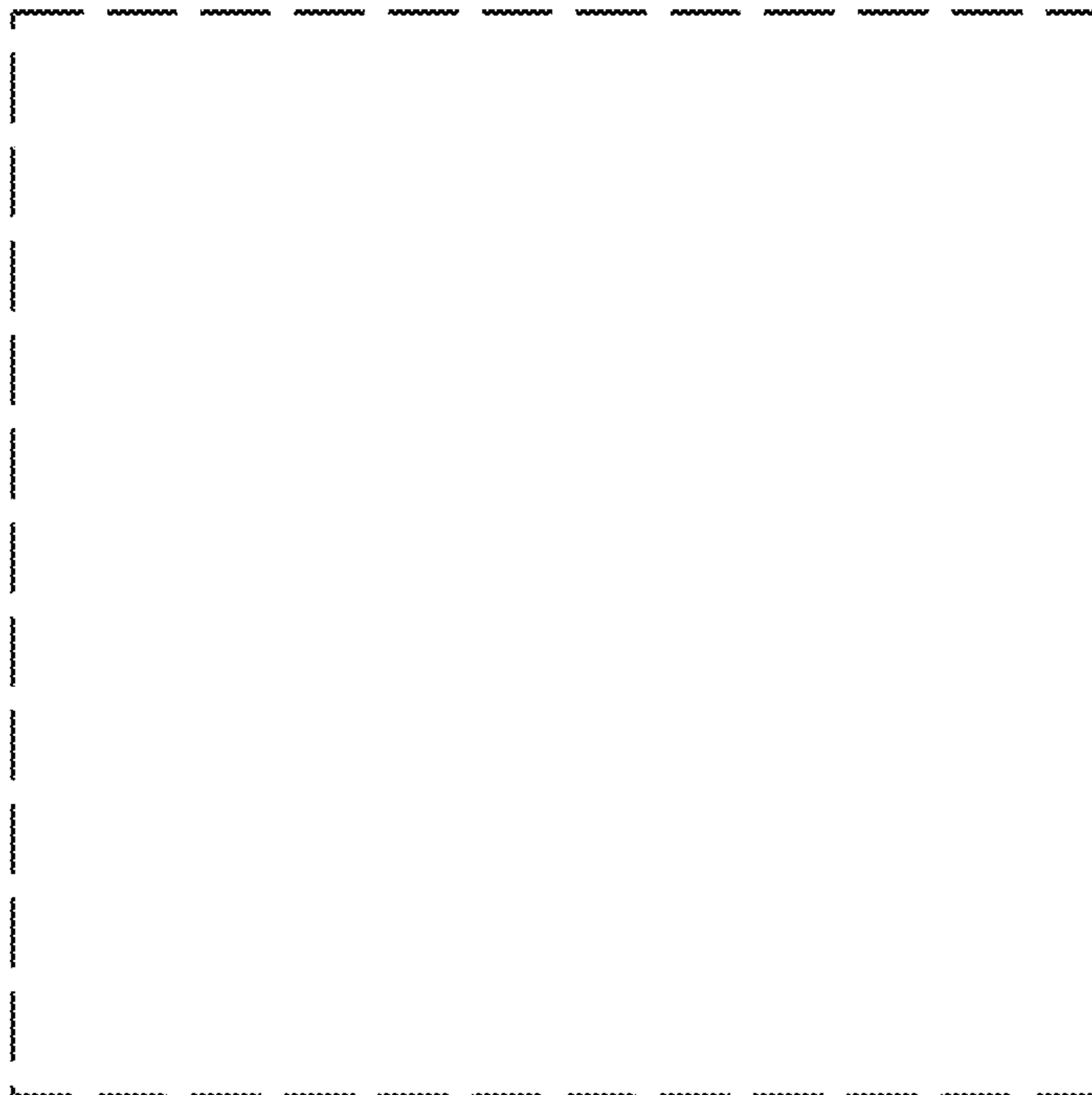

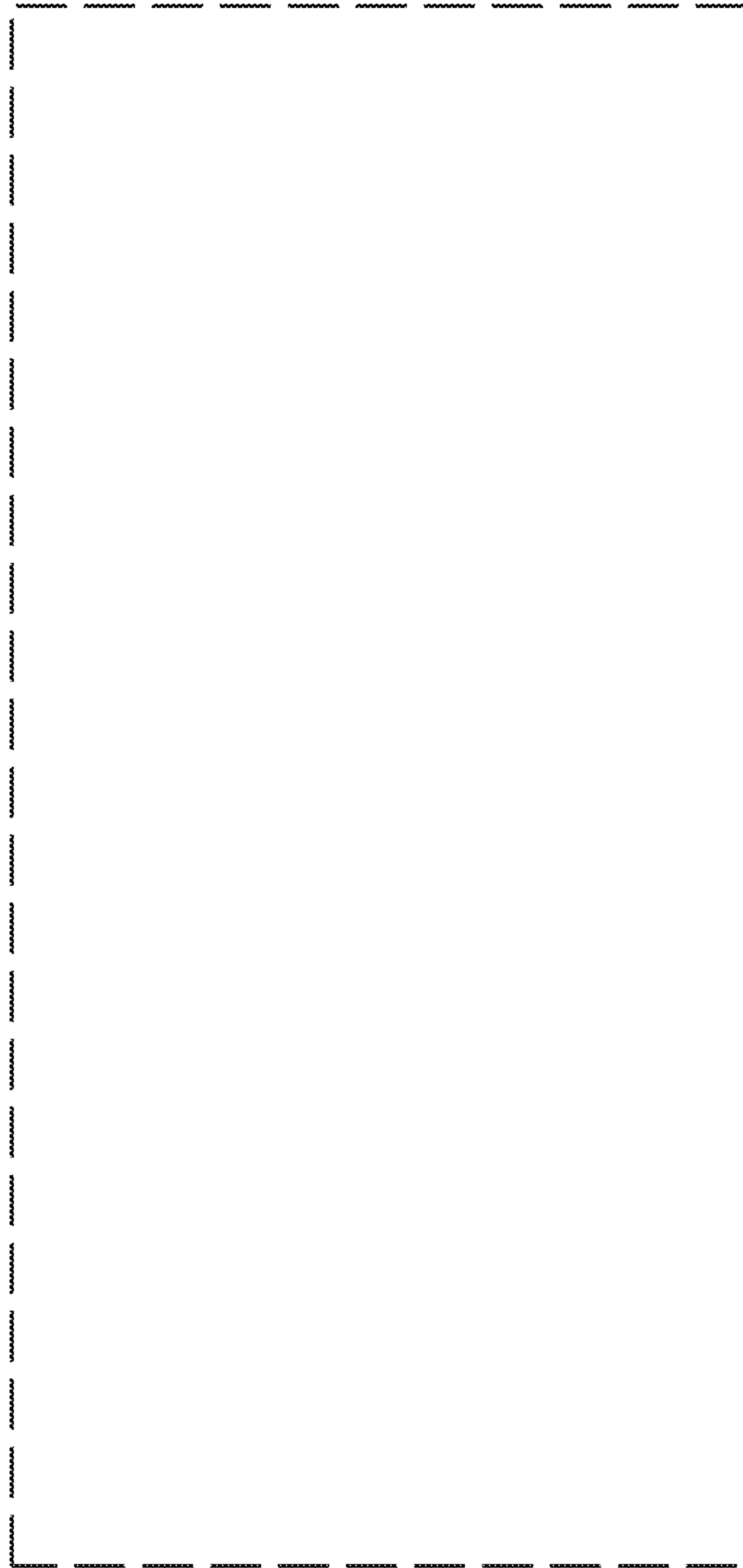

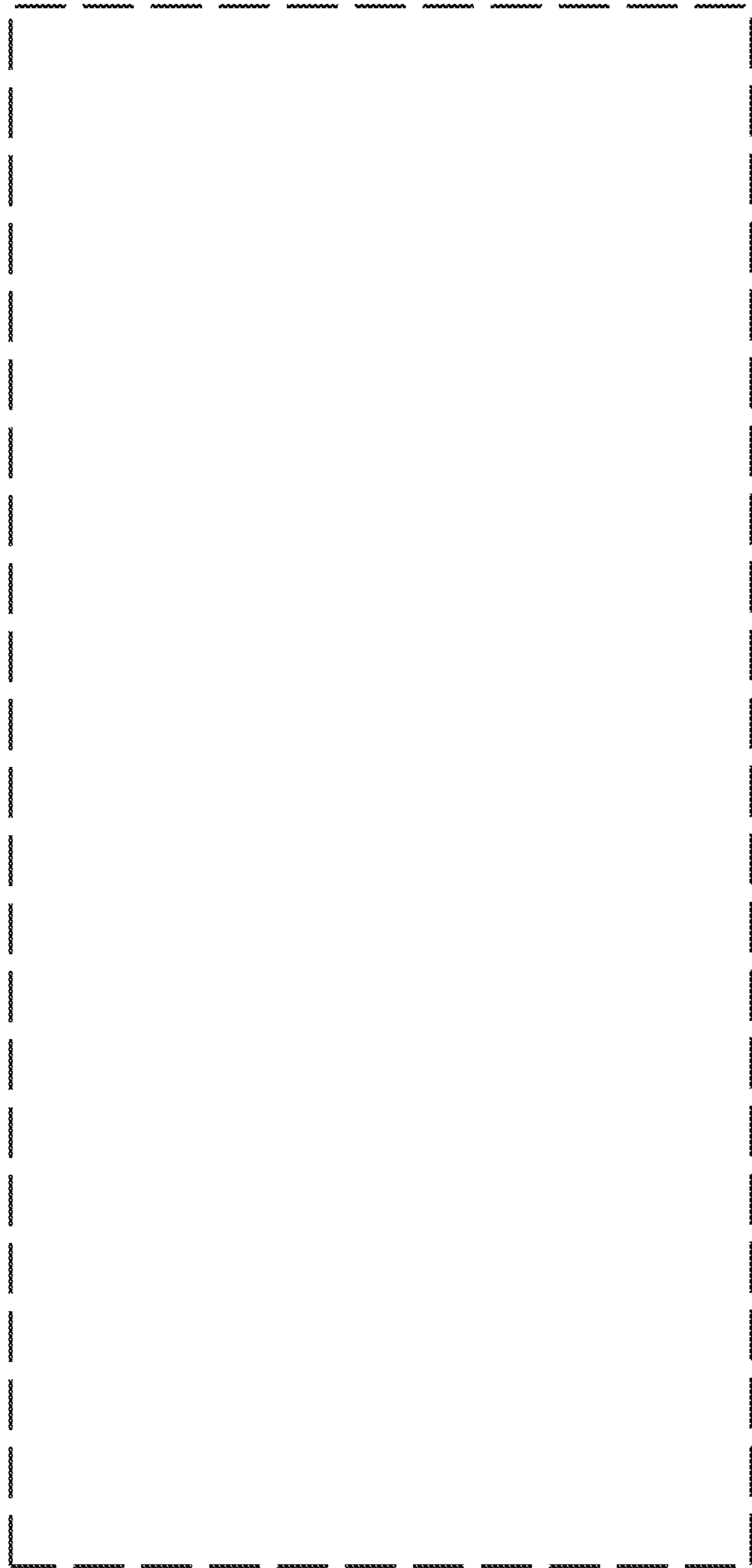

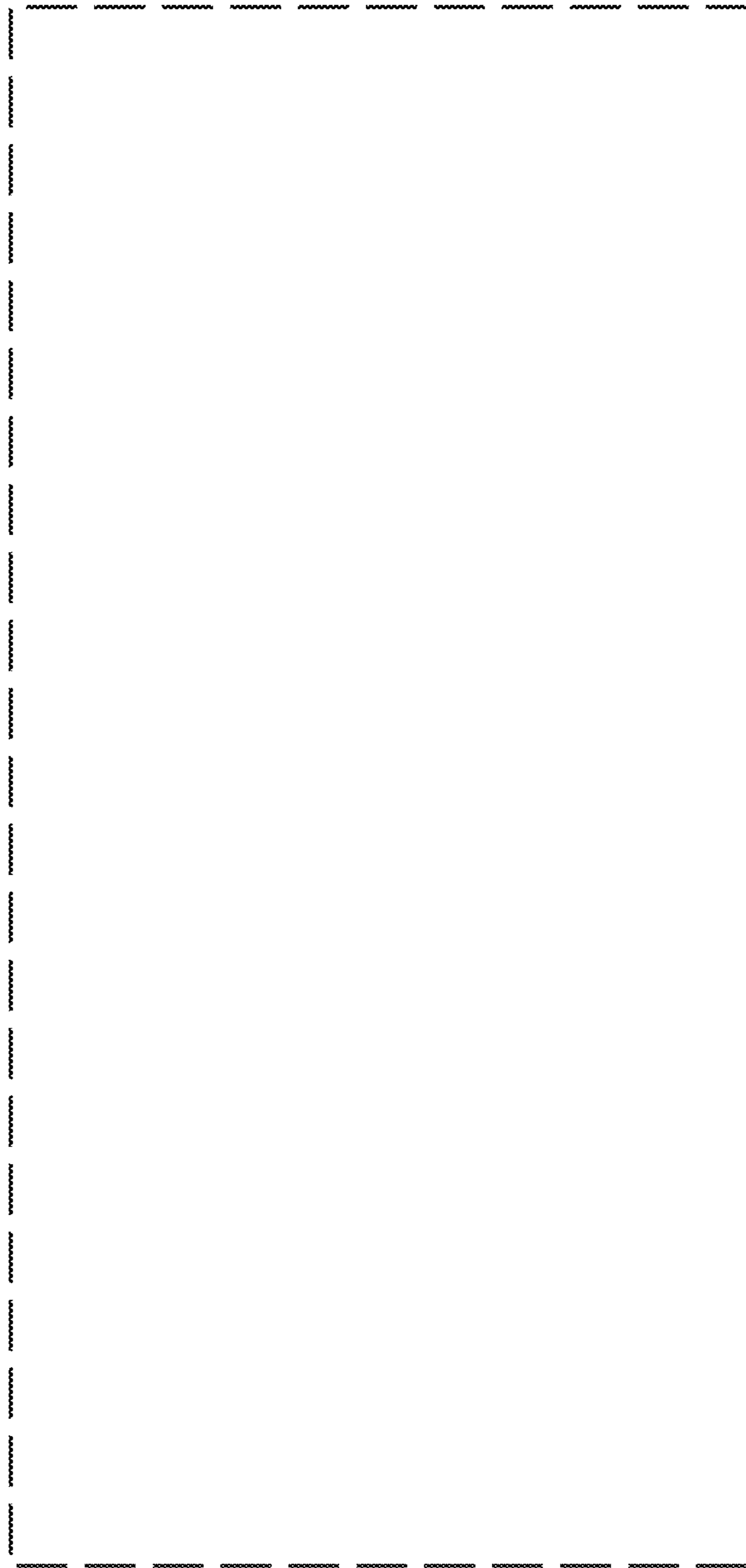

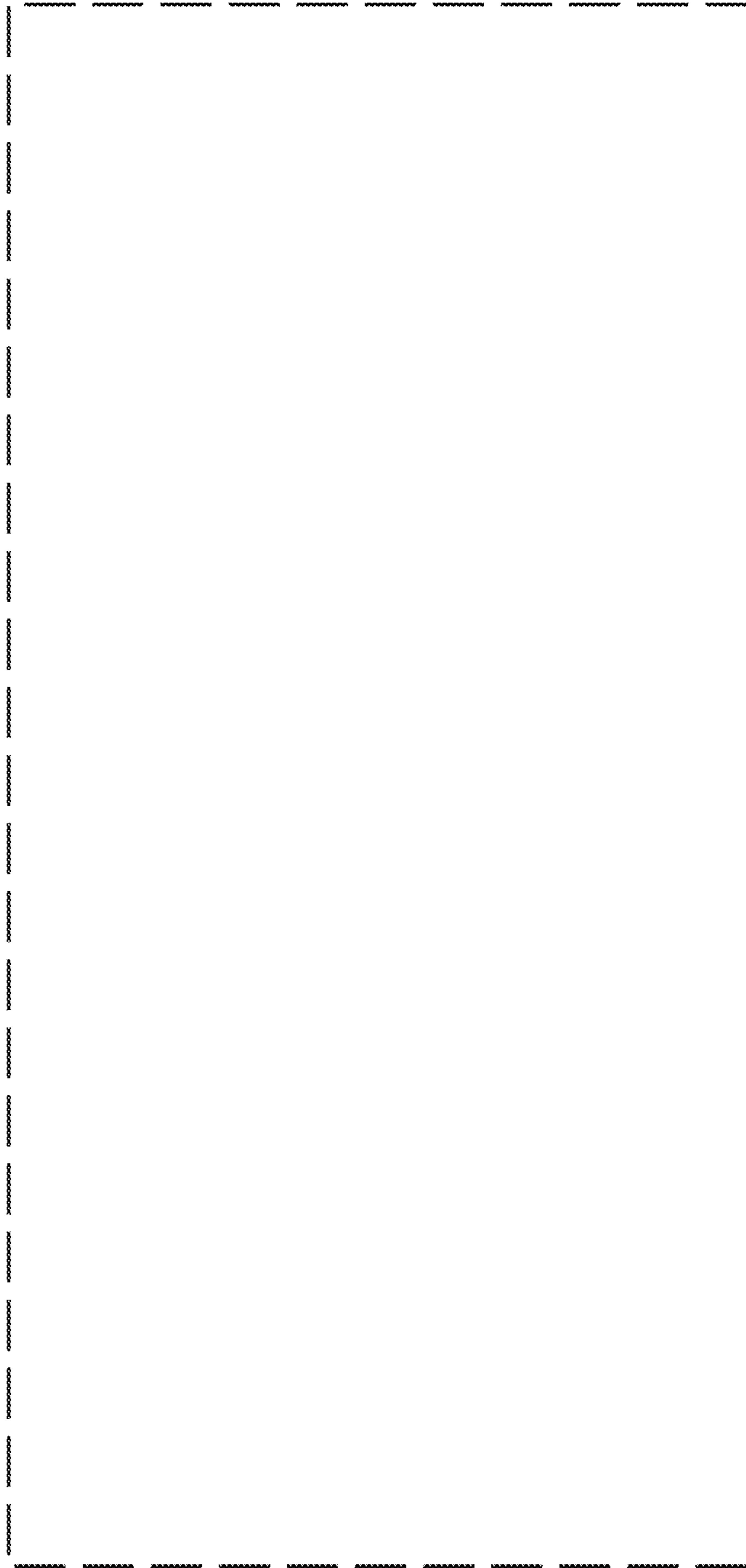
