The ornamental design for an articulating contact pin, as shown and described.

DESCRIPTION

This application incorporates co-pending patent application Ser. No. 29/460,414 filed 10 Jul. 2013 and co-pending patent application Ser. No. 29/480,754 filed 29 Jan. 2014 by reference in their entirety.

FIG. 25 is a front perspective view of the upper and lower portions of the second embodiment of an articulating contact pin, in an assembled condition, showing our design.

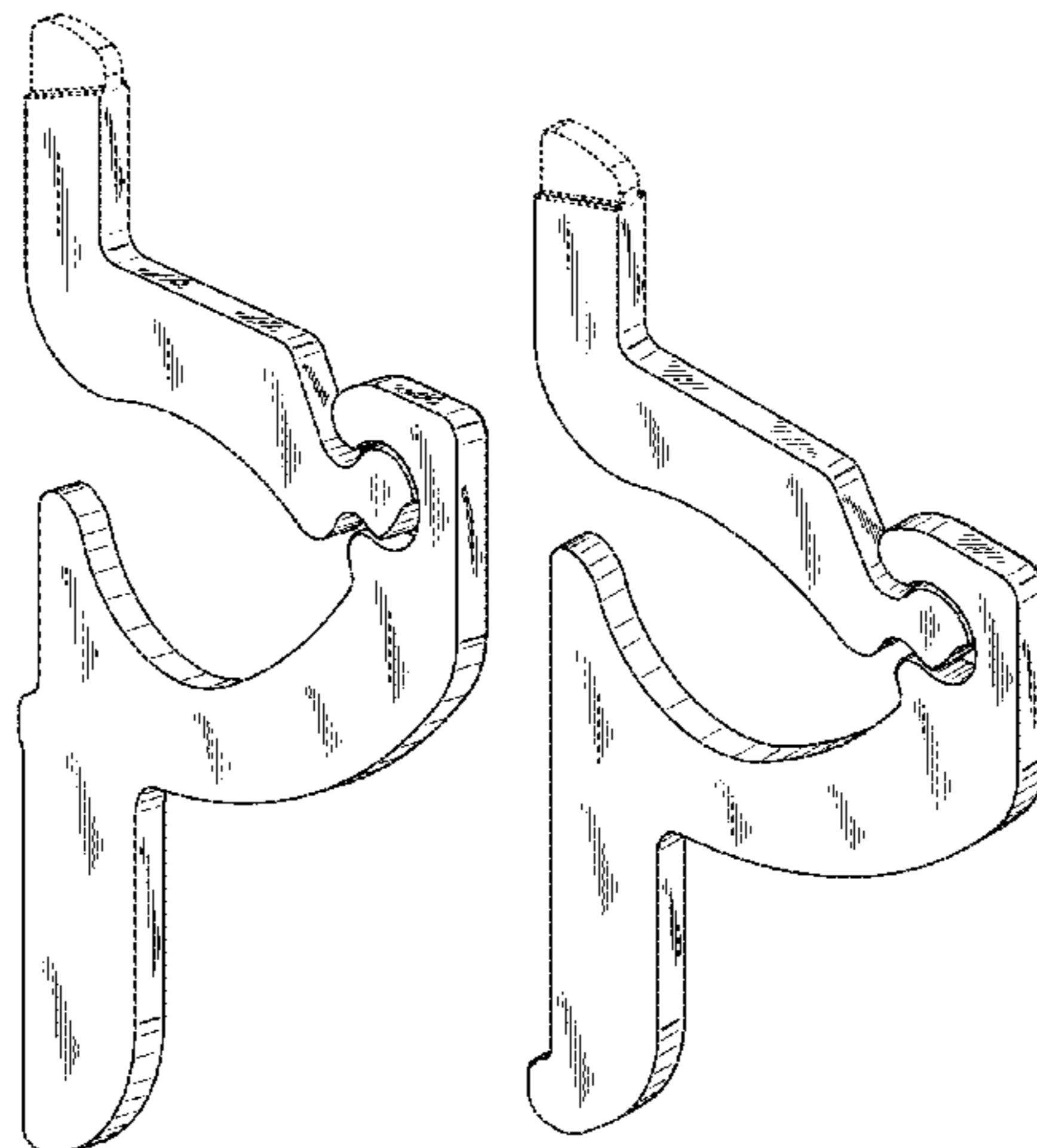


FIG. 26 is a rear perspective view thereof.

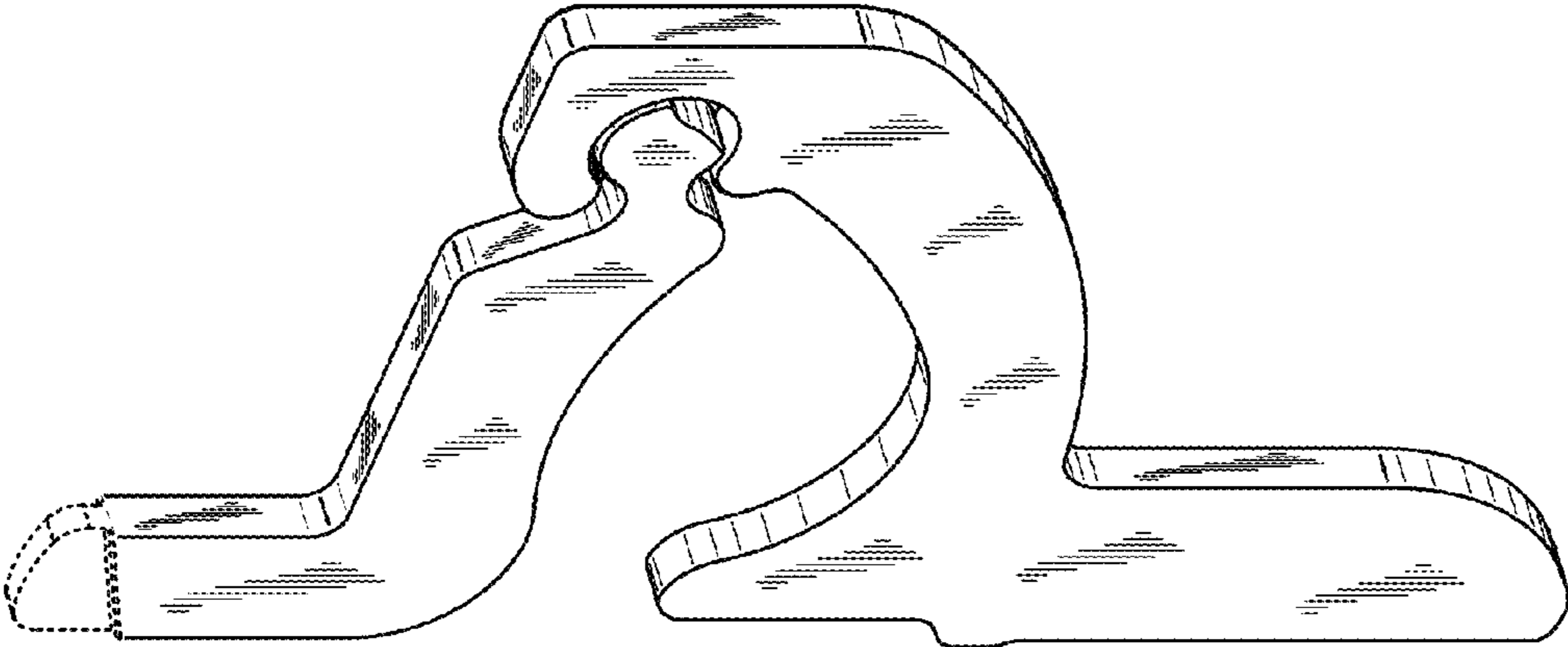

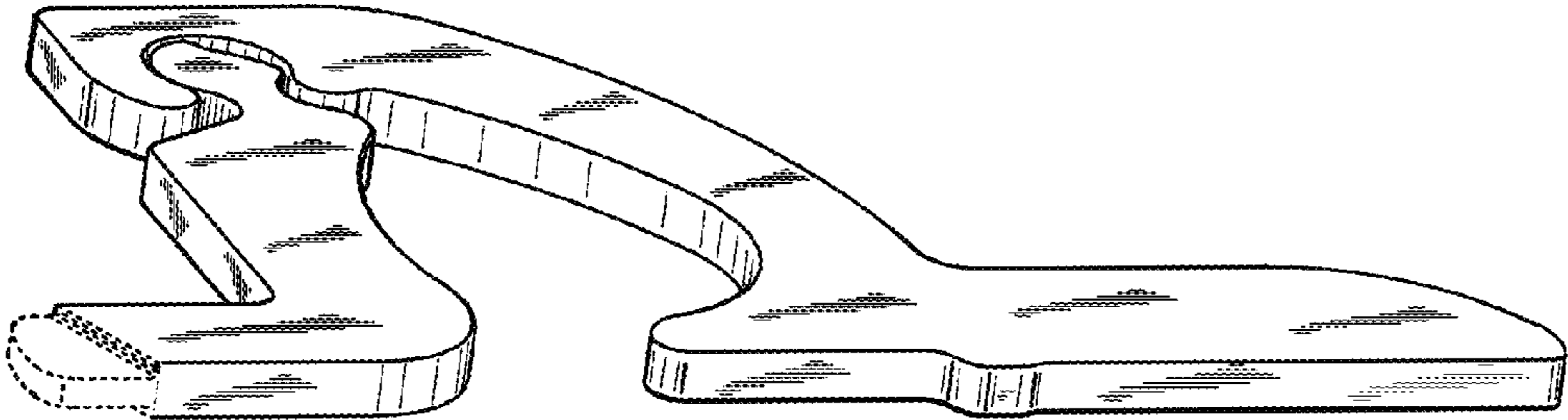

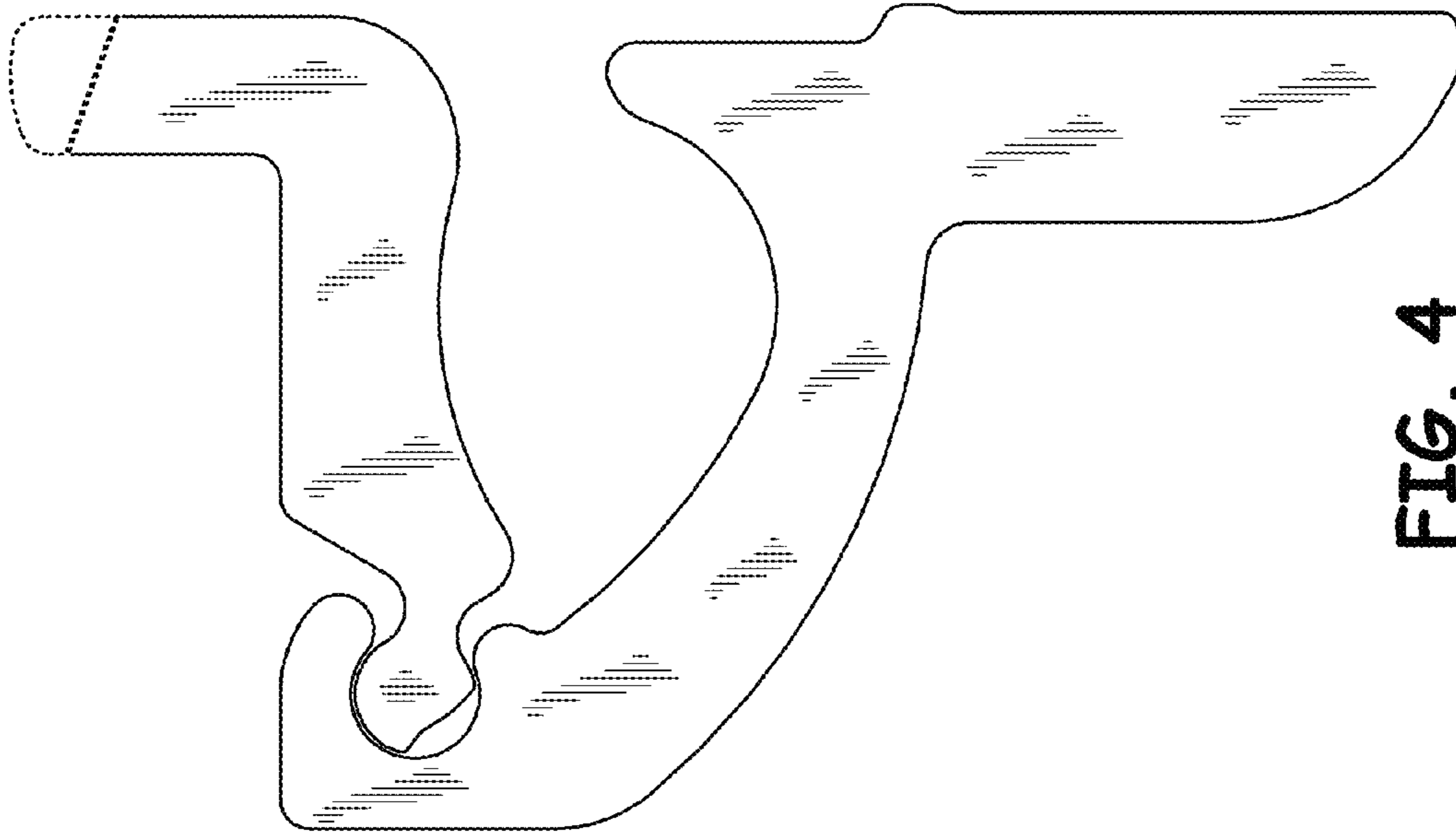

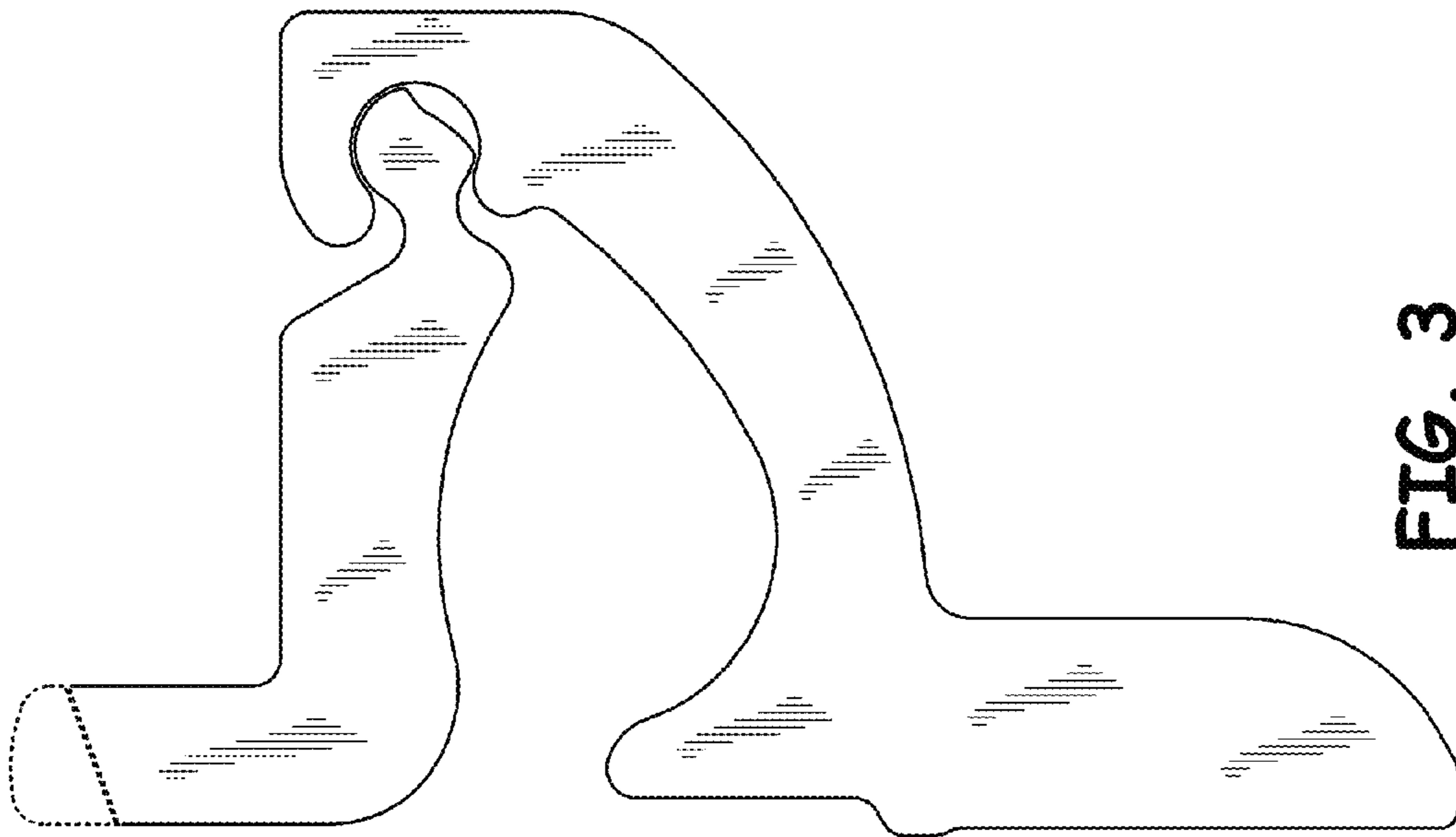

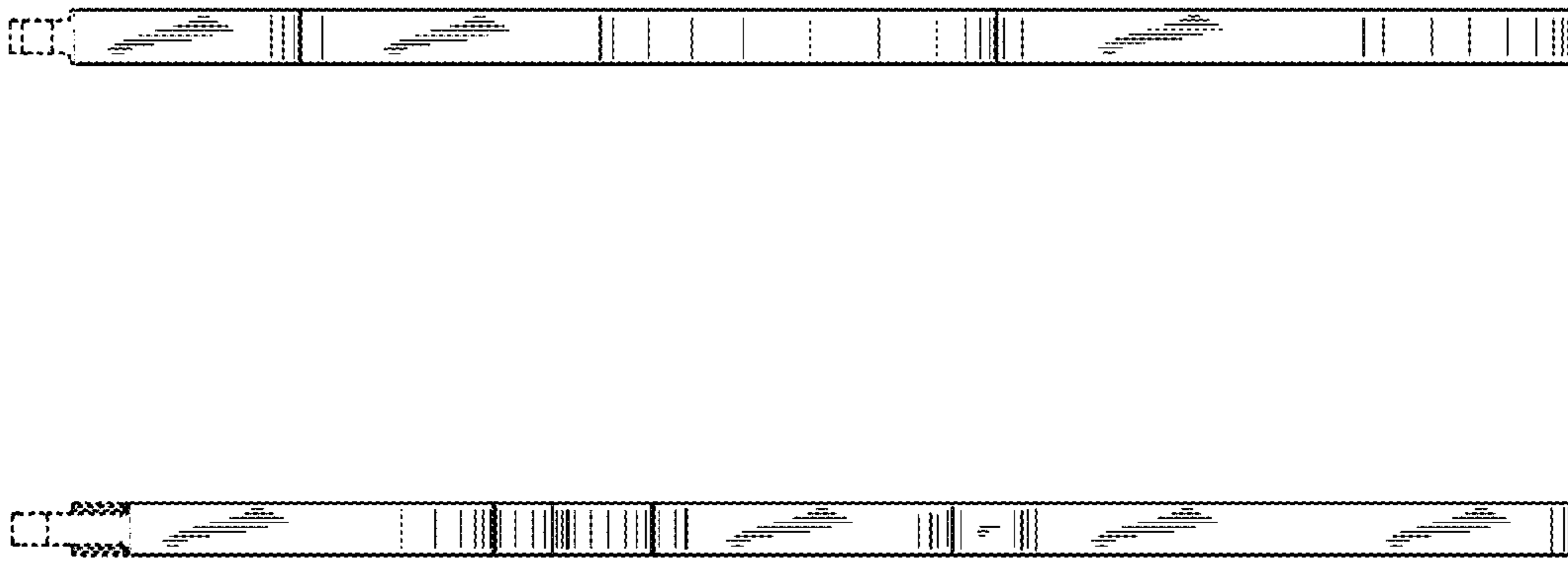


FIG. 5 FIG. 6

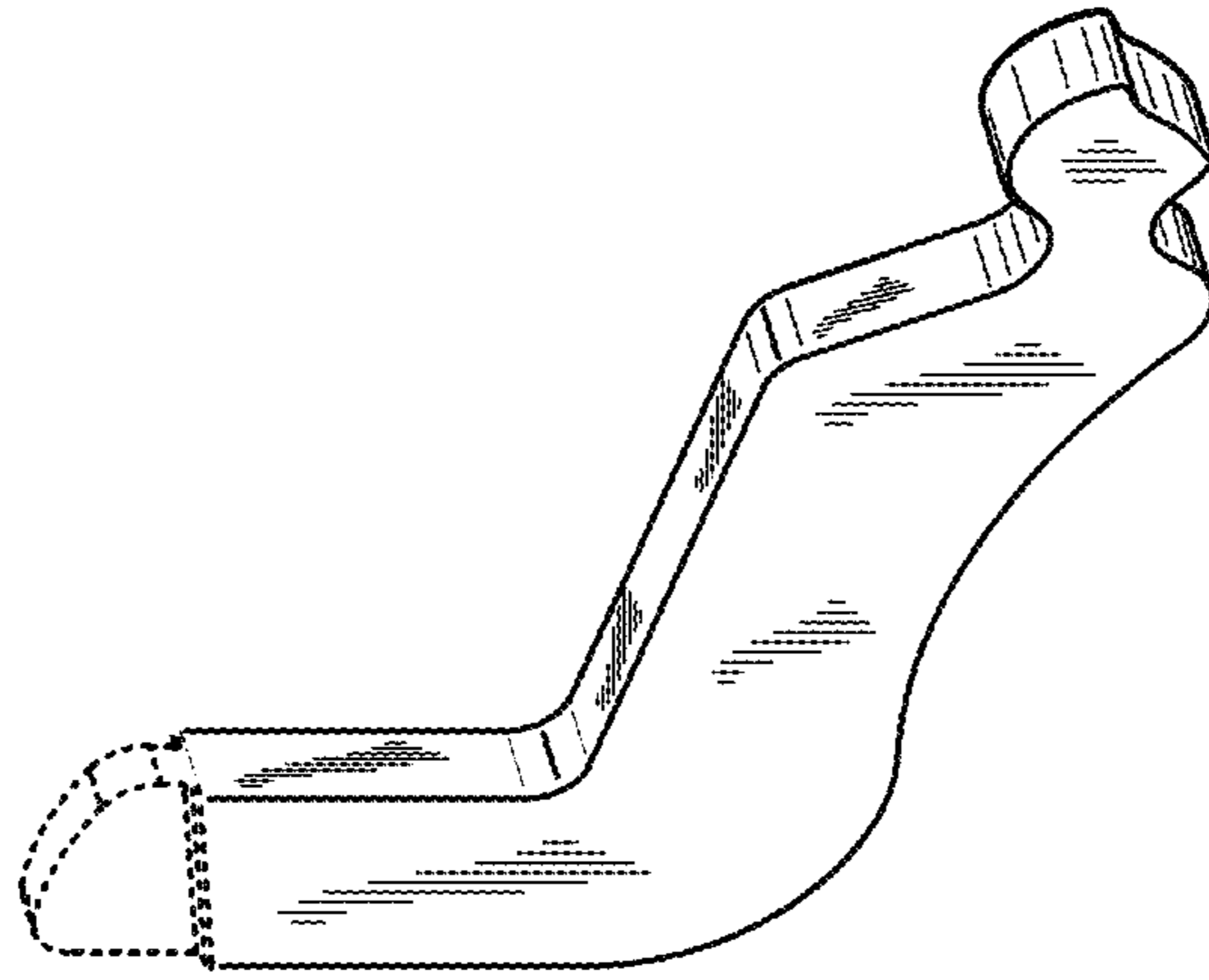

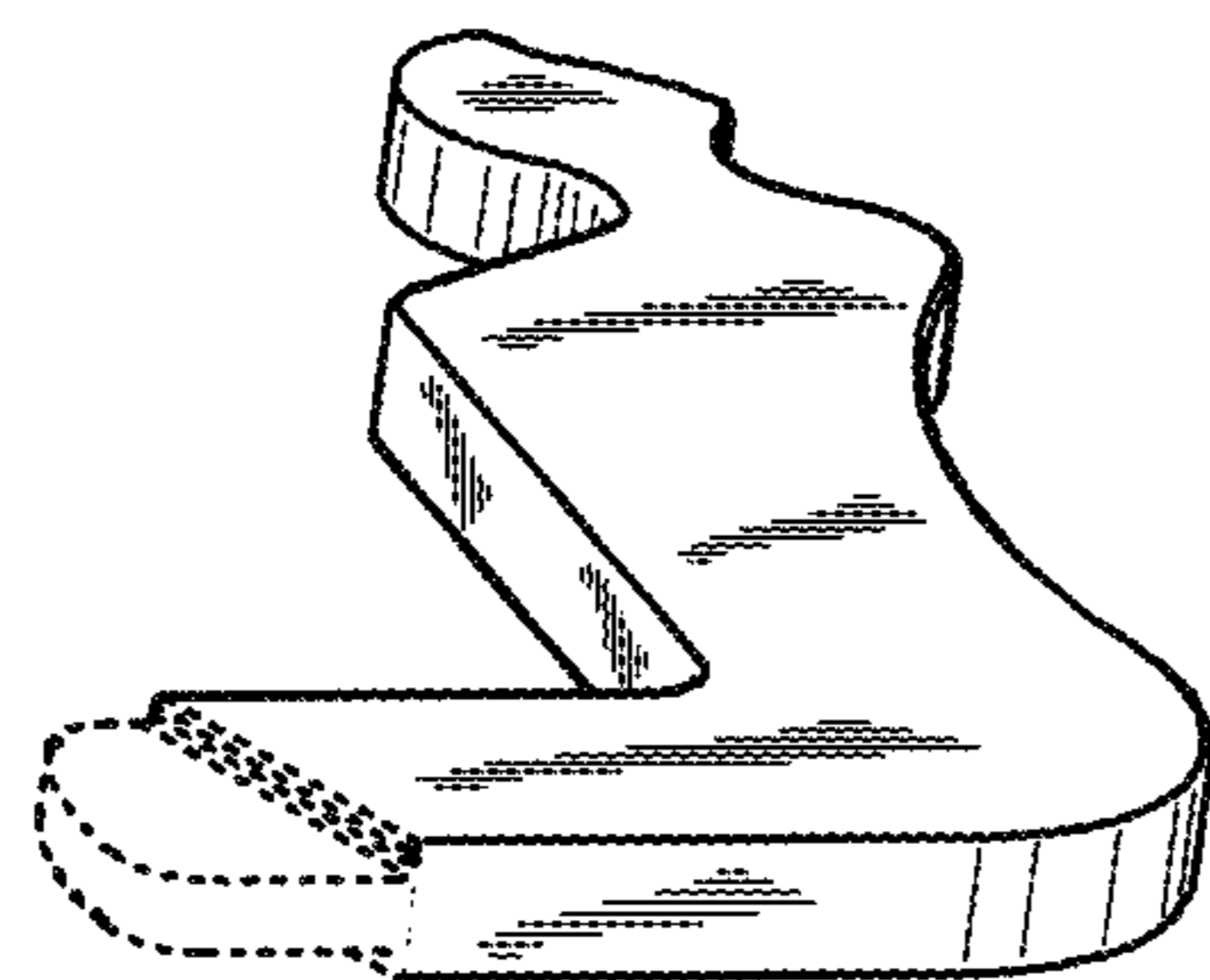

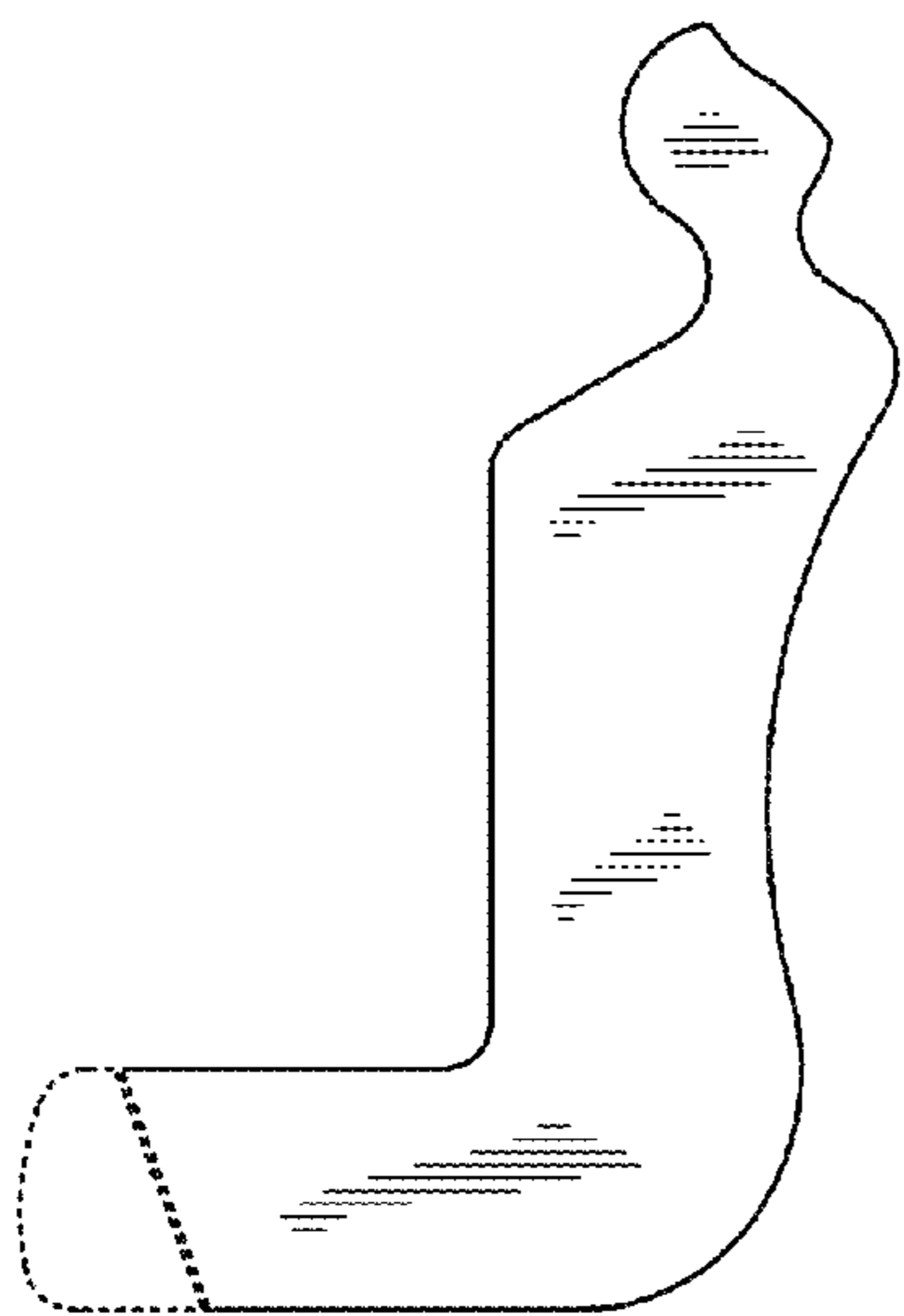

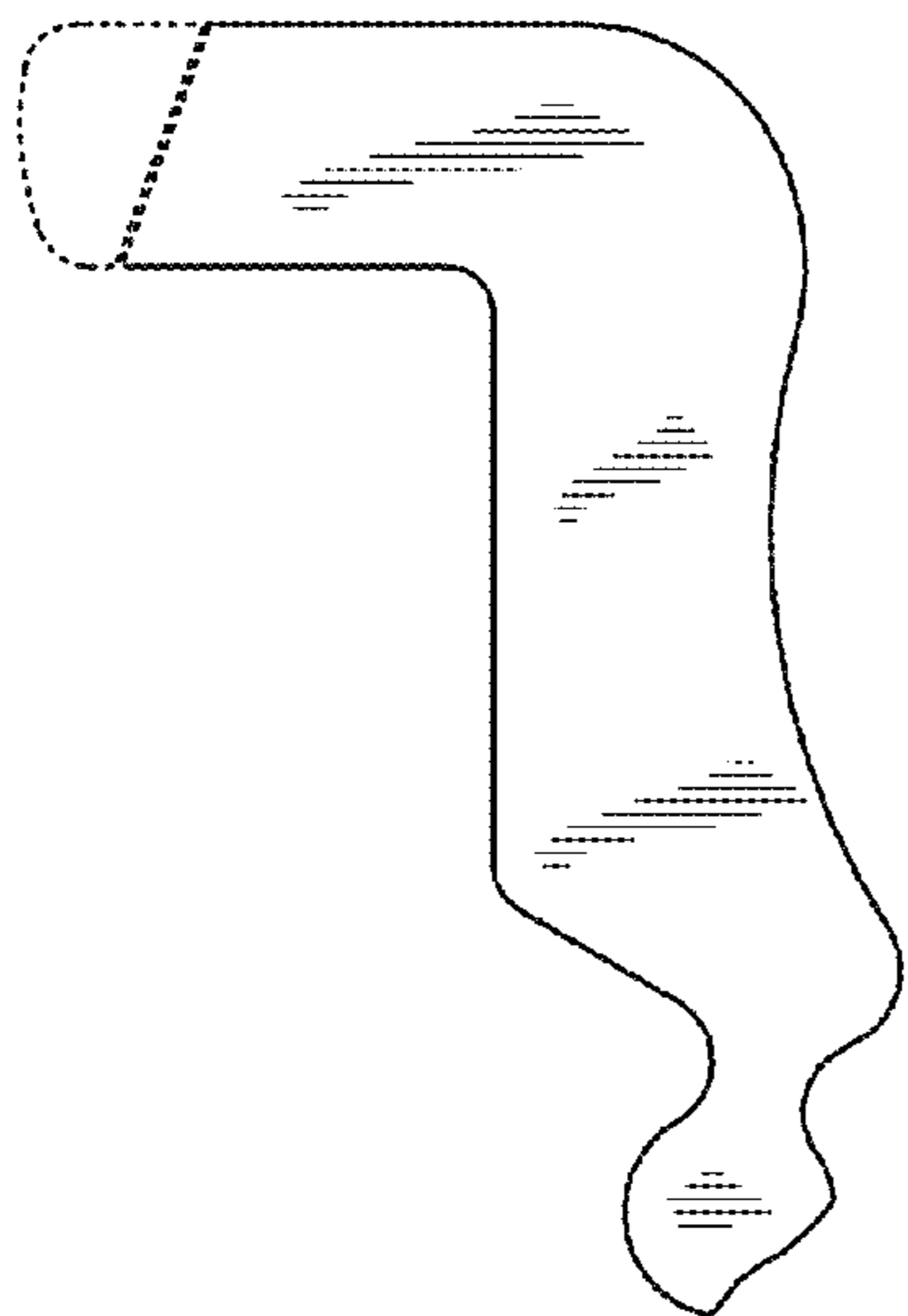

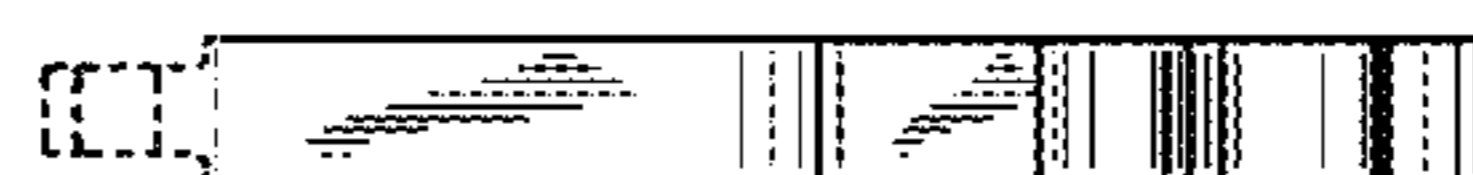

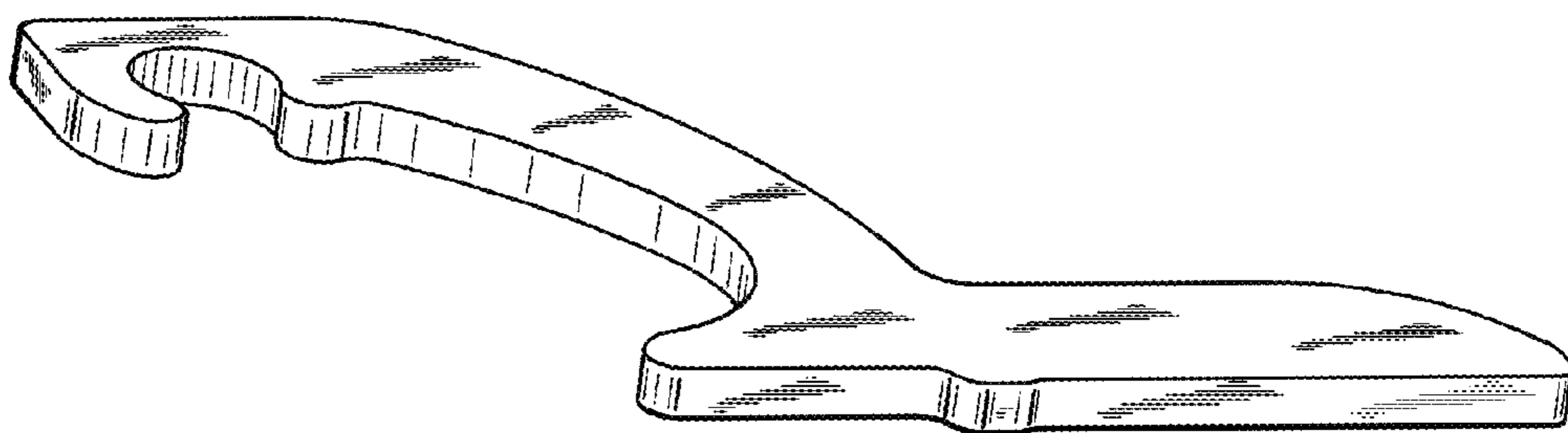

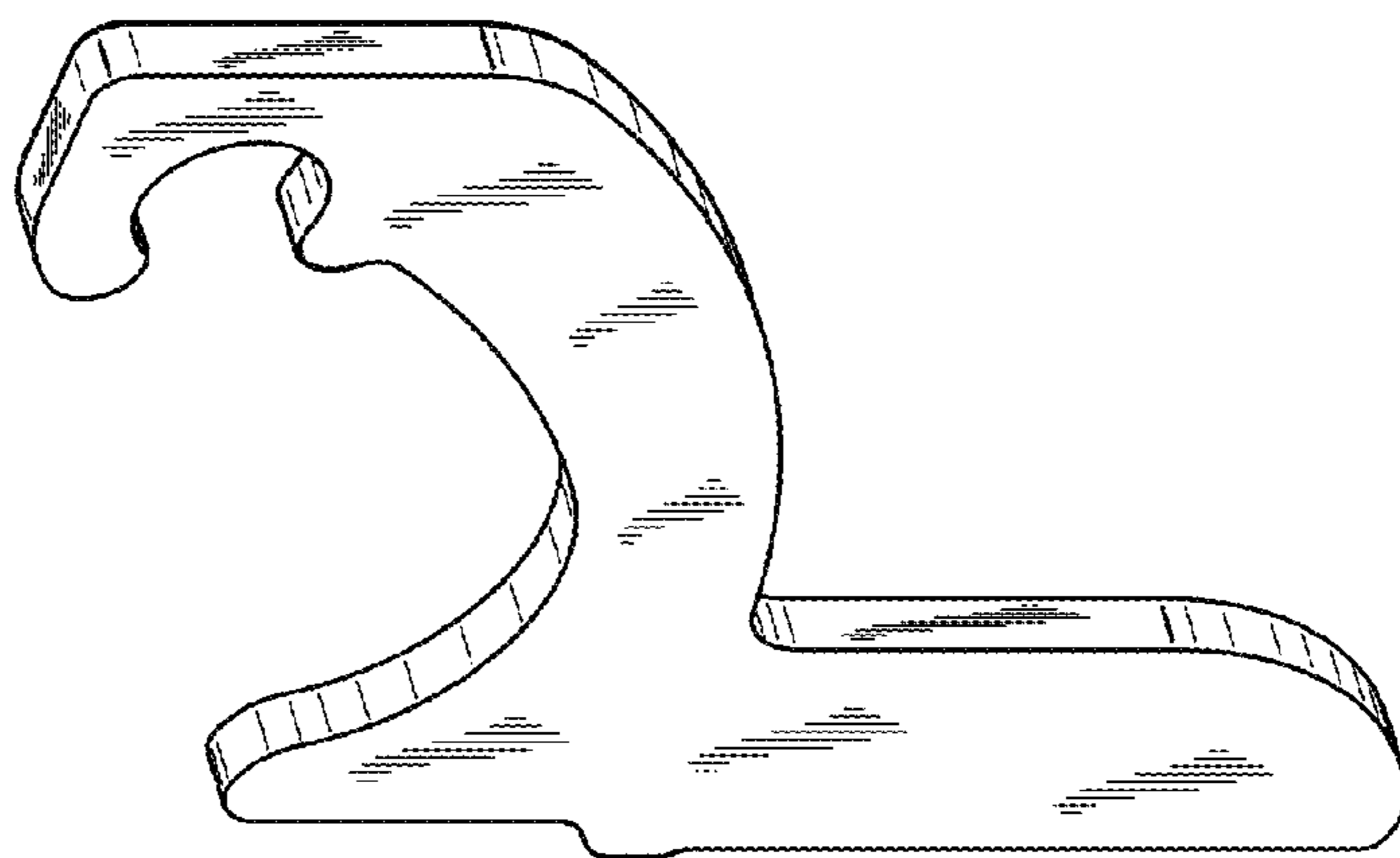

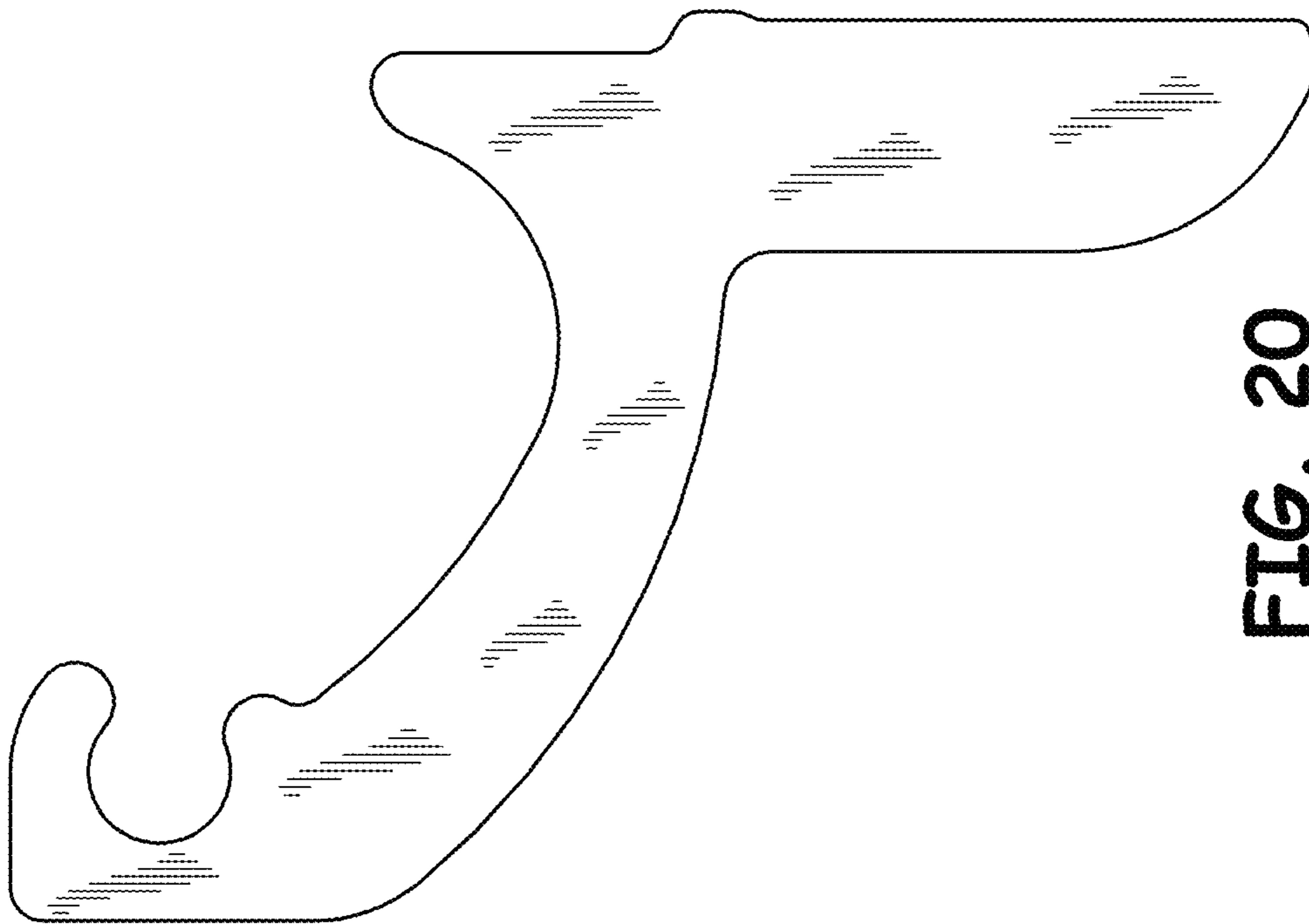

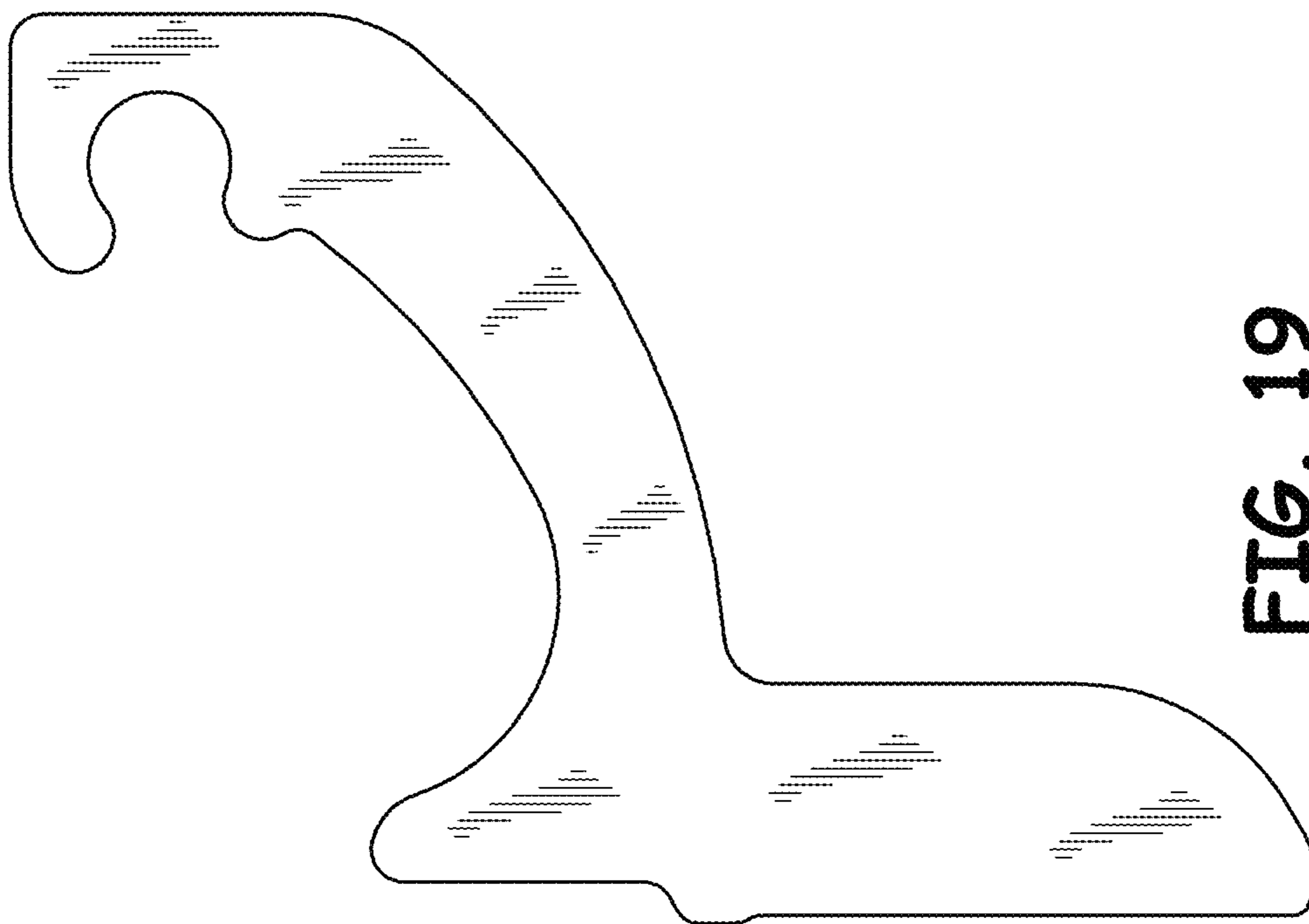

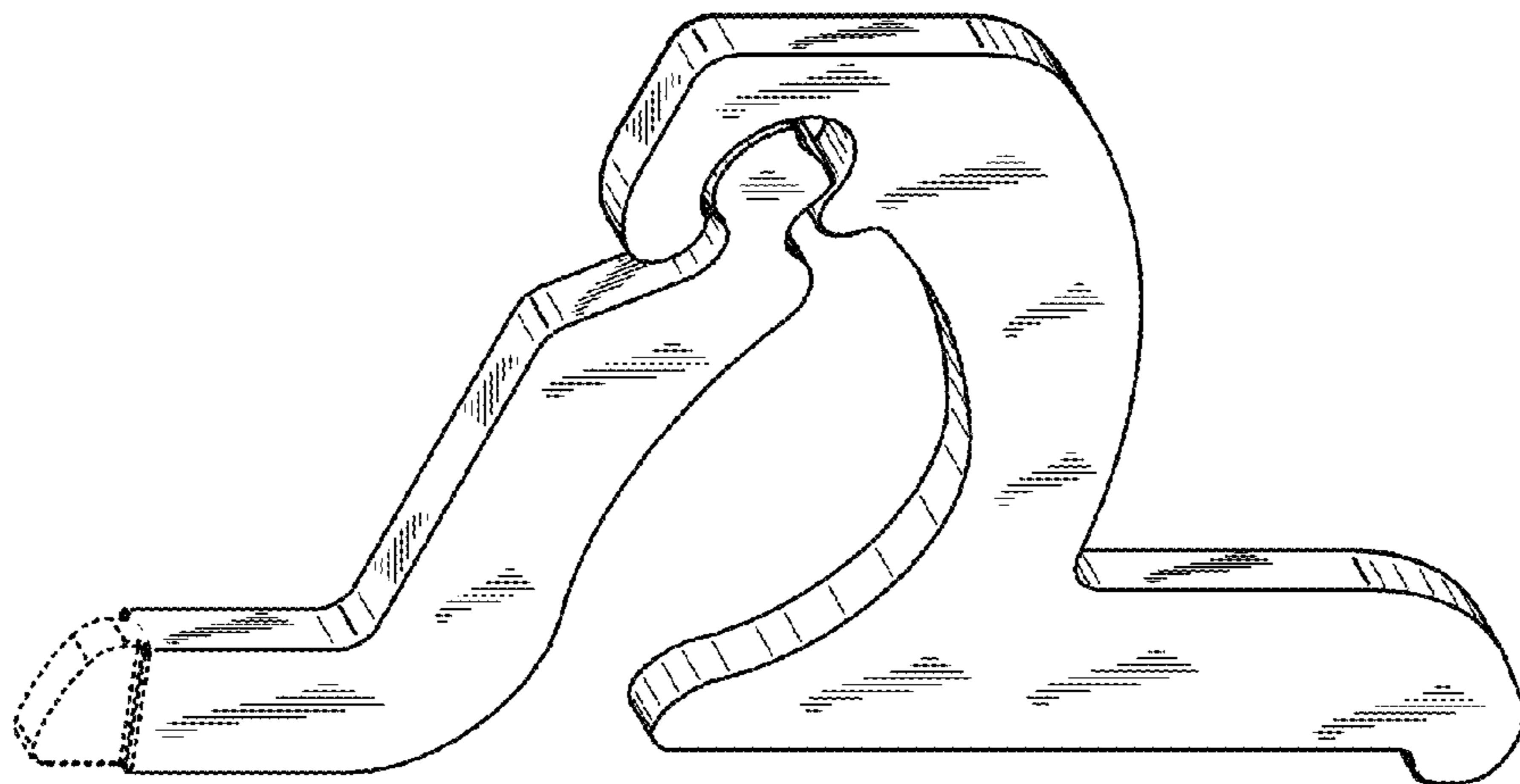

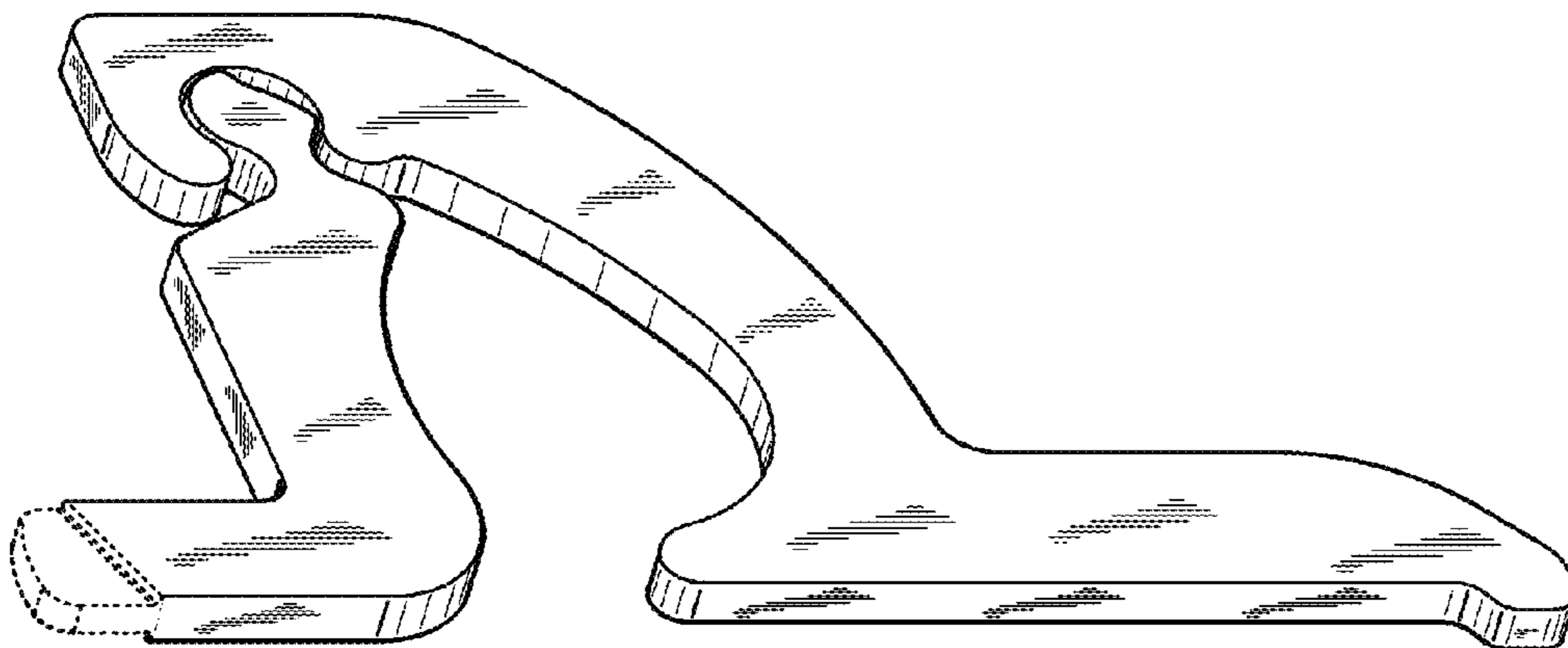

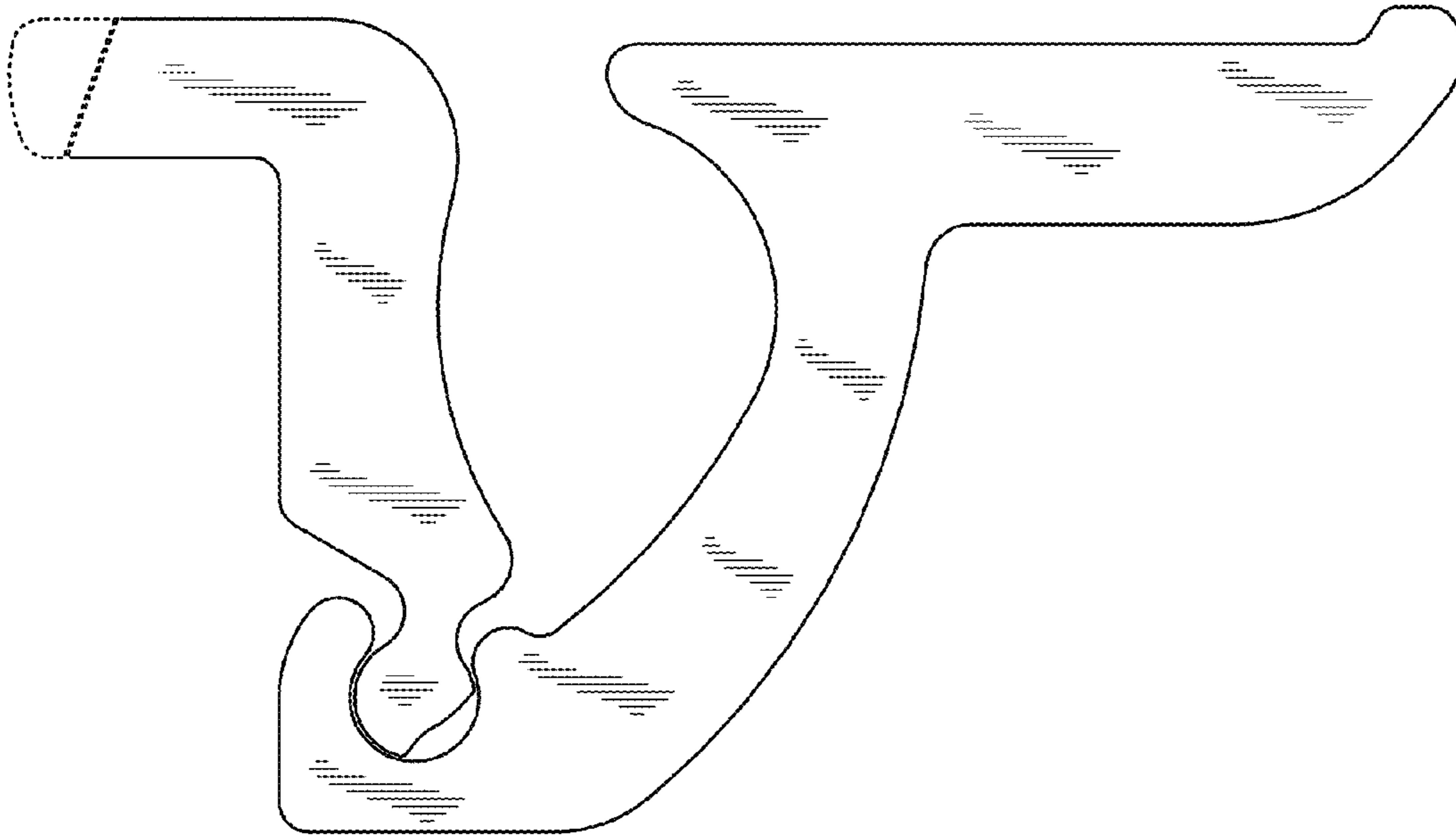

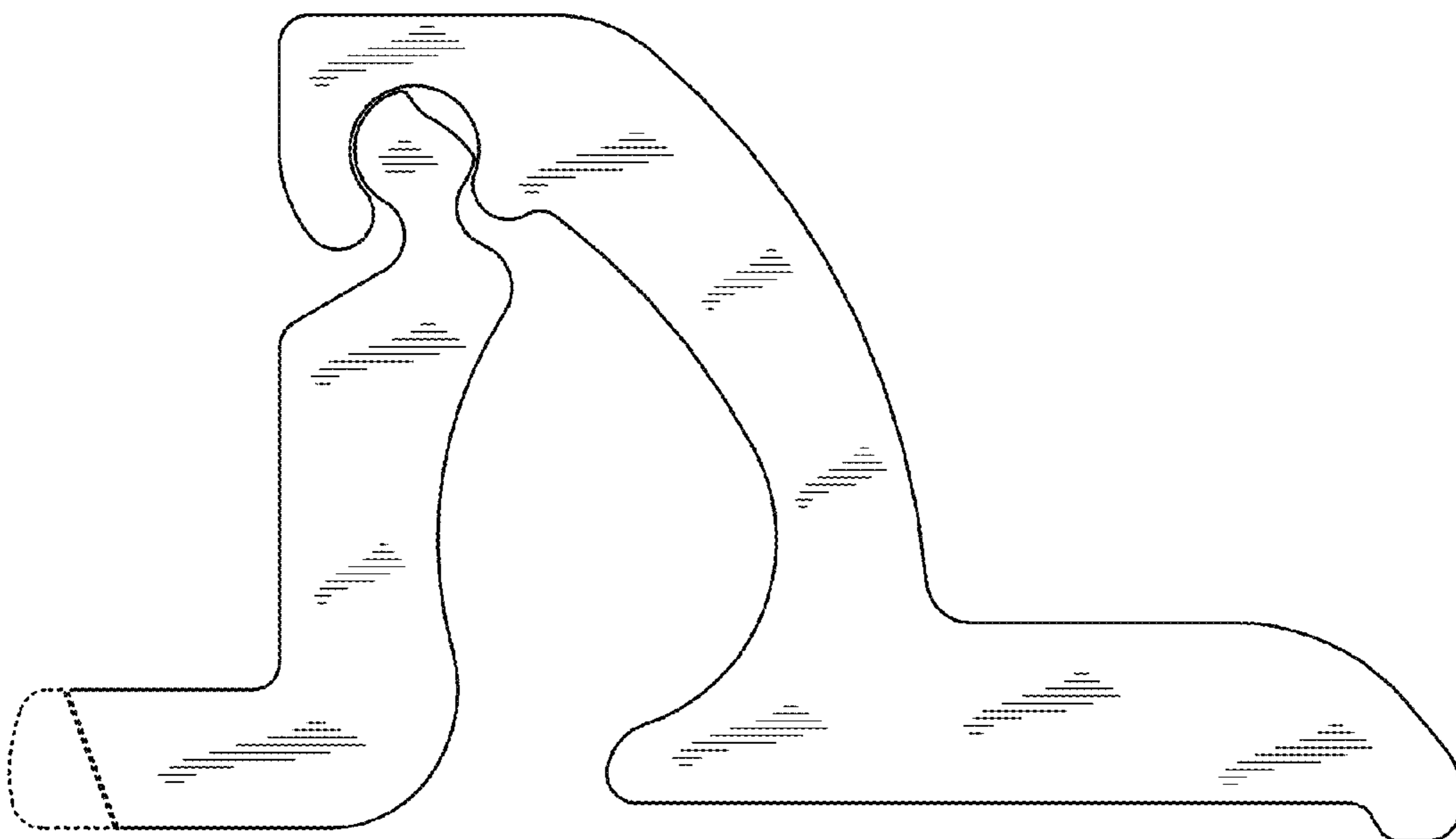

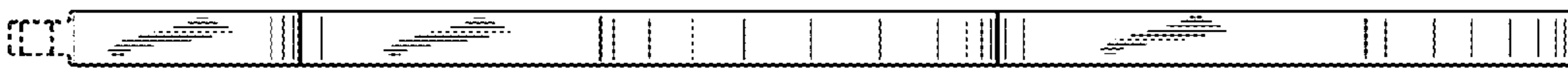

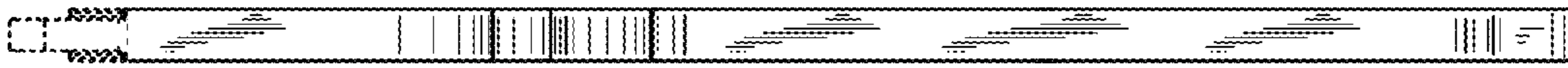

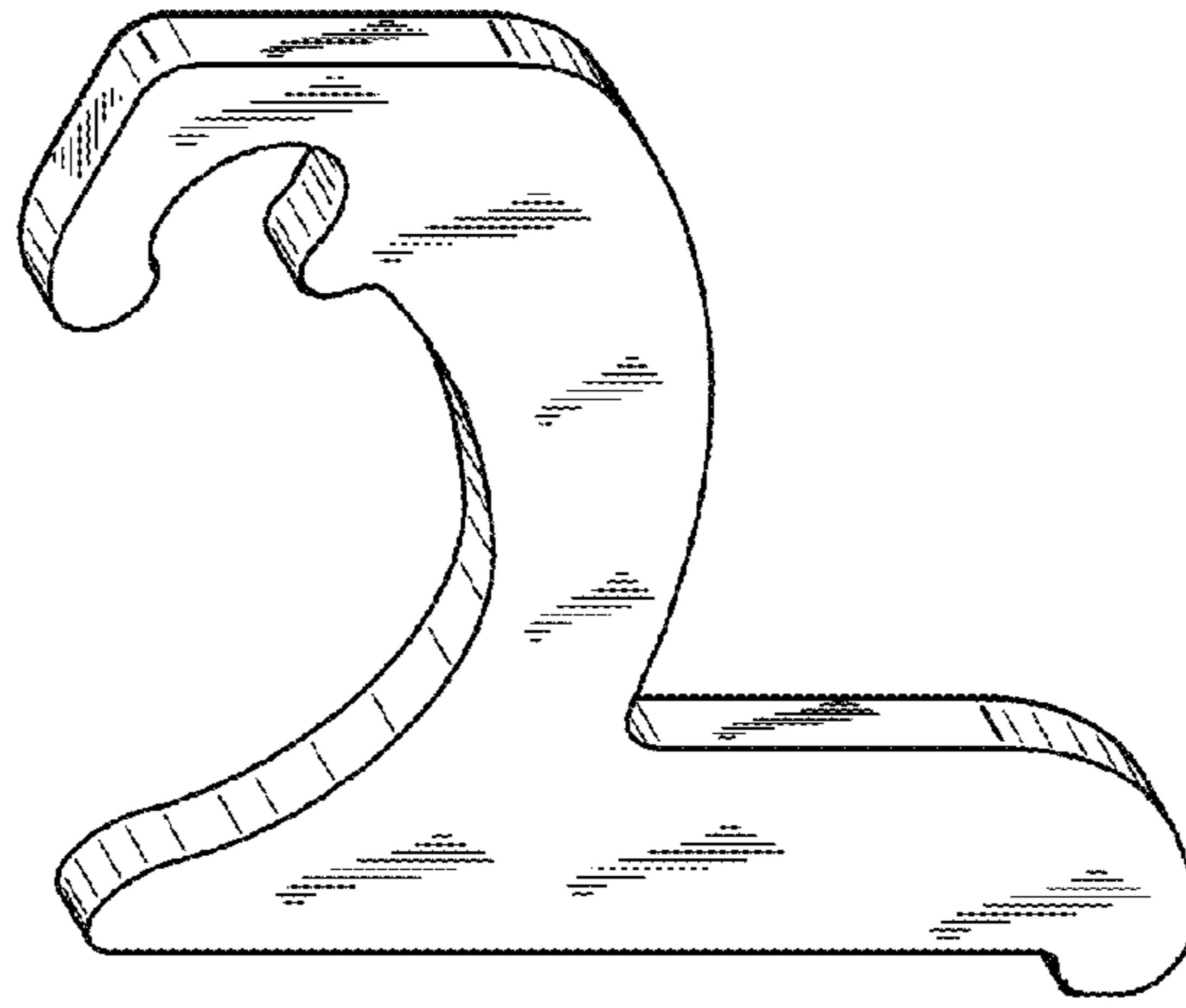

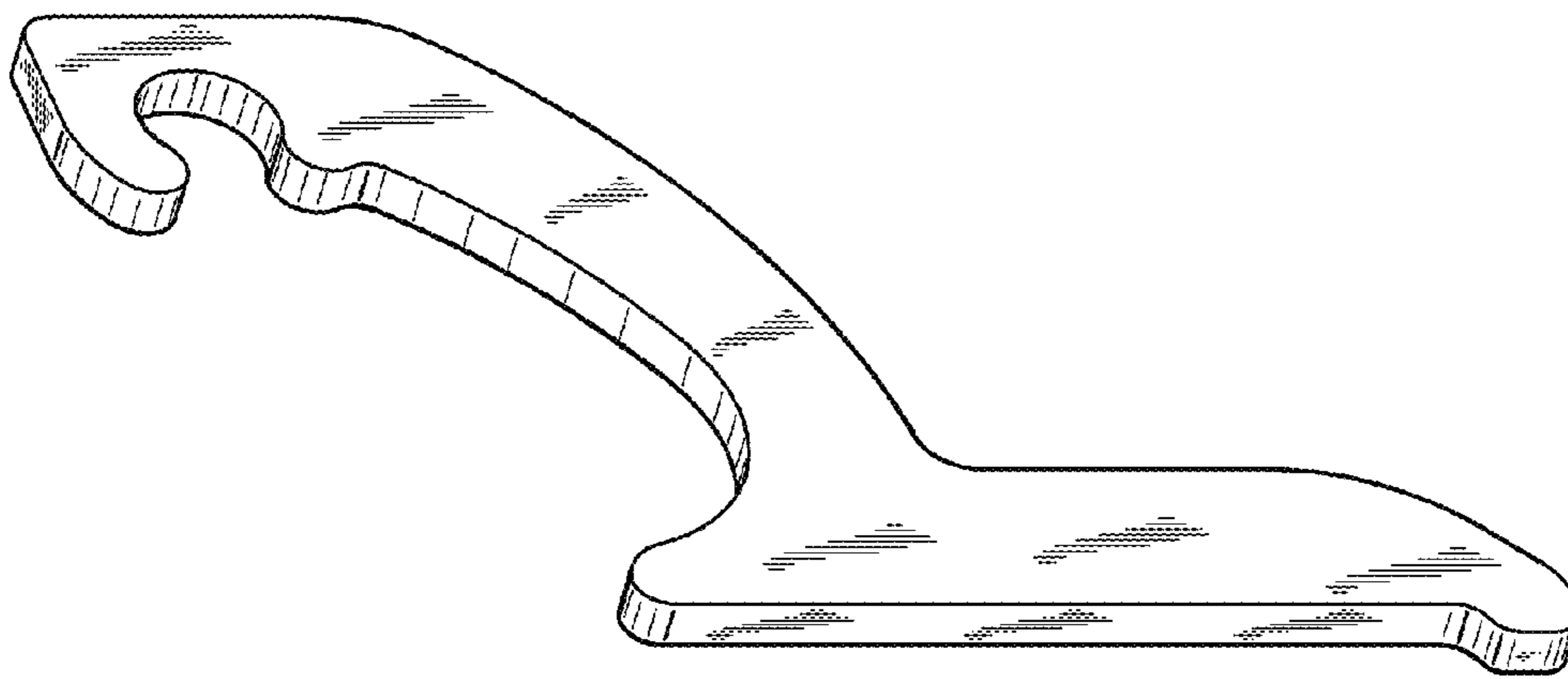

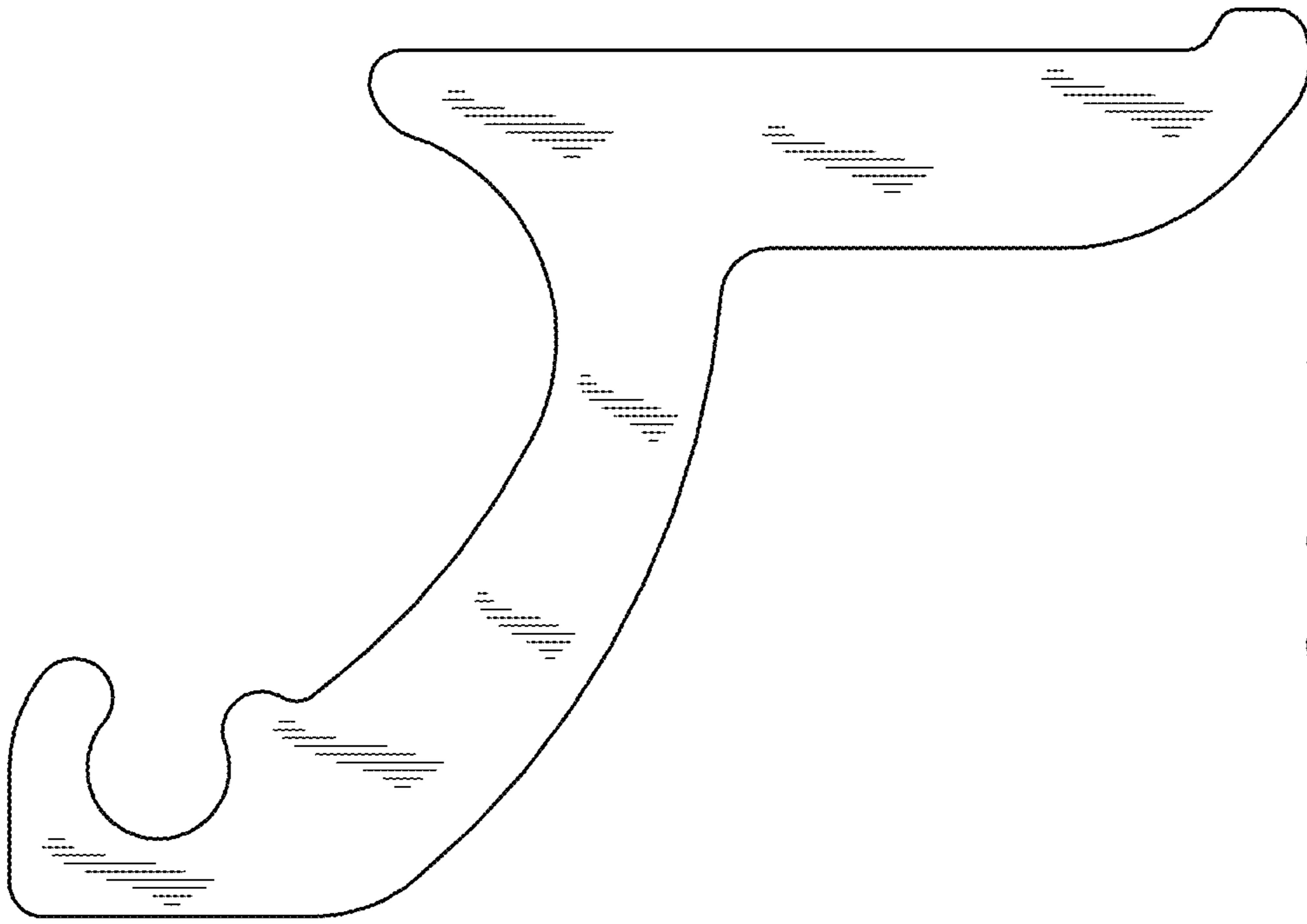

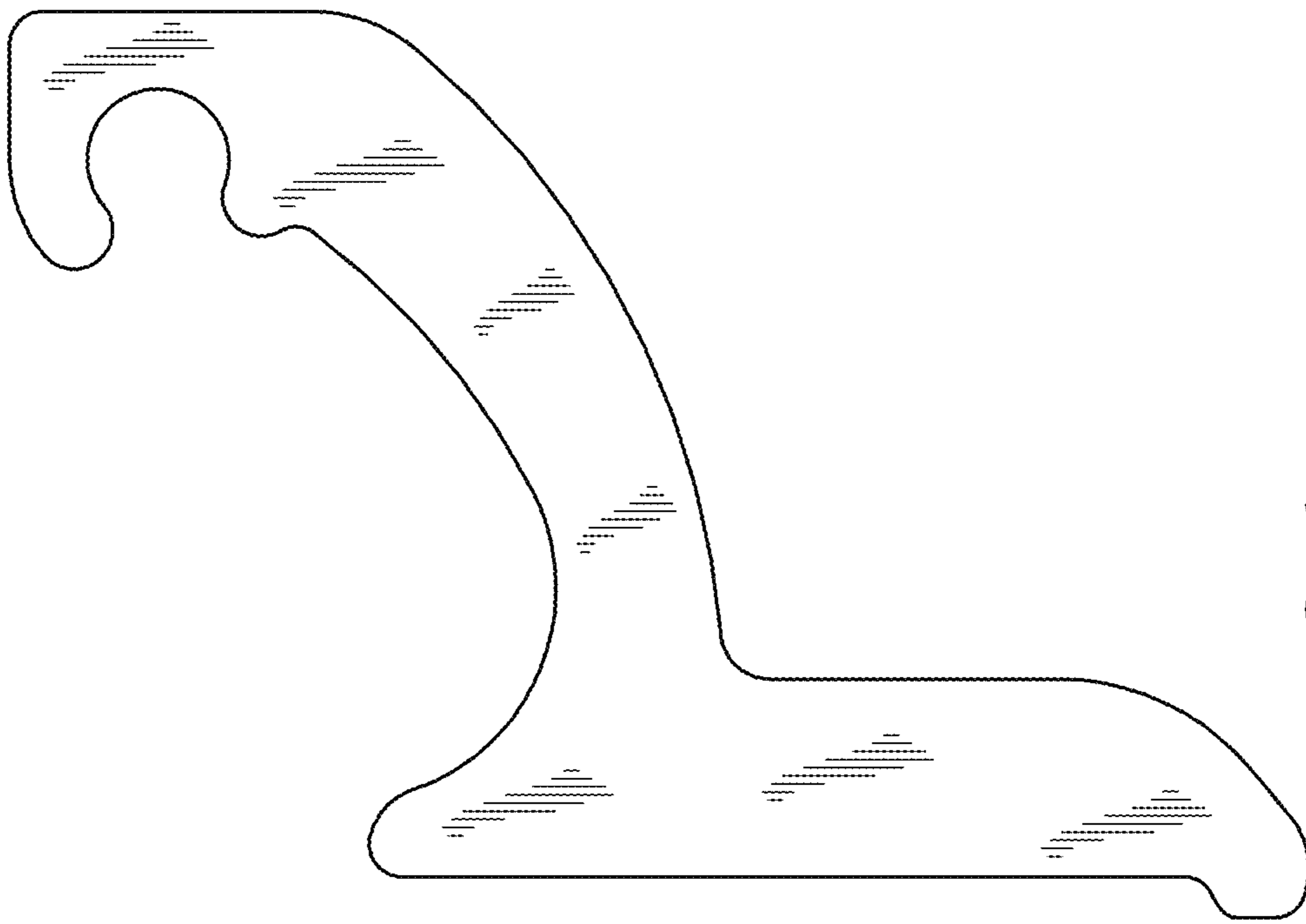

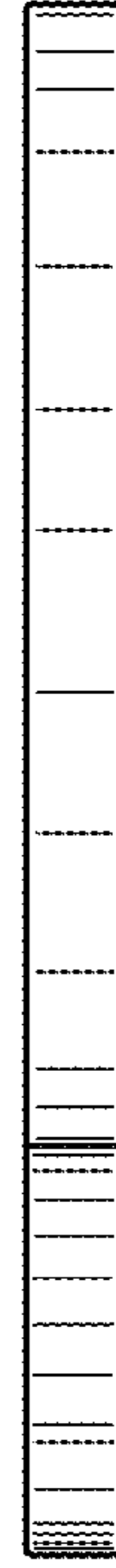

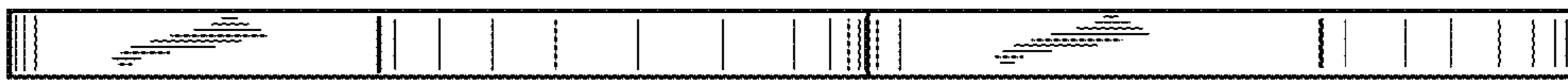


FIG. 37 FIG. 38
