The ornamental design for a cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of our design for a cover; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; and, FIG. 8 is an enlarged front partial view taken from an indicated portion of FIG. 1. The additional surface shading shown in FIG. 8 and not shown in the other views is shown for ease of illustration.

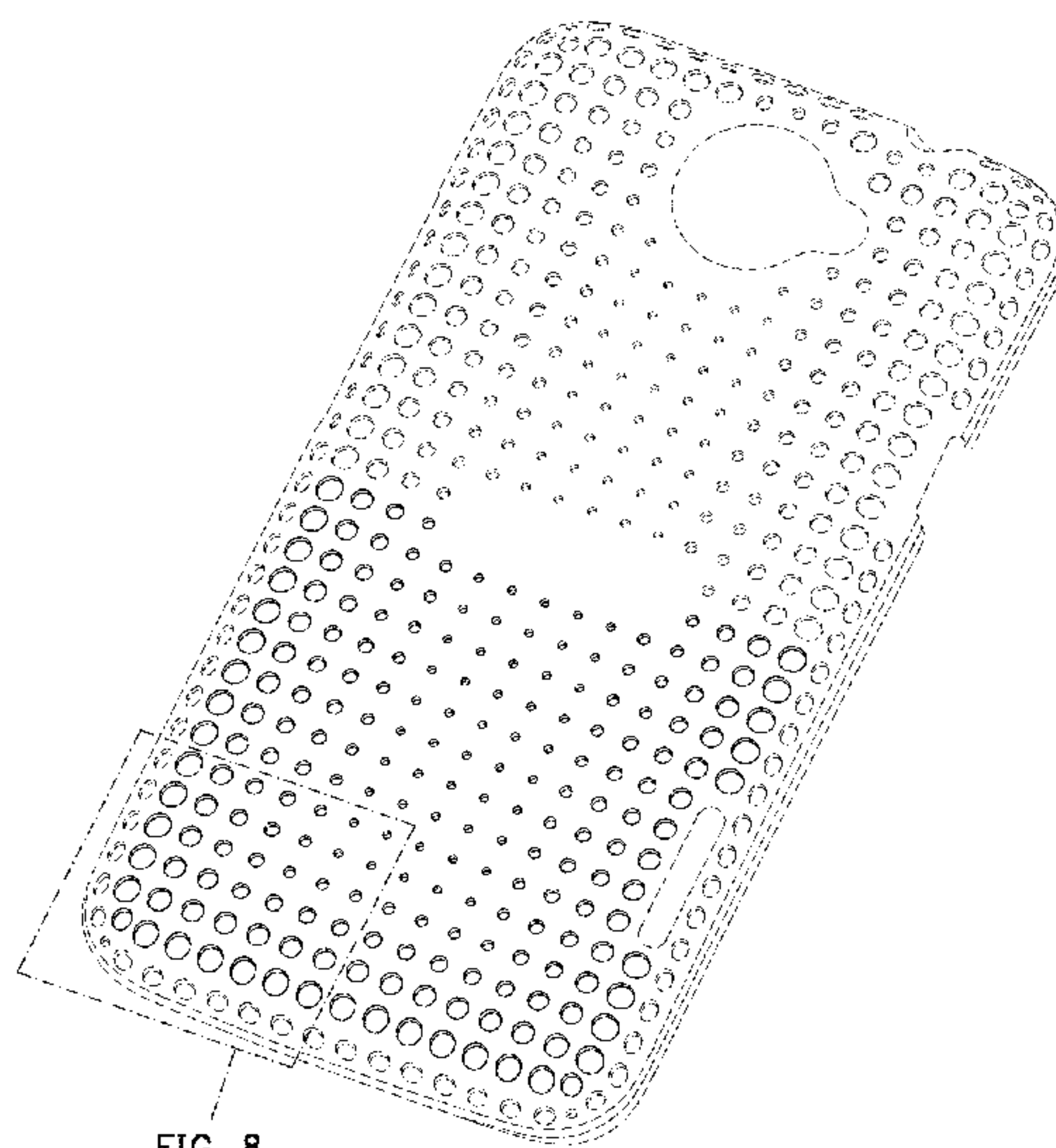

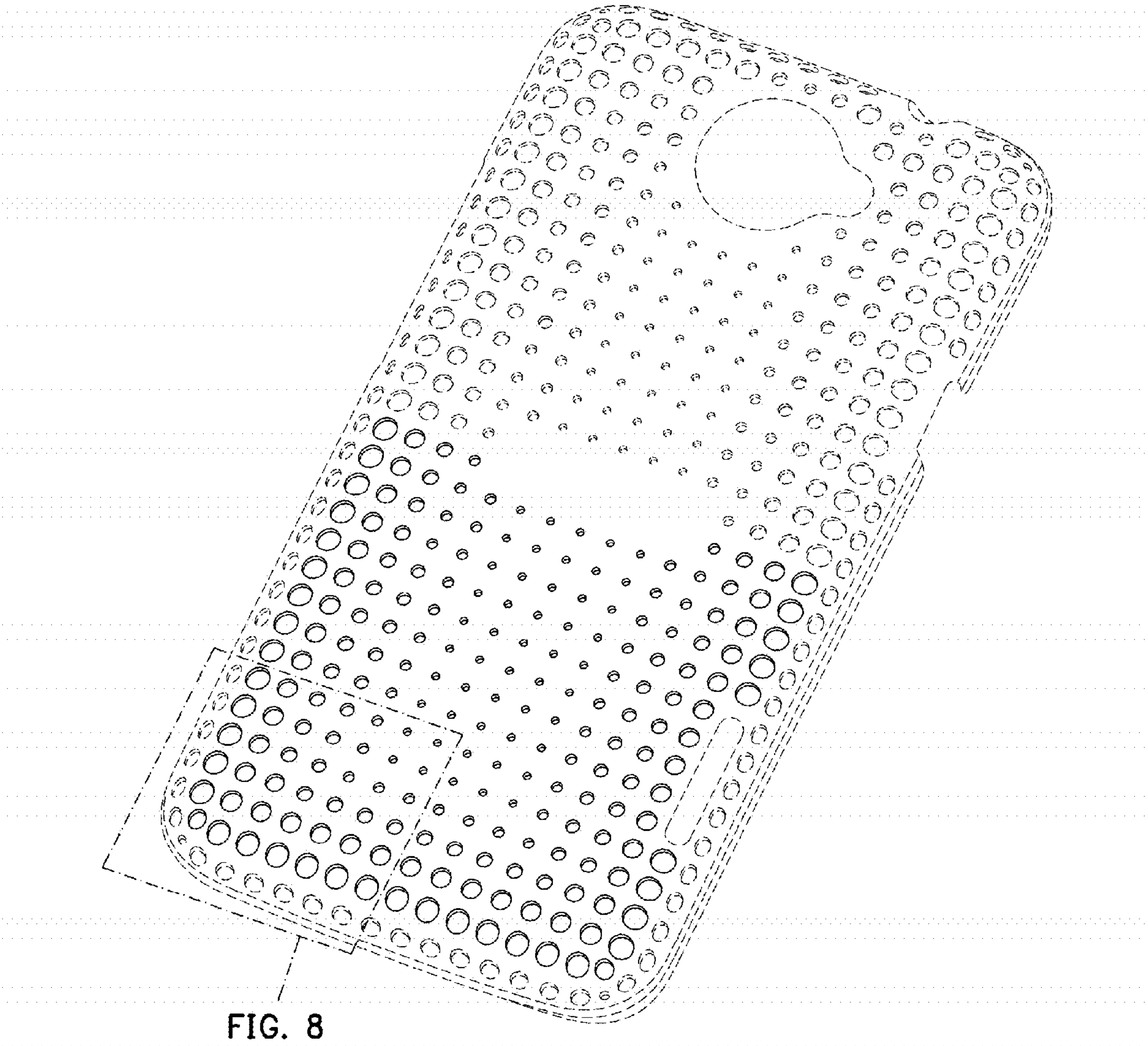

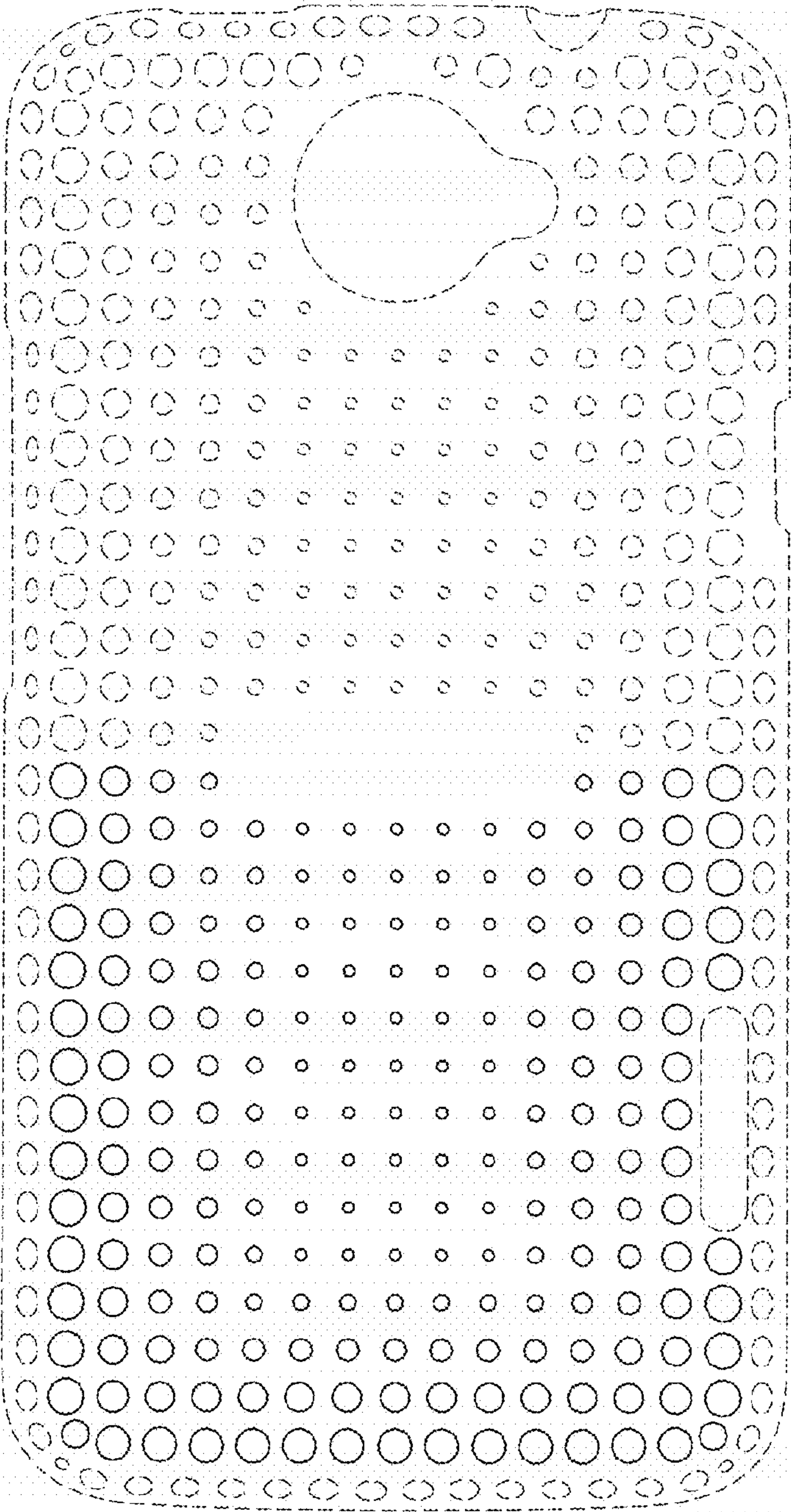

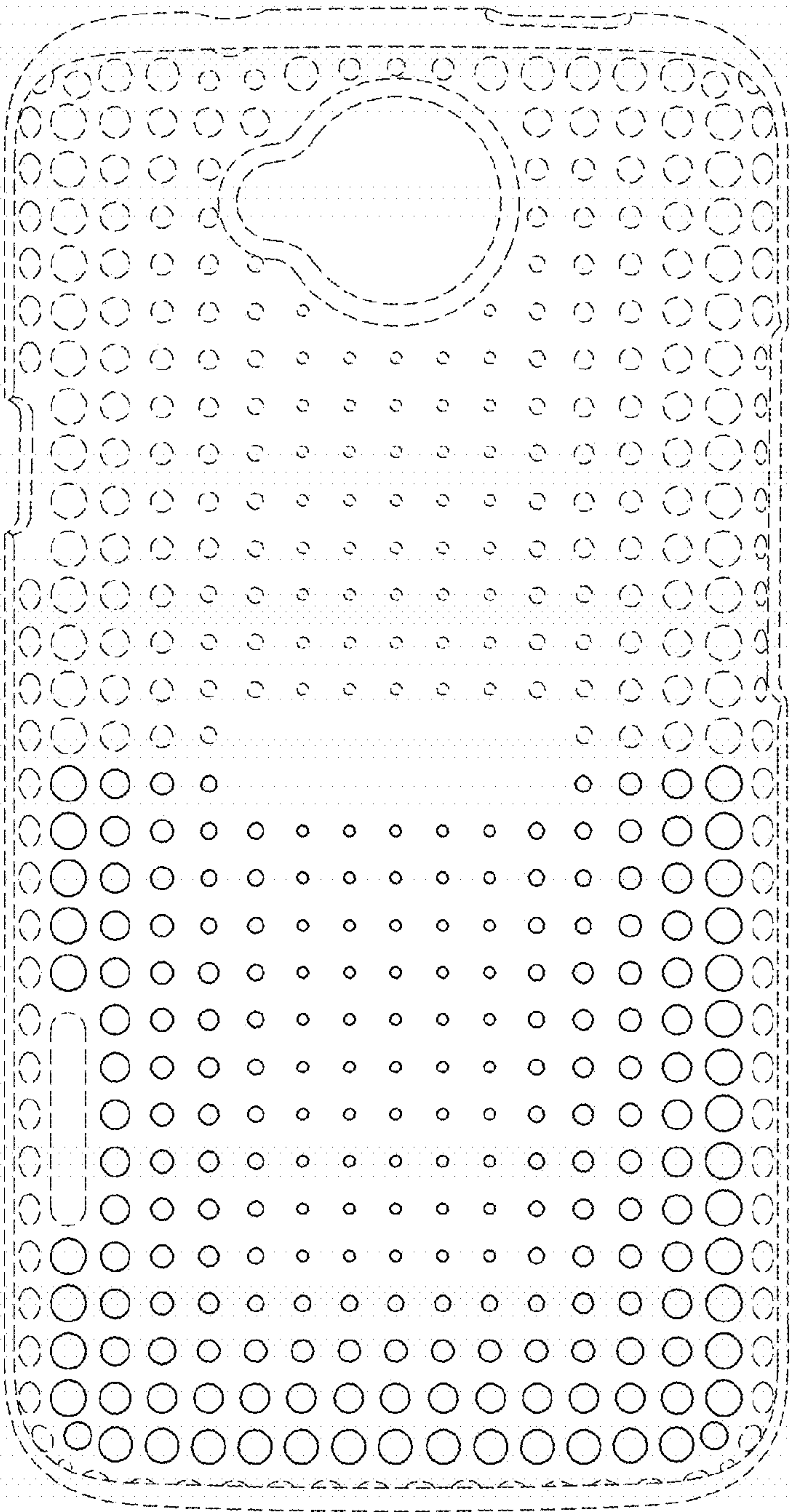

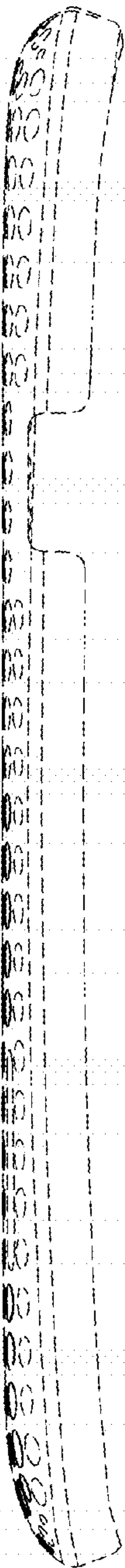

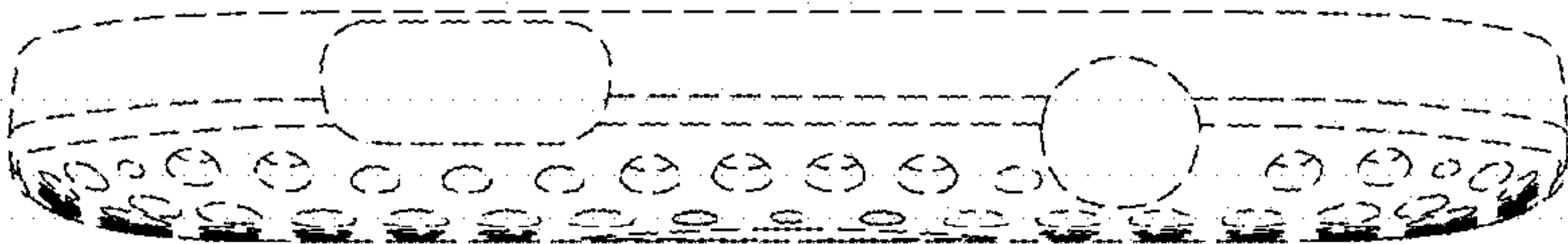

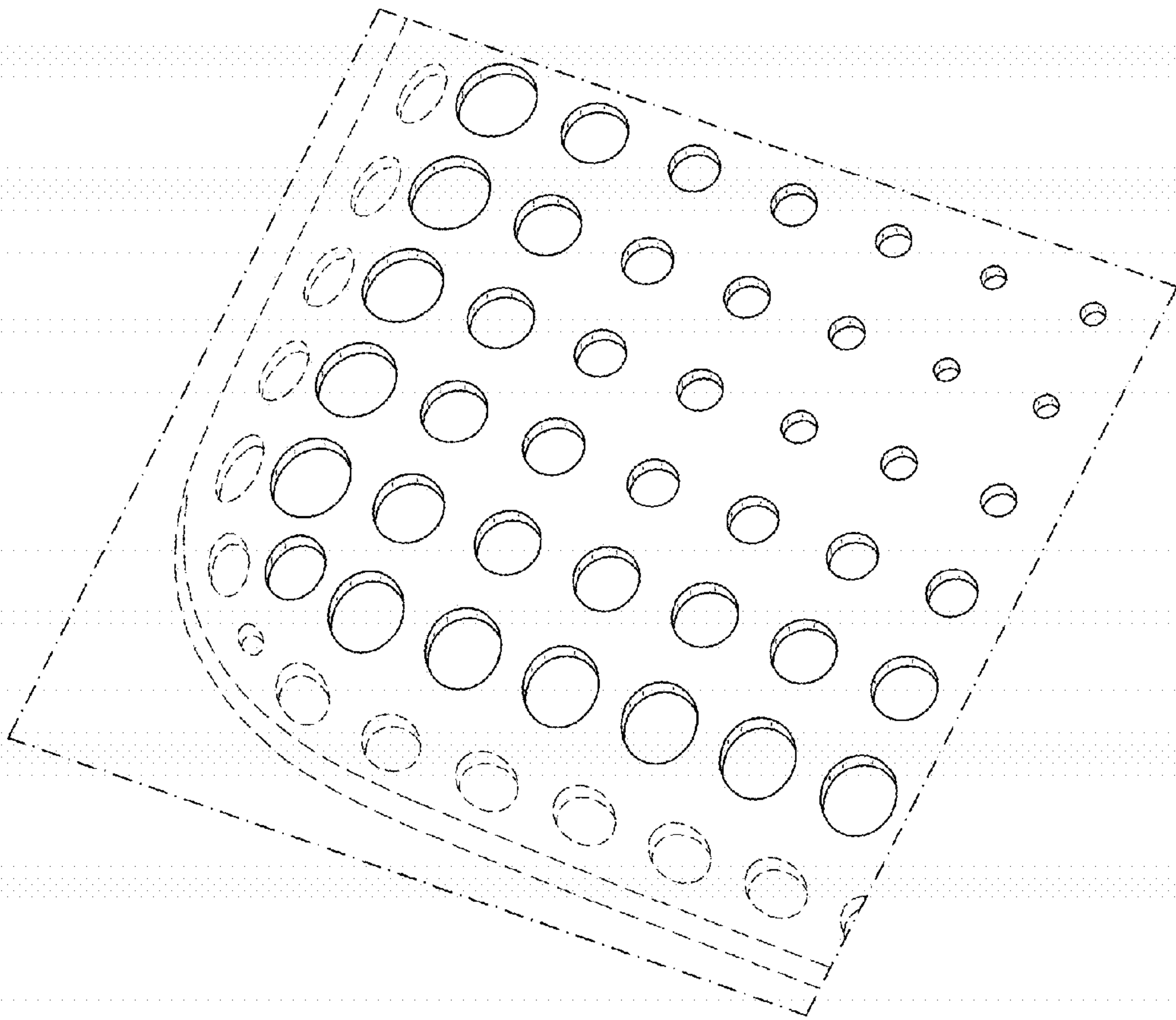
