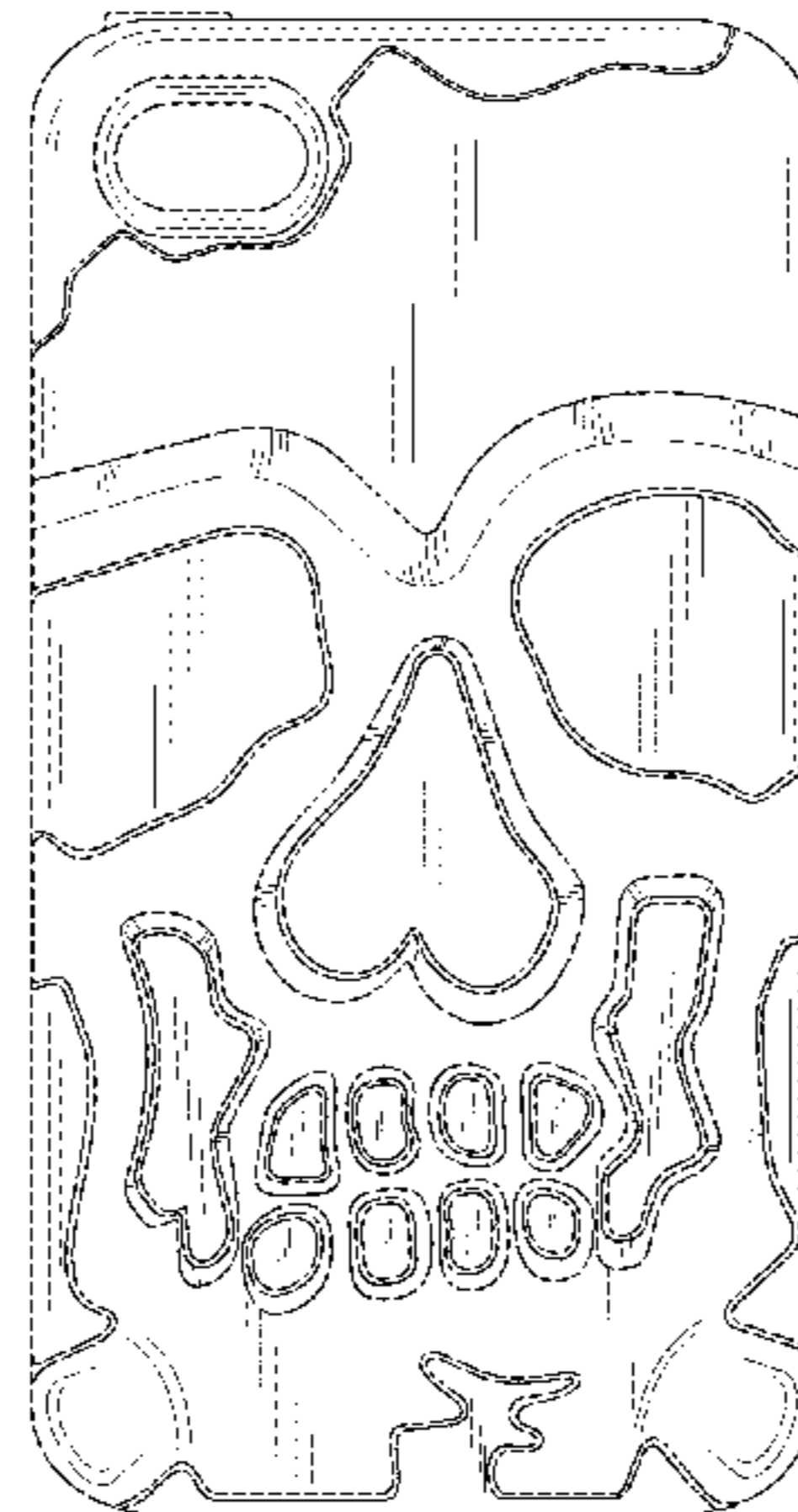
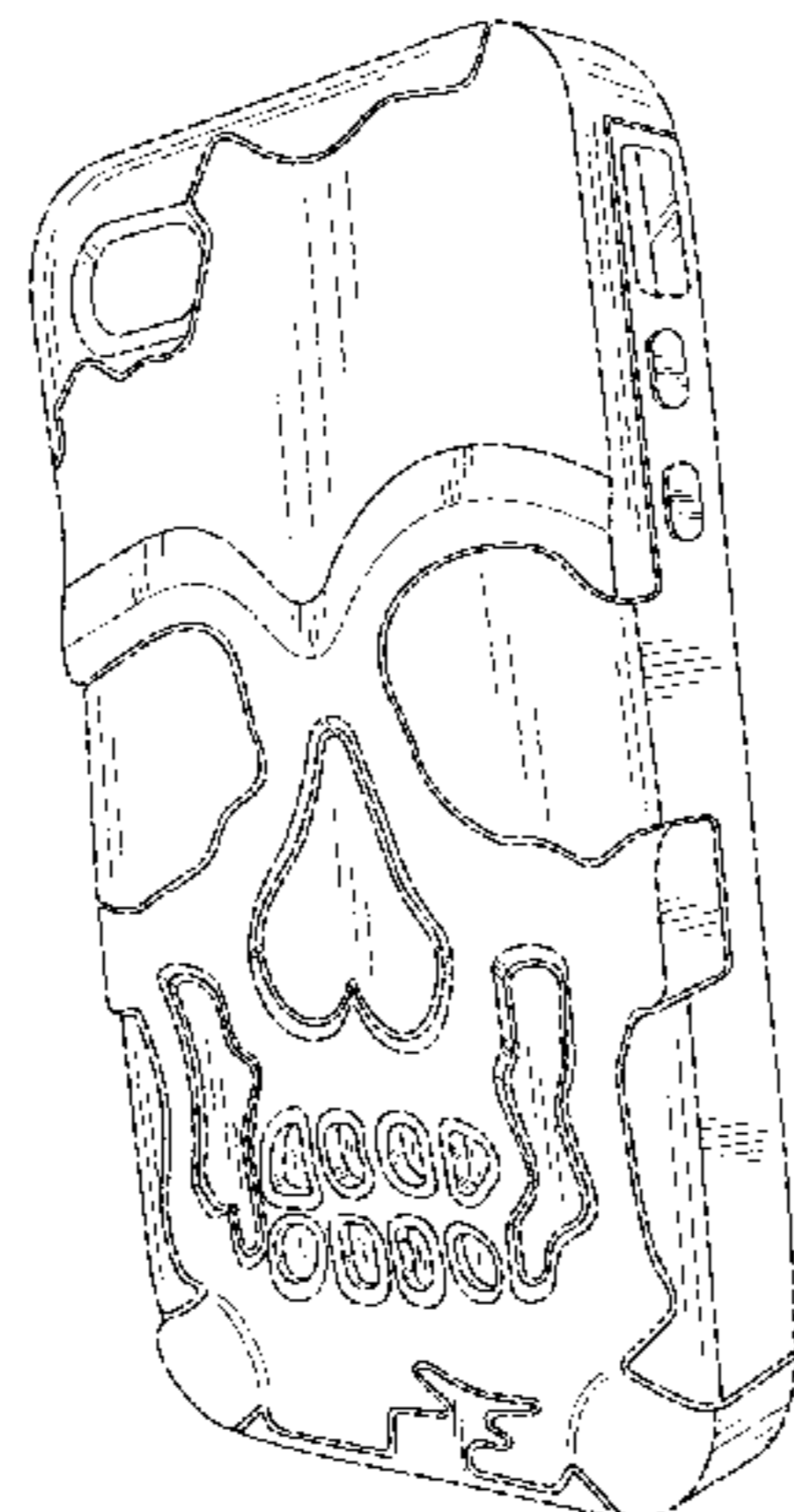
(57) **CLAIM**

The ornamental design for a cell phone protector case with three dimensional skull, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a cell phone protector case with three dimensional skull showing my new design; FIG. 2 is a front perspective view thereof; FIG. 3 is rear elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is an elevational view of a left side thereof; FIG. 6 is an elevational view of the right side thereof; FIG. 7 is a top elevational view thereof; FIG. 8 is a bottom elevational view thereof; FIG. 9 is a rear elevational view of the three-dimensional skullcap removed from the rear of the cell phone protector case illustrating the rear view of the three-dimensional skullcap and the rear view of the exterior rear portion of the cell phone protector case; and, FIG. 10 is a front elevational view of the three-dimensional skullcap removed from the cell phone protector case showing the front view of the three-dimensional skullcap and the front view of the cell phone protector case.

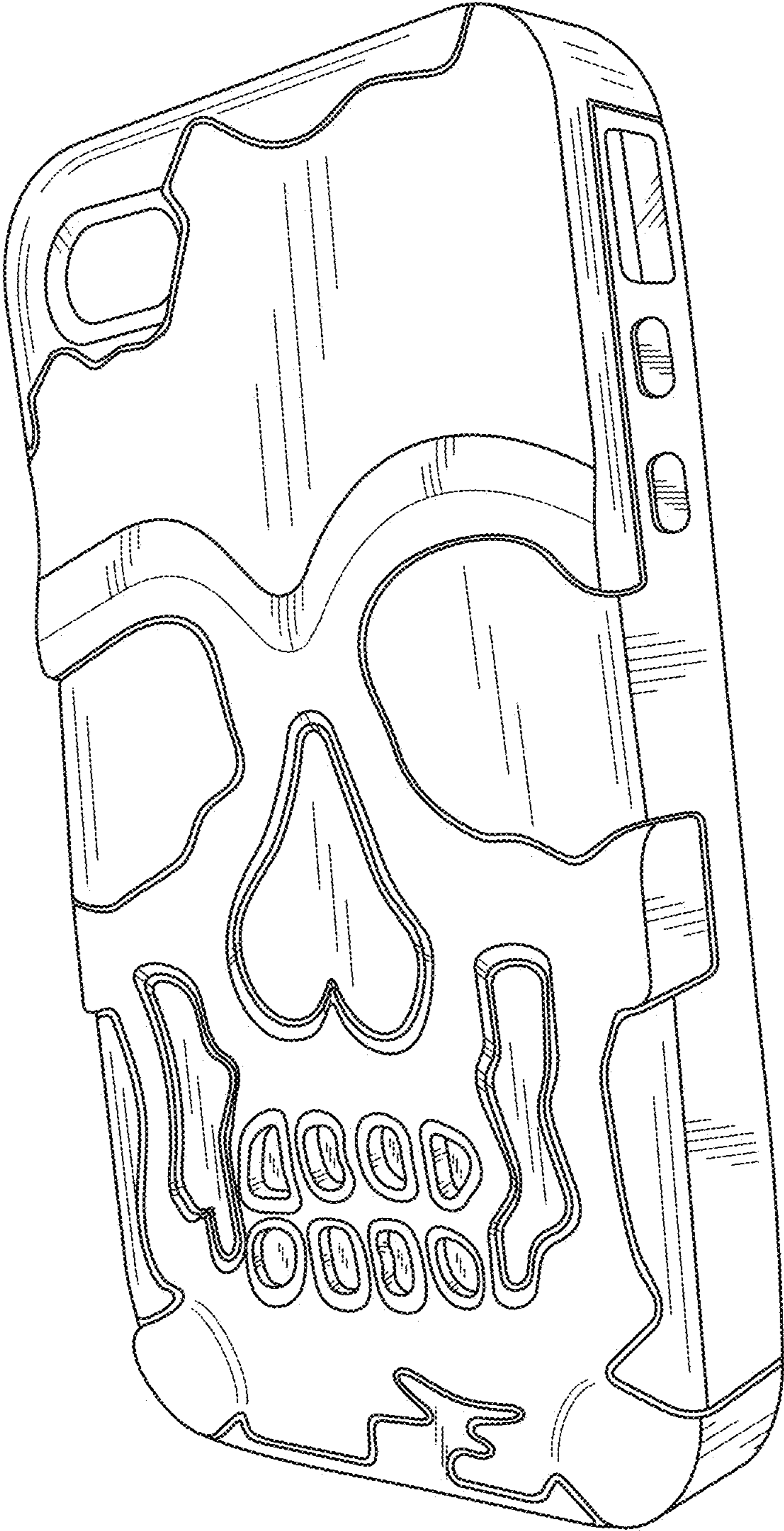

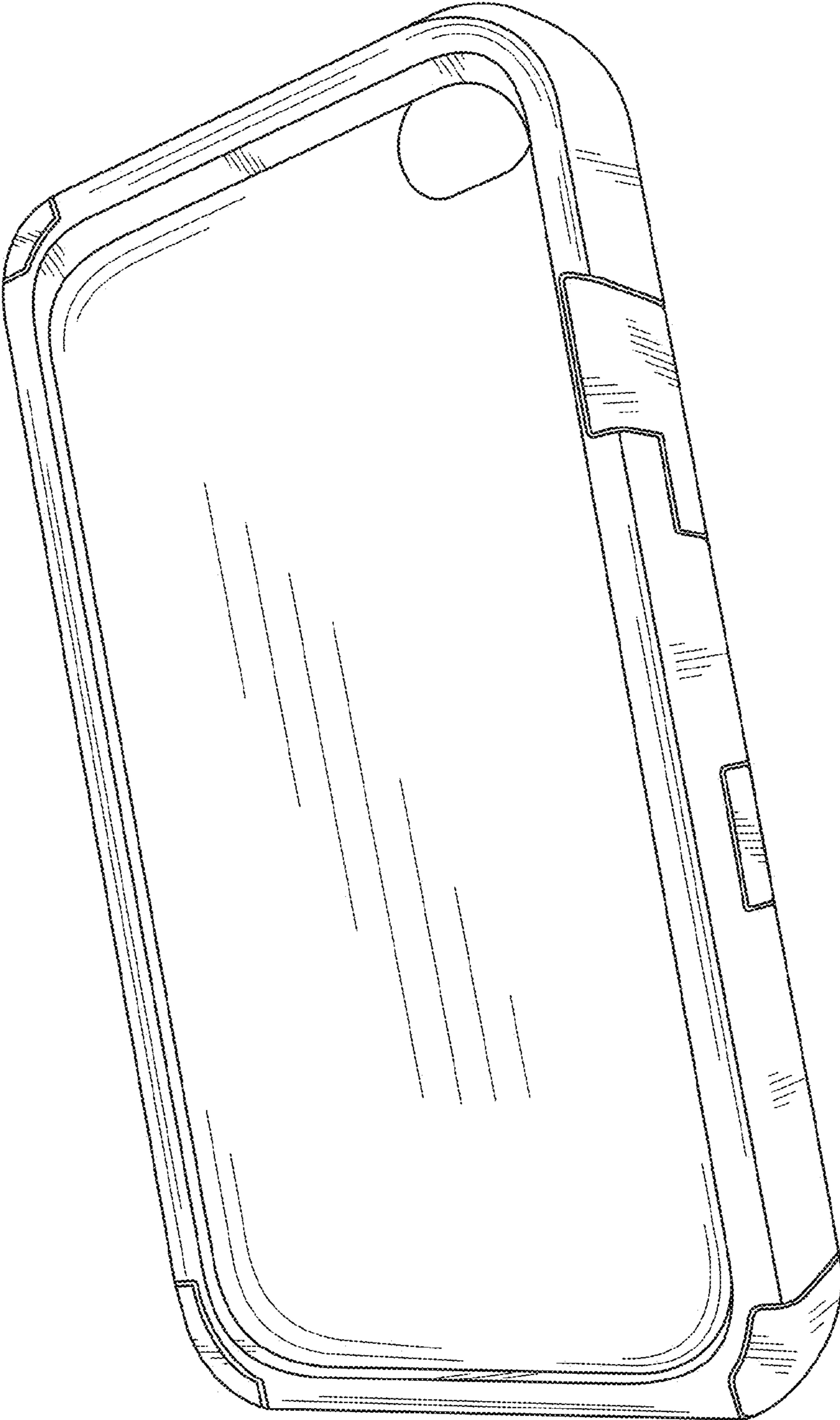

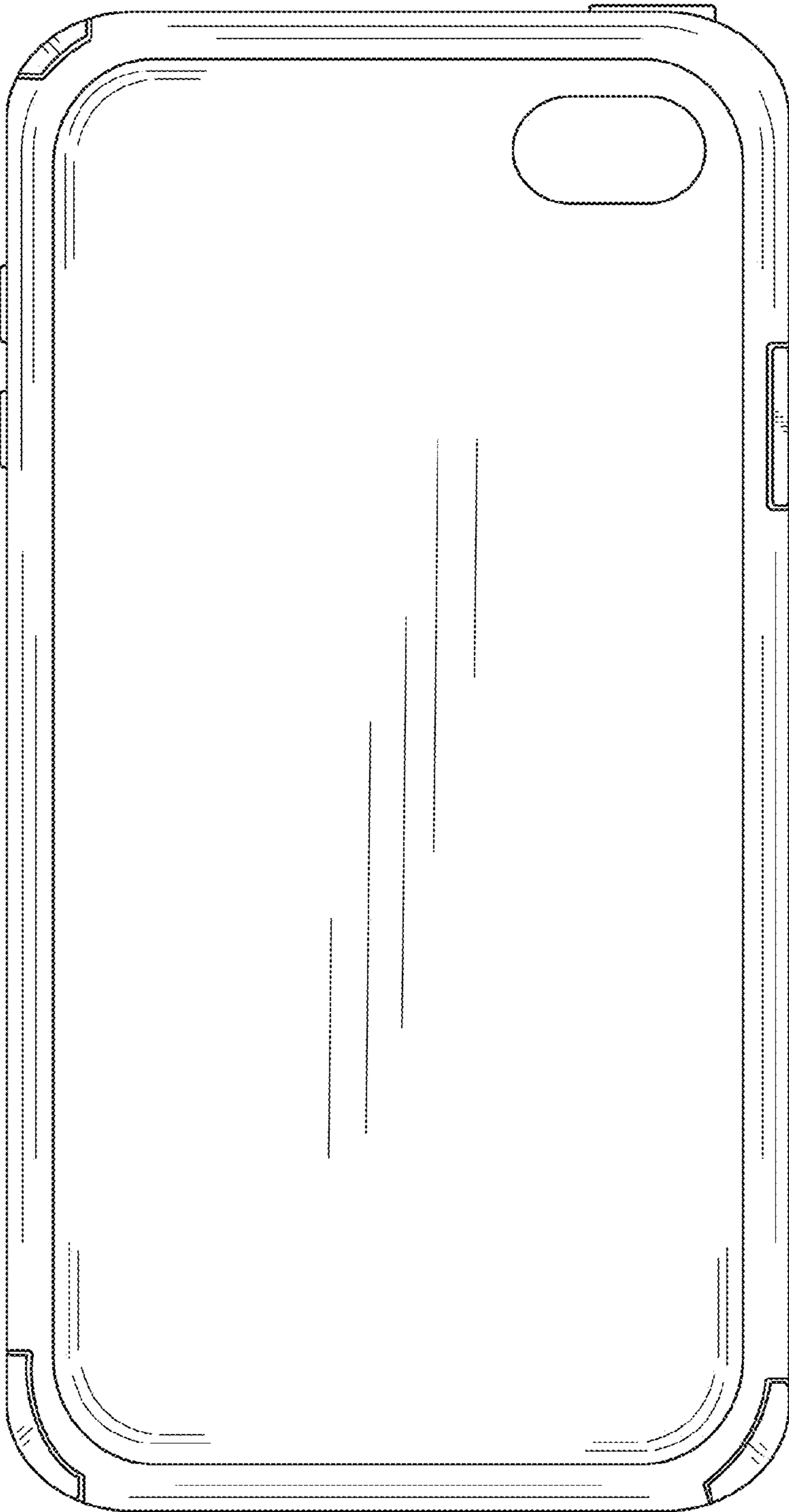

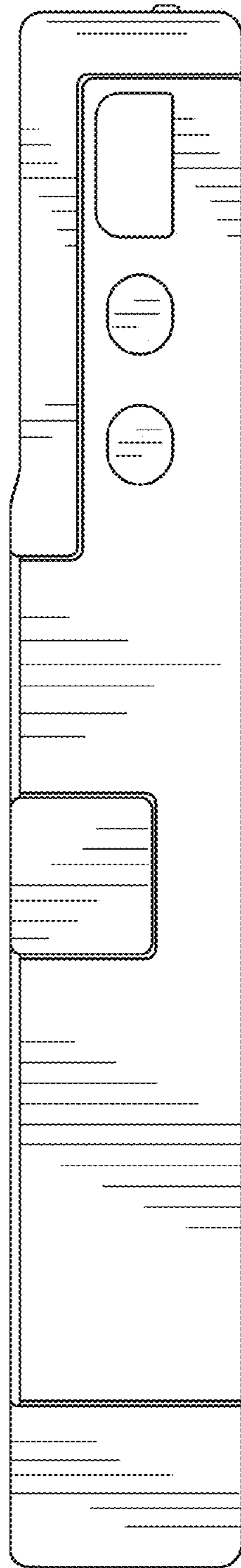

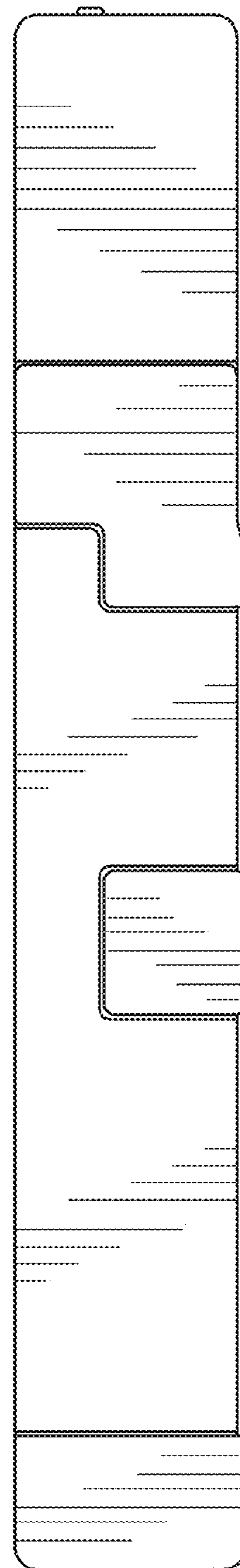

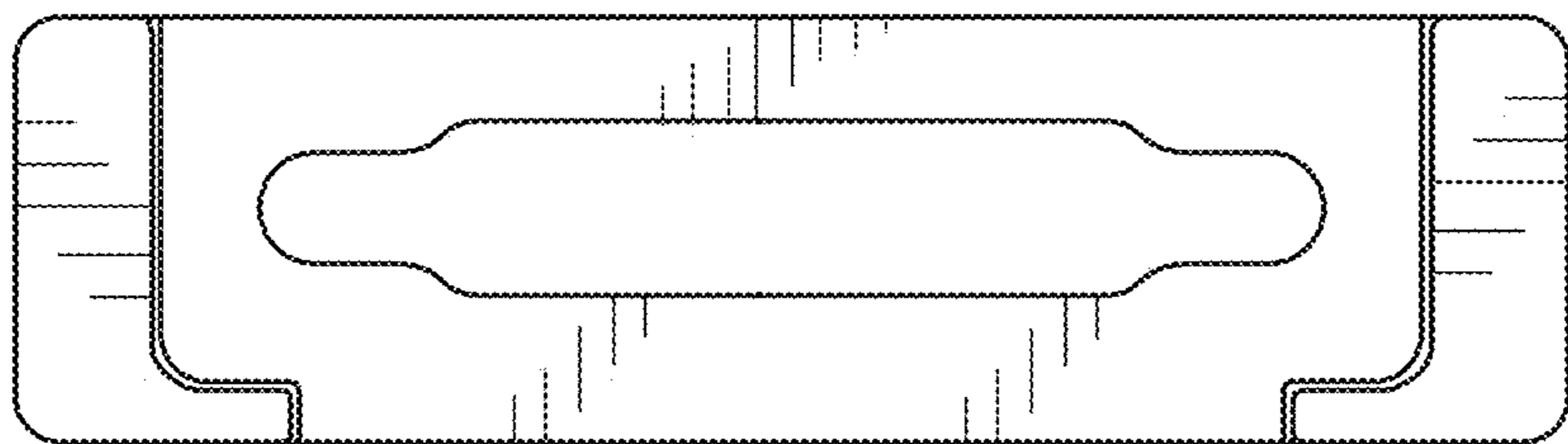

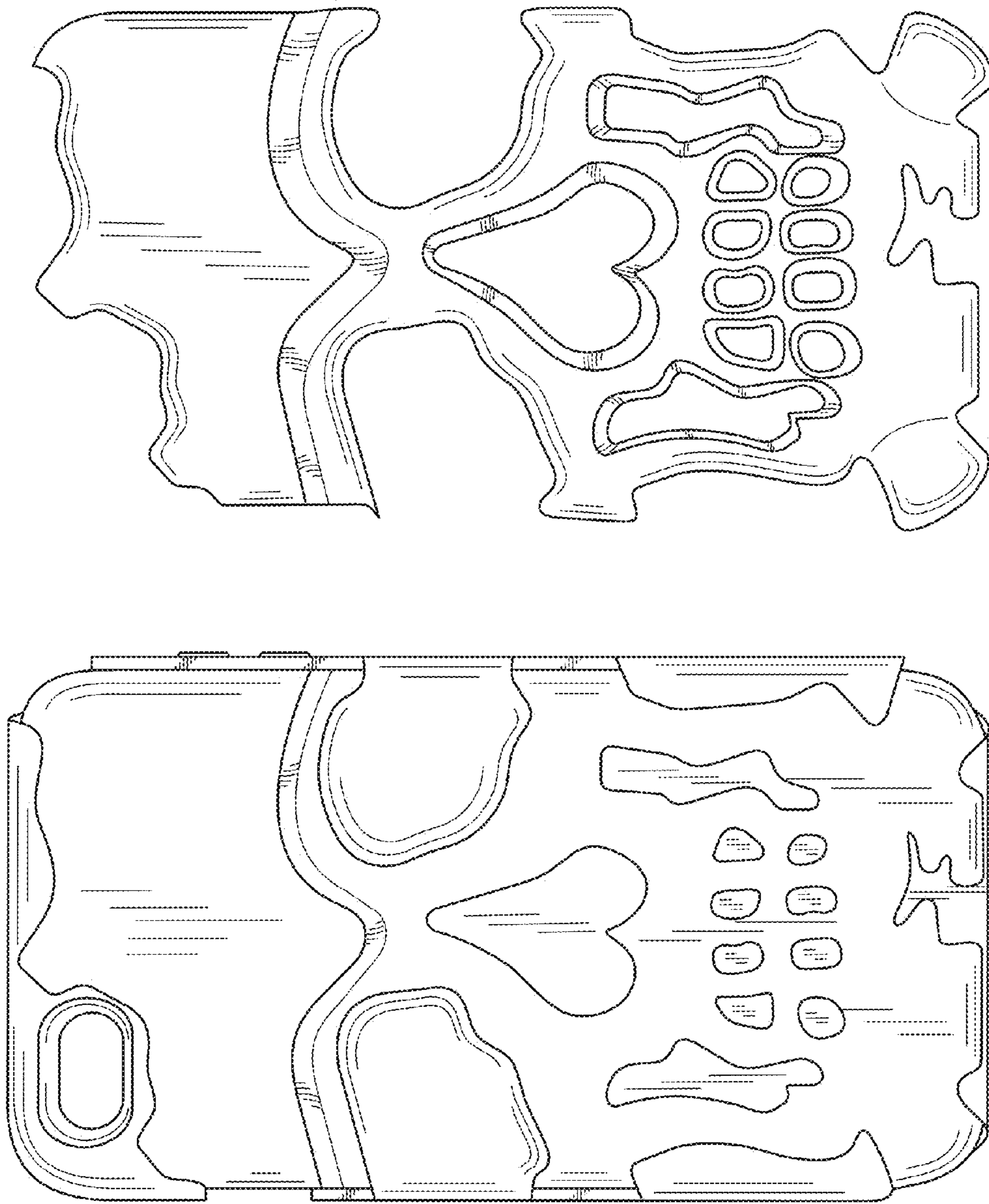

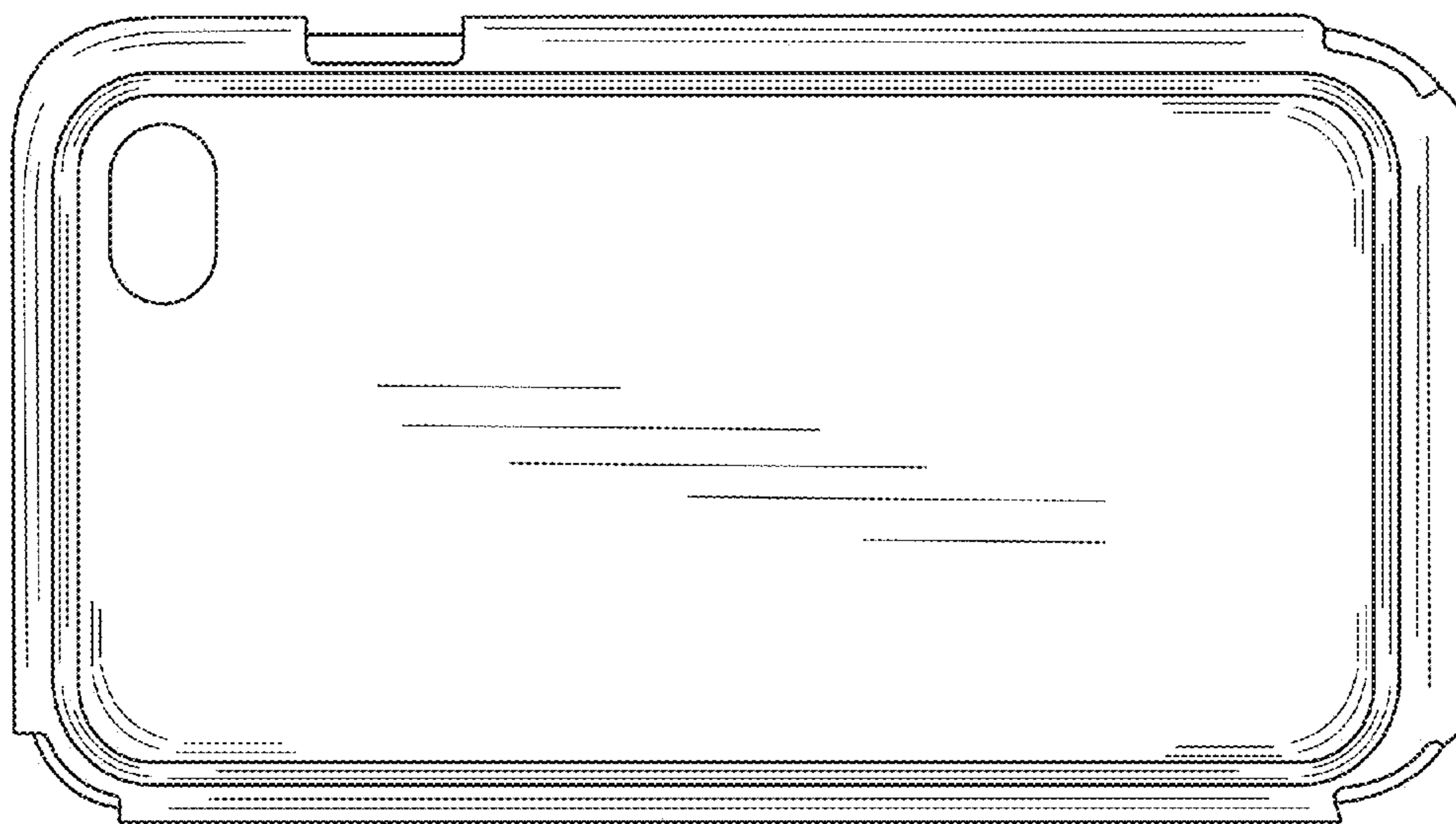
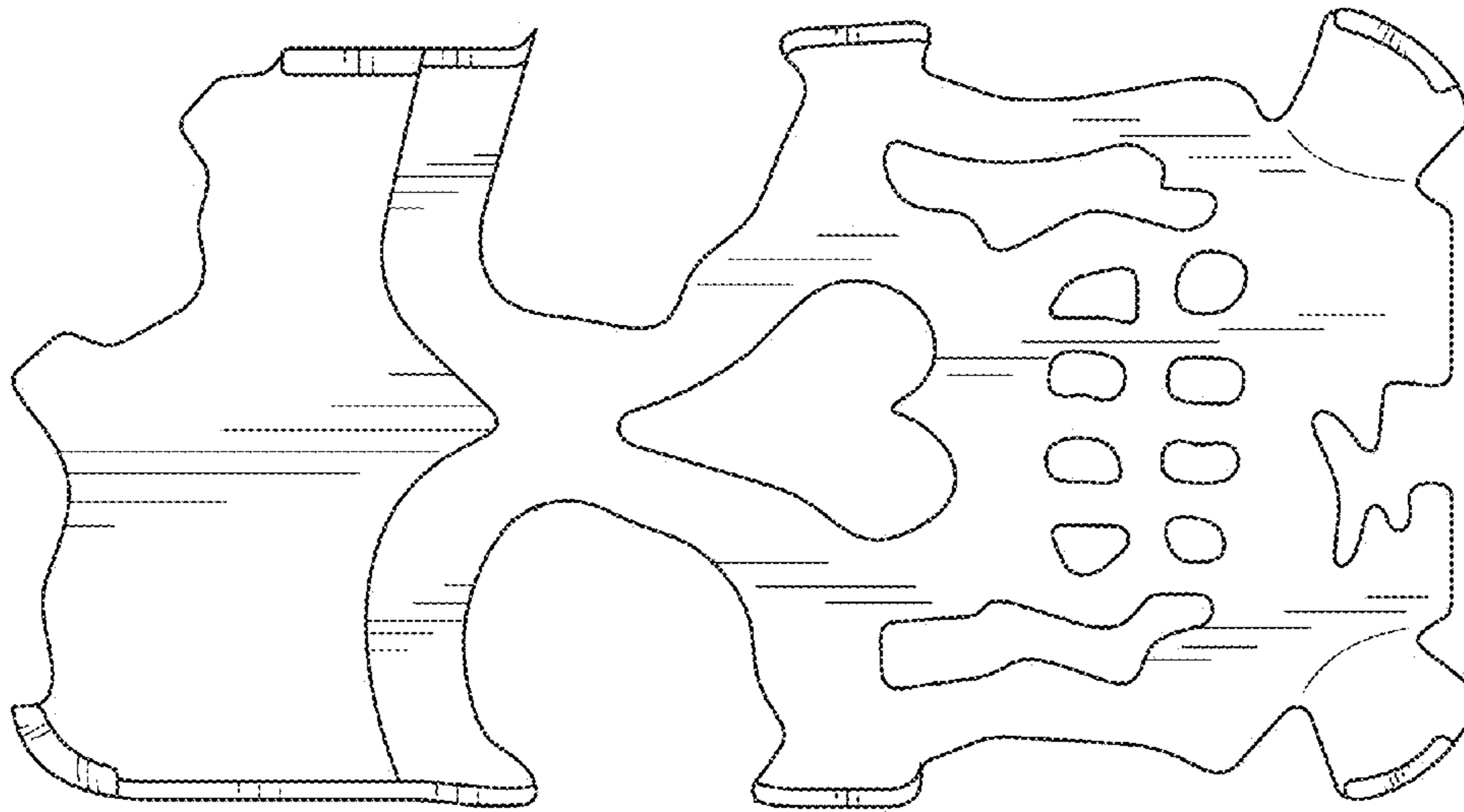
