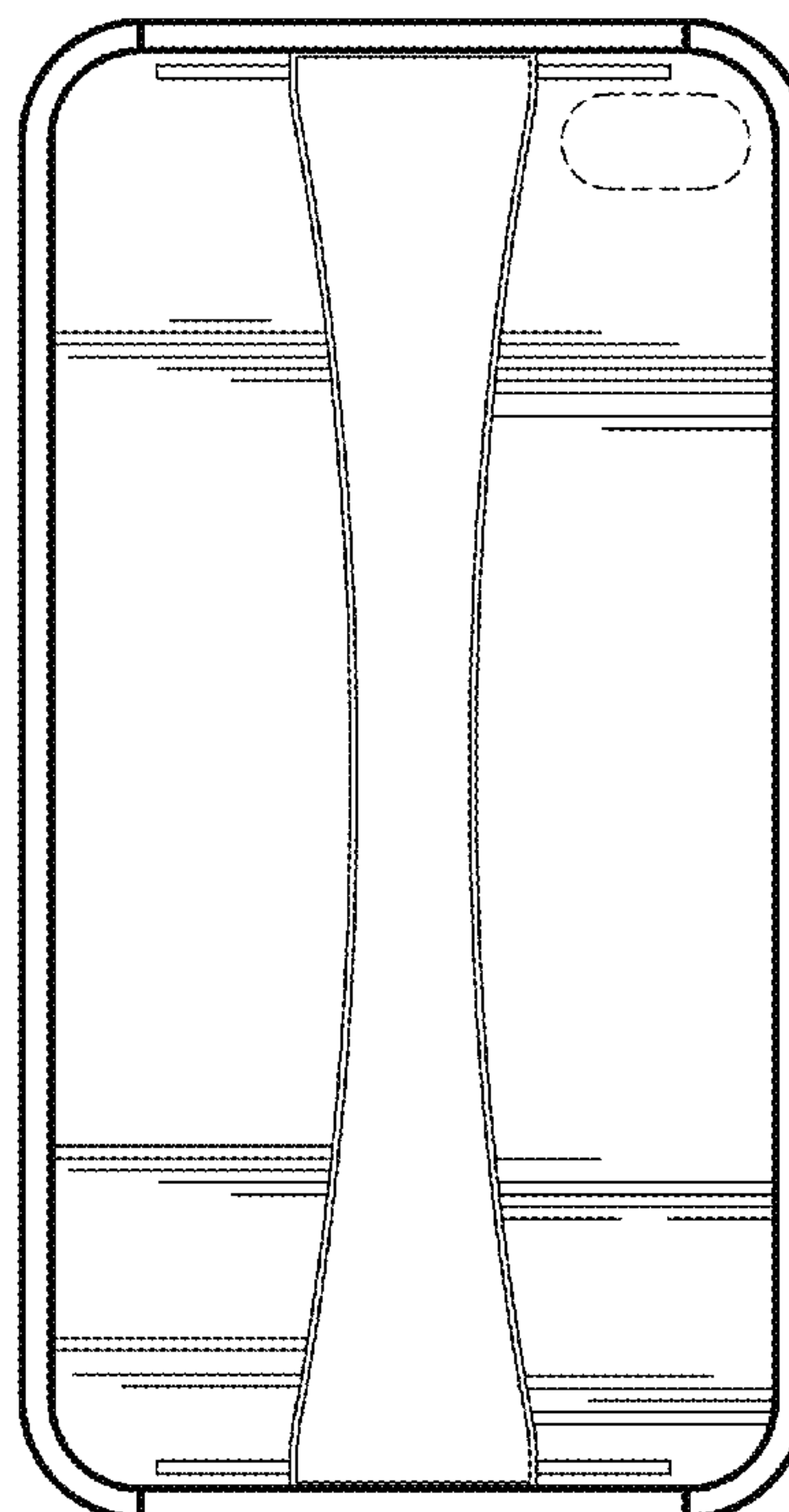
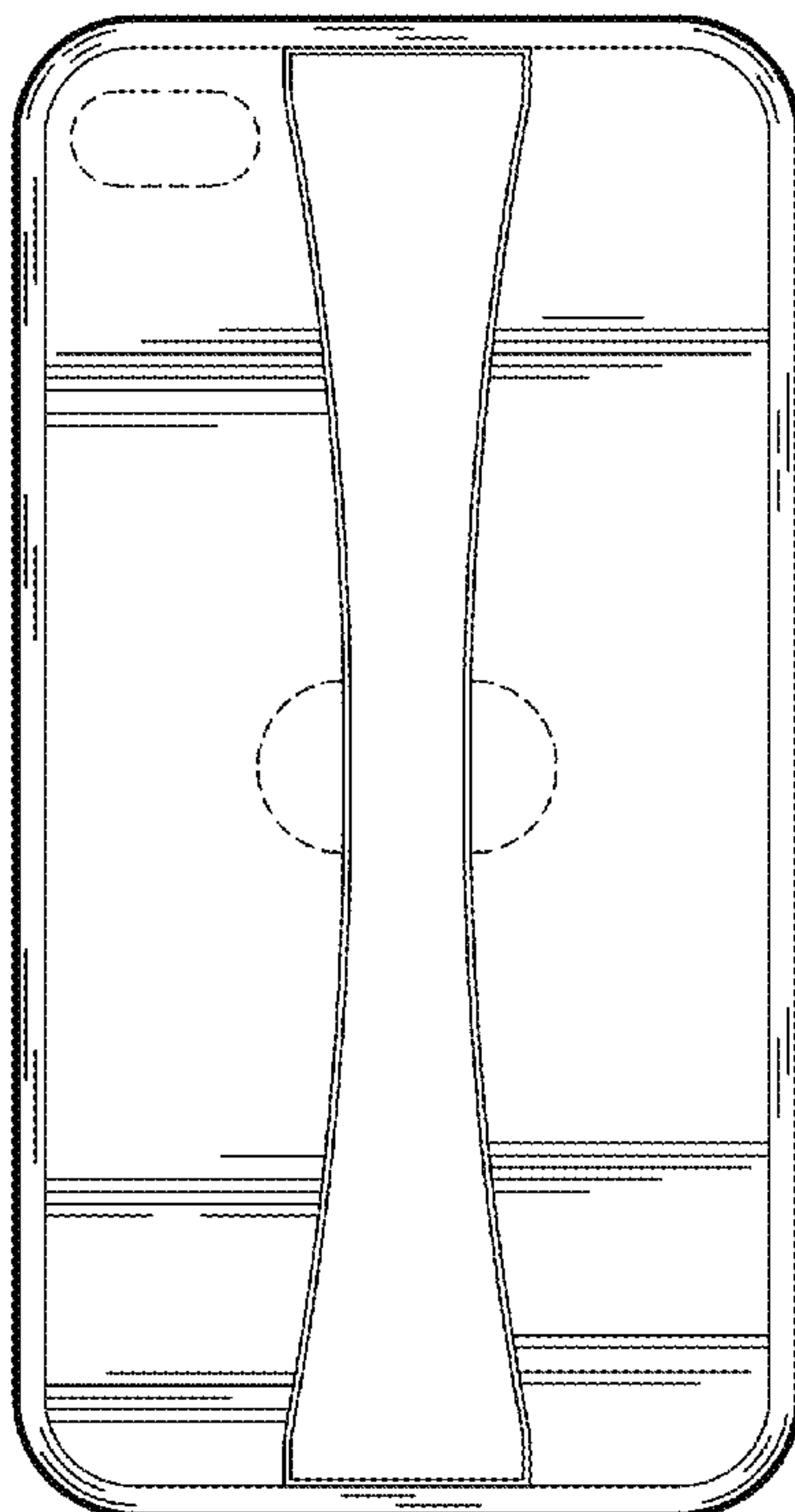
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a back view of a protective mobile phone case showing my new design;

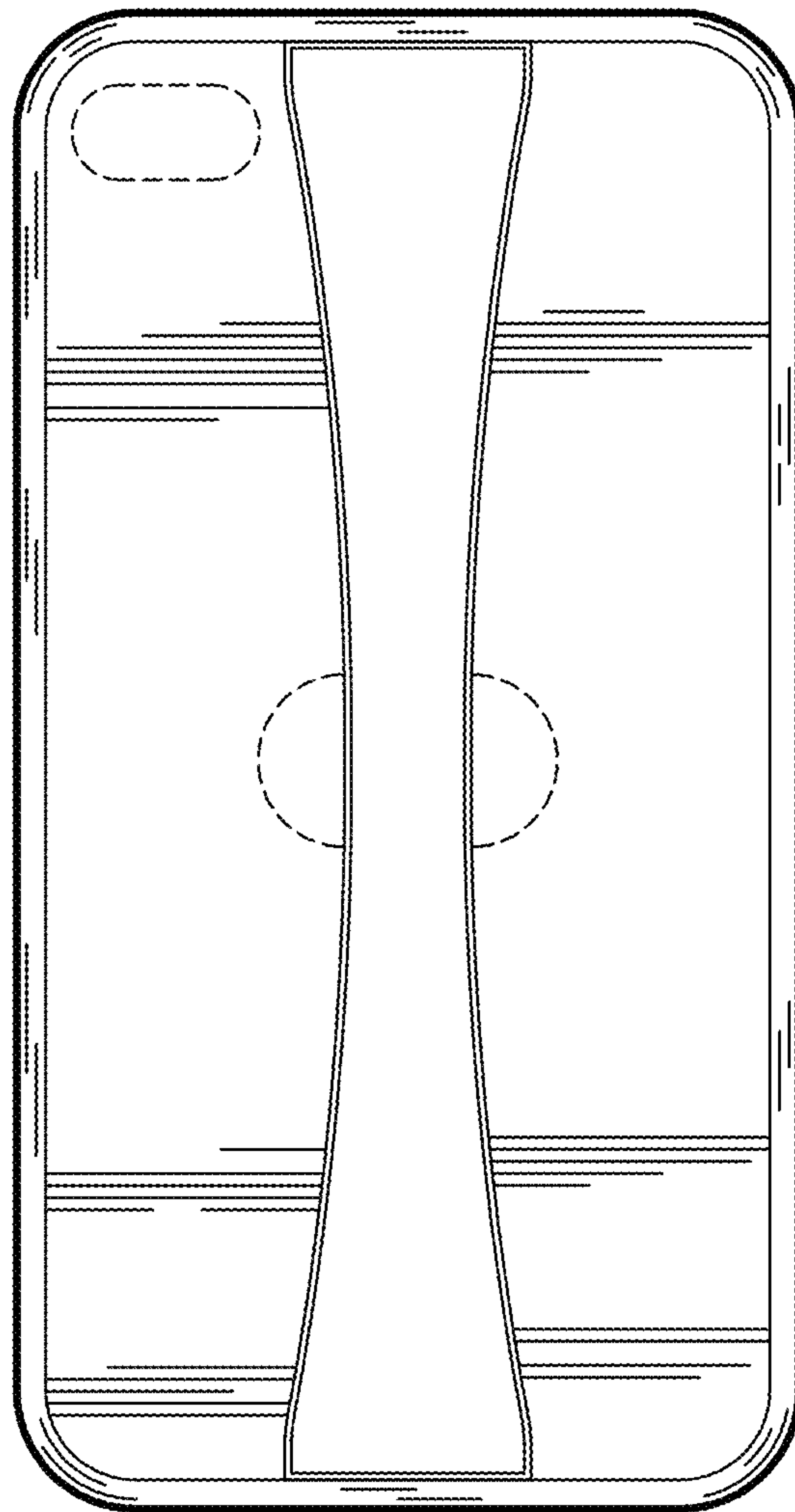

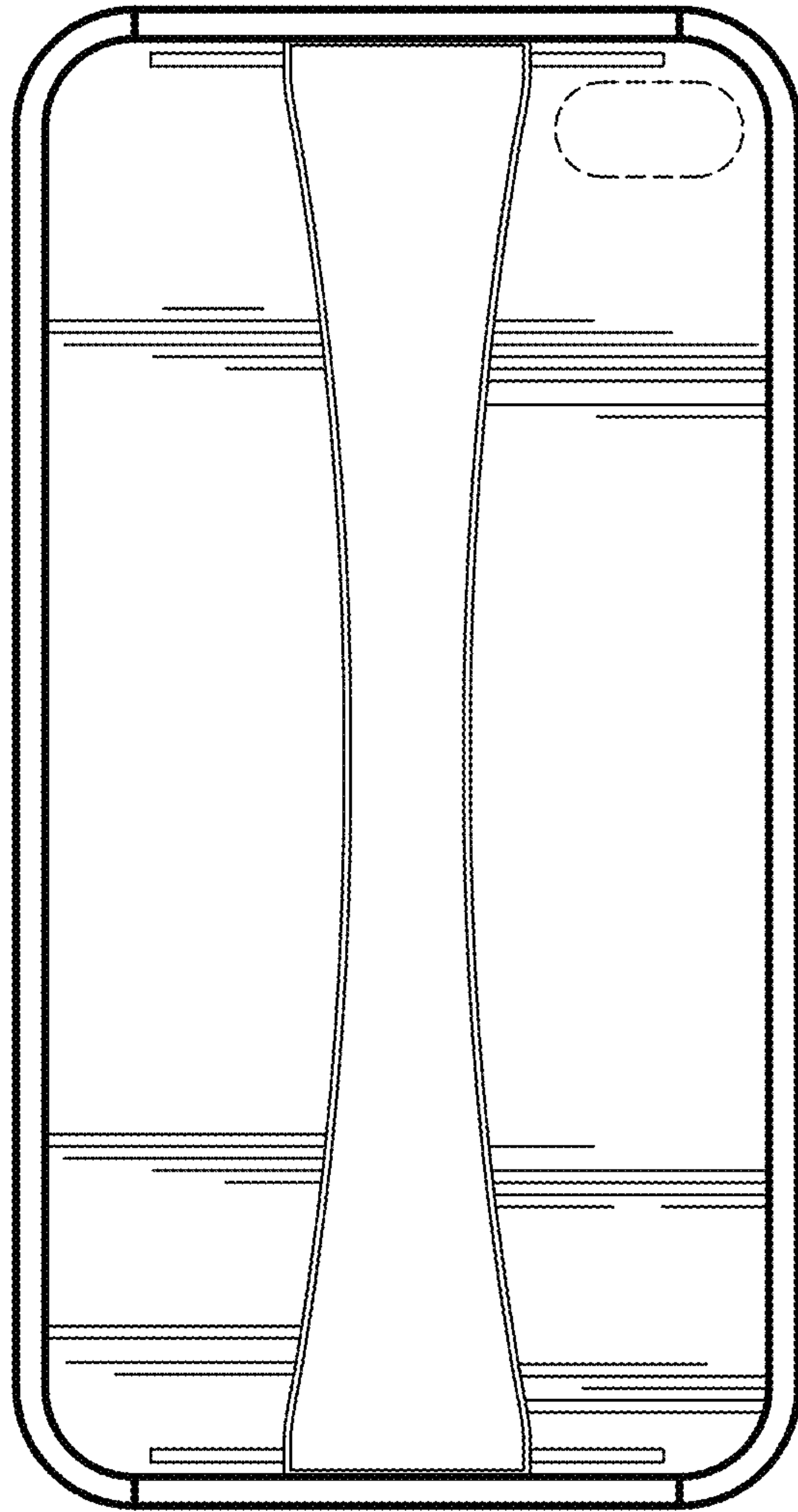

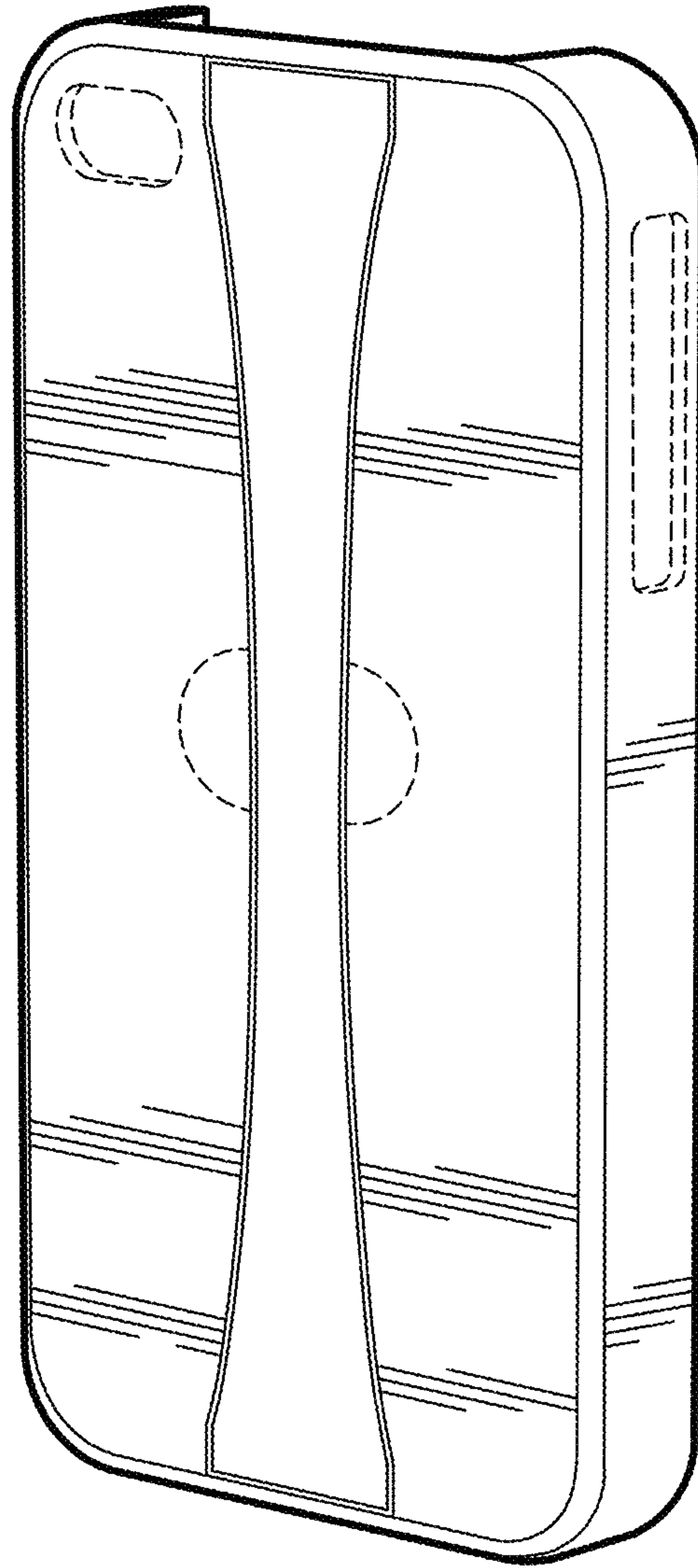

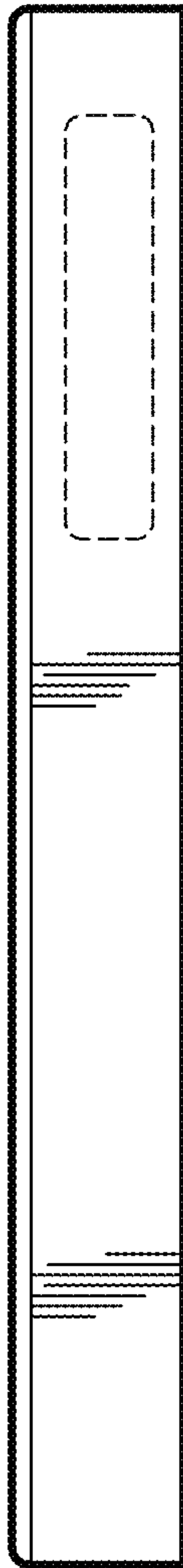

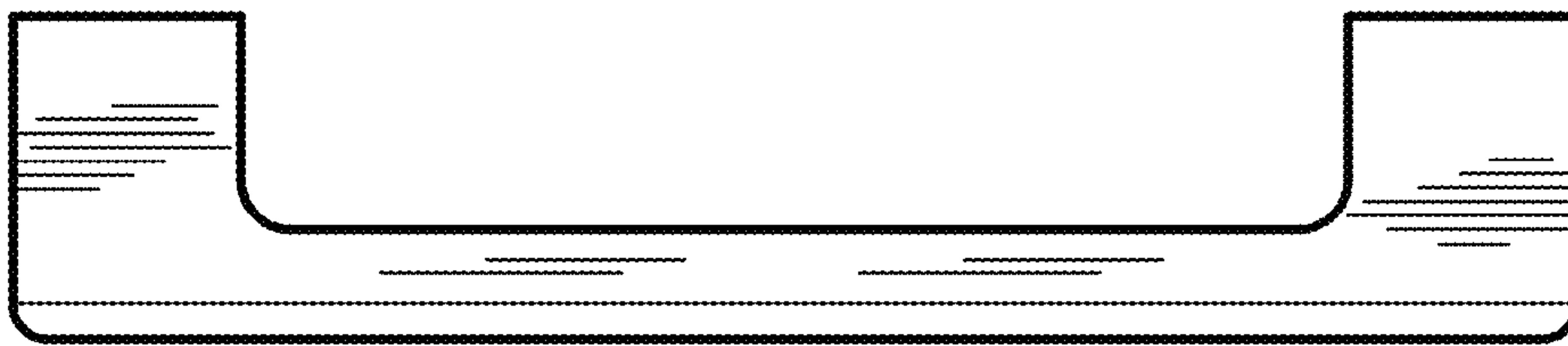

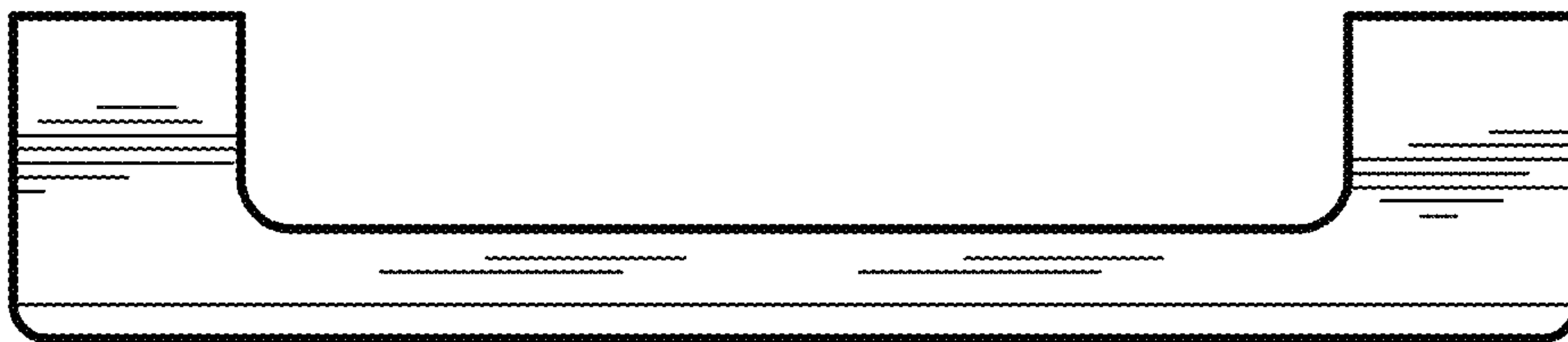
