**DESCRIPTION**

unfolded position.

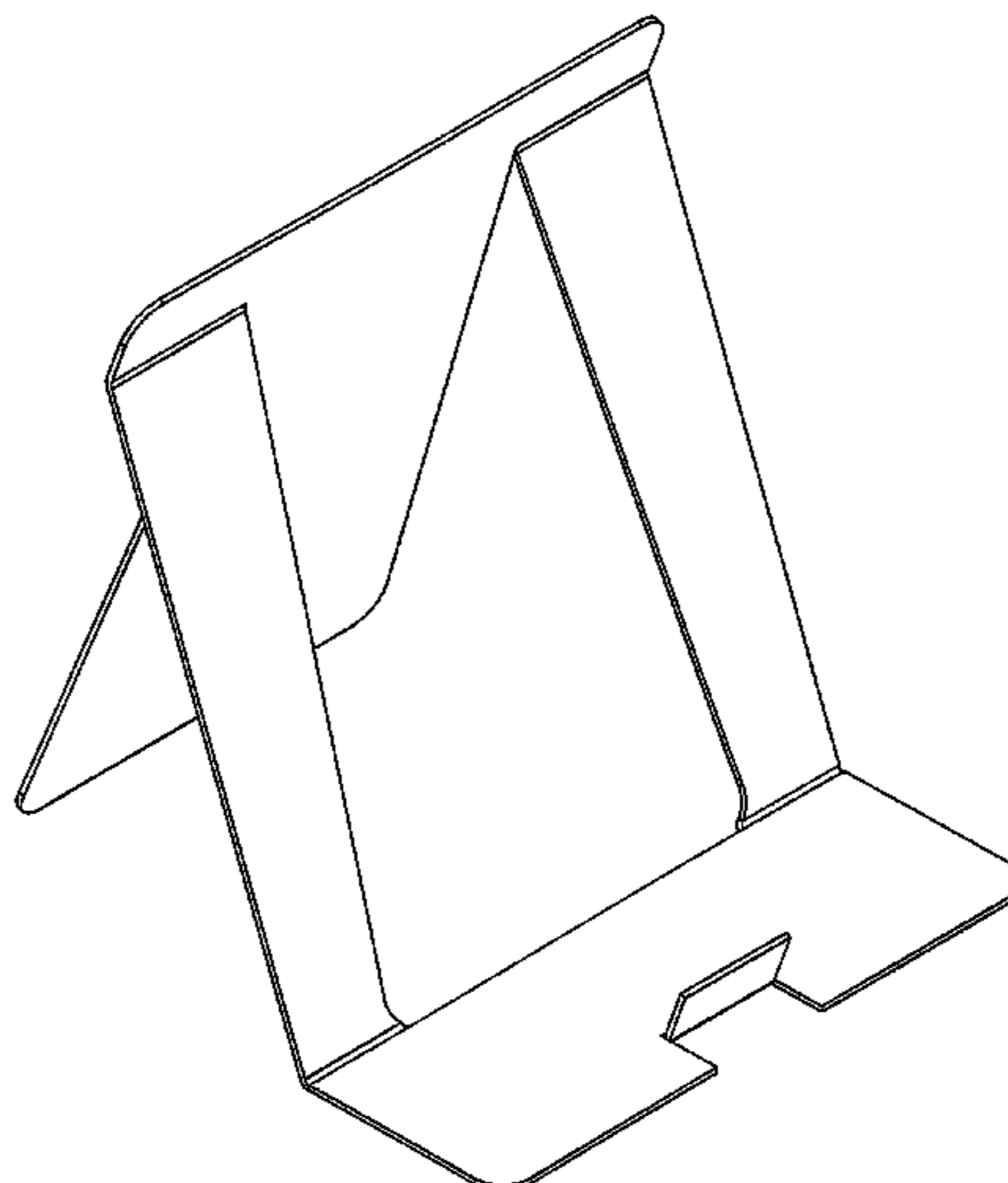
FIG. 16 is a right side view of the card stand of FIG. 15.

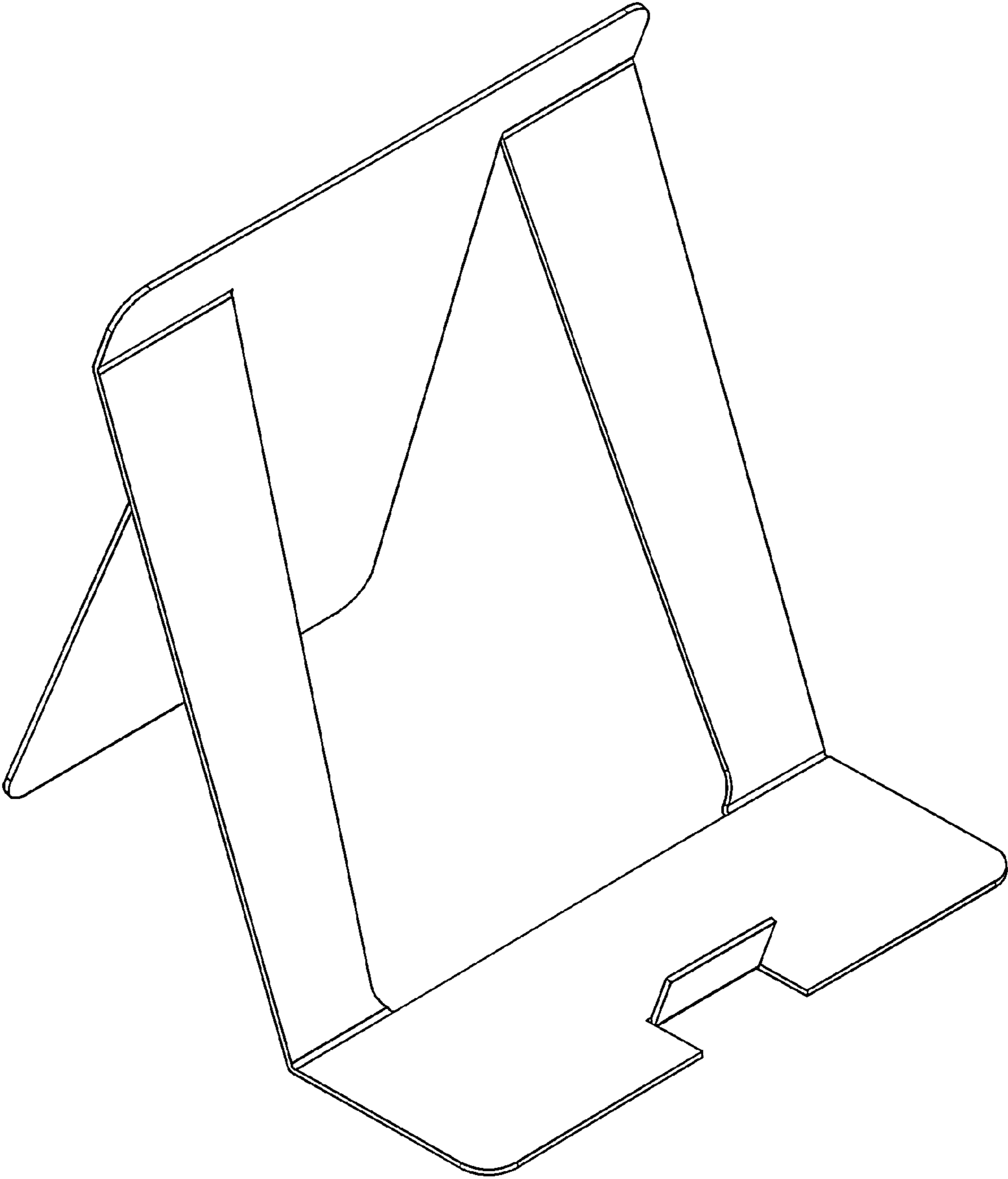

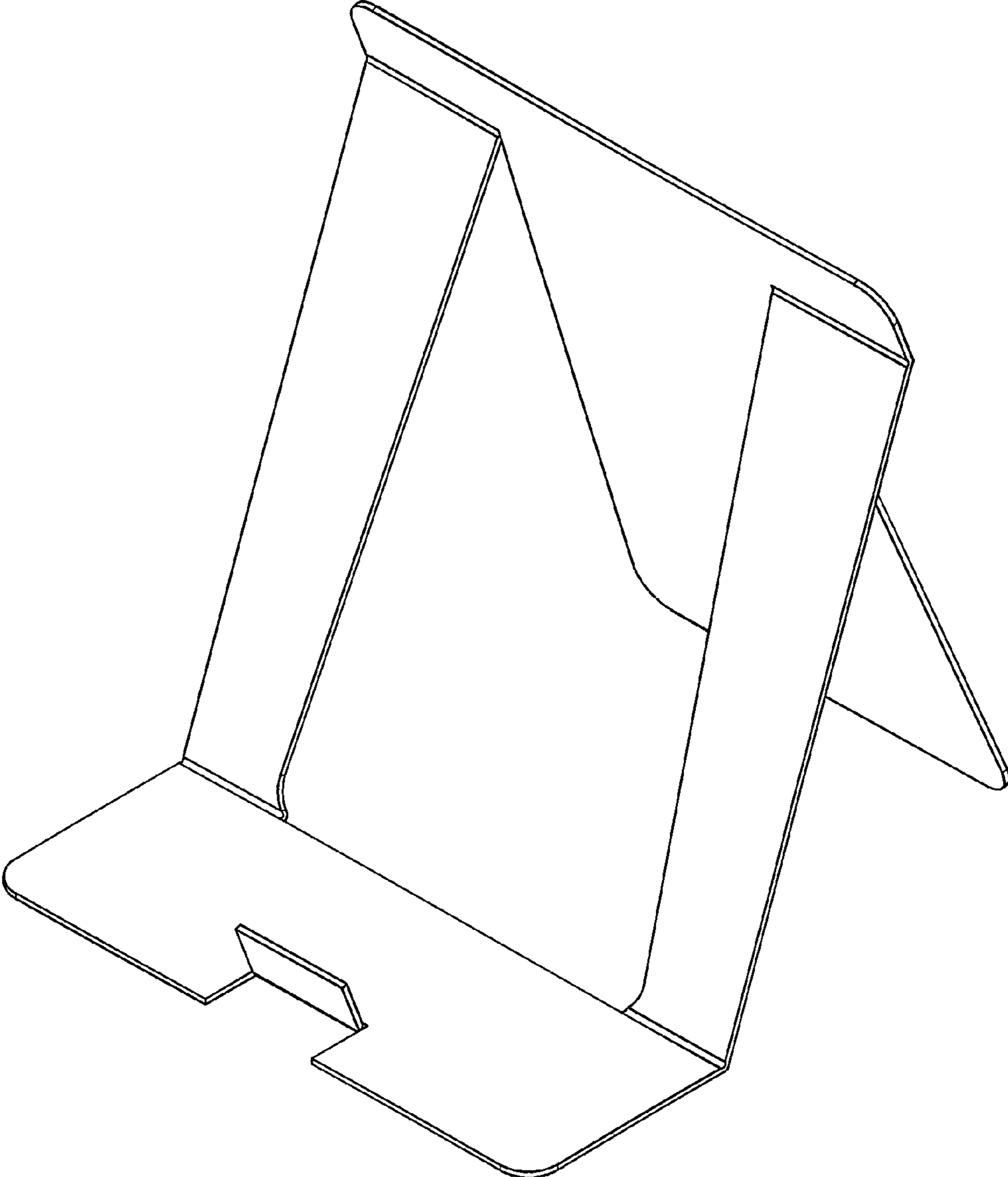

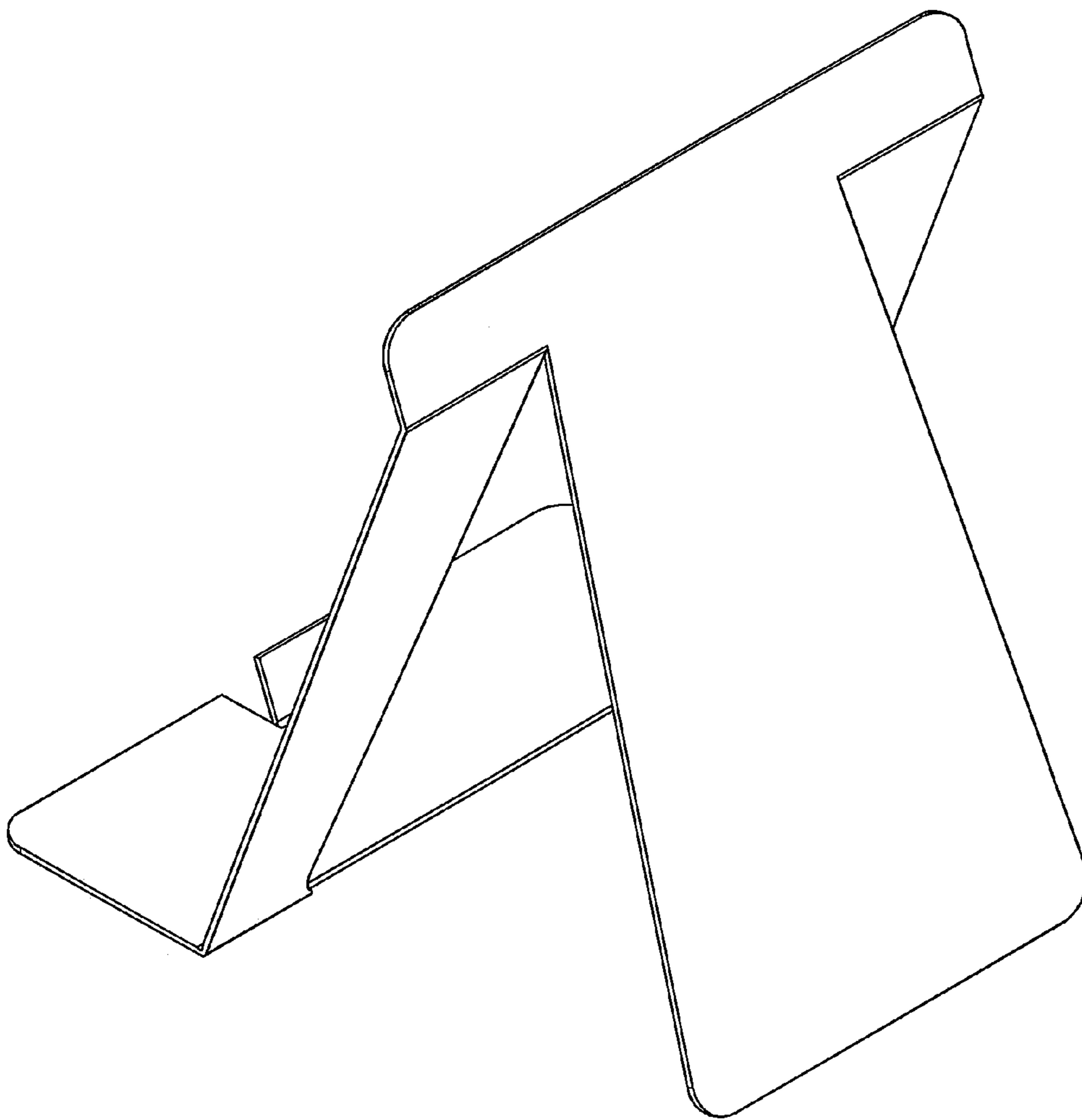

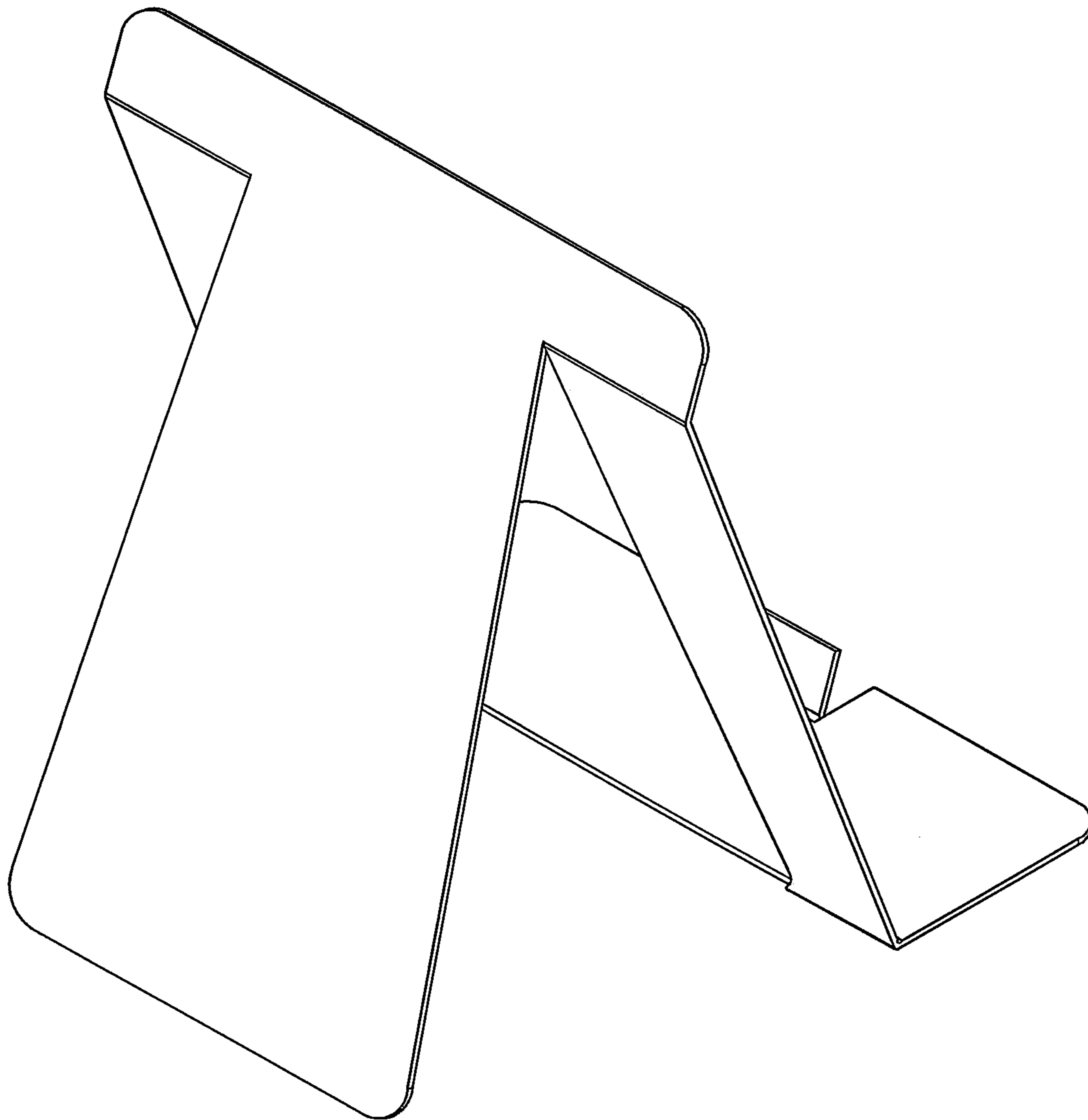

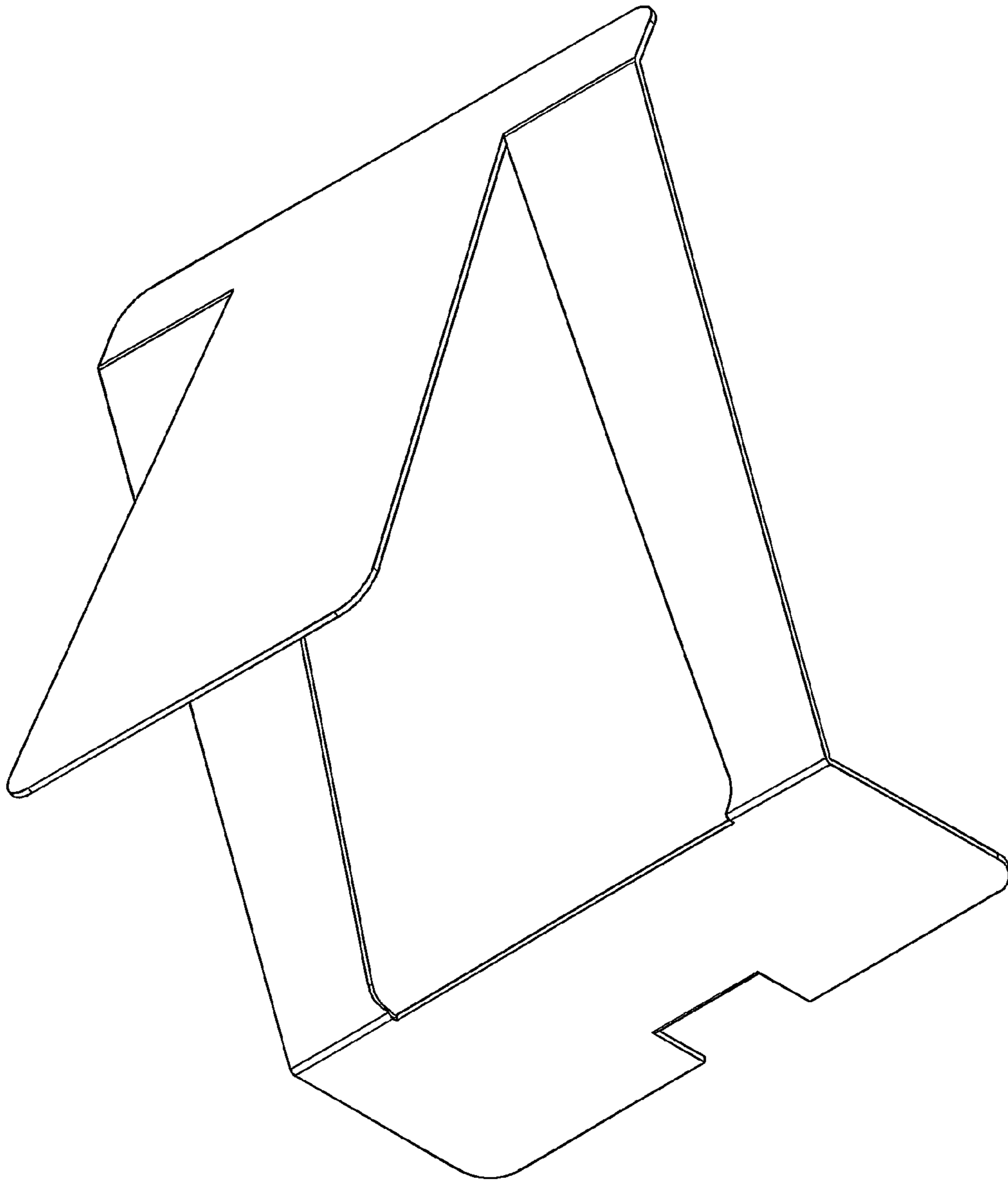

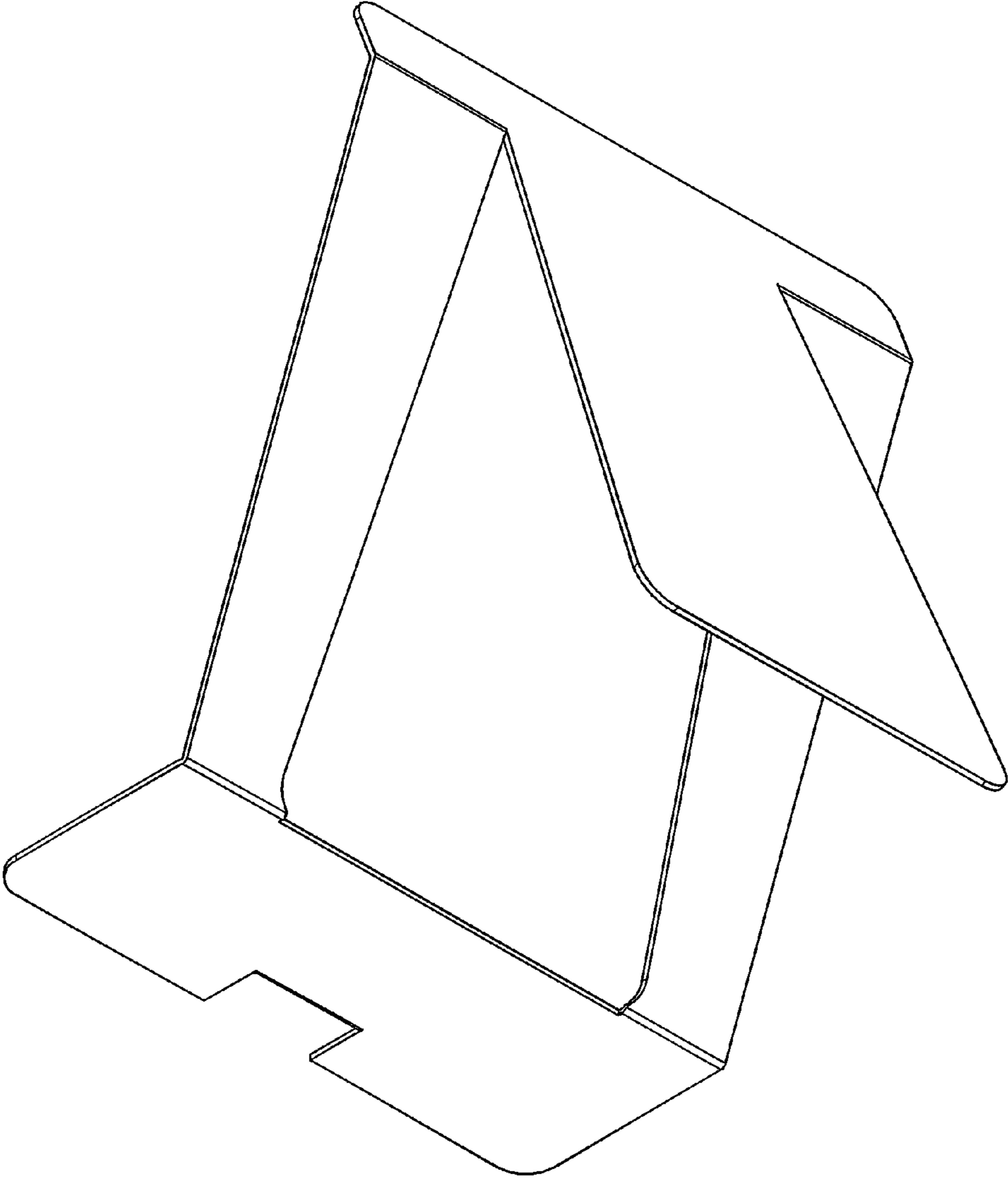

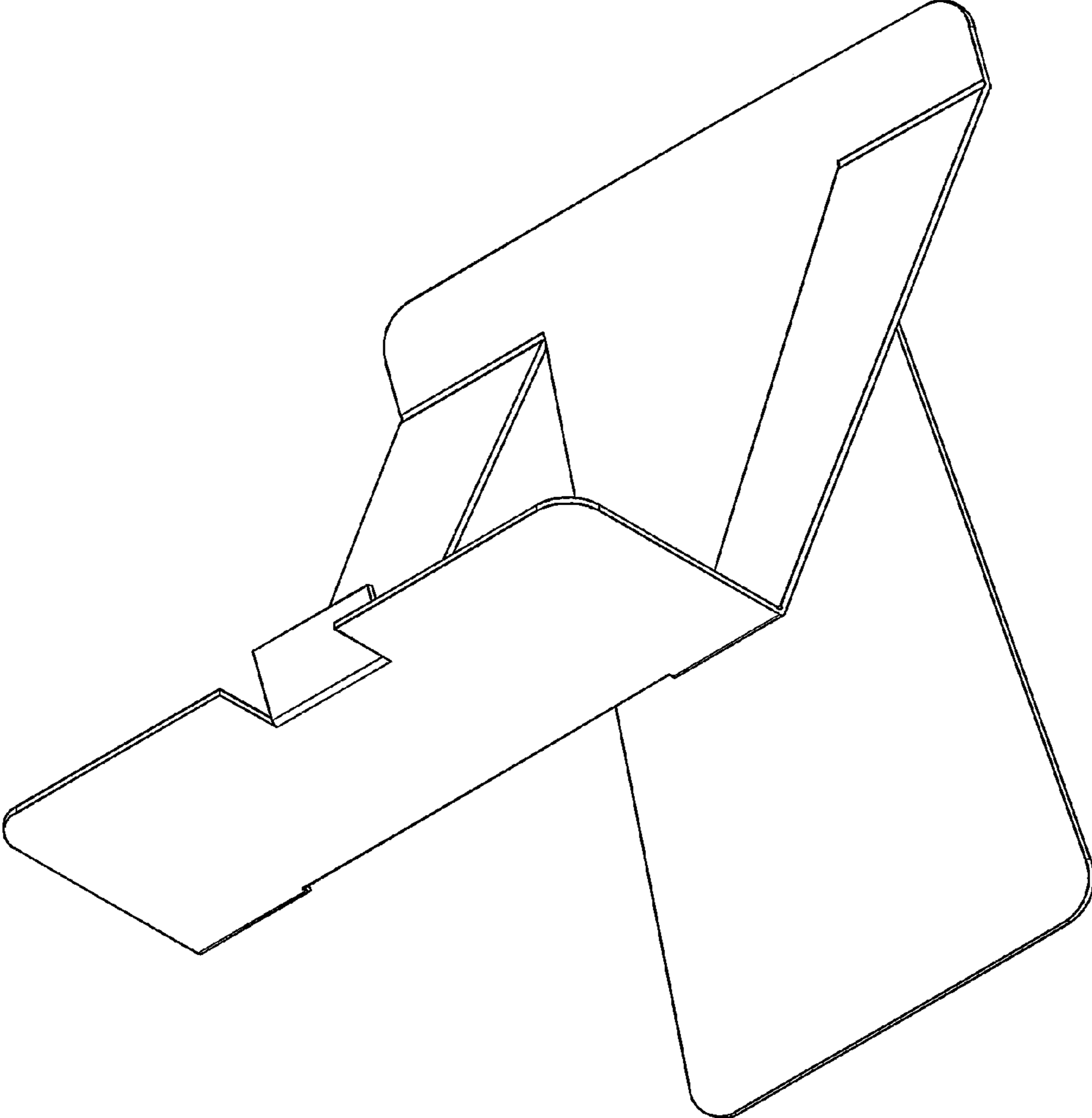

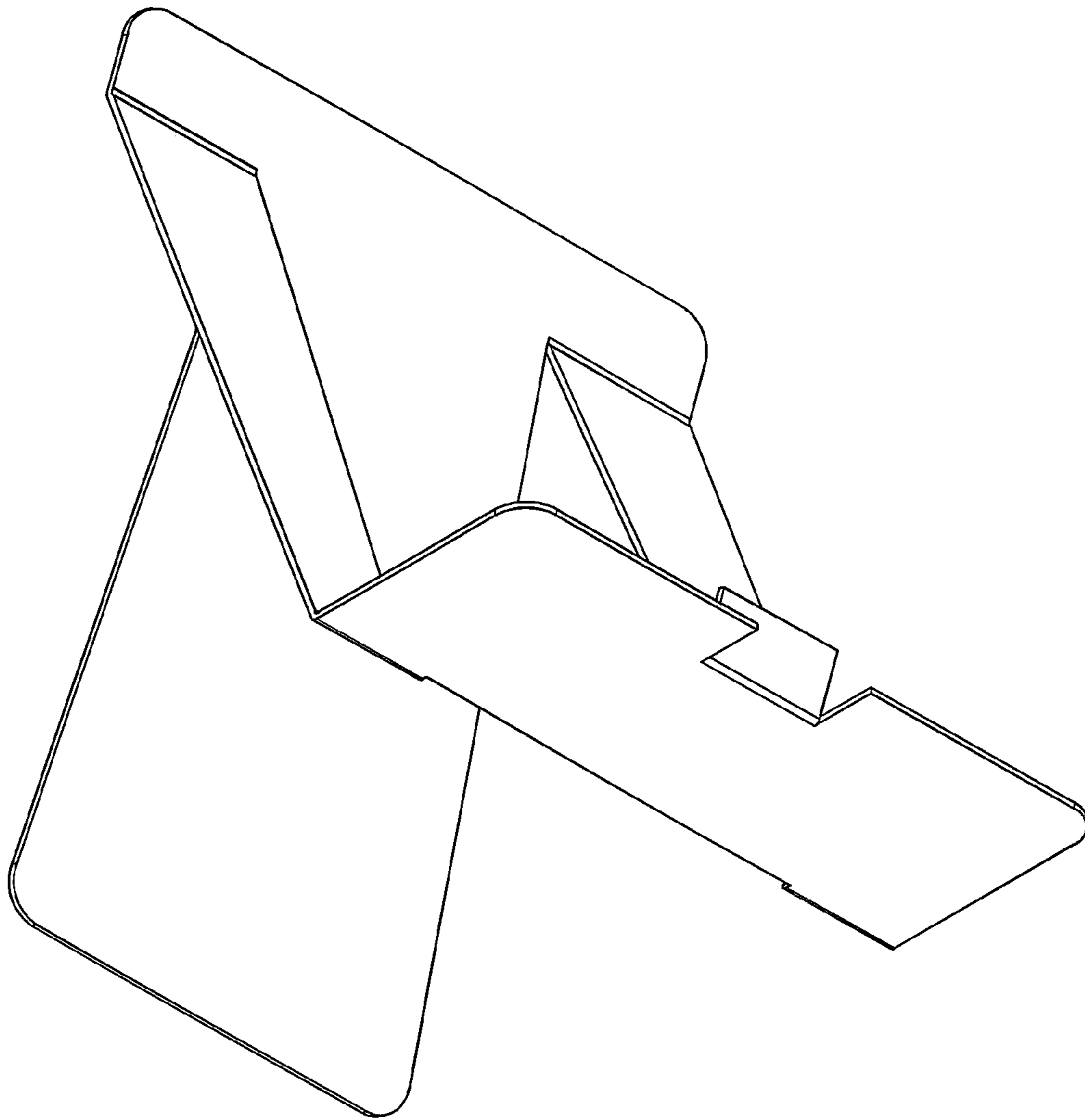

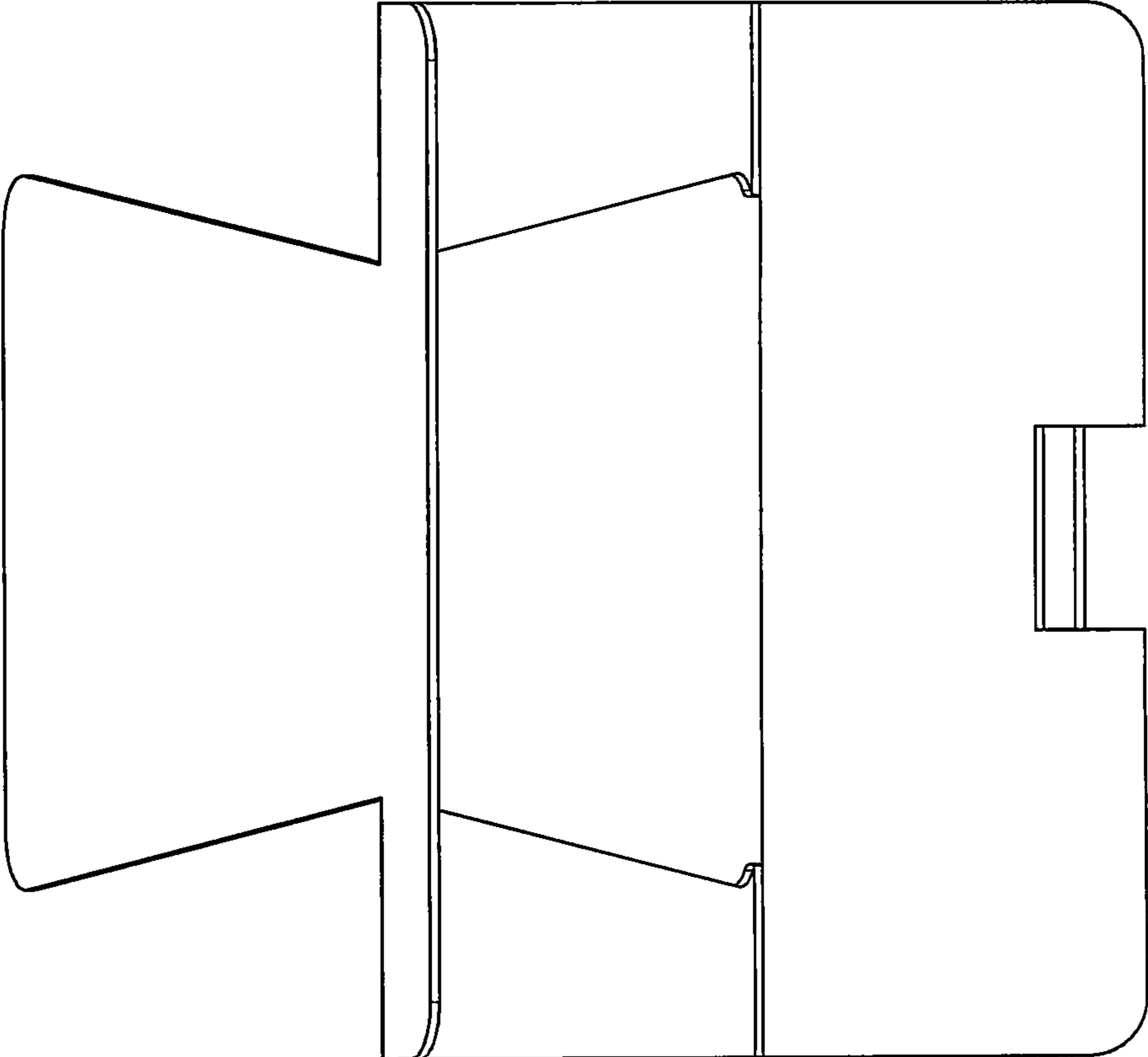

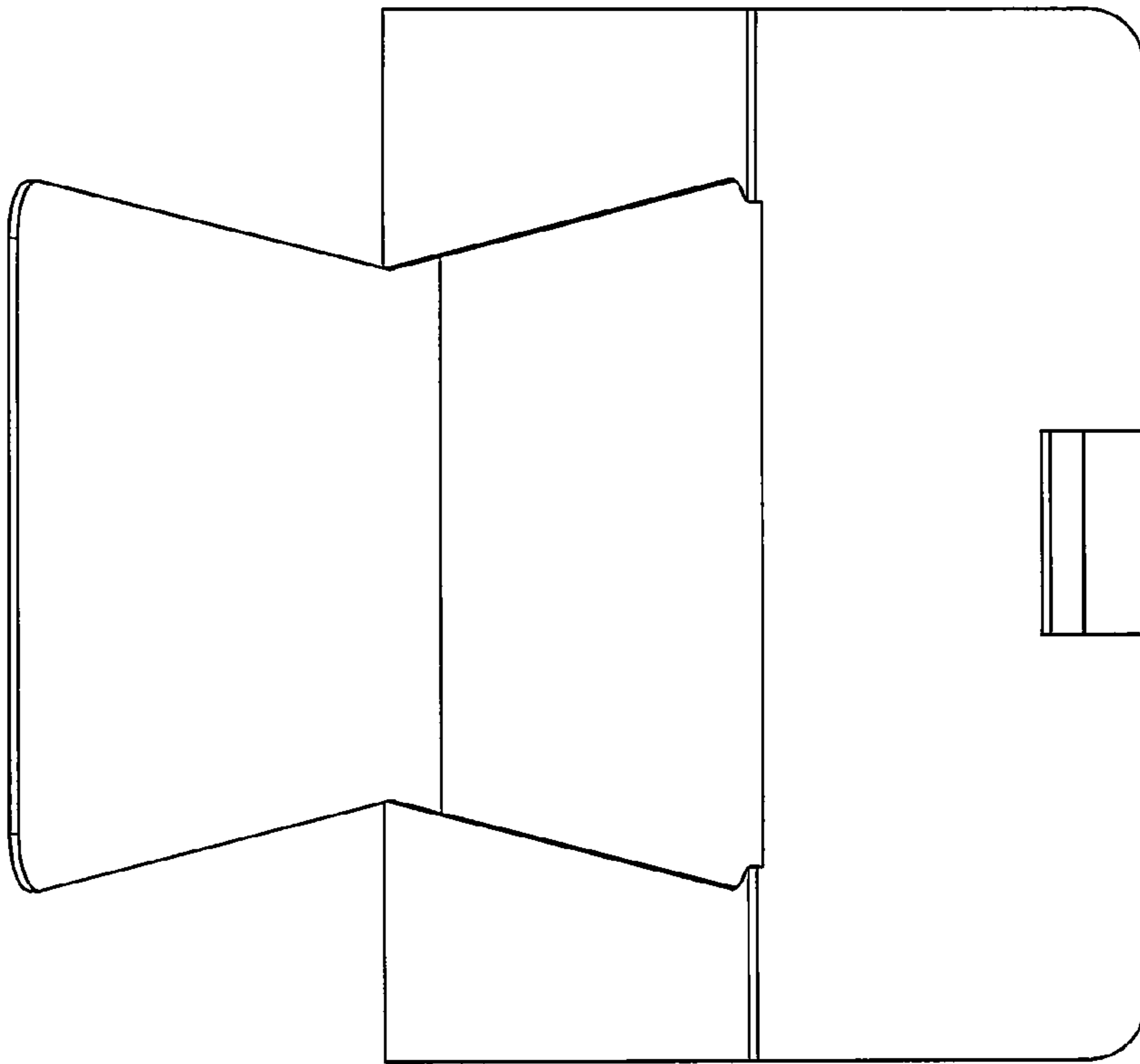

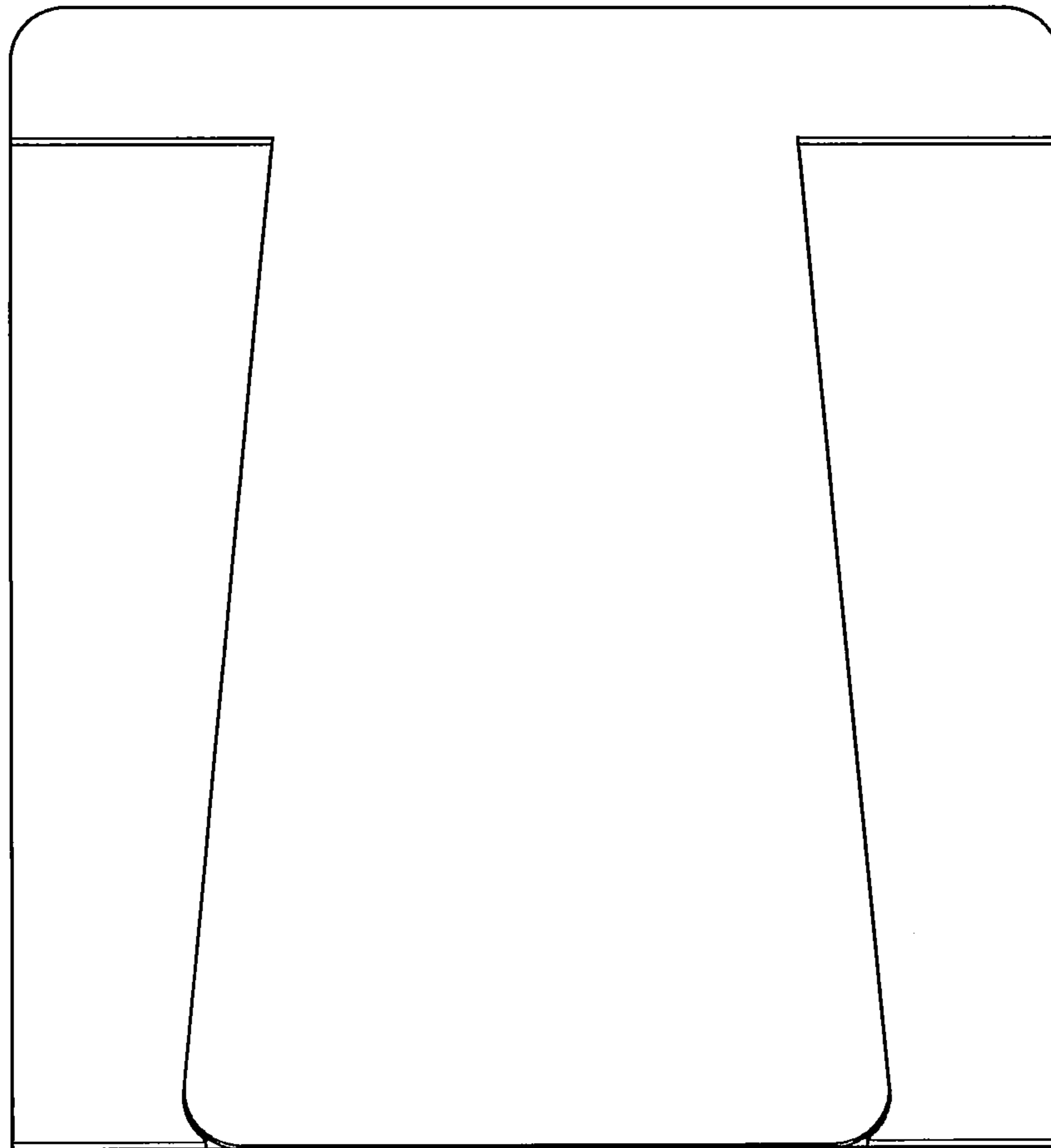

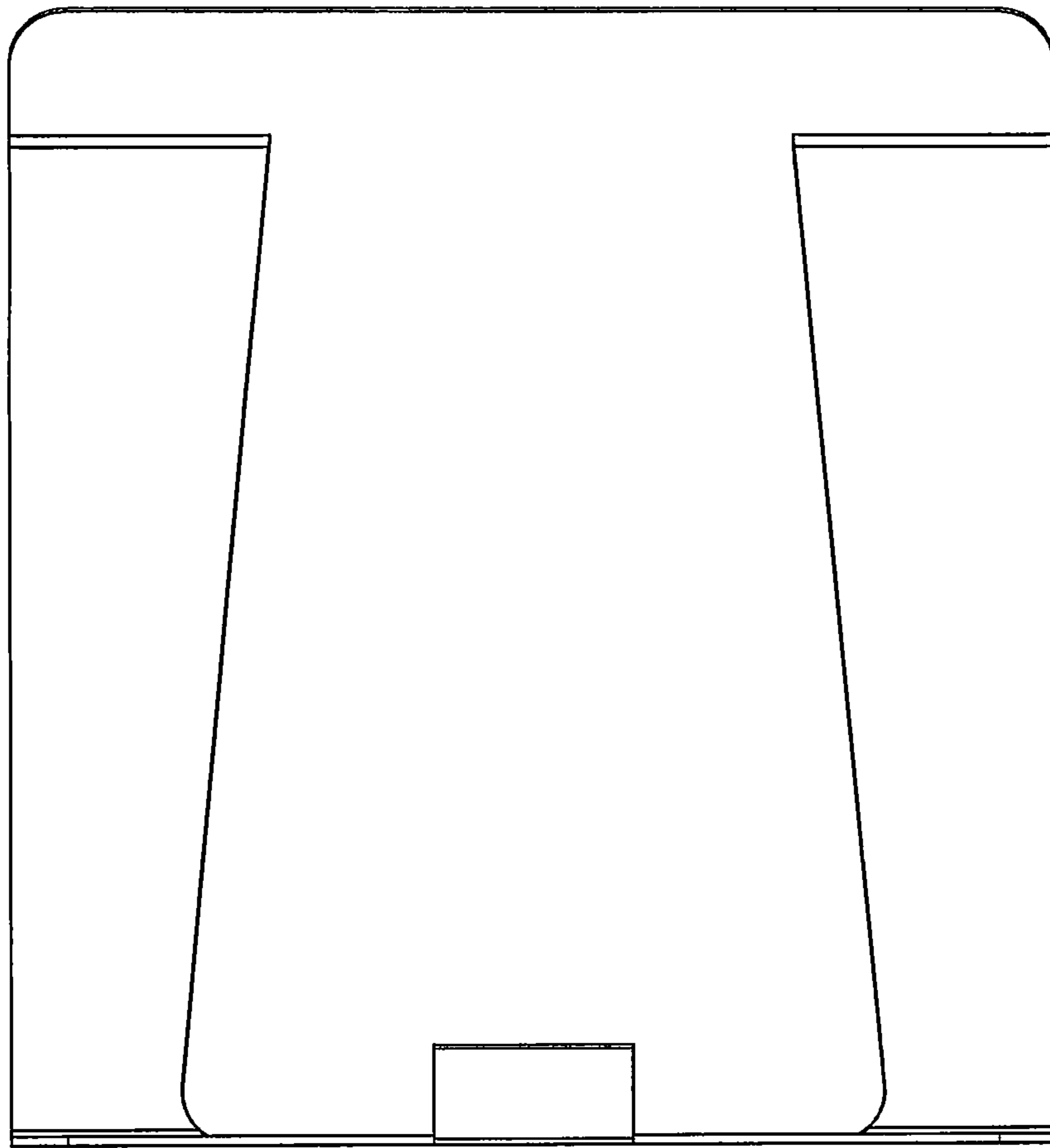

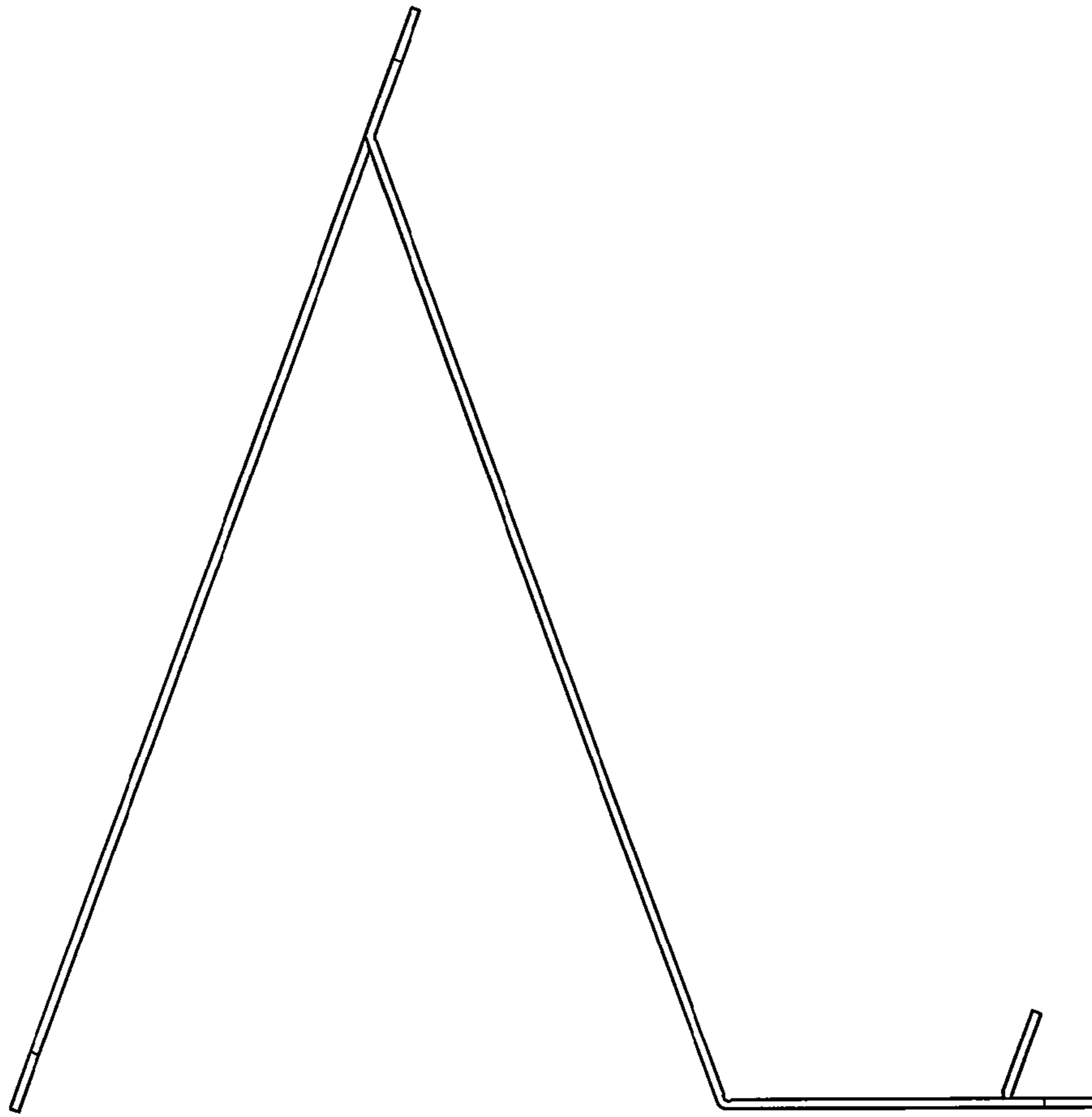

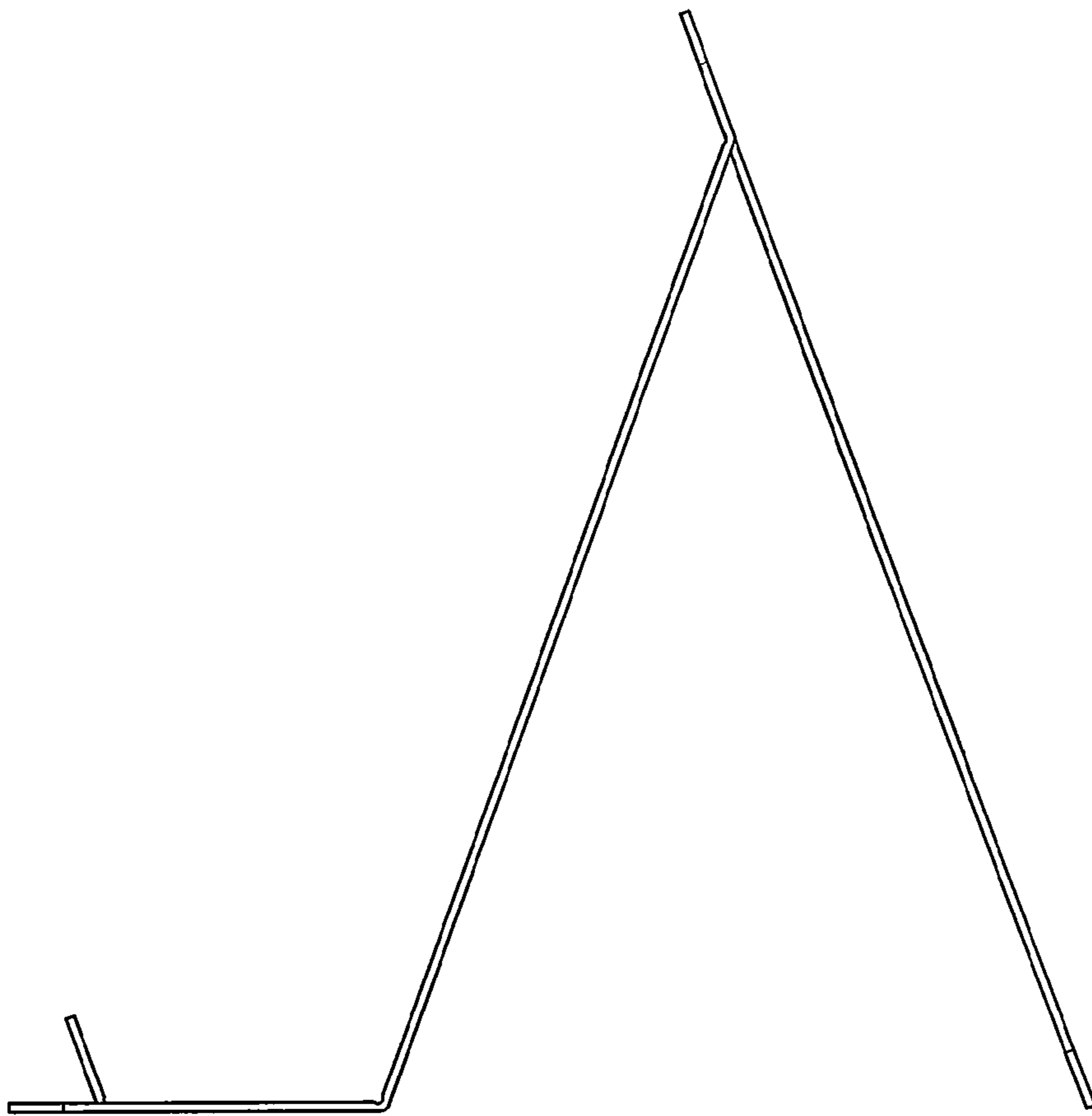

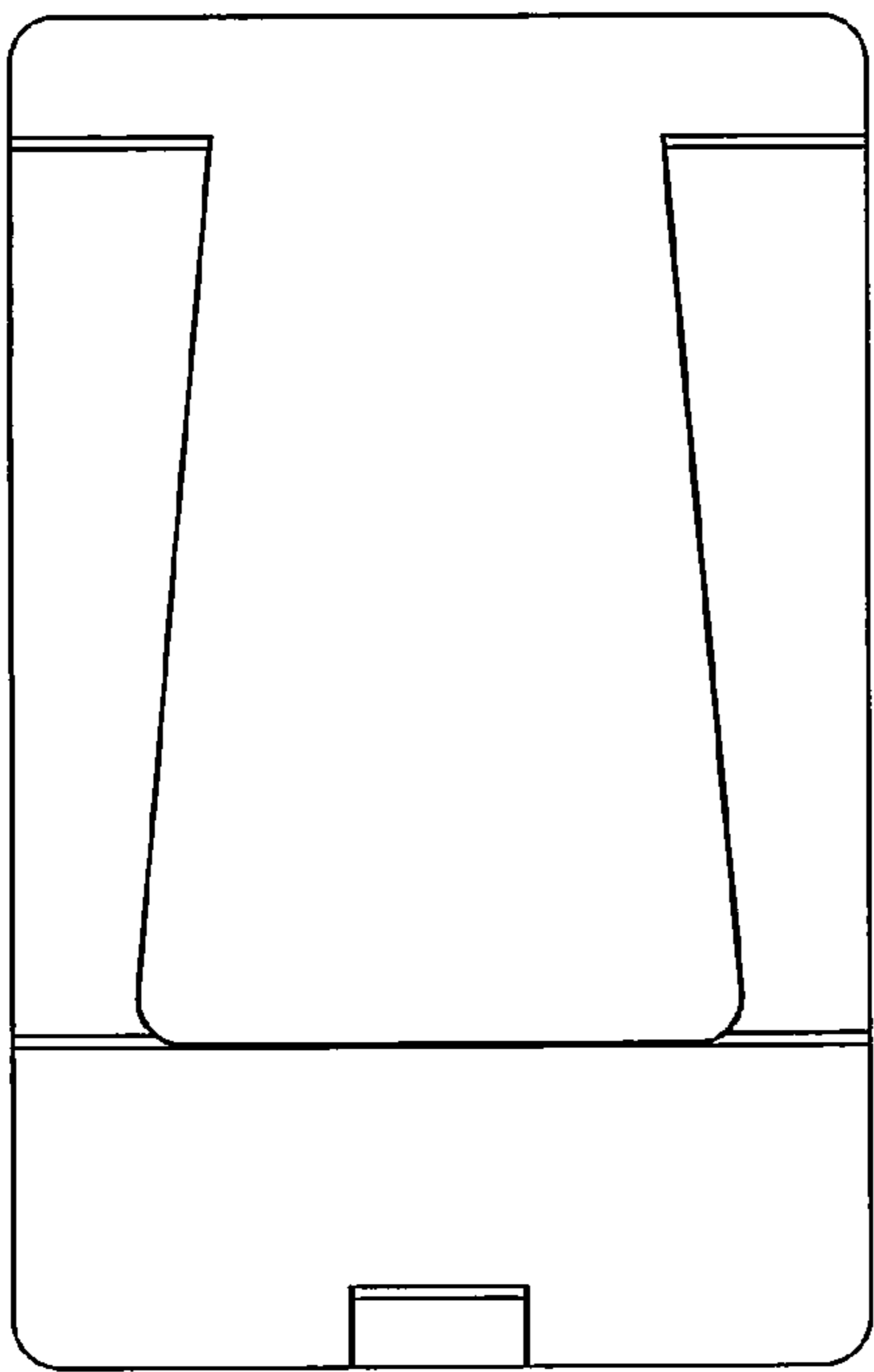
