FIG. 2 is a perspective rear view of the first component of the set of game components showing the other three sides of the die of FIG. 1;
FIG. 3 is a plan view of the blank of FIGS. 1 and 2;
FIG. 4 is a top plan view of a second component of the set of game components, the tokens;
FIG. 5 is a bottom plan view of the second components of the set of game components;
FIG. 6 is a left side elevation view of the second components of the set of game components;
FIG. 7 is a front elevation view of the second components of the set of game components;
FIG. 8 is a top plan view of a third component of the set of game components, the game board;
FIG. 9 is a right side elevation view of the third component of a set of game components; and,
FIG. 10 is a front elevation view of the third component of a set of game components.
The width of the game board is shown in broken lines for illustrative purposes of the depth of the game board only and forms no part of the claimed design.

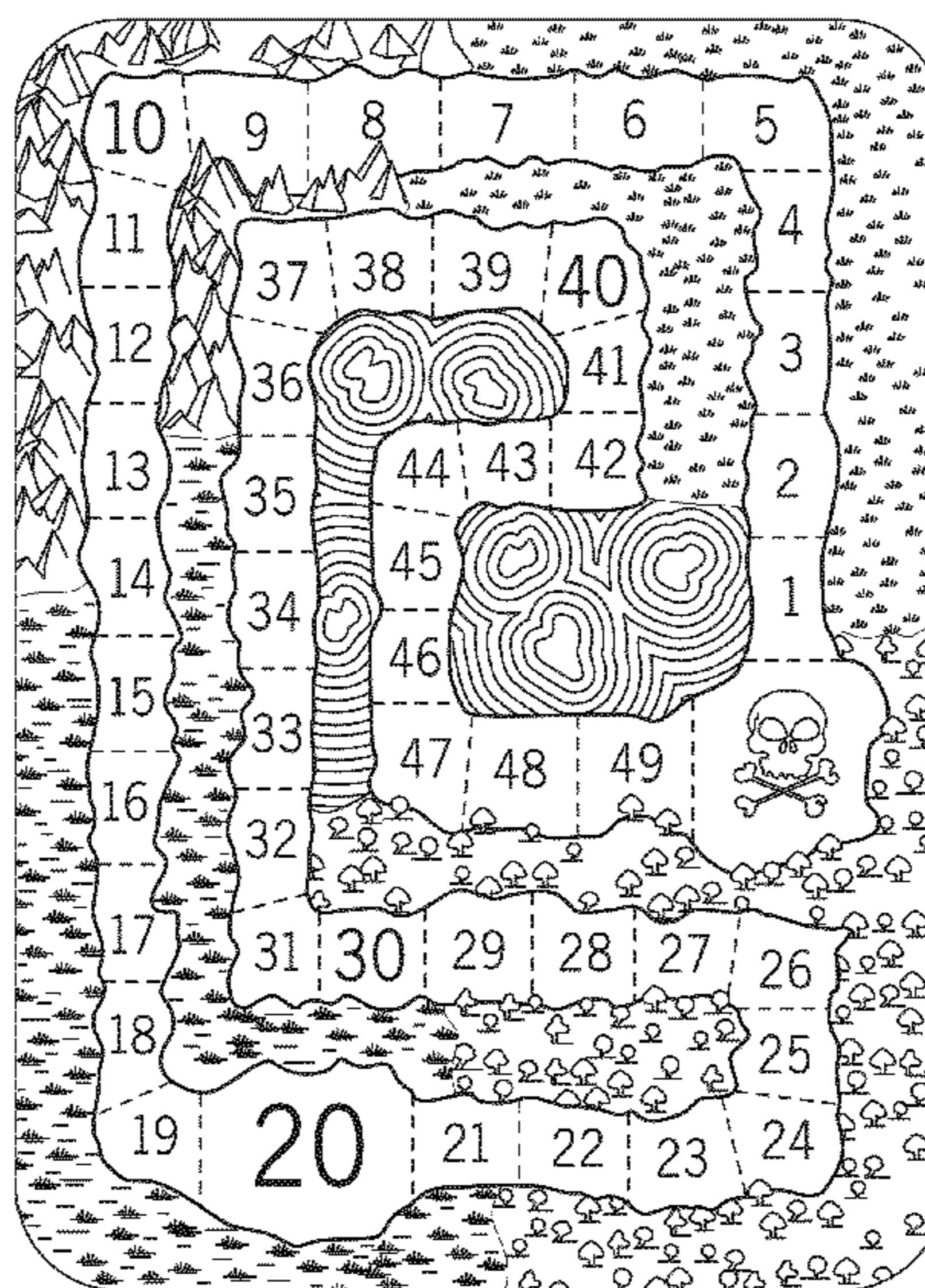
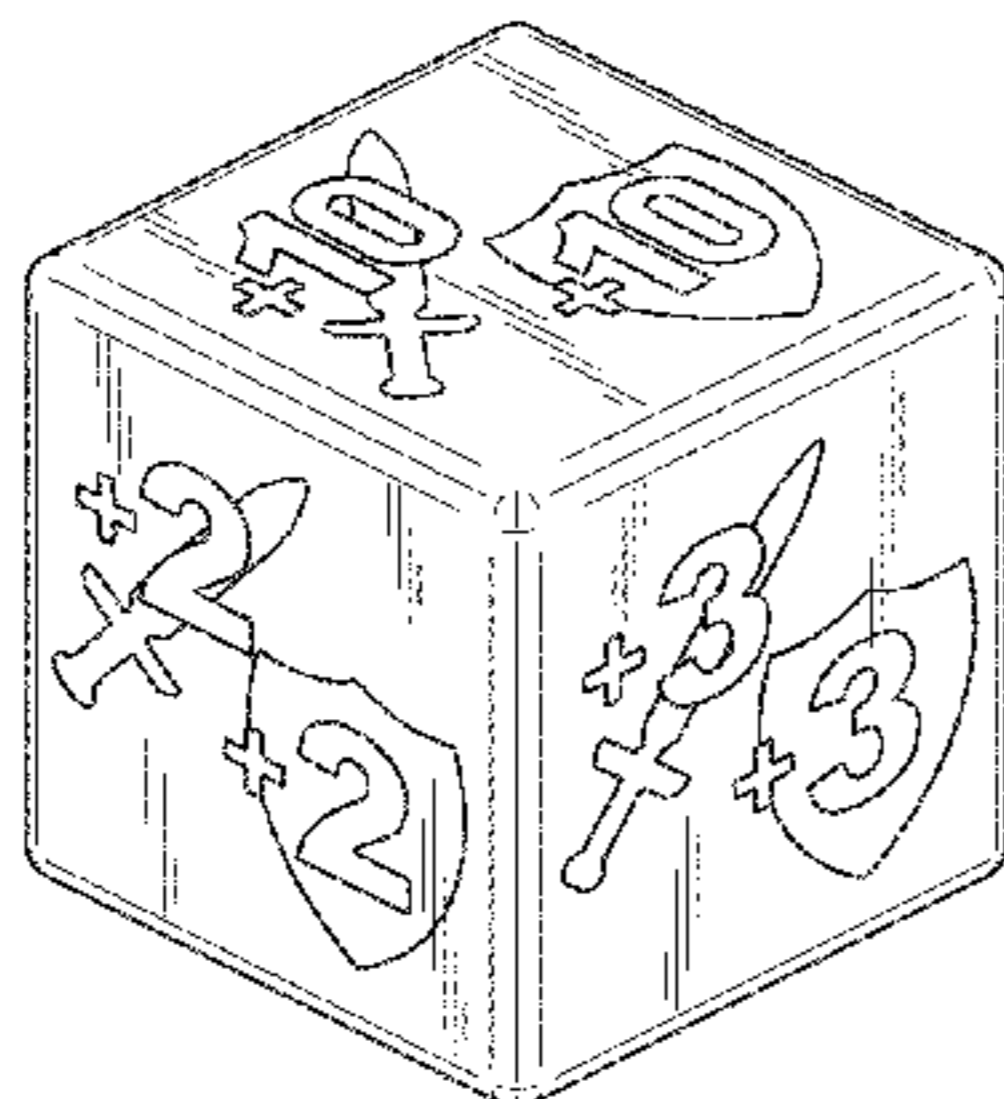

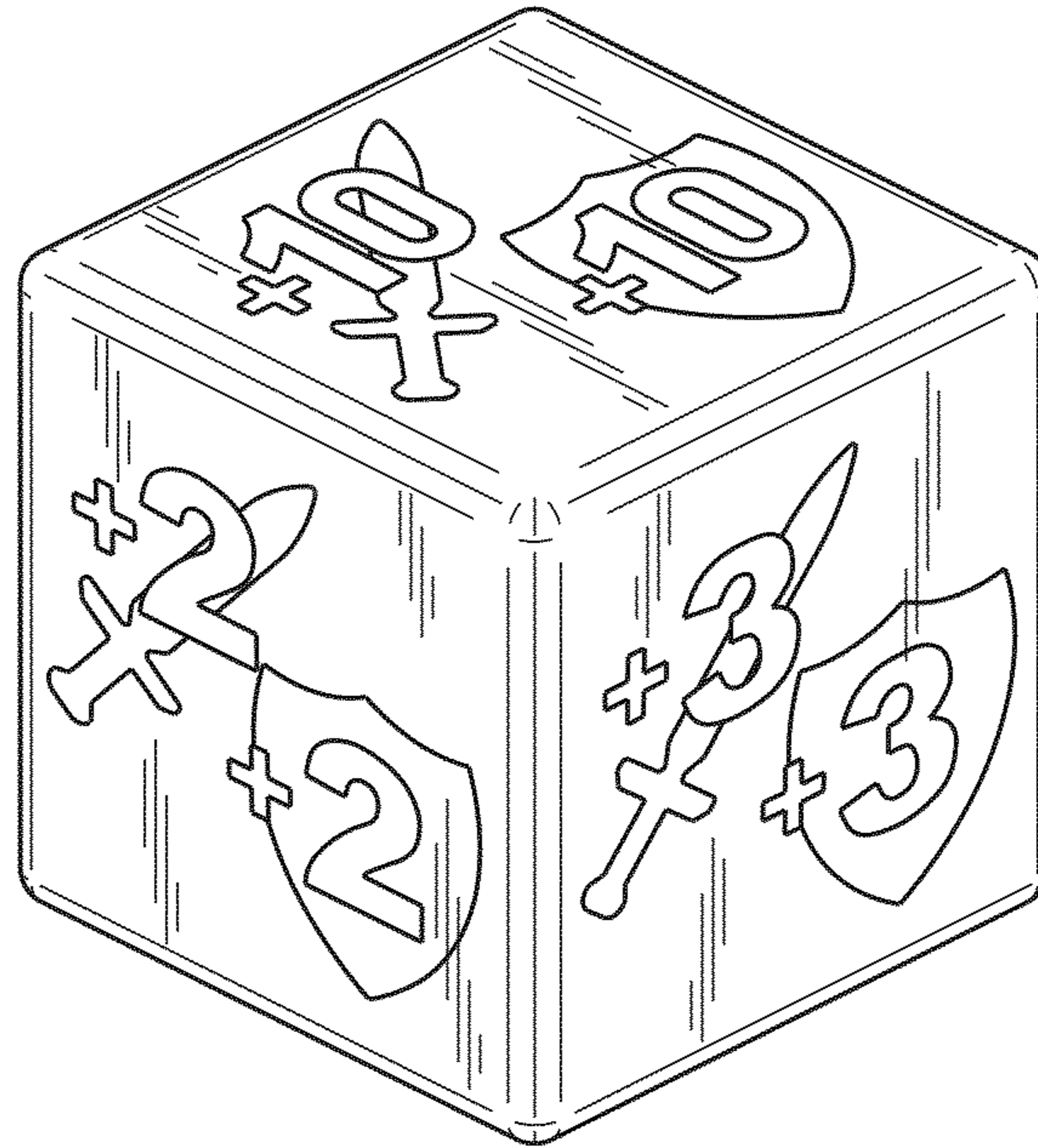
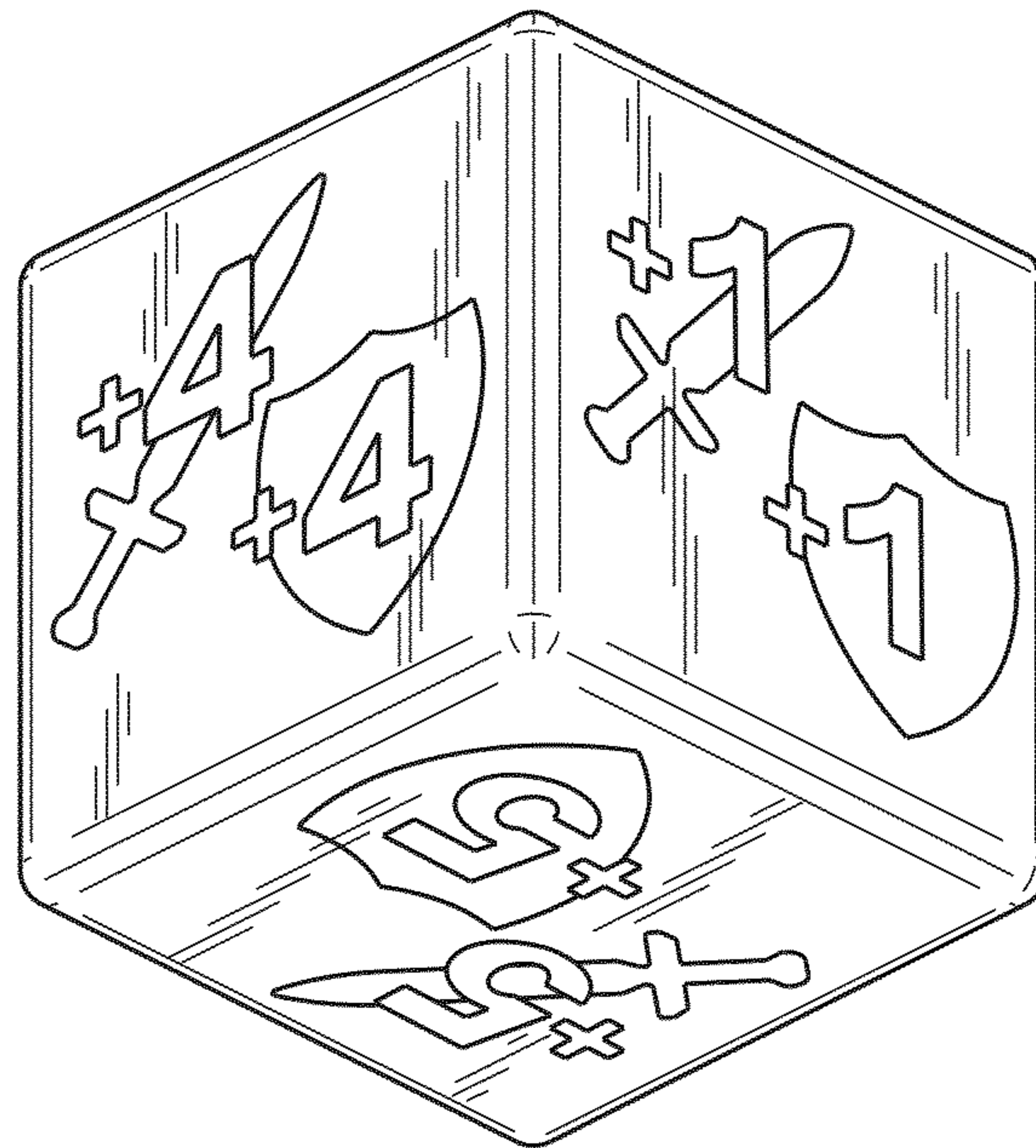

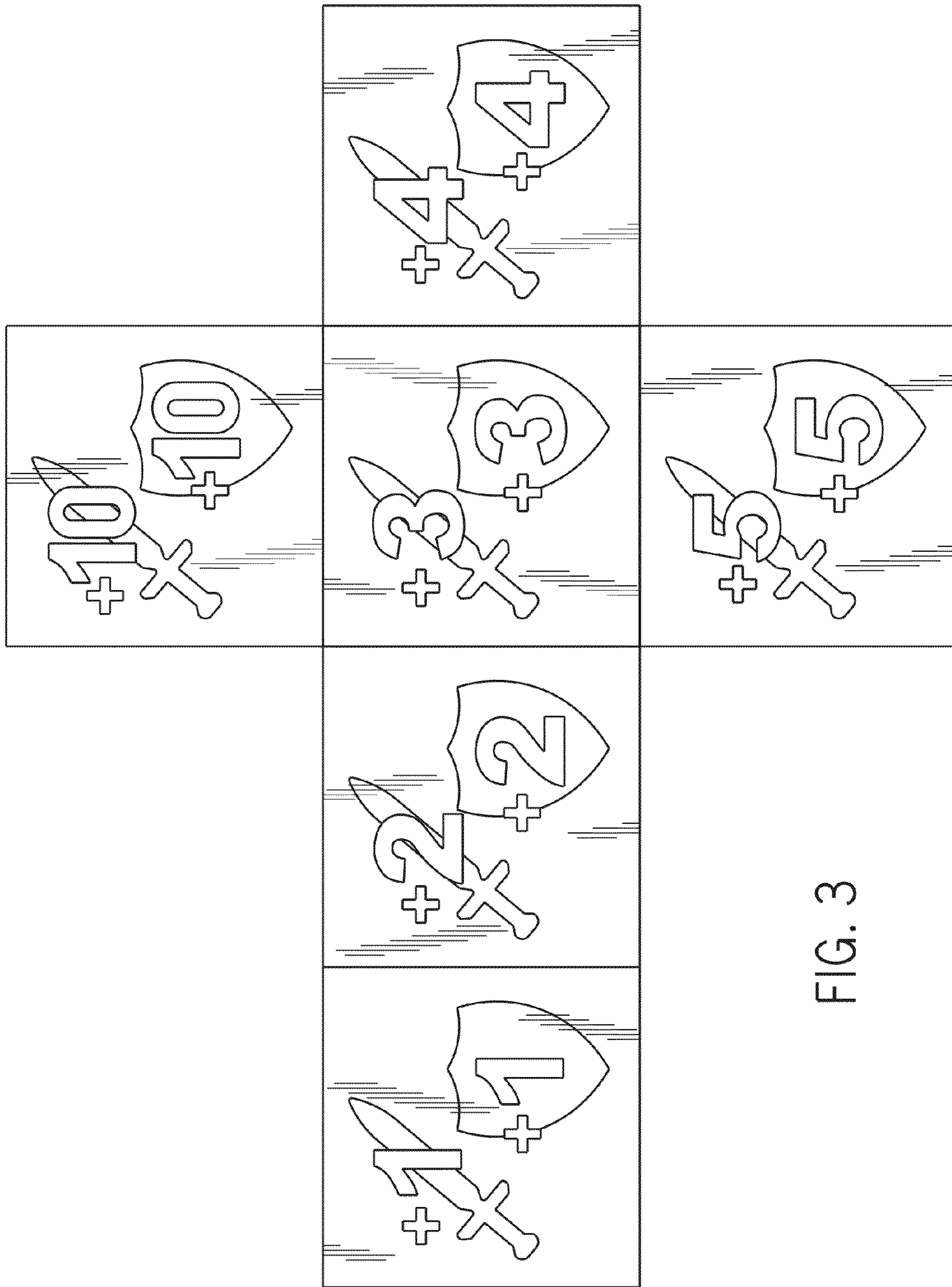

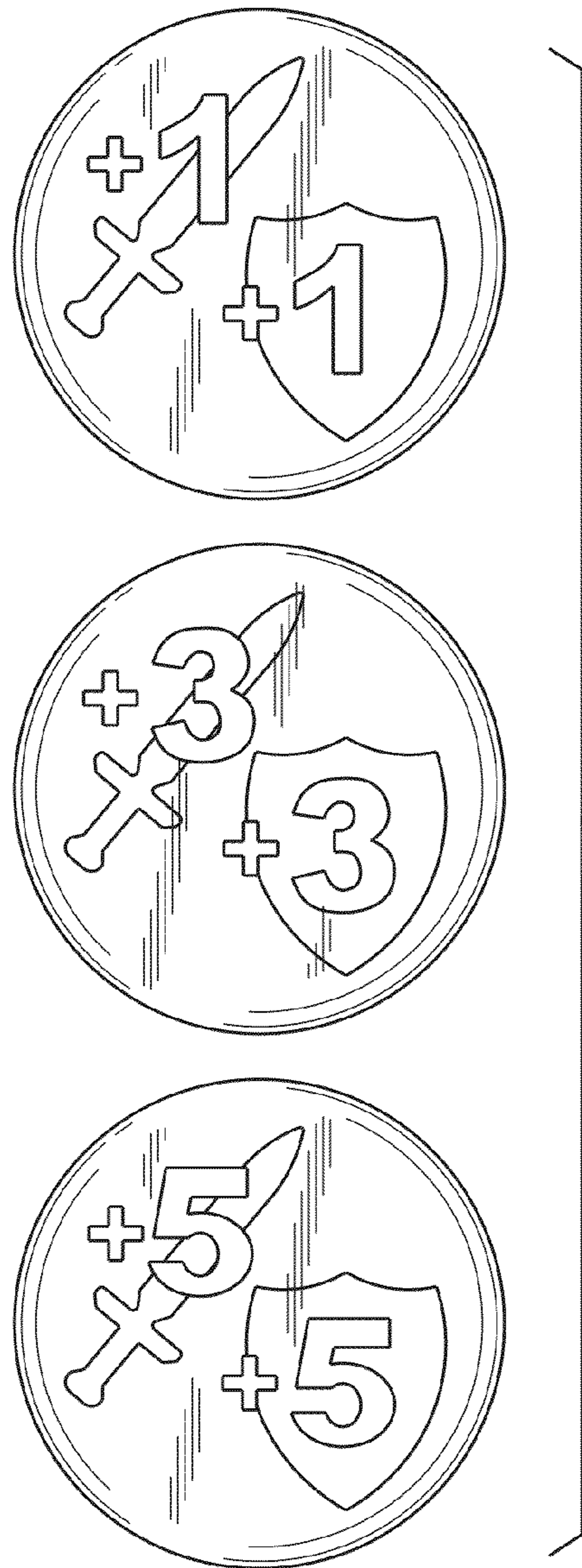

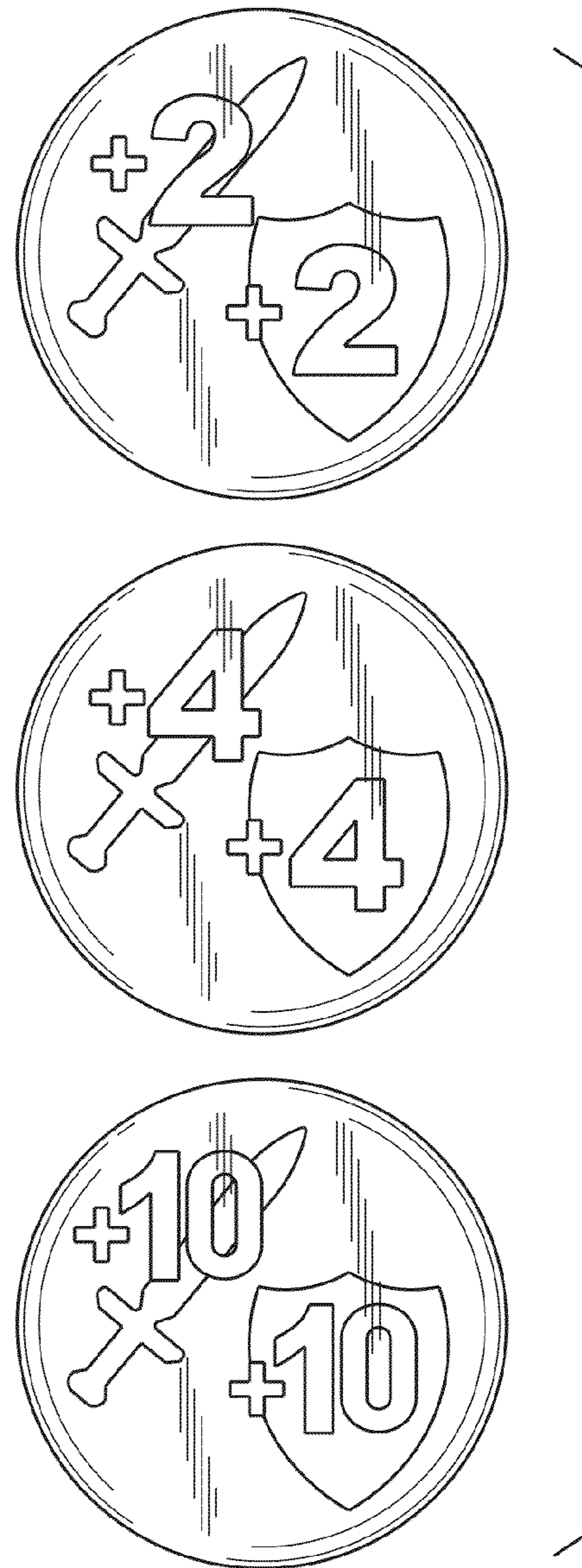

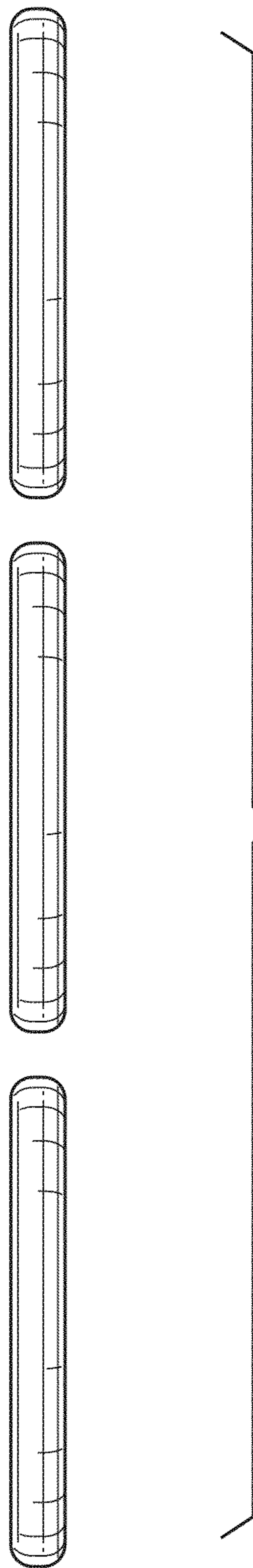

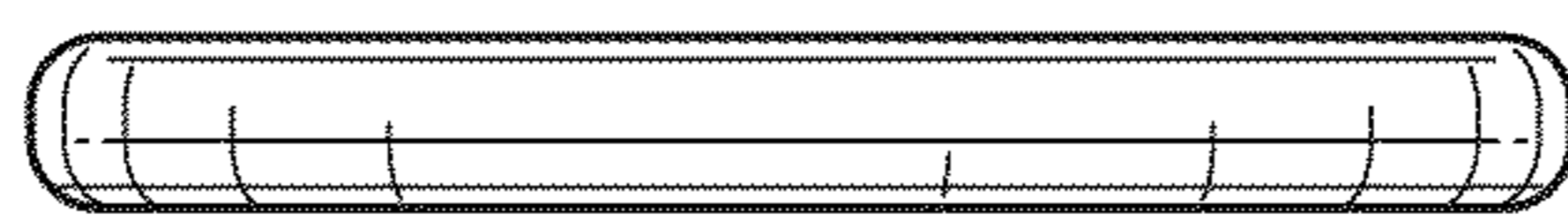

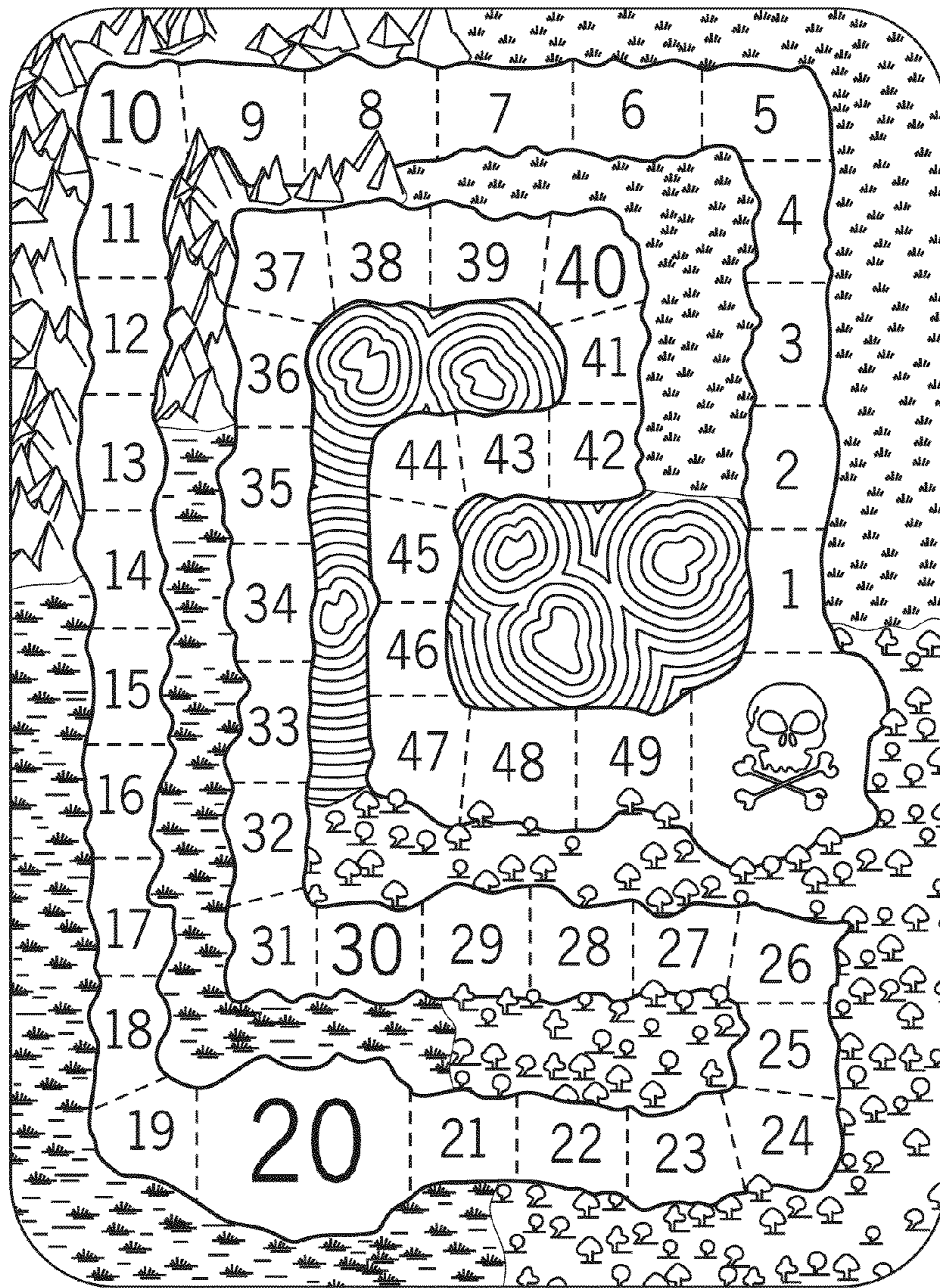
