**DESCRIPTION**

FIG. 3 is a front view thereof.

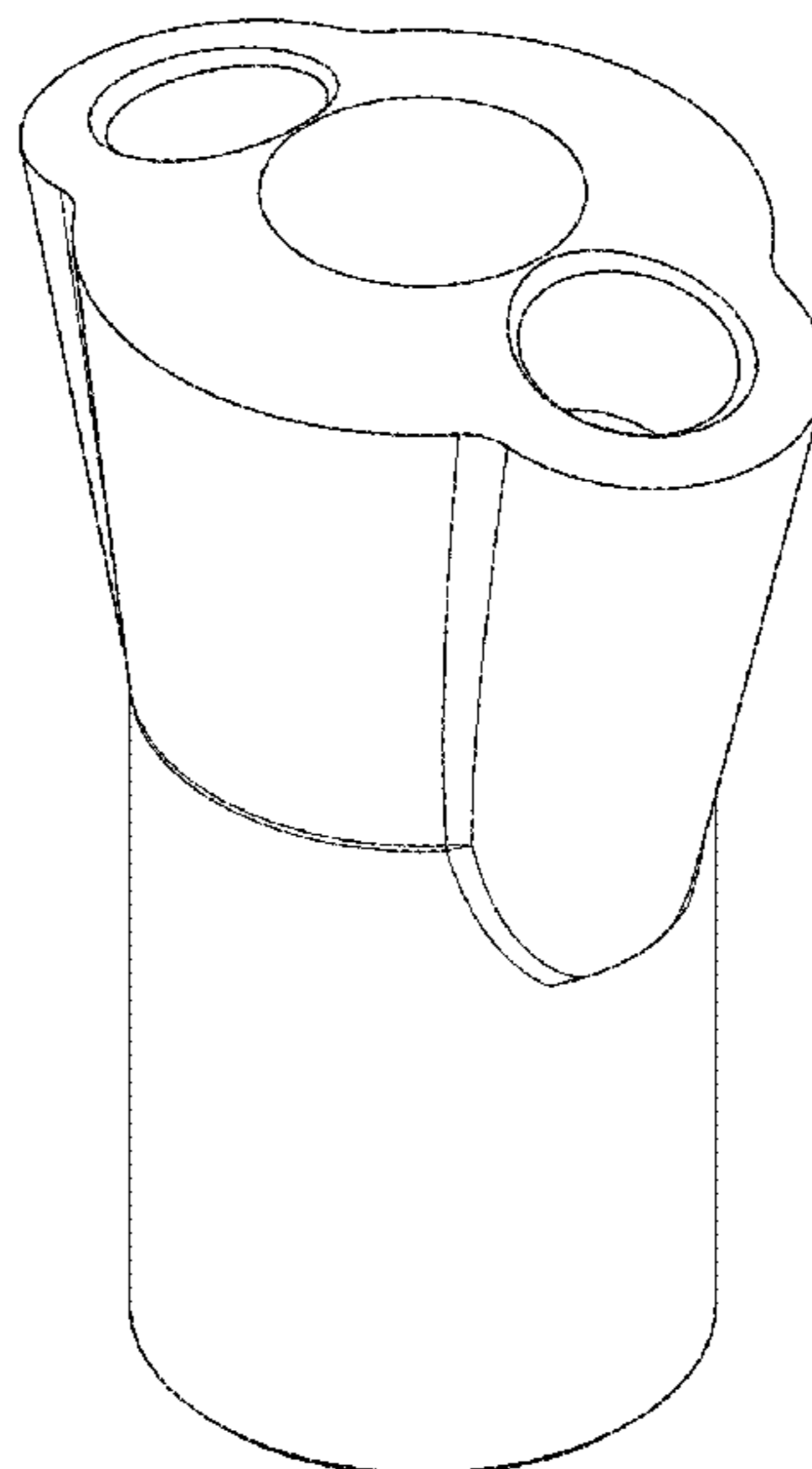
FIG. 4 is a rear view thereof.

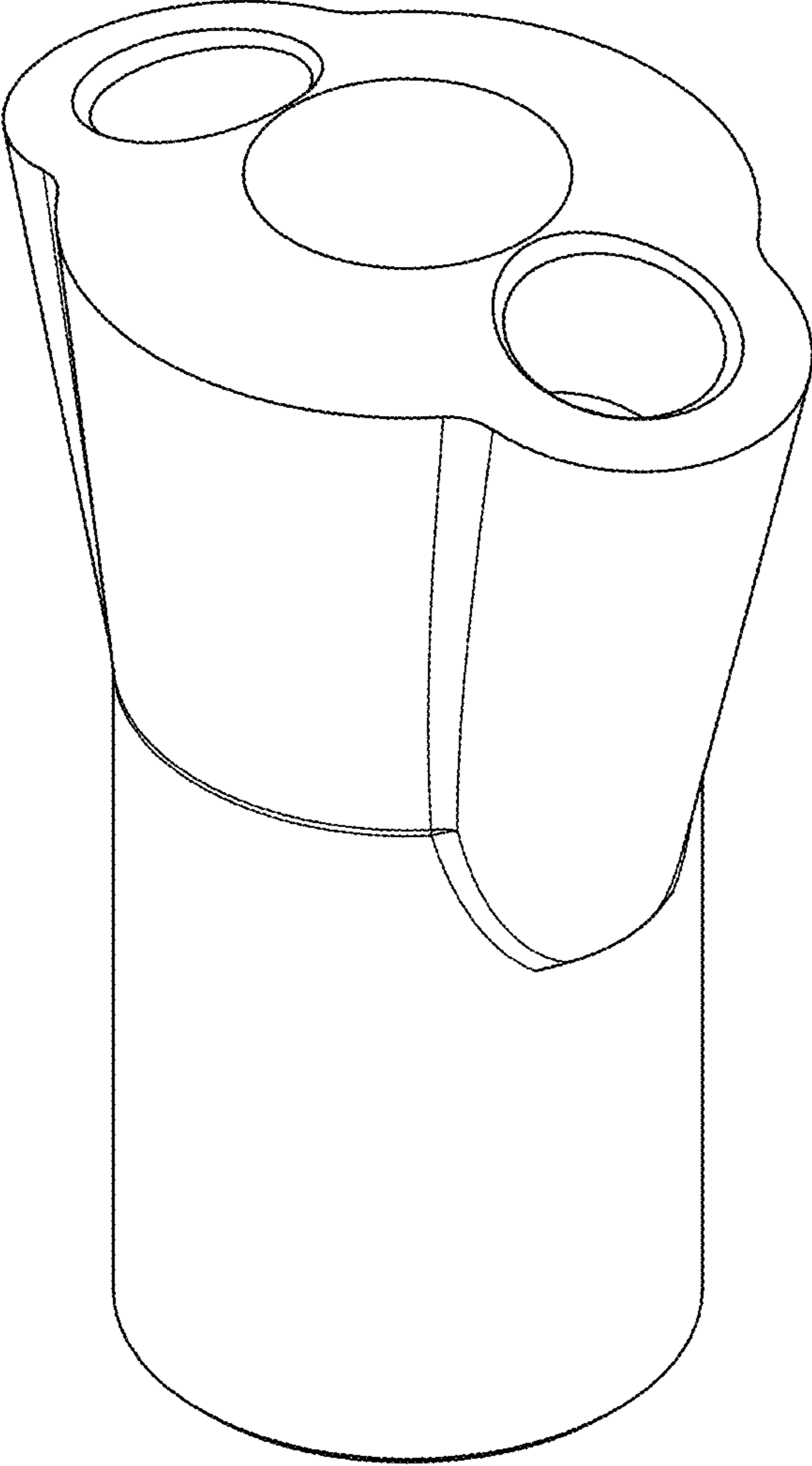

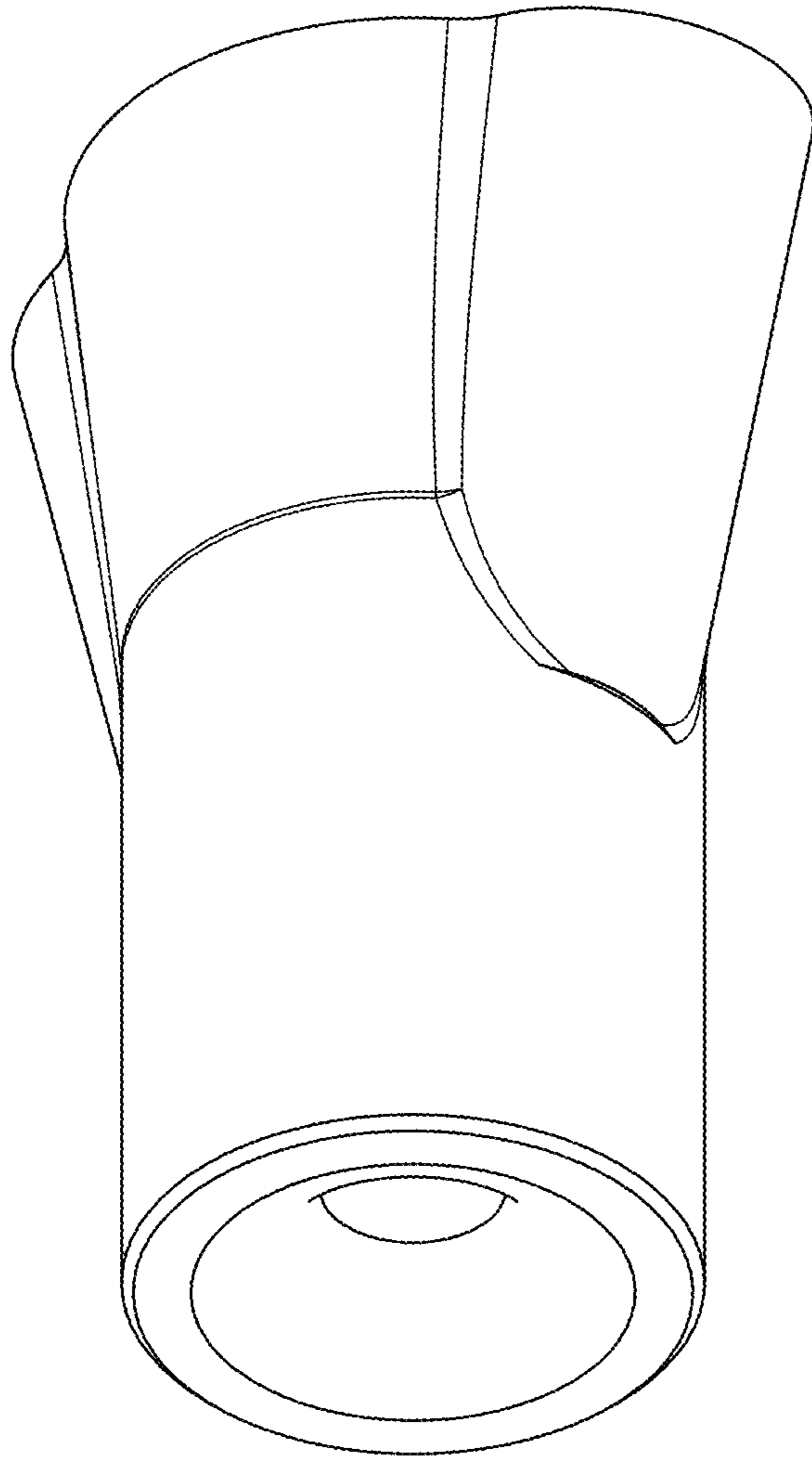

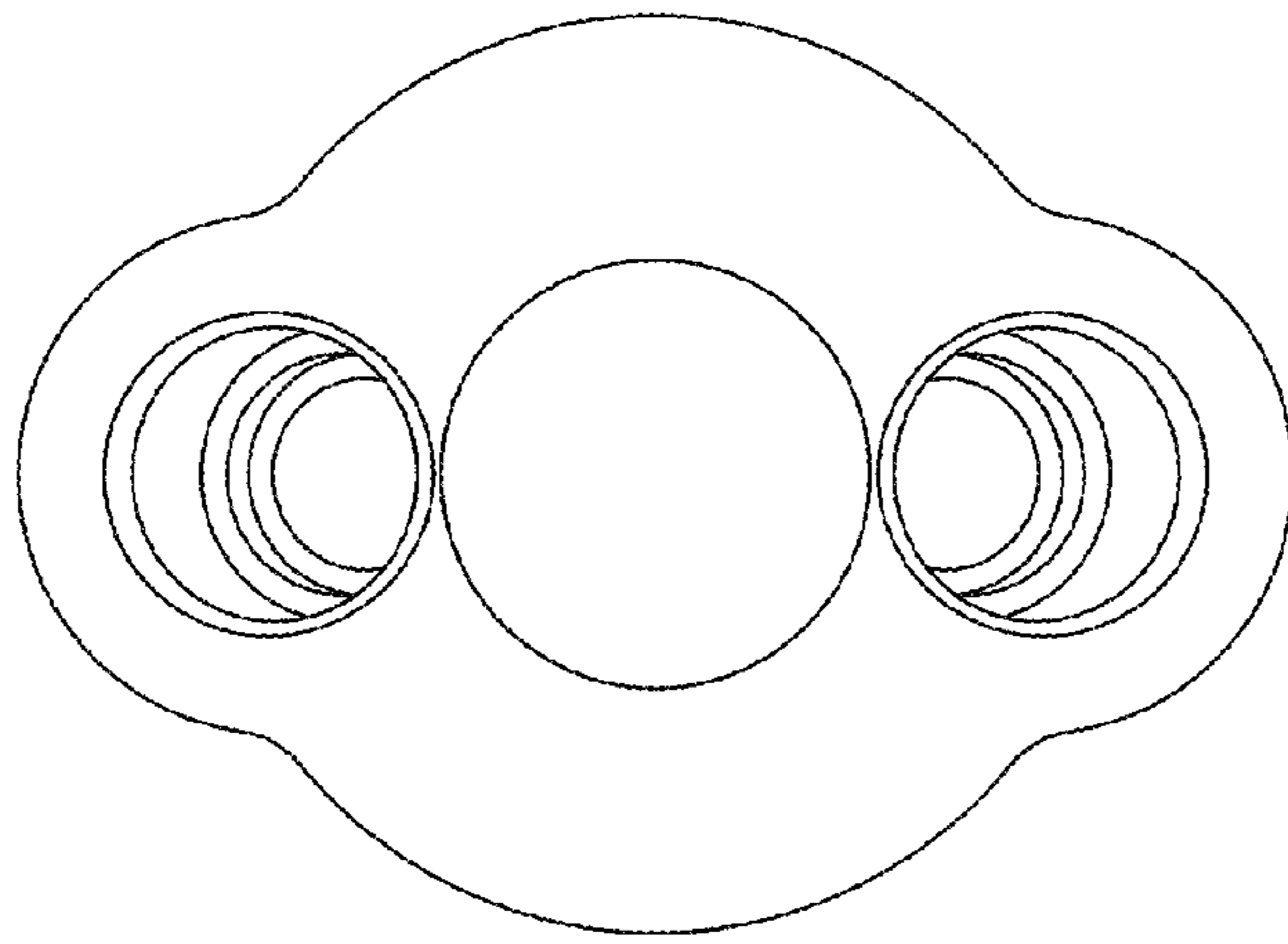

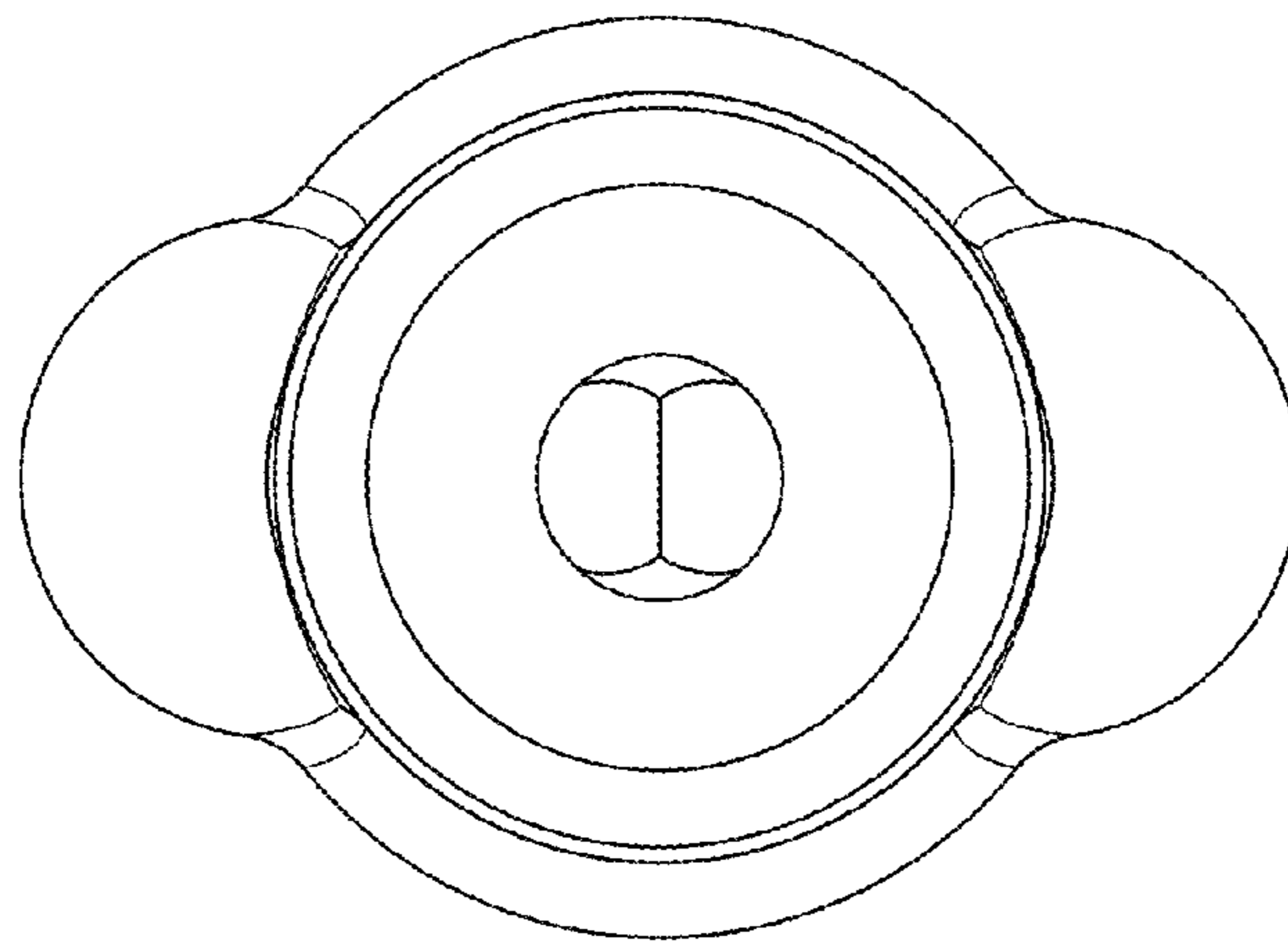

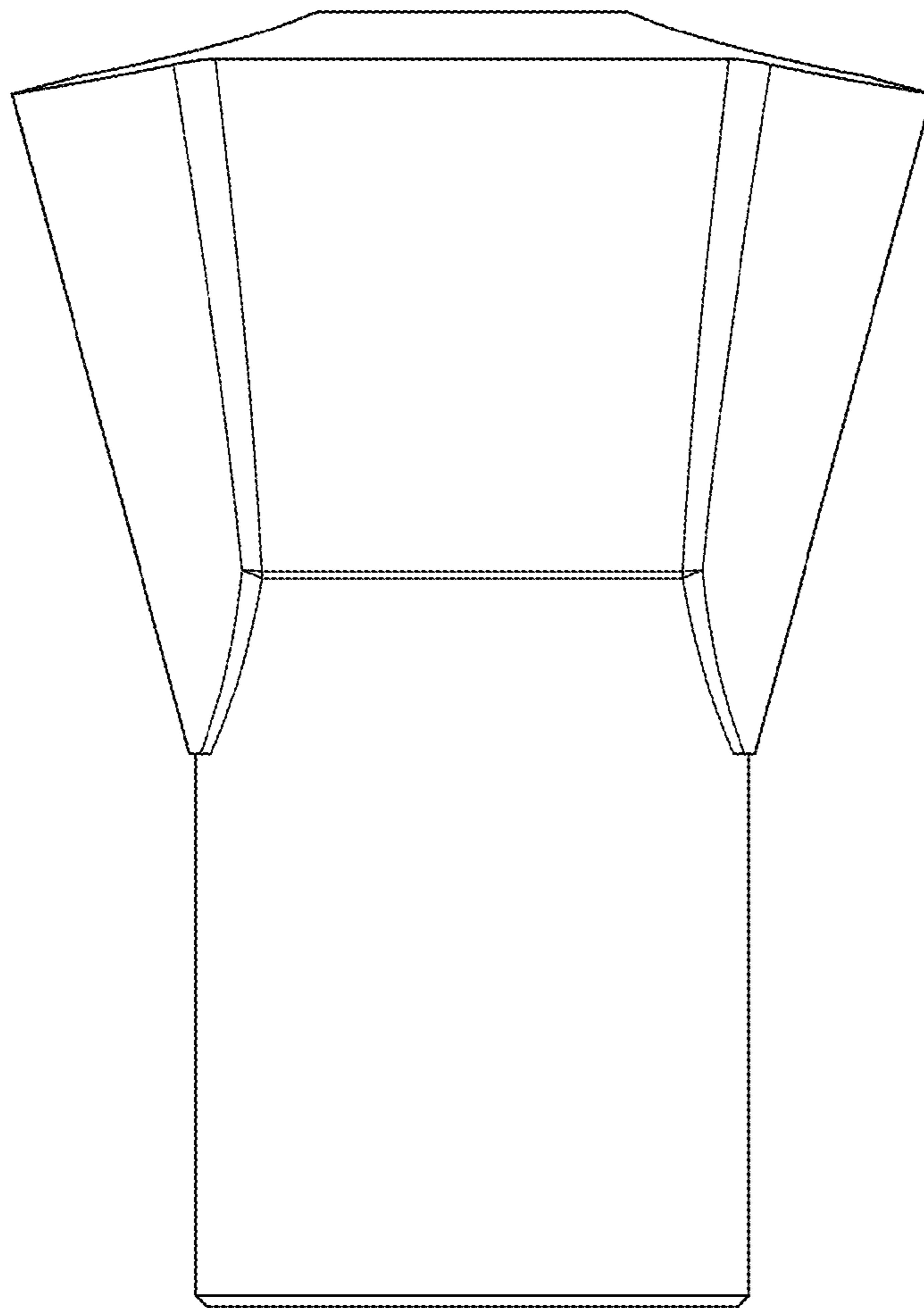

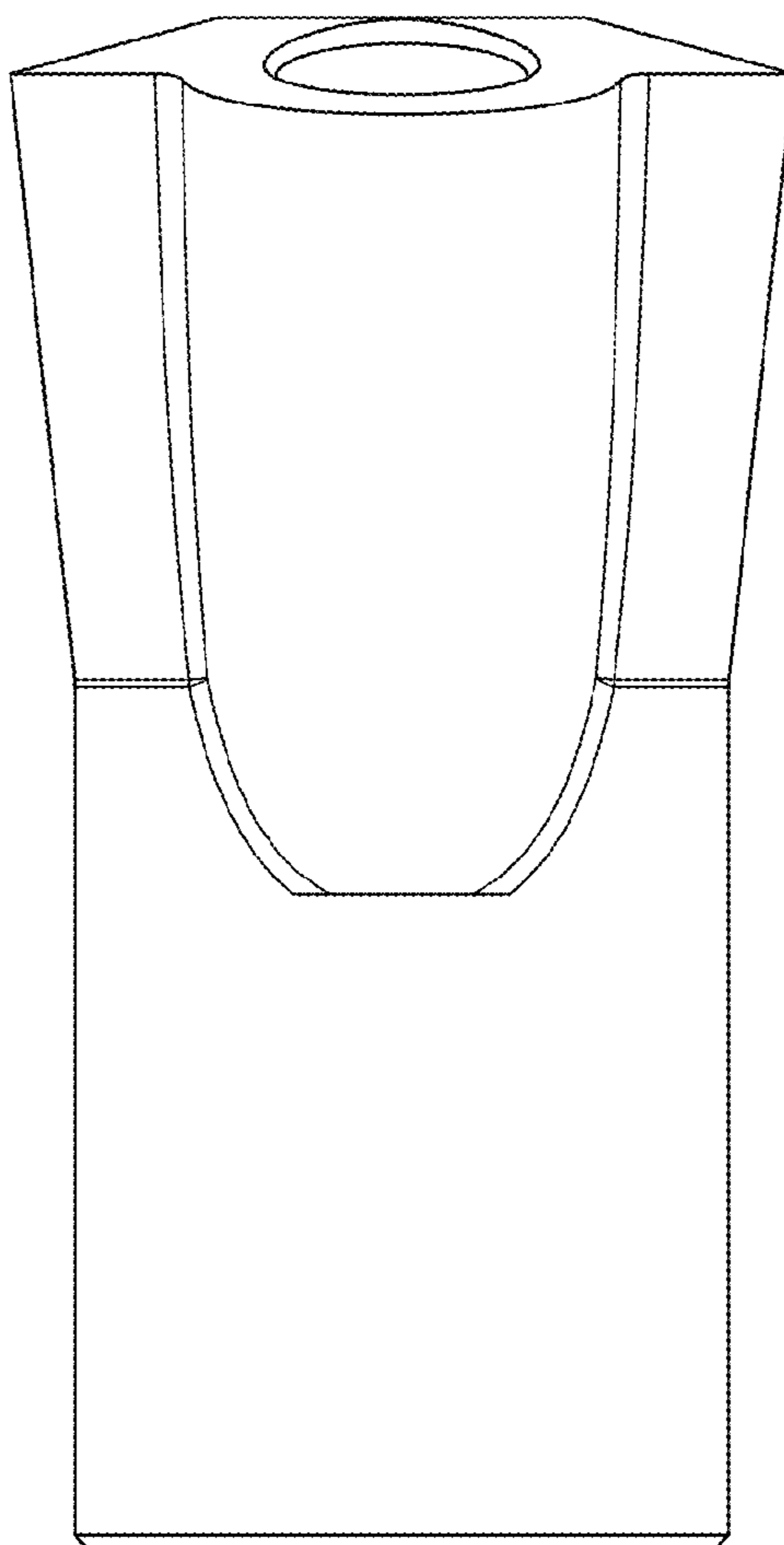
