(57) **CLAIM**

The ornamental design for a hand-held submersible pool and spa vacuum cleaner, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, rear, right side perspective view of a first embodiment of a hand-held submersible pool and spa vacuum cleaner showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a top, rear, right side perspective view of a second embodiment of the hand-held submersible pool and spa vacuum cleaner showing our new design and being the same as the first embodiment except with a forward housing portion being transparent; FIG. 9 is a top plan view thereof; FIG. 10 is a right side elevational view thereof; FIG. 11 is a front elevational view thereof; FIG. 12 is a left side elevational view thereof; FIG. 13 is a rear elevational view thereof; and, FIG. 14 is a bottom plan view thereof.

The broken lines showing structural features are included for the purpose of illustrating non-claimed subject matter and form no part of the claimed design.

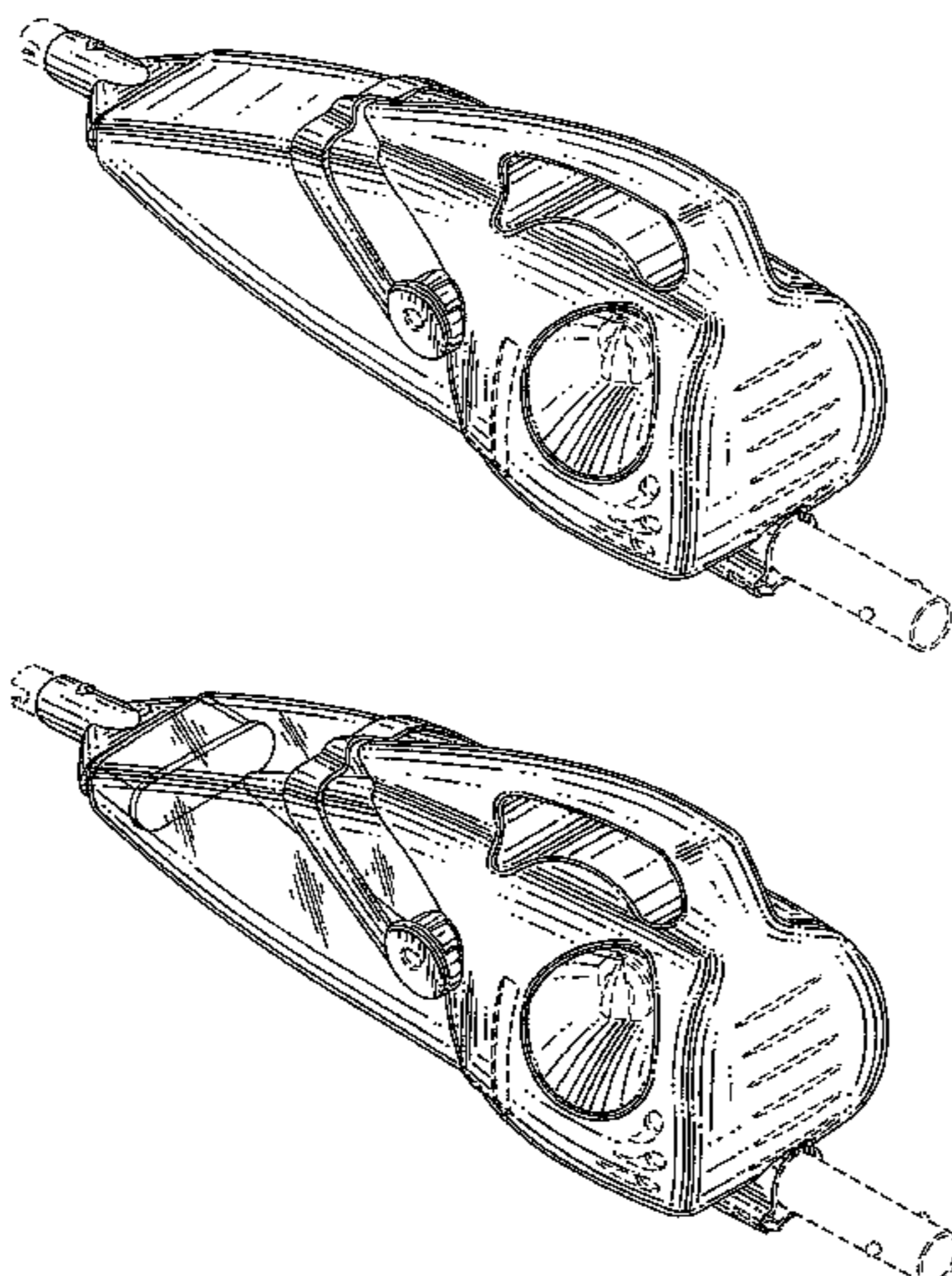

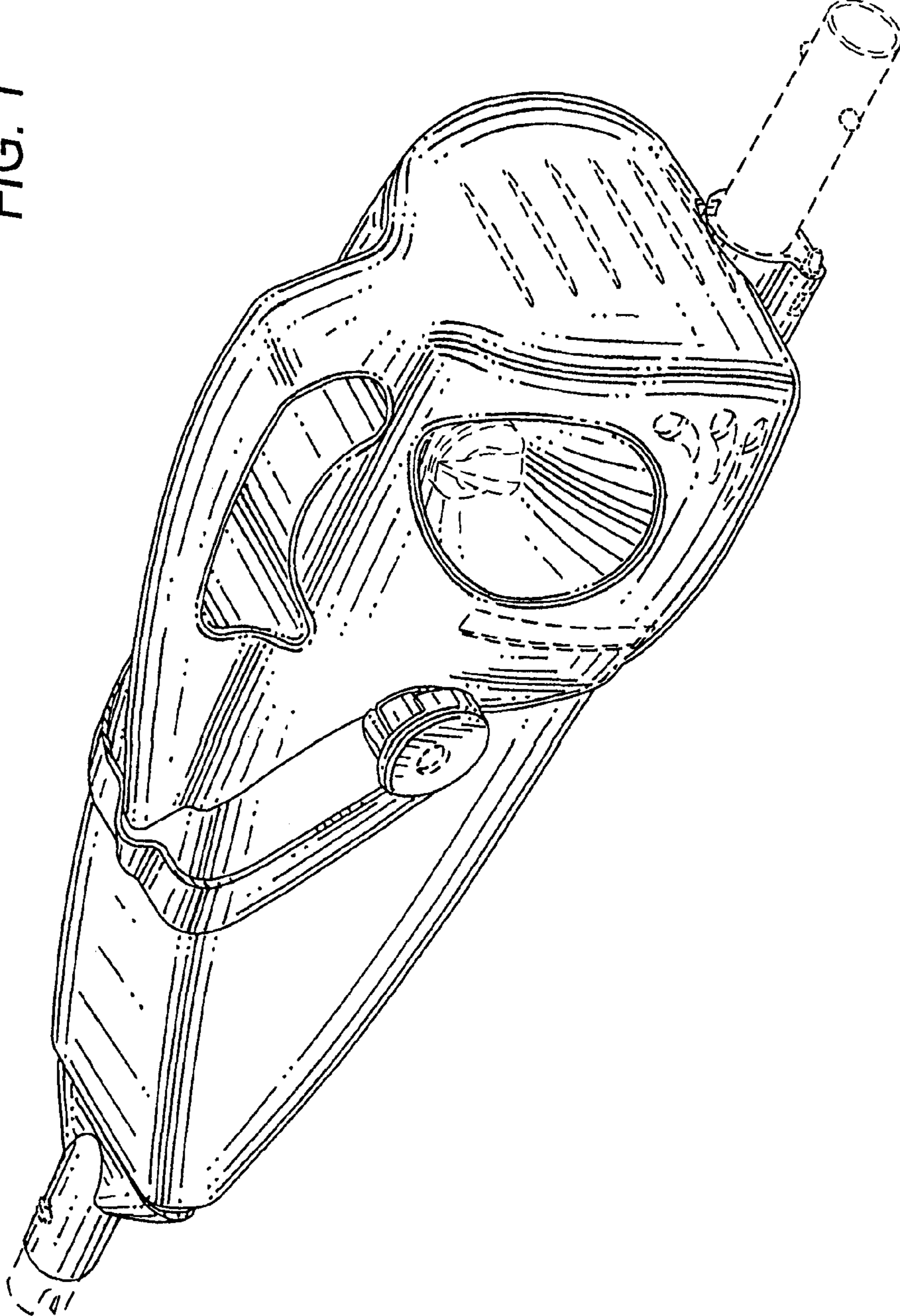
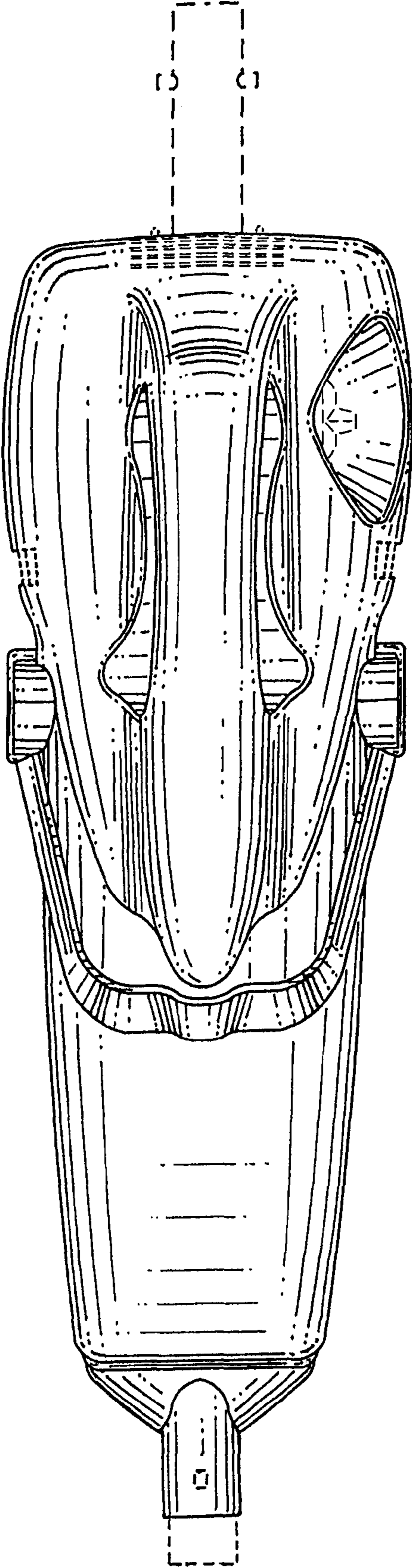

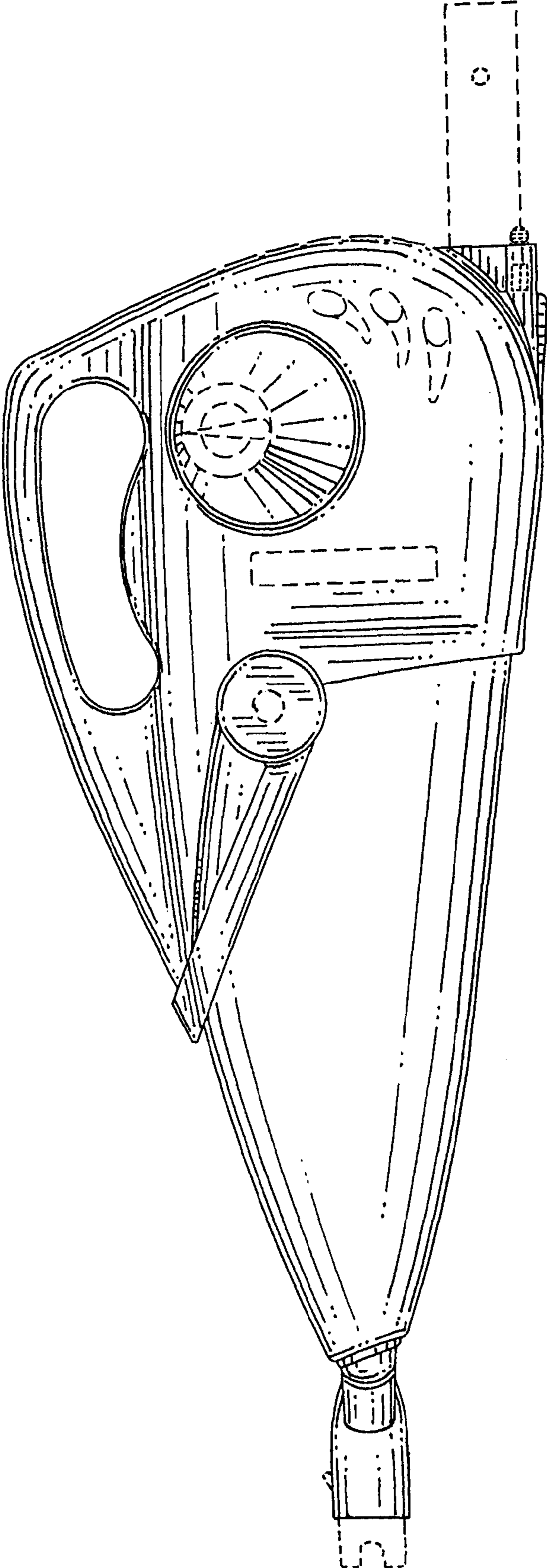

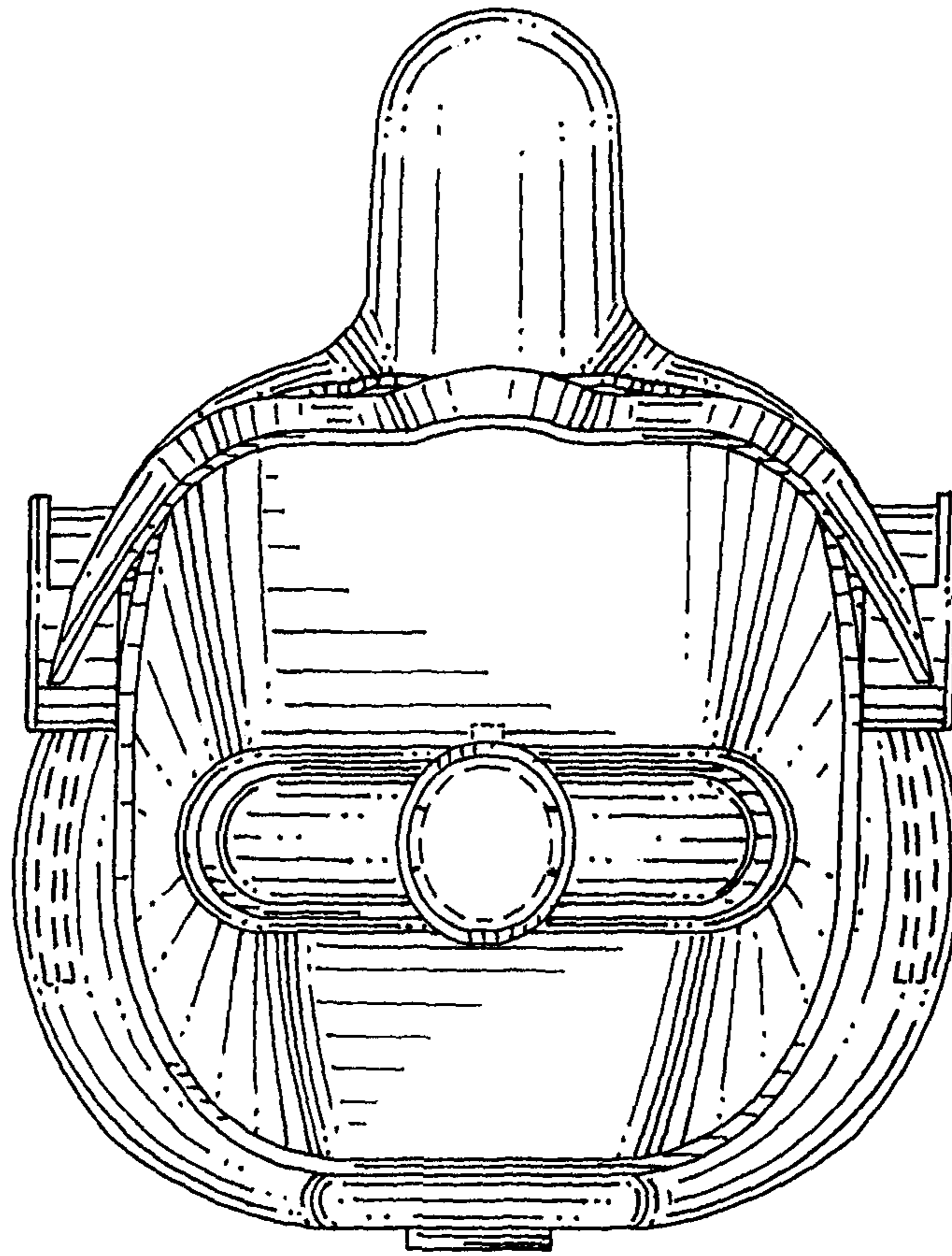
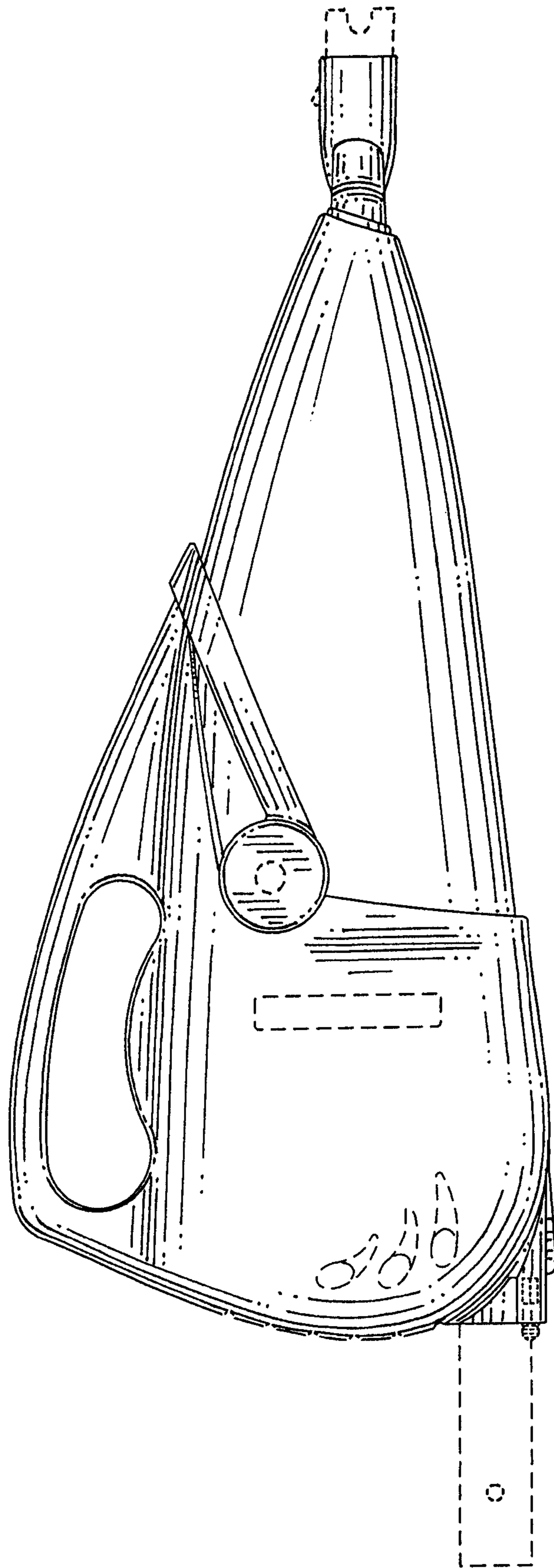

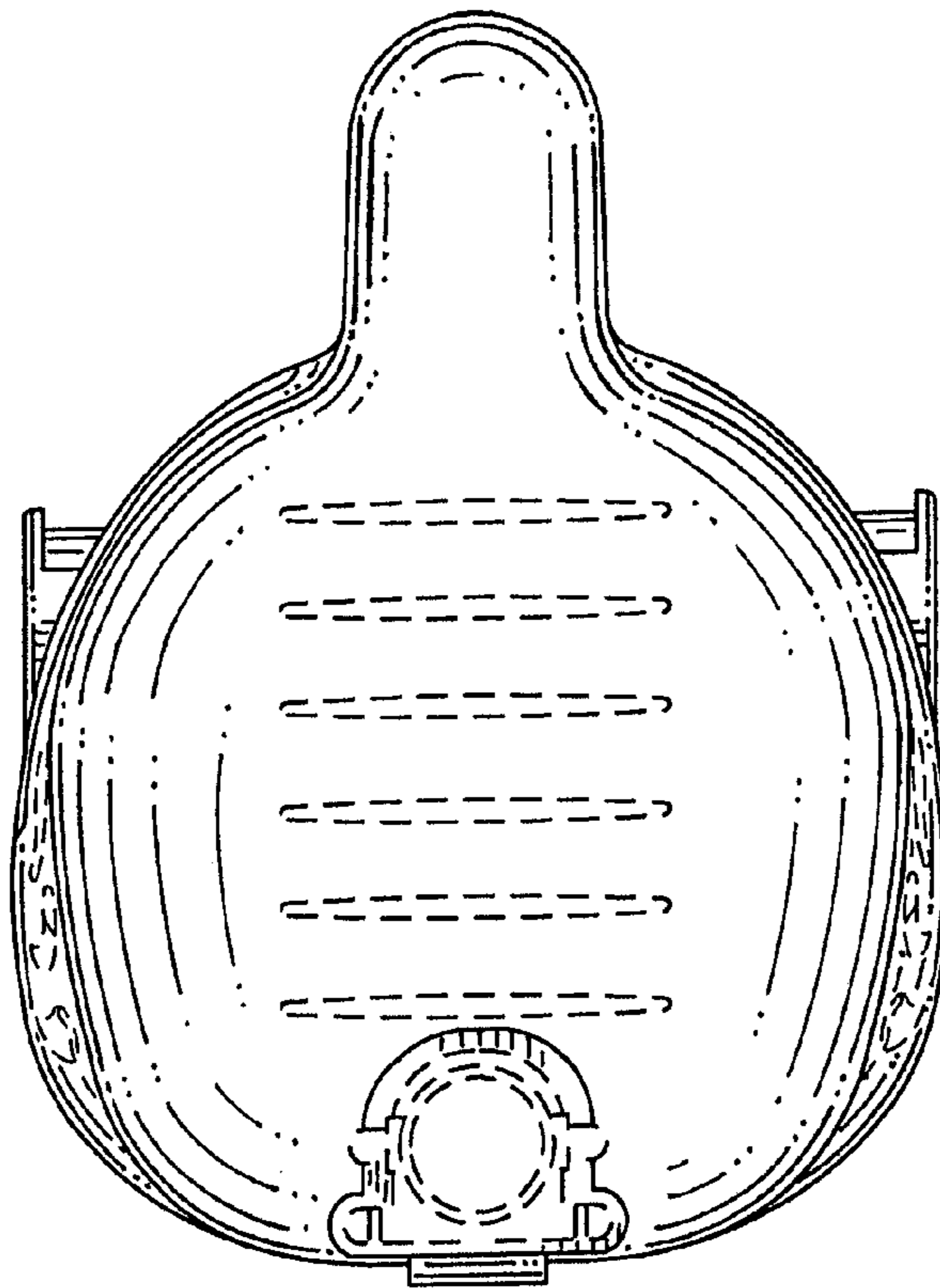

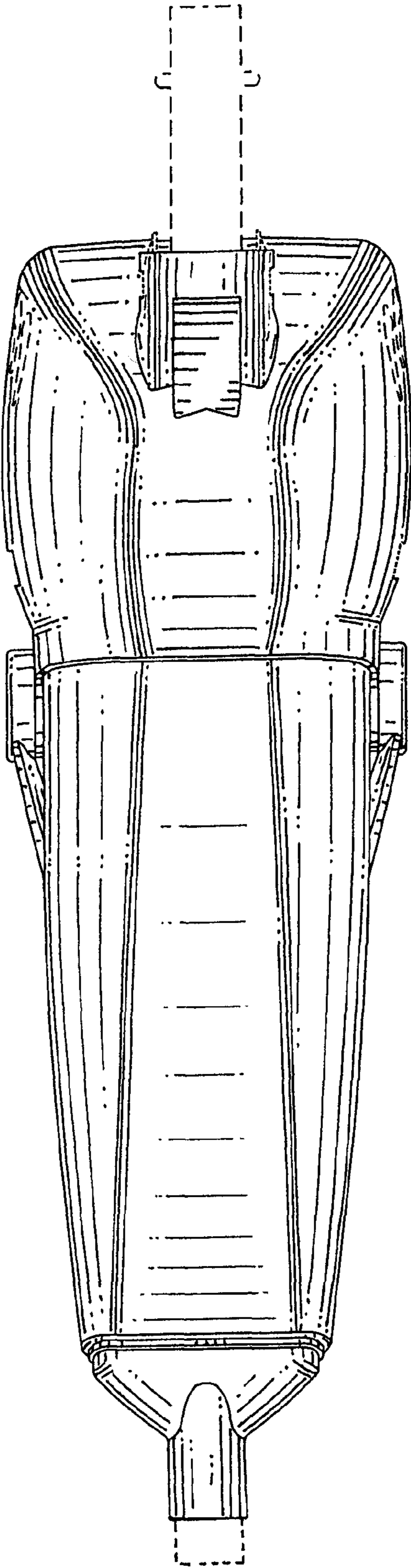

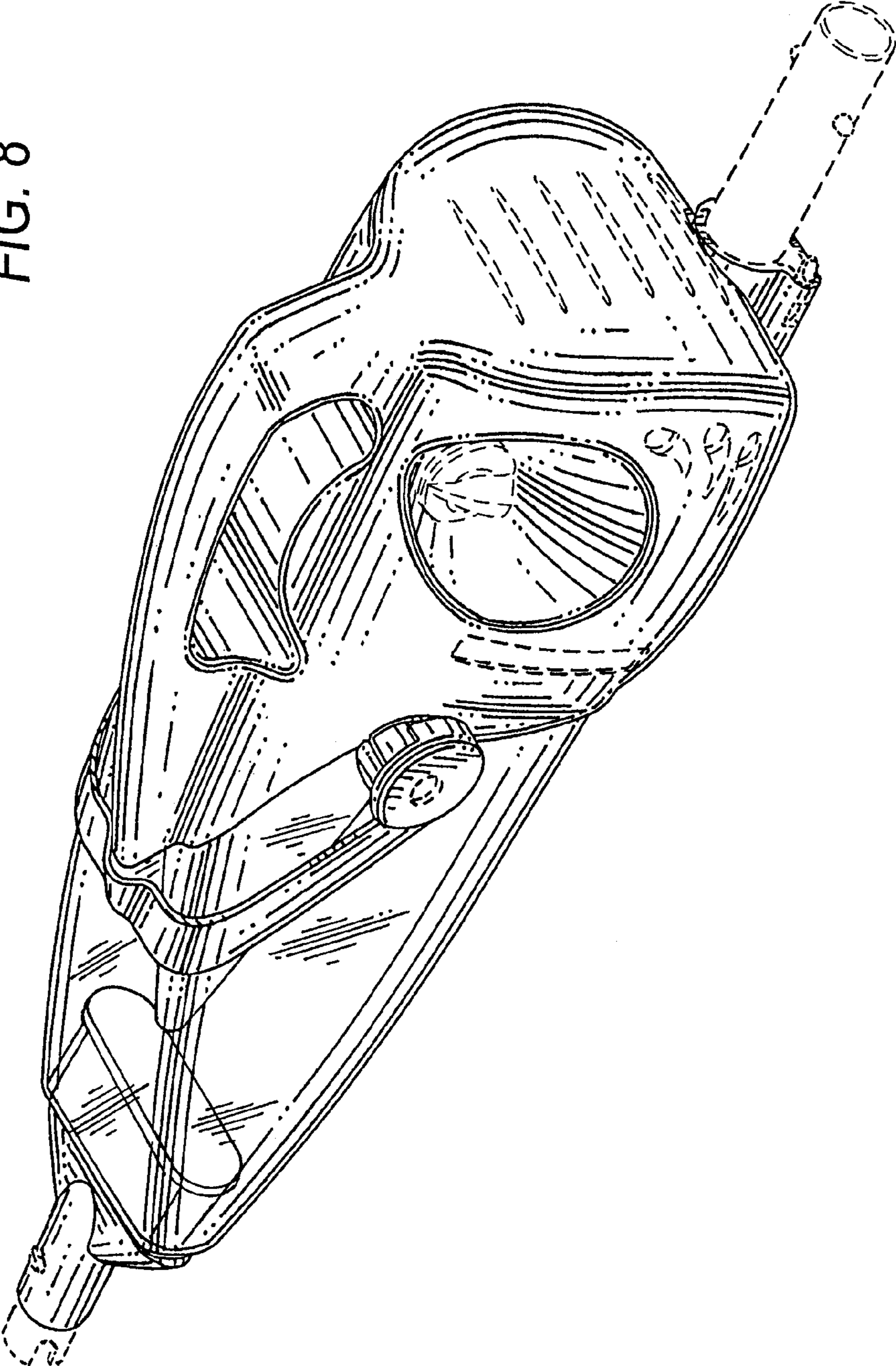
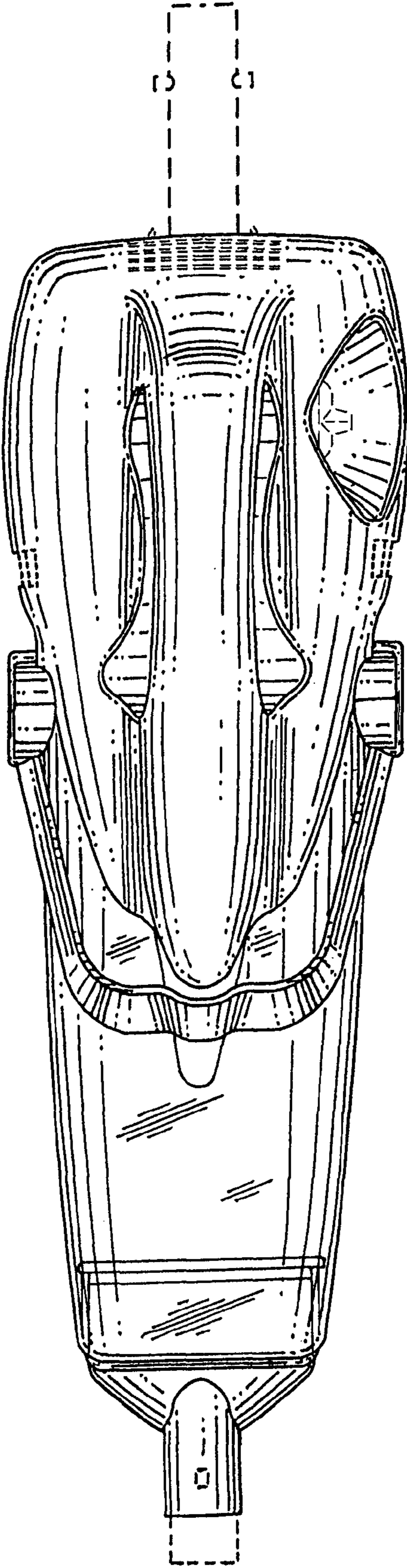

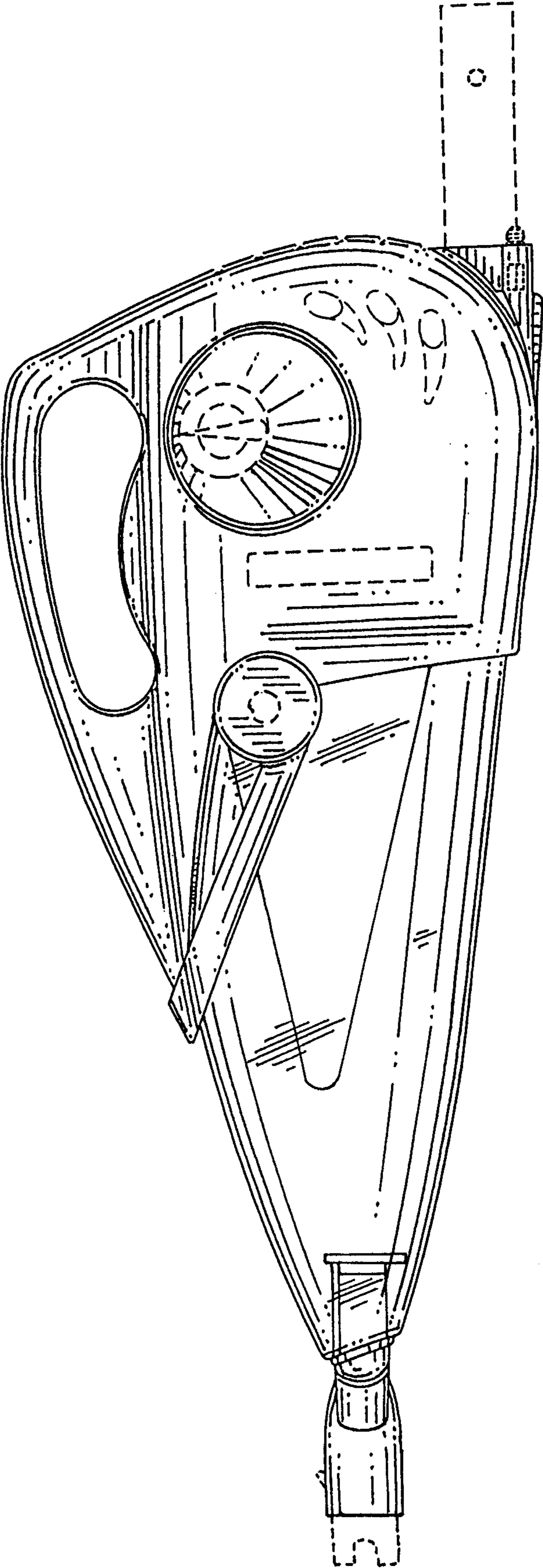

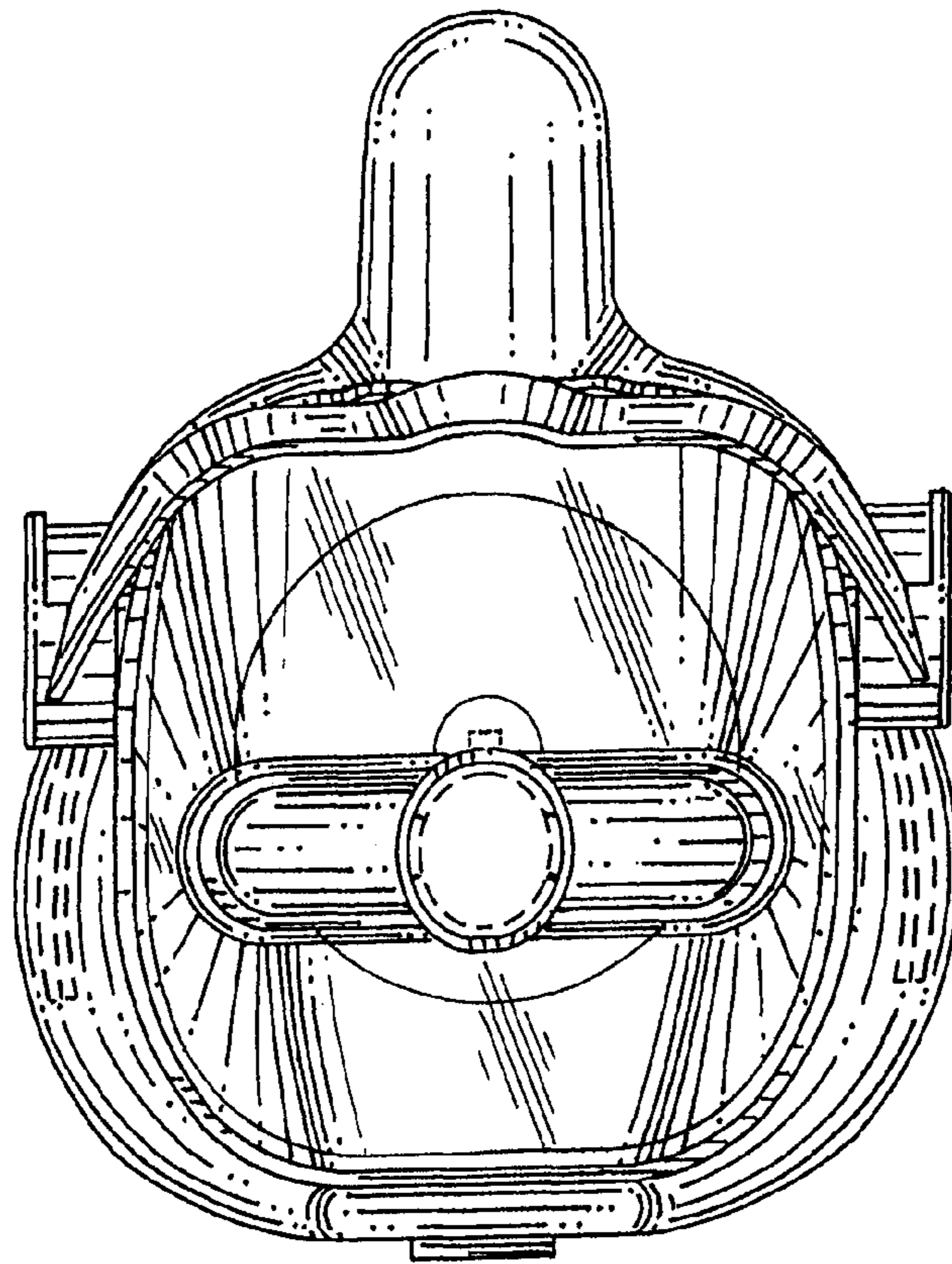
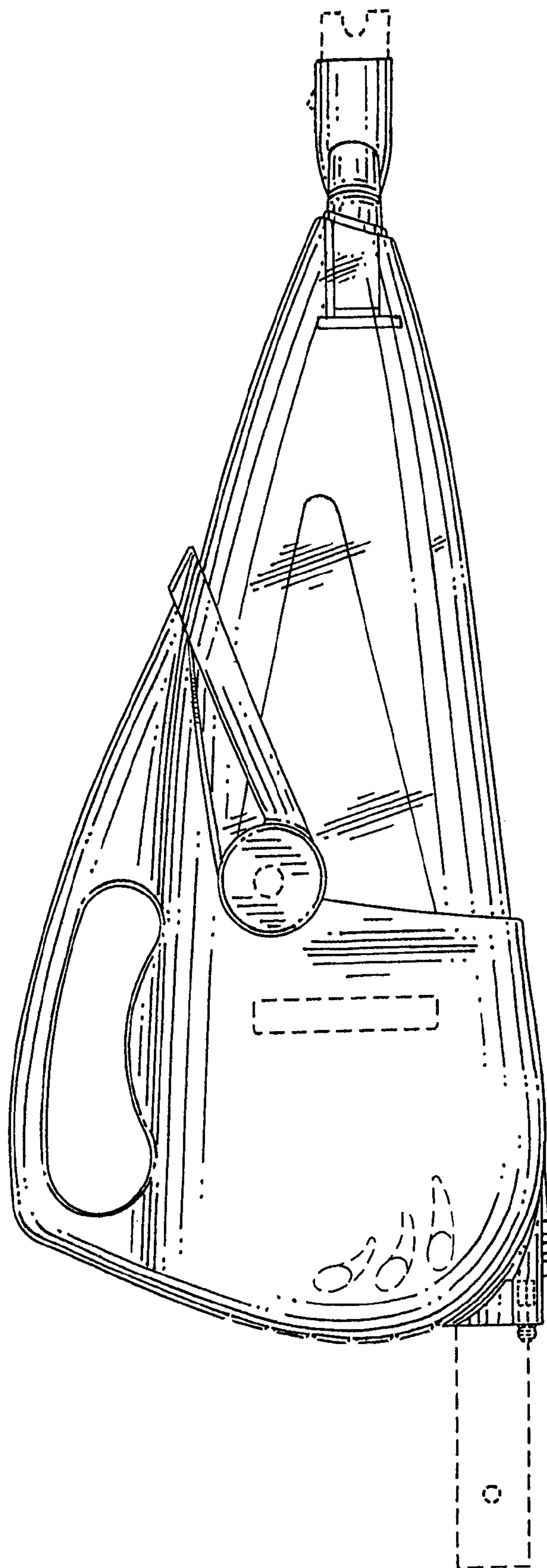

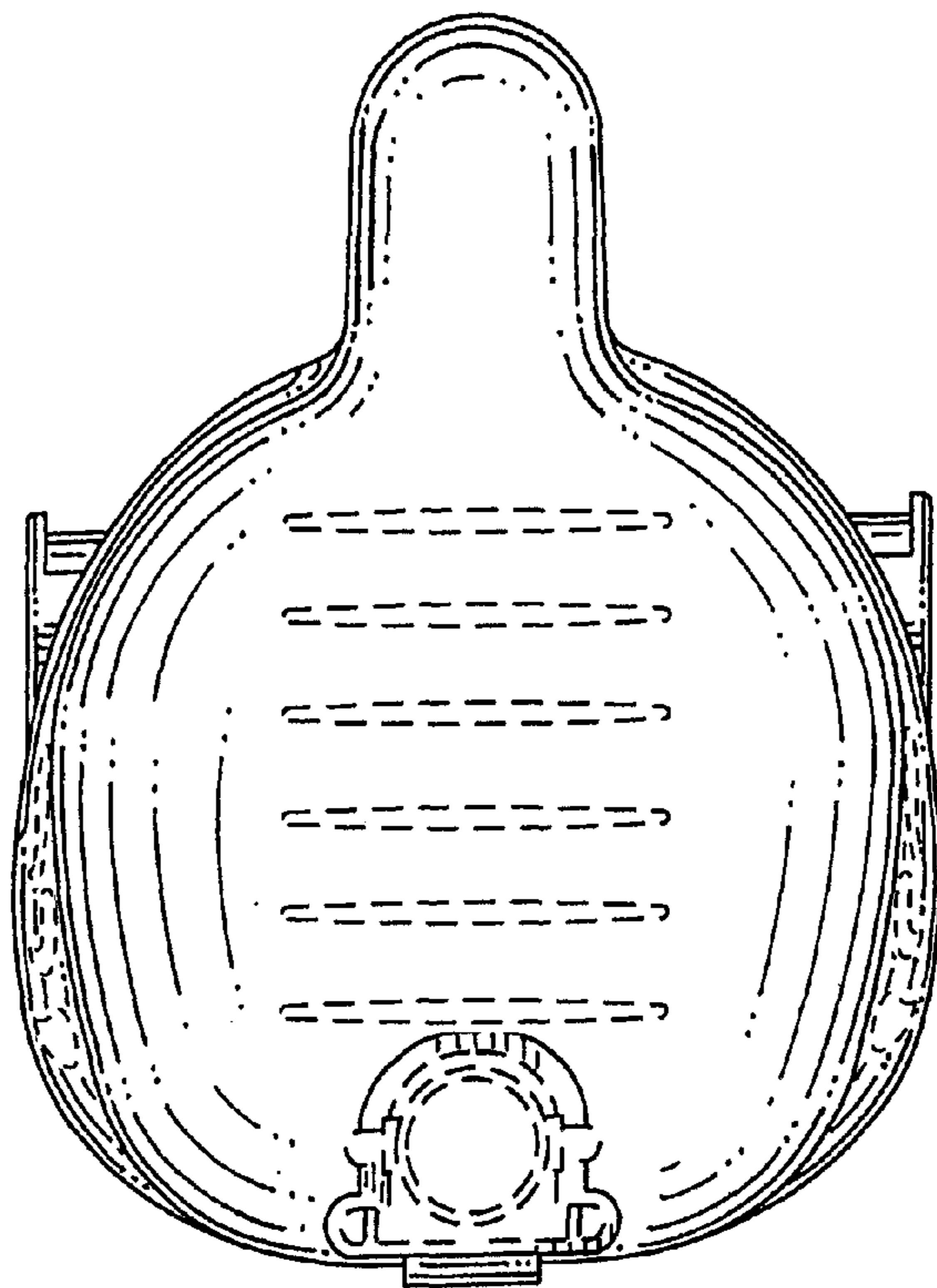

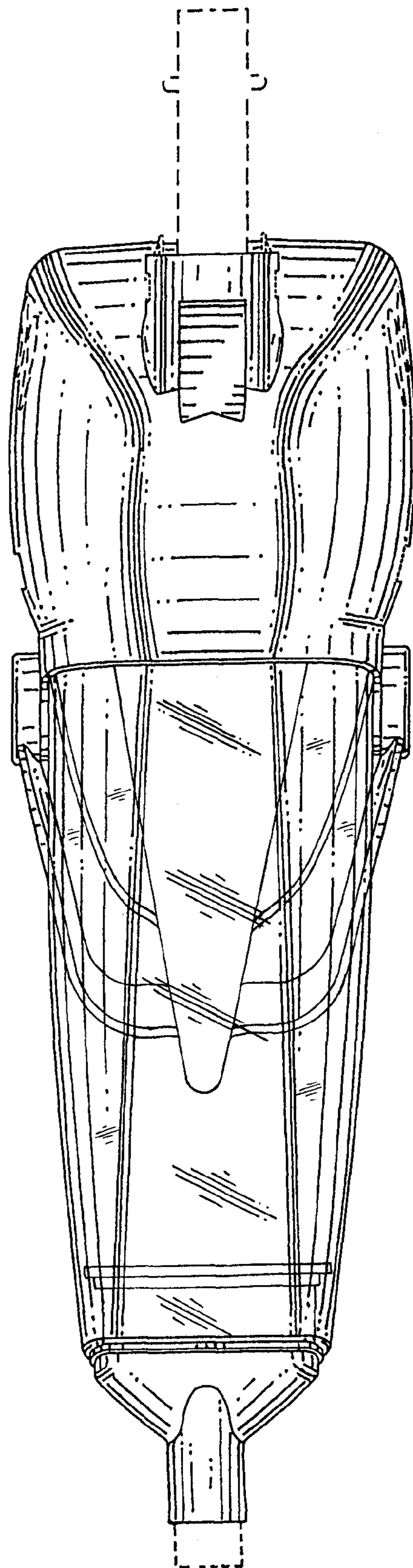
