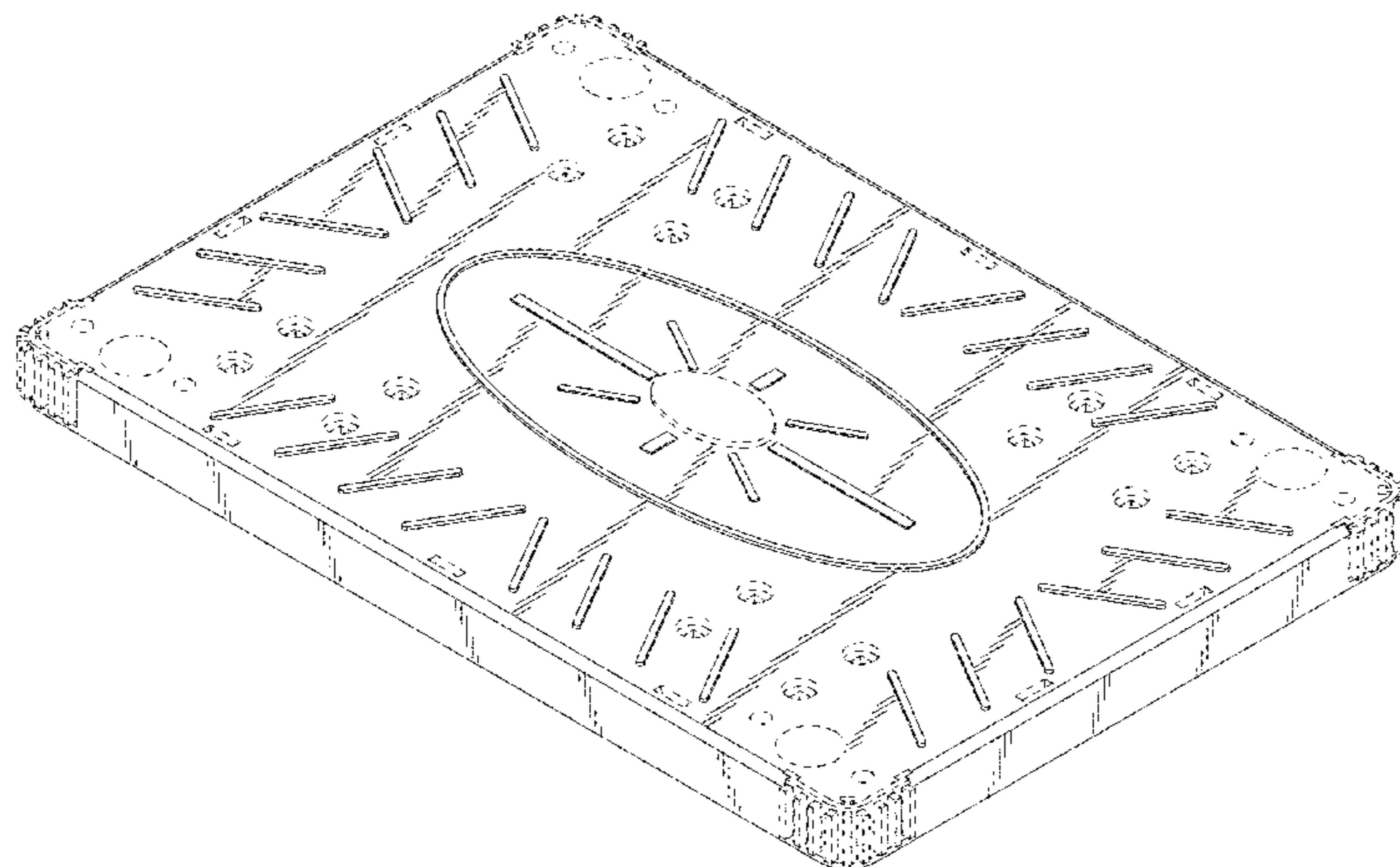

FIG. 1 is a perspective view of a carrier board of a hand cart showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof; and,  
FIG. 6 is a top plan view.

The bottom of the carrier board of a hand cart is flat and unornamented. The portions shown in broken lines are for the purpose of illustrating environmental structure only and form no part of the claimed design.

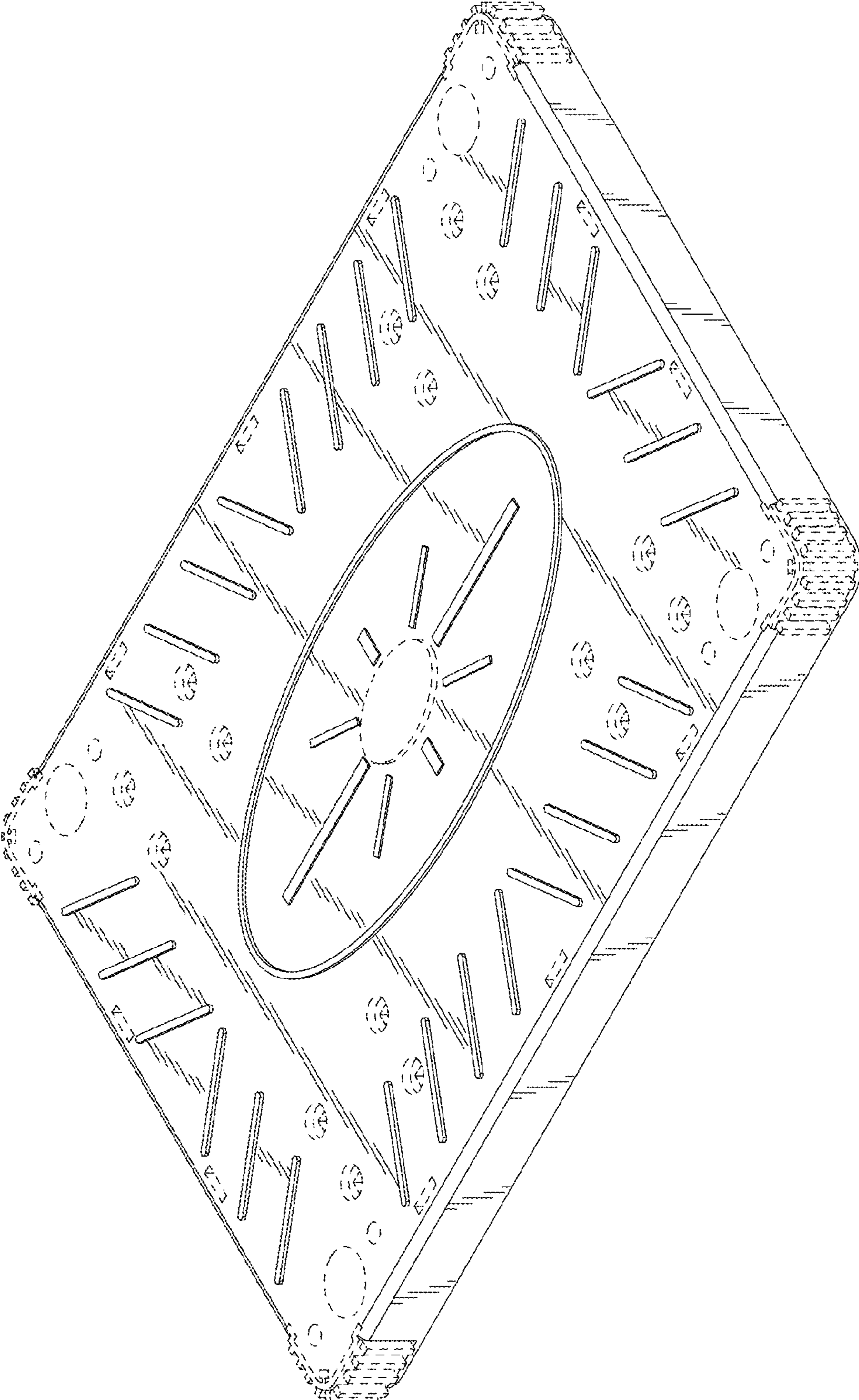

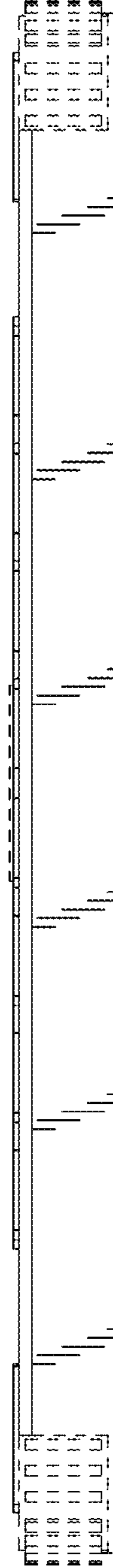

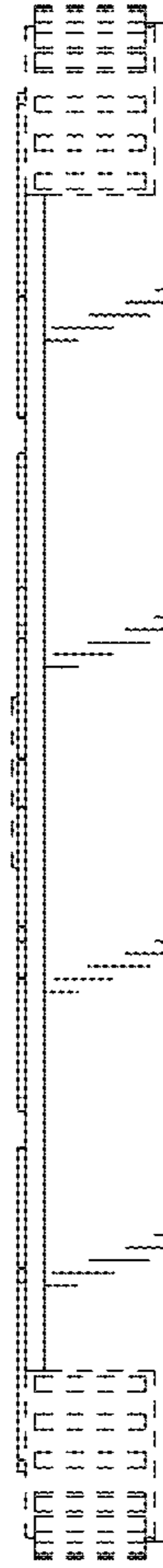

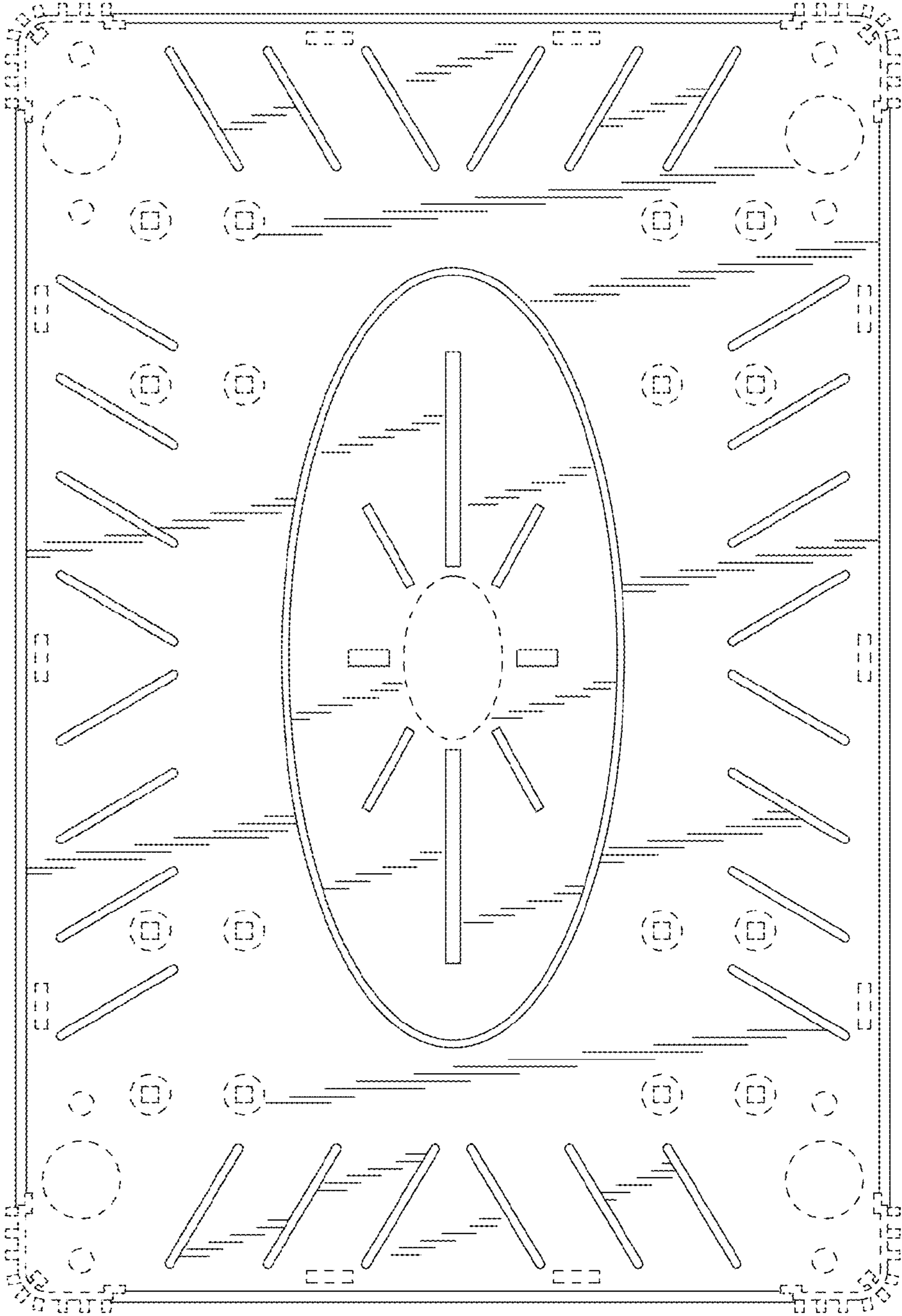
