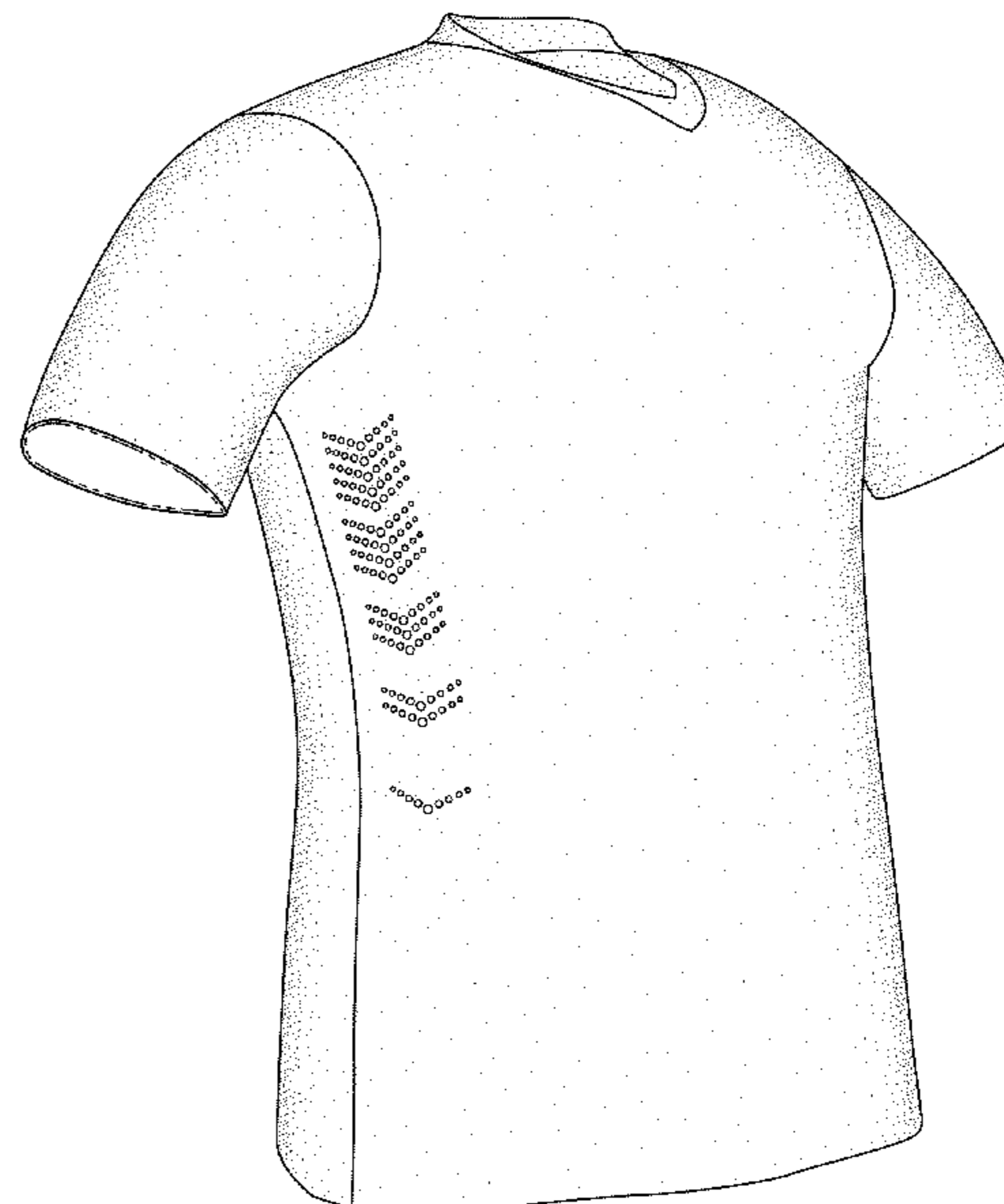
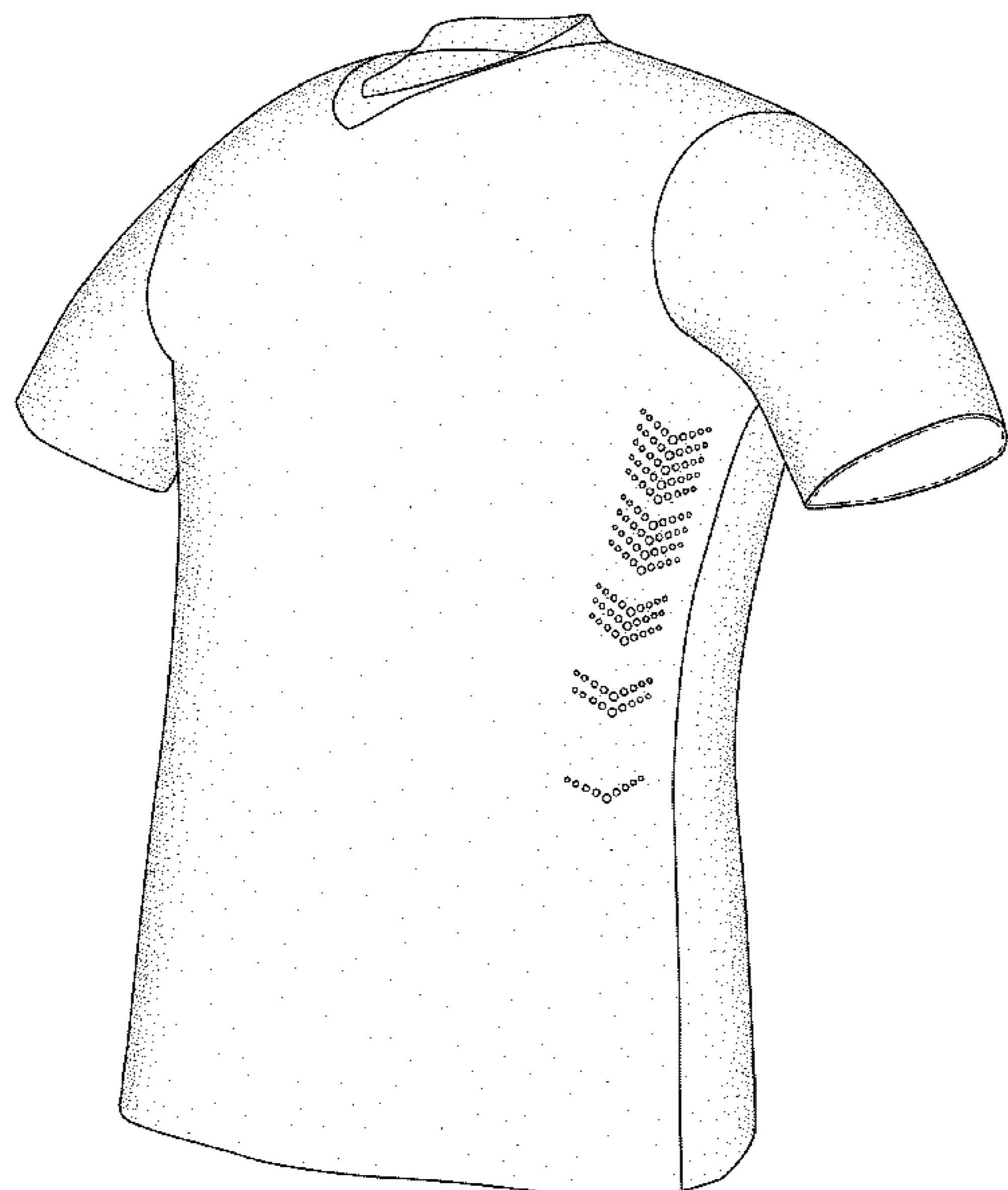
(57) **CLAIM**

The ornamental design for a shirt, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a shirt showing our new design in an in-use configuration;
 FIG. 2 is a right side view thereof;
 FIG. 3 is a left side view thereof;
 FIG. 4 is a front view thereof; and,
 FIG. 5 is a front left perspective view thereof.

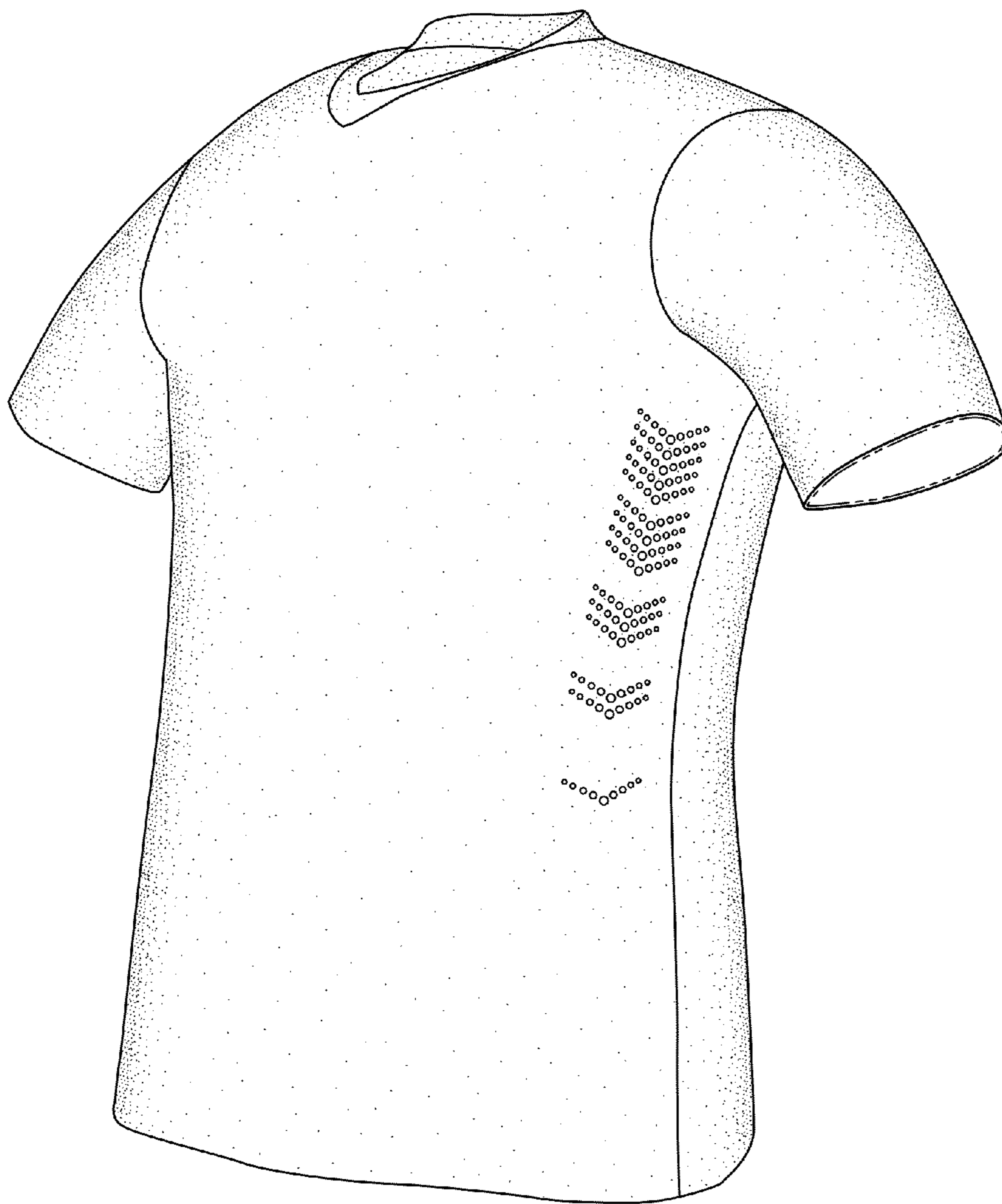

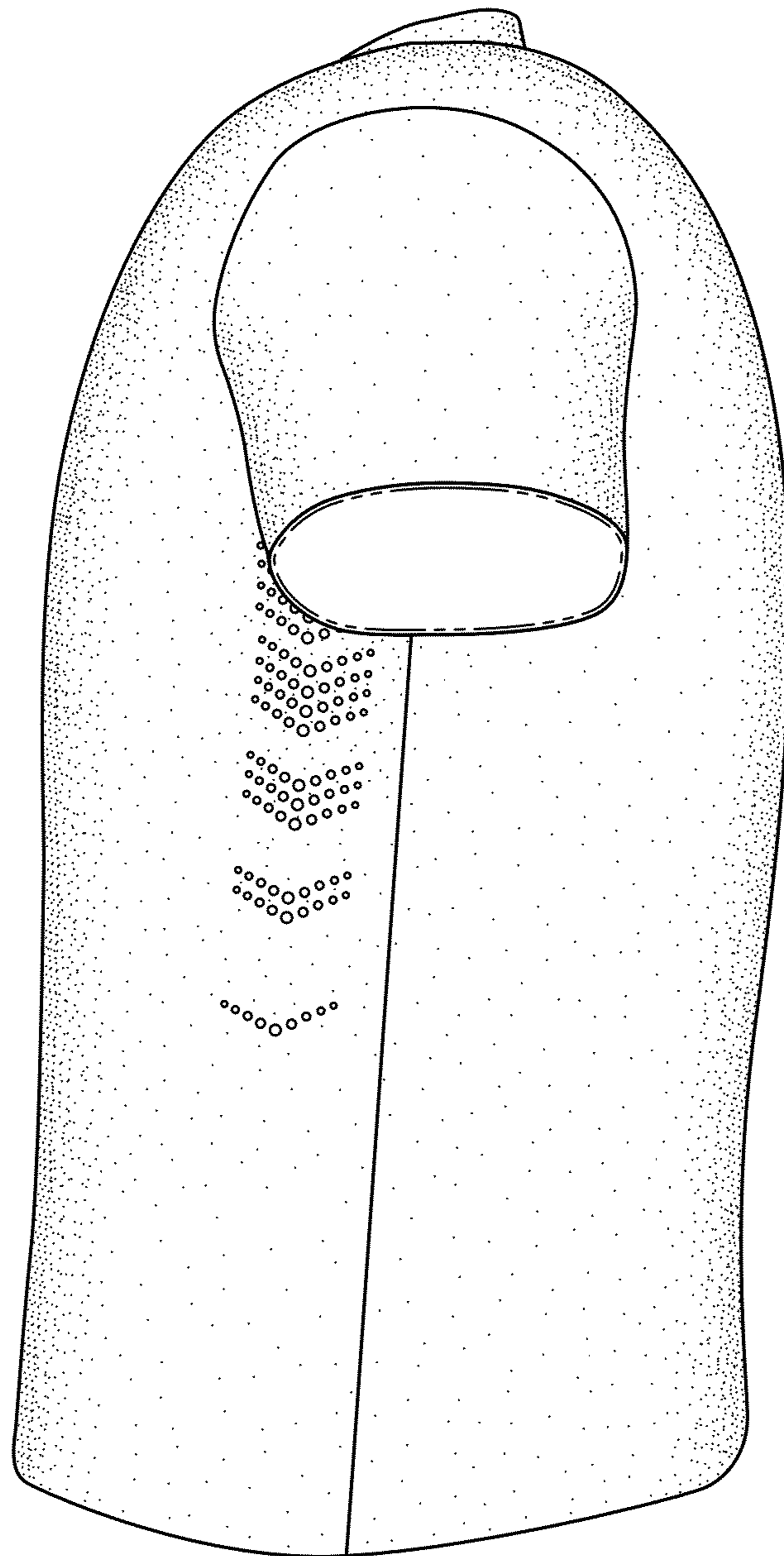

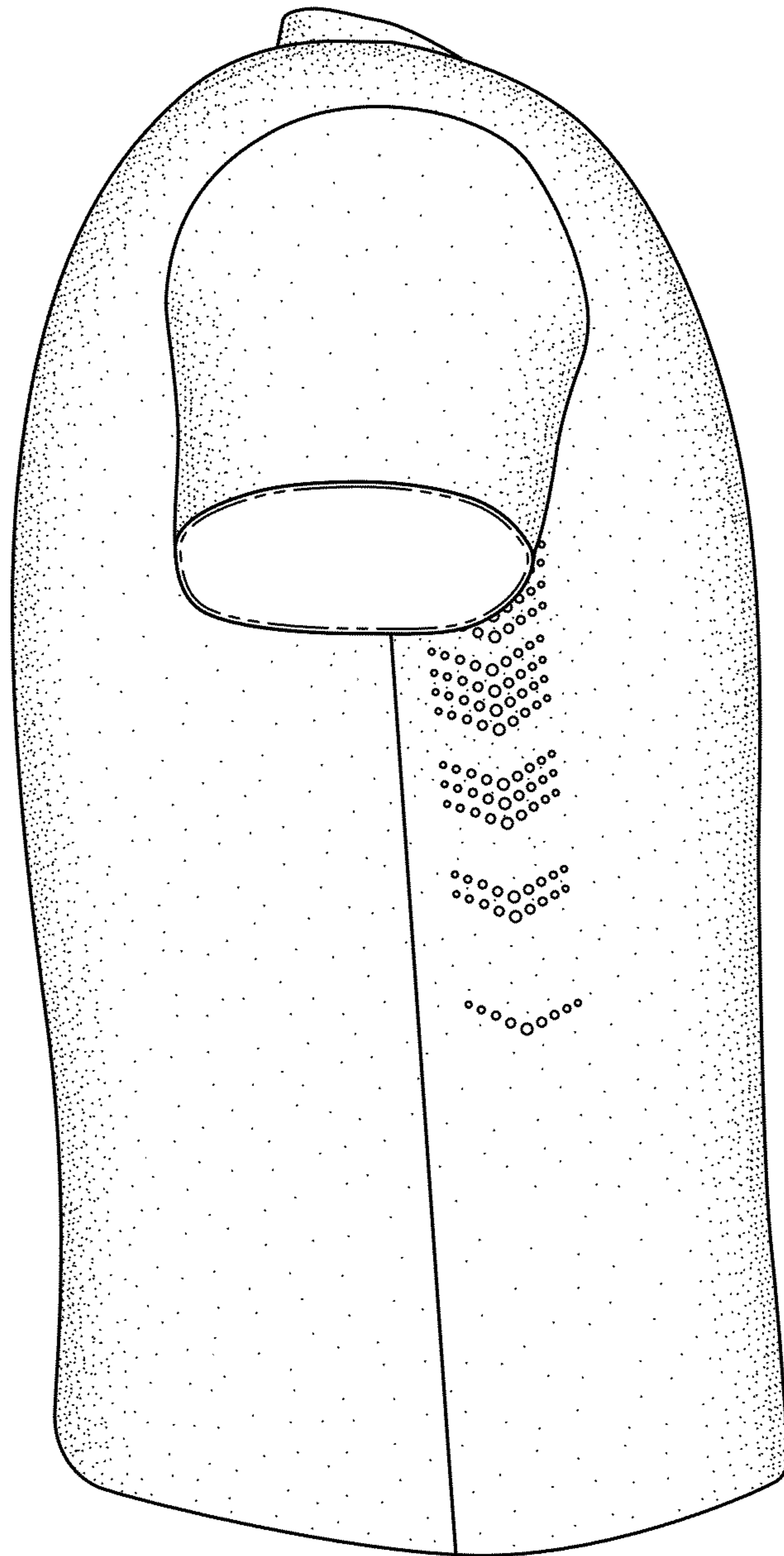

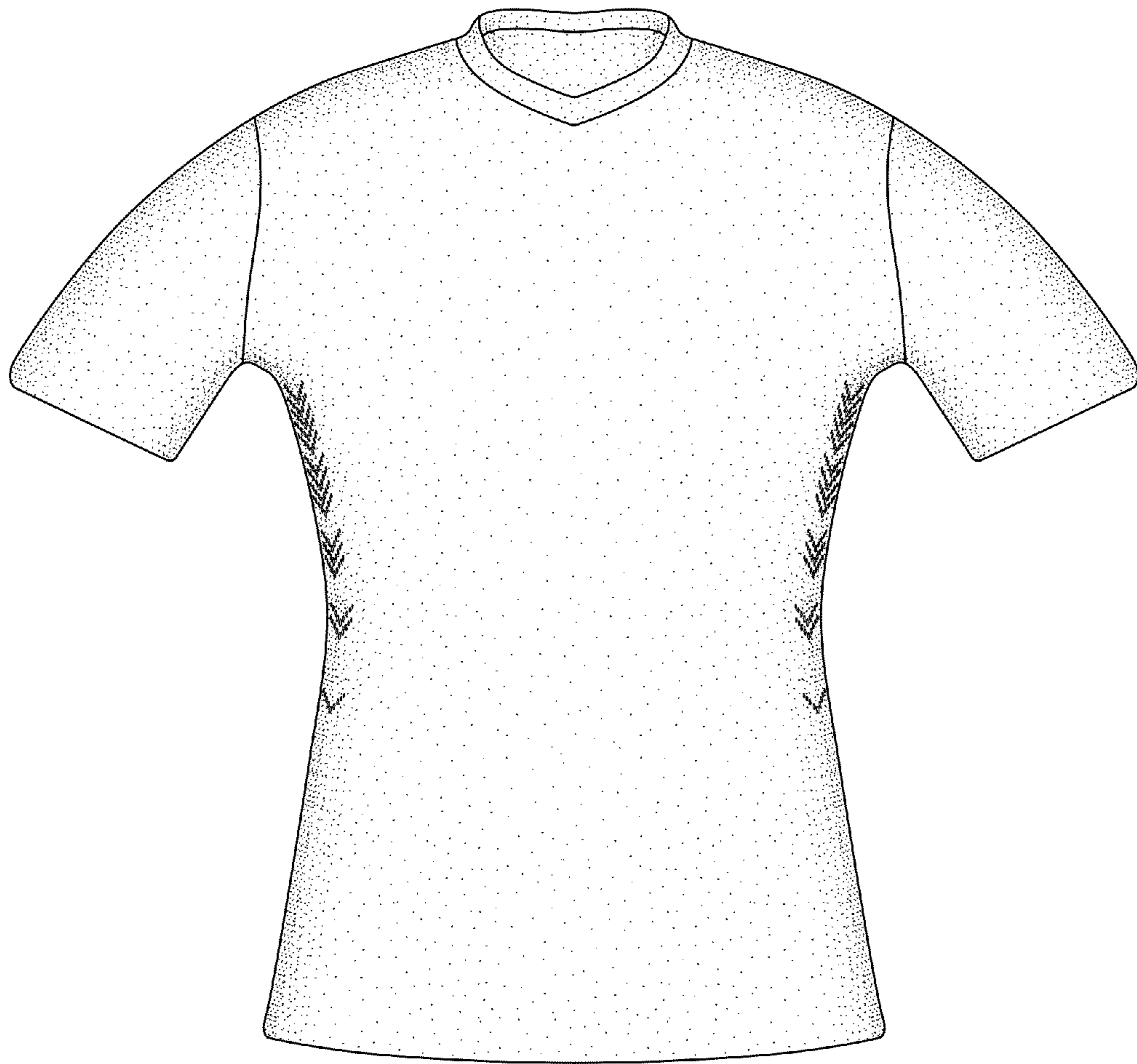

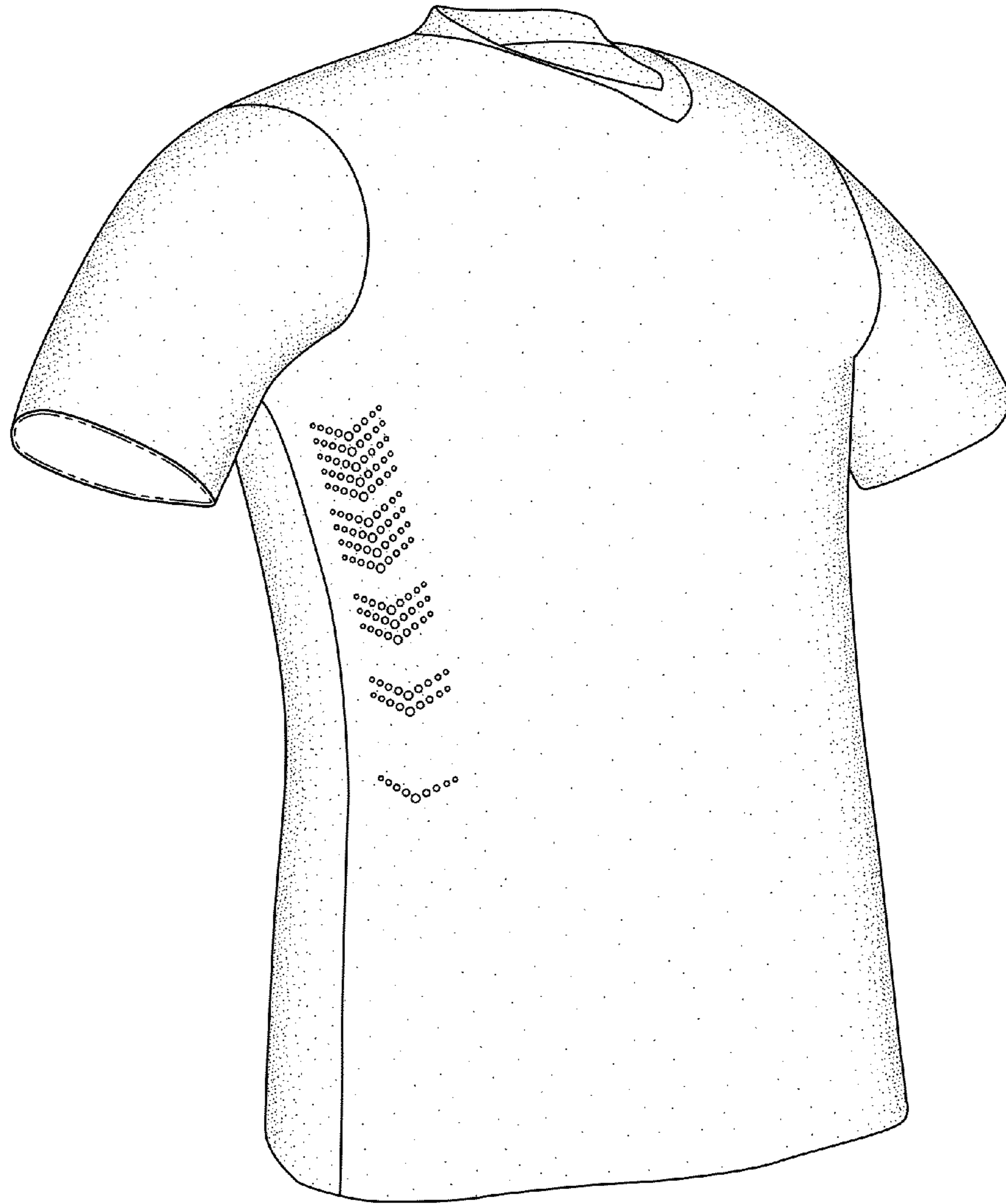
