(57) **CLAIM**

The ornamental design for a portion of a fabric, as shown and described.

DESCRIPTION

FIG. 1 is a top surface view of a portion of a fabric showing my new design; and,

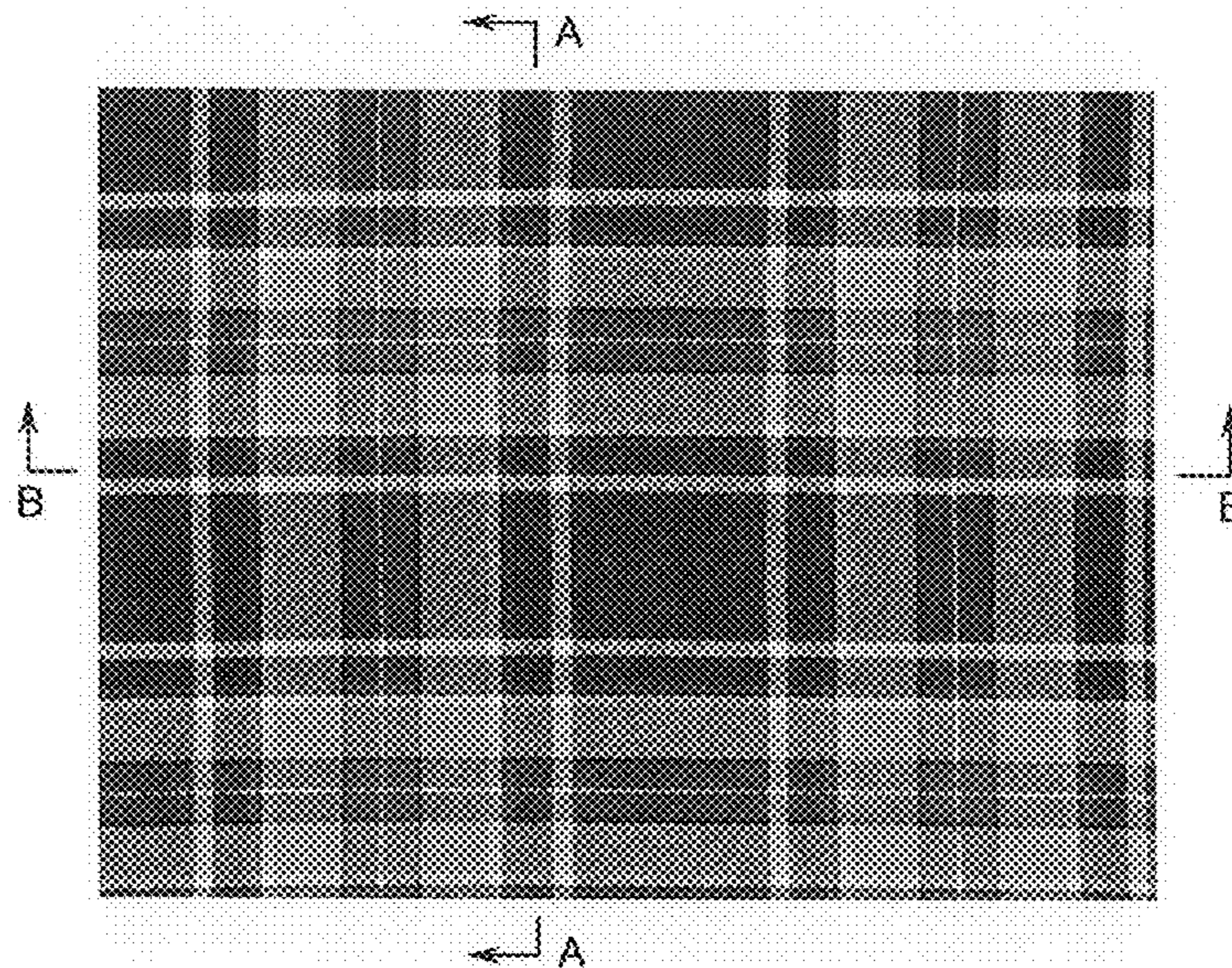

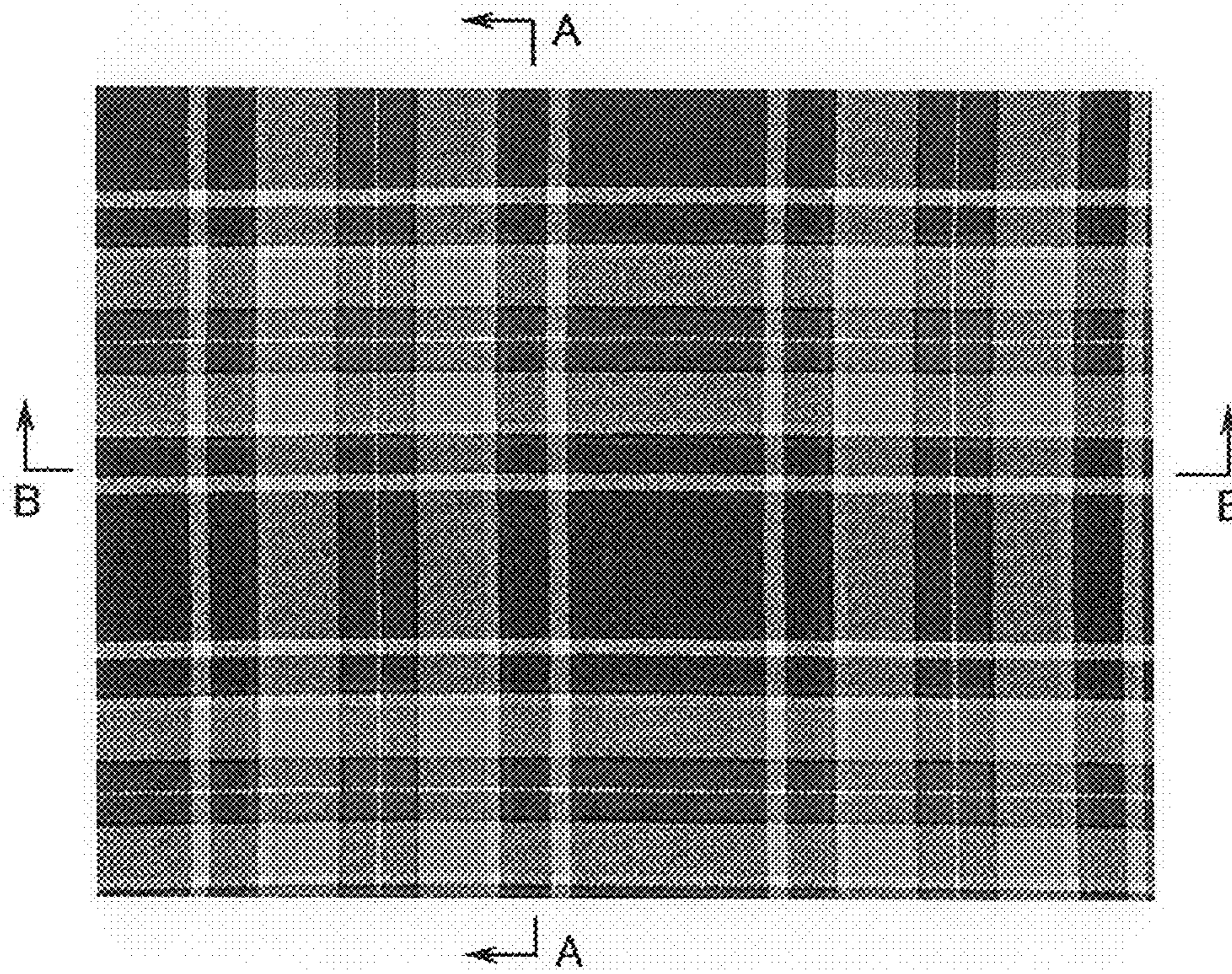
