The ornamental design for a furniture item, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a furniture item of the present invention;

FIG. 2 is a perspective front view of the furniture item;

FIG. 3 is a perspective rear view of the furniture item;

FIG. 4 is a perspective left view of the furniture item;

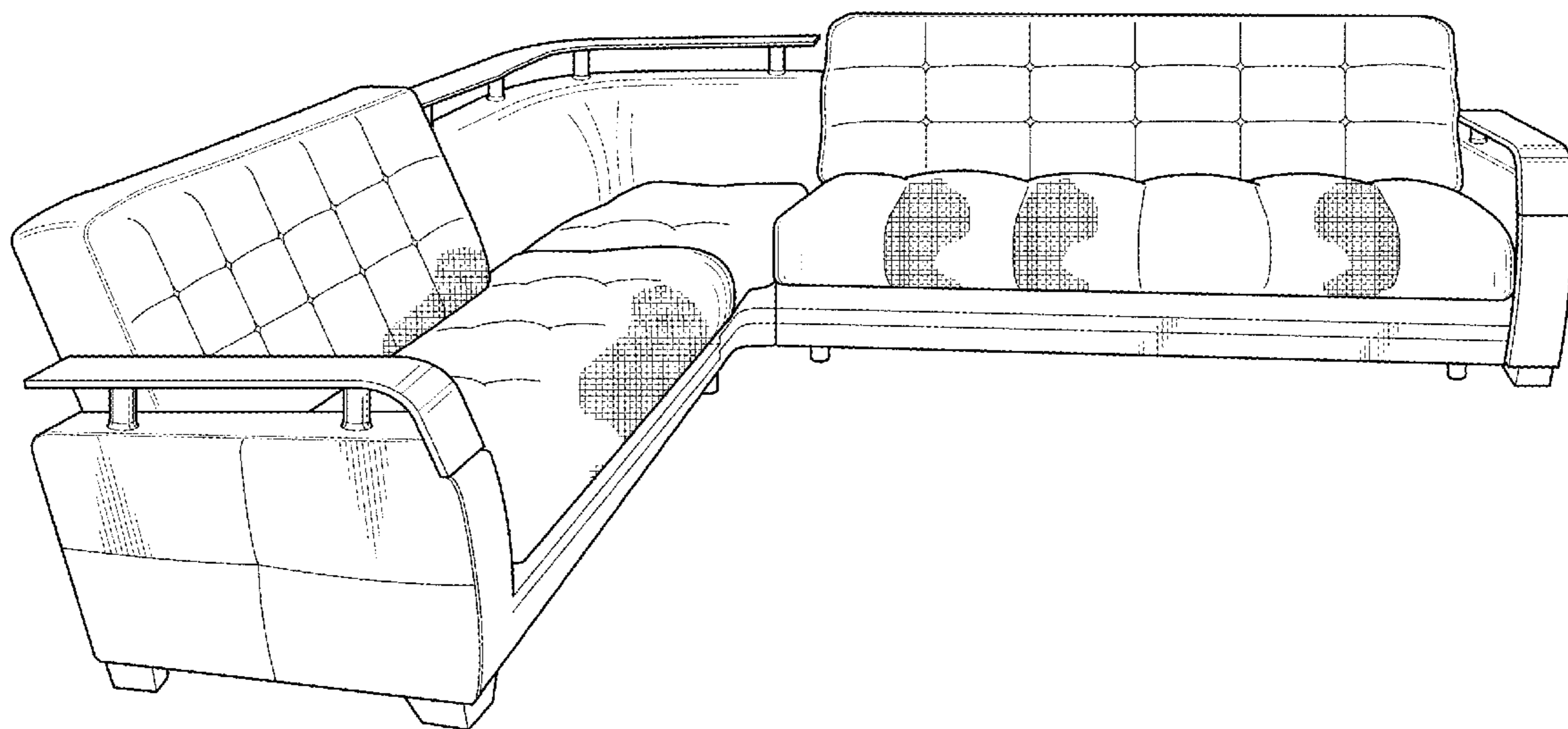
FIG. 5 is a perspective right side view of the furniture item;

FIG. 6 is a perspective top side view of the furniture item; and,

FIG. 7 is an exploded perspective bottom view of the furniture item, the furniture item separated for ease of illustration.

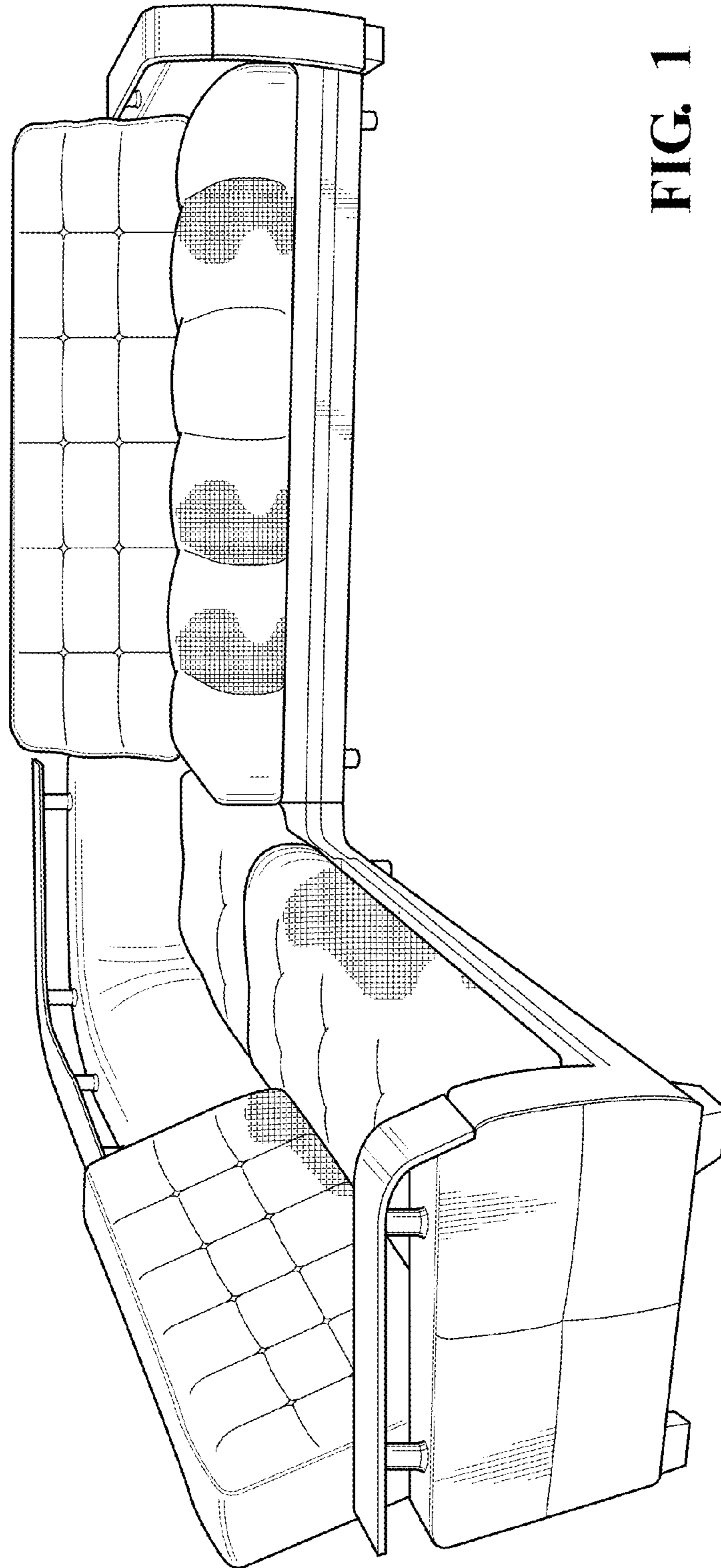

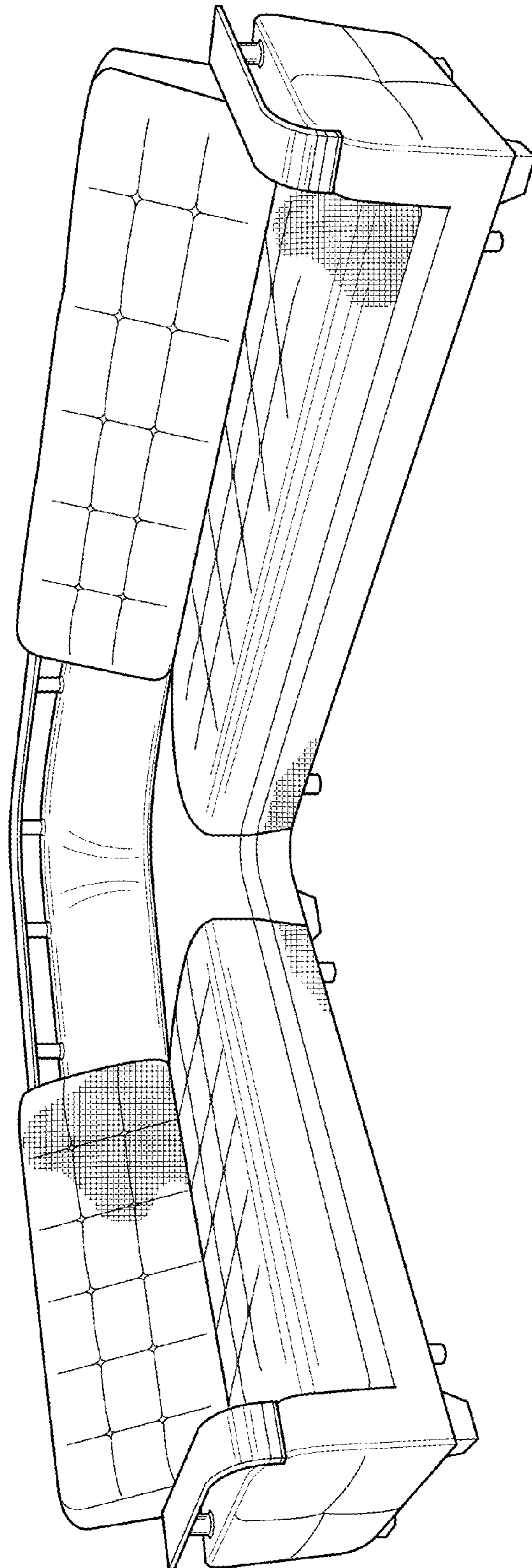
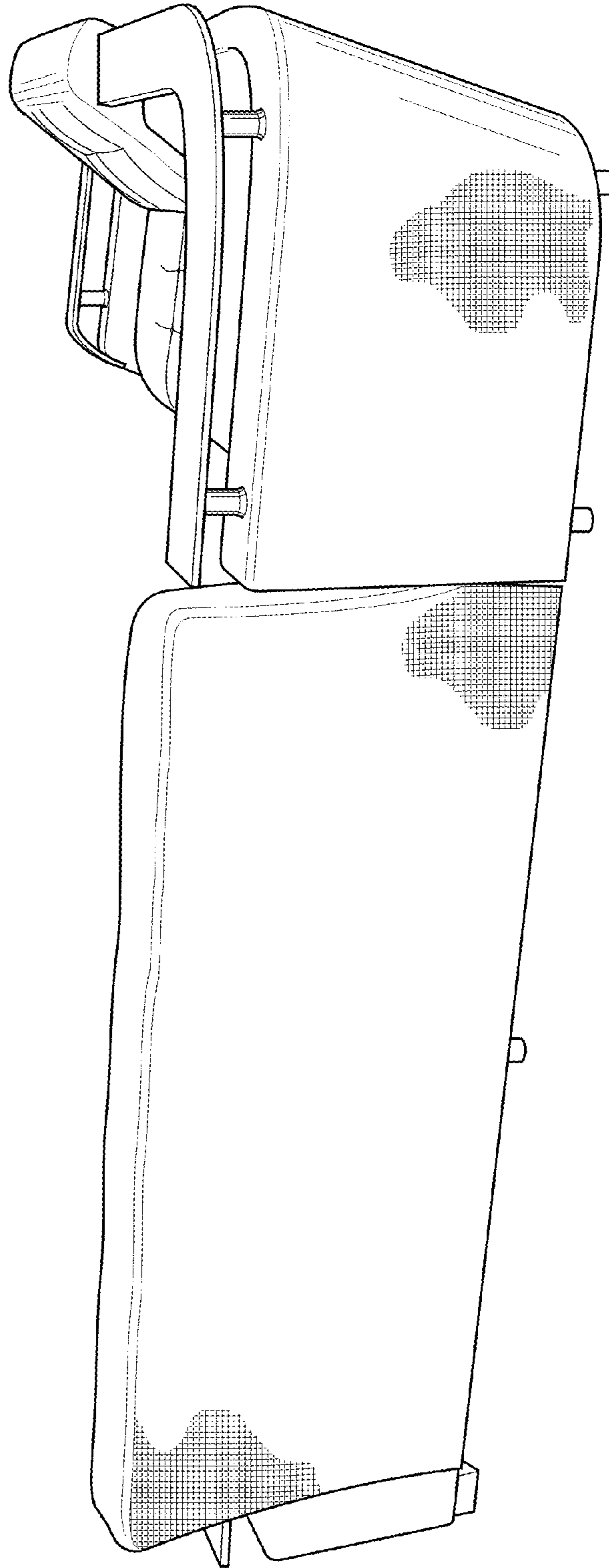

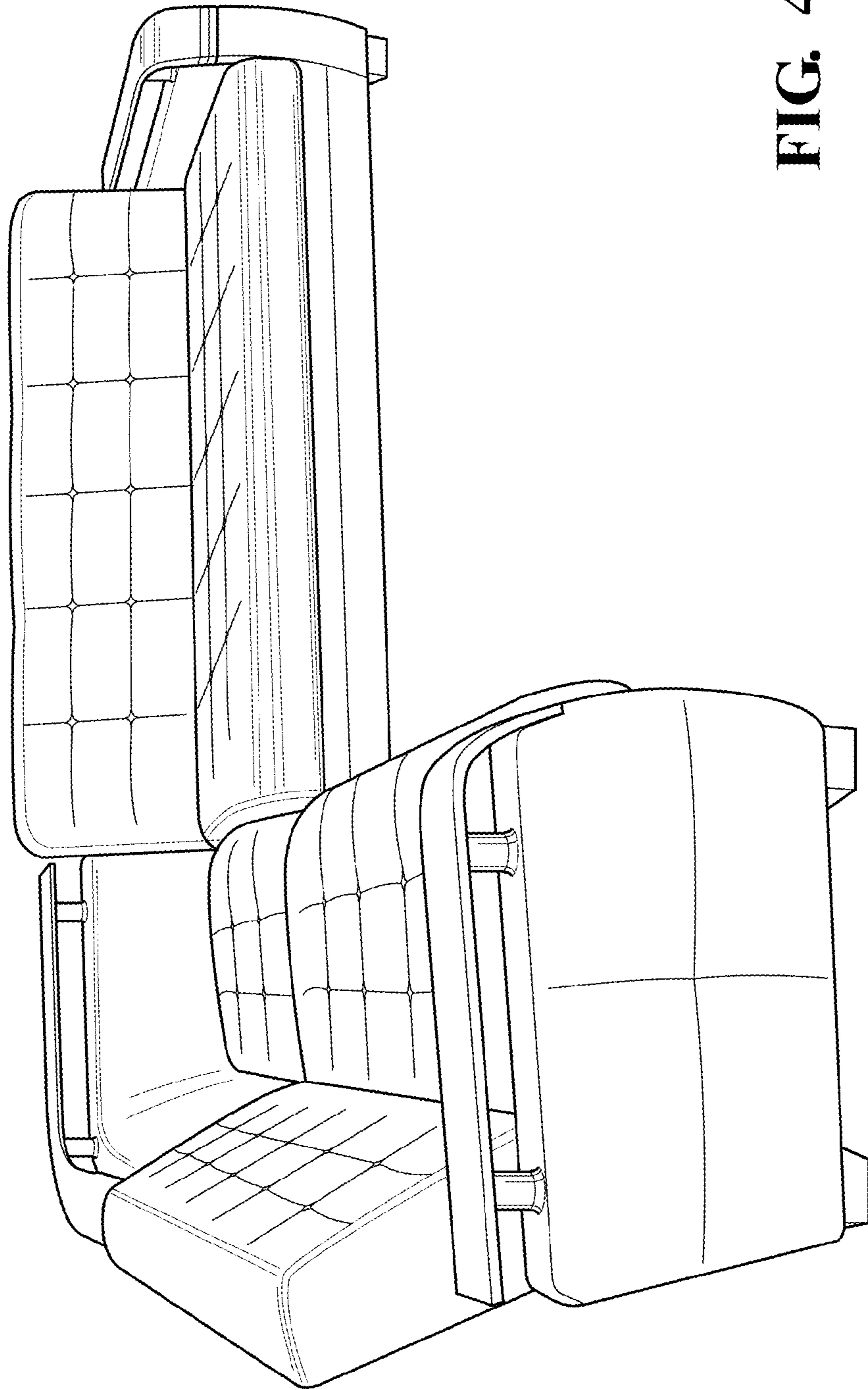

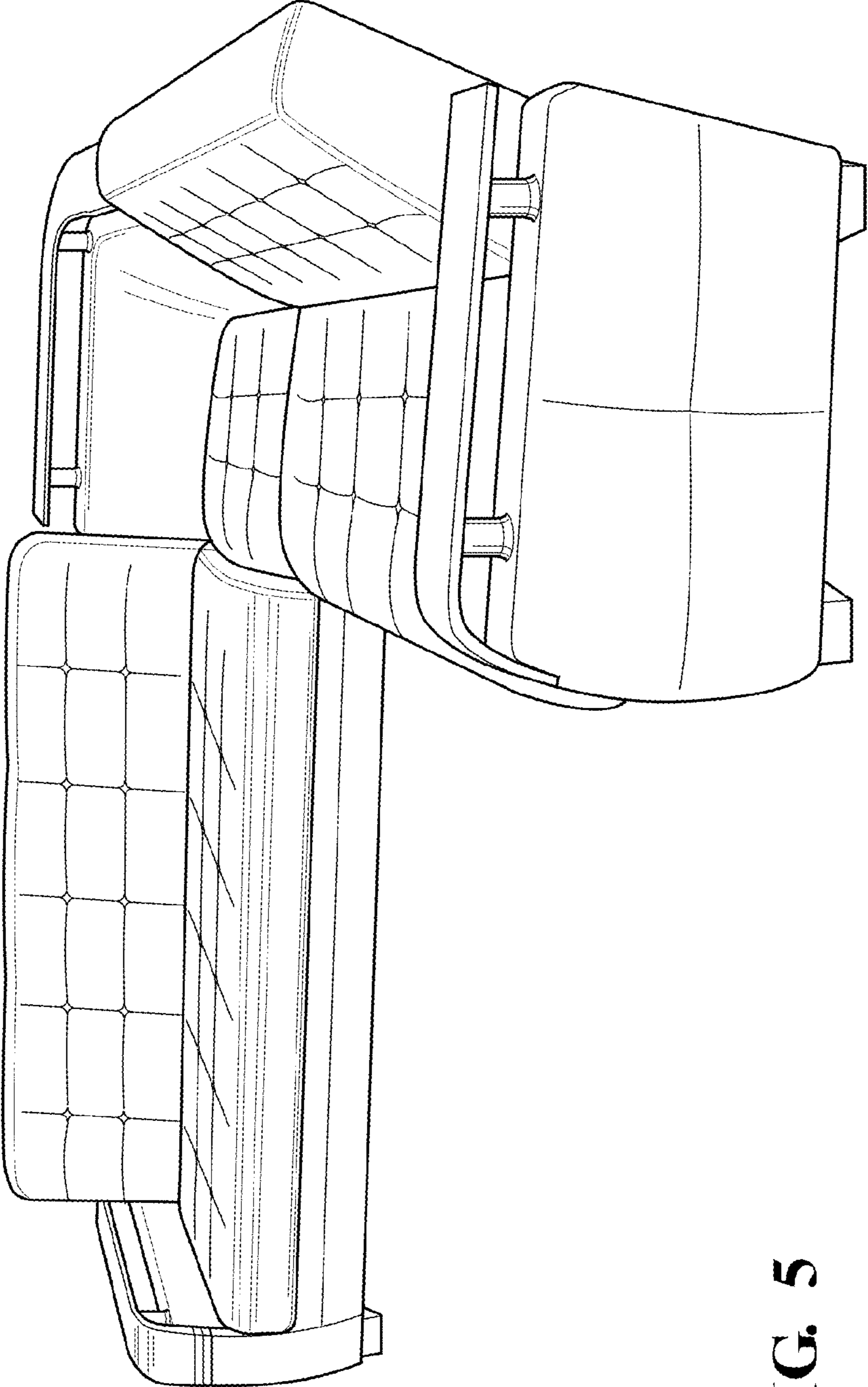

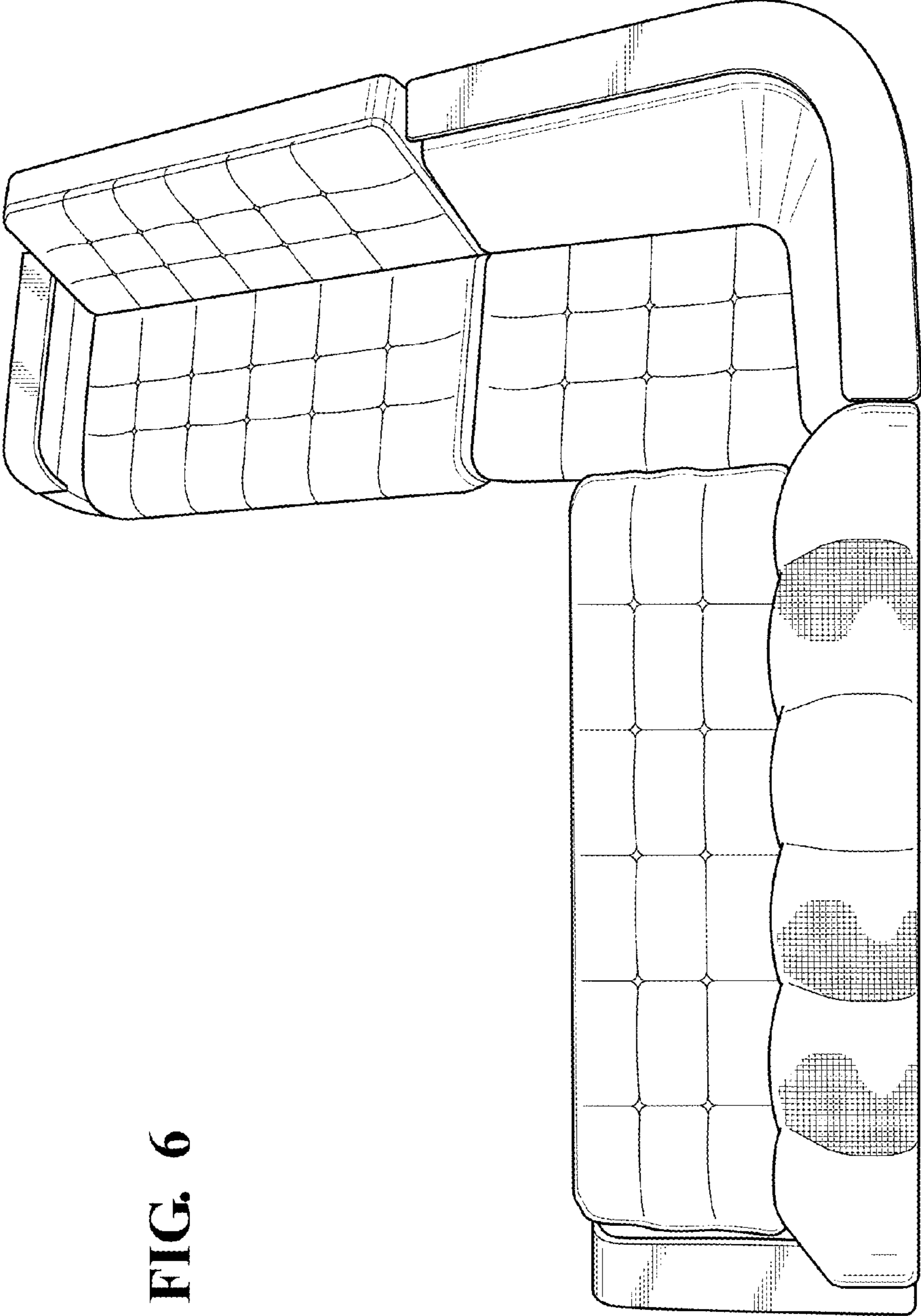
