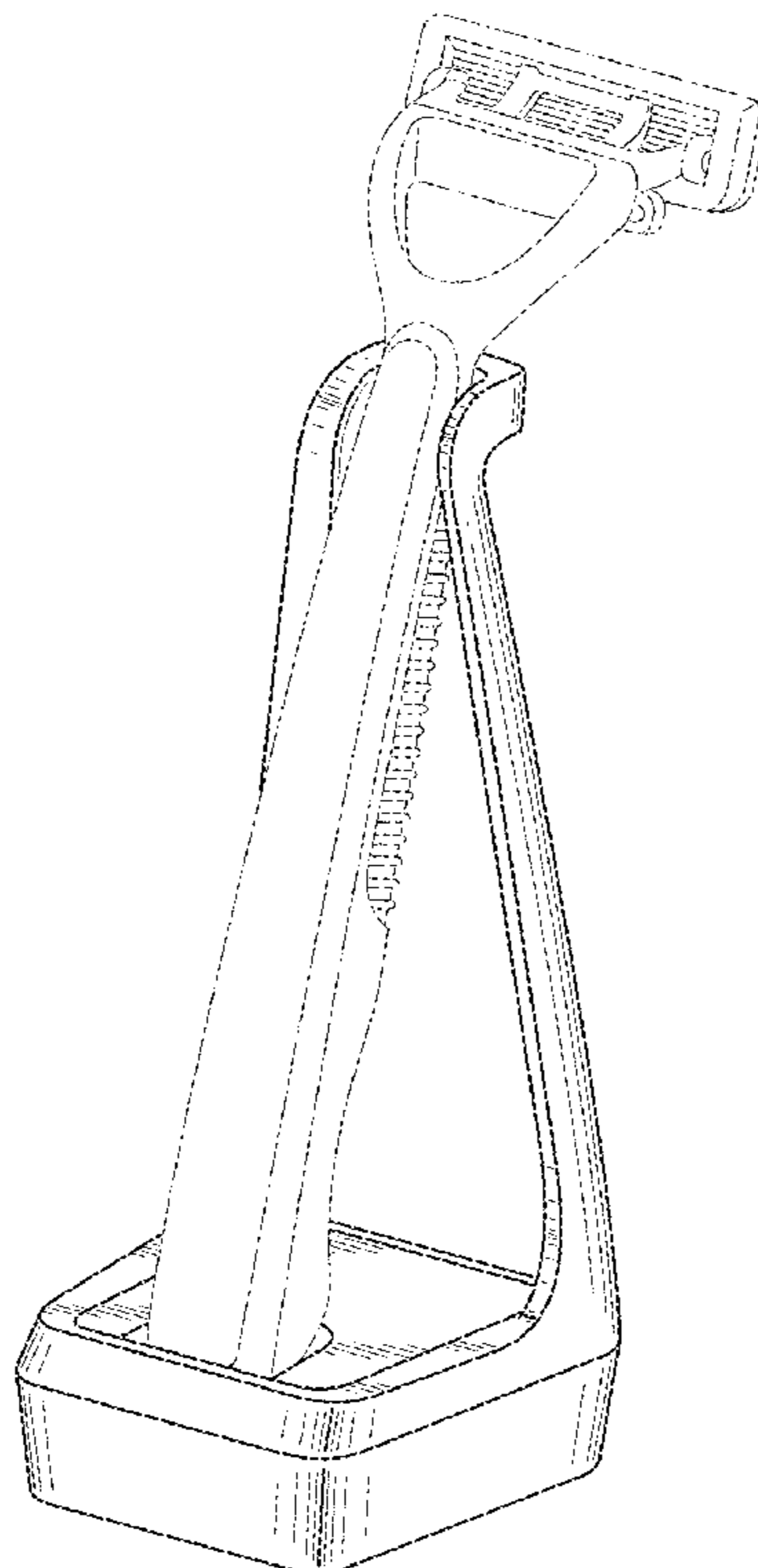

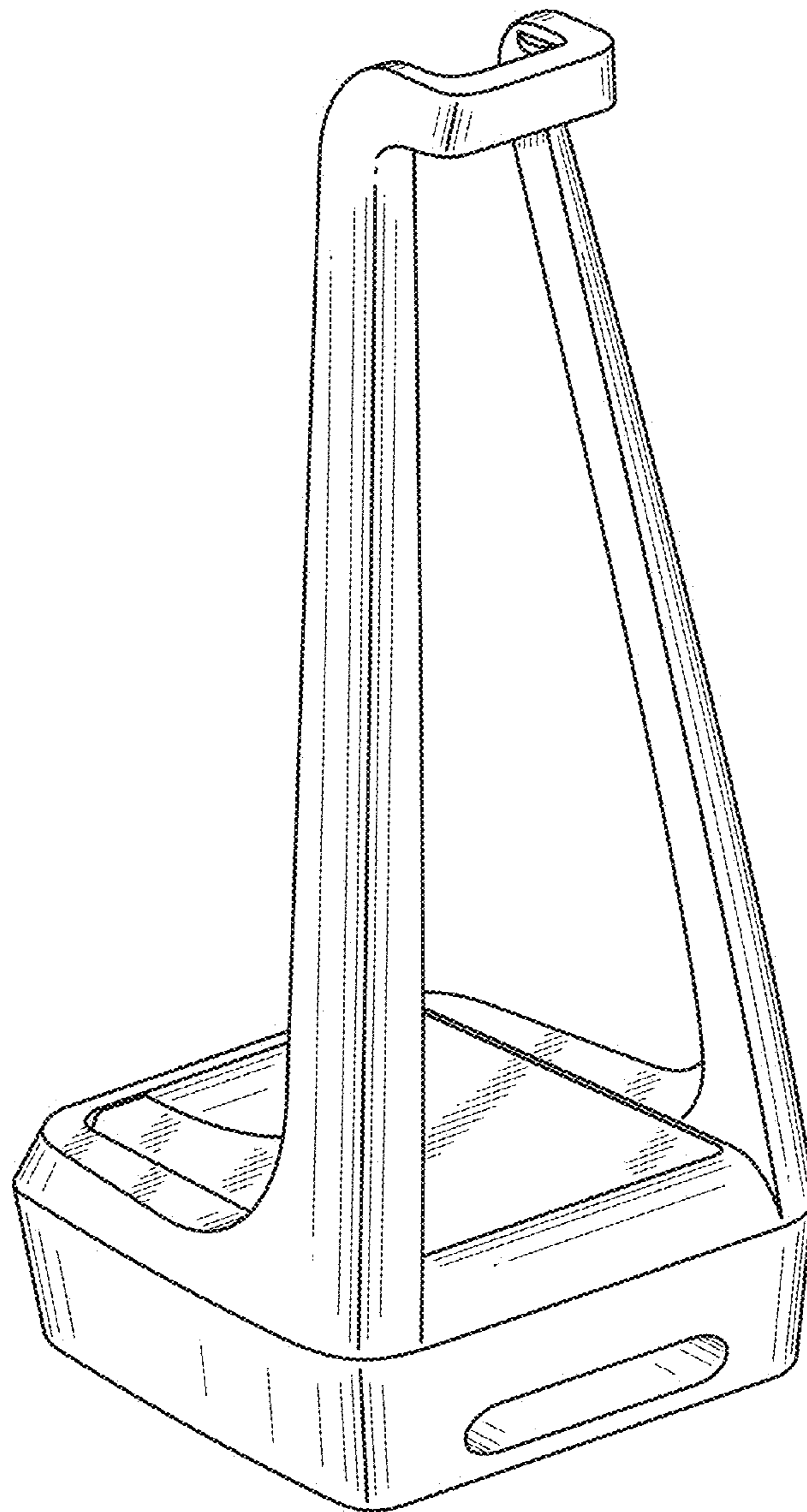
FIG. 1 is a top, rear, and right side perspective view of a shaving razor stand showing our new design;

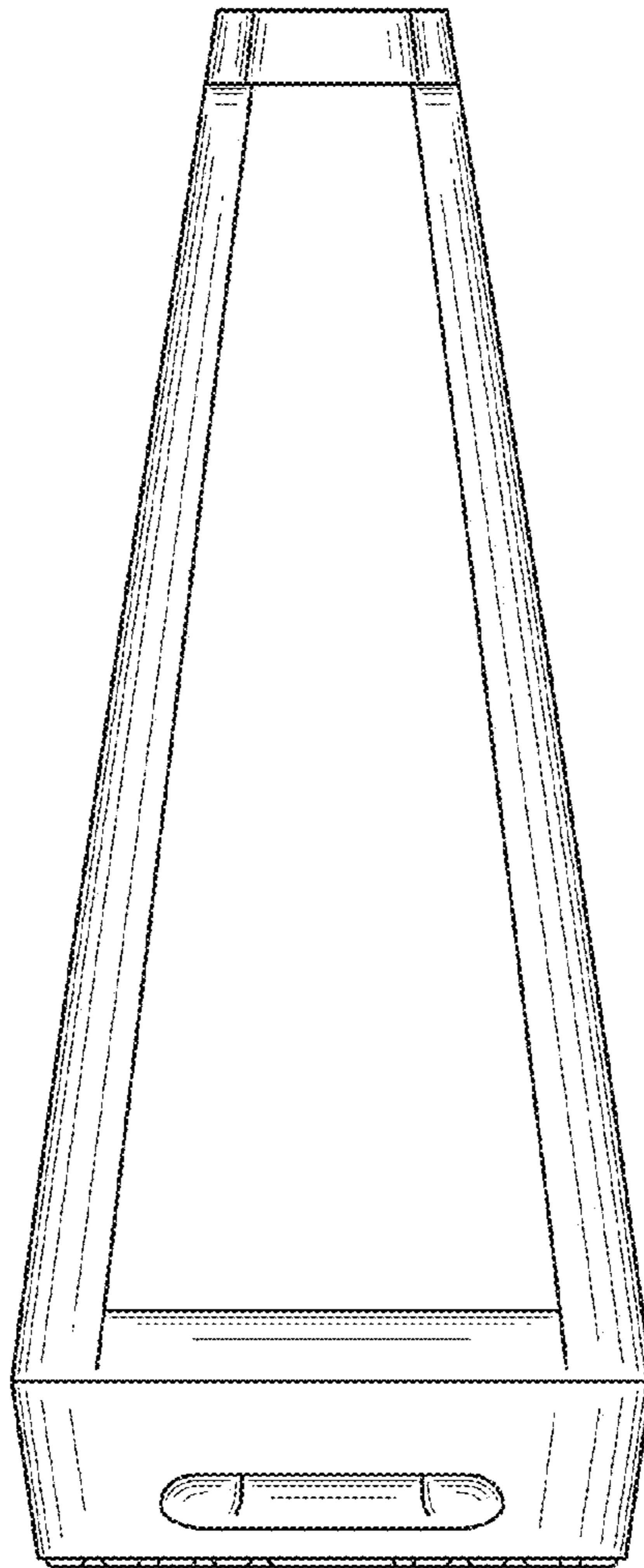

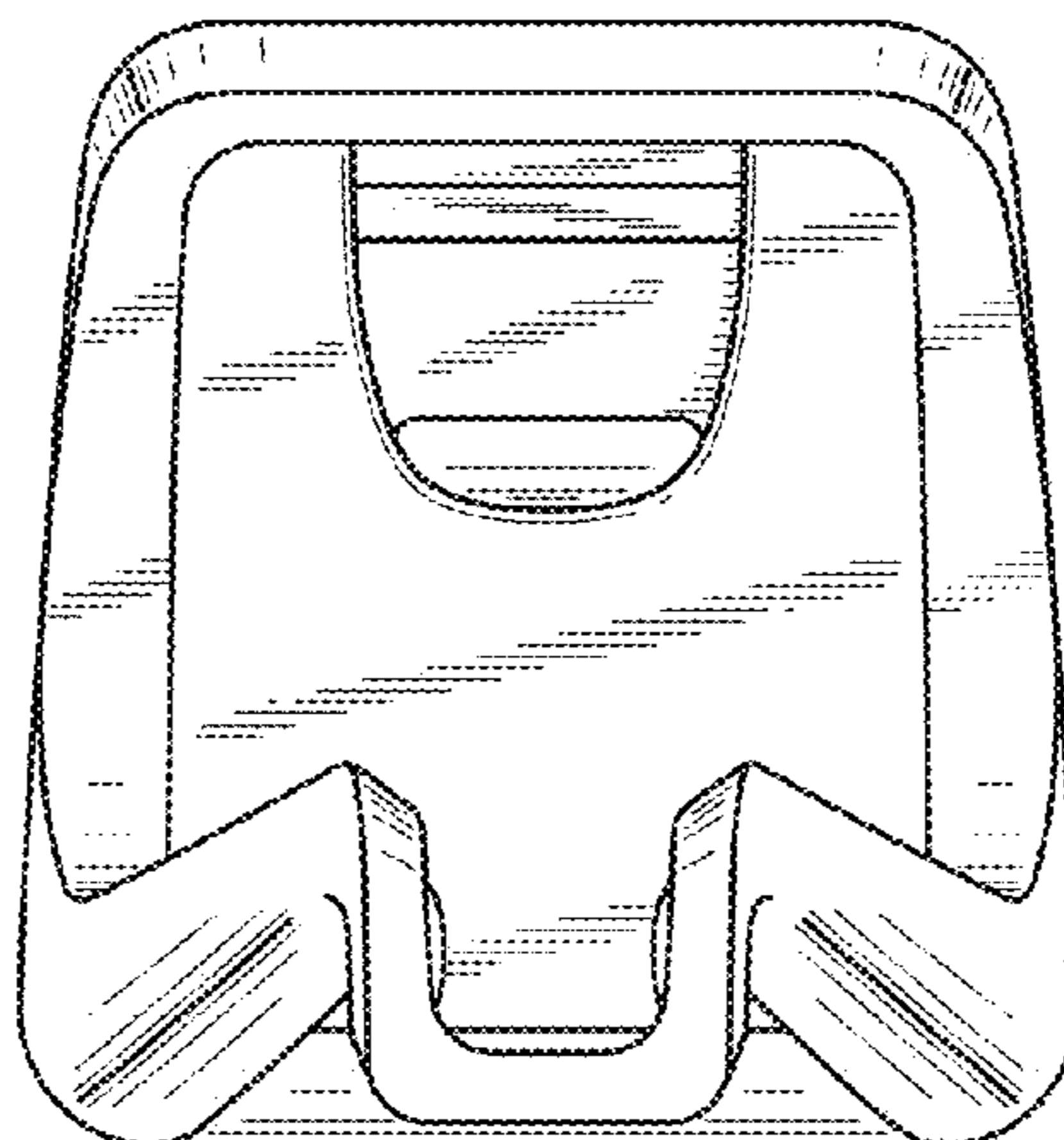

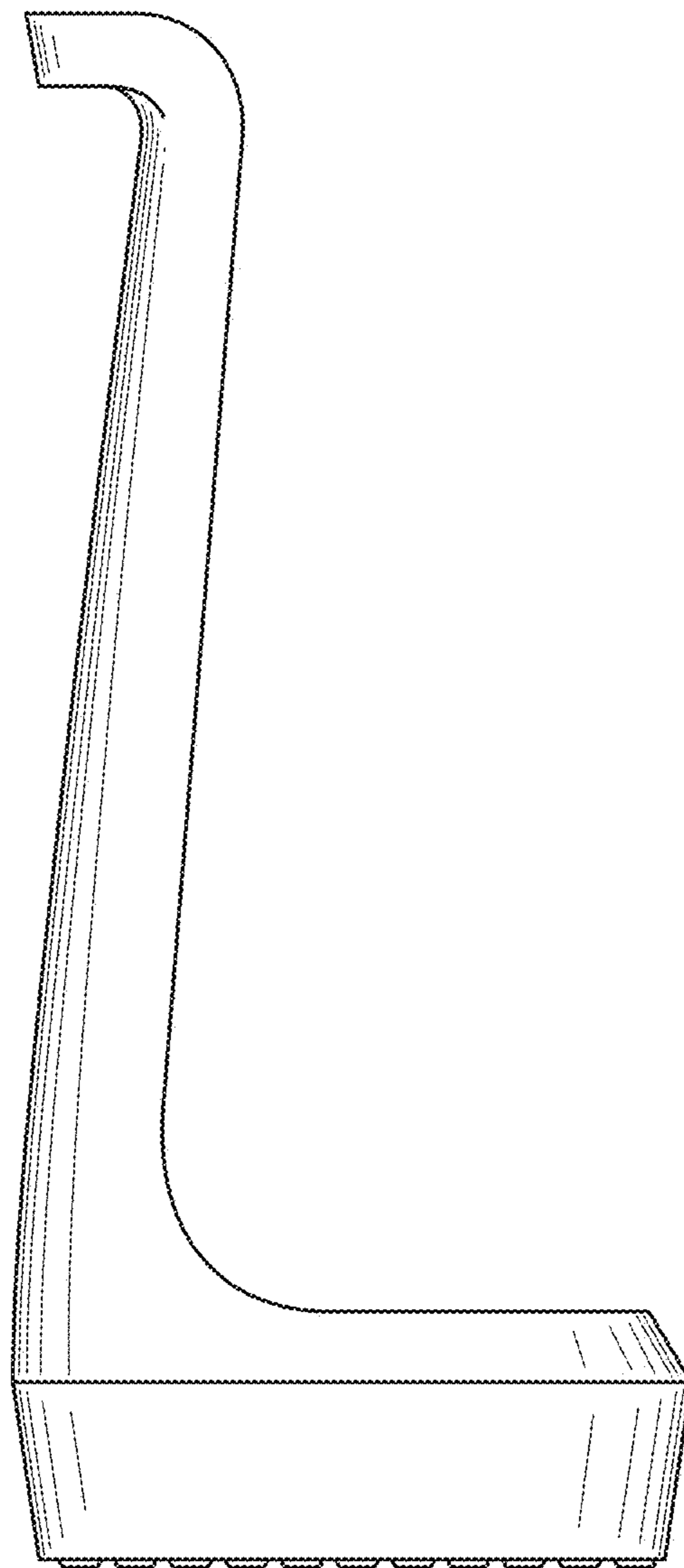

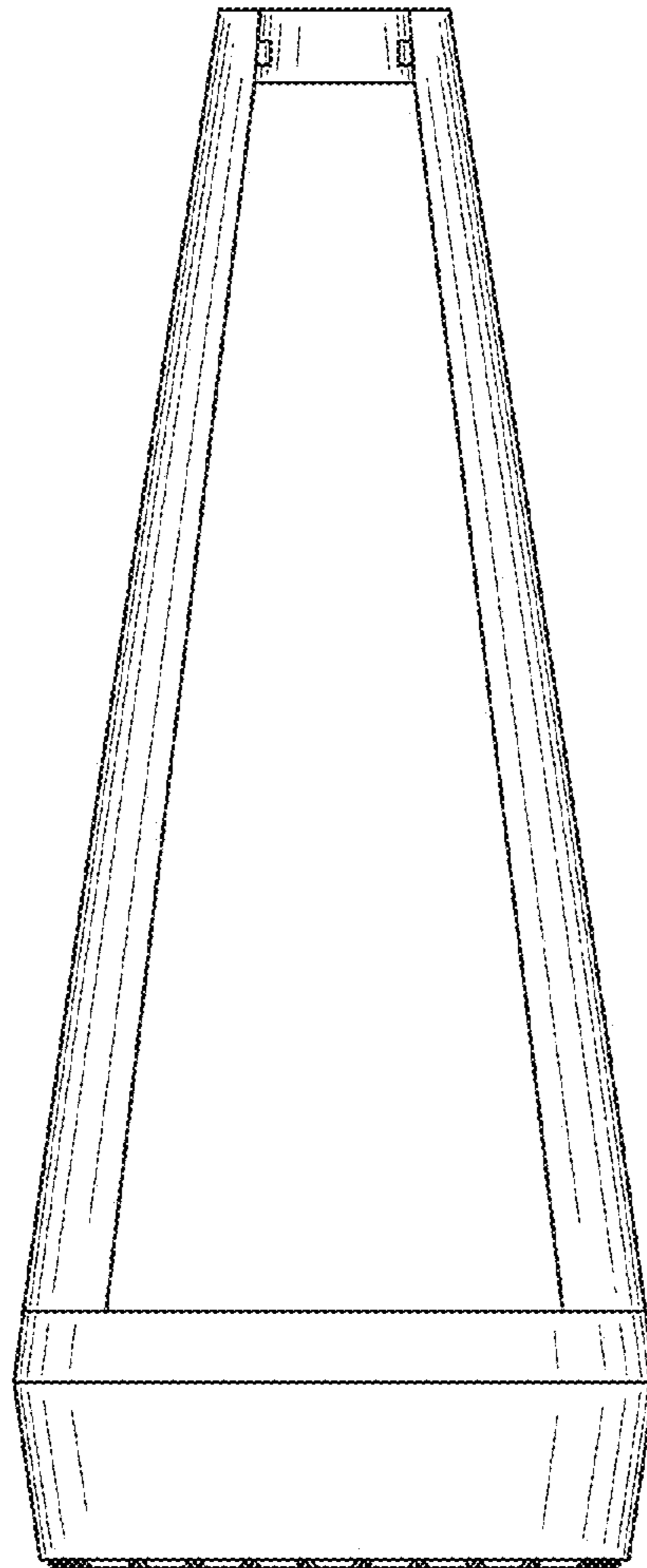

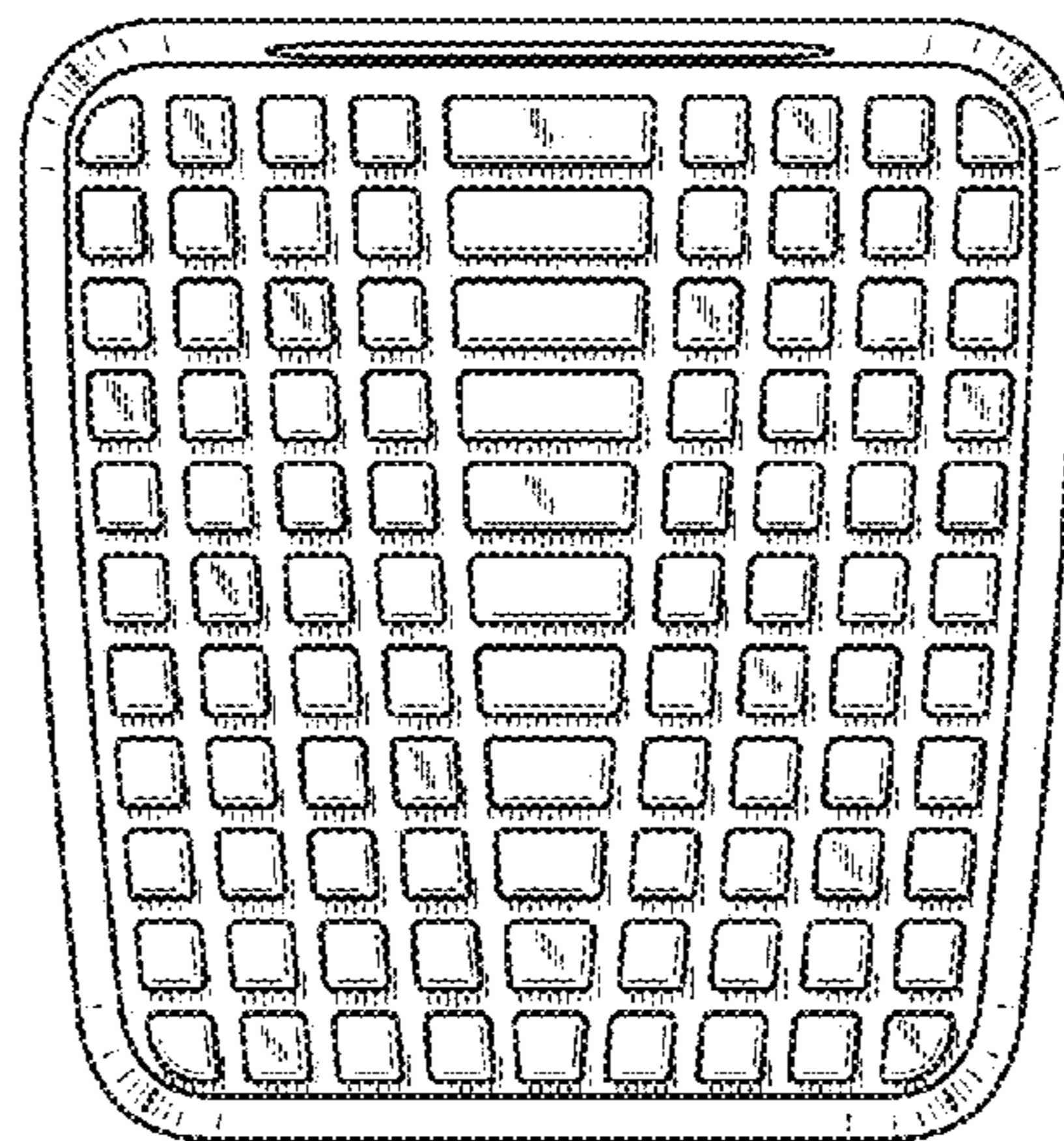

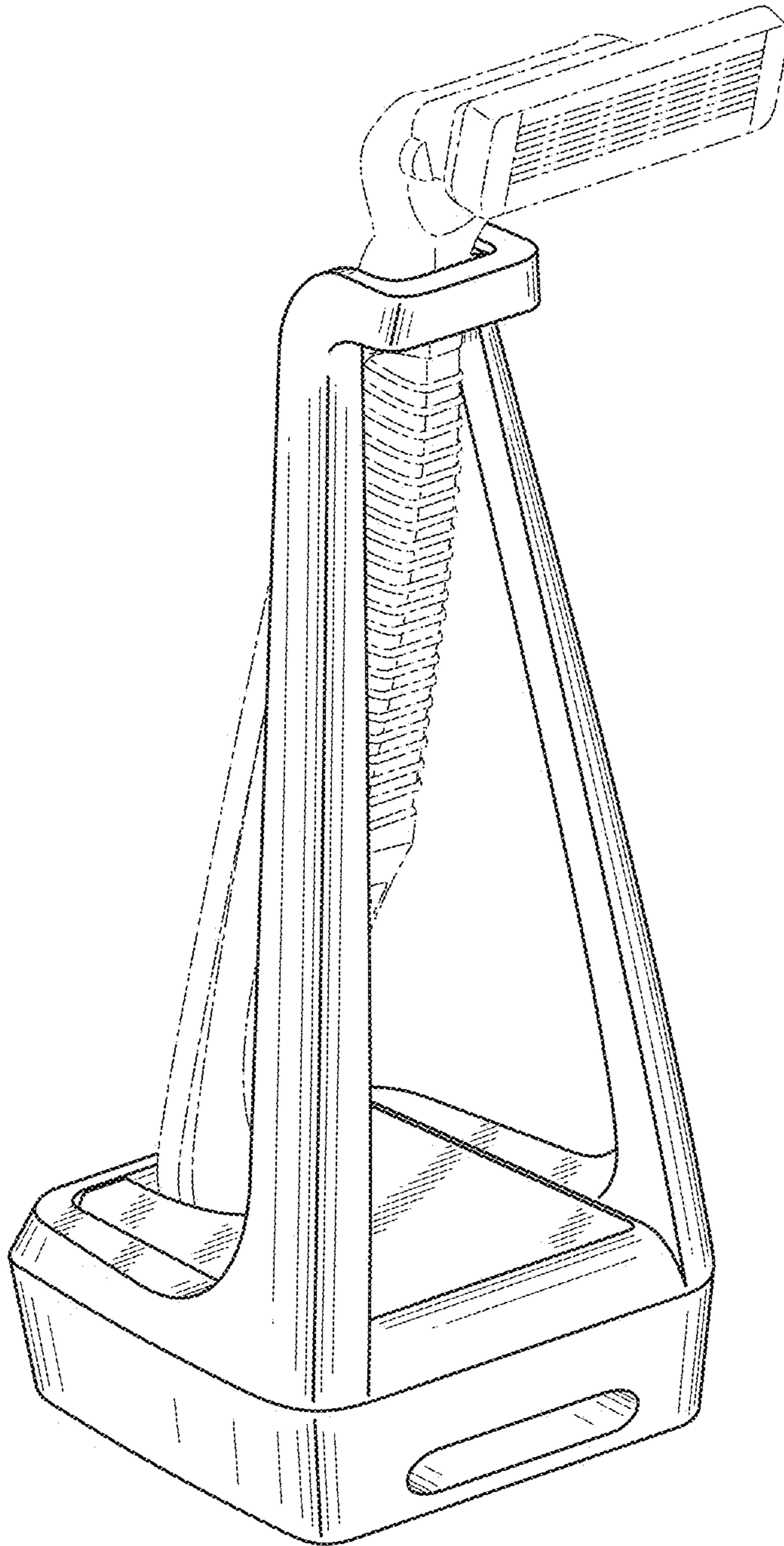
