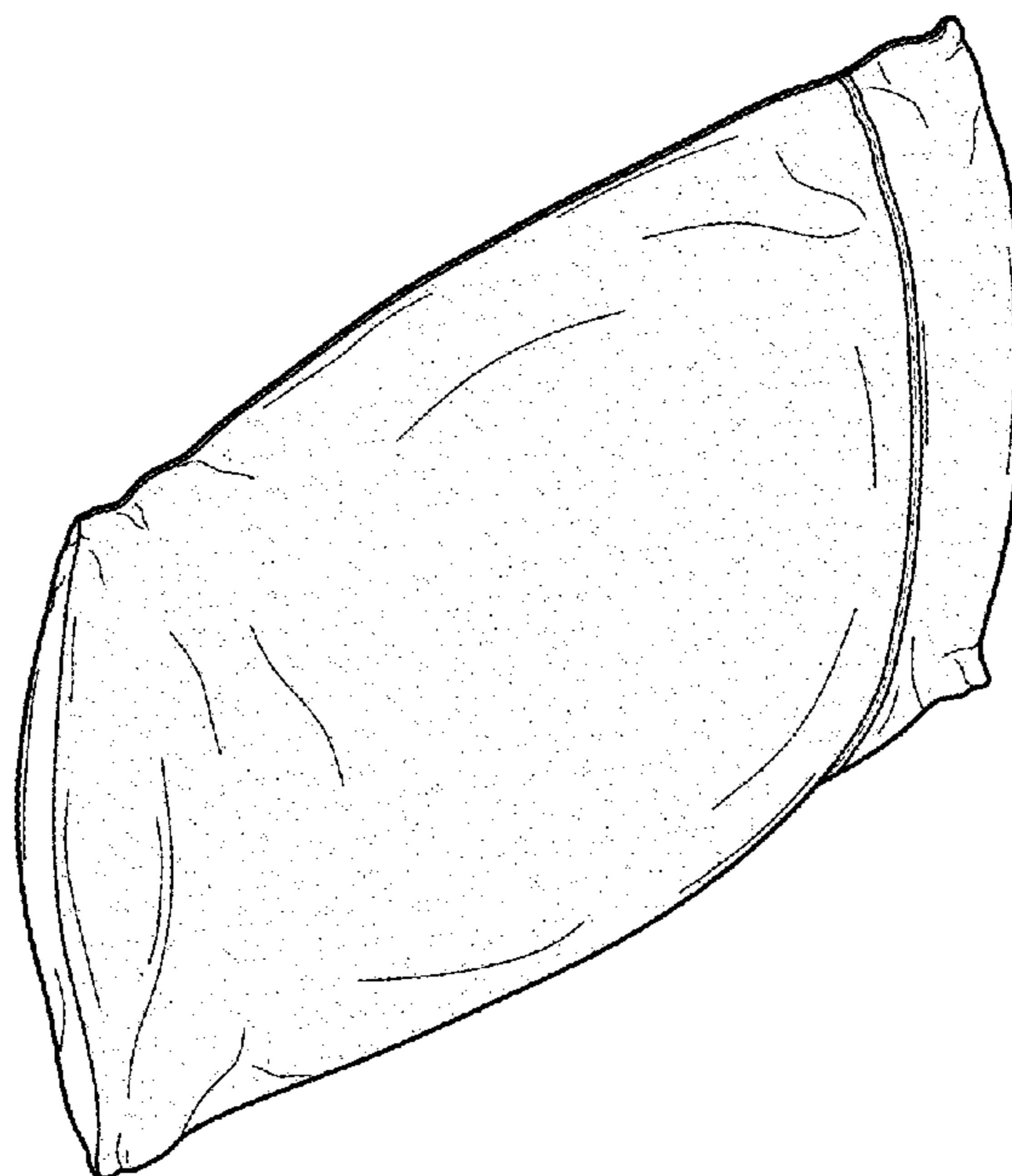
(57) **CLAIM**

The ornamental design for a pillow case, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pillow case showing our new design;  
FIG. 2 is a perspective view of the rear of the pillow case of FIG. 1;  
FIG. 3 is a front elevational view of the pillow case of FIG. 1;  
FIG. 4 is a rear elevational view of the pillow case of FIG. 1;  
FIG. 5 is a top elevational view of the pillow case of FIG. 1;  
FIG. 6 is a left elevational view of the pillow case of FIG. 1;

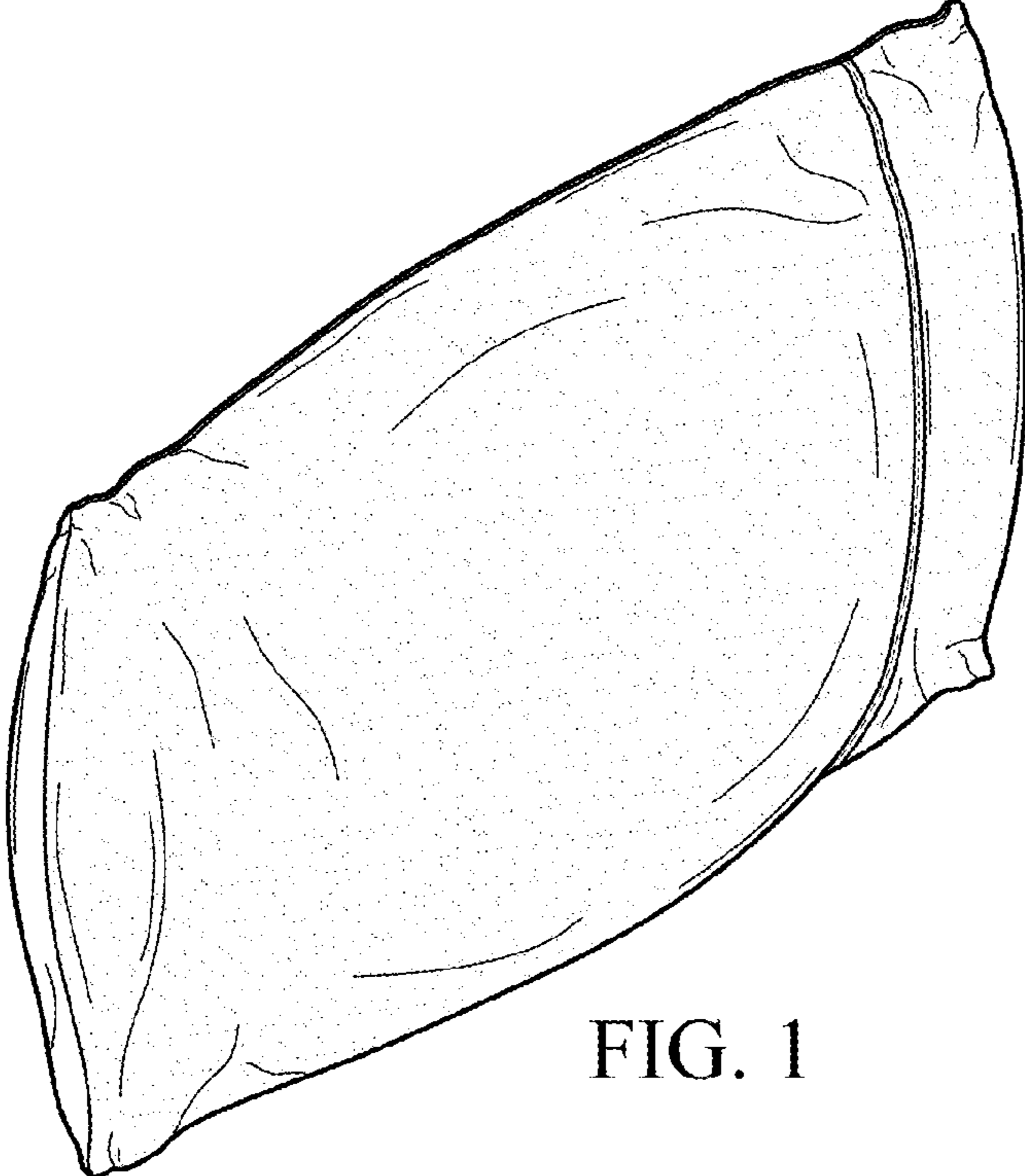

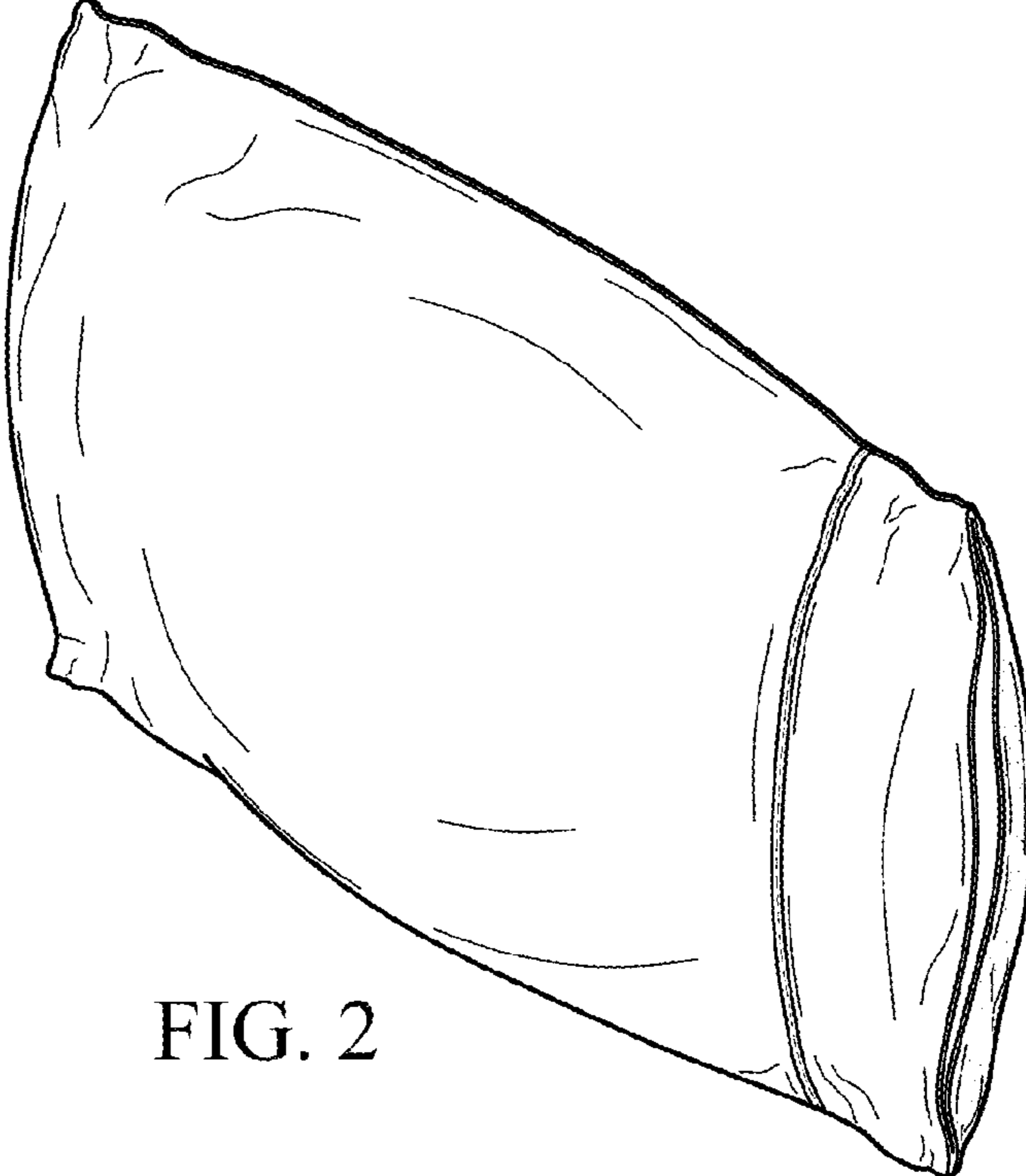

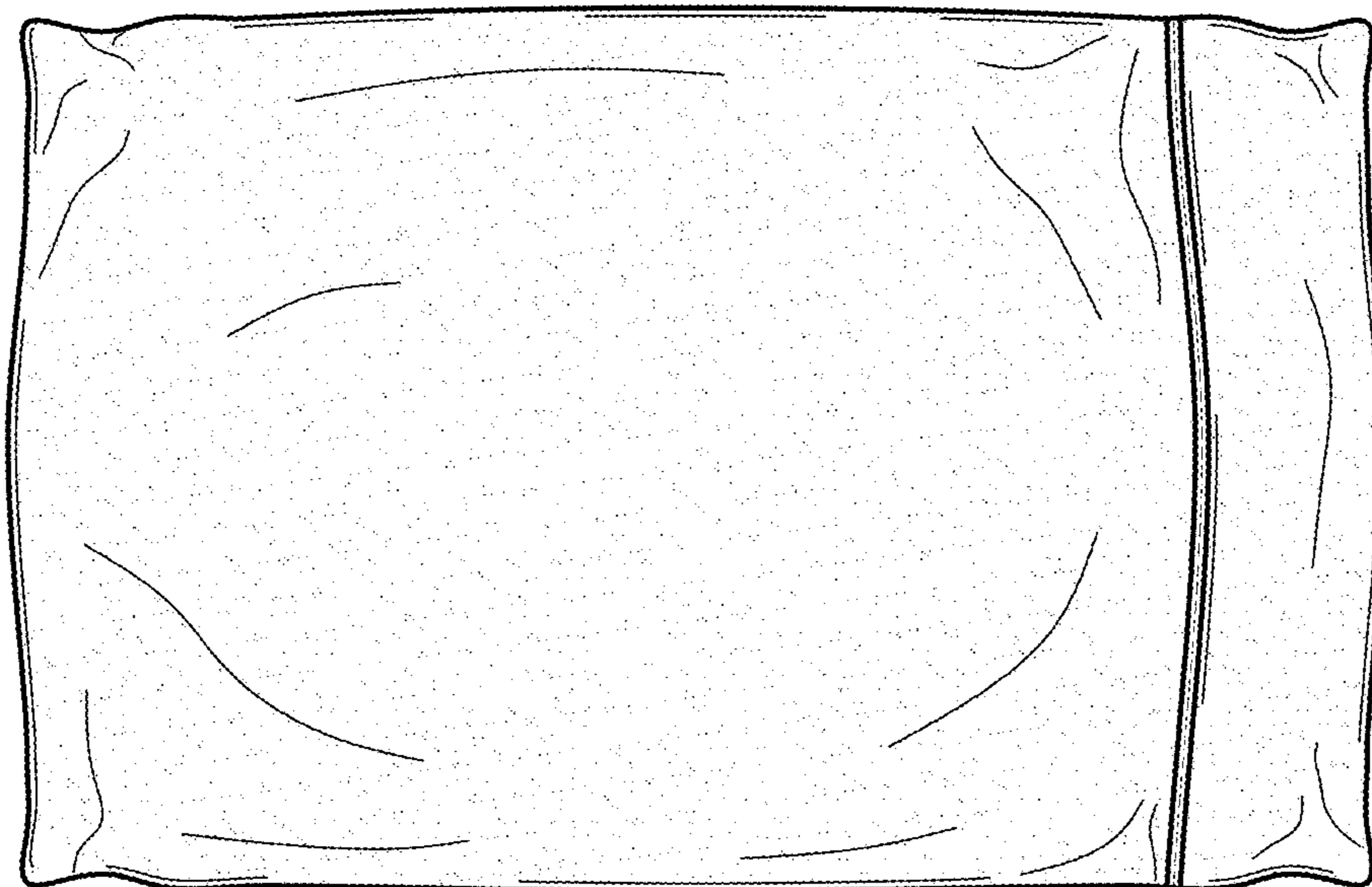

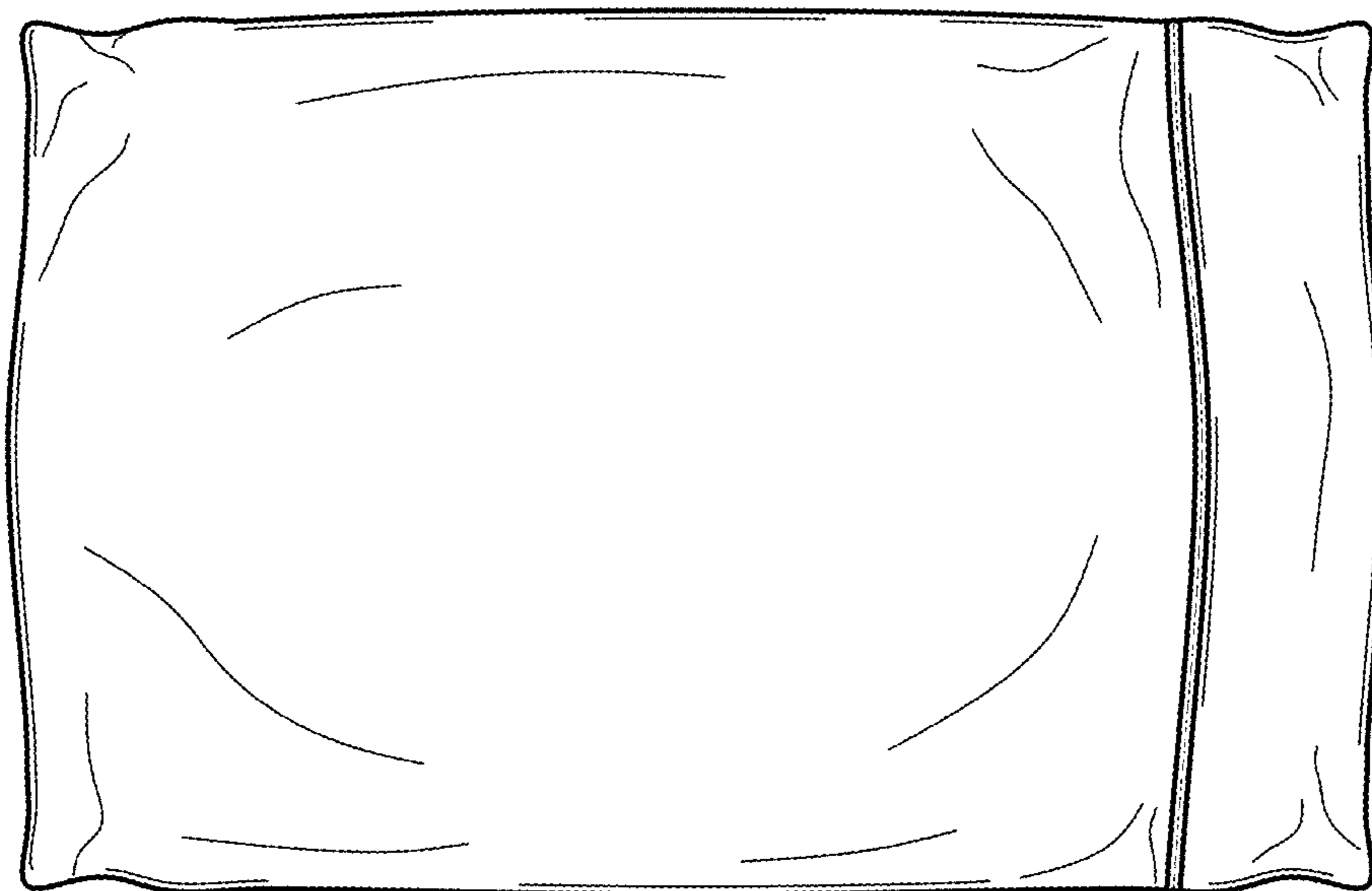

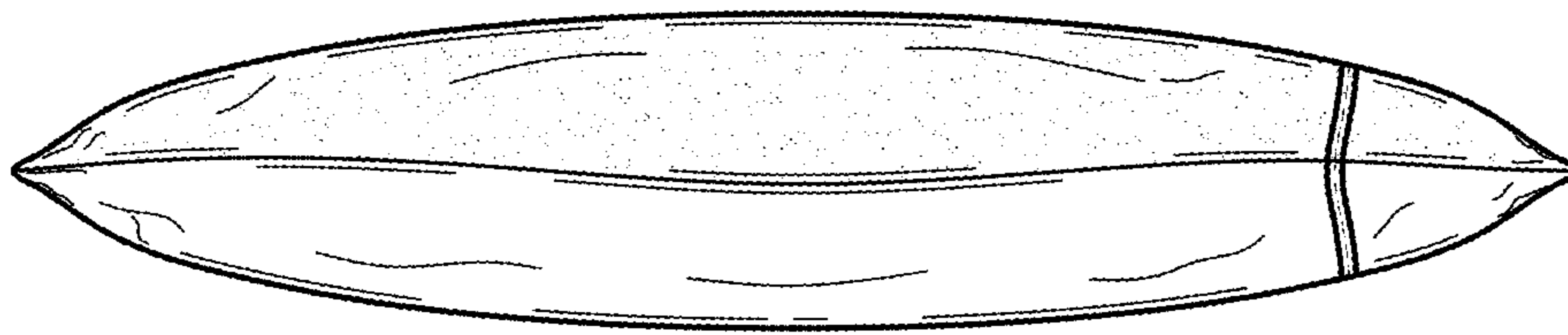

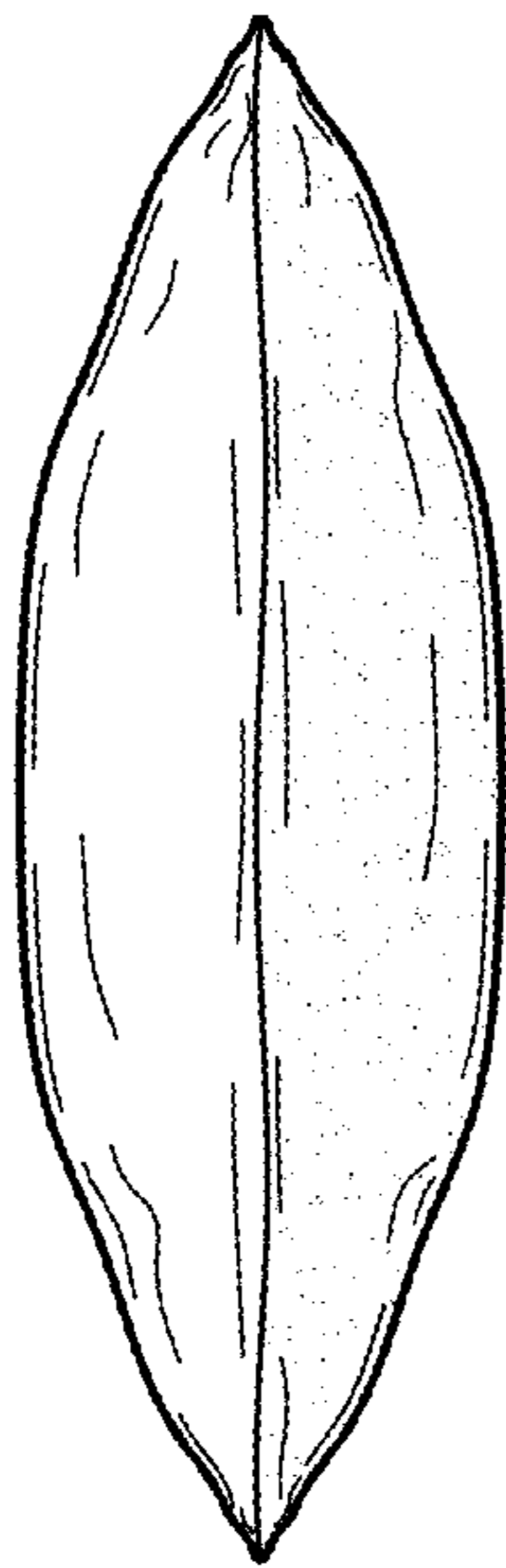

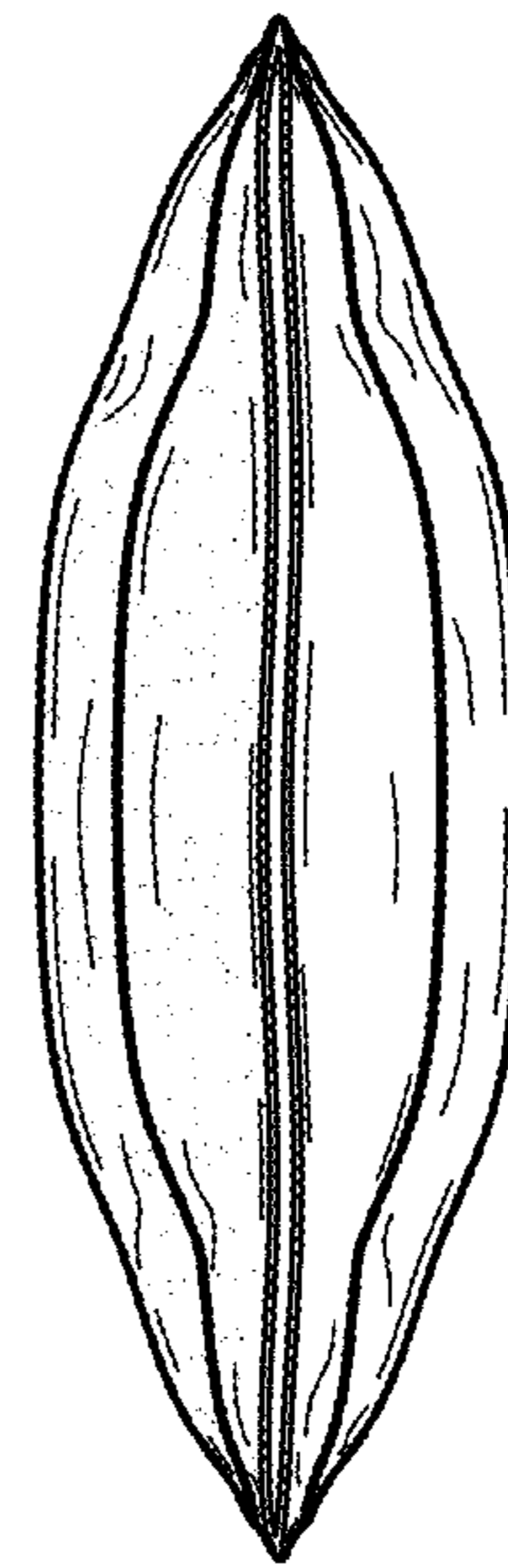
