(57) **CLAIM**

The ornamental design for a rotatable knob for an electronic cam lock, substantially as shown and described.

DESCRIPTION

FIG. 8 is a top plan view thereof;

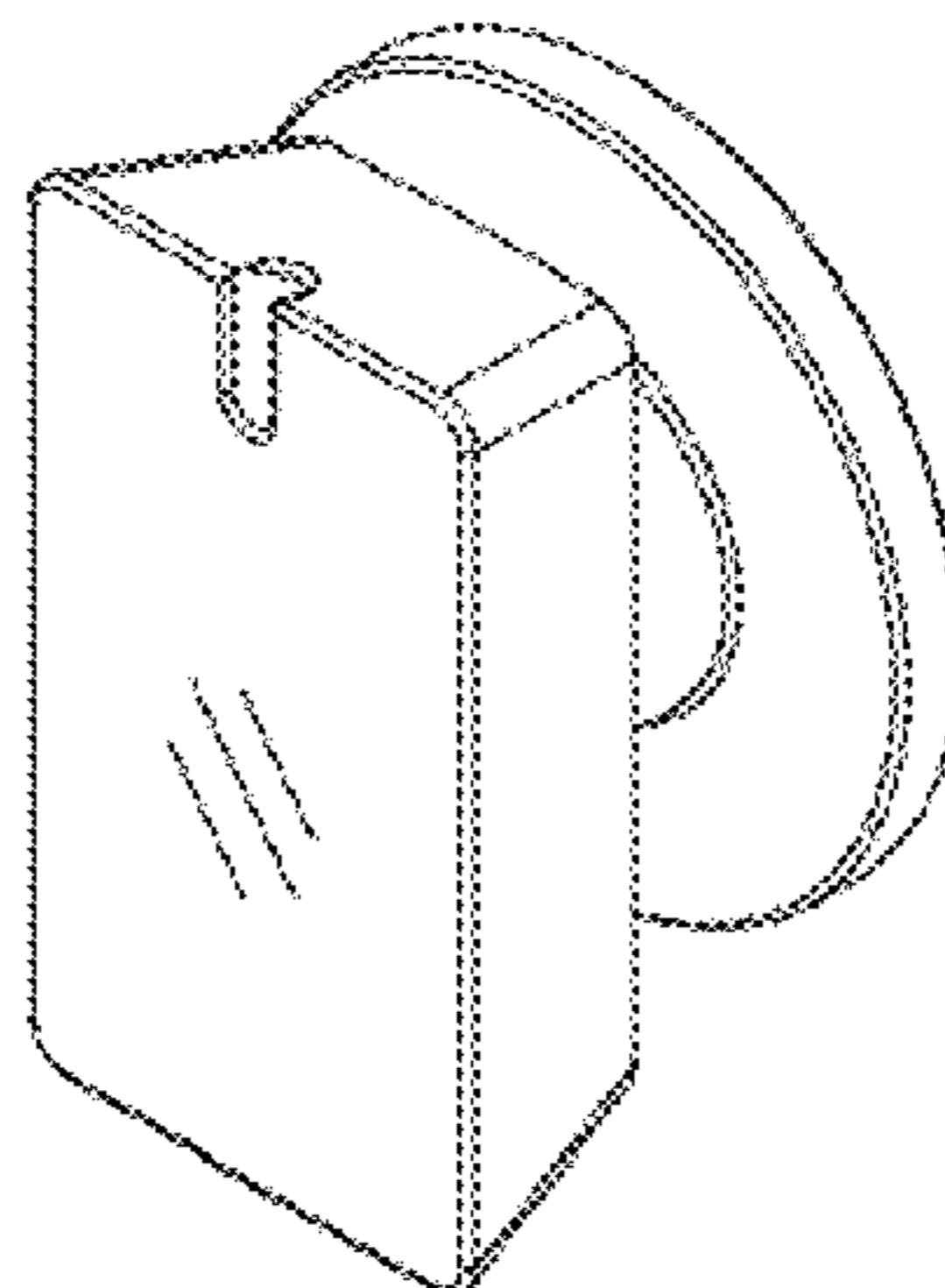
FIG. 9 is a left side view thereof;

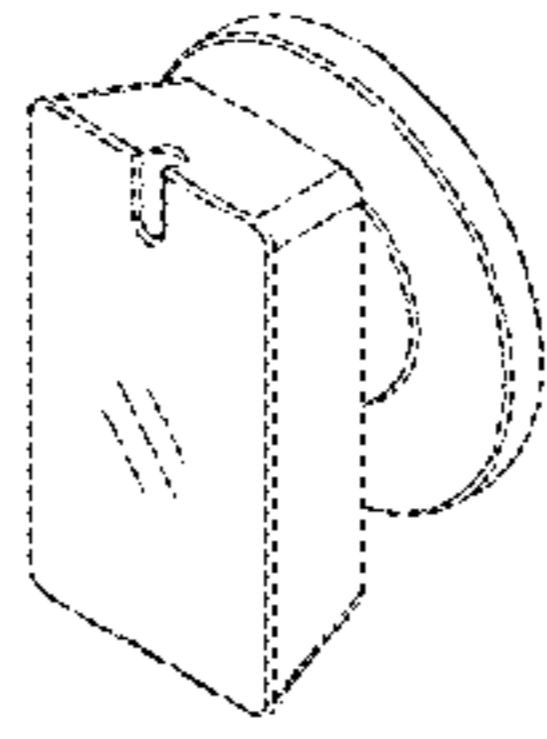

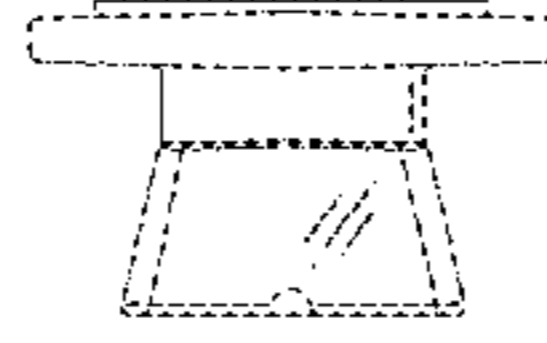

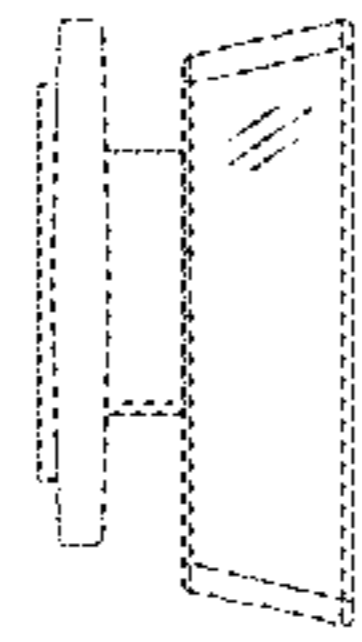

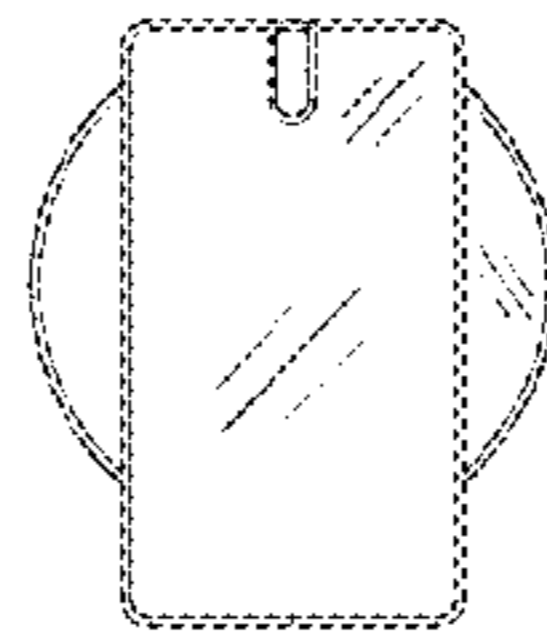

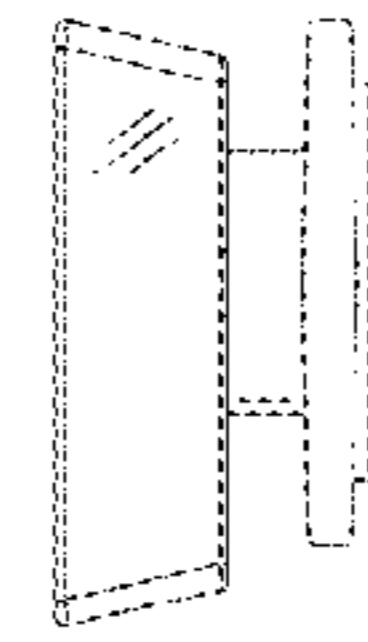

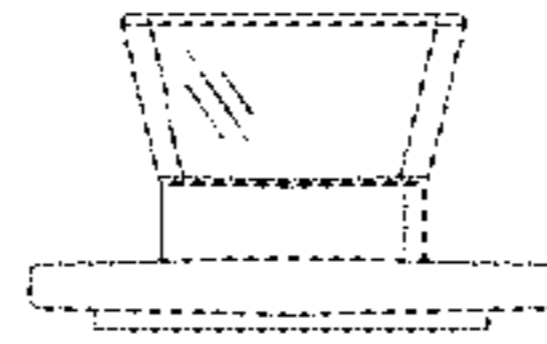

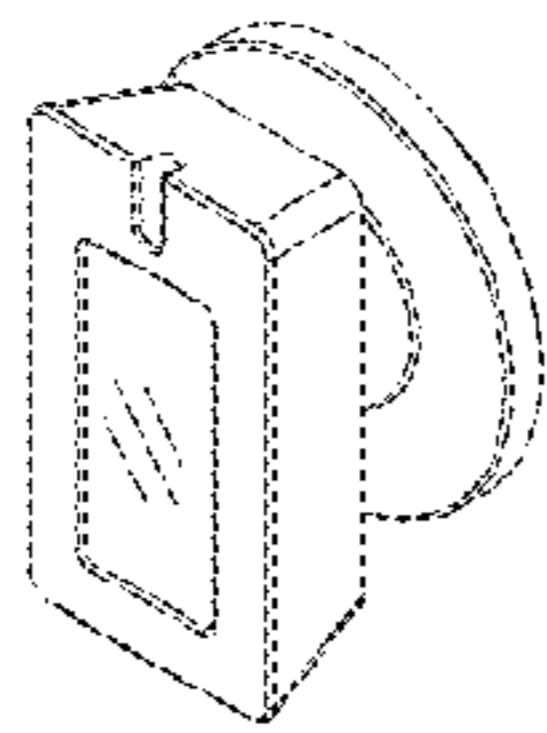

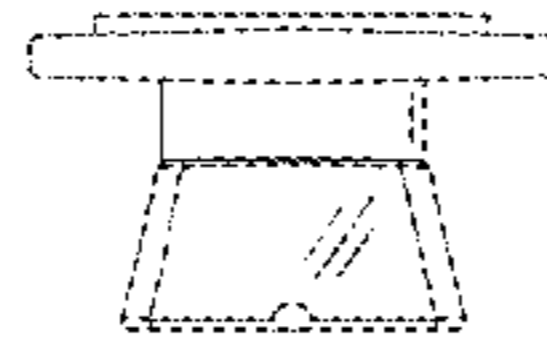

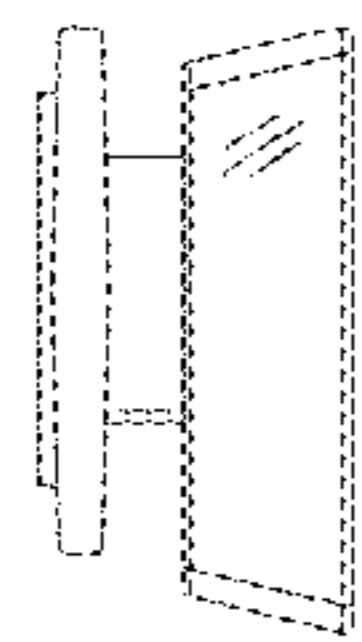

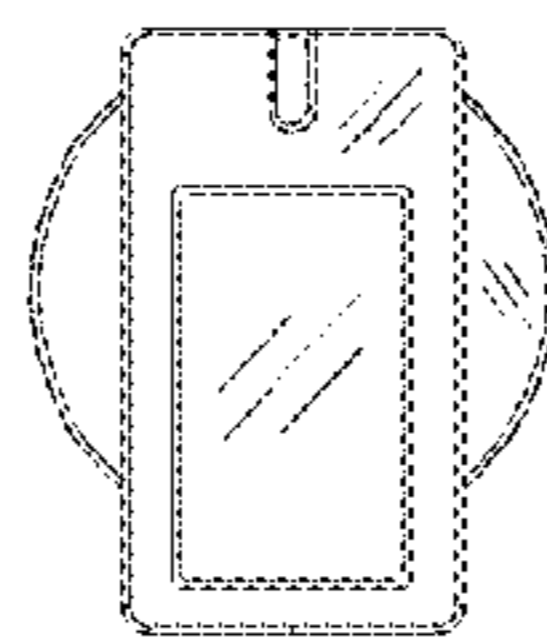

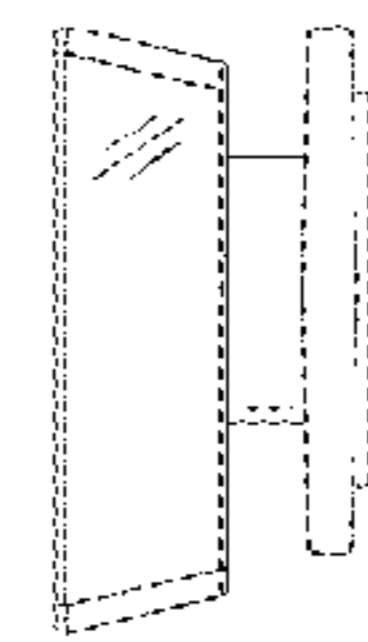
