(57) **CLAIM**

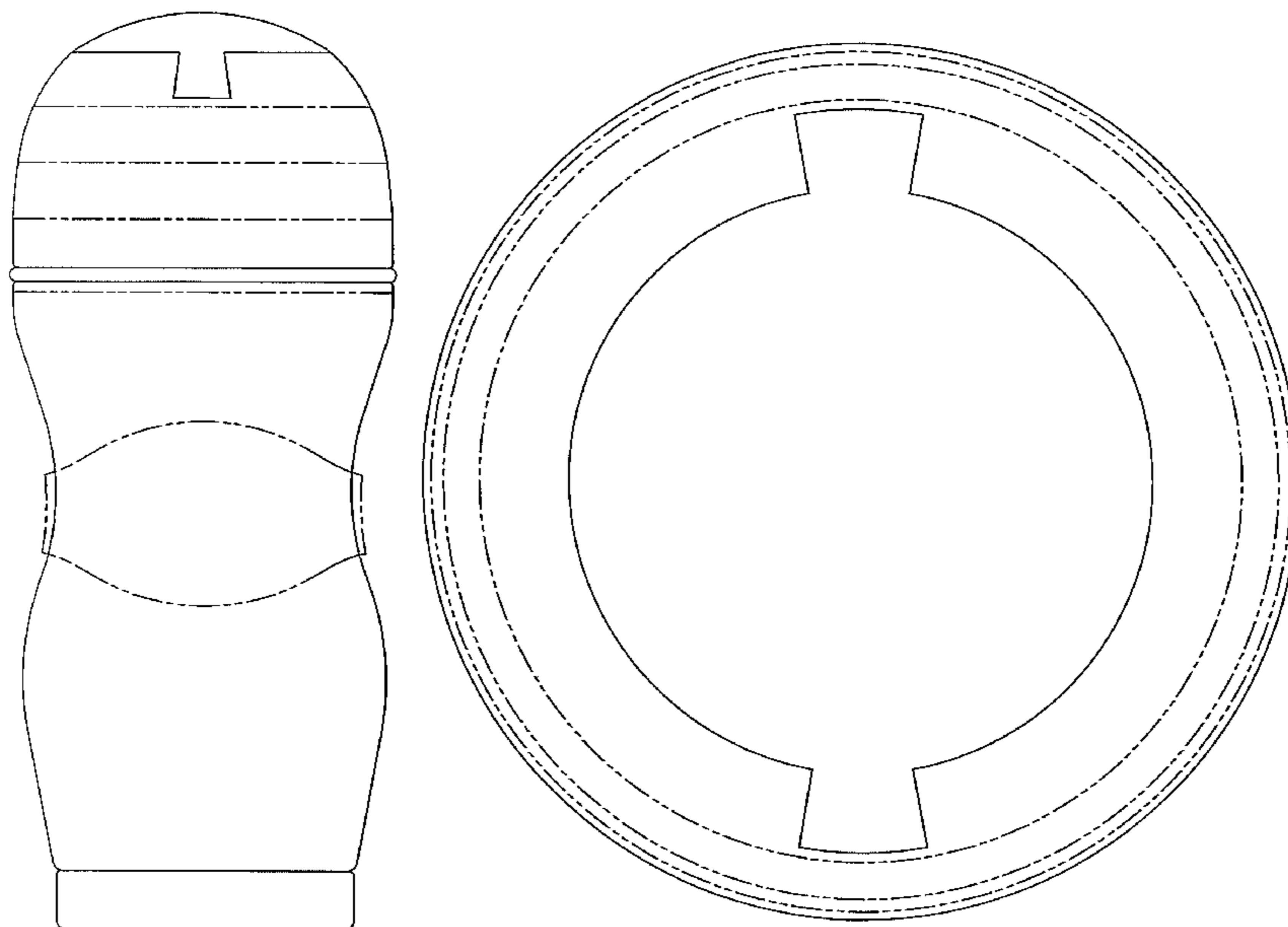
The ornamental design for a cosmetic container, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a cosmetic container showing our new design; FIG. 2 is a right side elevation view thereof, the left side elevation view is being identical; FIG. 3 is a top plan view thereof, shown at an enlarged scale; FIG. 4 is a rear elevation view of FIG. 1; and, FIG. 5 is a front elevation view of the cosmetic container of FIGS. 1-4 with the unclaimed waistband element to show the claimed surface beneath.

The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design. The four horizontal broken lines in FIGS. 1, 2, 4 & 5 and the three circular broken lines in FIG. 3 represent unclaimed lines on claimed surfaces. The waistband element shown in broken lines in FIGS. 1, 2 & 4 has been shown for illustrative purposes only, also forming no part of the claimed design.

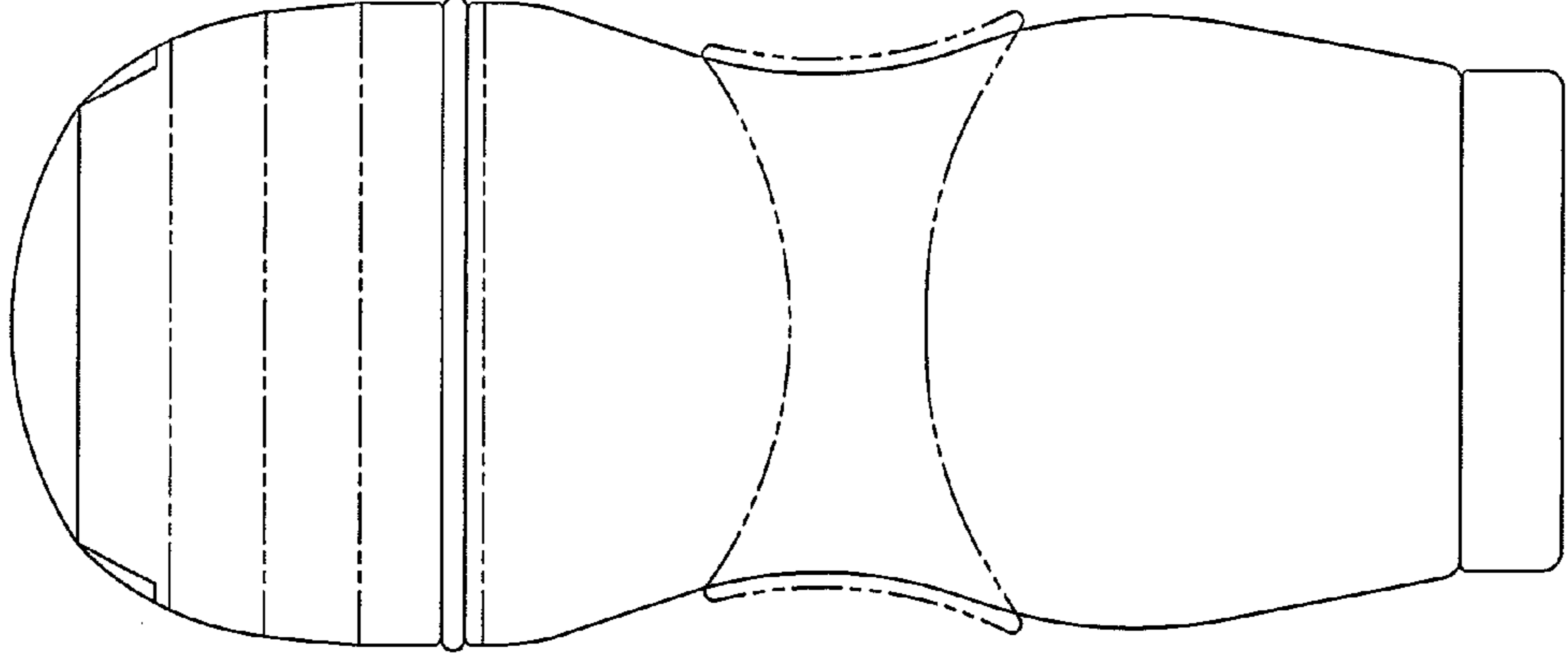

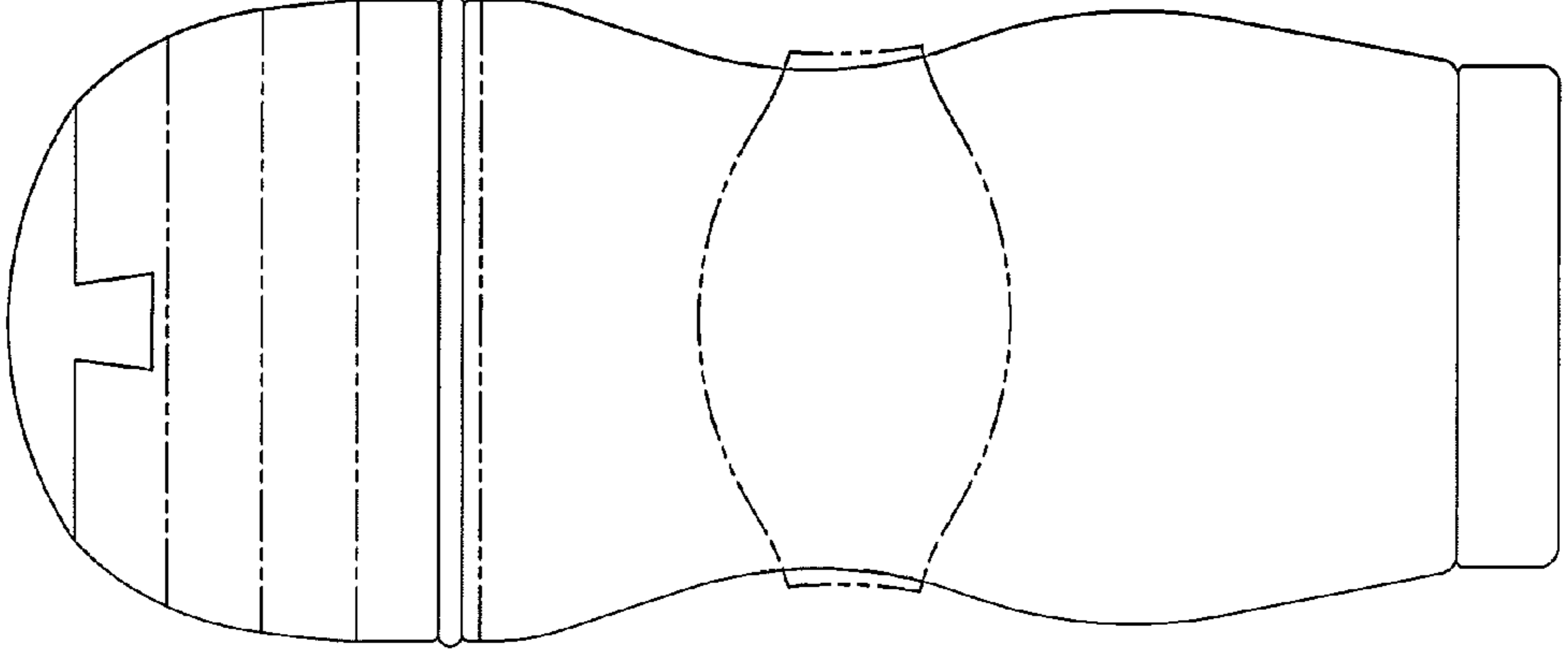

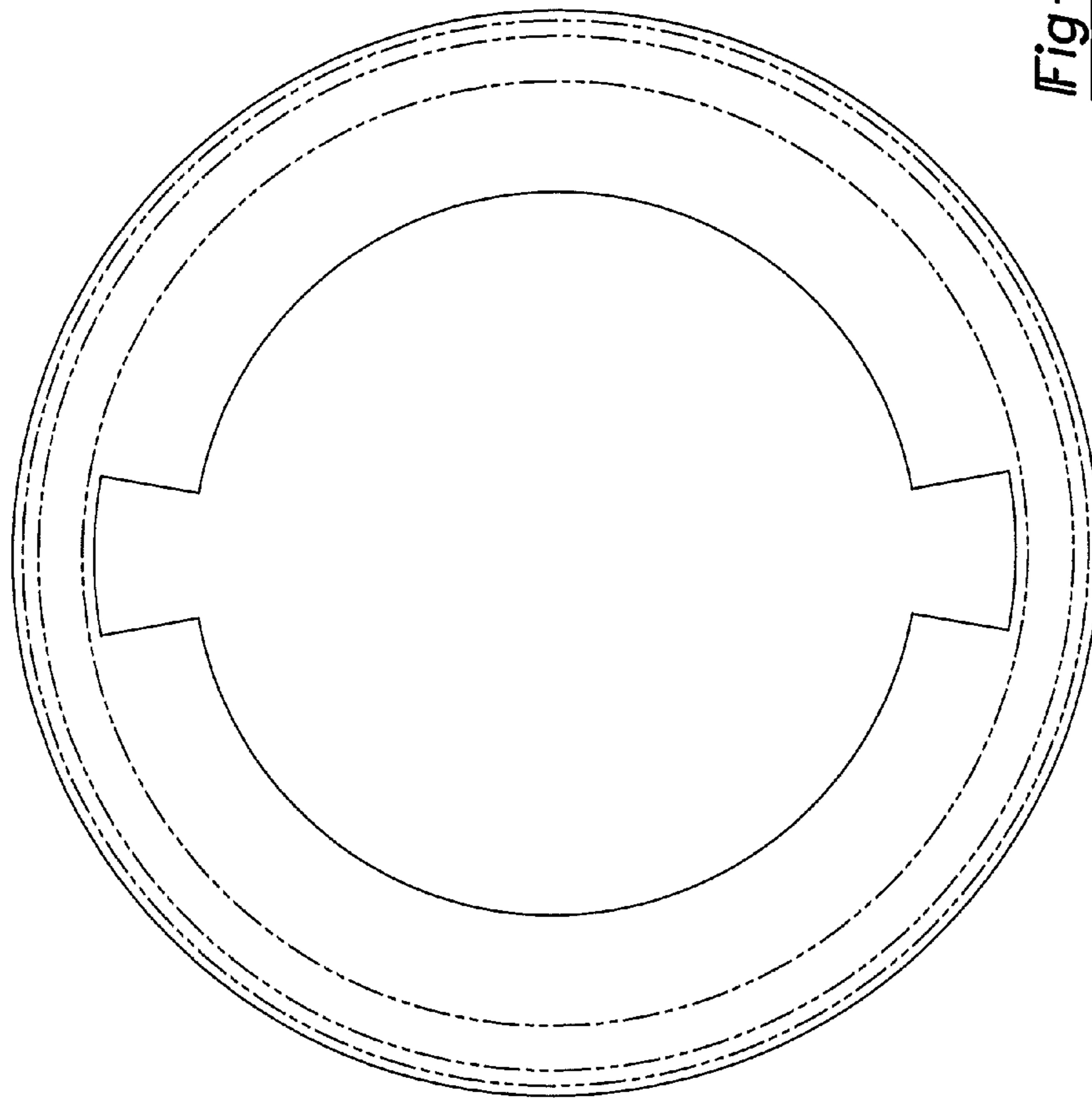

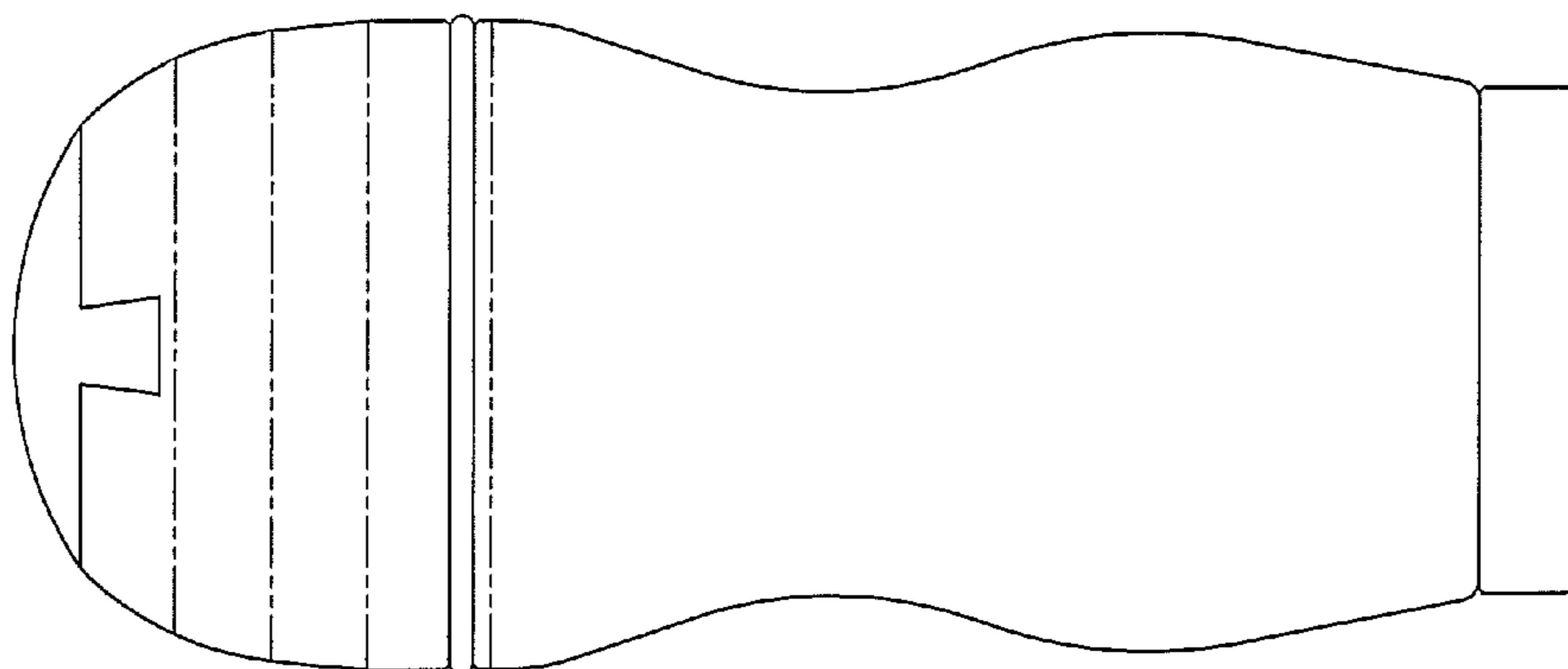

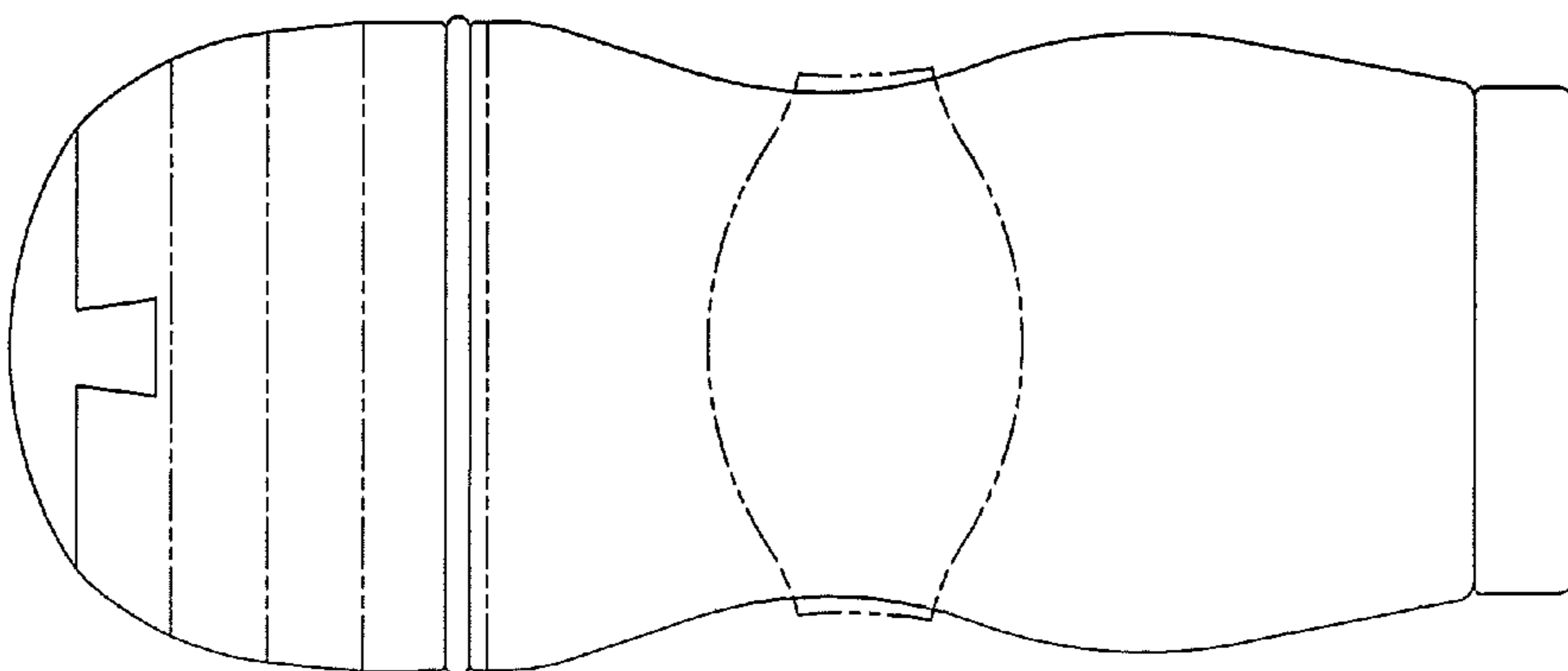
