FIG. 1 is a top, front perspective view of a container according to our new design;

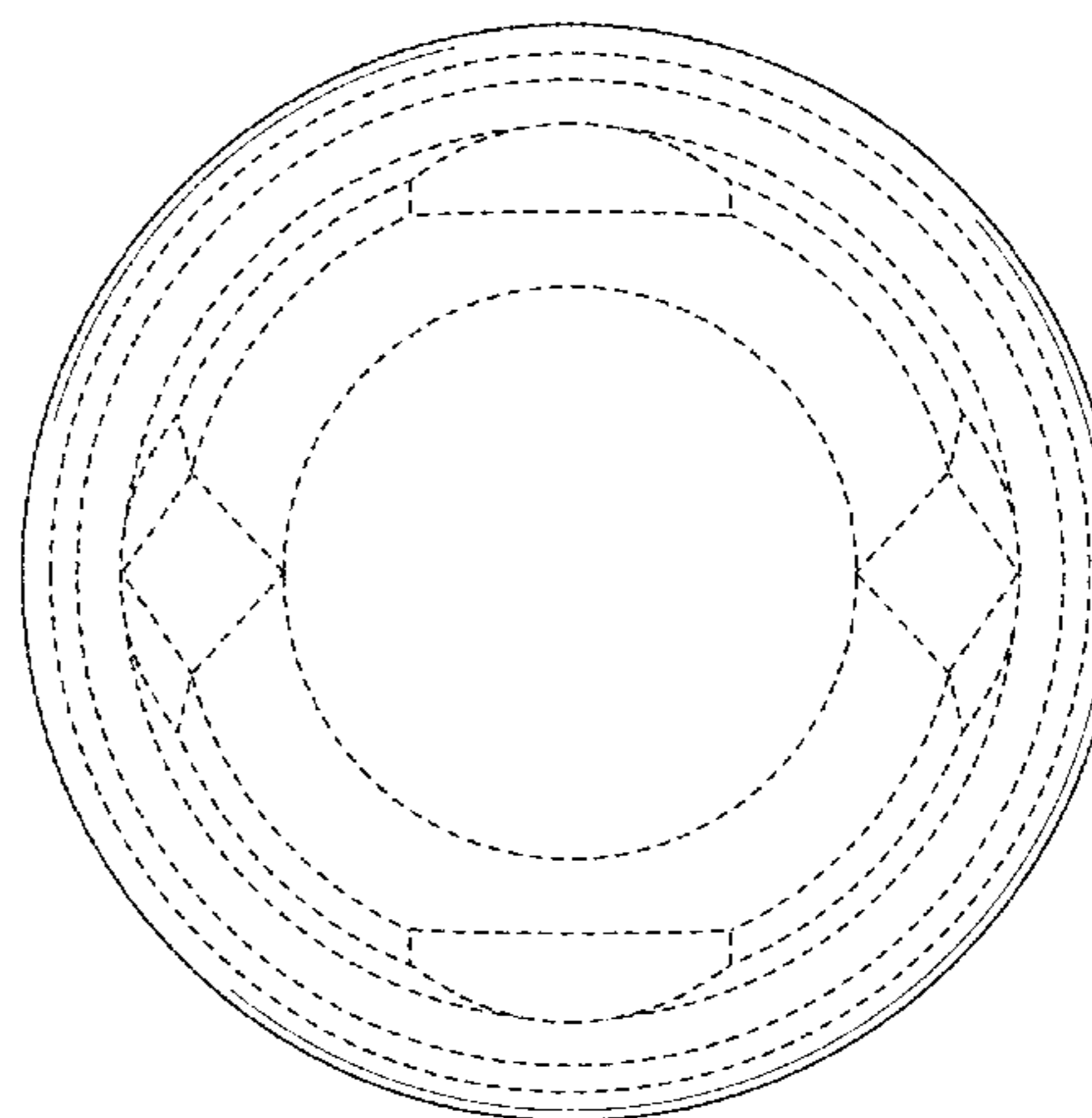
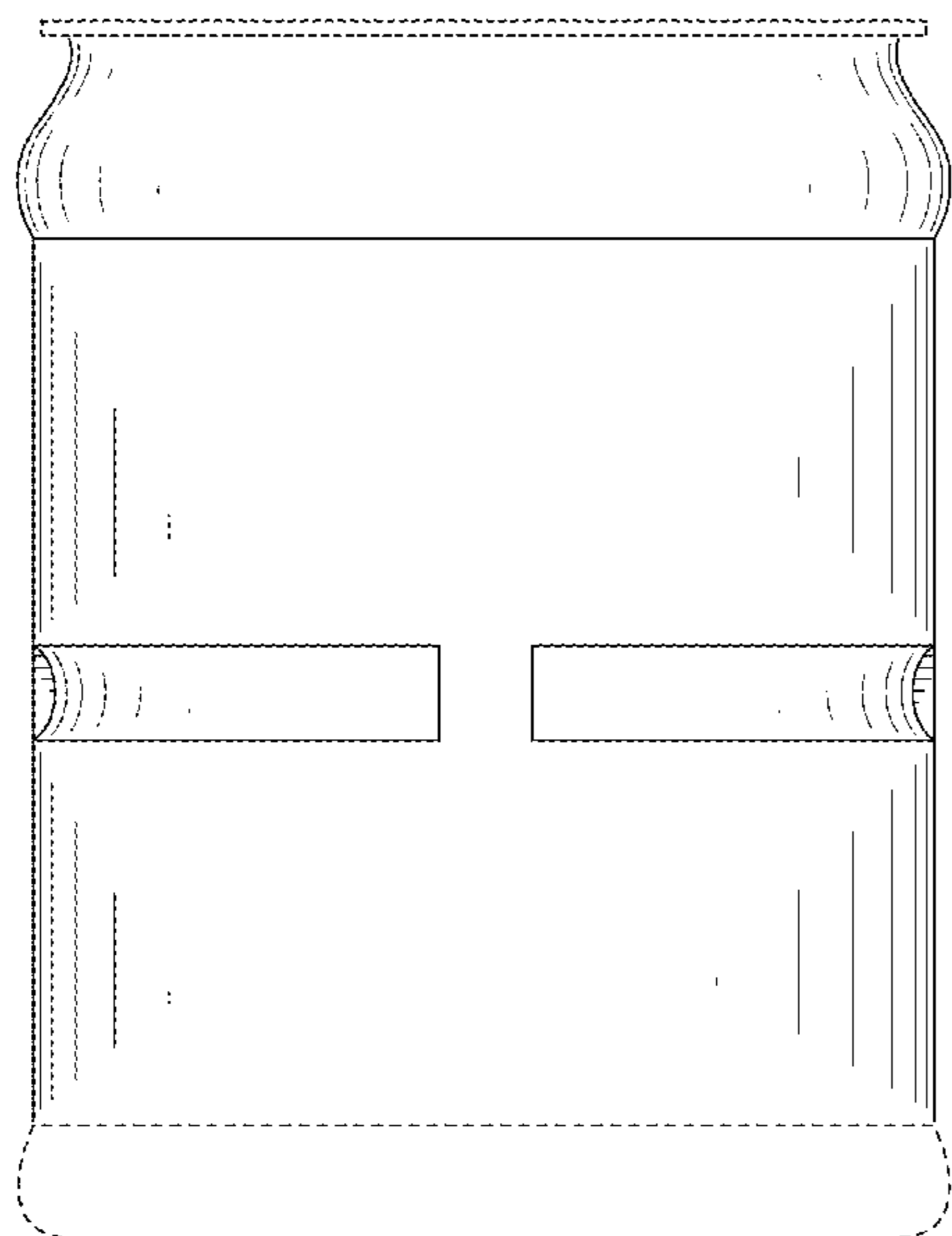
FIG. 2 is a side view of the container of FIG. 1;

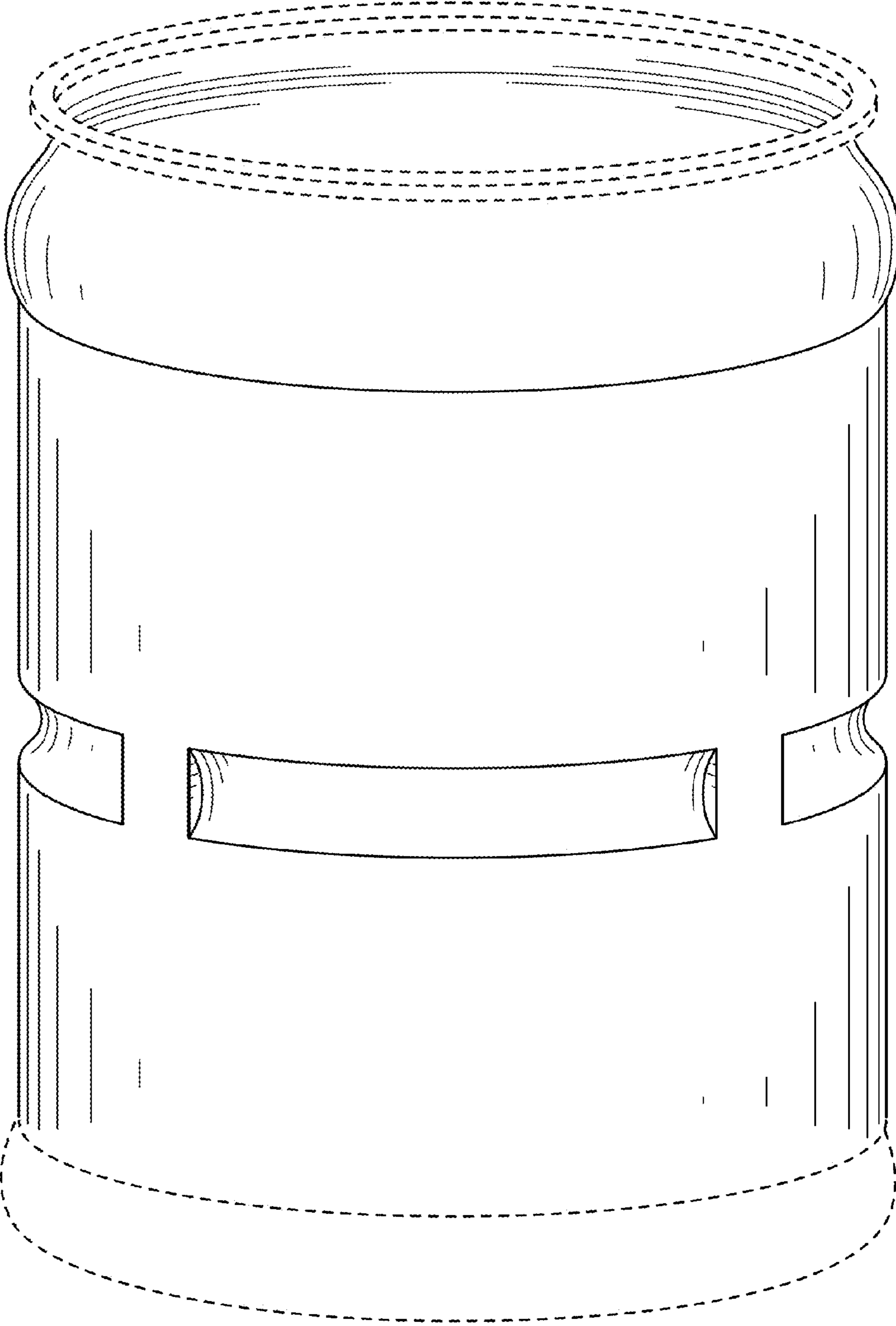

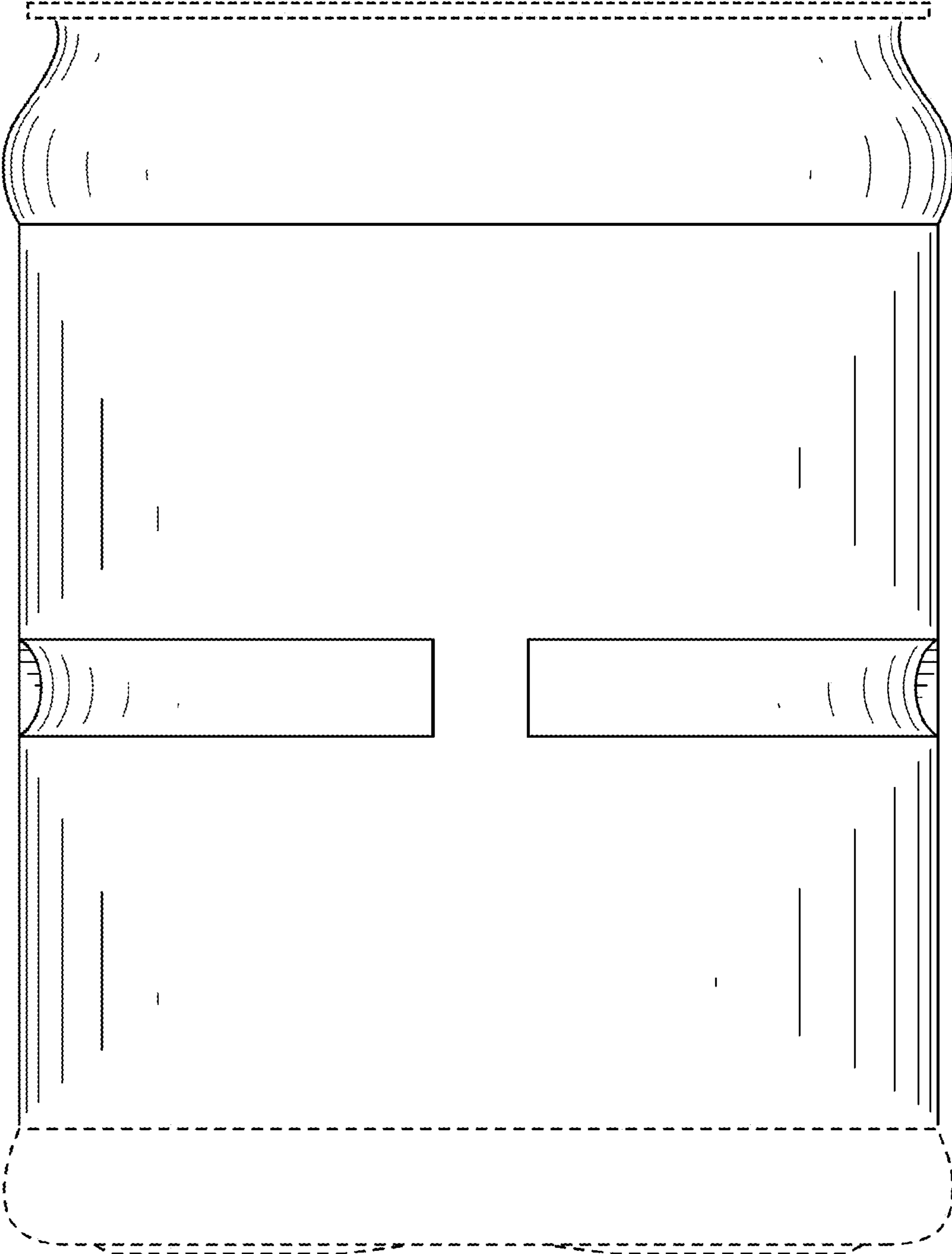

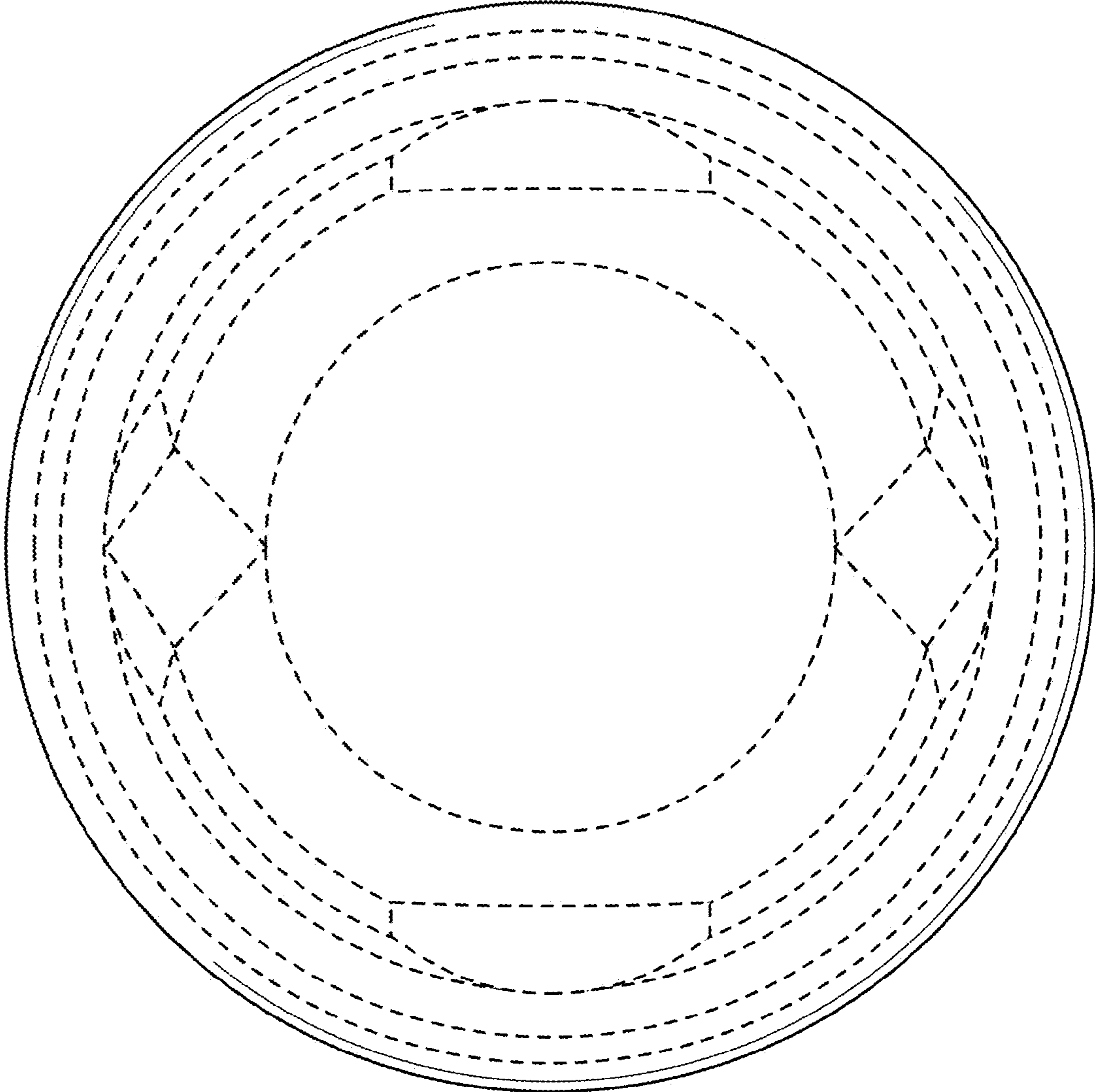

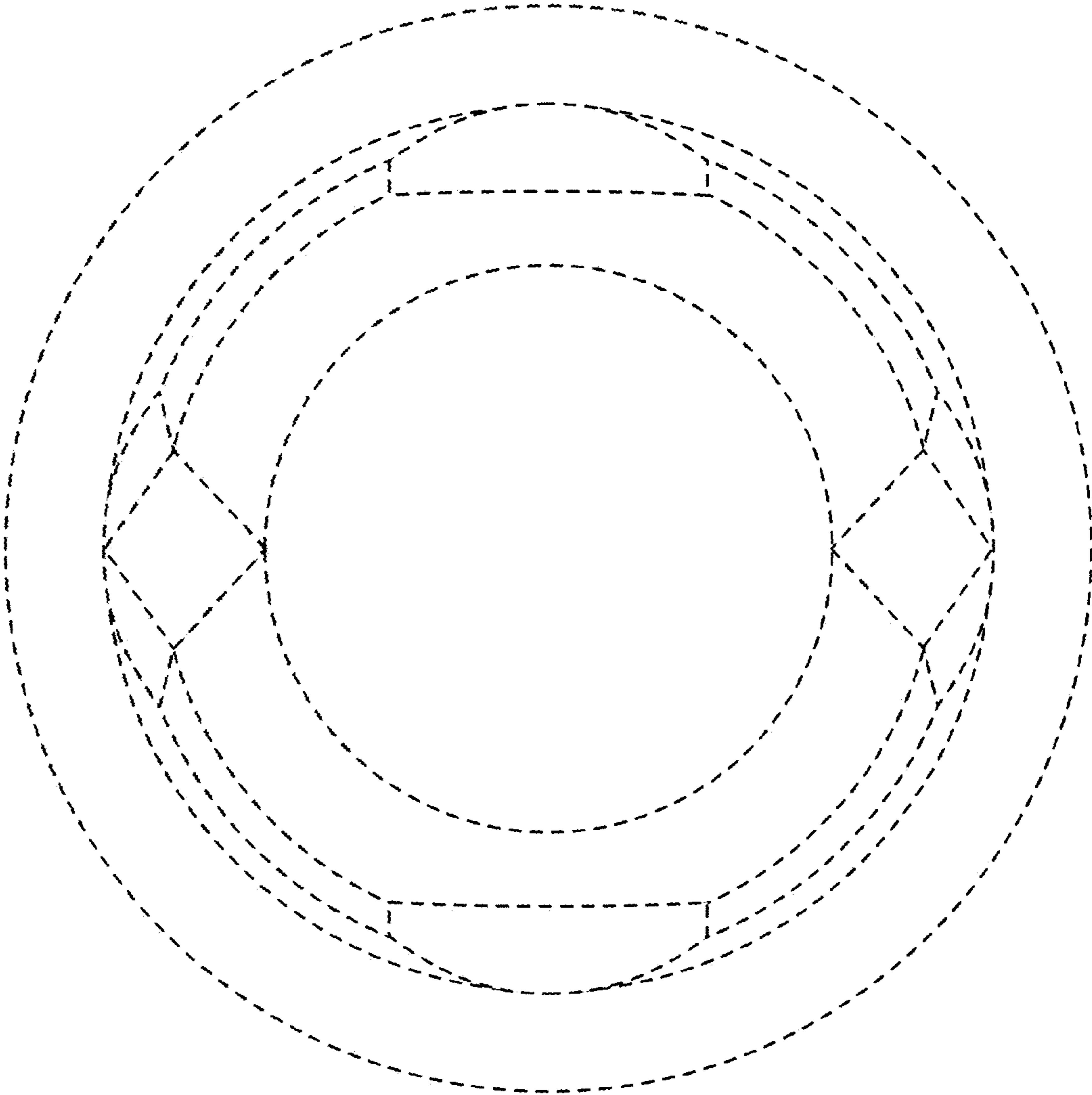
