FIG. 14 is a perspective view thereof.

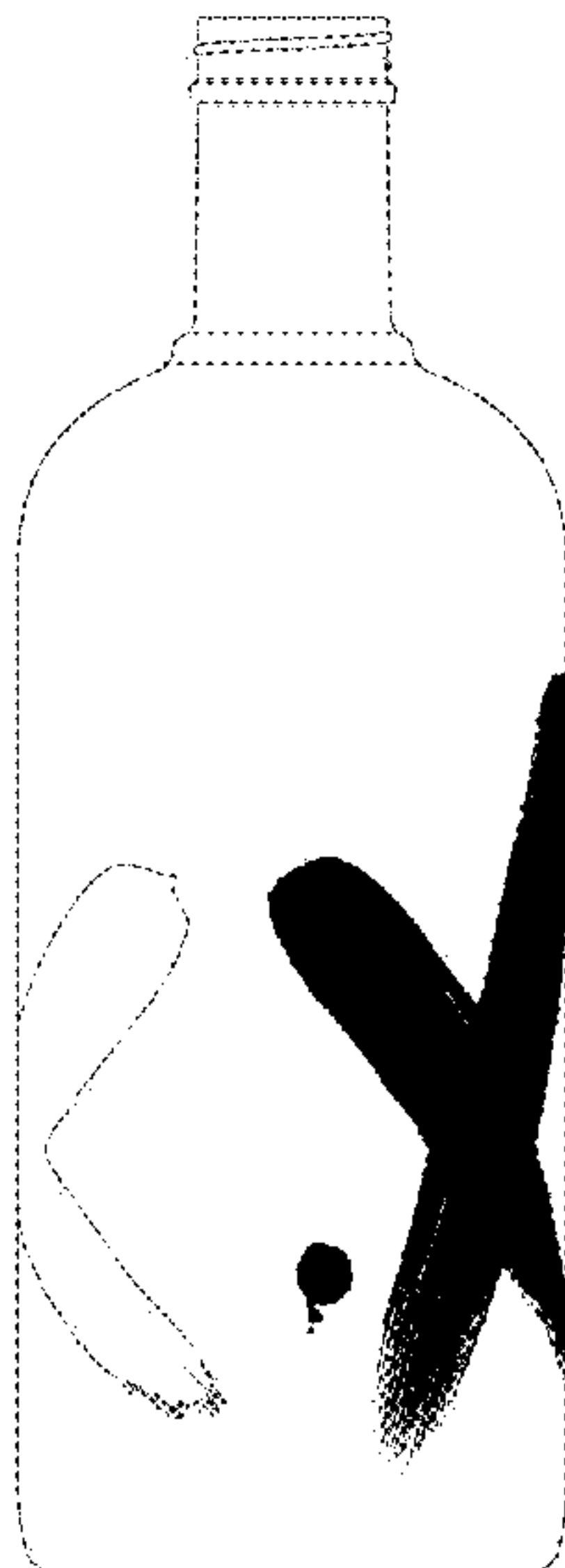

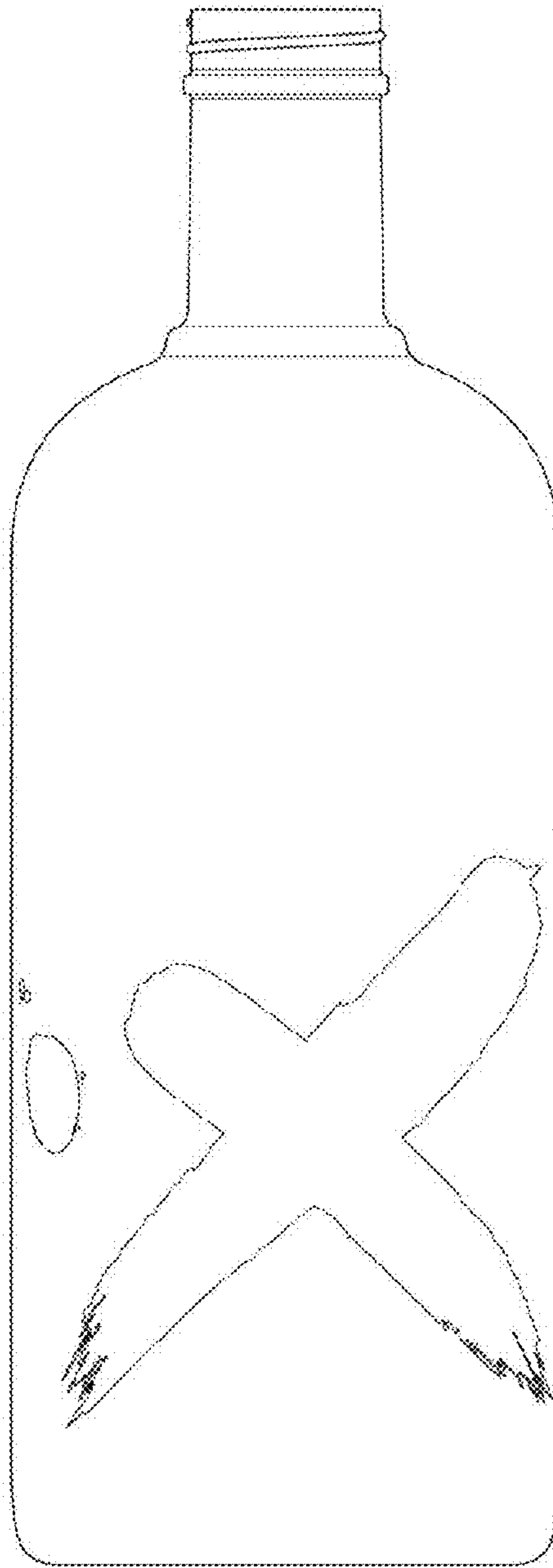

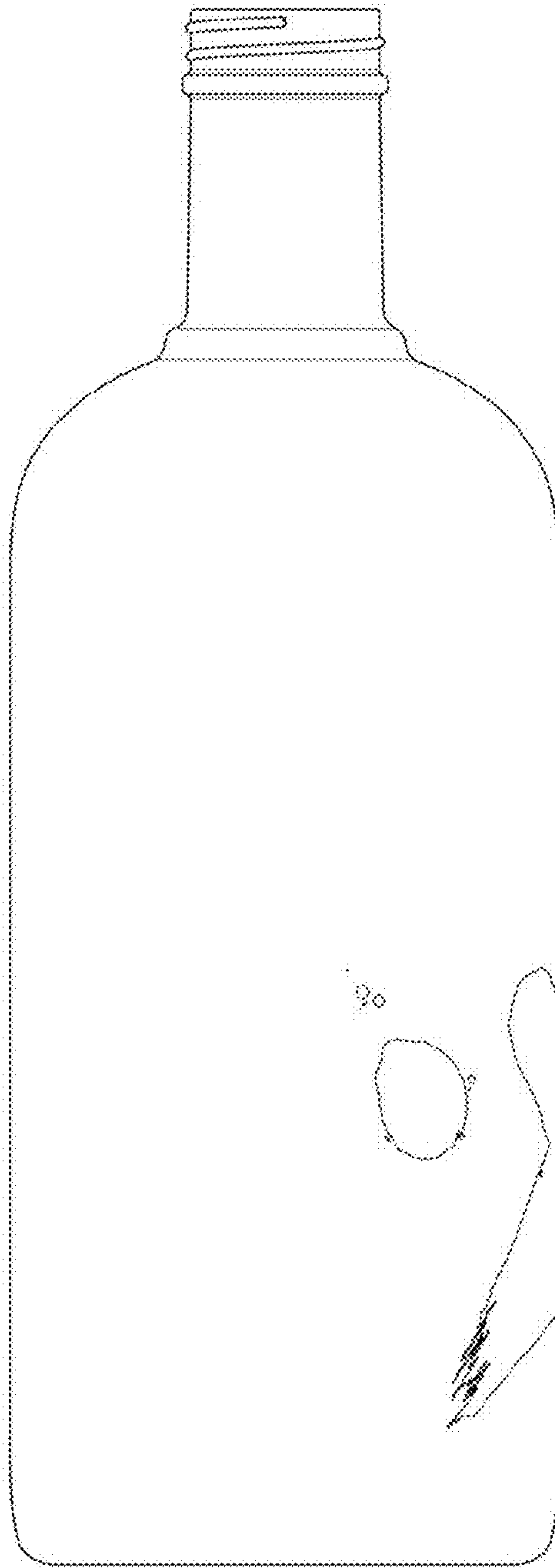

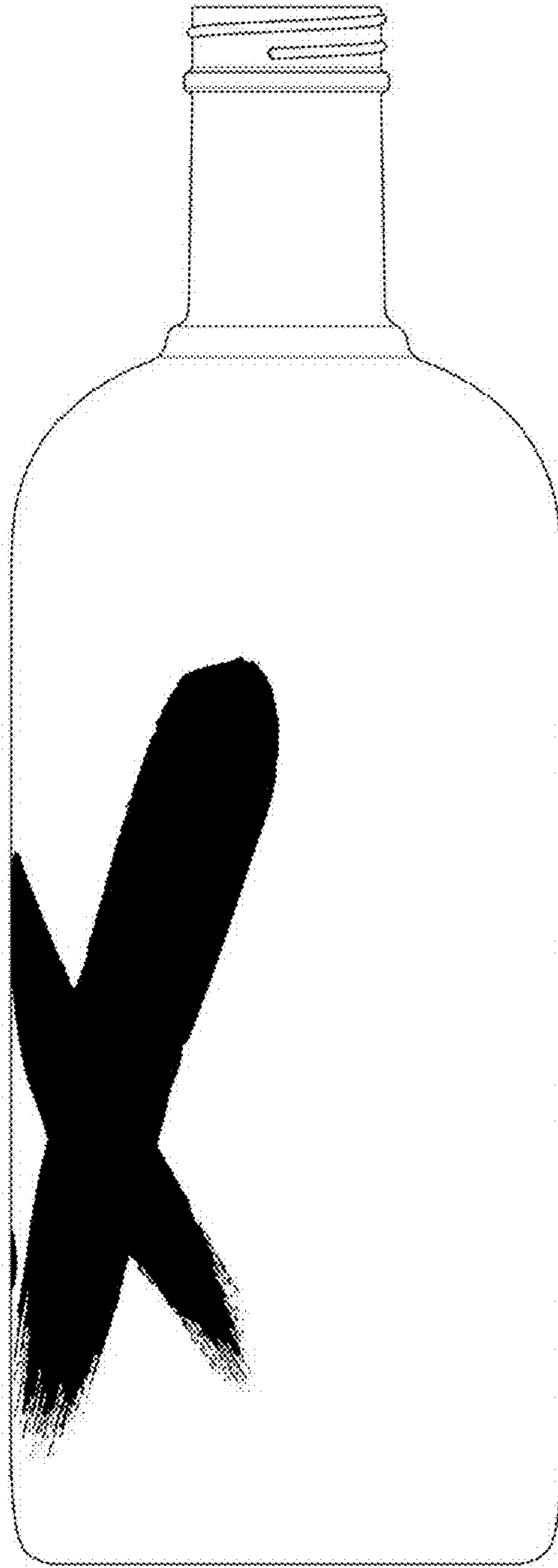

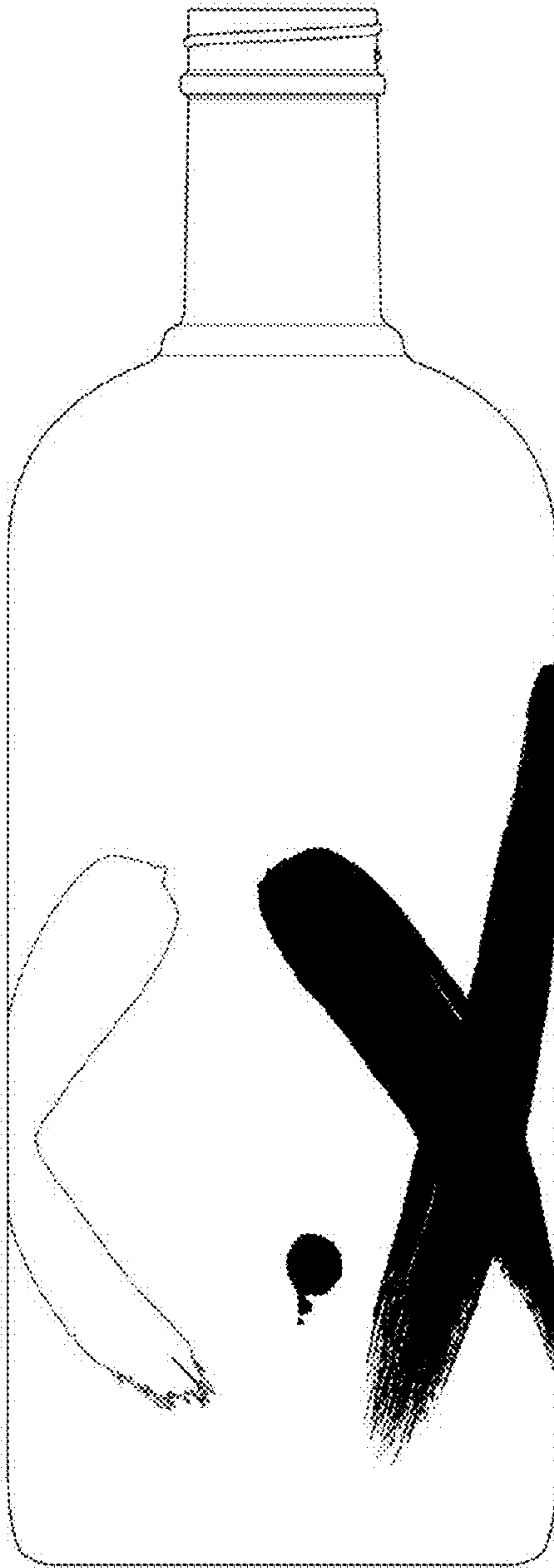

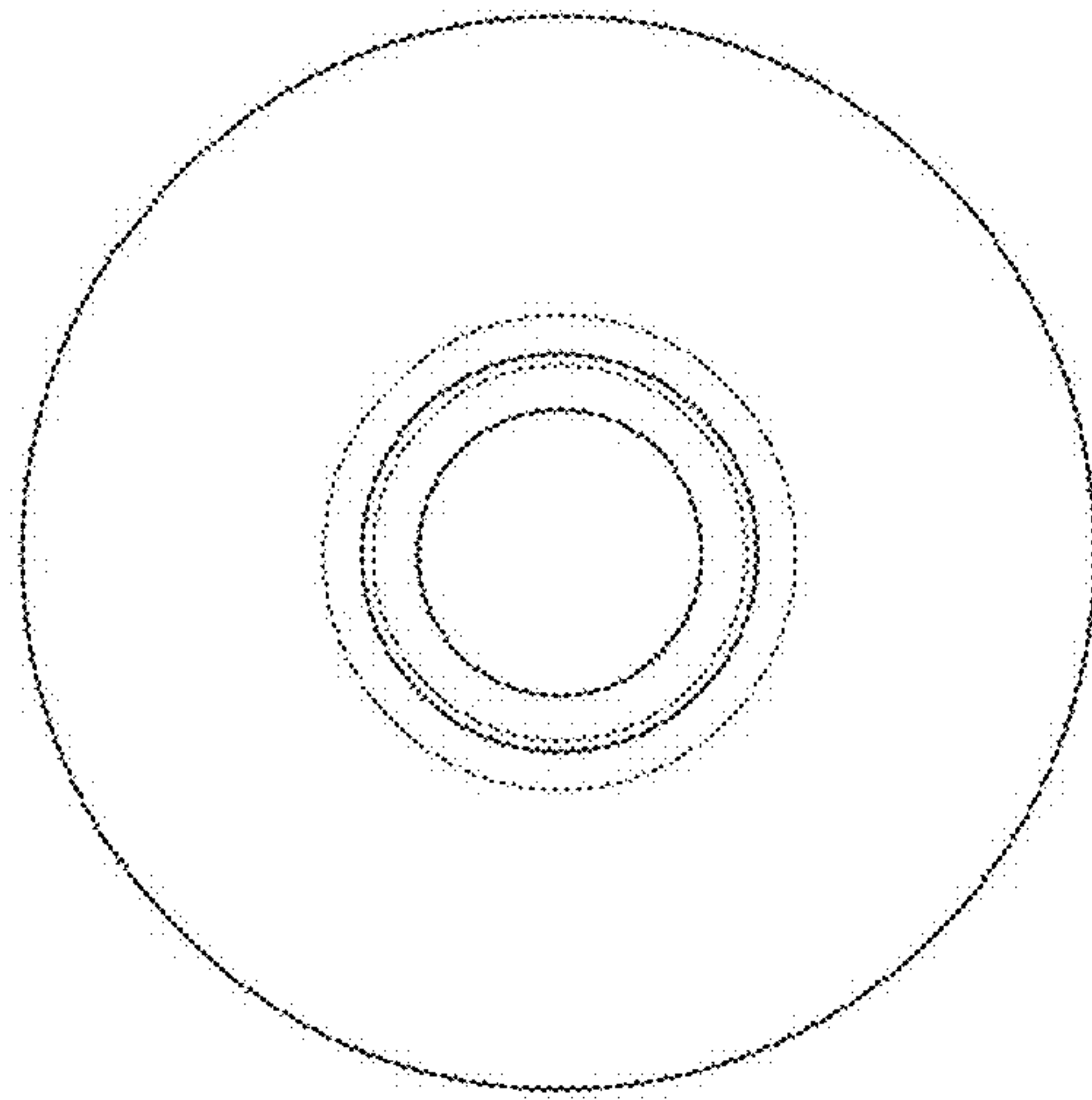

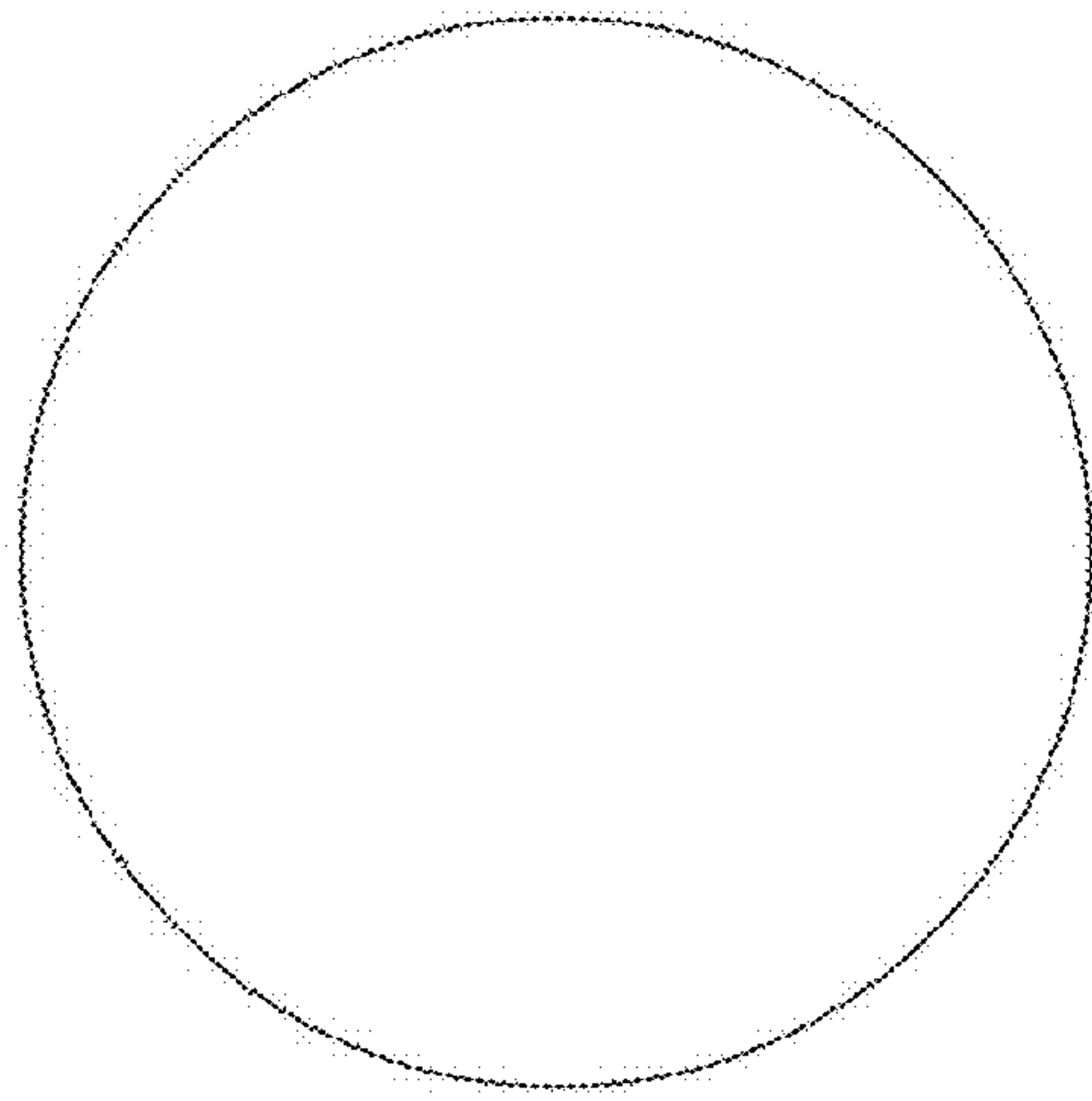

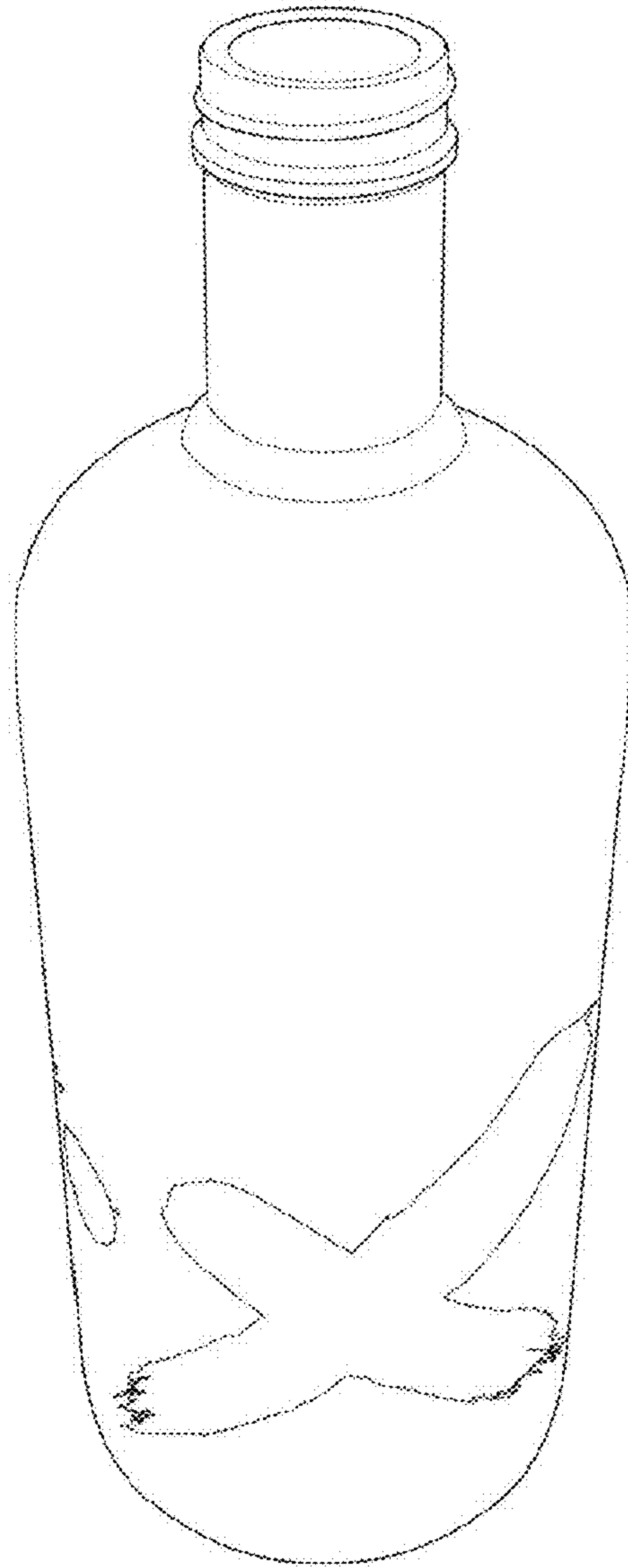

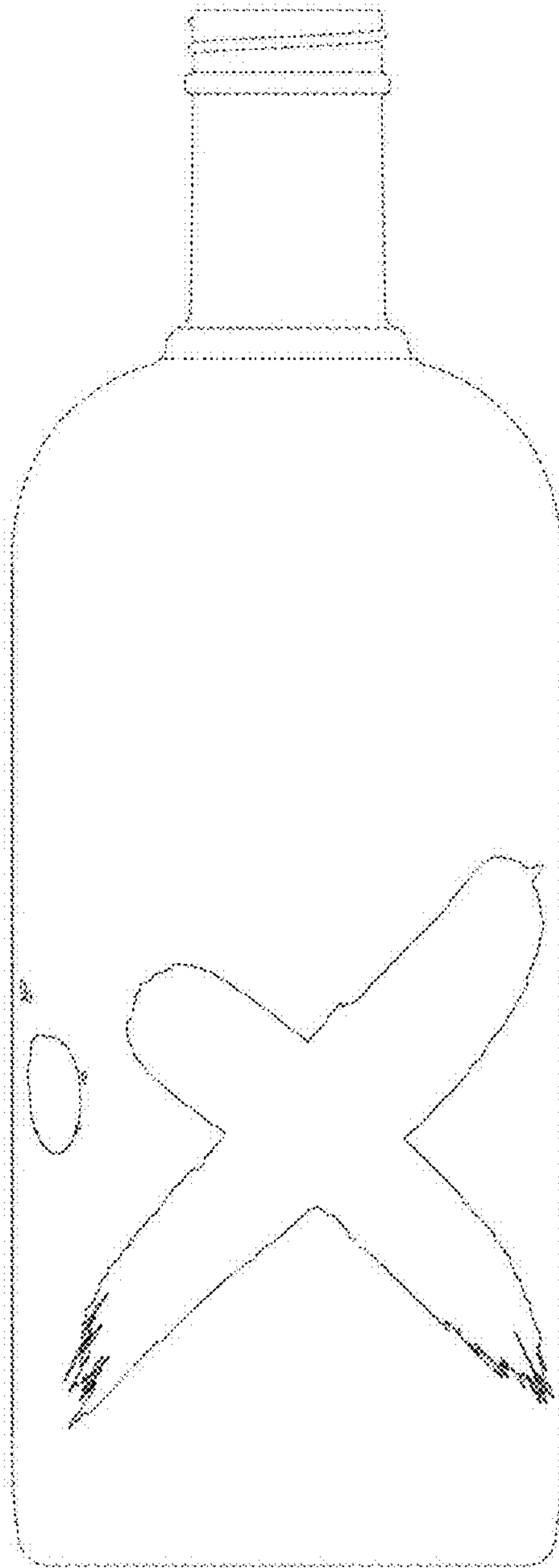

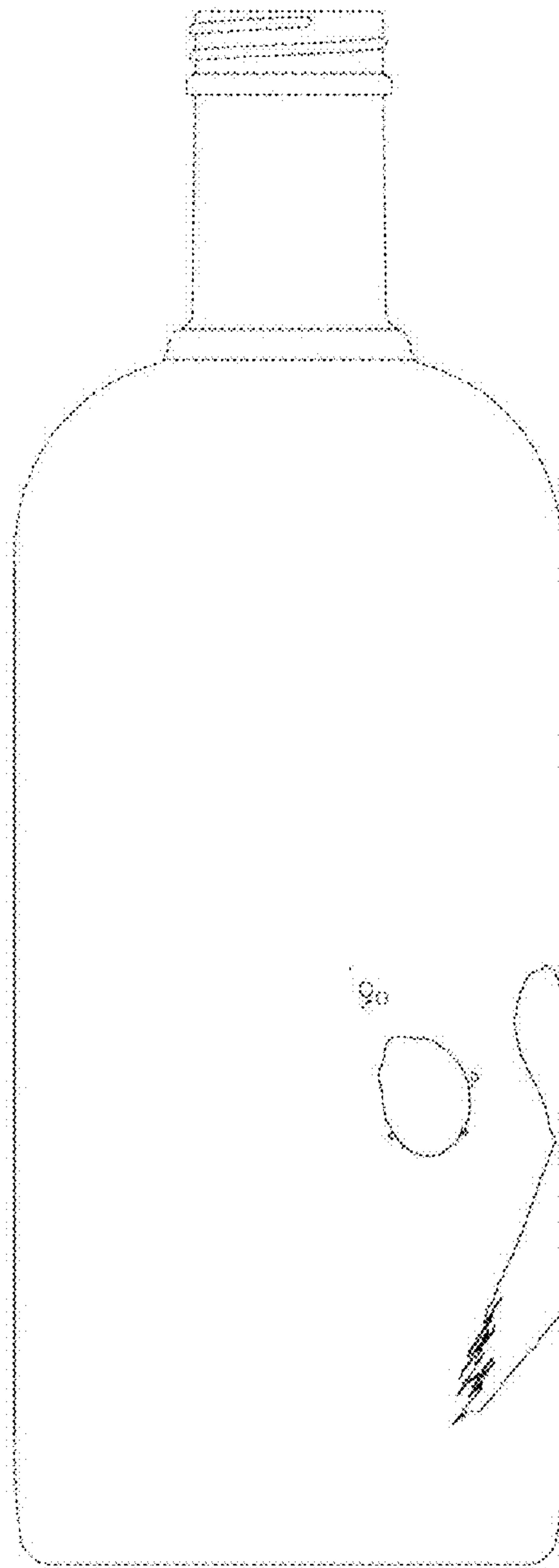

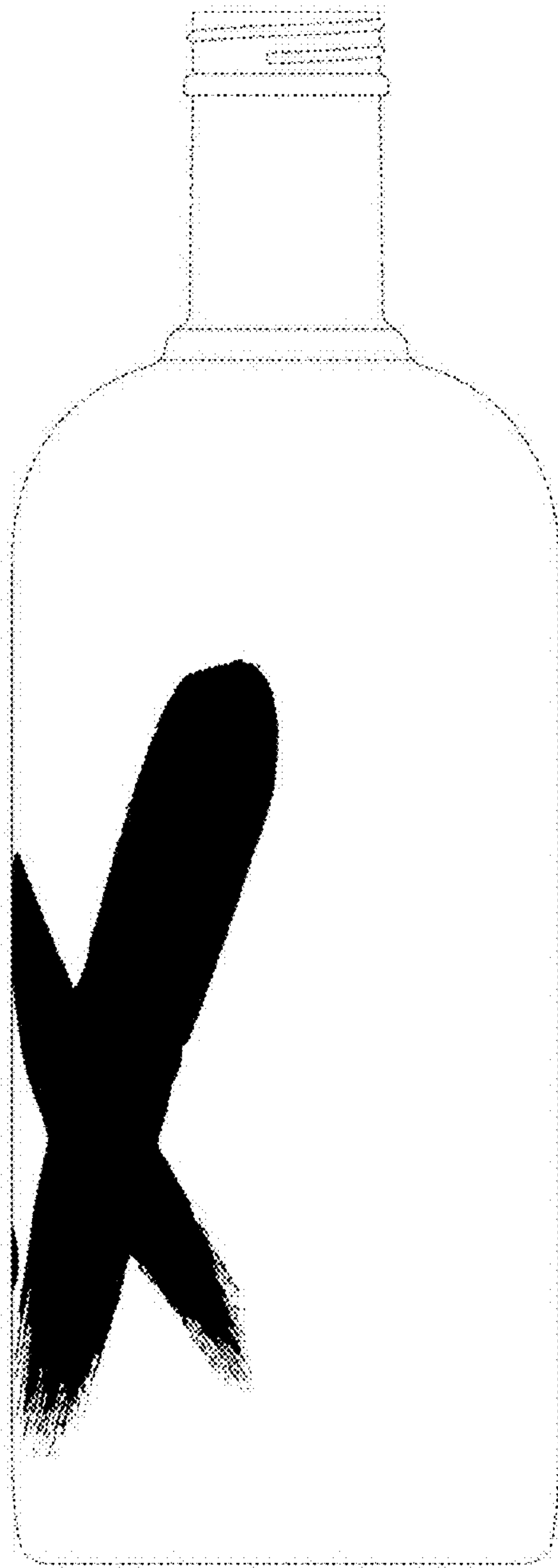

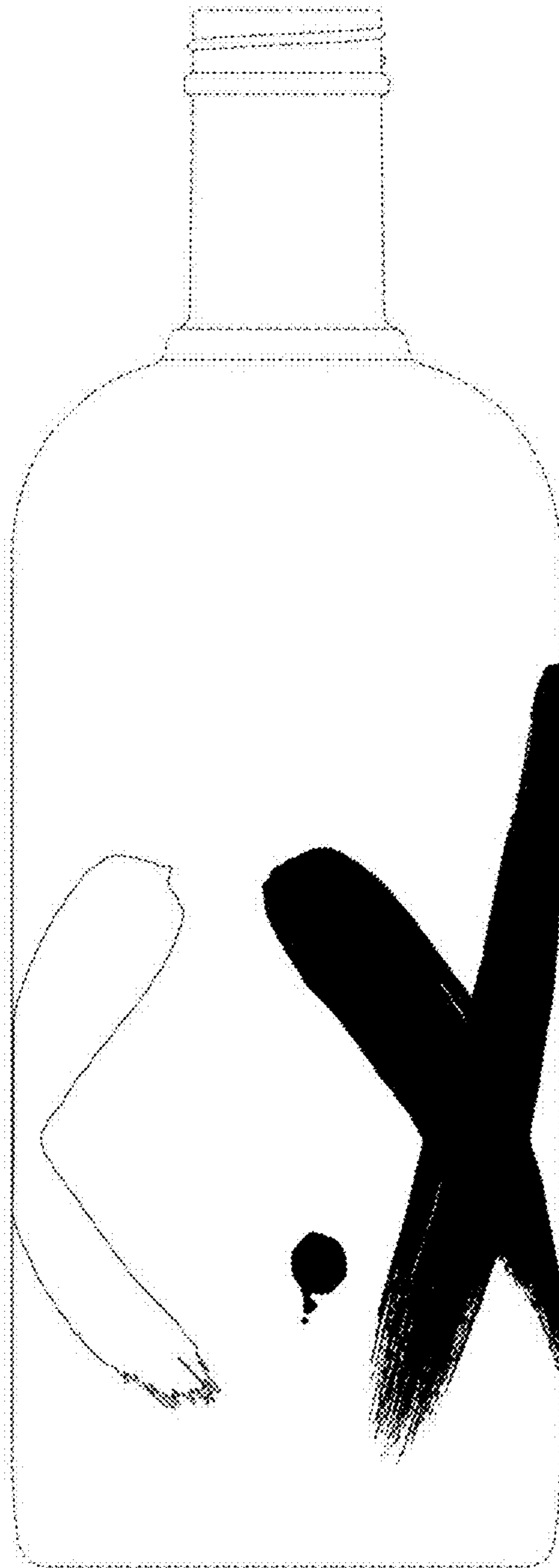

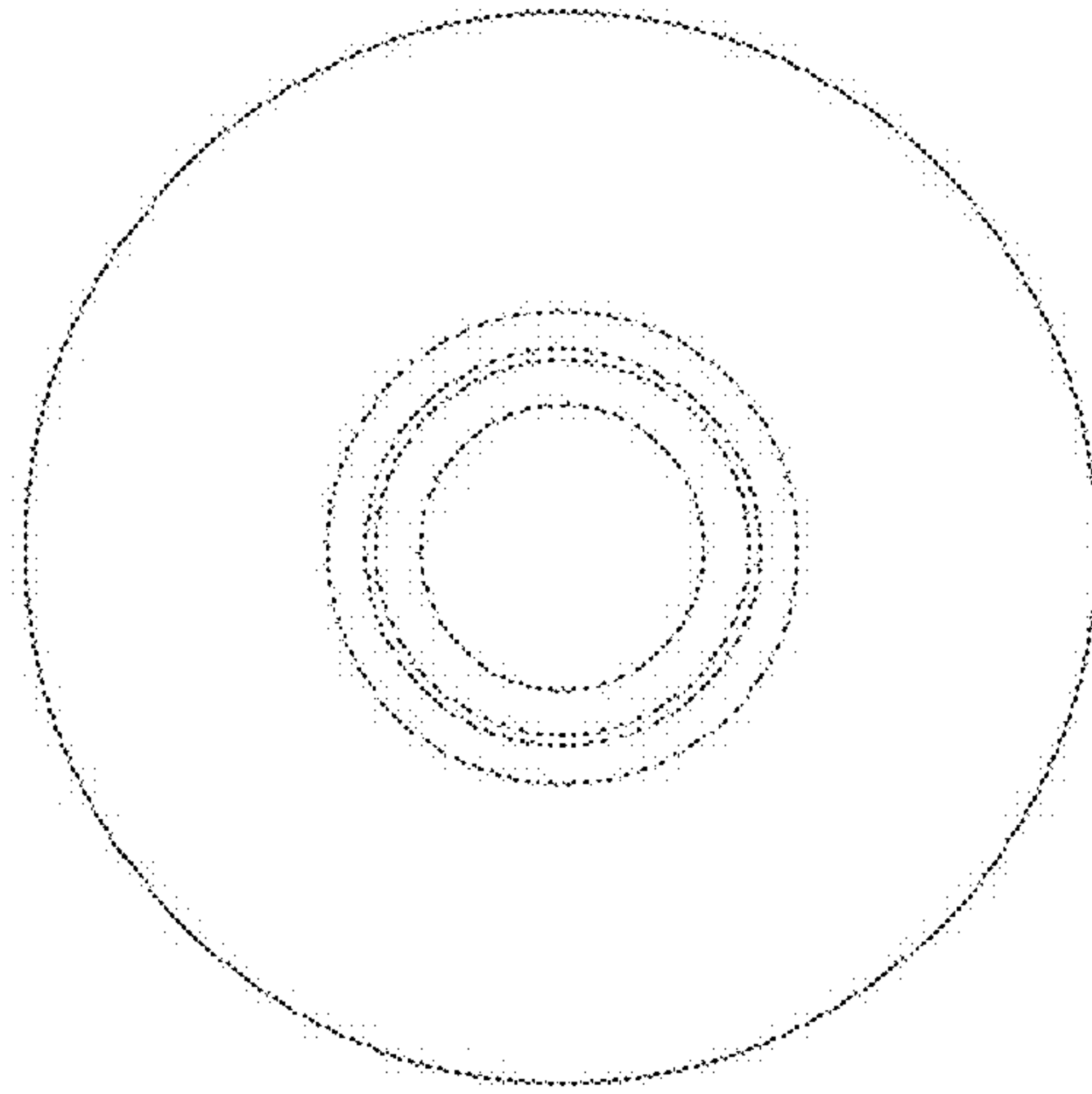

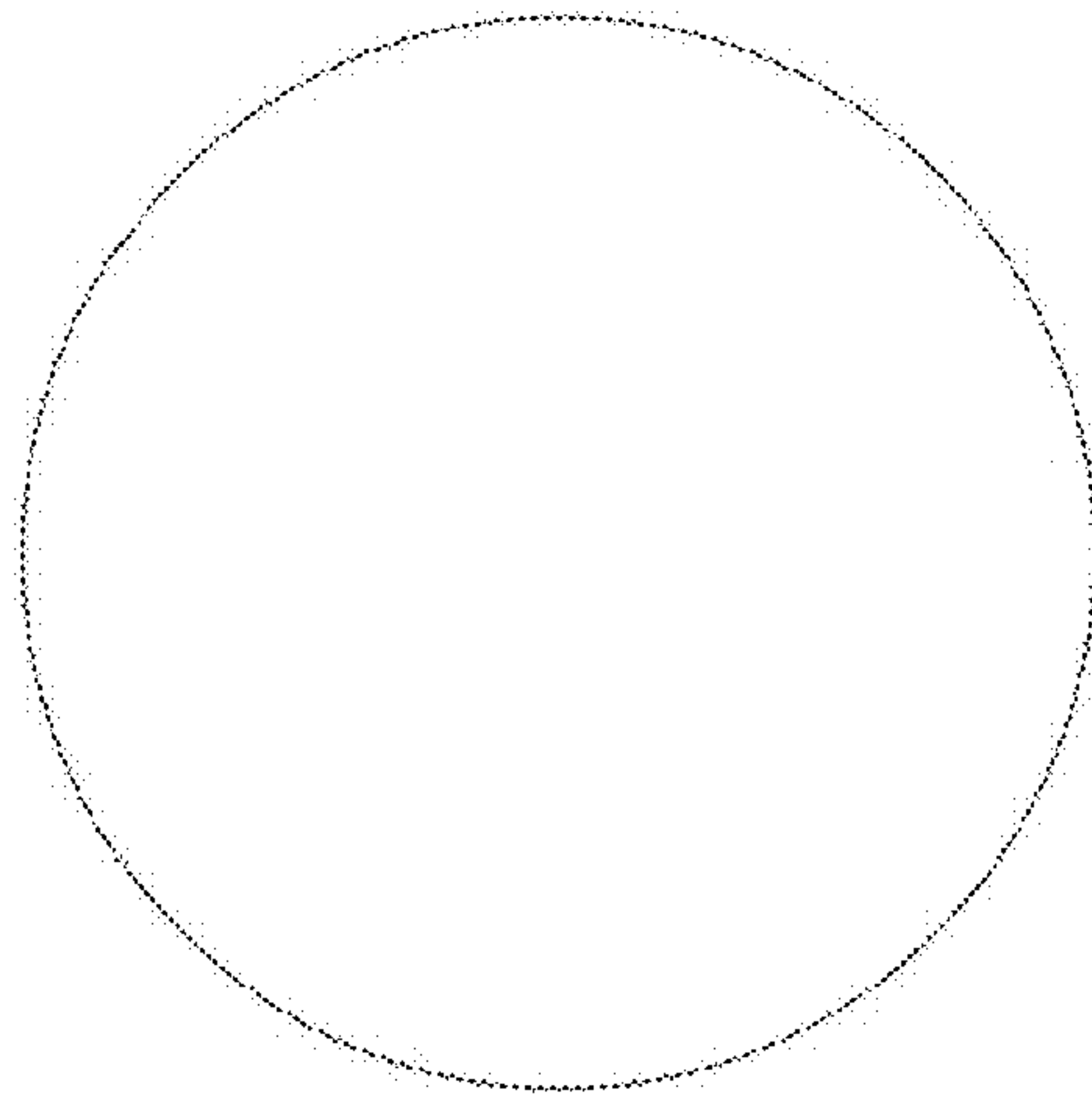

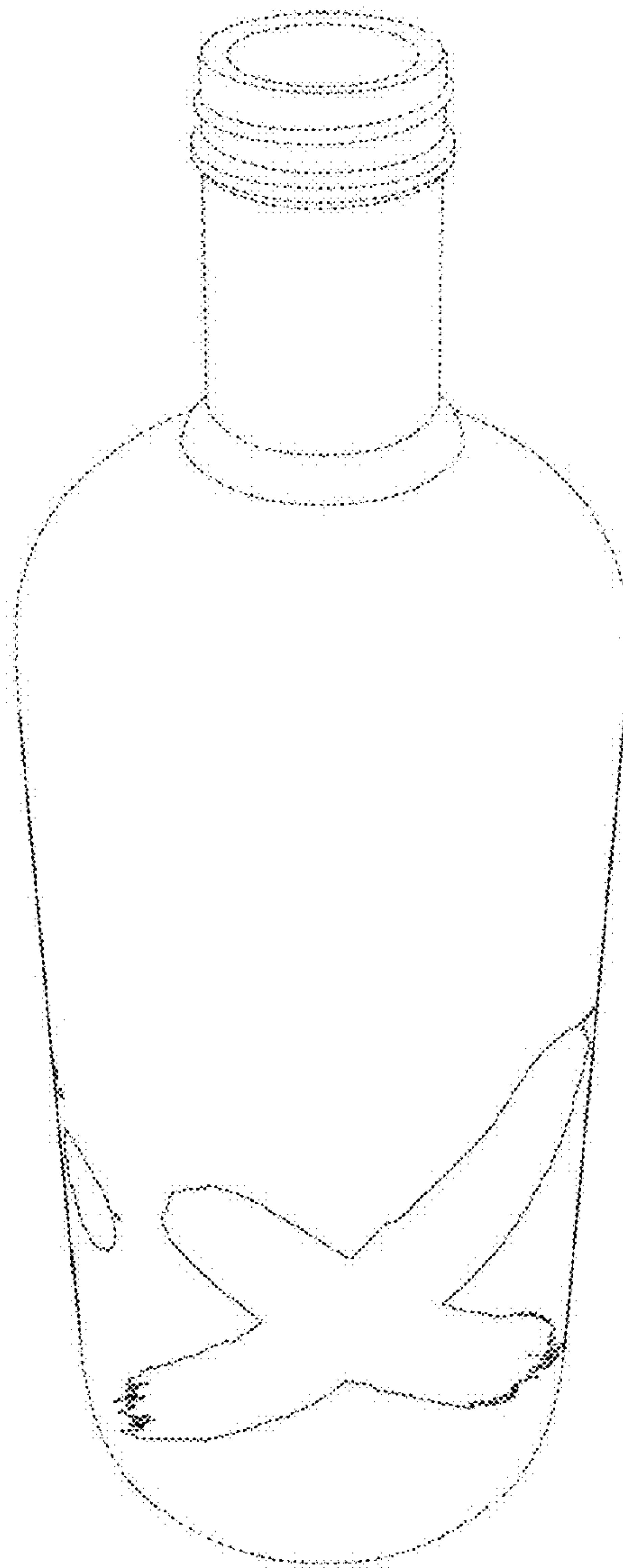
