(57) **CLAIM**

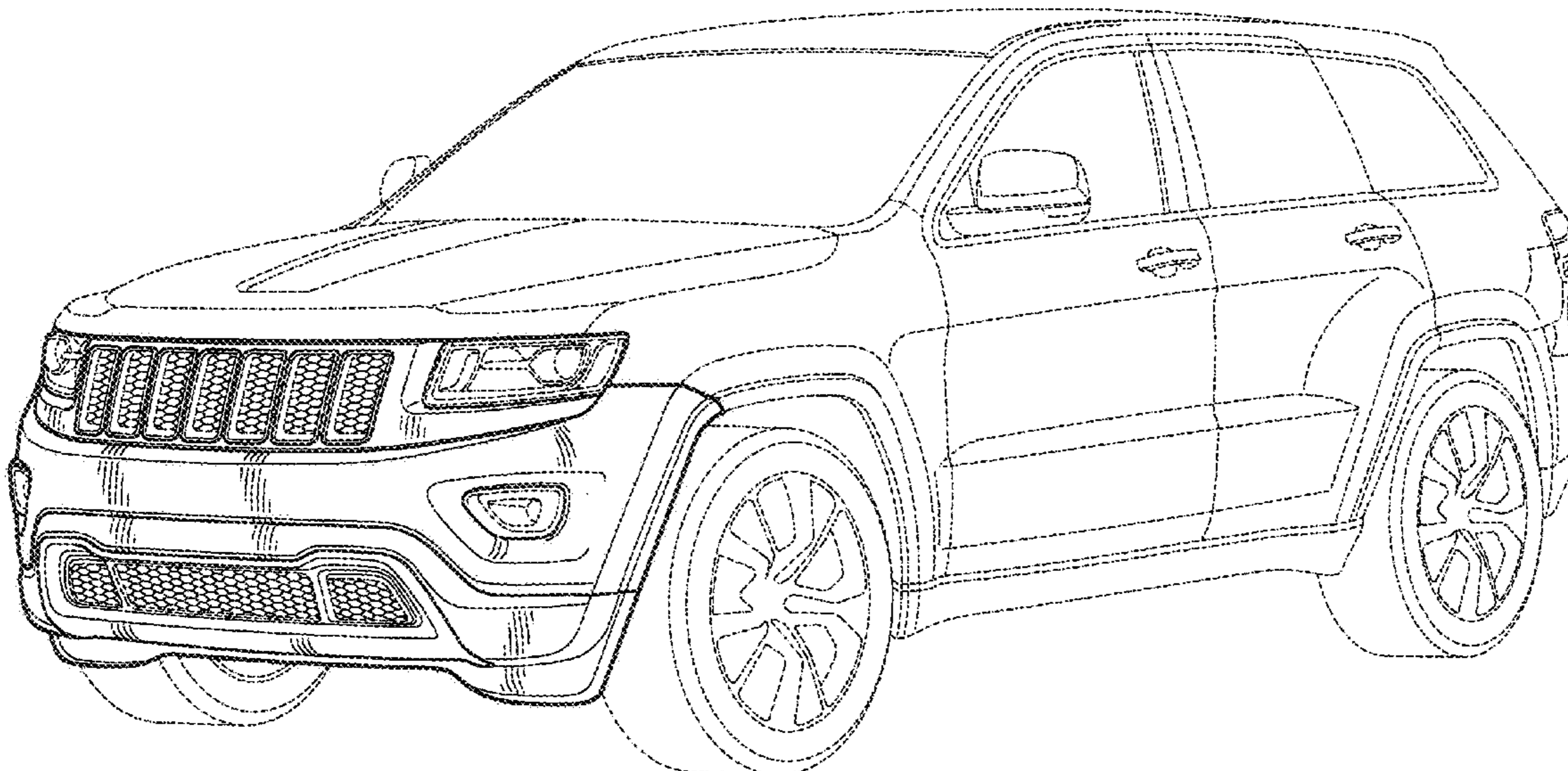
The ornamental design for an automobile exterior, as shown and described.

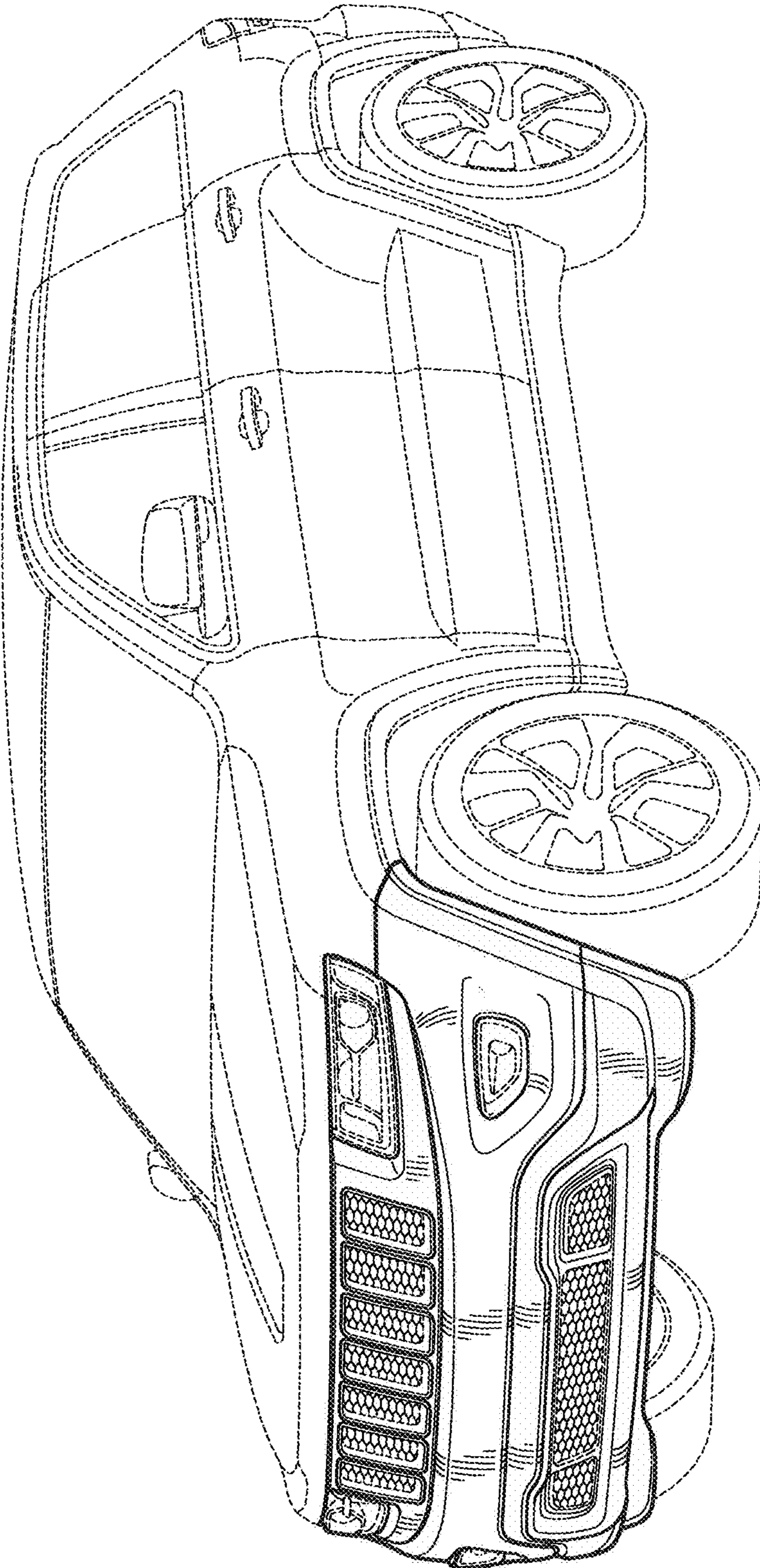

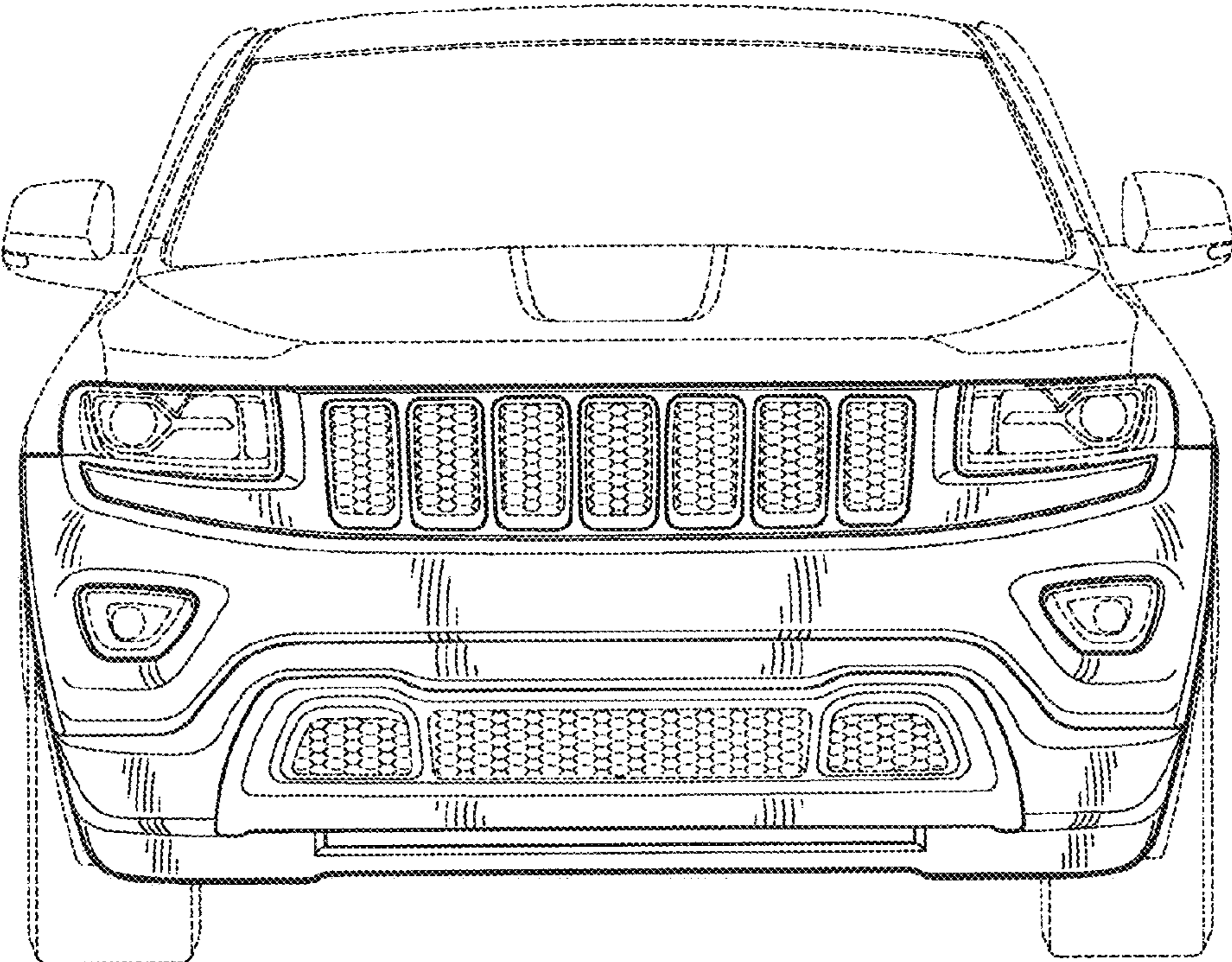
