We claim the ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mobile phone showing the new design;

FIG. 2 is a front elevation view thereof;

FIG. 4 is a left-side elevation view thereof;

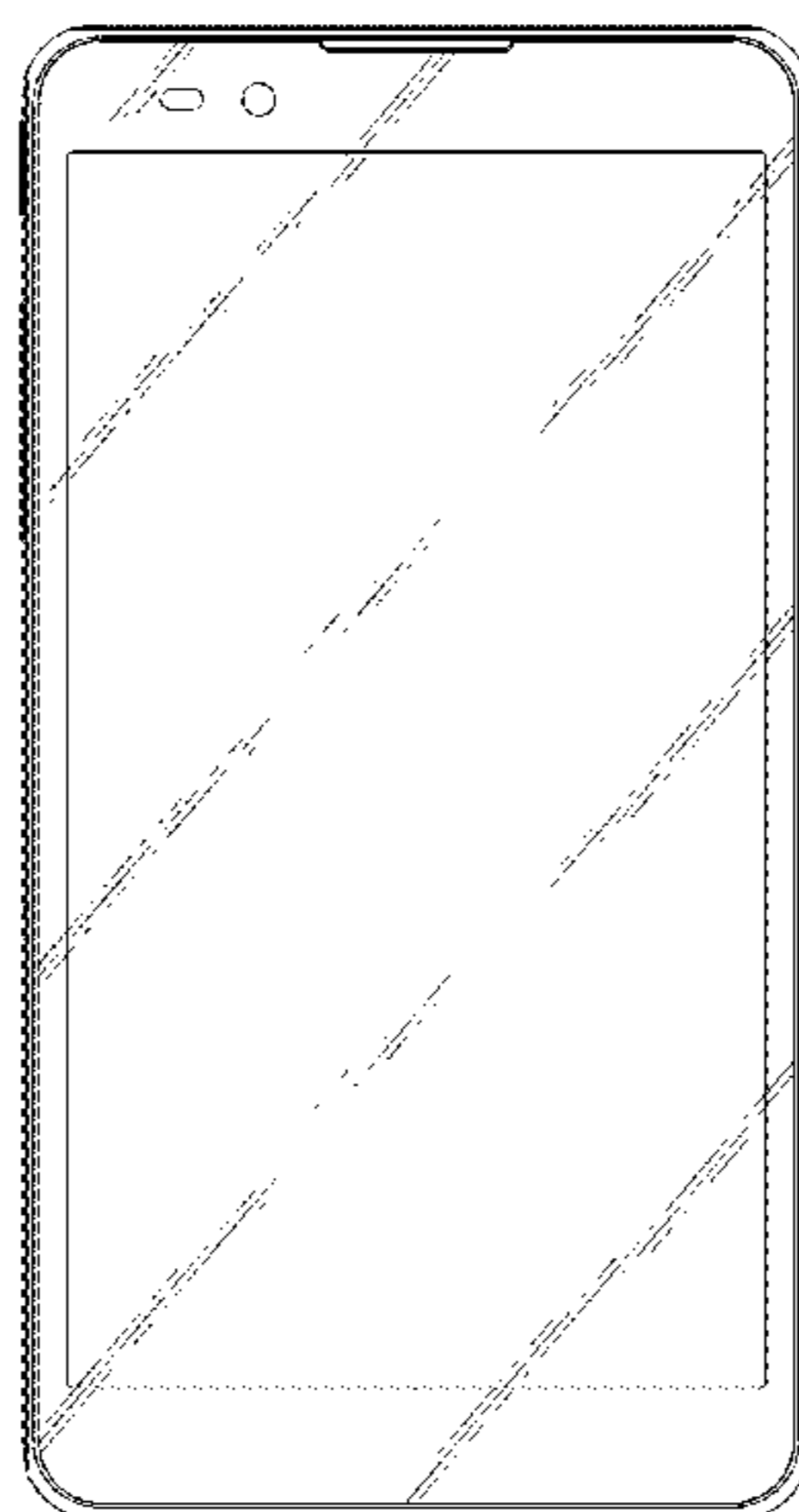
FIG. 5 is a right-side elevation view thereof;

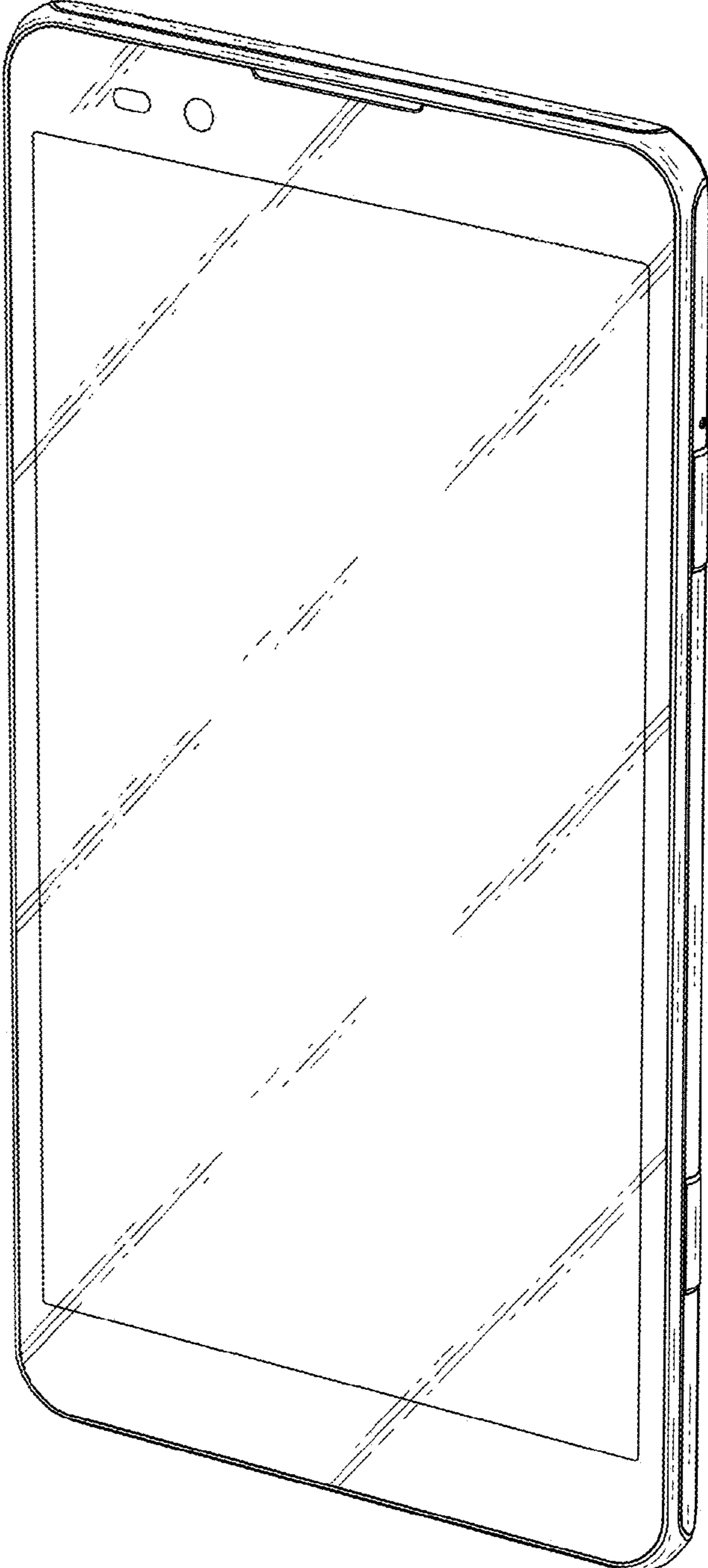

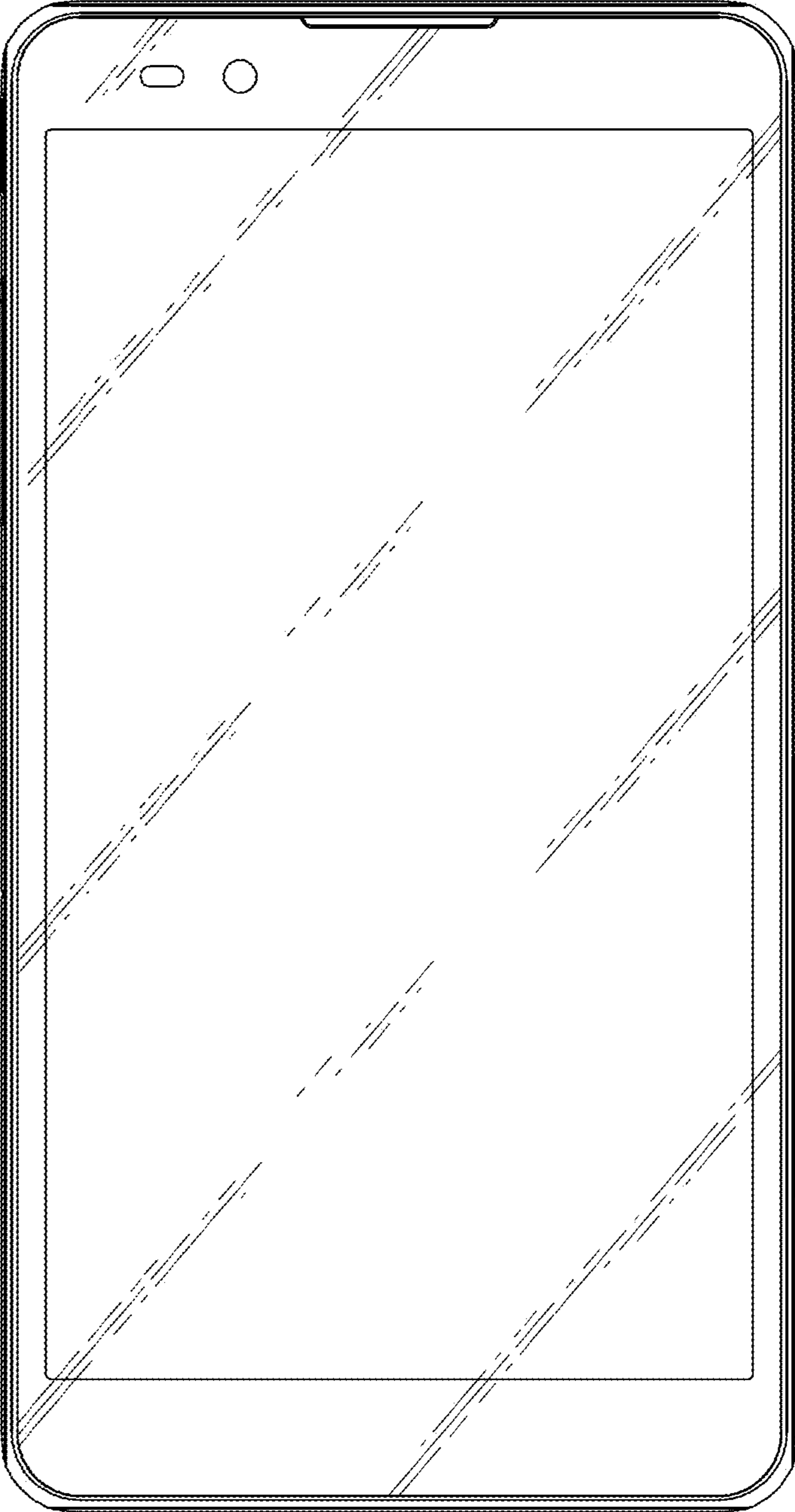

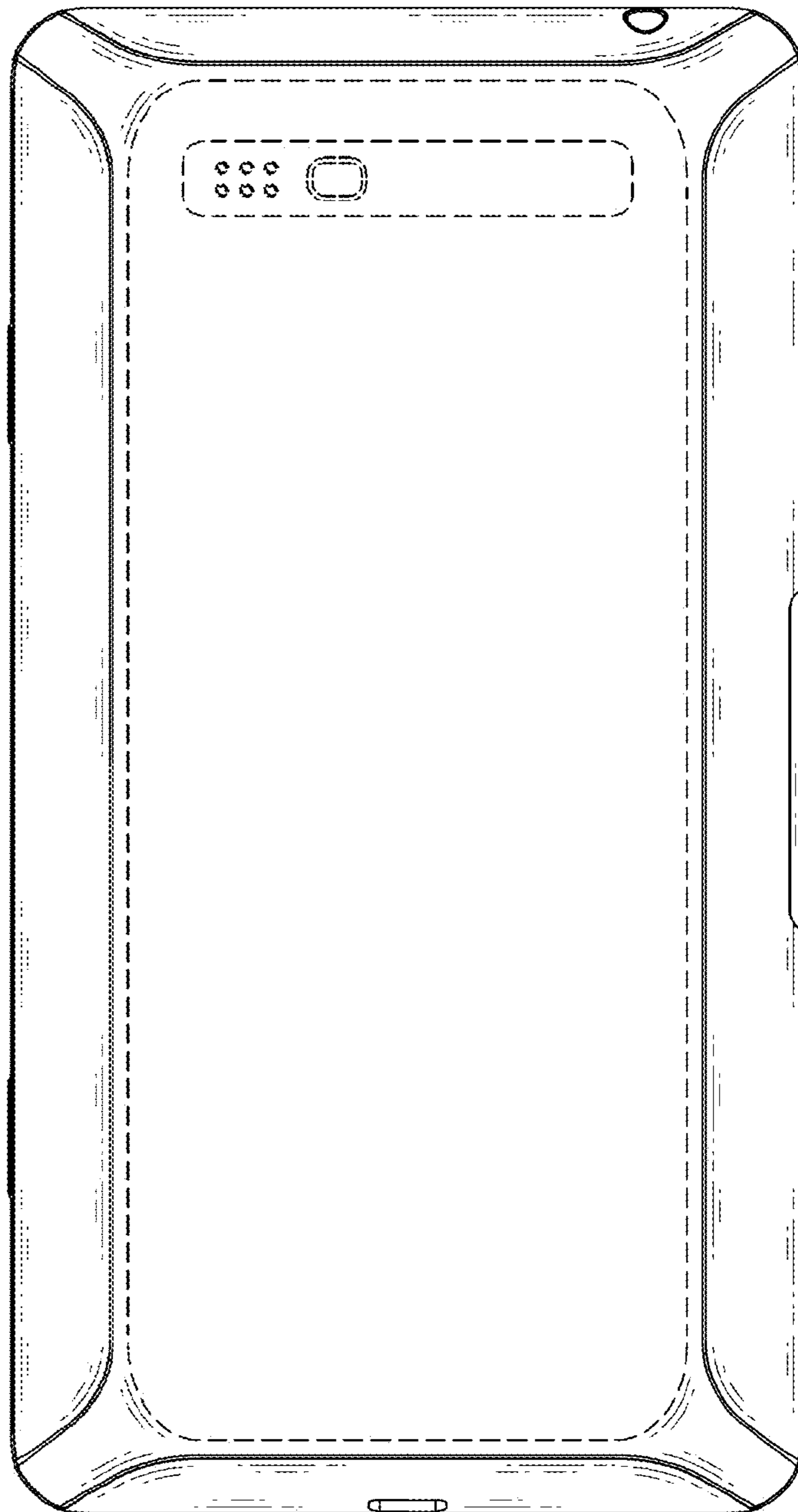

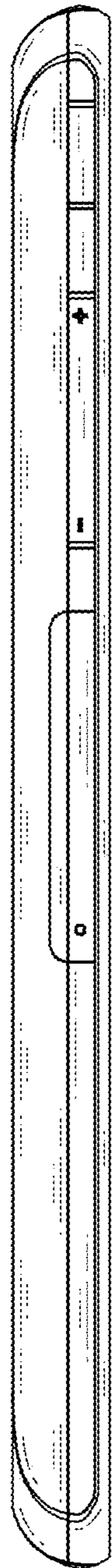
