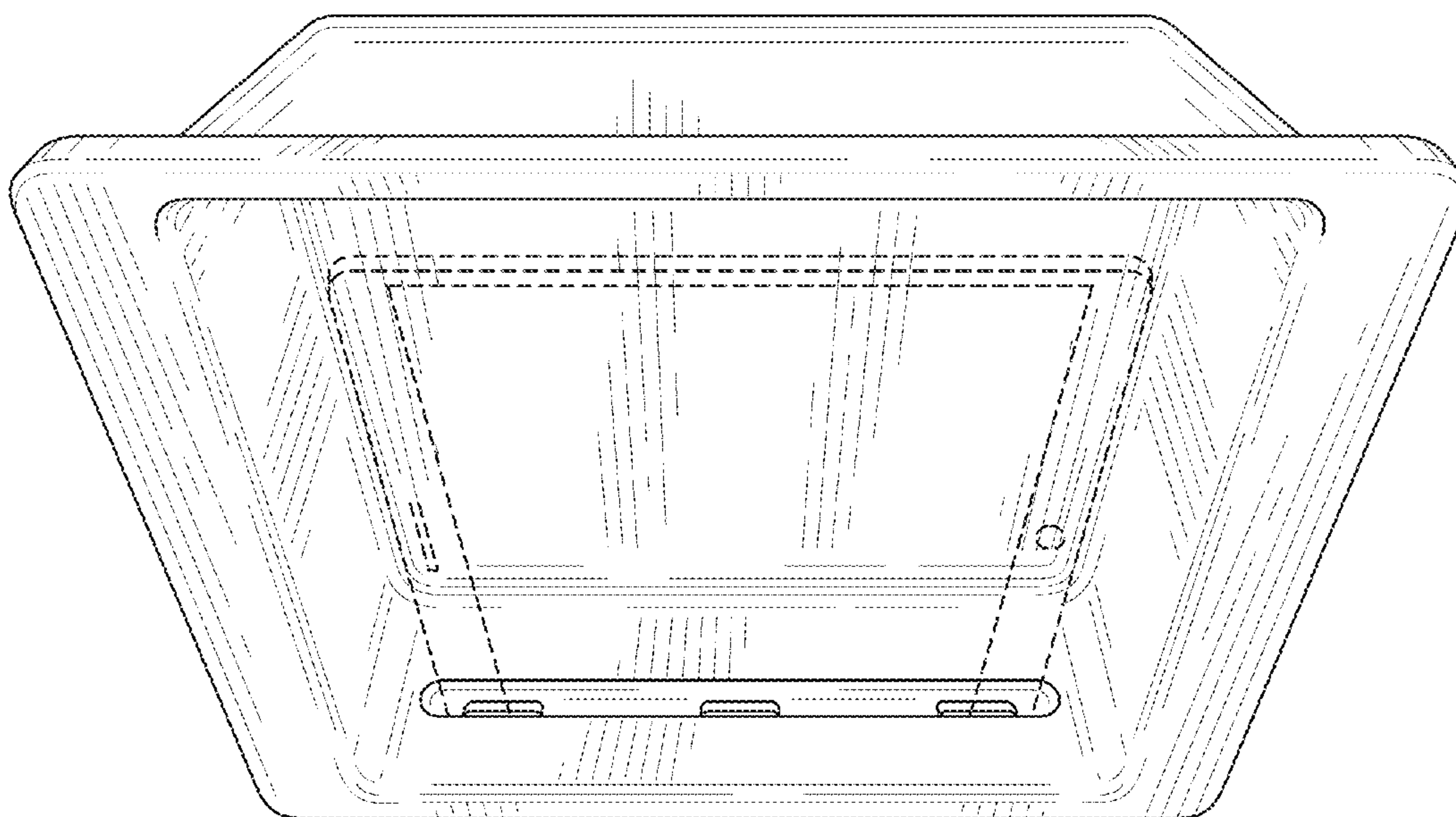
The ornamental design for the personal electronic holder, as shown and described.

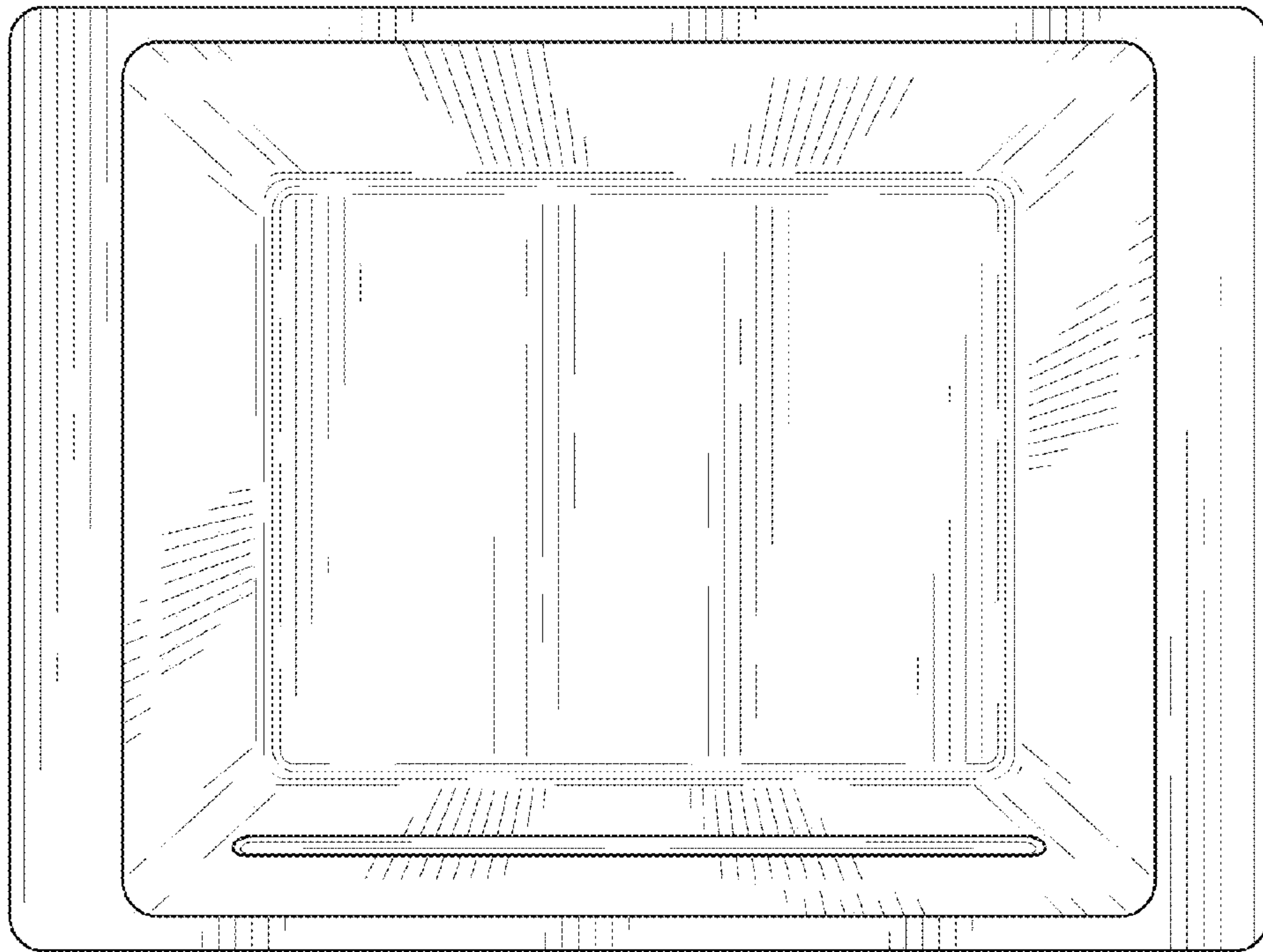

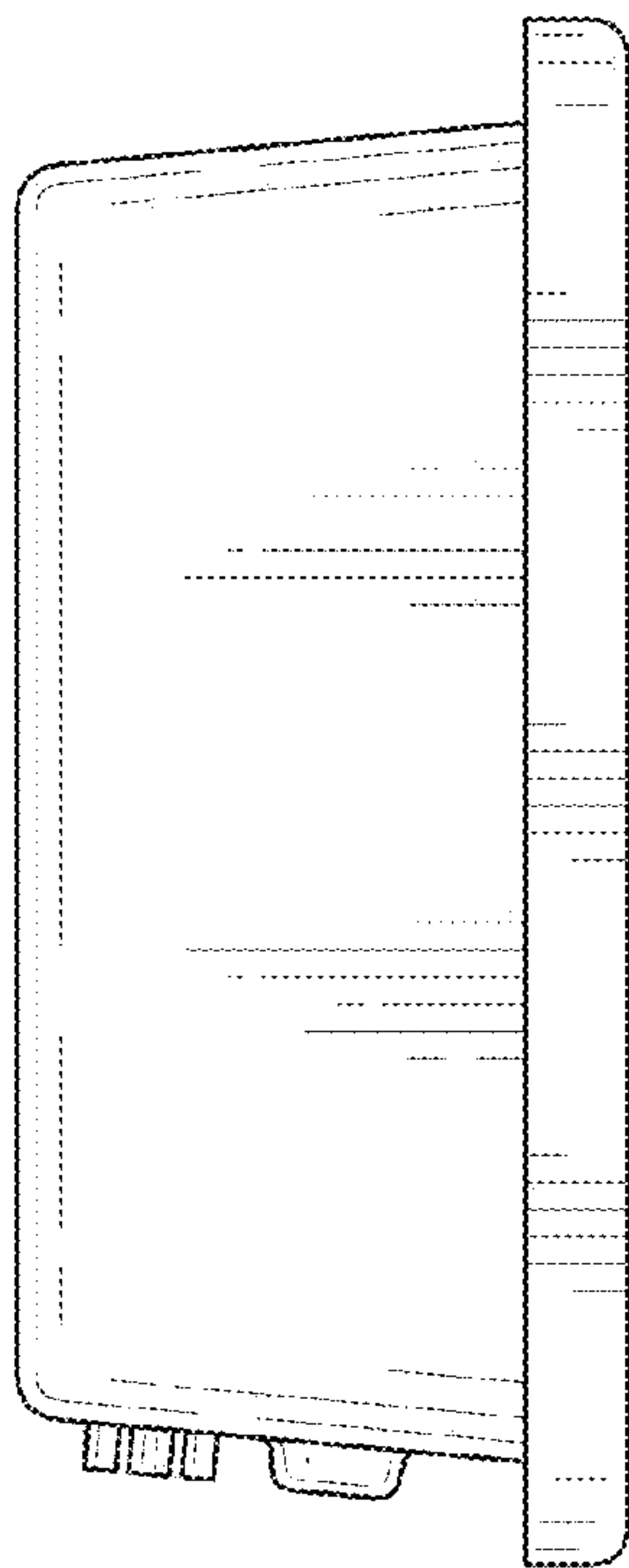

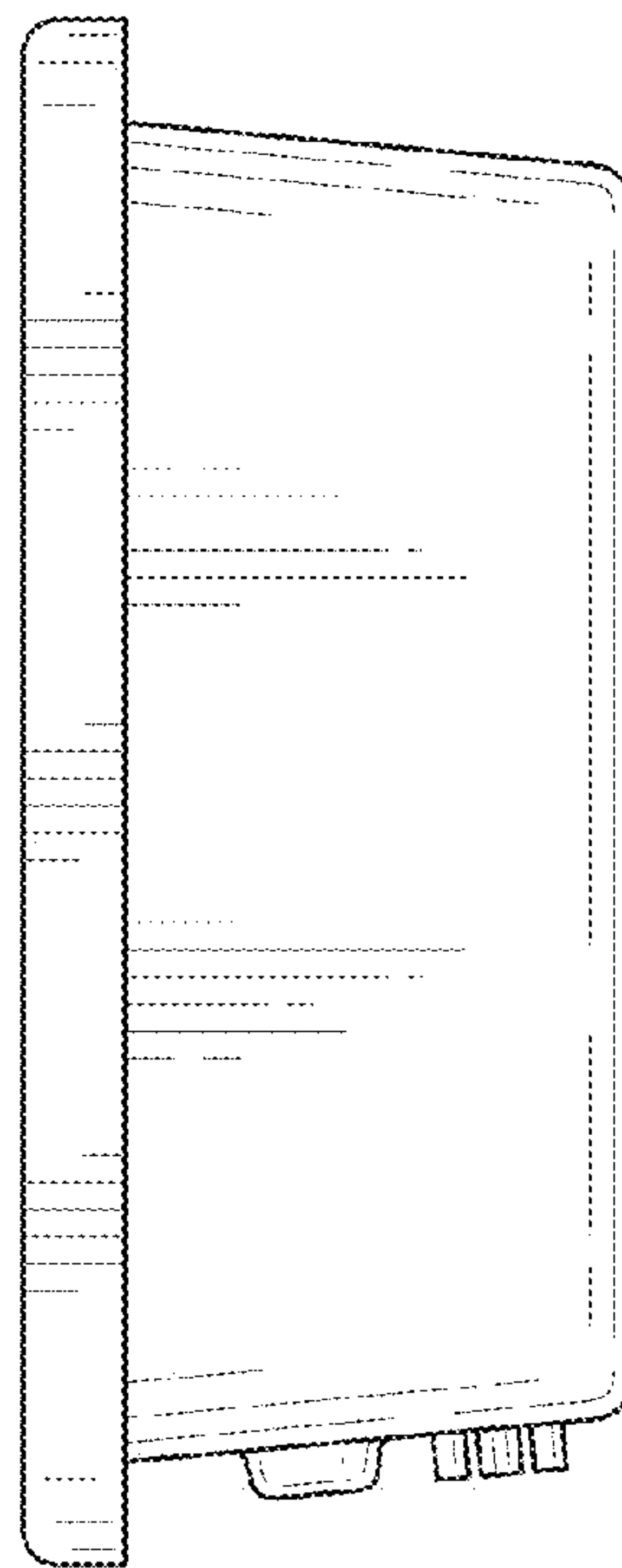

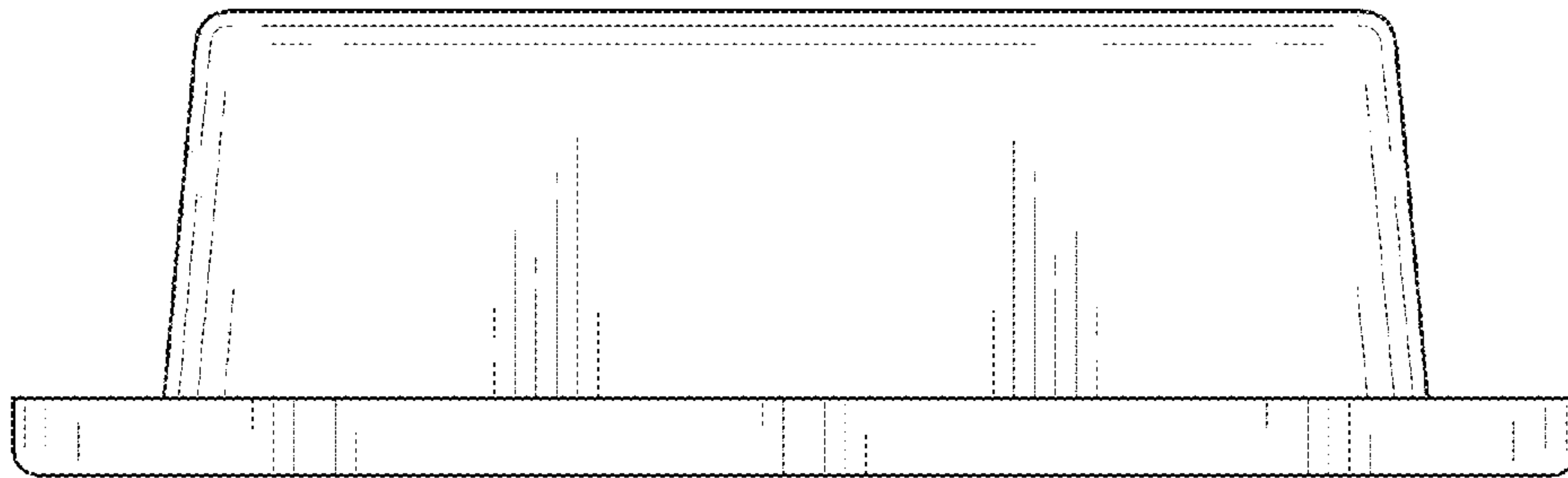

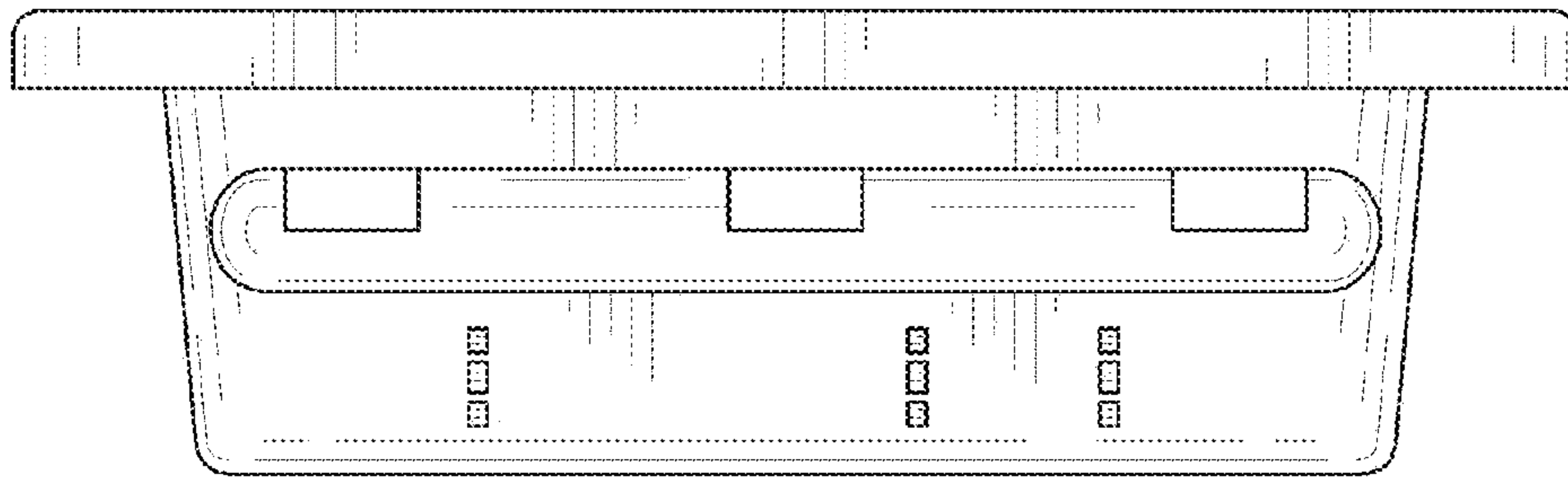

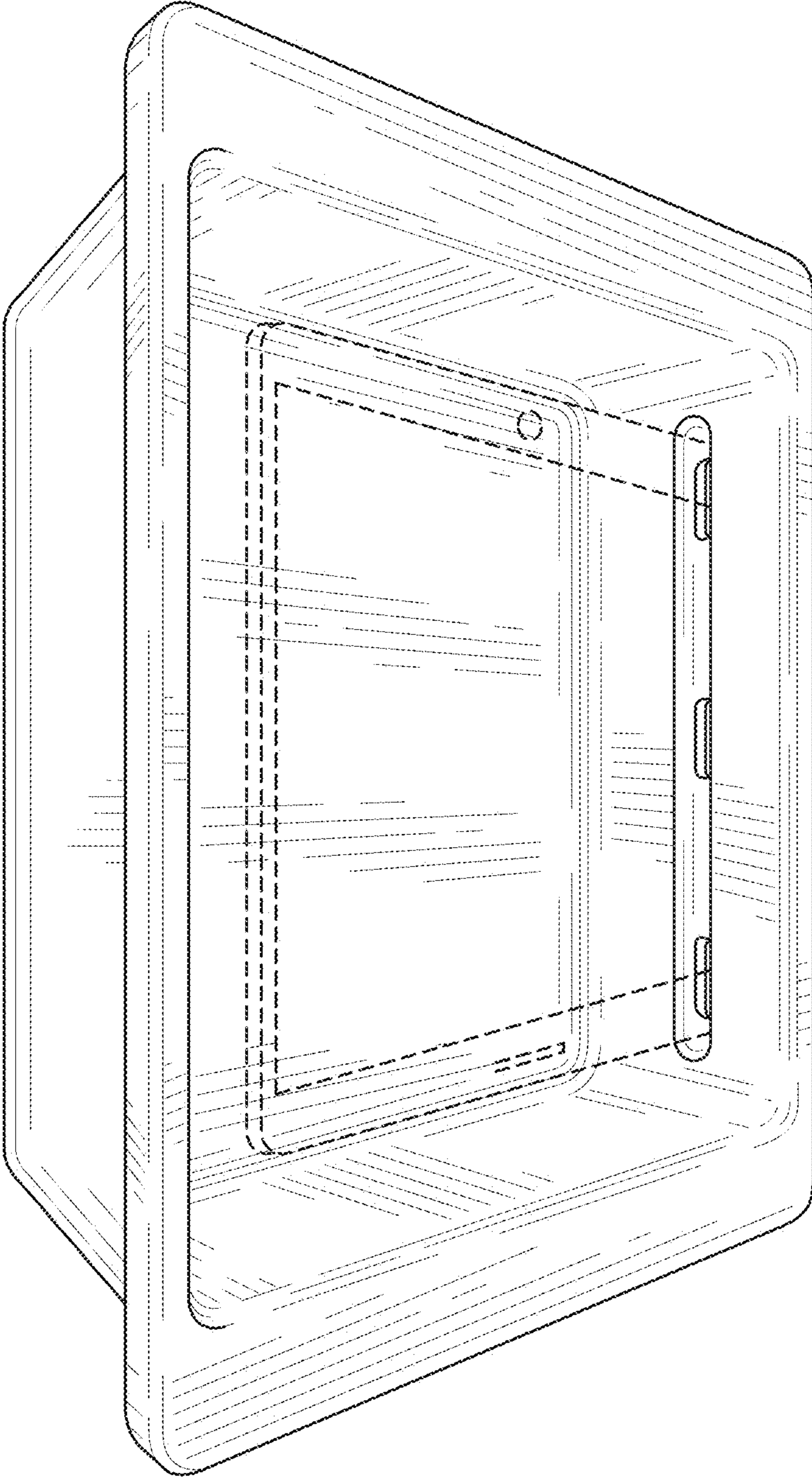
