FIG. 1 is a front perspective view of a ruffle tie shown being worn around the neck of a human.

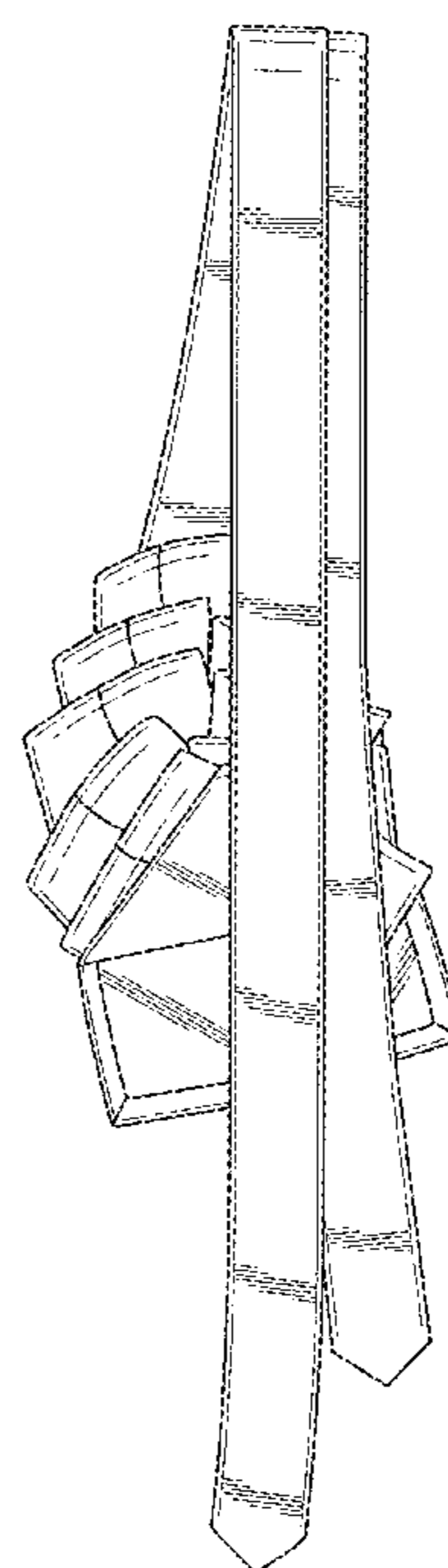
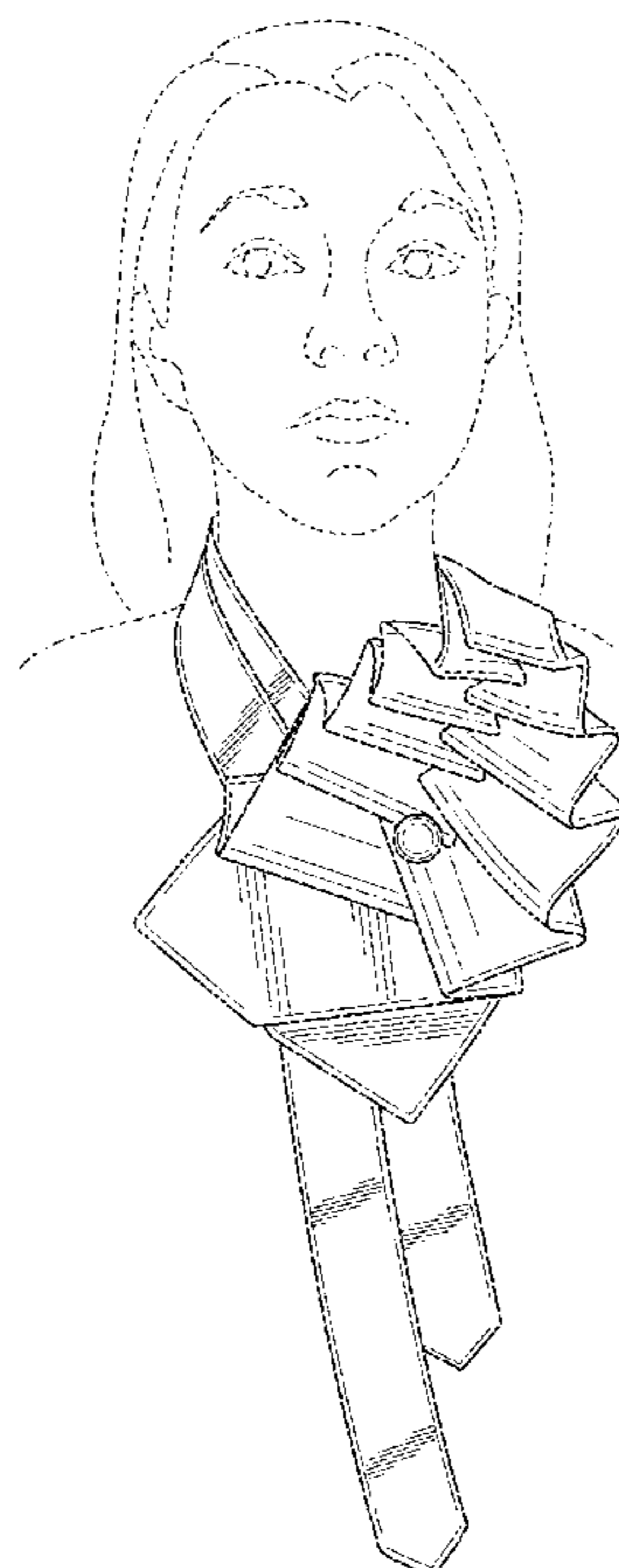
FIG. 2 is a front elevation view of the ruffle tie of FIG. 1.

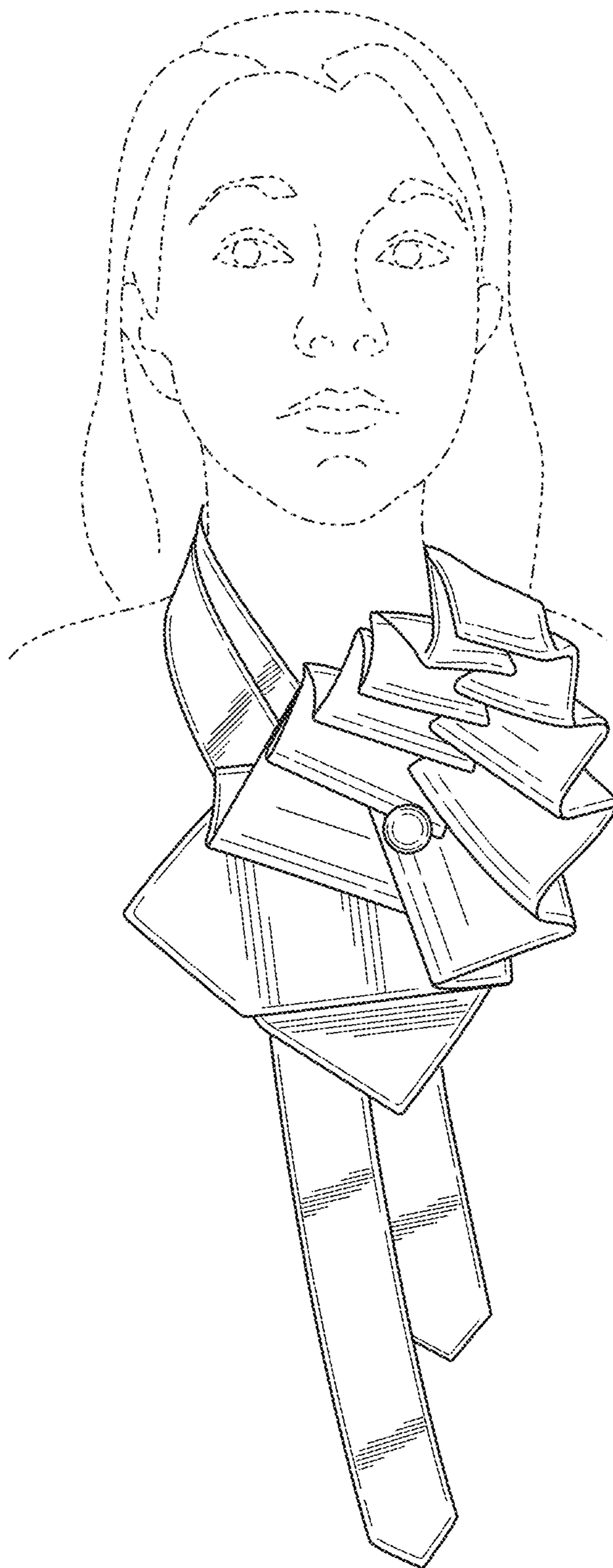

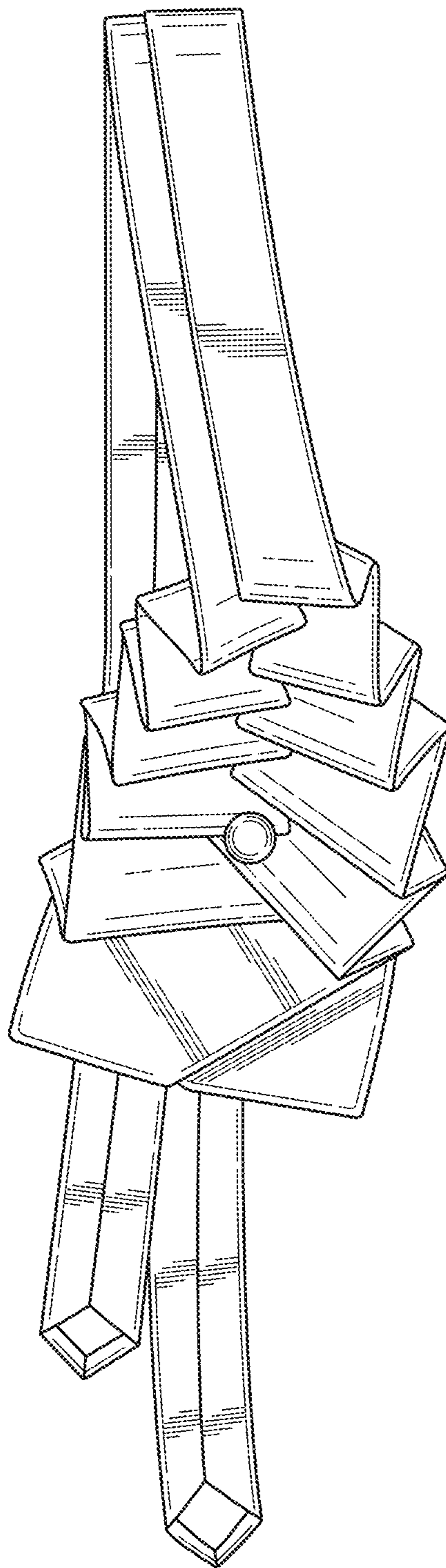

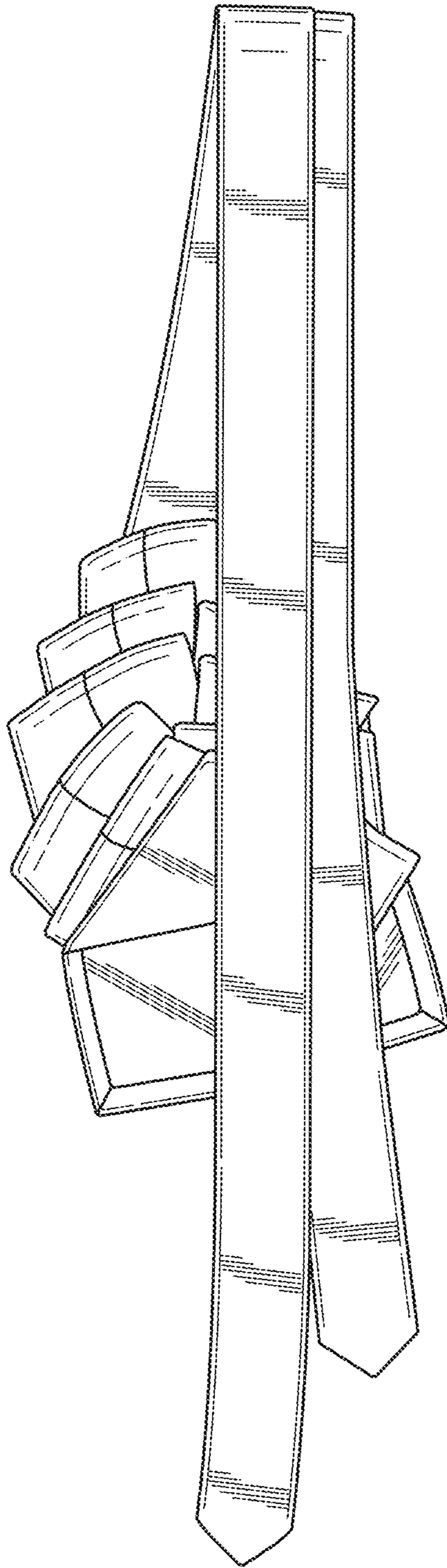
