**DESCRIPTION**

FIG. 3 is a bottom view of a torso bib with collar of the present invention, showing the new, original, and ornamental design;

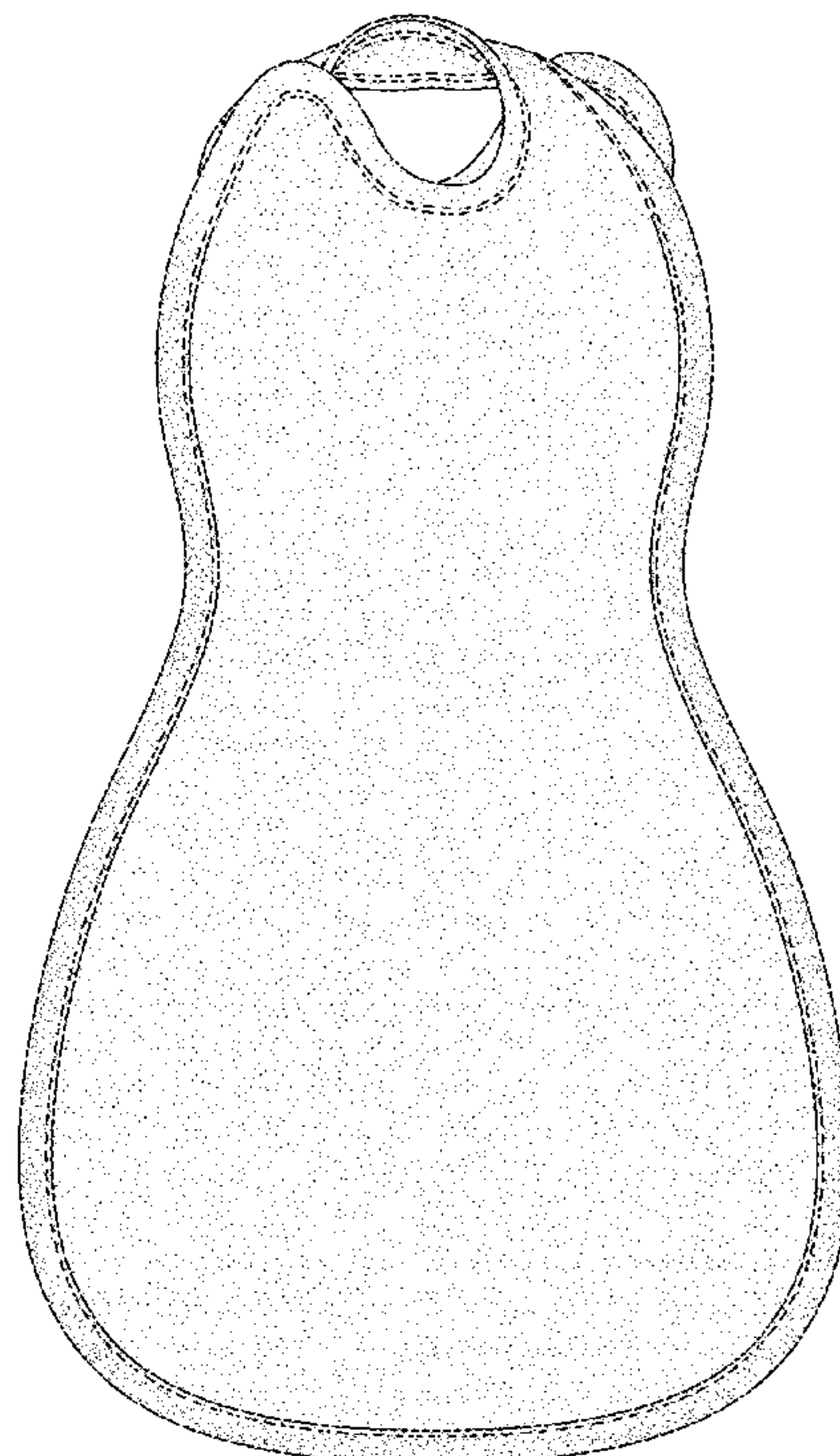
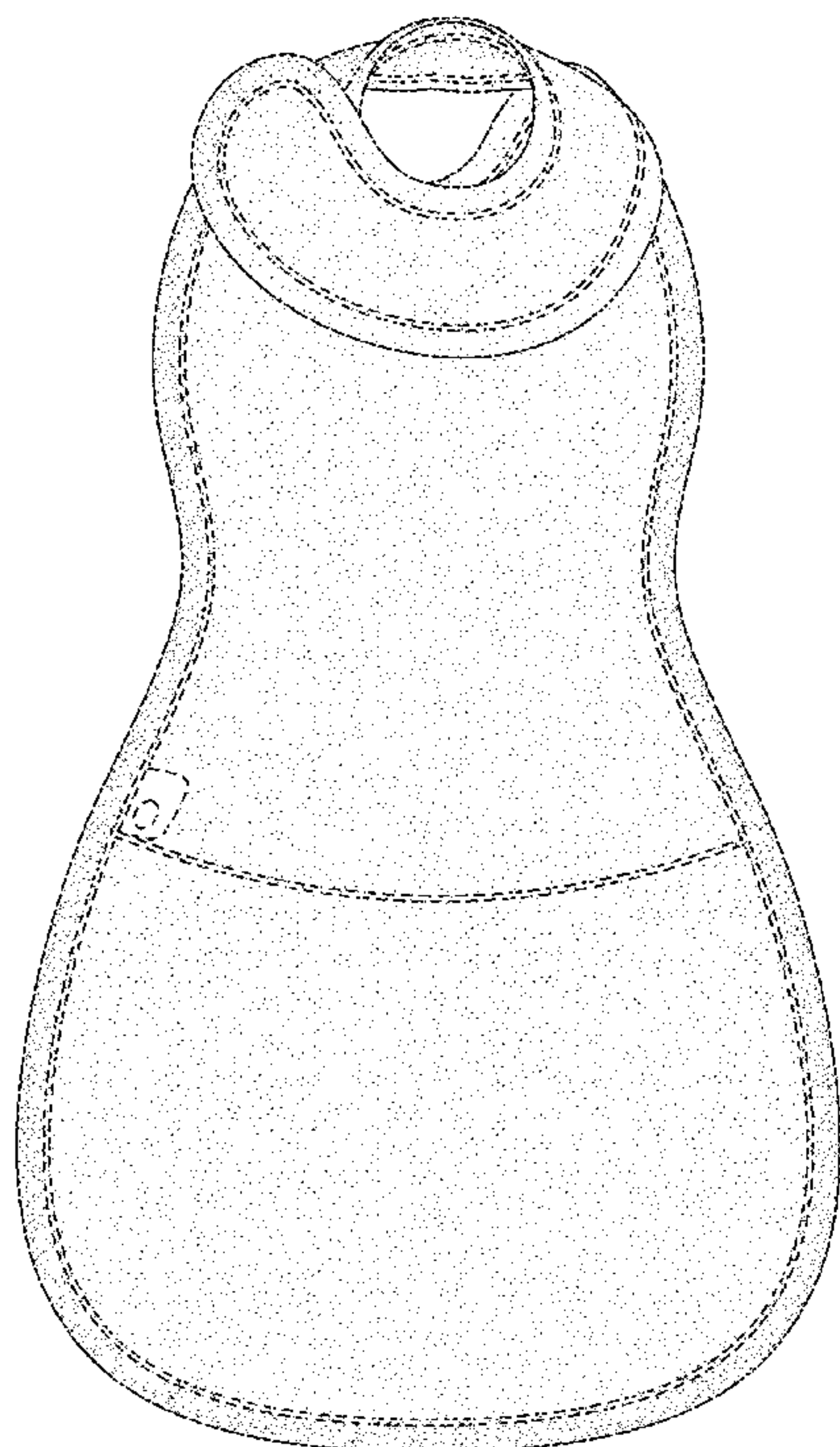
FIG. 4 is a left side elevation view of a torso bib with collar of the present invention, showing the new, original, and ornamental design;

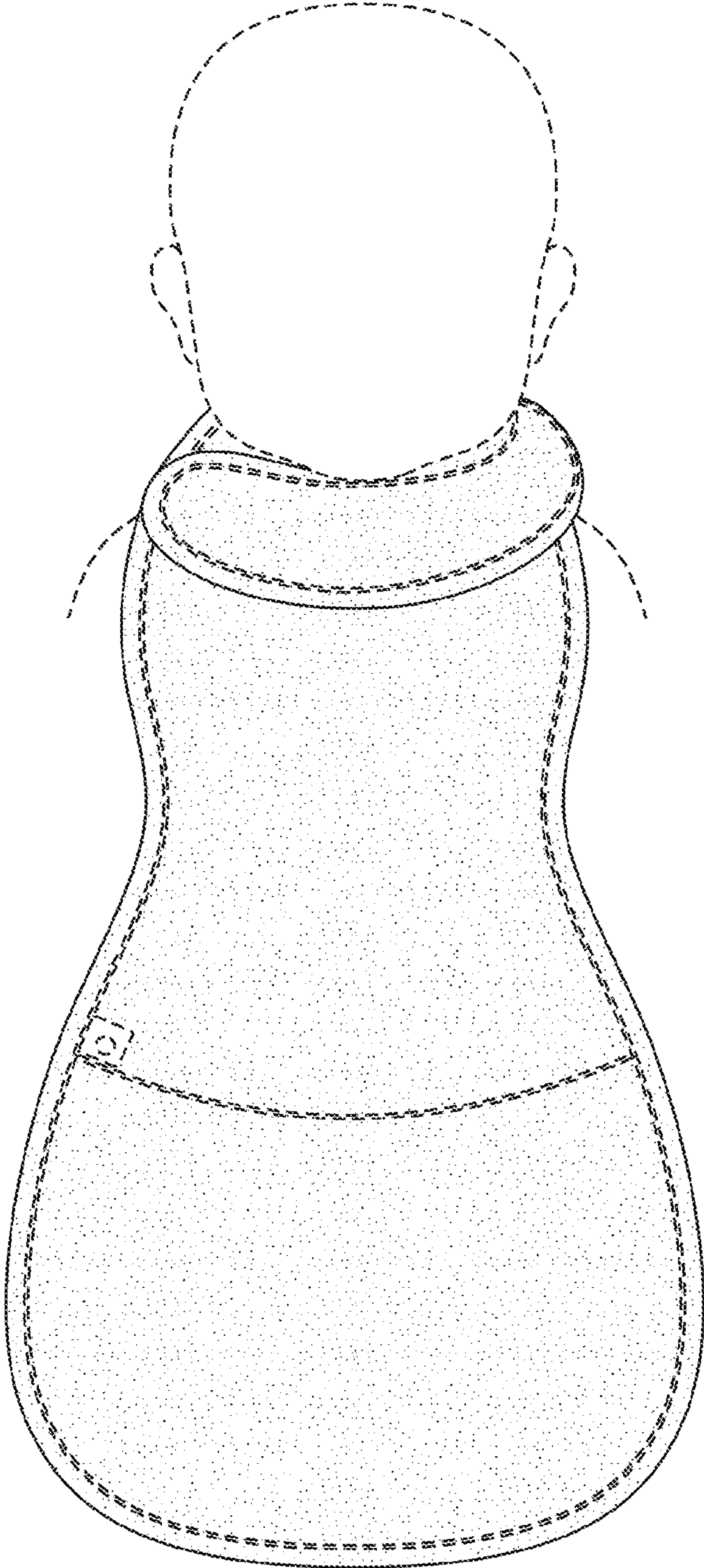

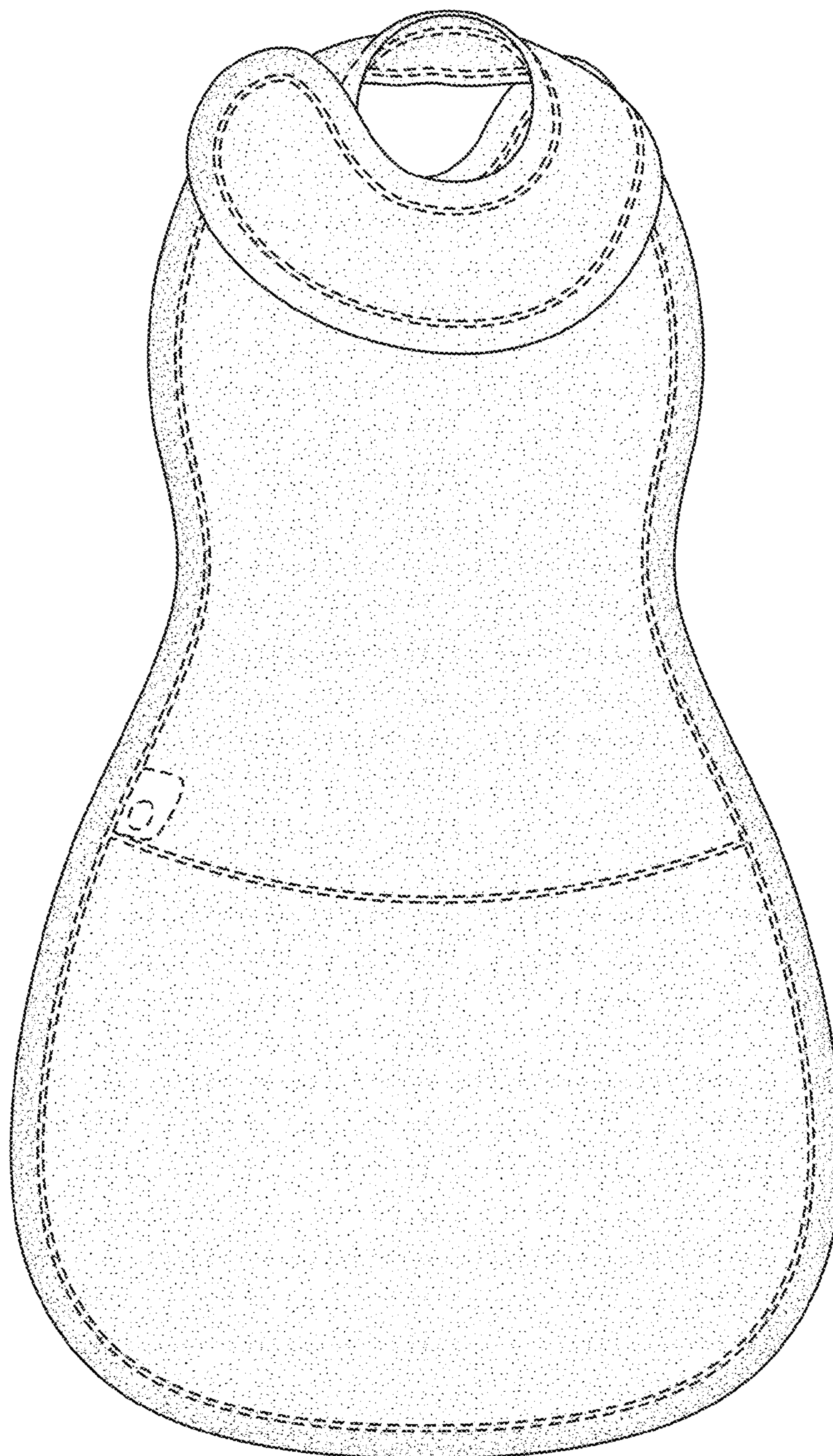

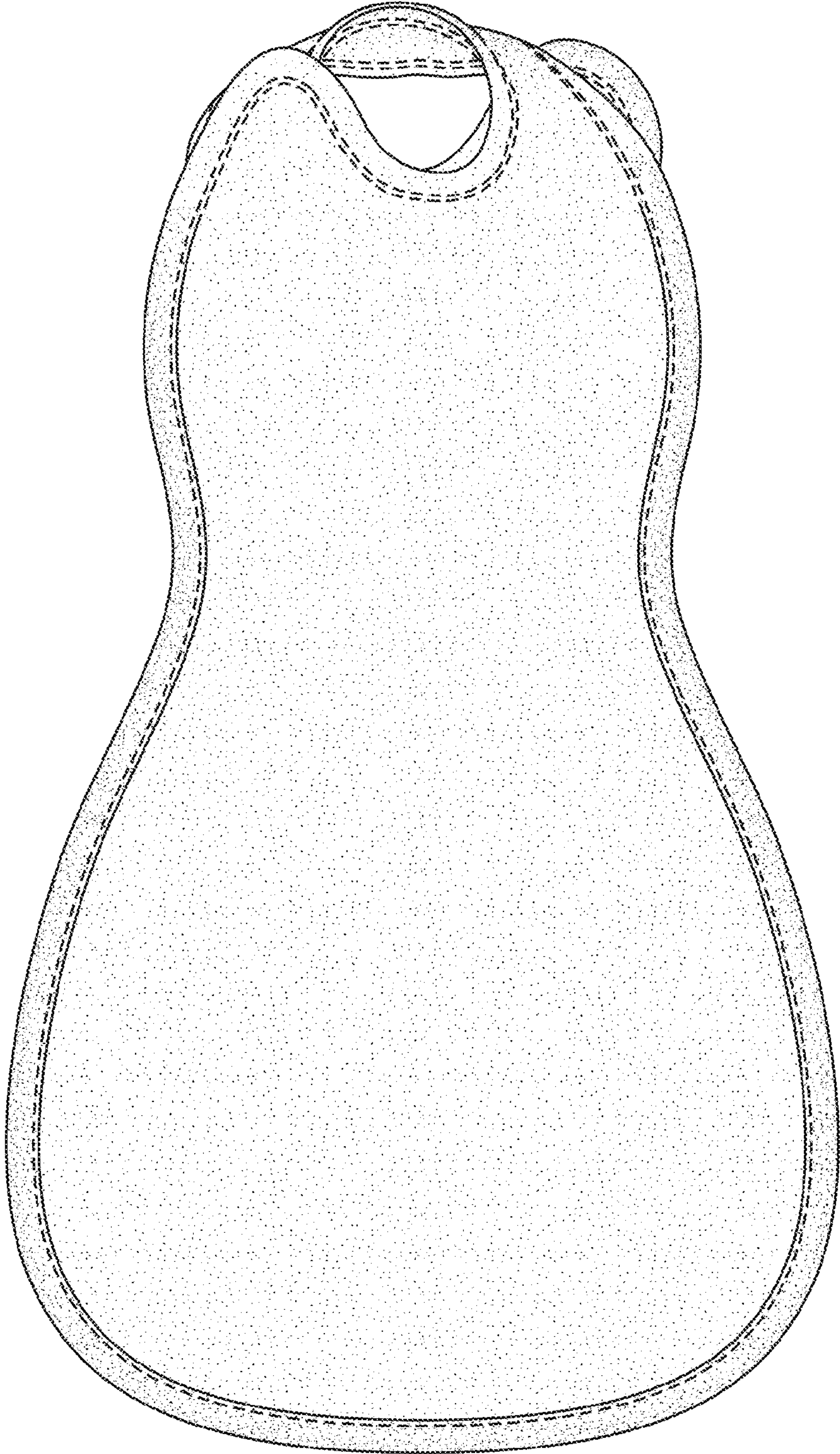

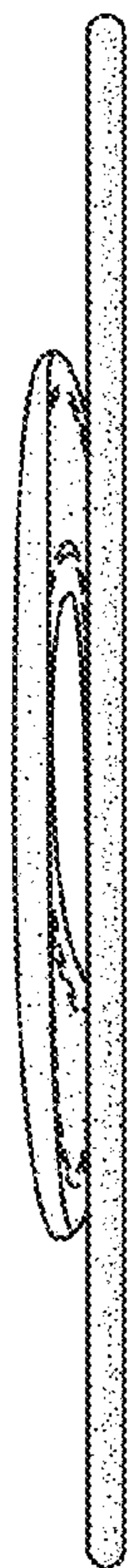
