FIG. 4 is a front view of a collar bib of the present invention, showing the new, original, and ornamental design;

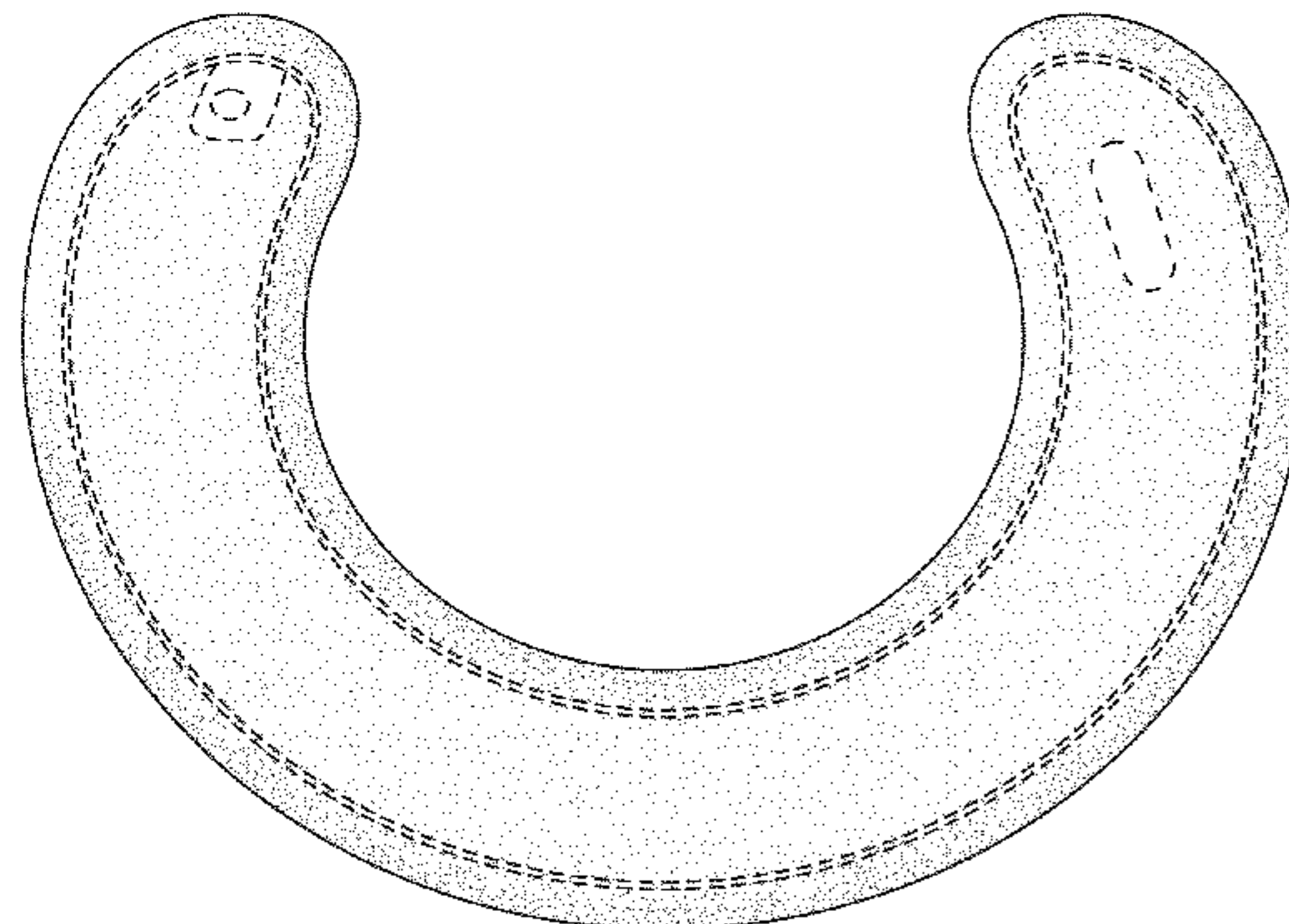
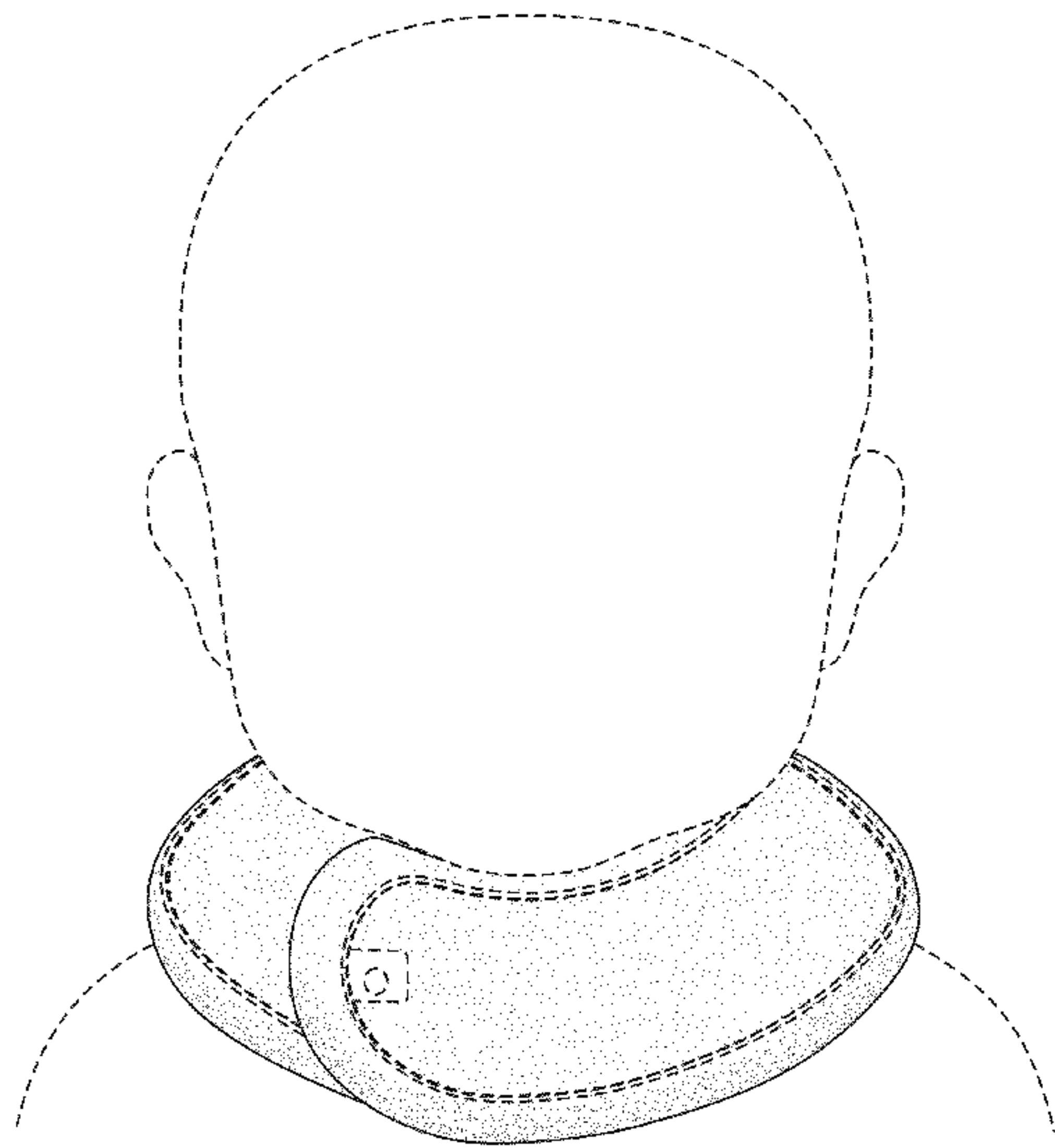
FIG. 5 is a rear view of a collar bib of the present invention, showing the new, original, and ornamental design.

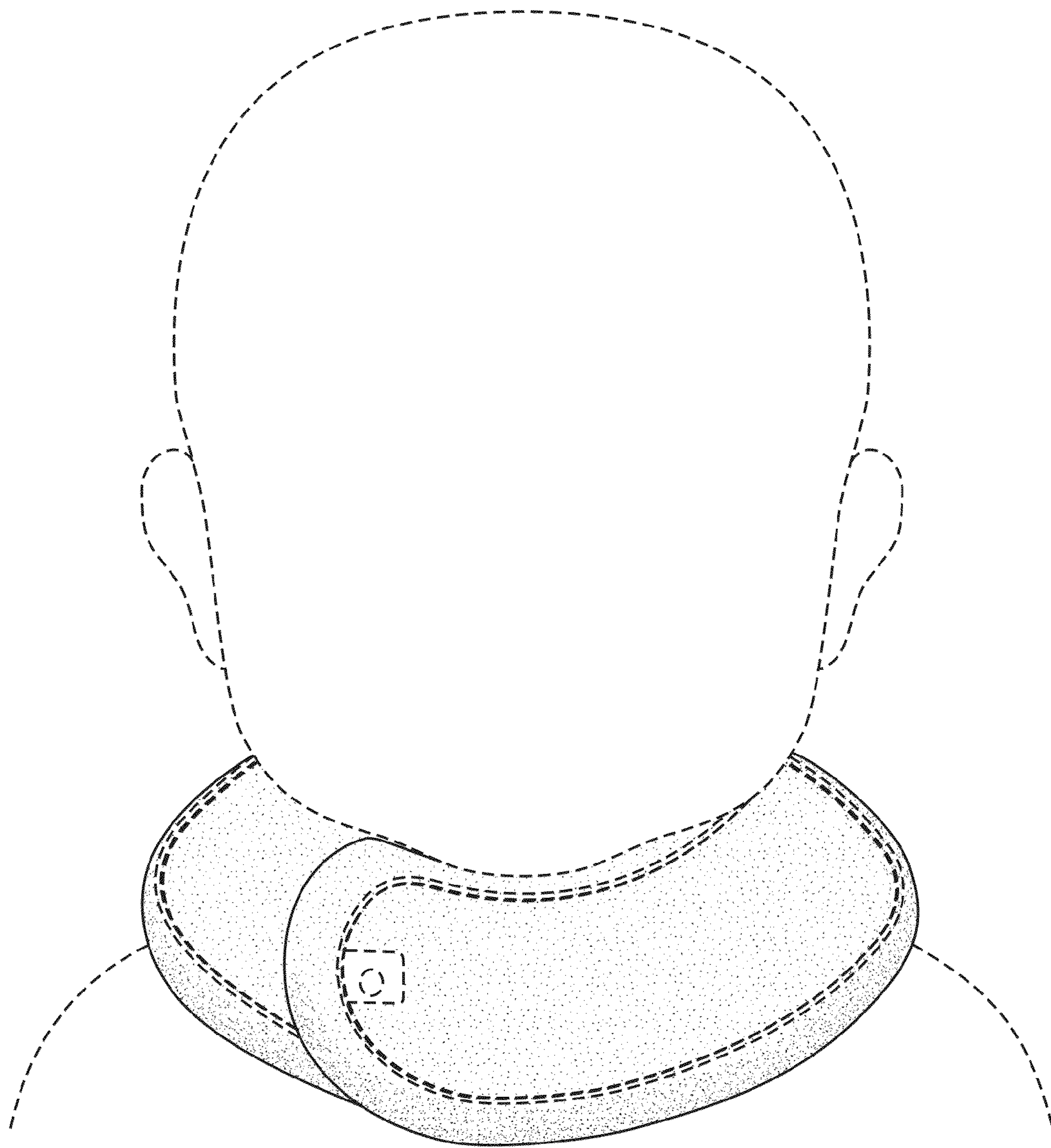

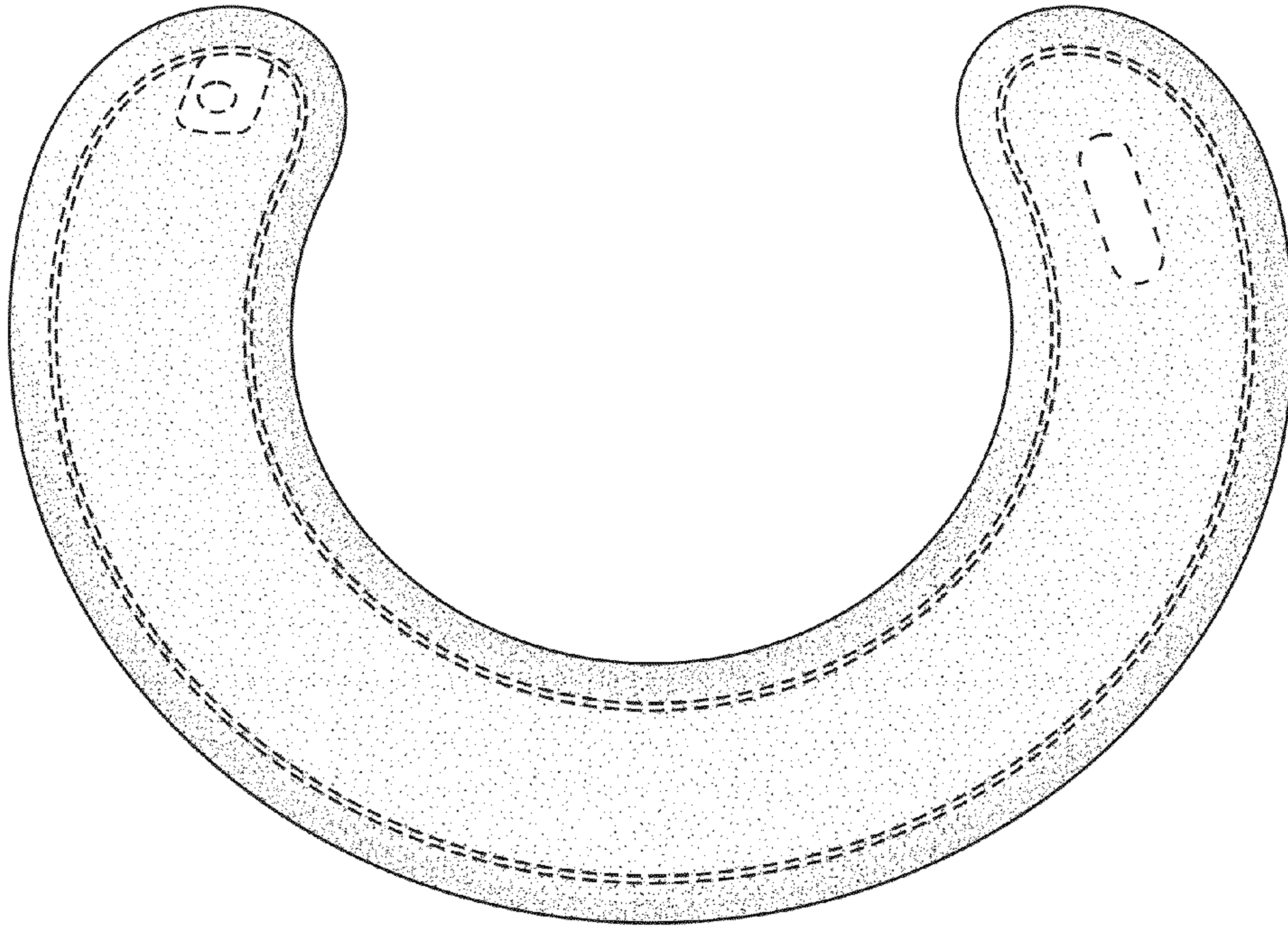

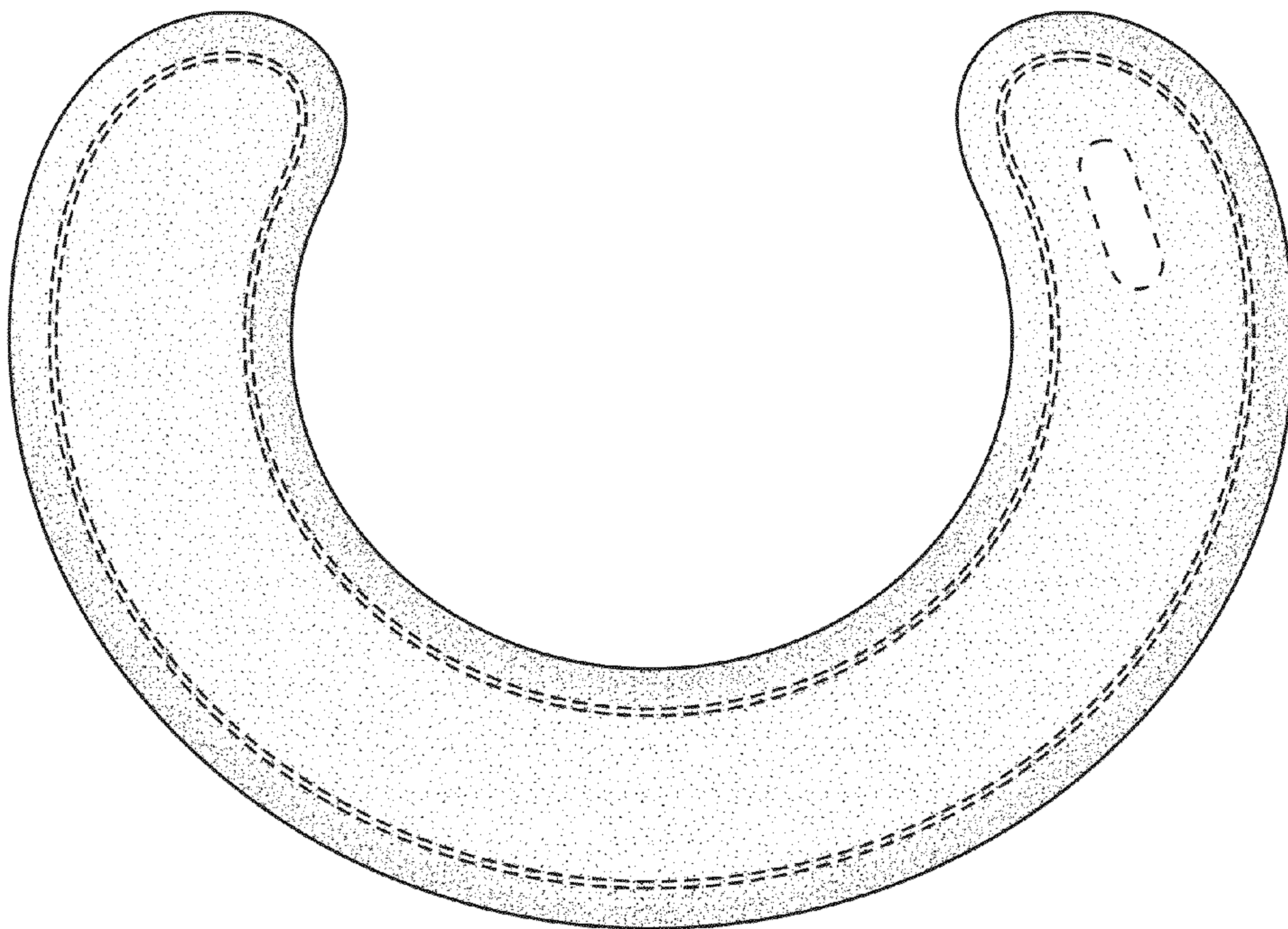

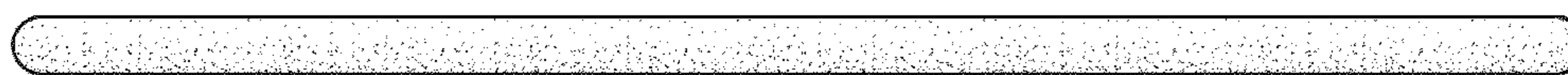

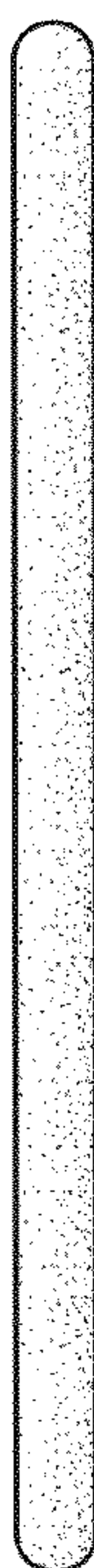
