I claim the ornamental design for a coffee cup sleeve, as shown and described.

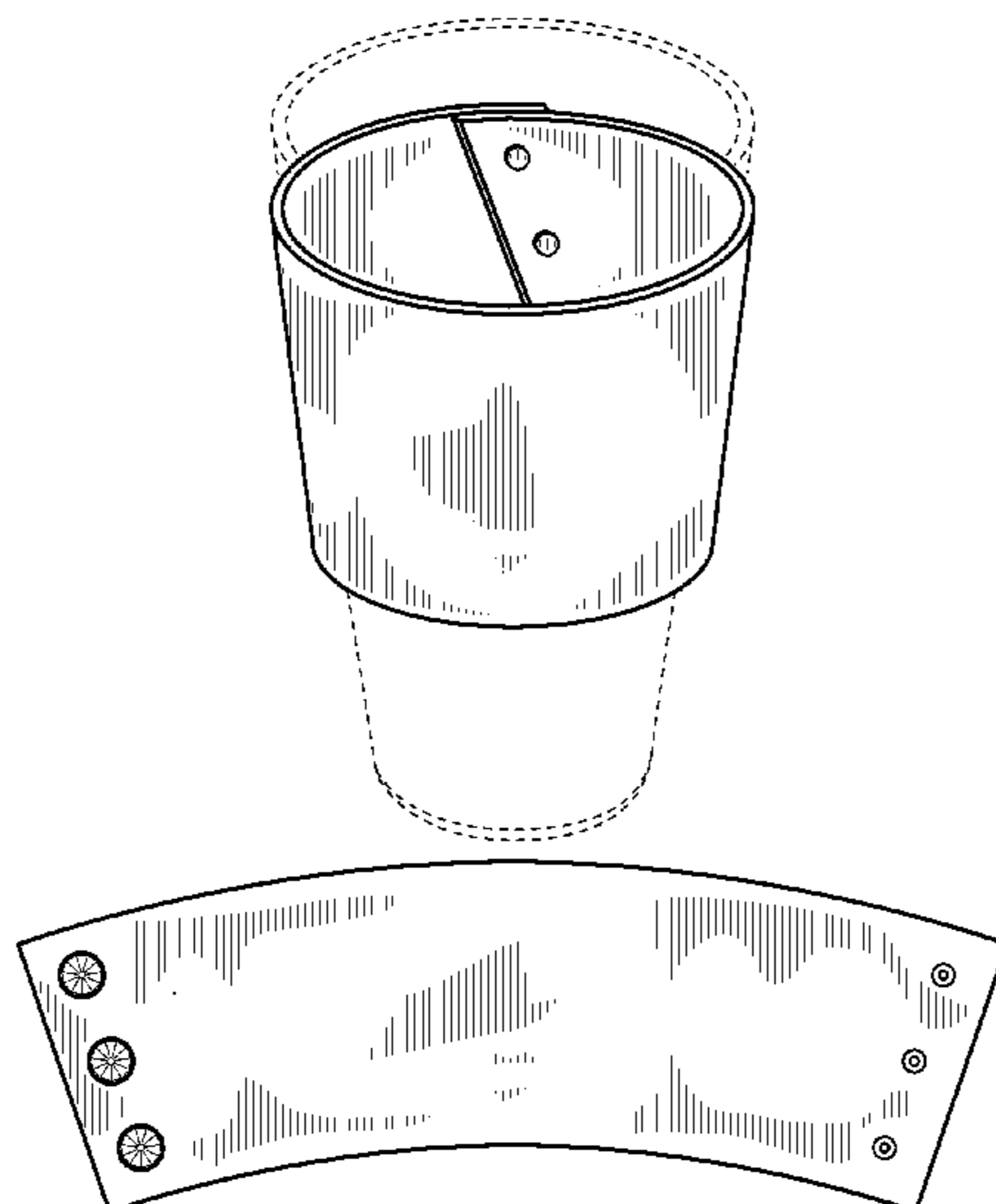
DESCRIPTION

FIG. 1 is a top, front perspective view of a coffee cup sleeve showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken lines in FIGS. 1, 3, 5 and 6 of the coffee cup sleeve are for the purpose of illustrating environment, and form no part of the claimed design.

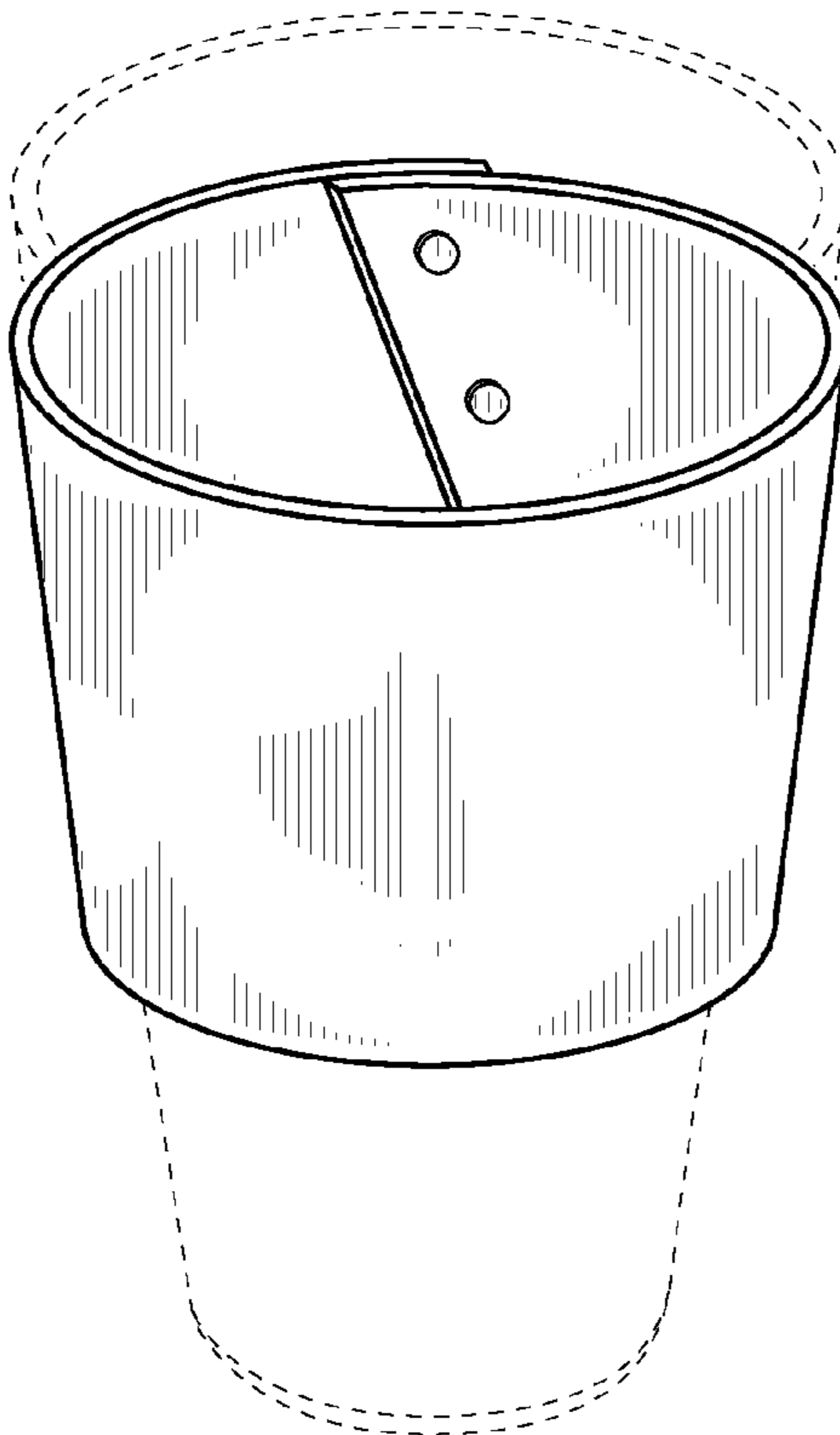

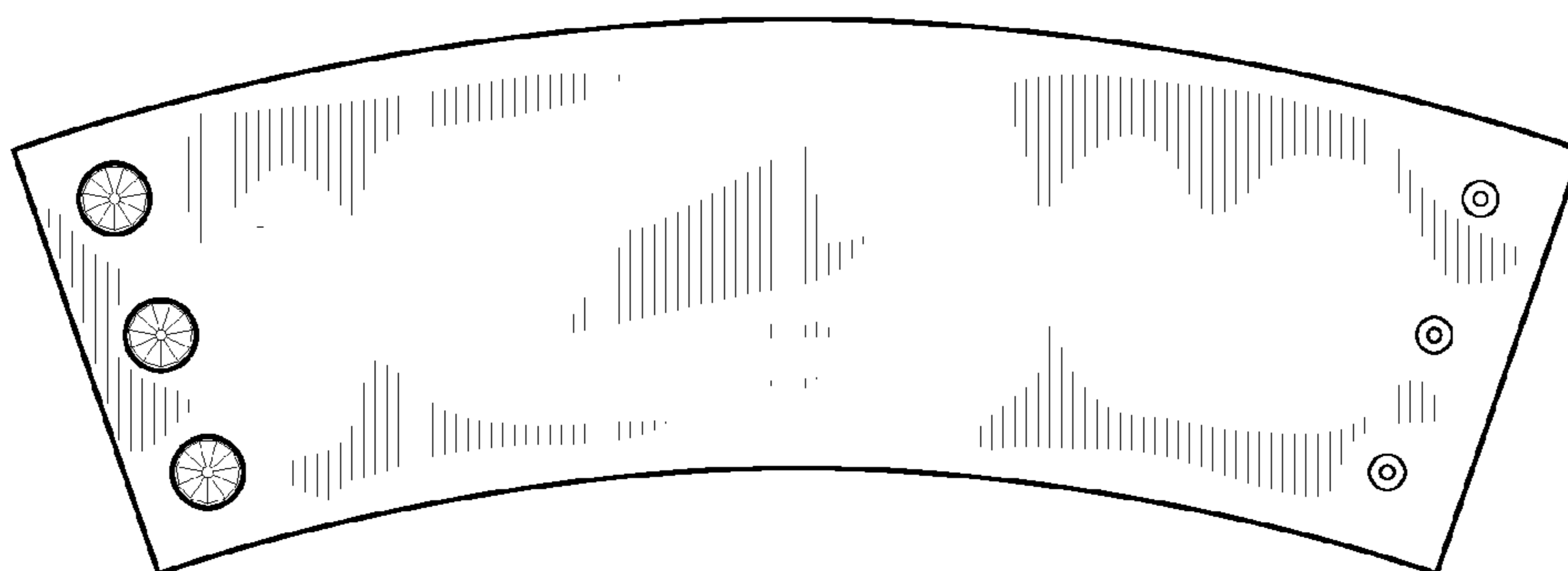

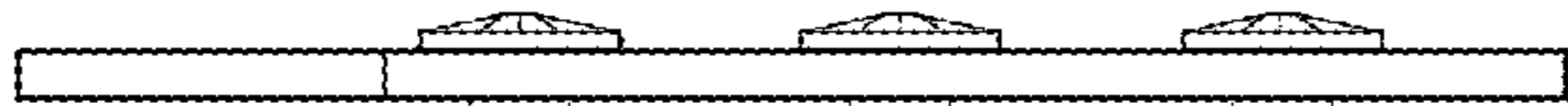

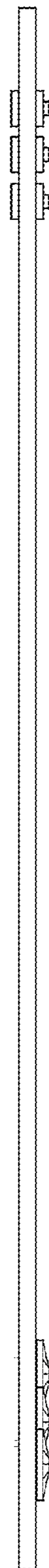
