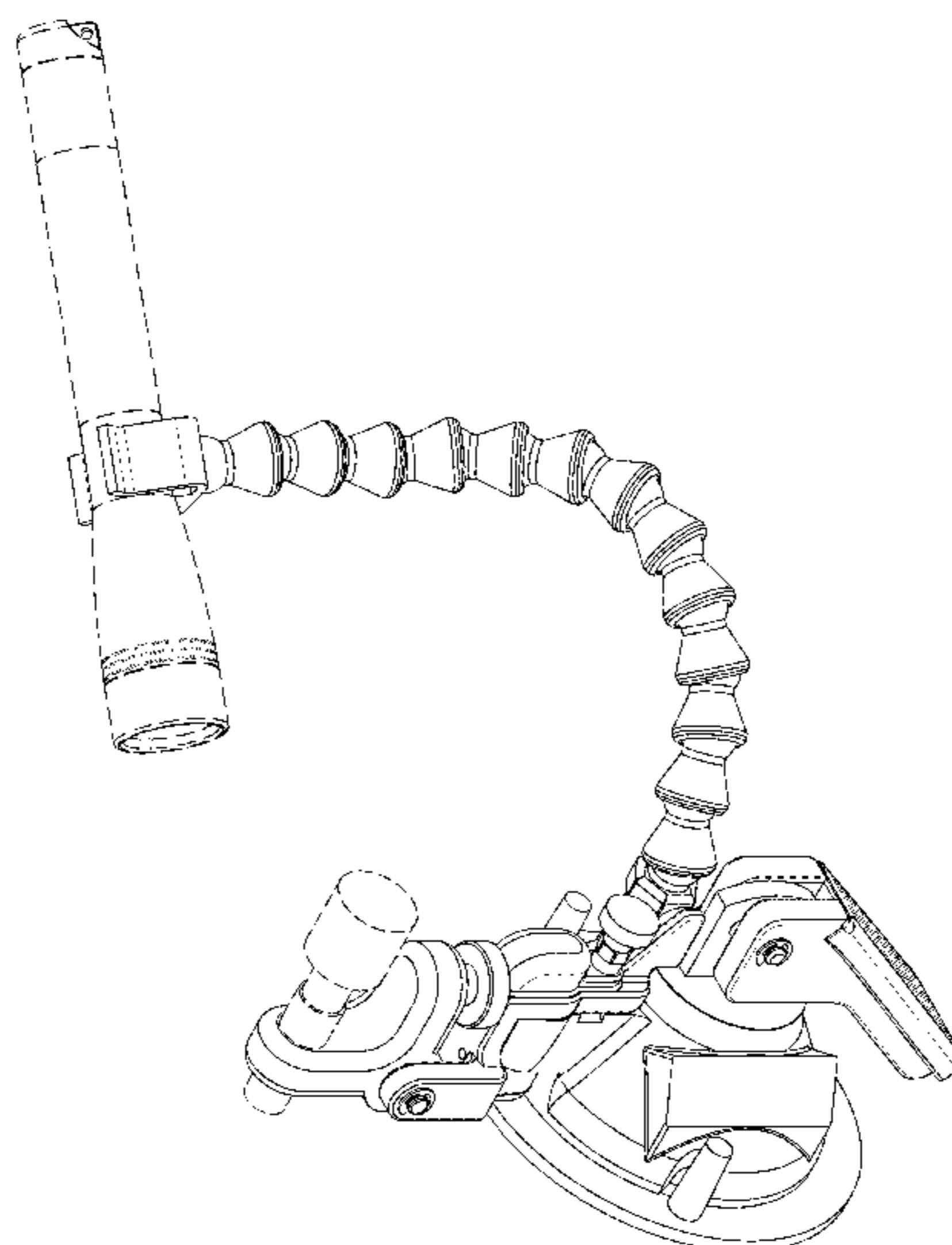

The ornamental design for windshield repair bridge, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of a first embodiment of a windshield repair bridge;  
FIG. 2 is a second perspective view of the windshield repair bridge of FIG. 1;  
FIG. 3 is a first side view of the windshield repair bridge of FIG. 1;  
FIG. 4 is an opposite side view of the windshield repair bridge, of FIG. 3;  
FIG. 5 is another side view of the windshield repair bridge of FIG. 1;  
FIG. 6 is an opposite side view of the windshield repair bridge shown in FIG. 5;  
FIG. 7 is a top view of the windshield repair bridge of FIG. 1; and,  
FIG. 8 is a bottom view of the windshield repair bridge of FIG. 1.

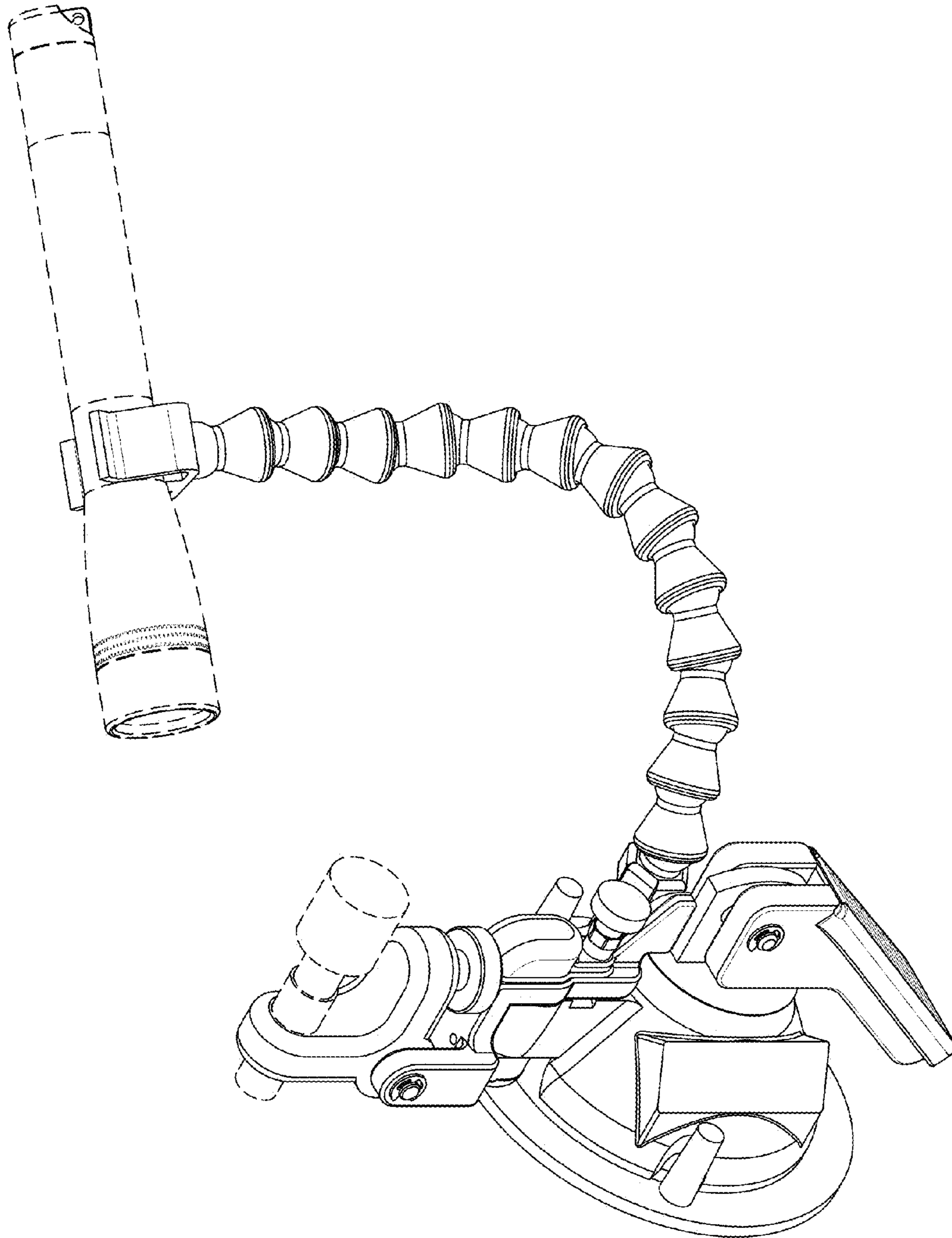
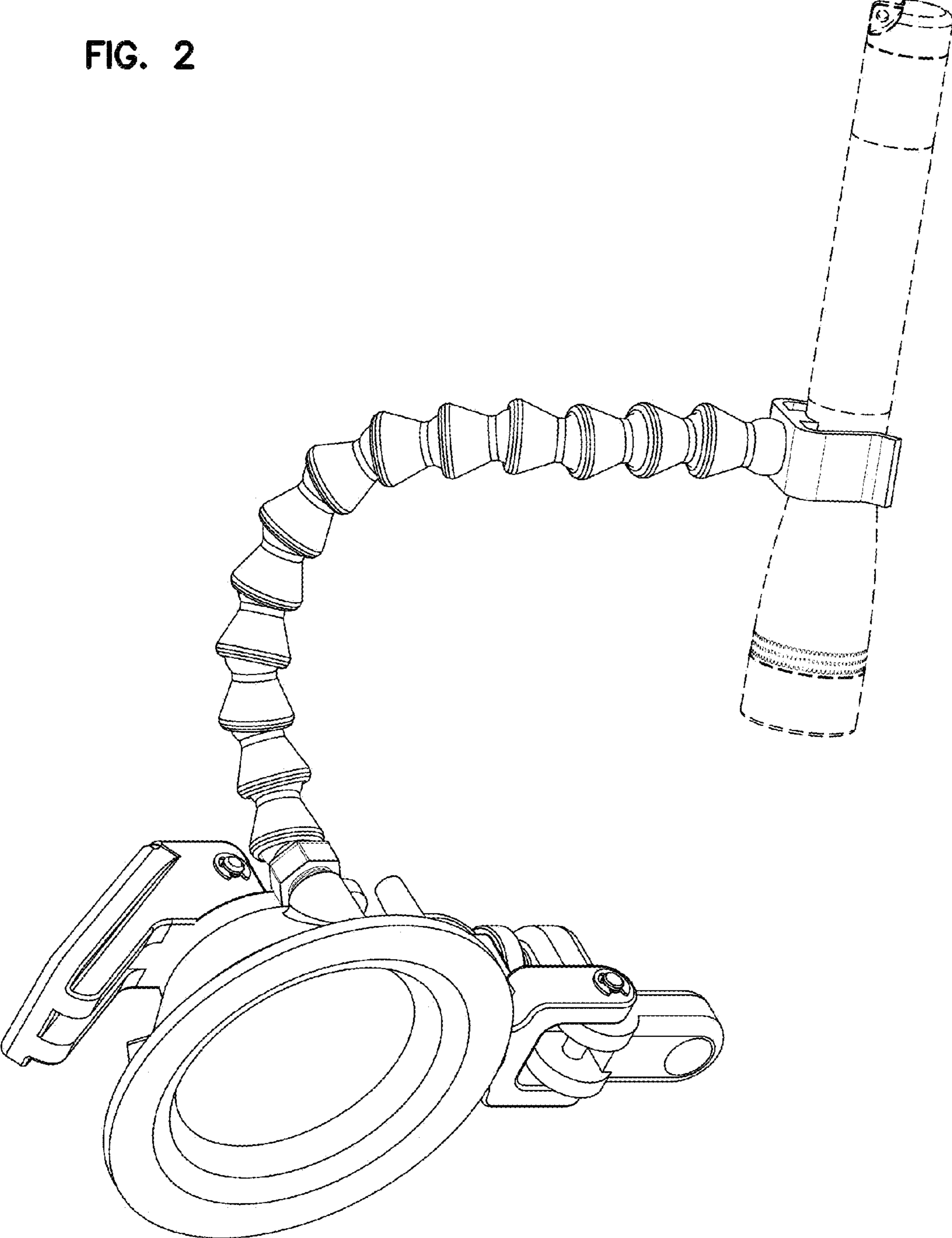

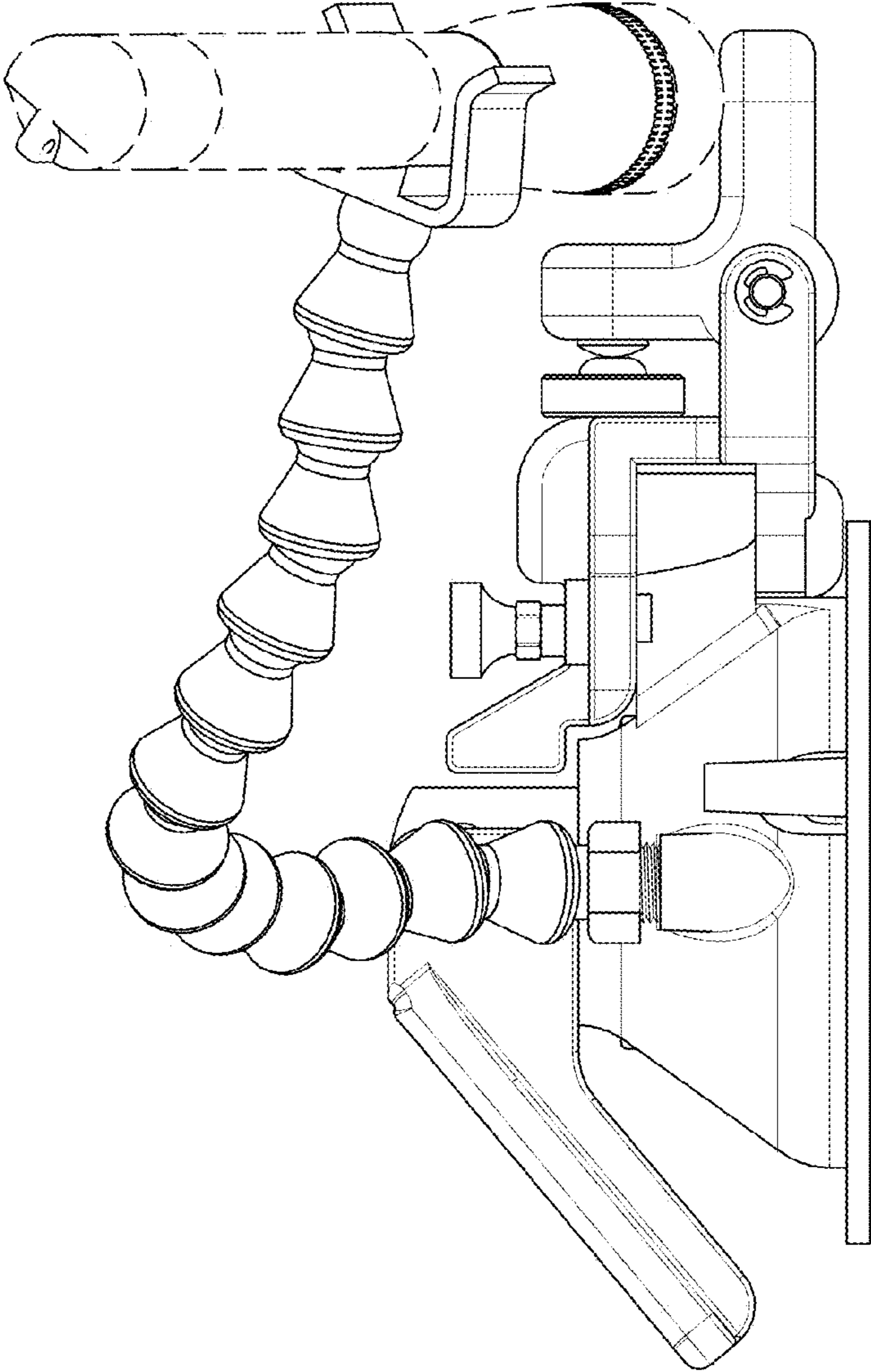

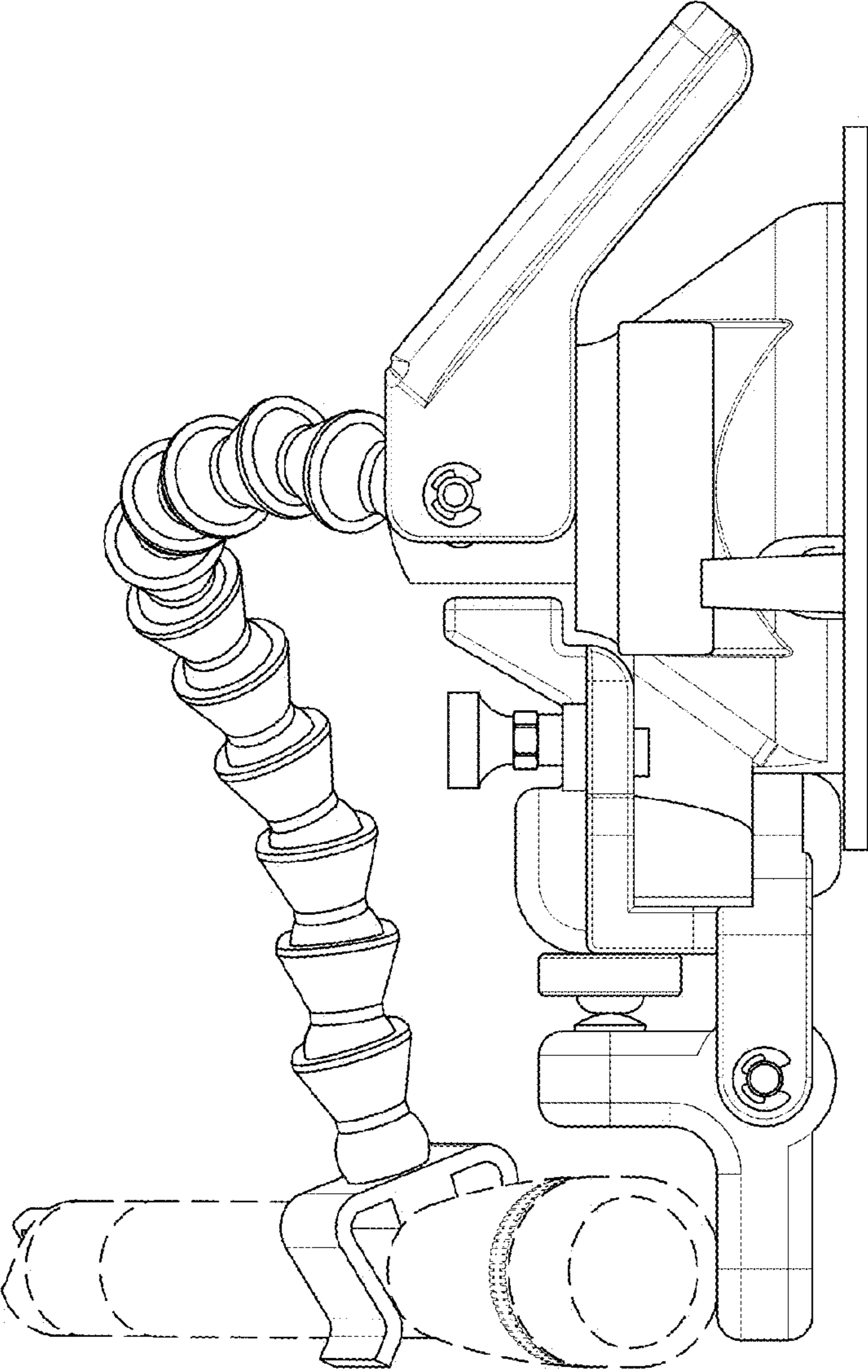

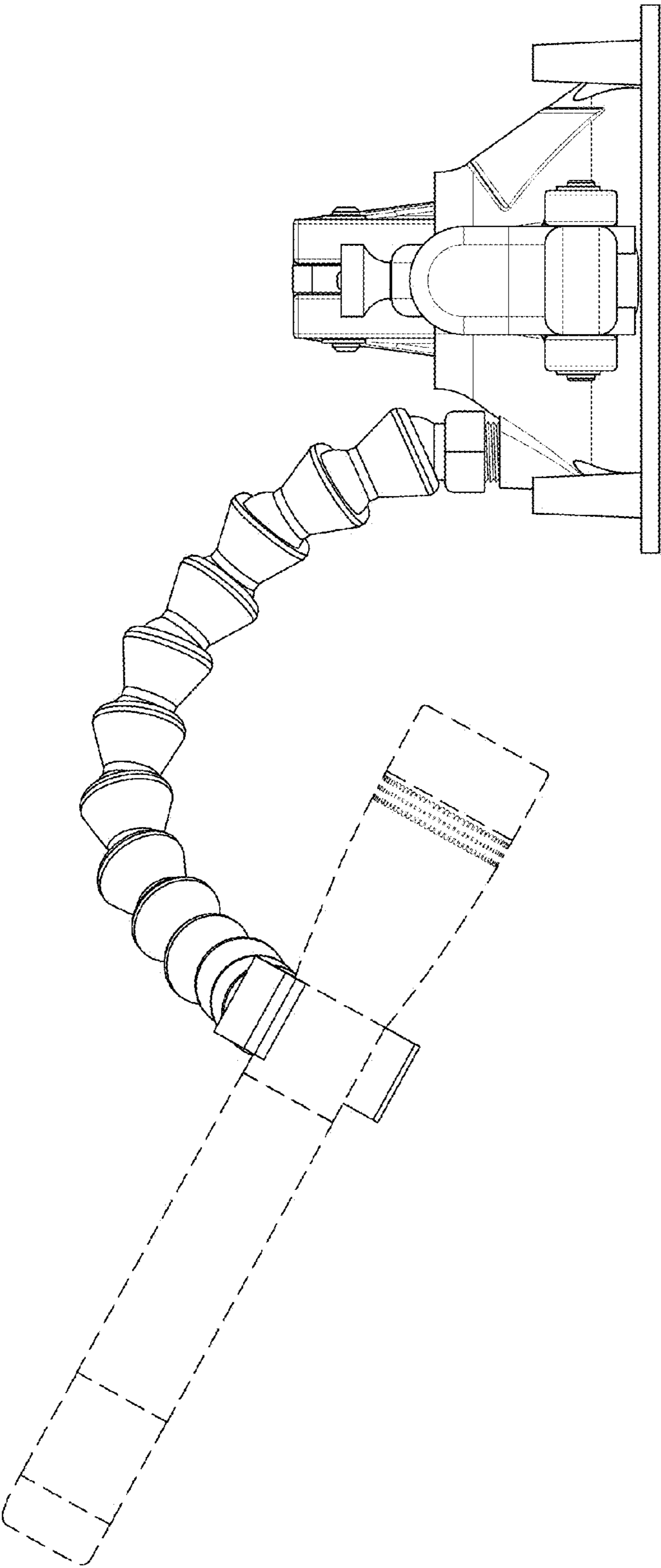

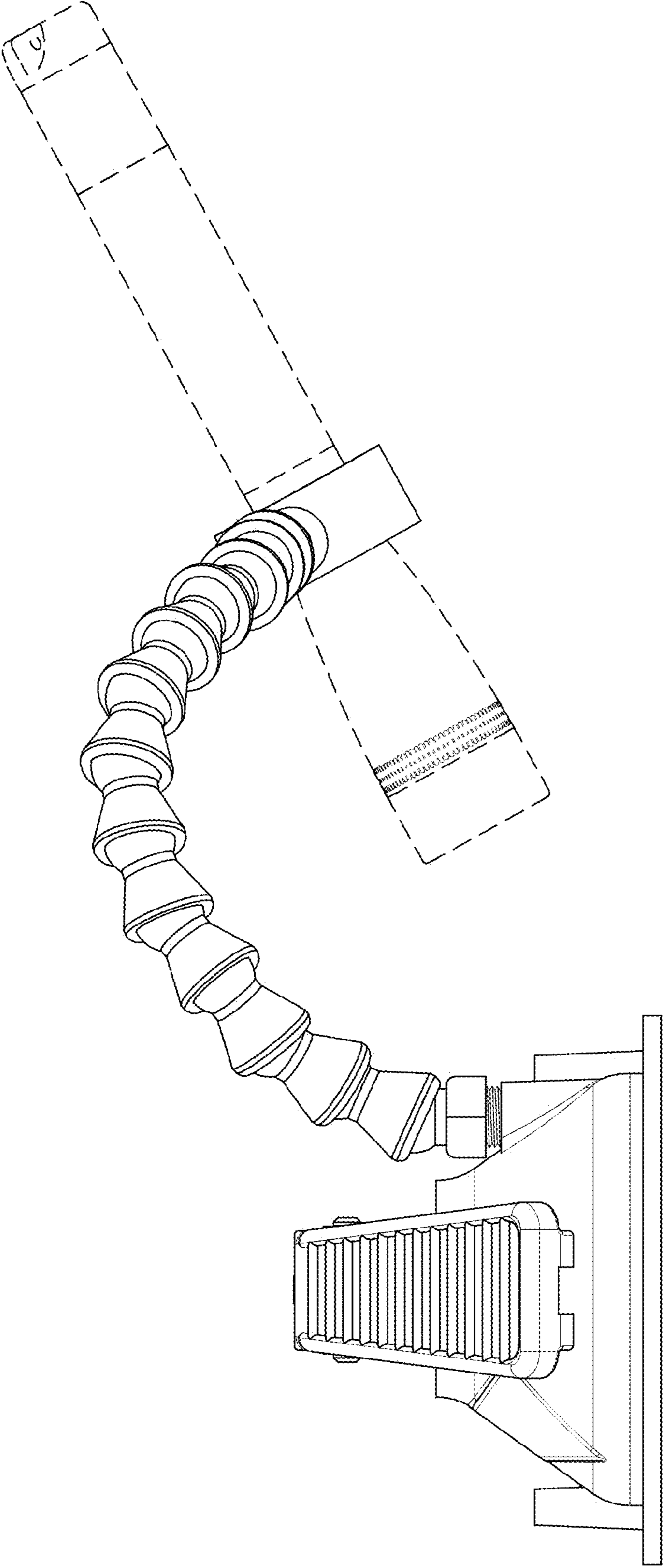

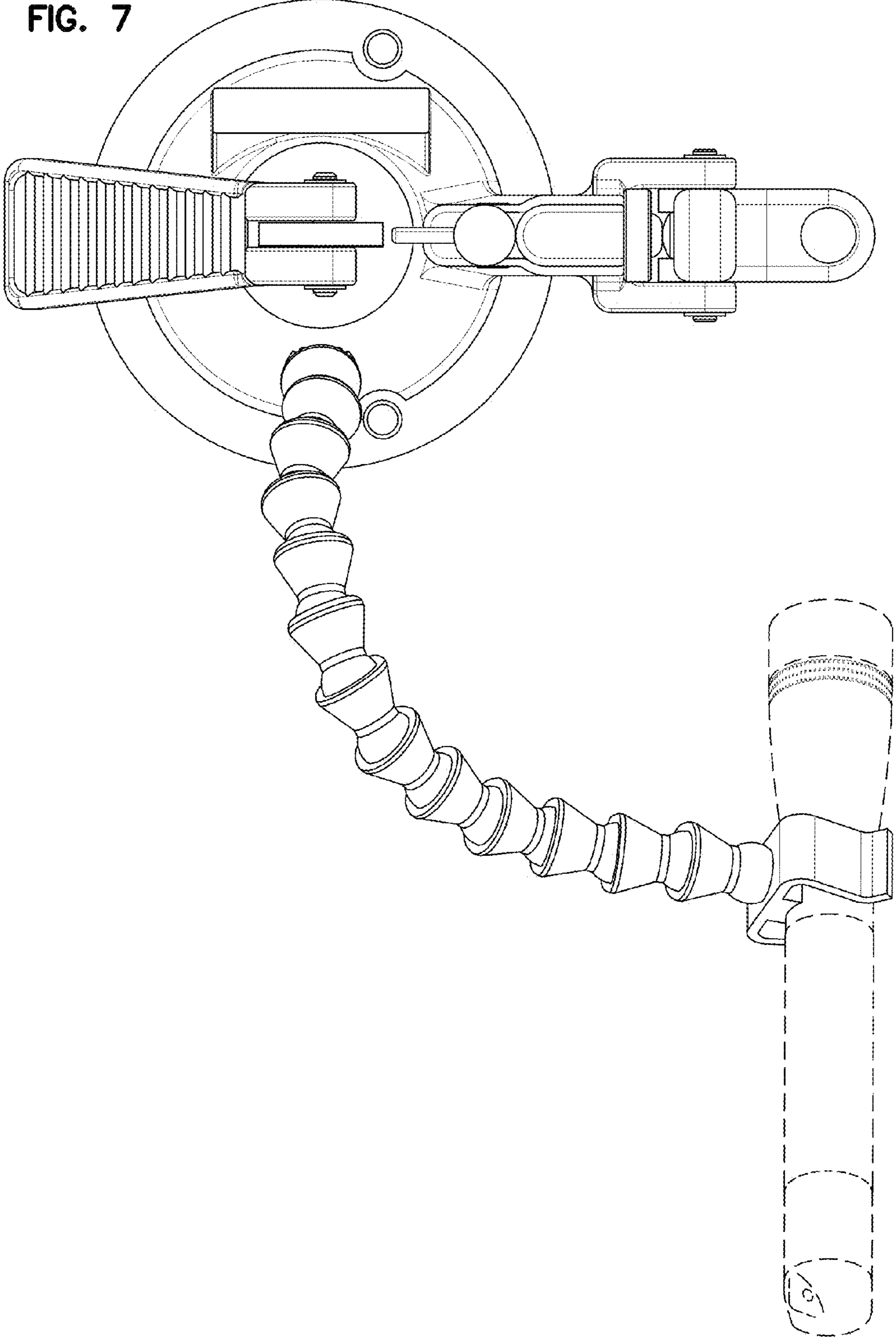
