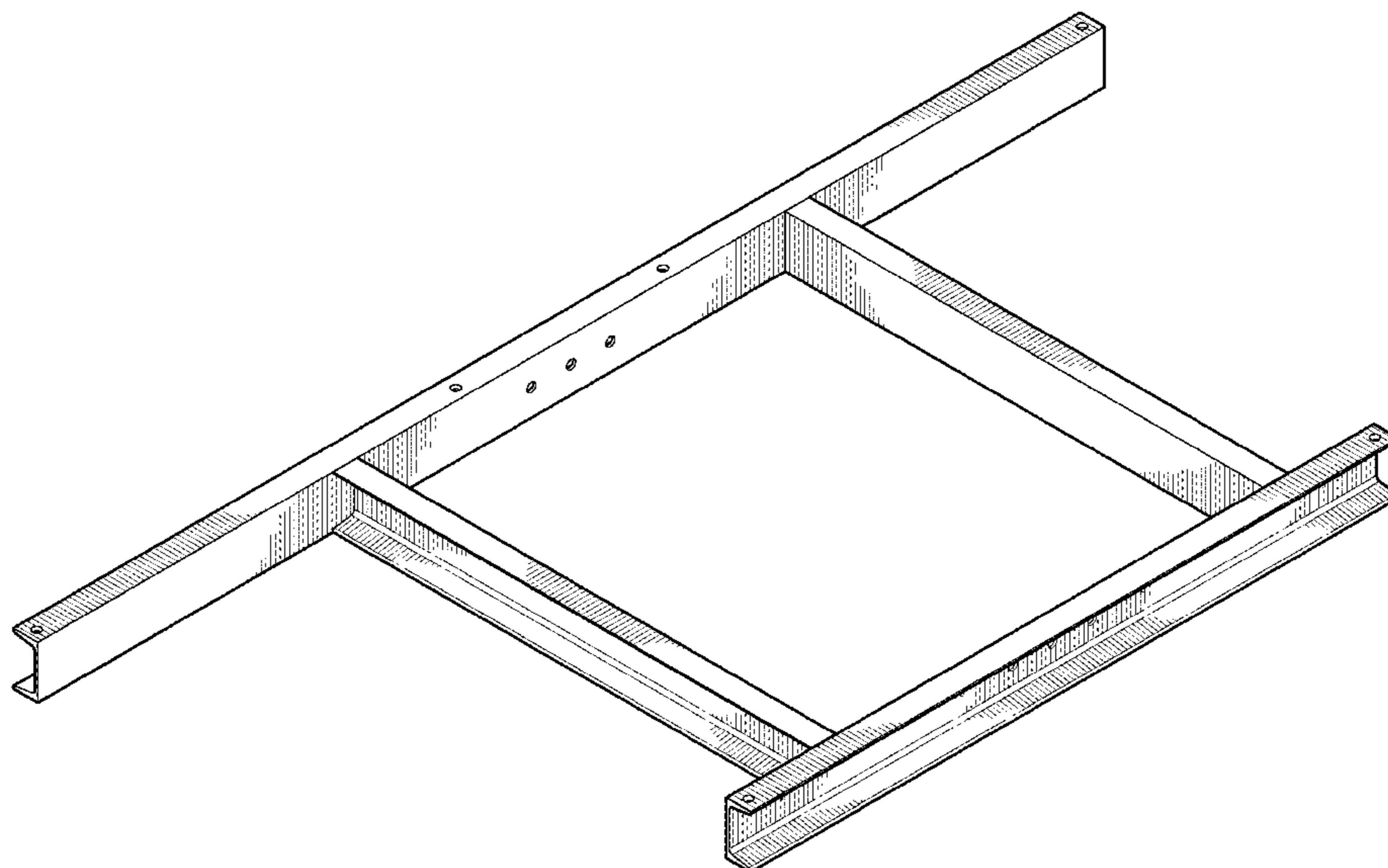
(57) **CLAIM**

The ornamental design for a horizontal frame member for supporting a concentrating photovoltaic system module, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a horizontal frame member for supporting a concentrating photovoltaic system module; FIG. 2 is a front side elevation view of the horizontal frame member of FIG. 1; FIG. 3 is a rear side elevation view of the horizontal frame member of FIG. 1; FIG. 4 is a top plan view of the horizontal frame member of FIG. 1; FIG. 5 is a bottom plan view of the horizontal frame member of FIG. 1; FIG. 6 is a right side elevation view of the horizontal frame member of FIG. 1; and, FIG. 7 is a left side elevation view of the horizontal frame member of FIG. 1.

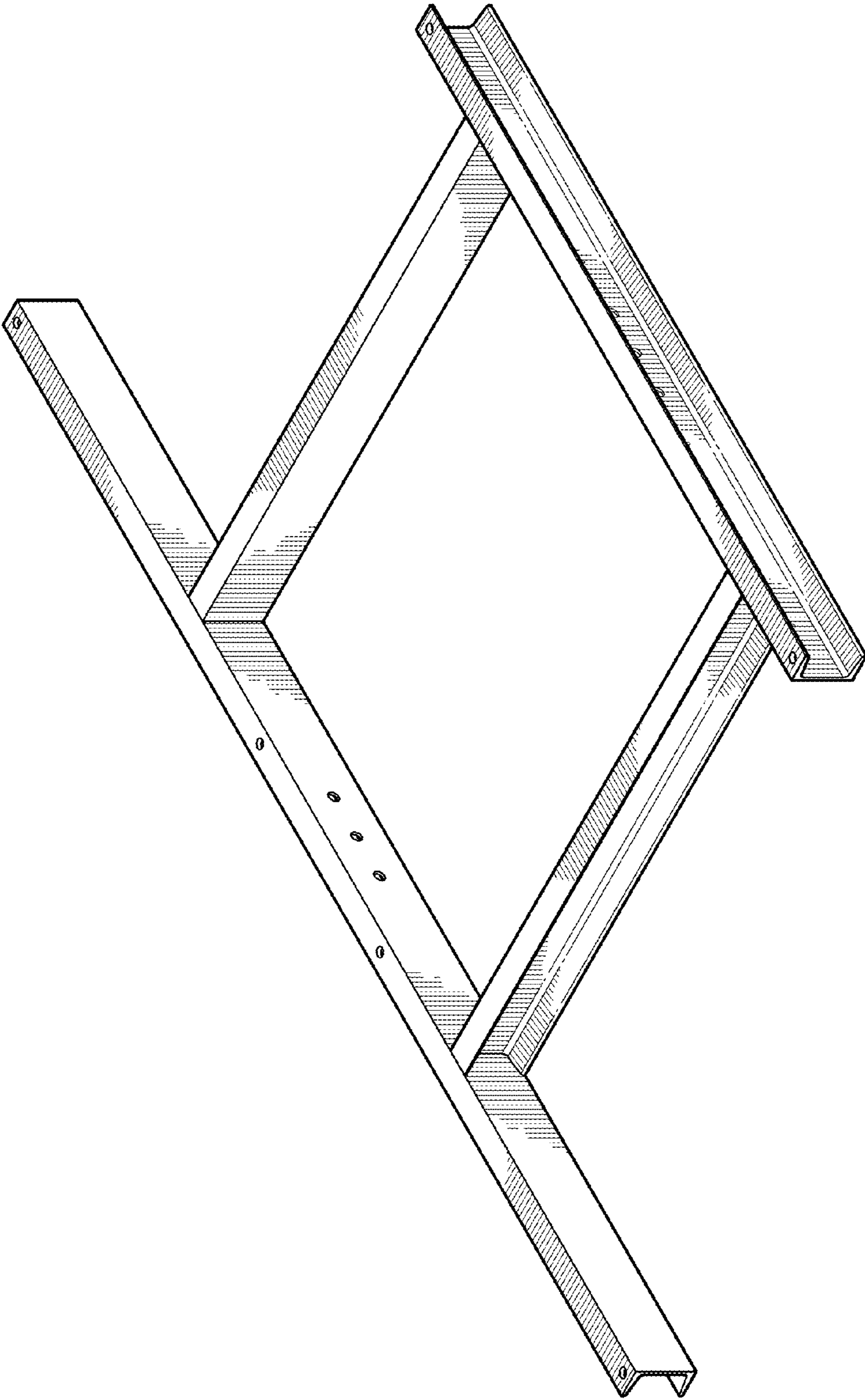

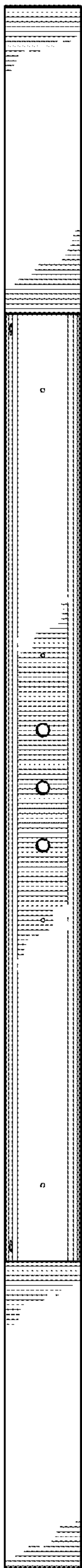

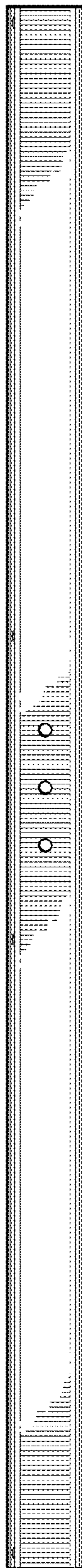

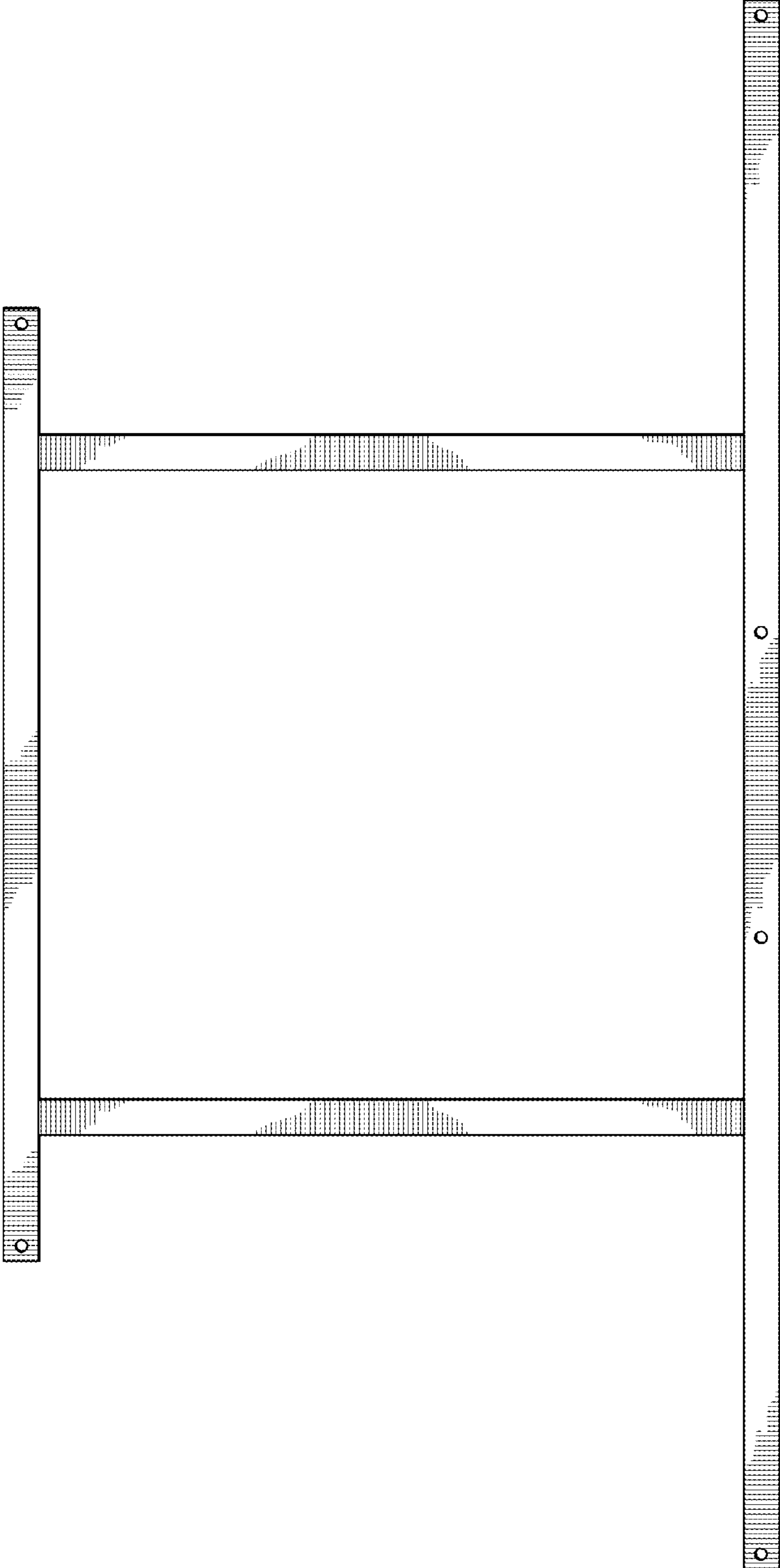

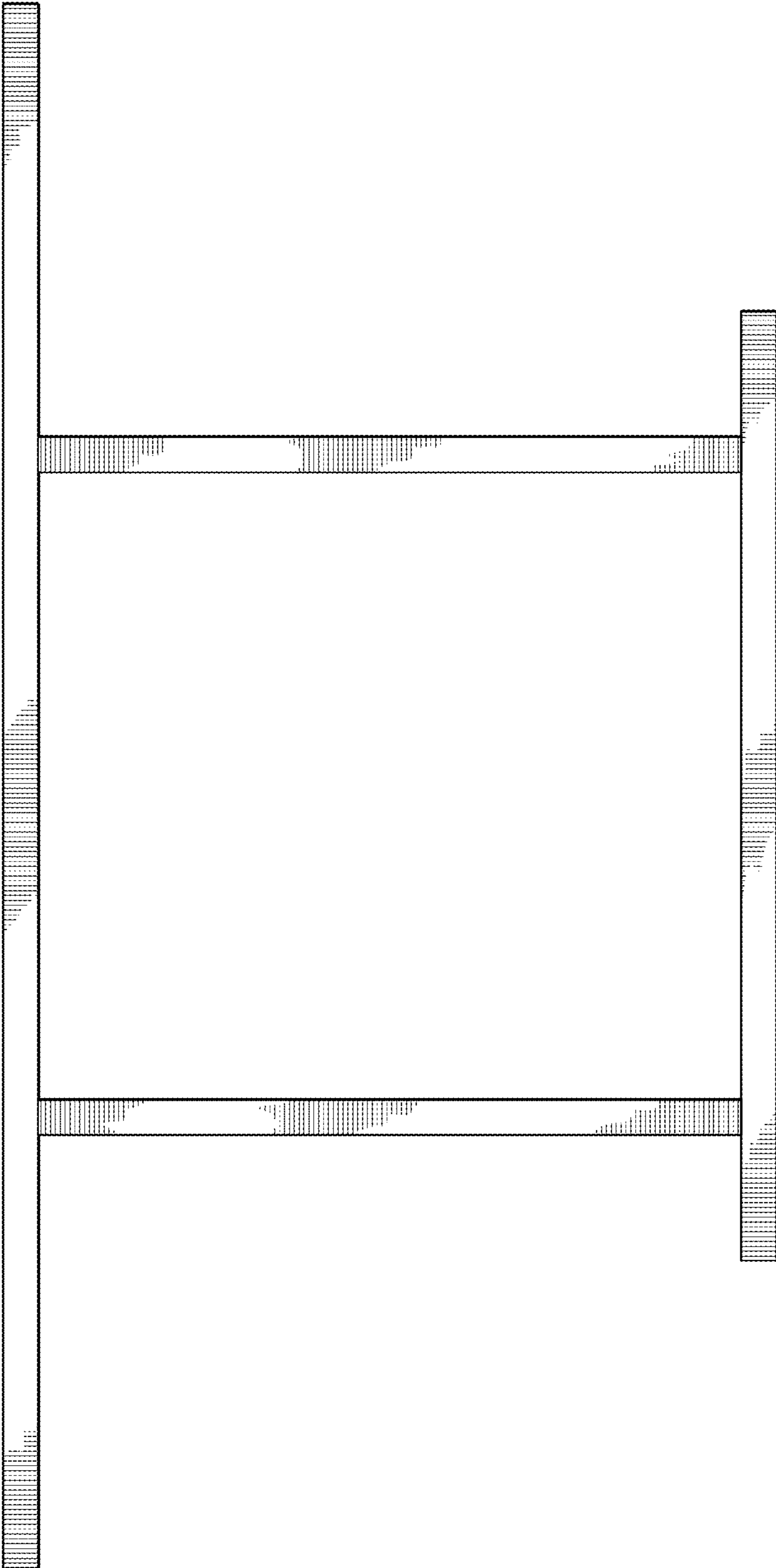

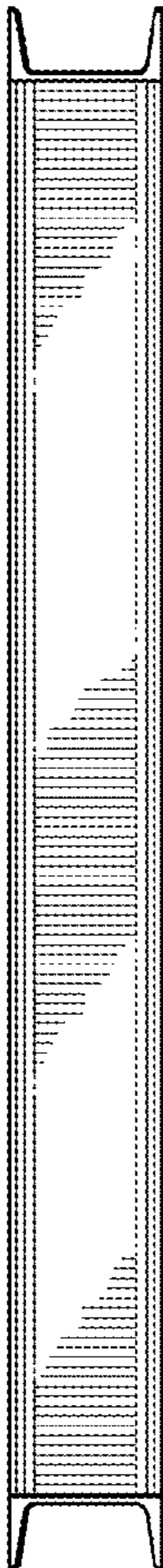

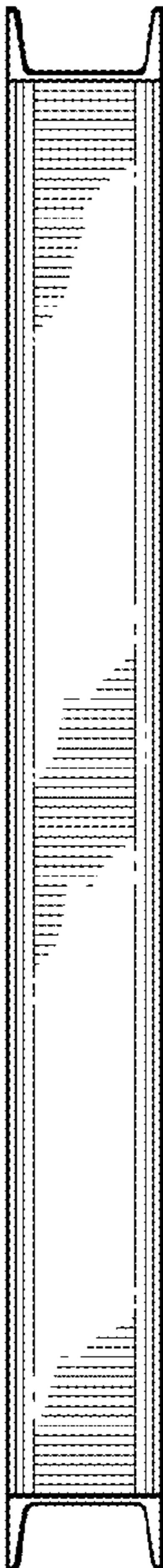
