FIG. 13 is a left-side view of the second embodiment;

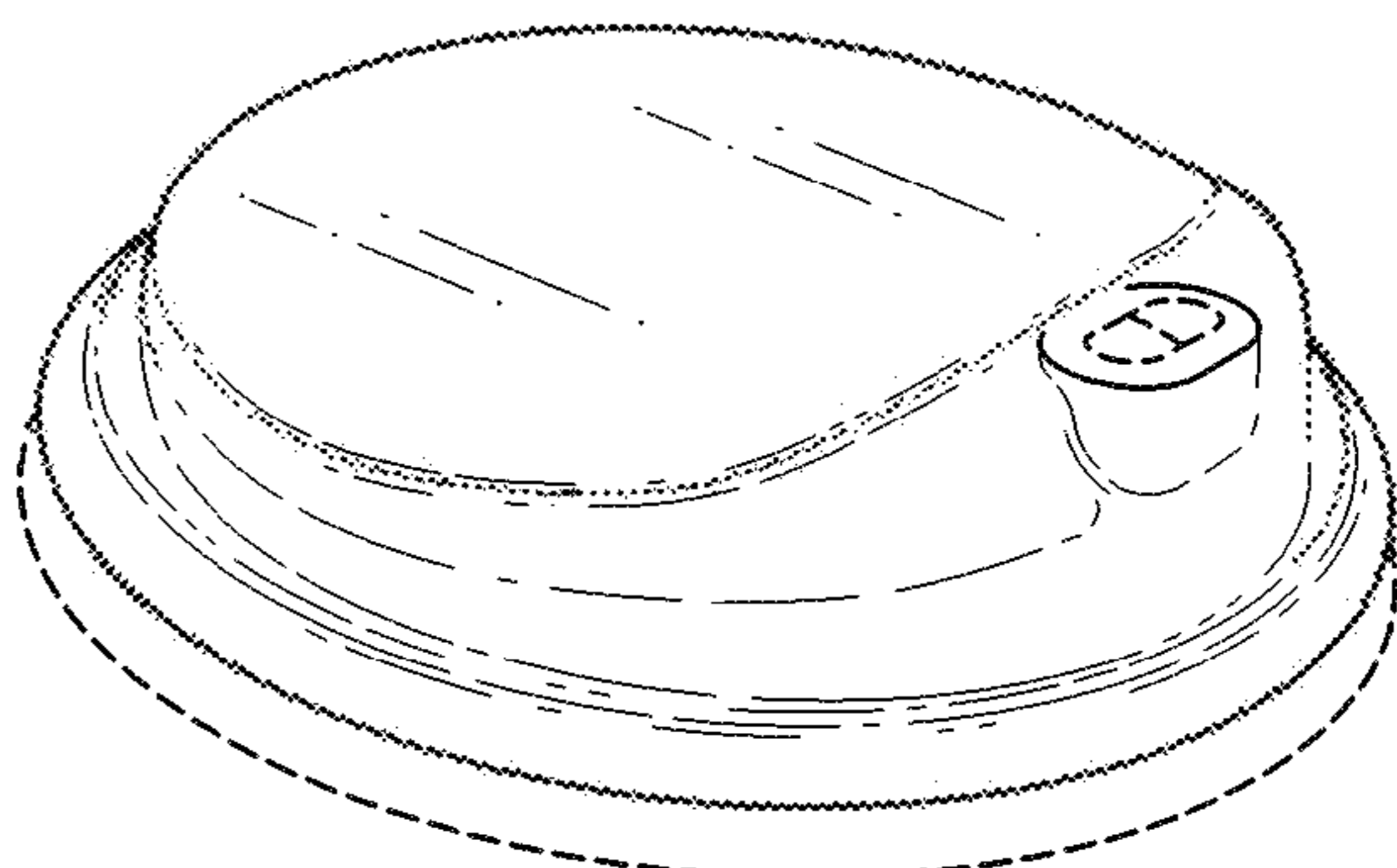
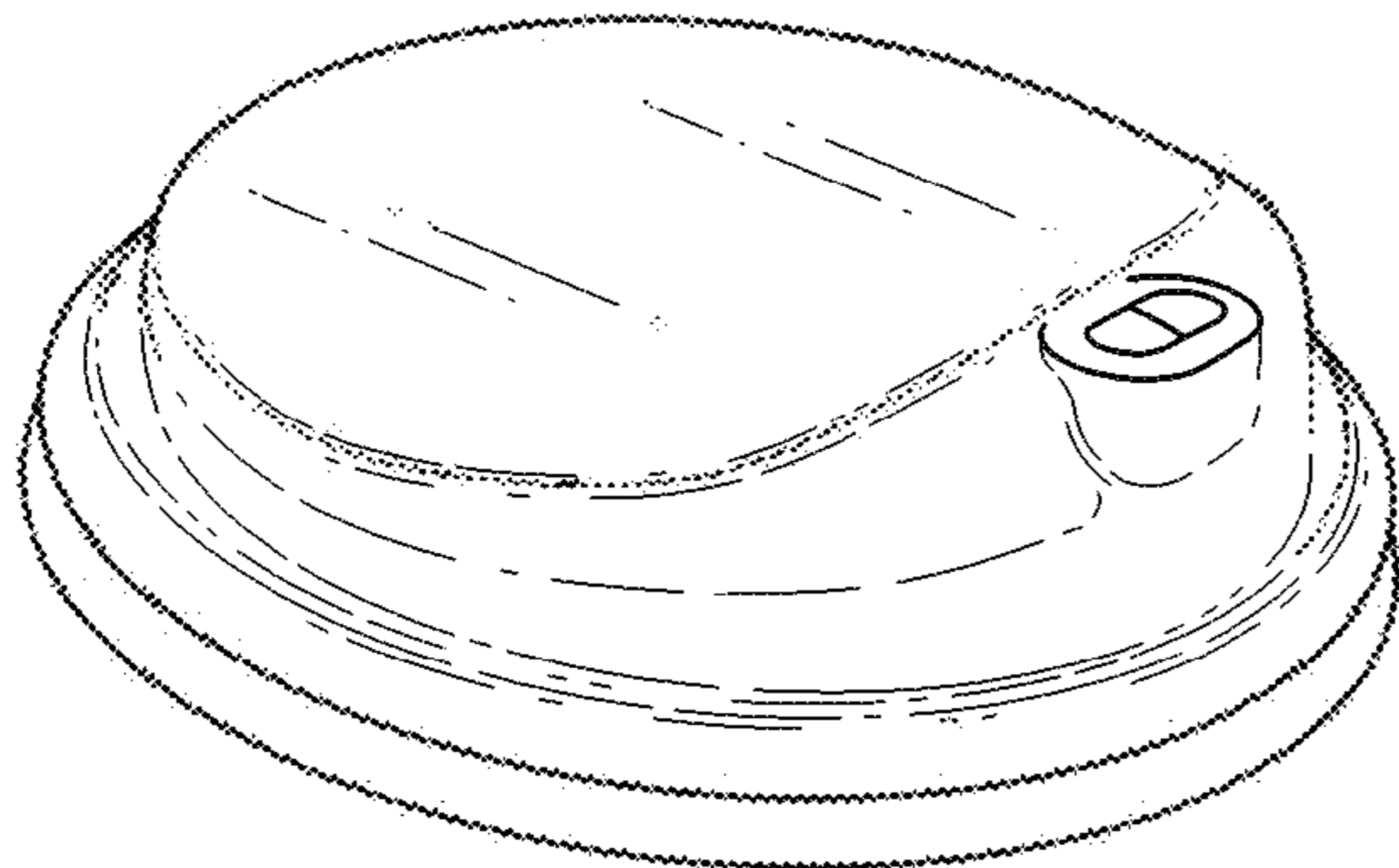
FIG. 14 is a top plan view of the second embodiment;

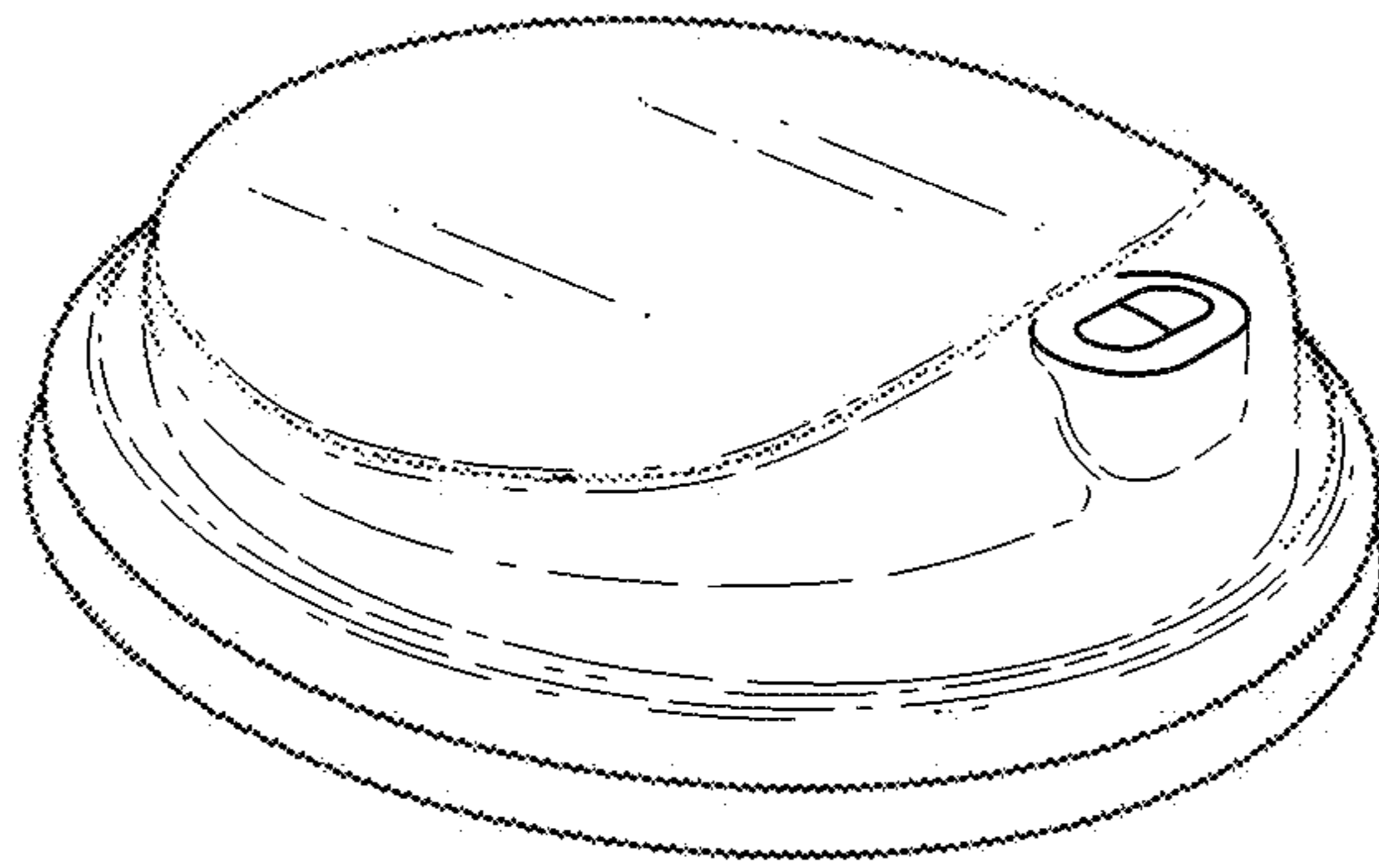

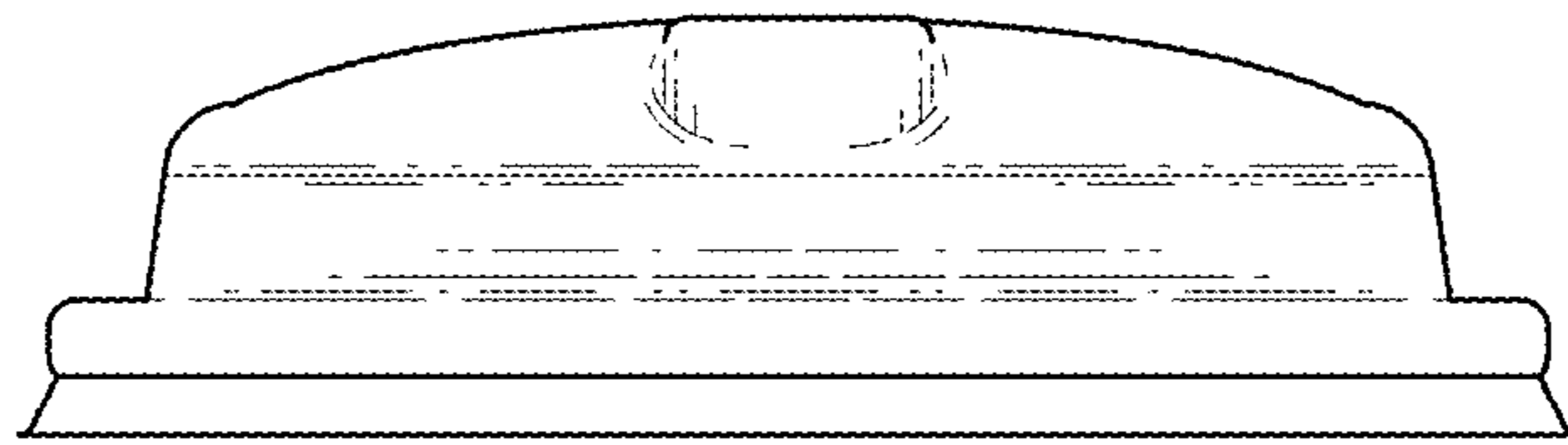

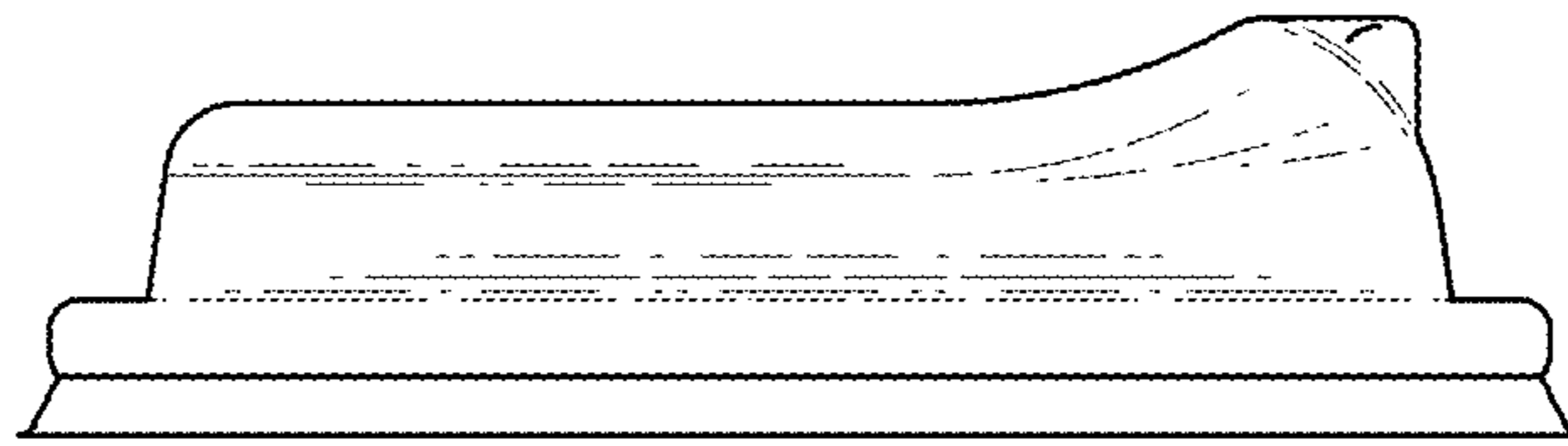

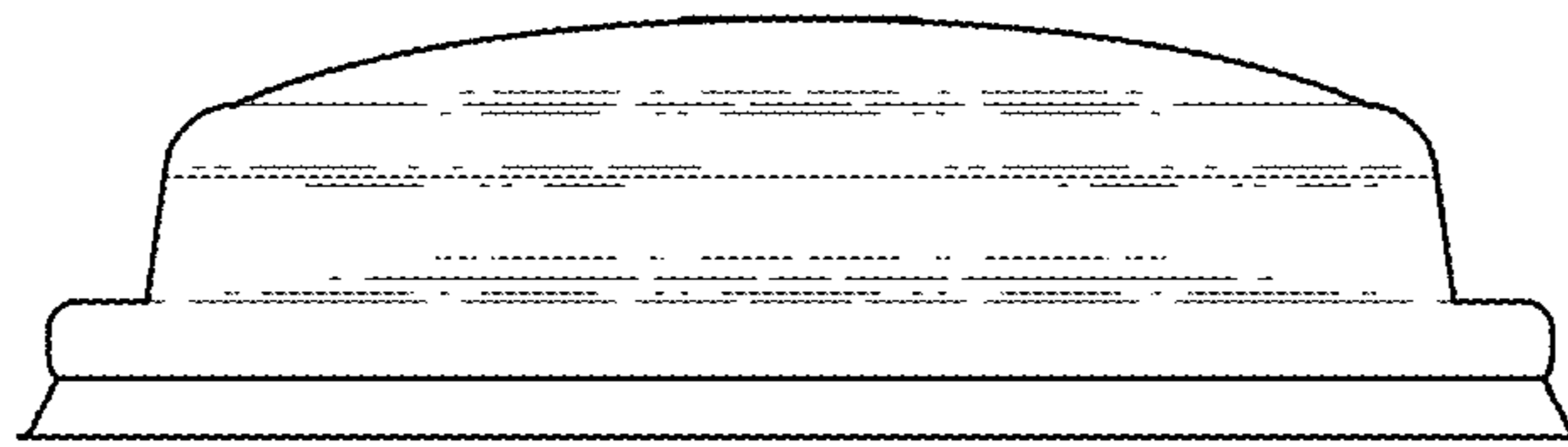

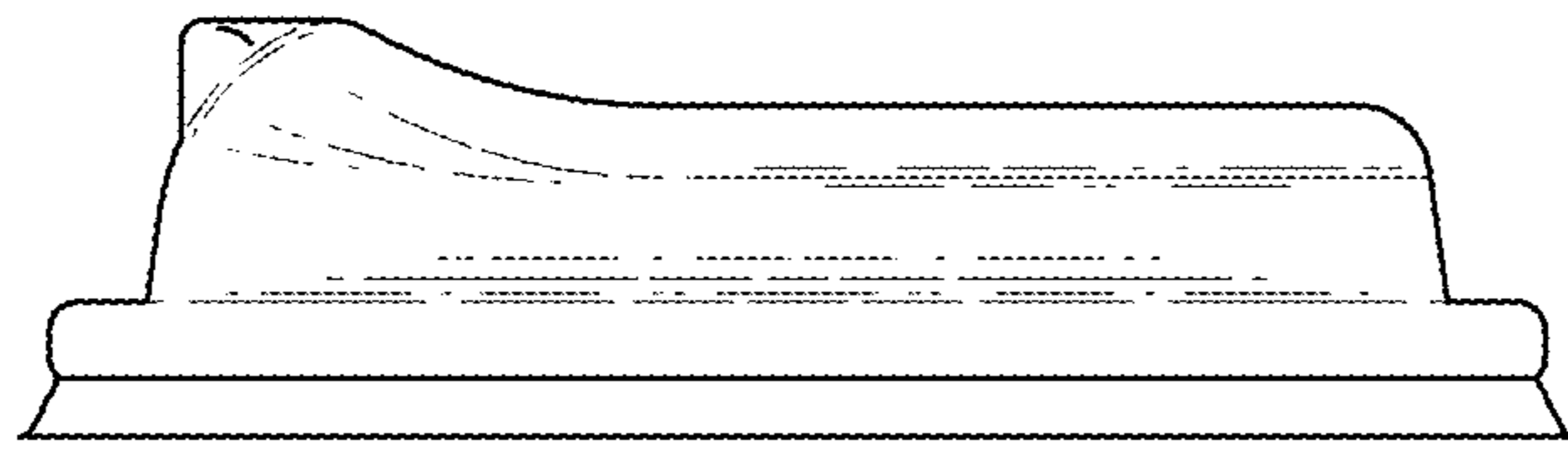

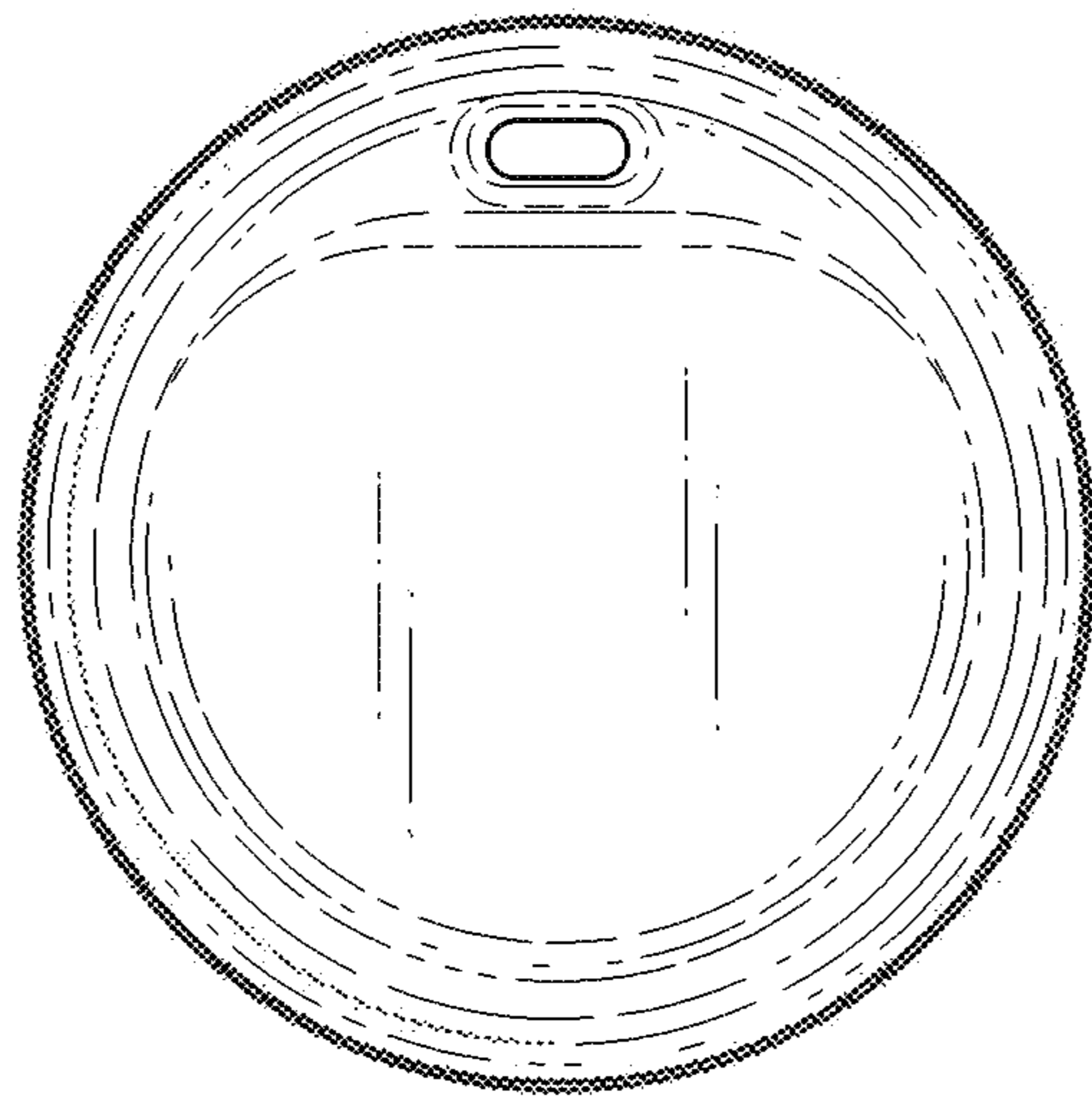

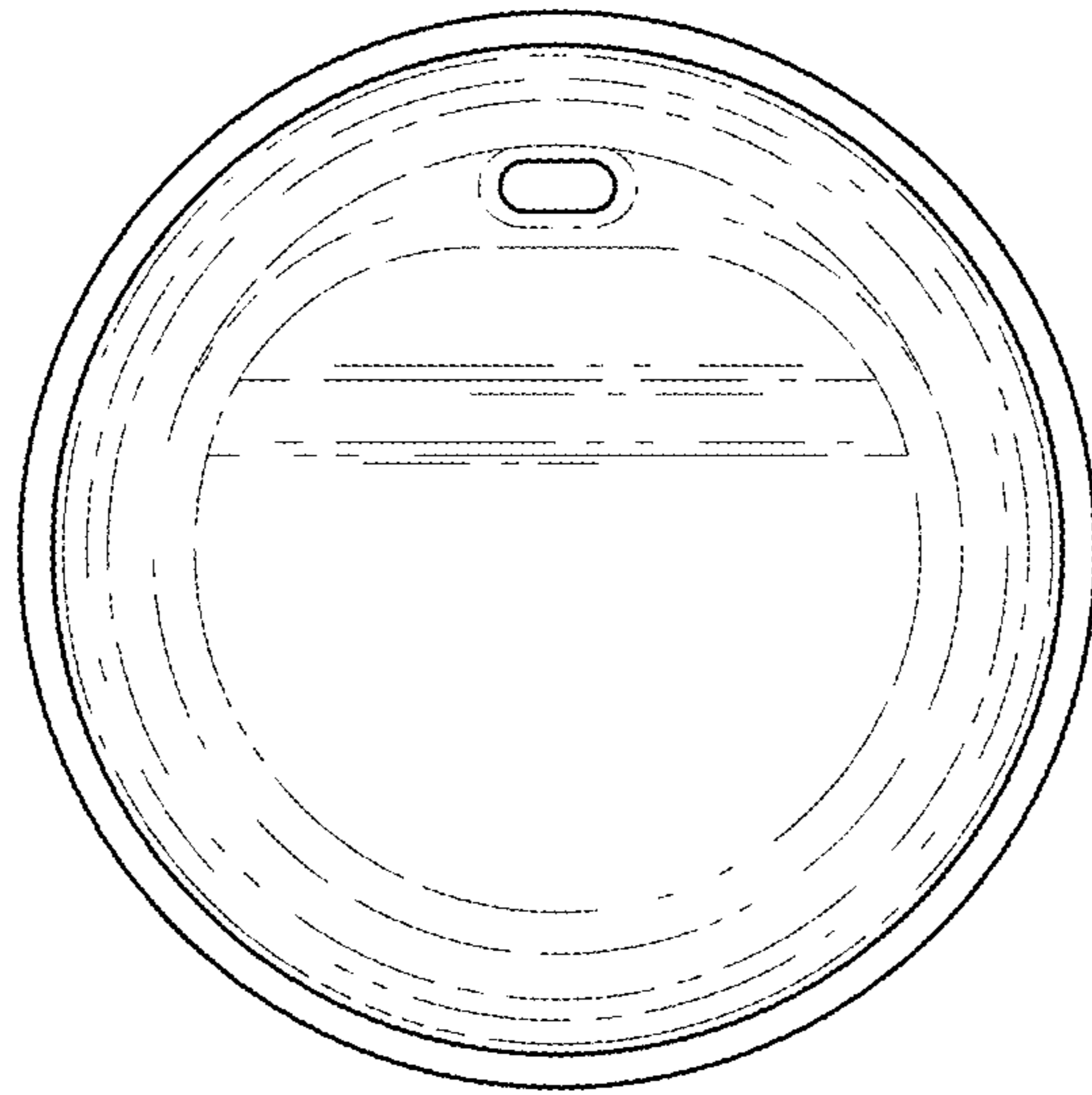

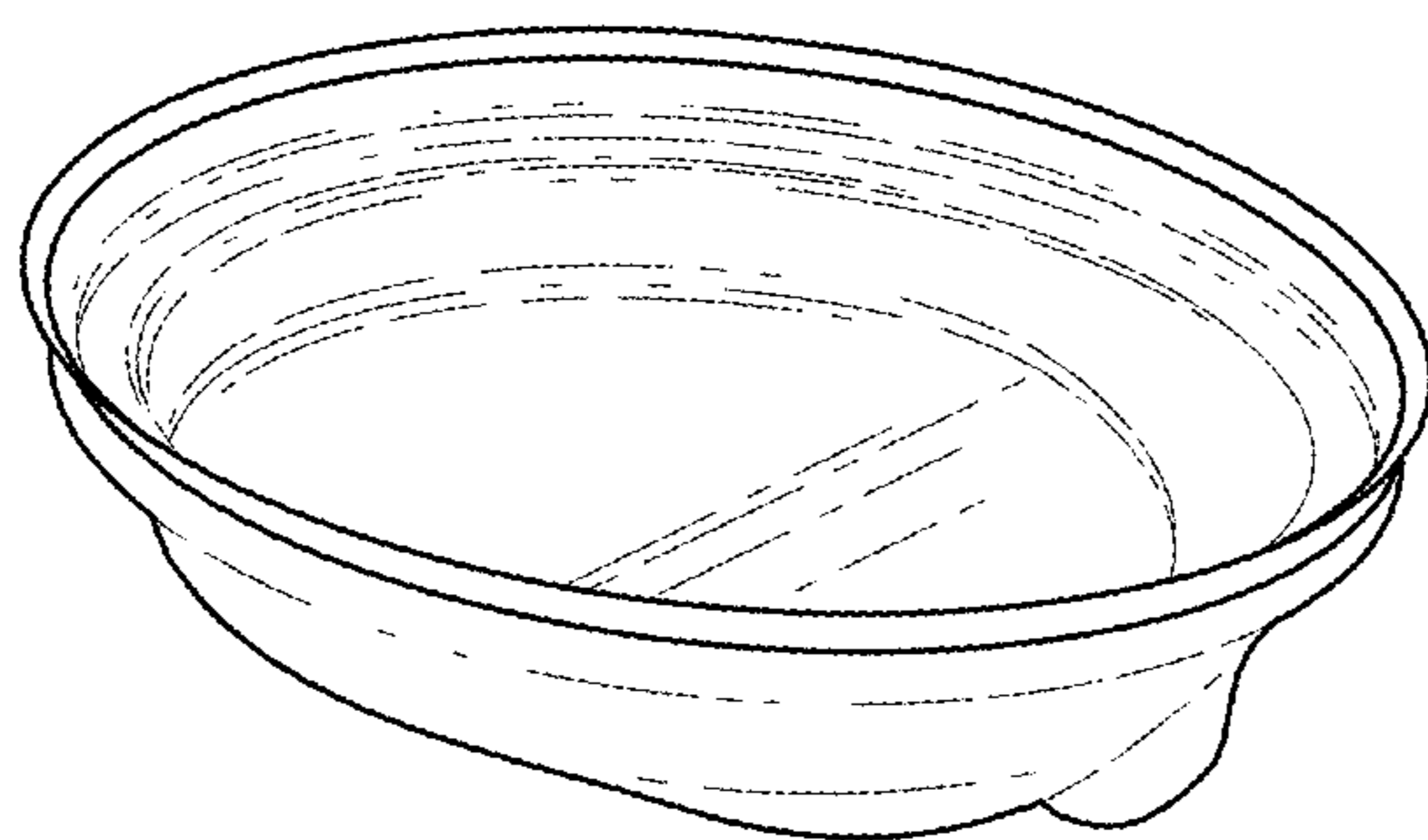

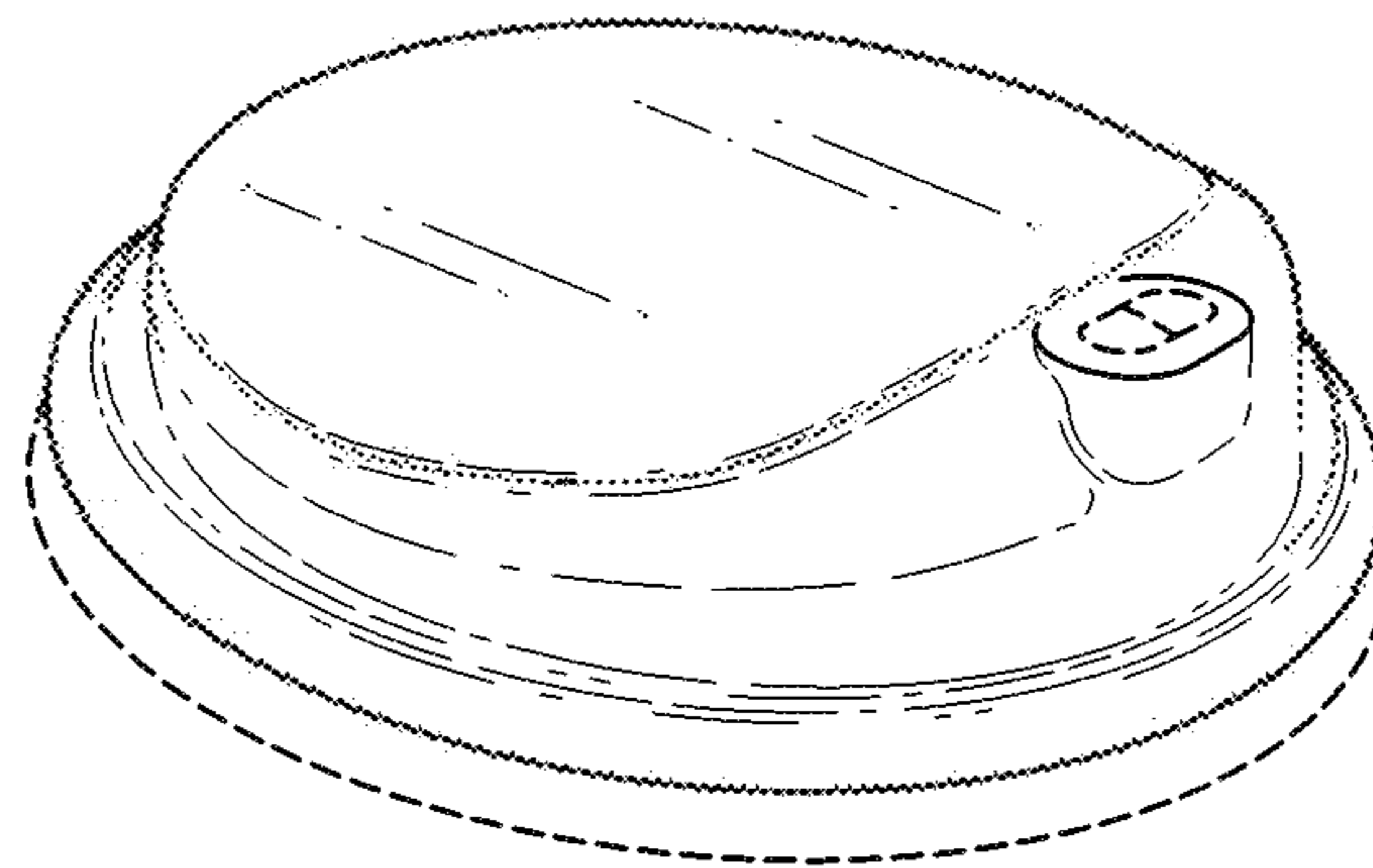

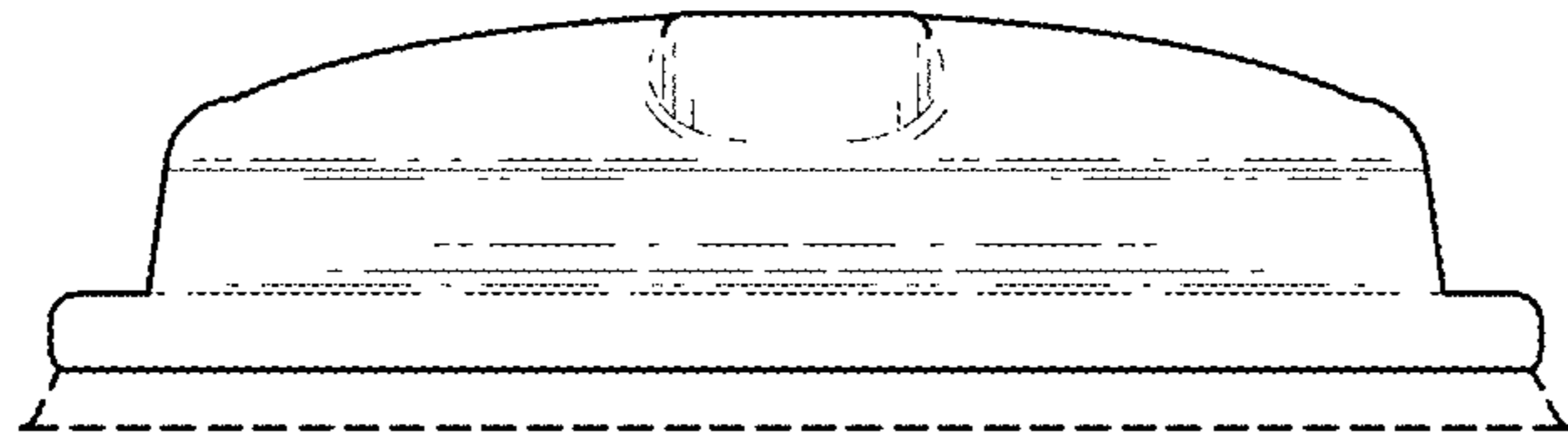

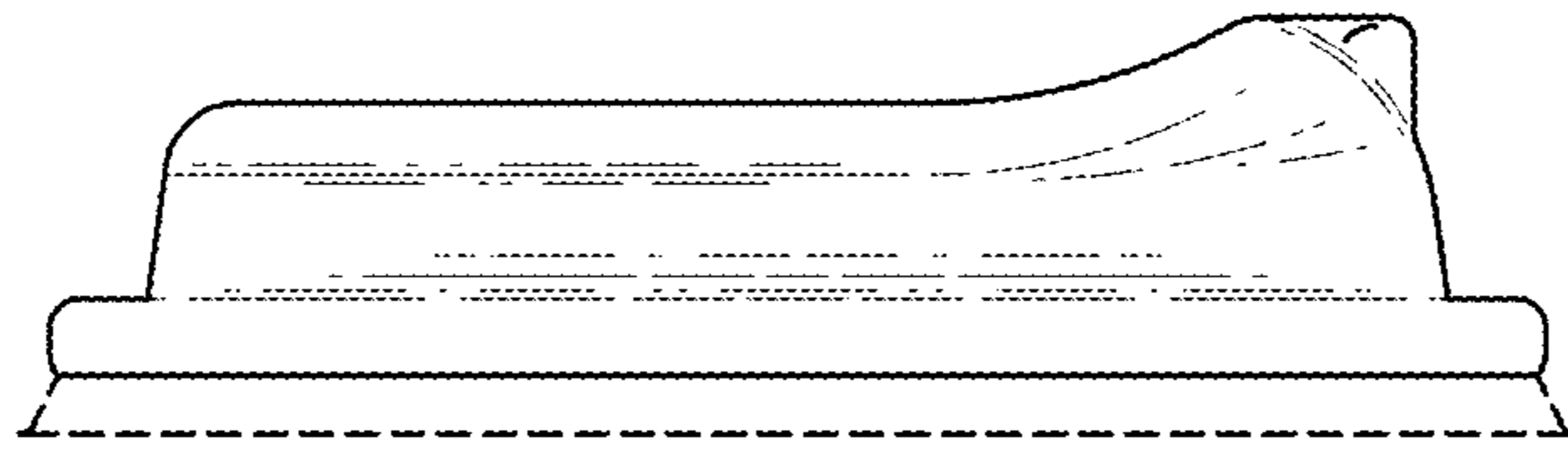

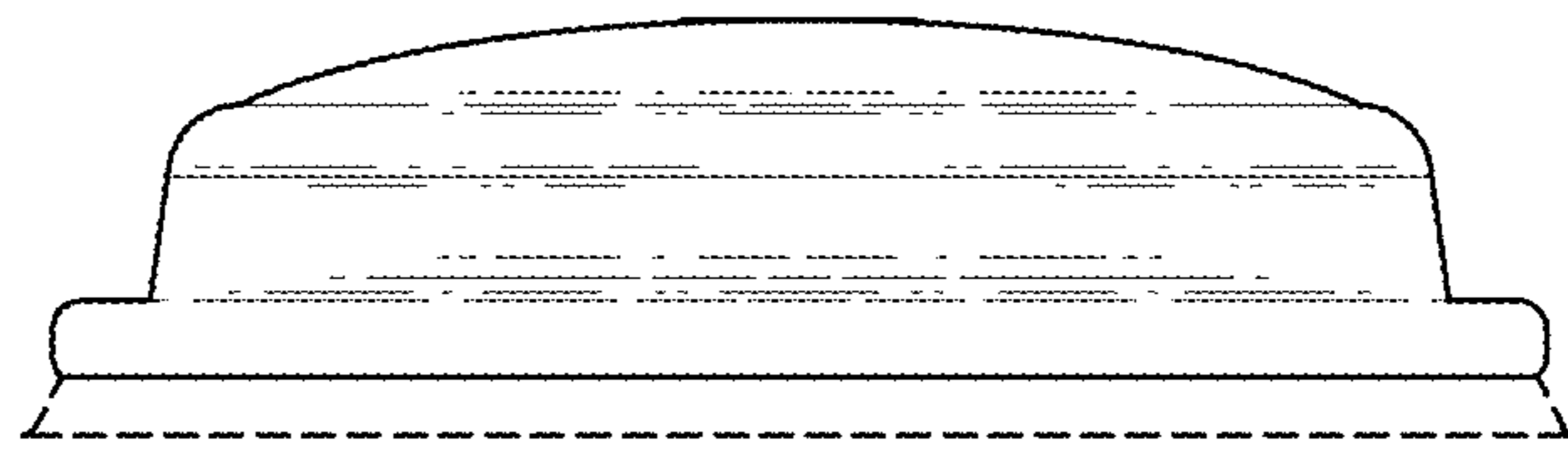

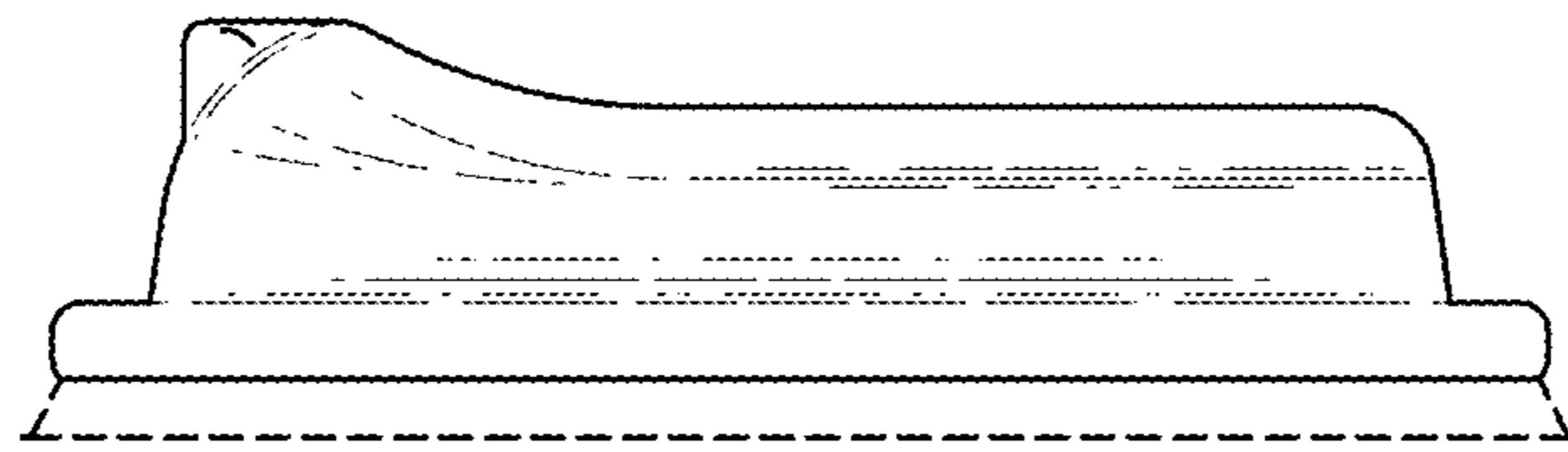

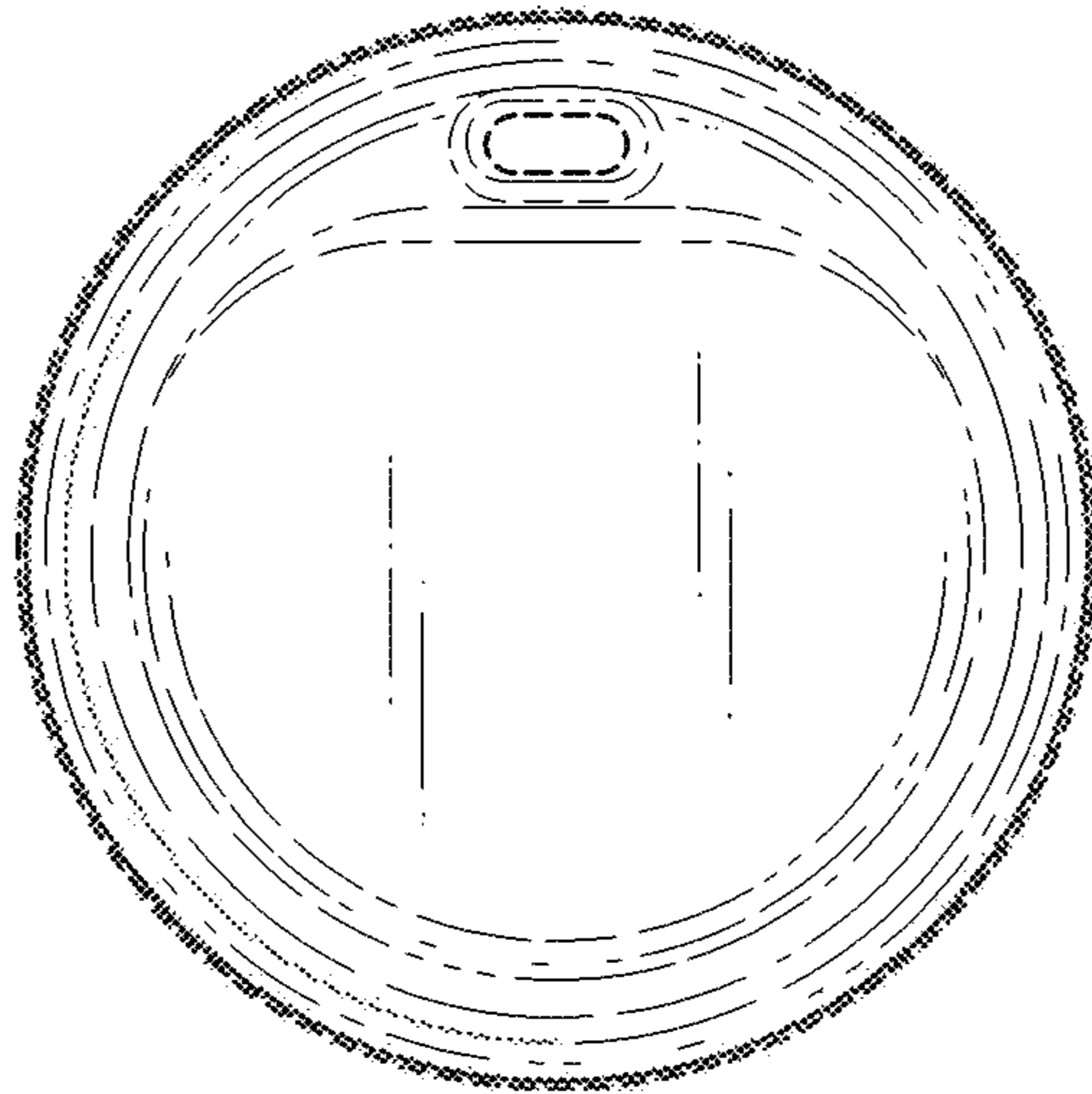

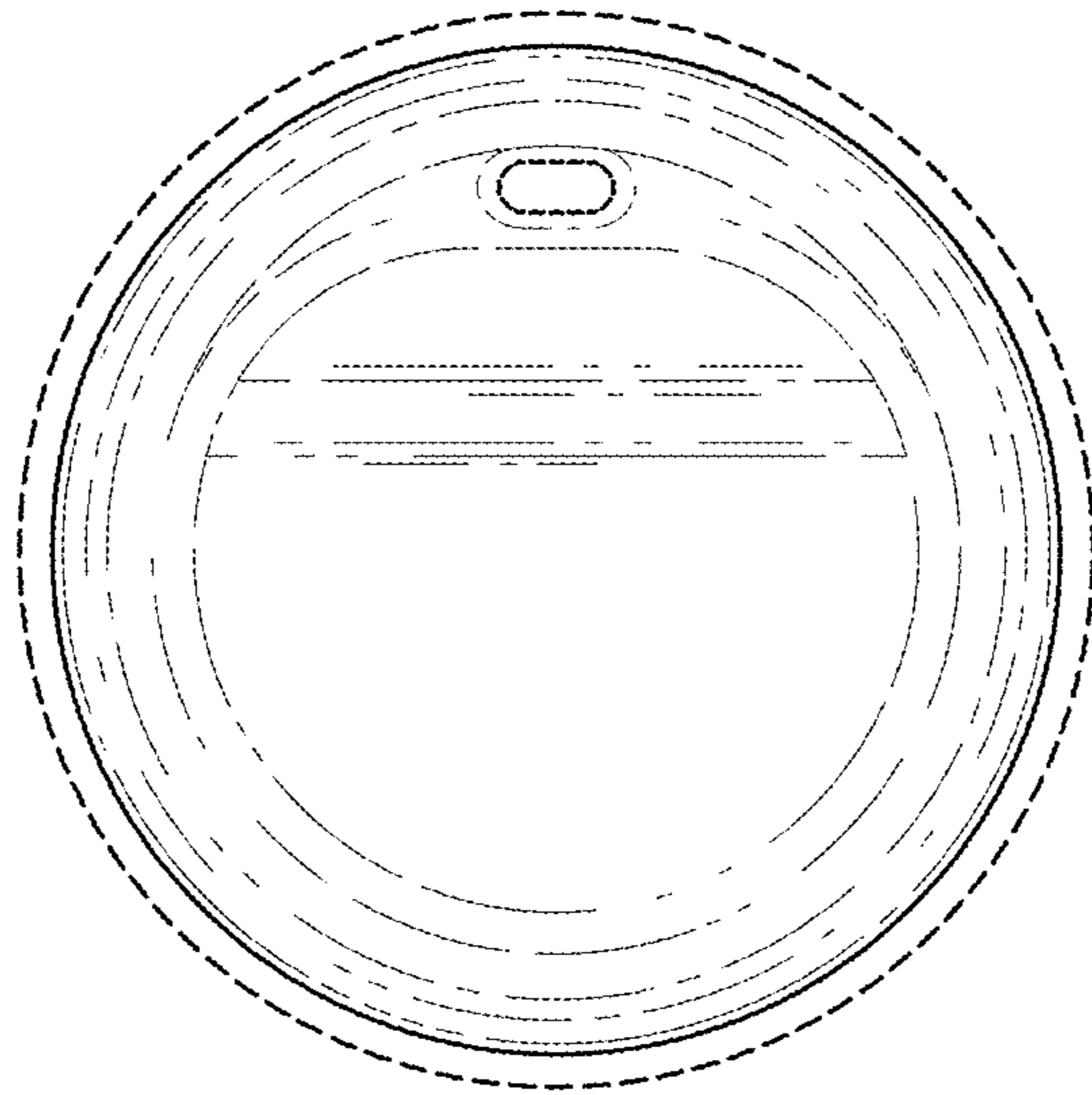

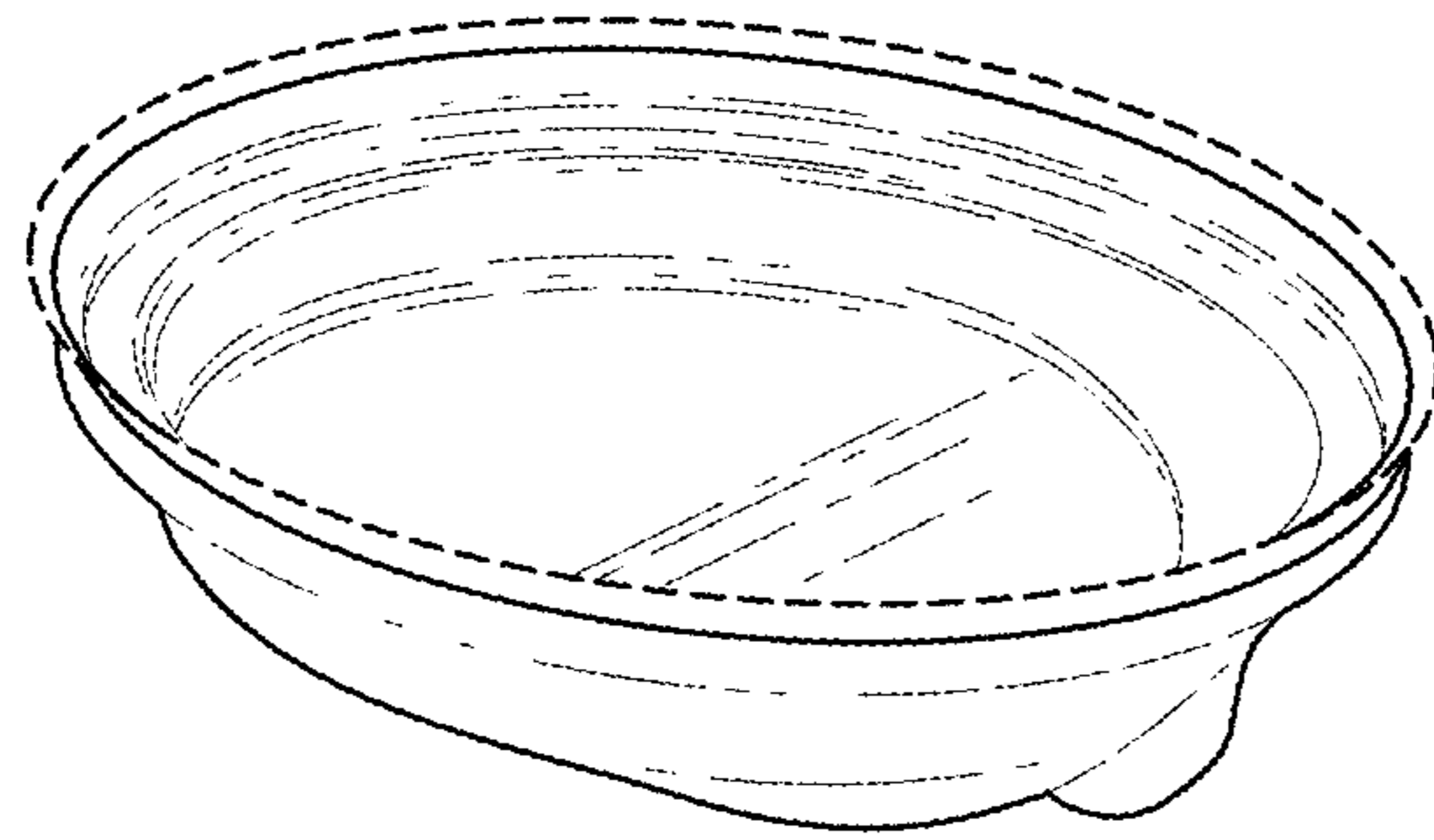
