DESCRIPTION

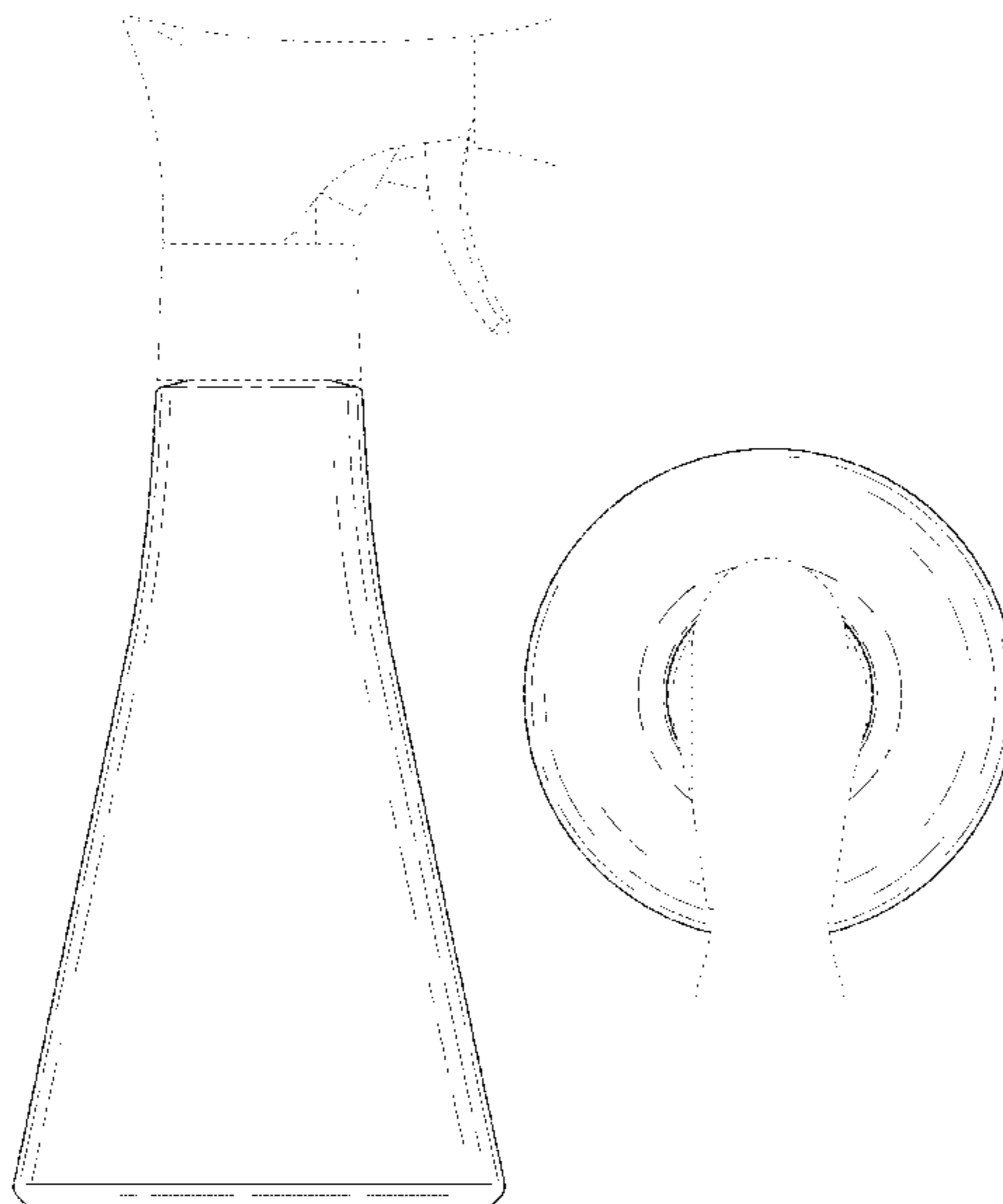
FIG. 1 is a top perspective view of a bottle showing my new design;

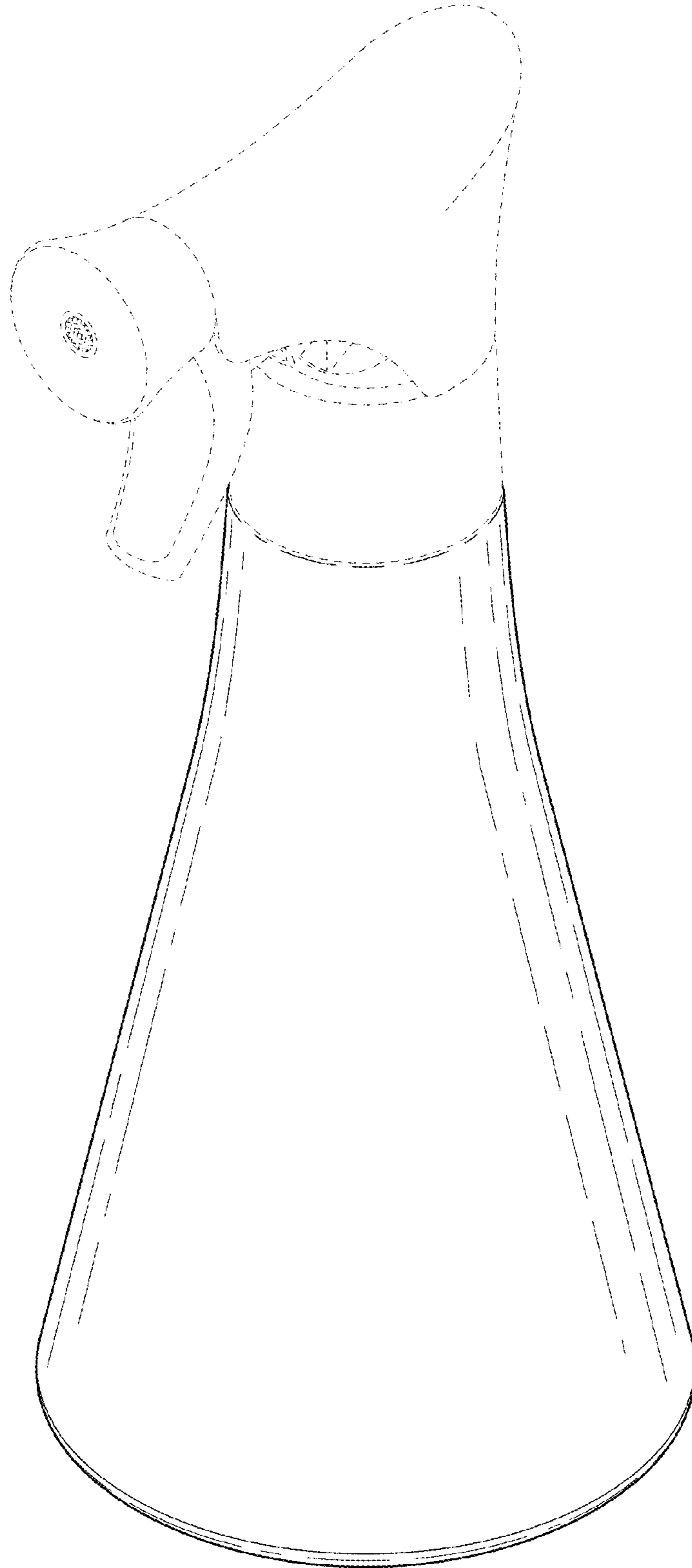

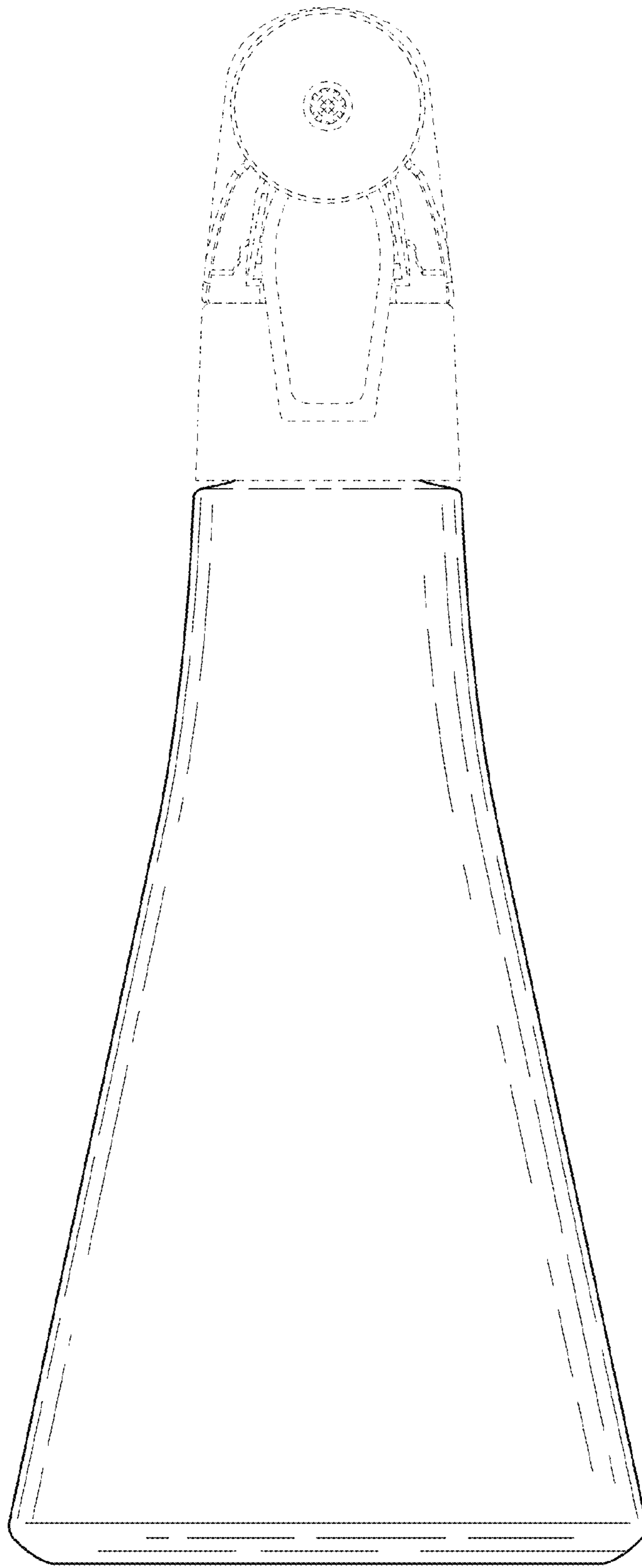

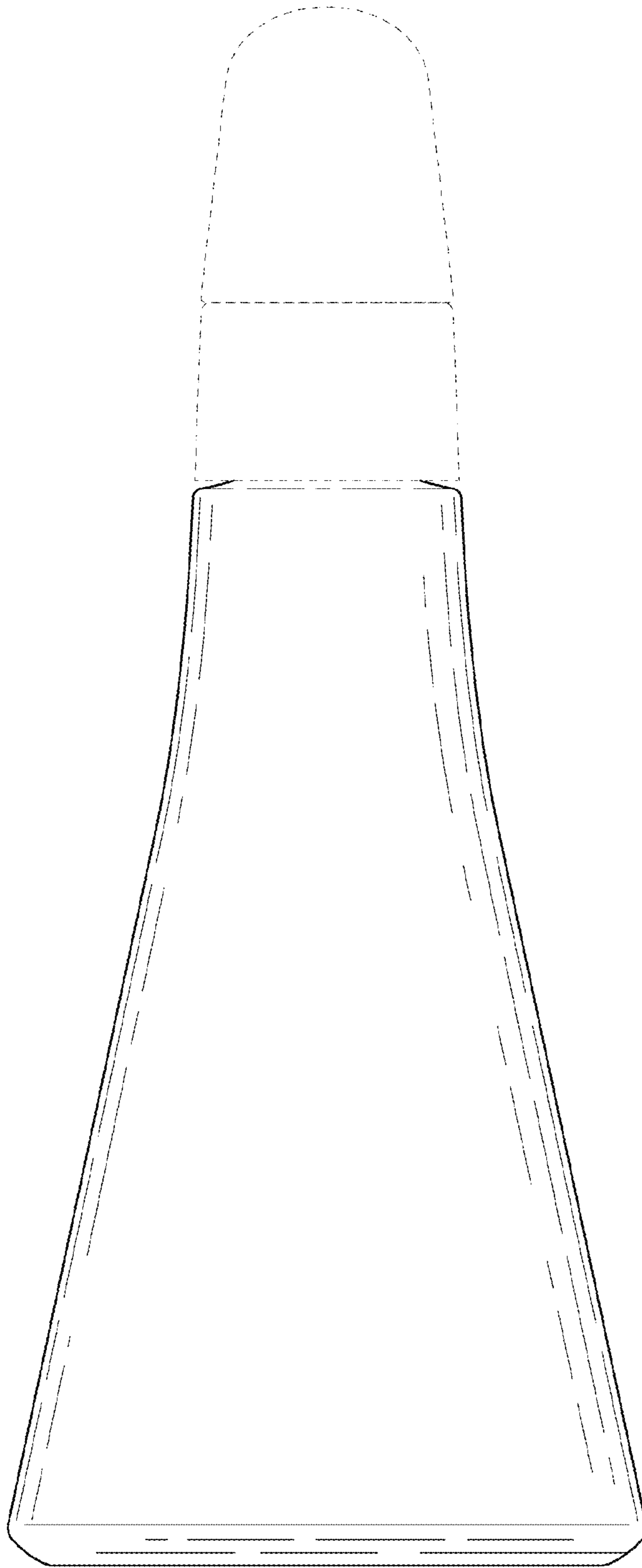

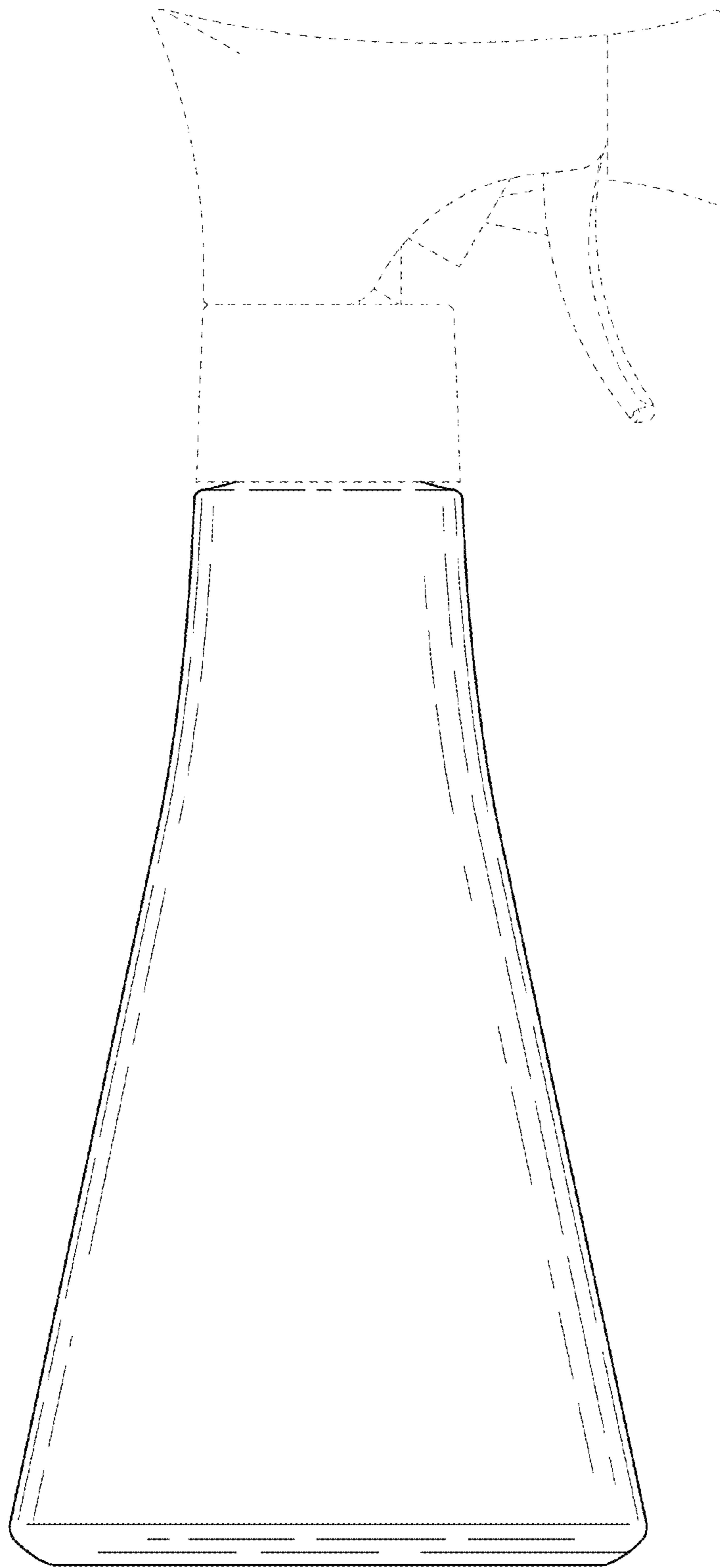

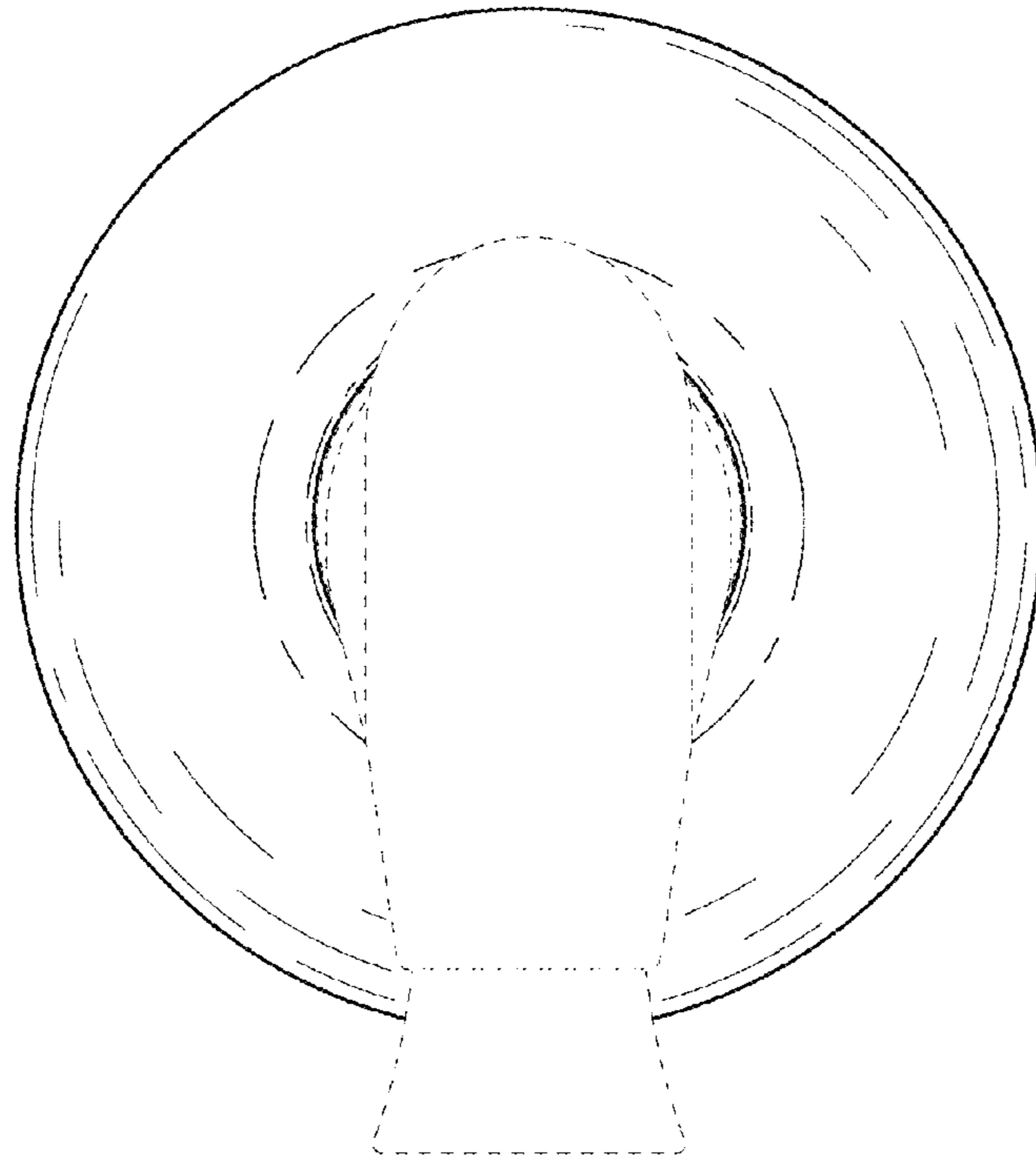

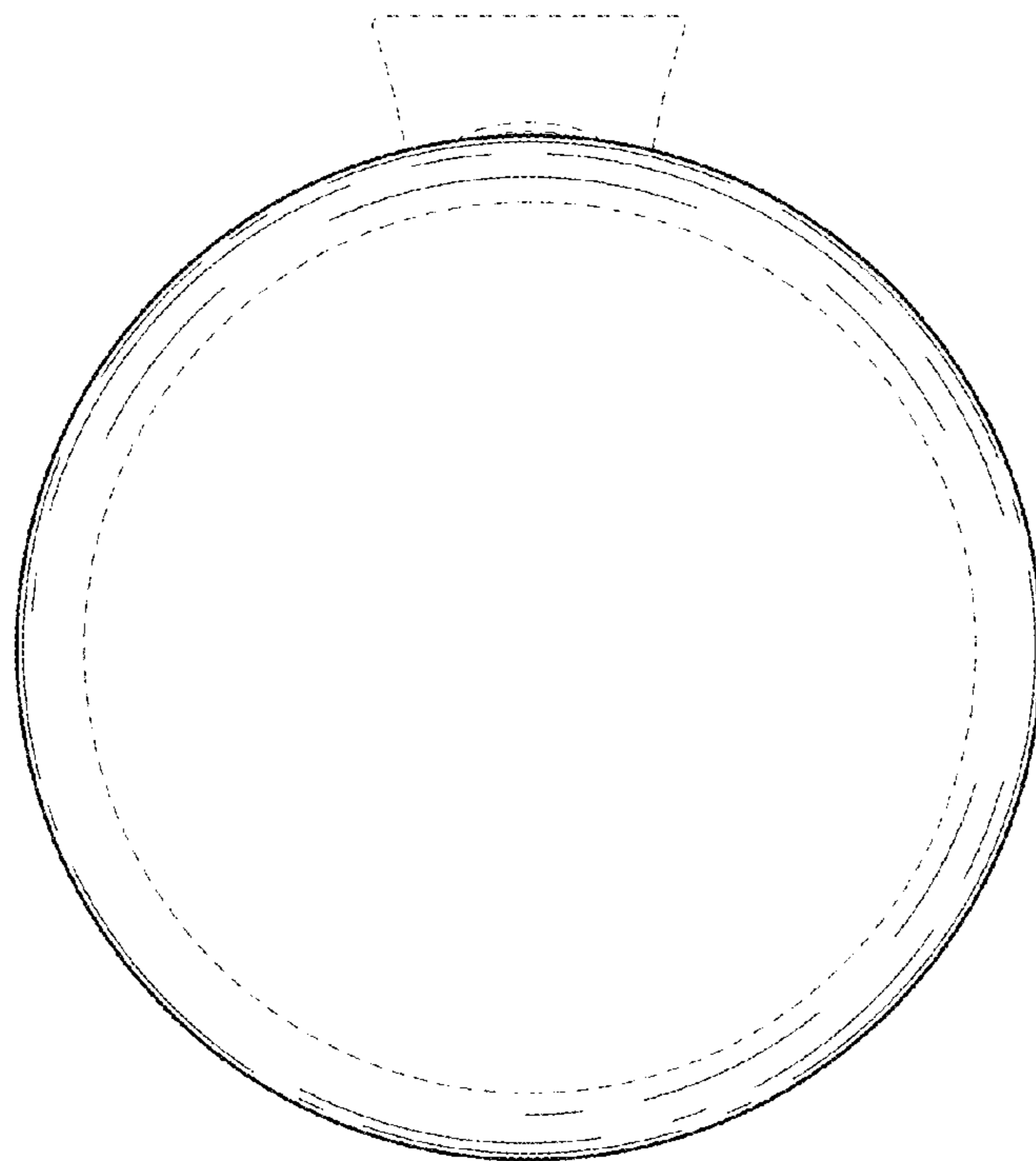
