FIG. 1 is a top plan view of a keyboard showing my new design;

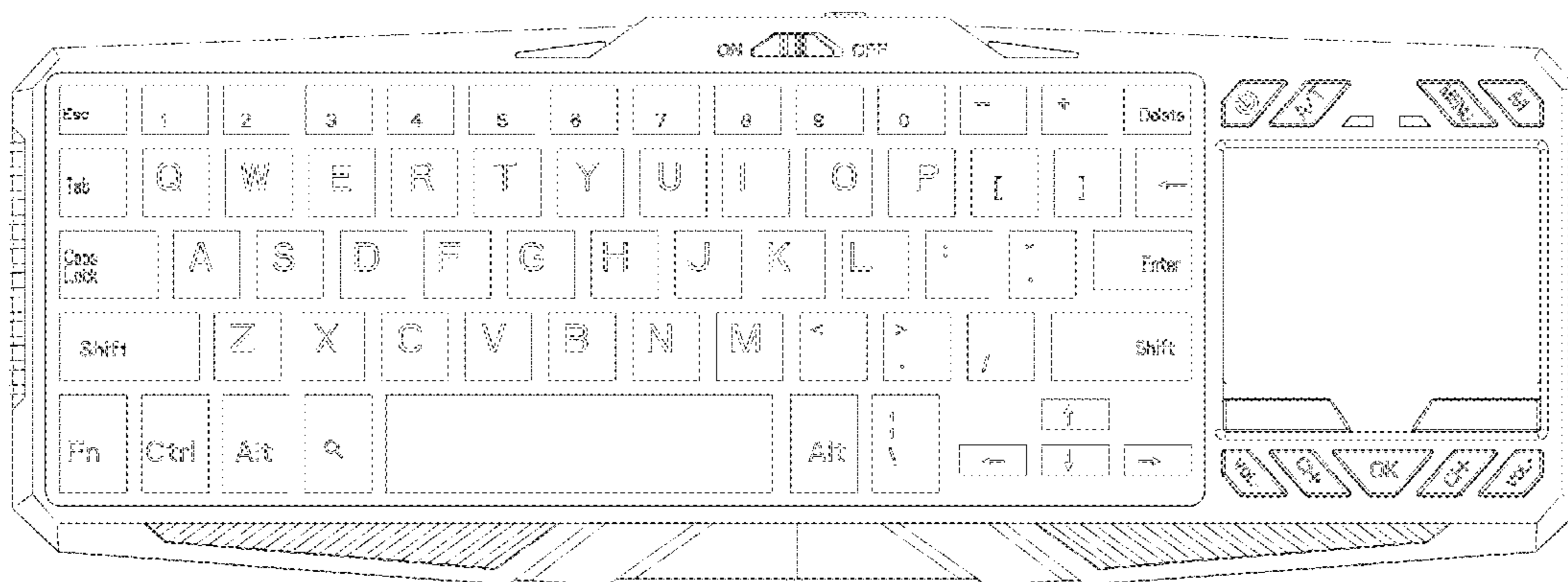
FIG. 2 is a first perspective view thereof;

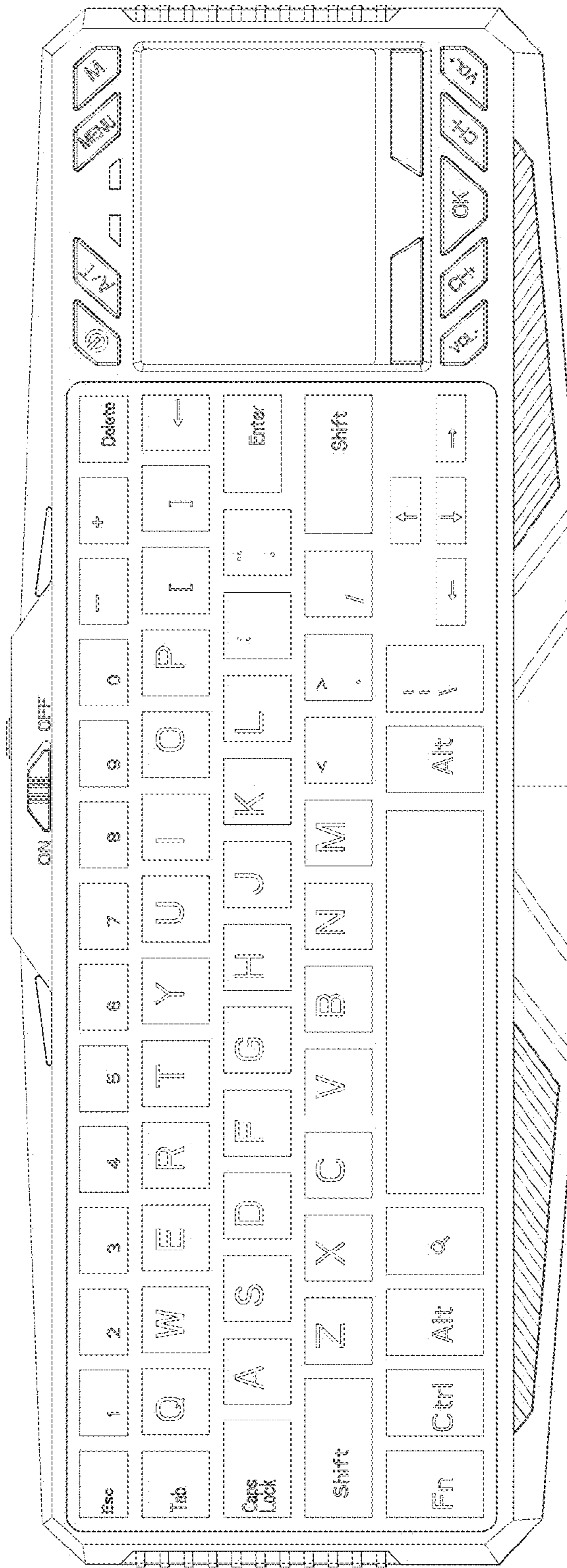

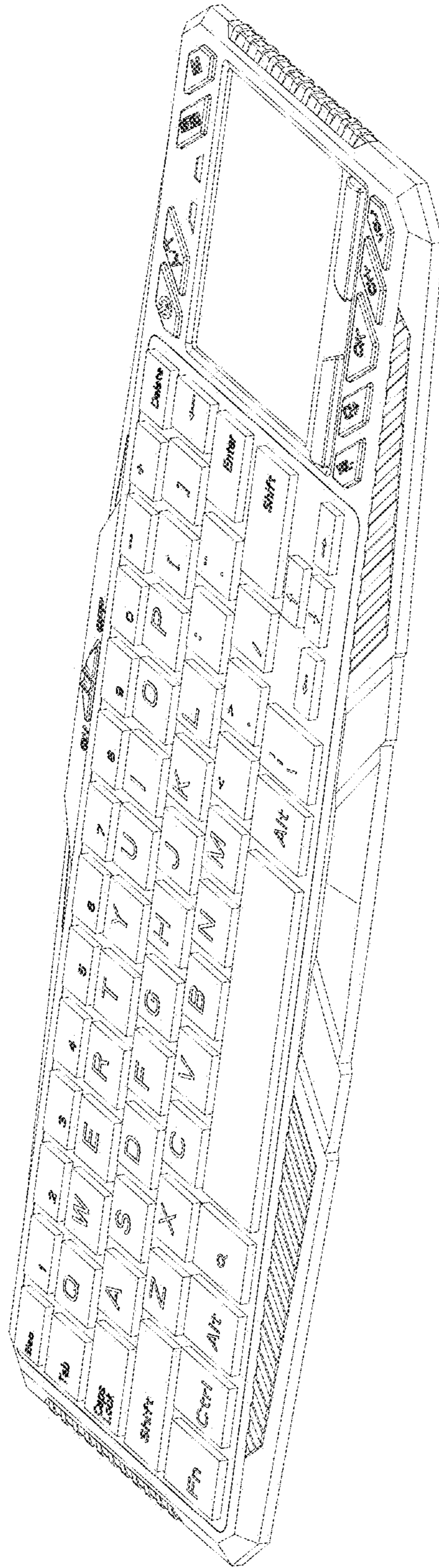

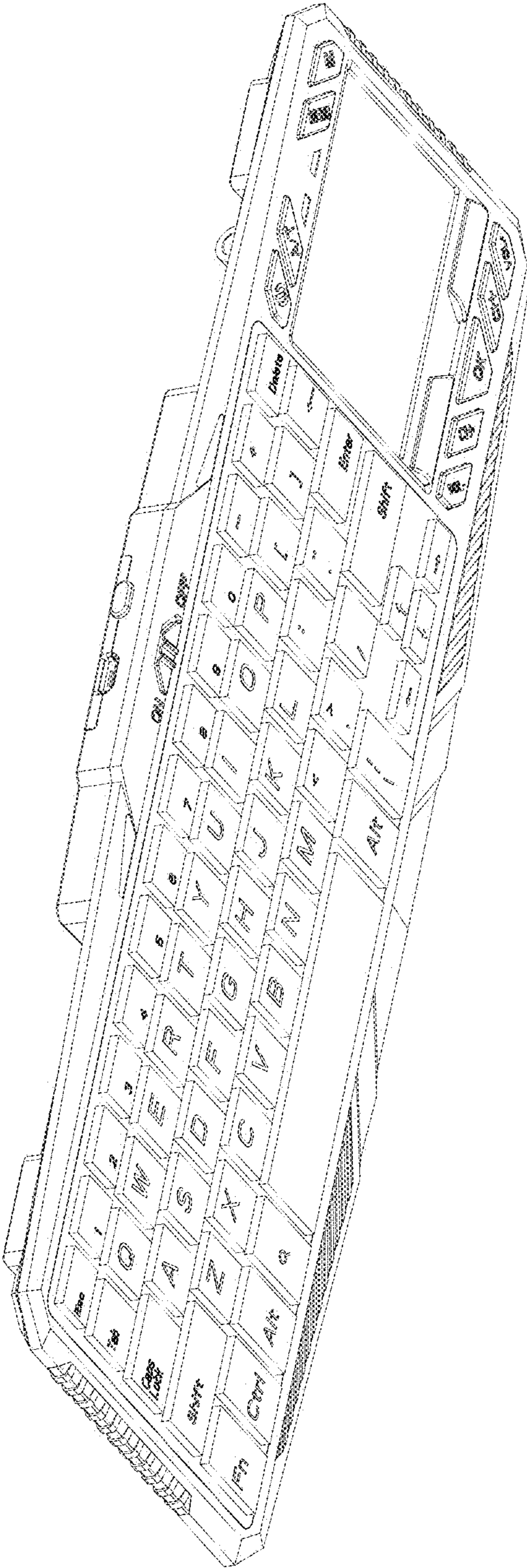

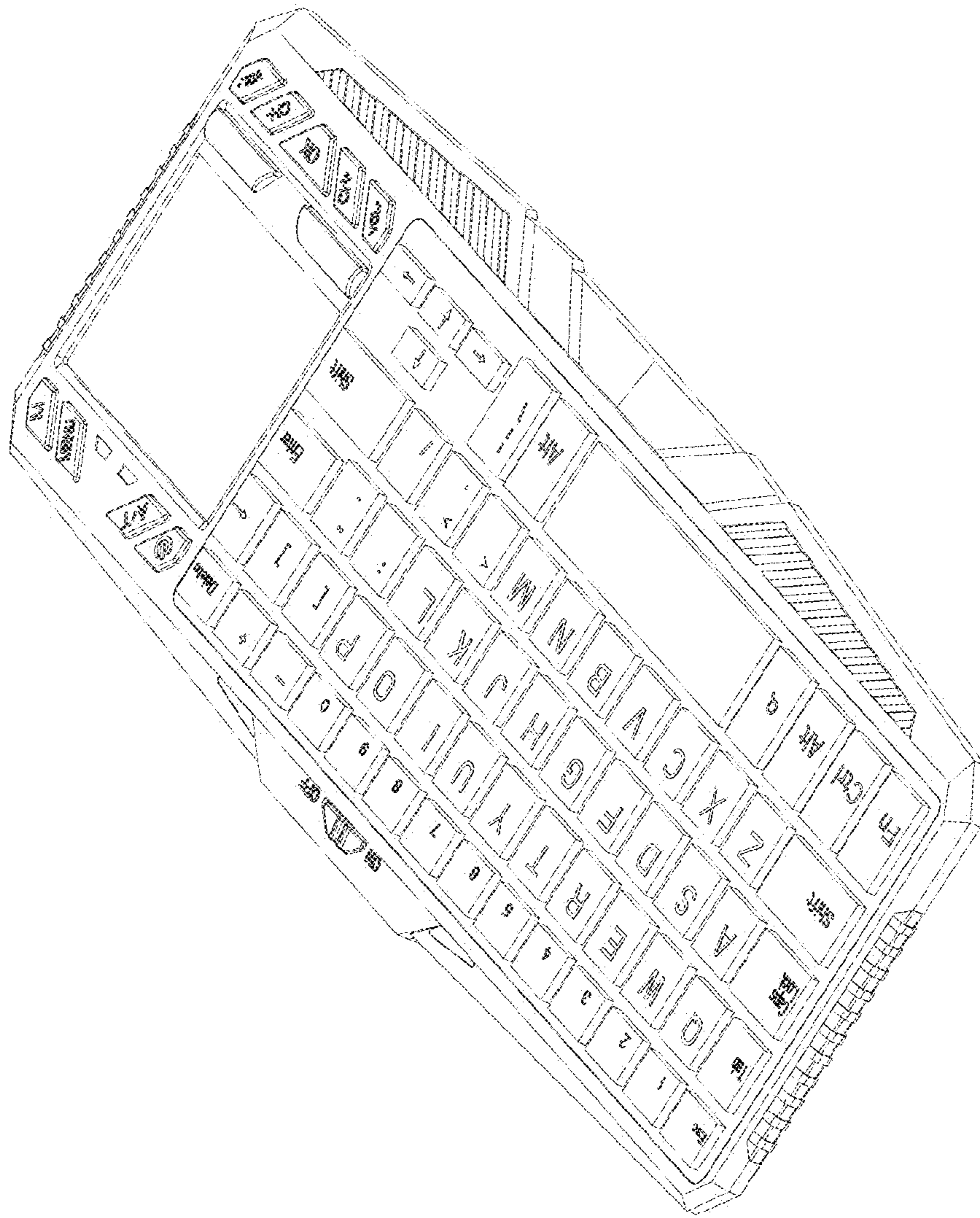

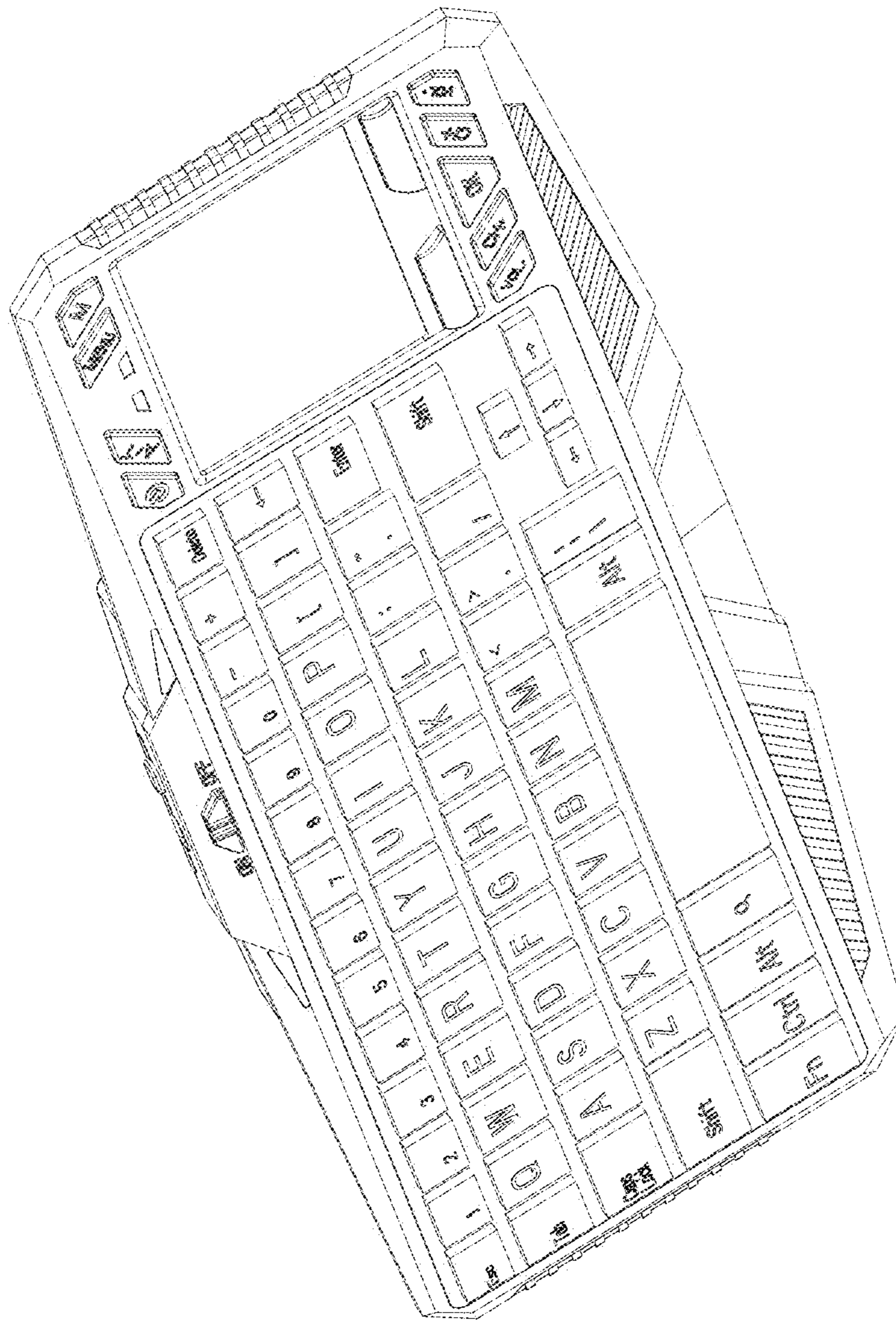
