(57) **CLAIM**

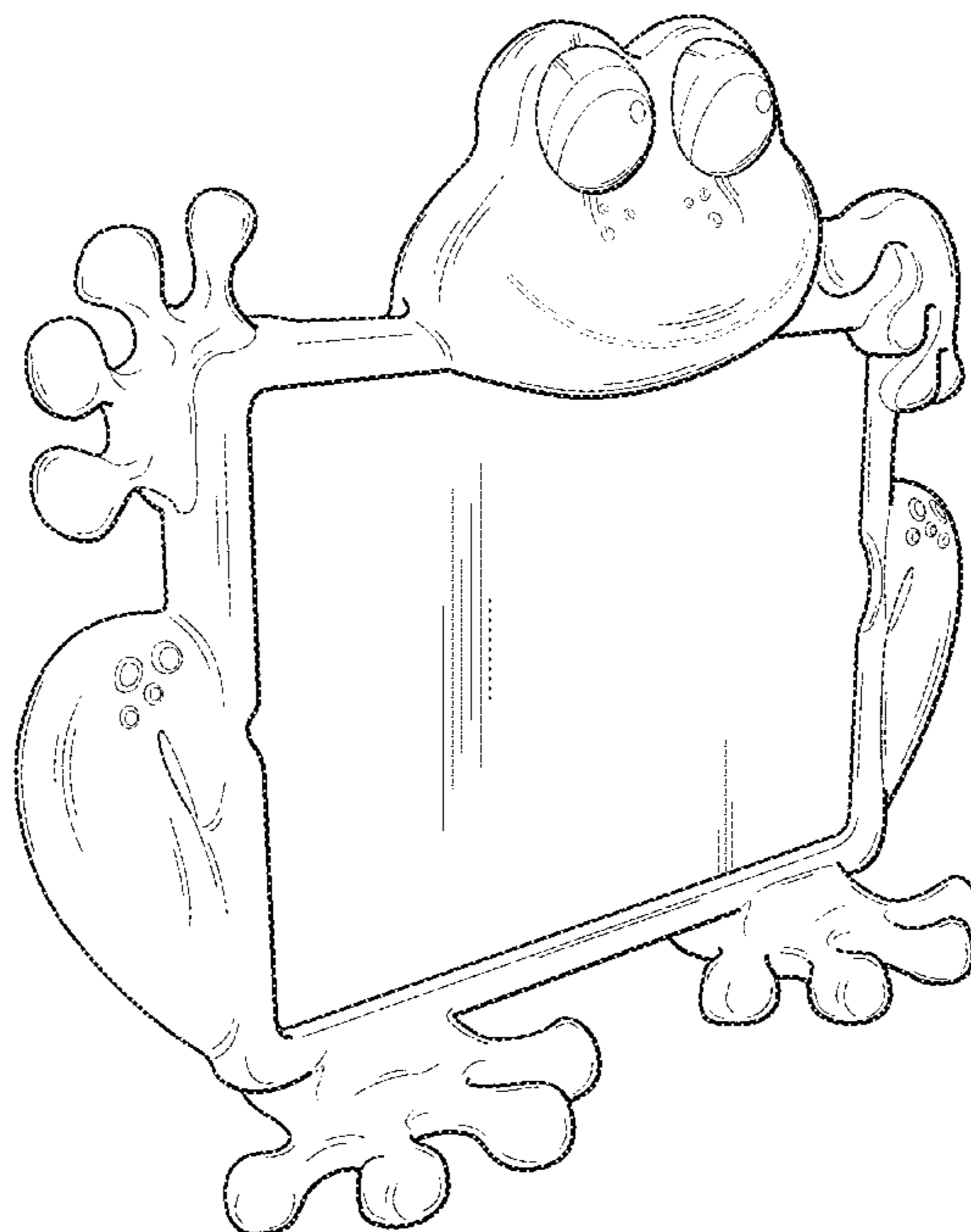
The ornamental design for a cover for a computer tablet, as shown and described.

**DESCRIPTION**

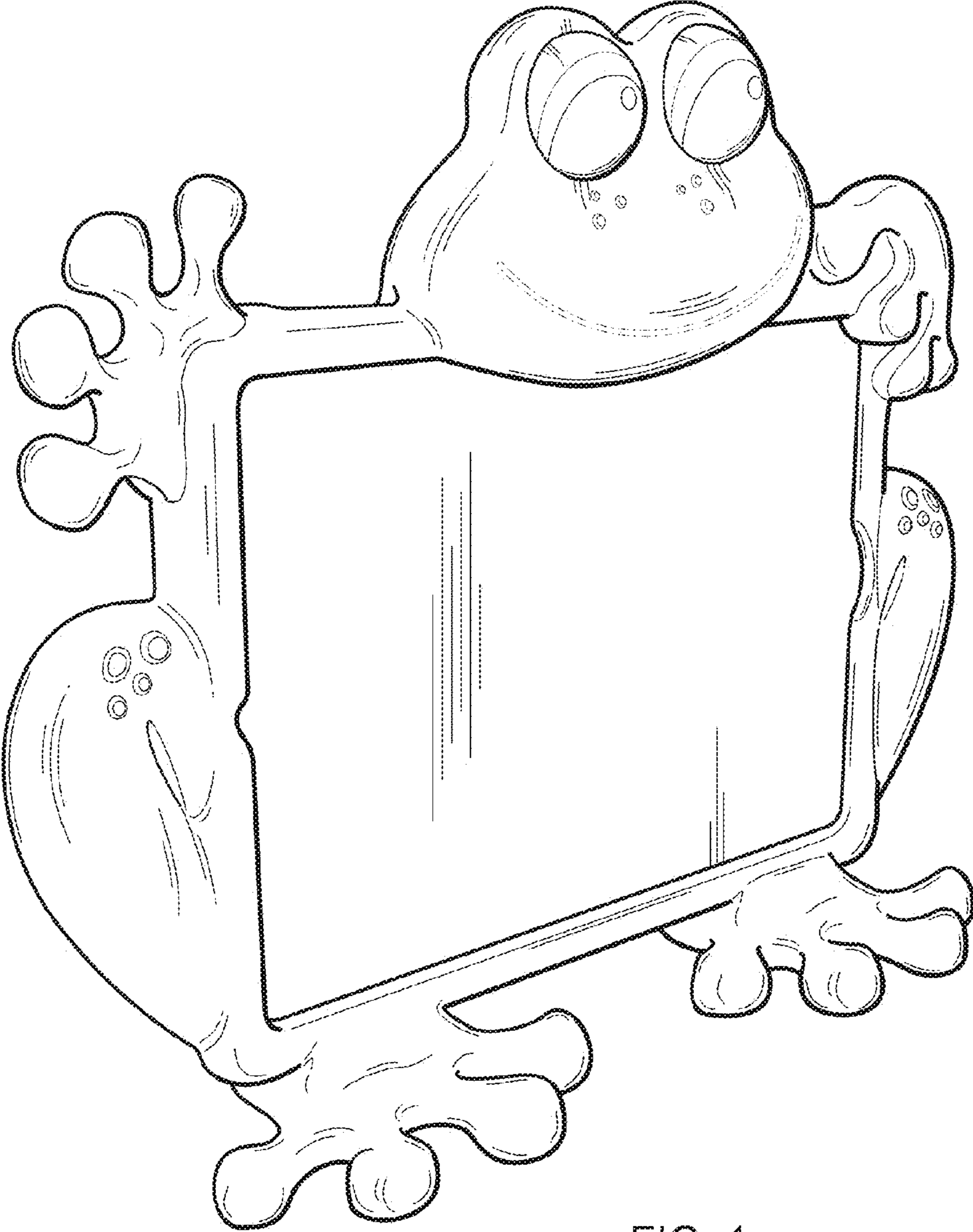

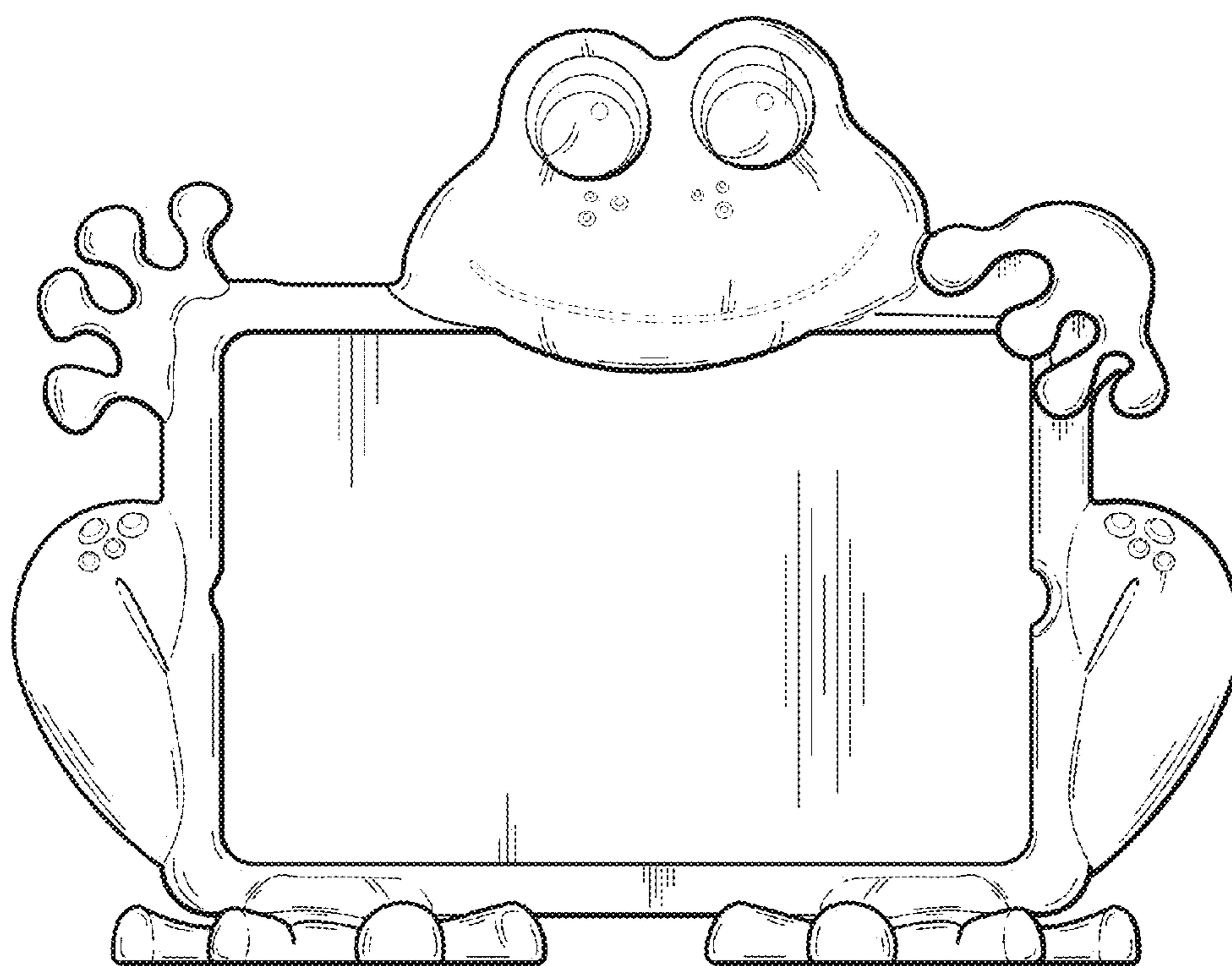

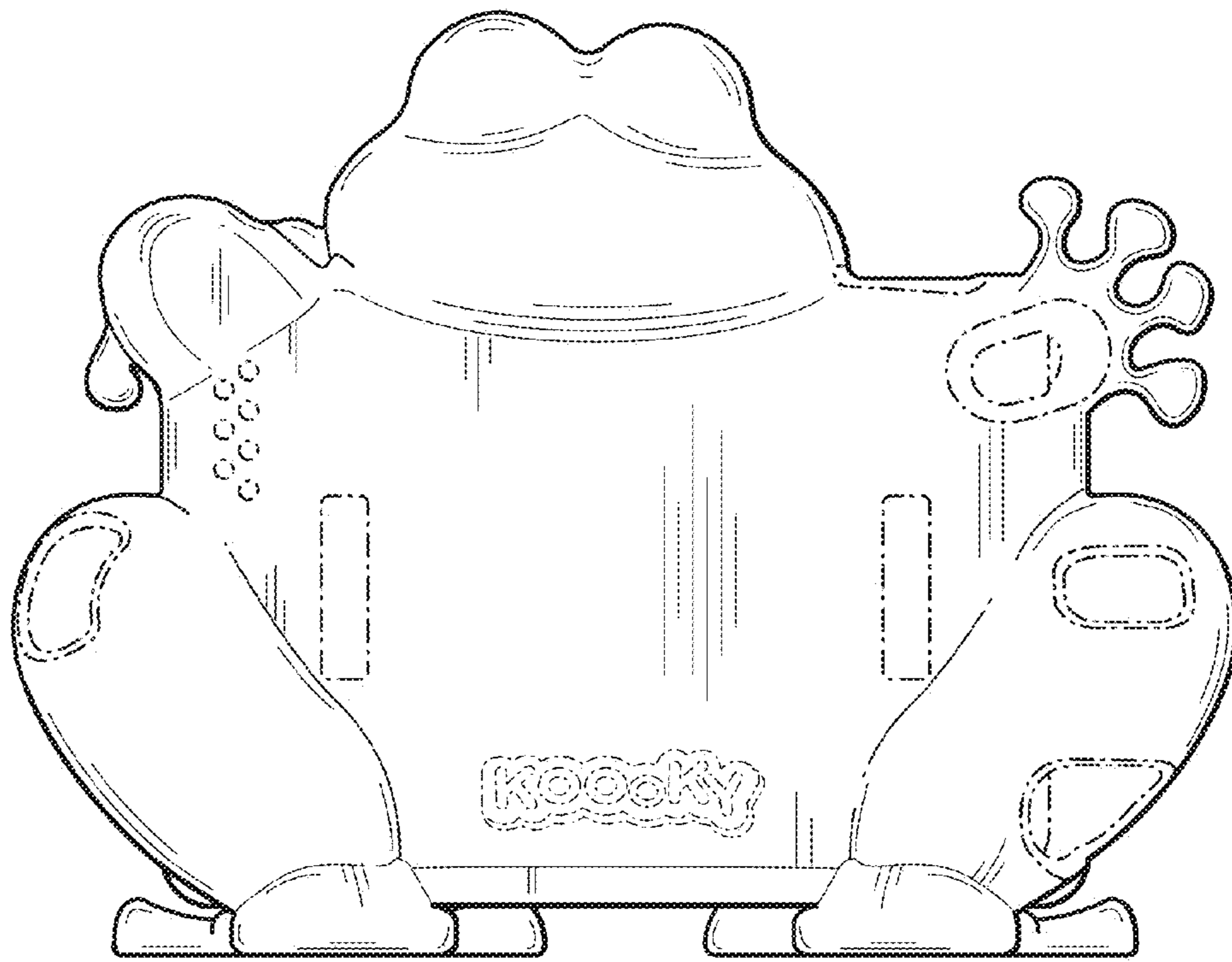

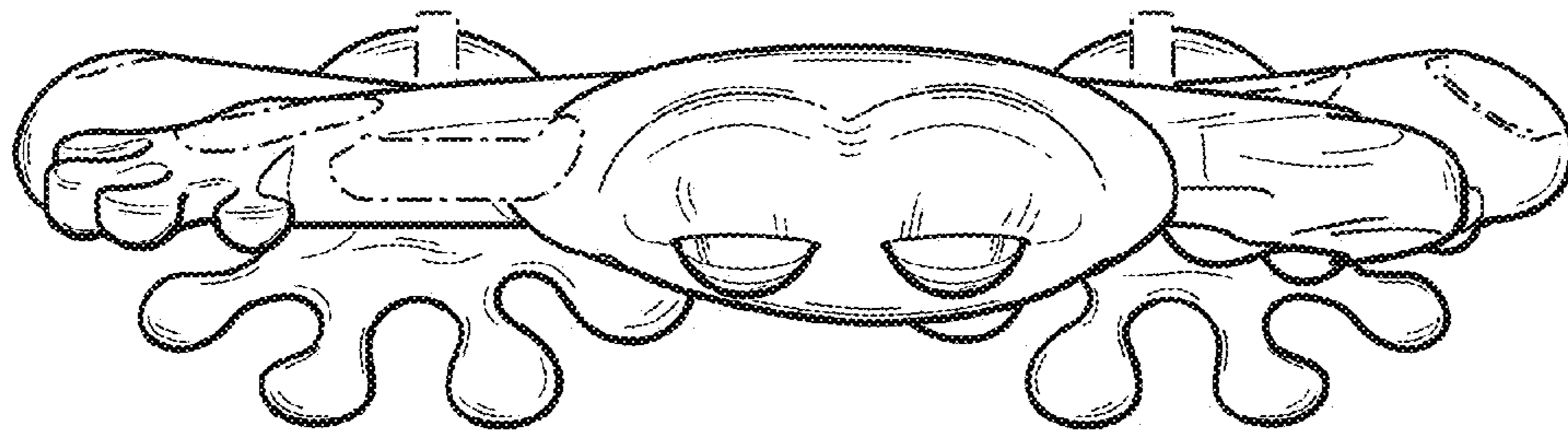

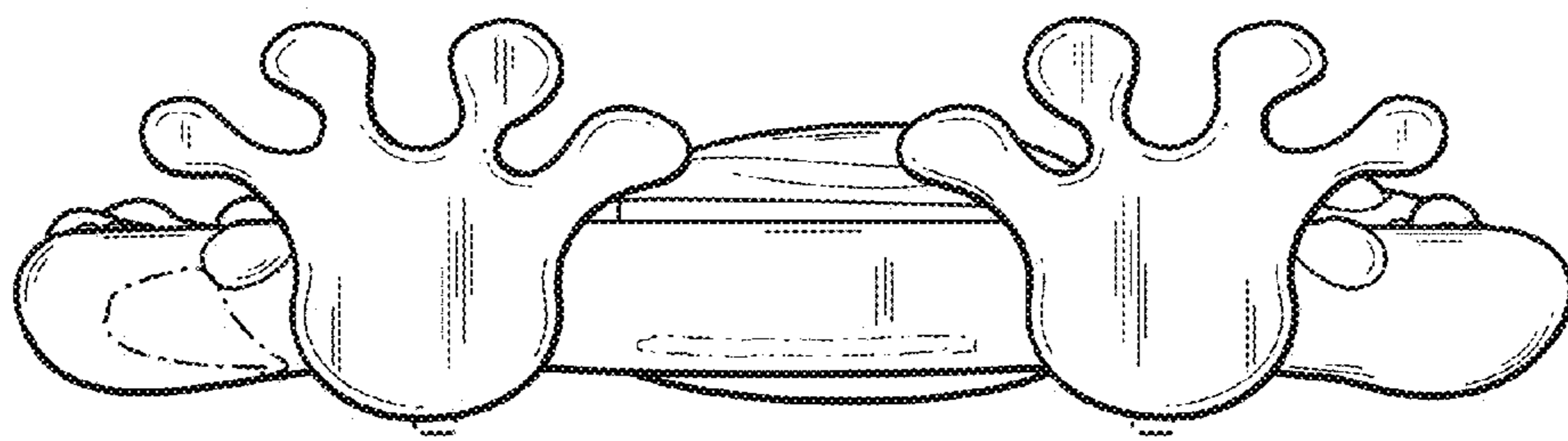

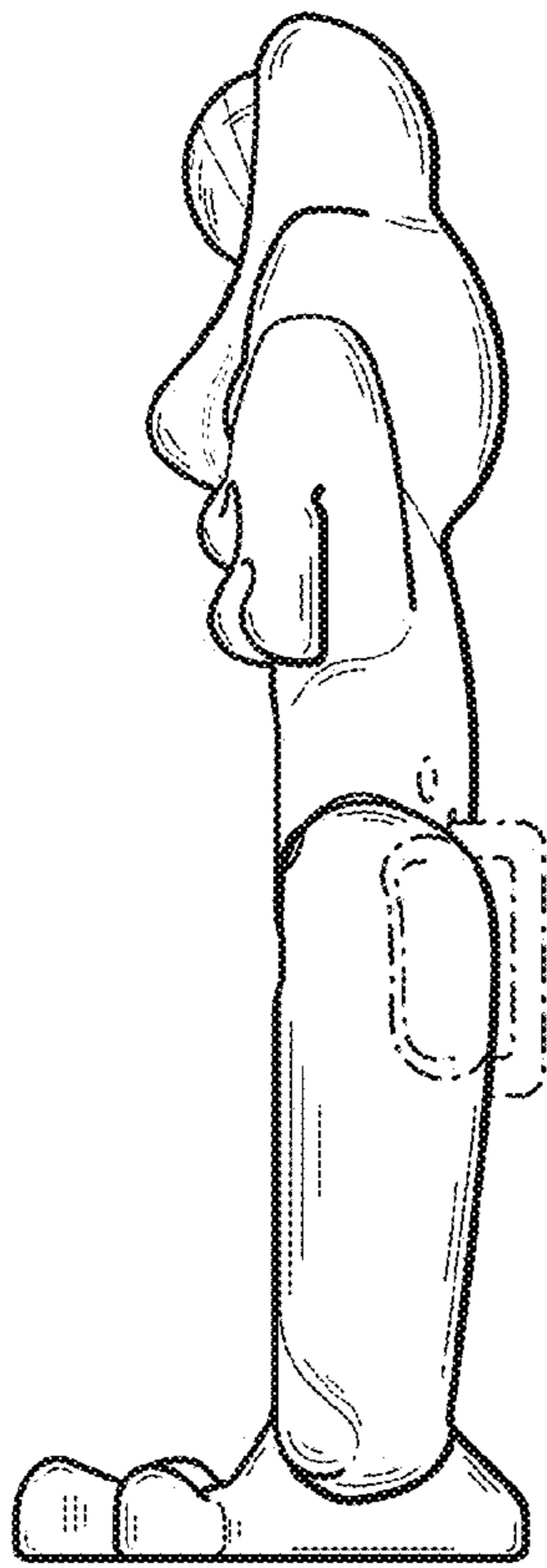

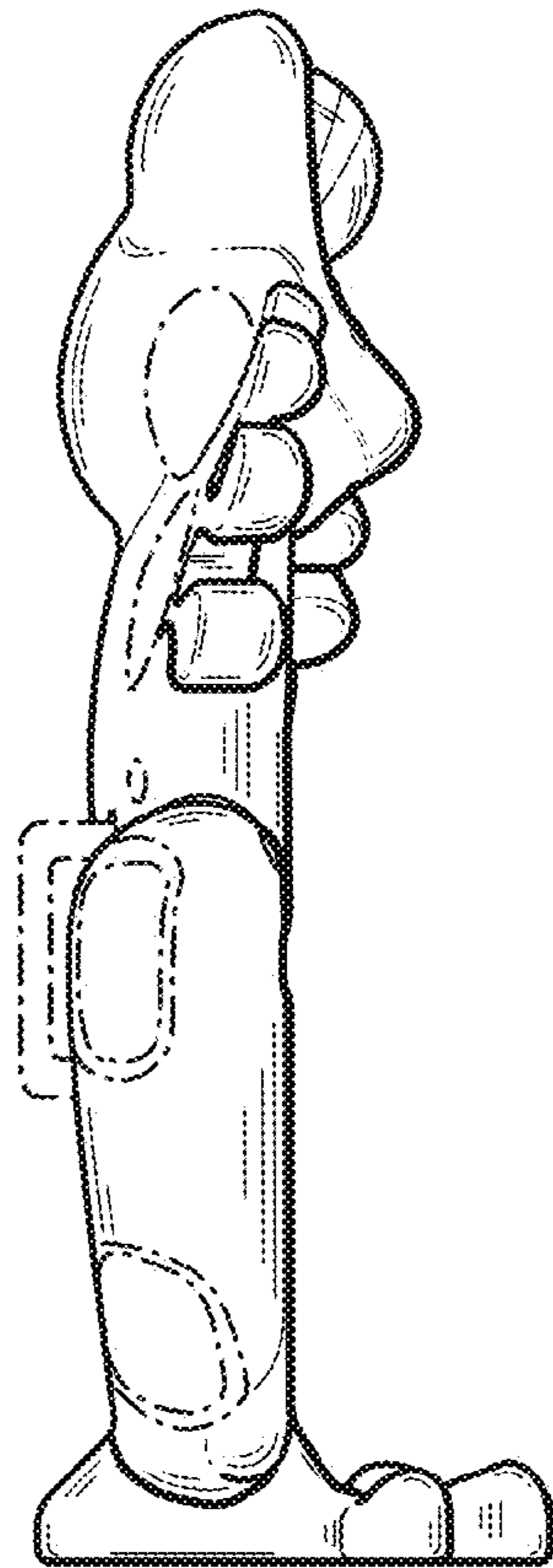
