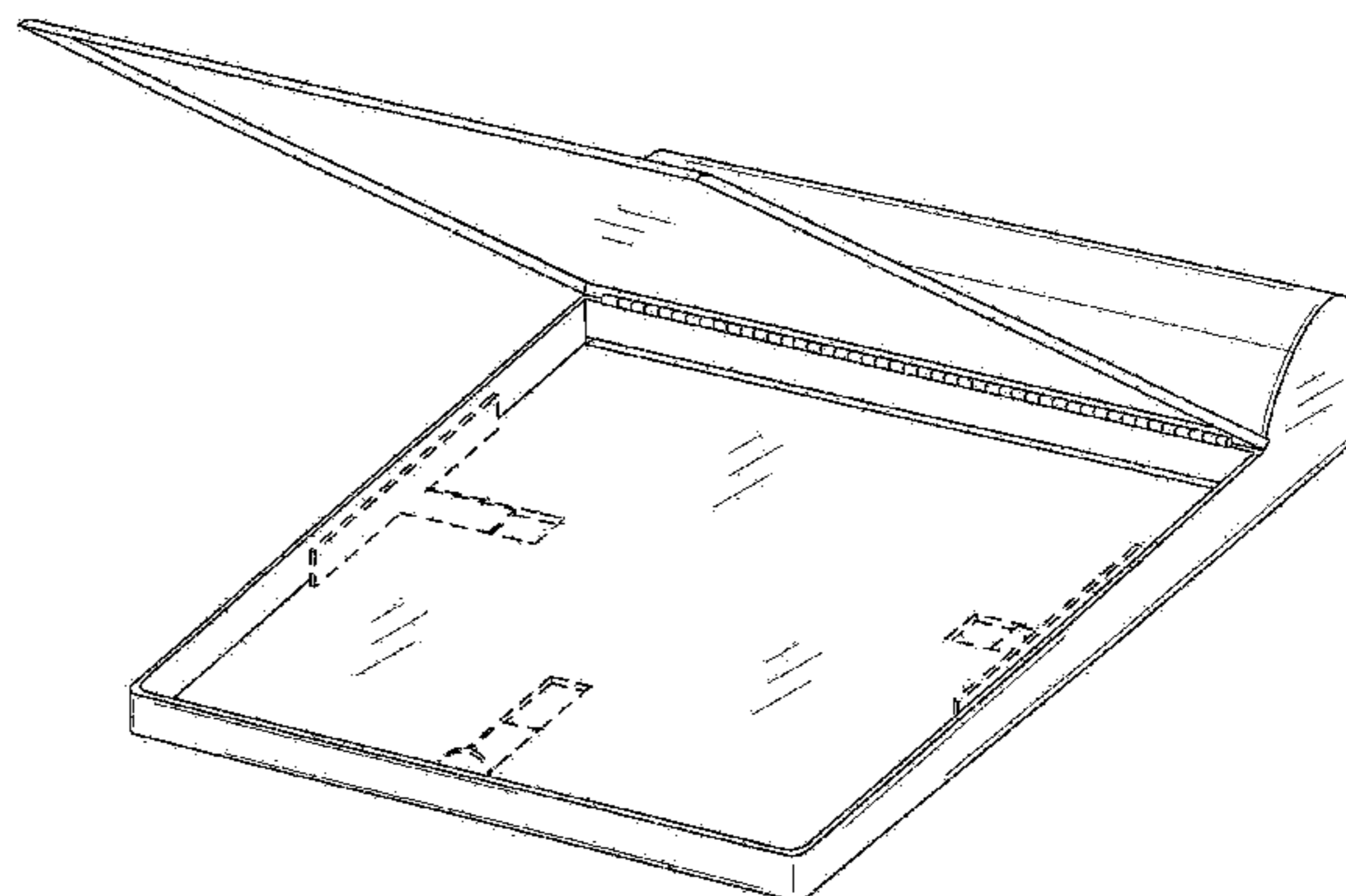
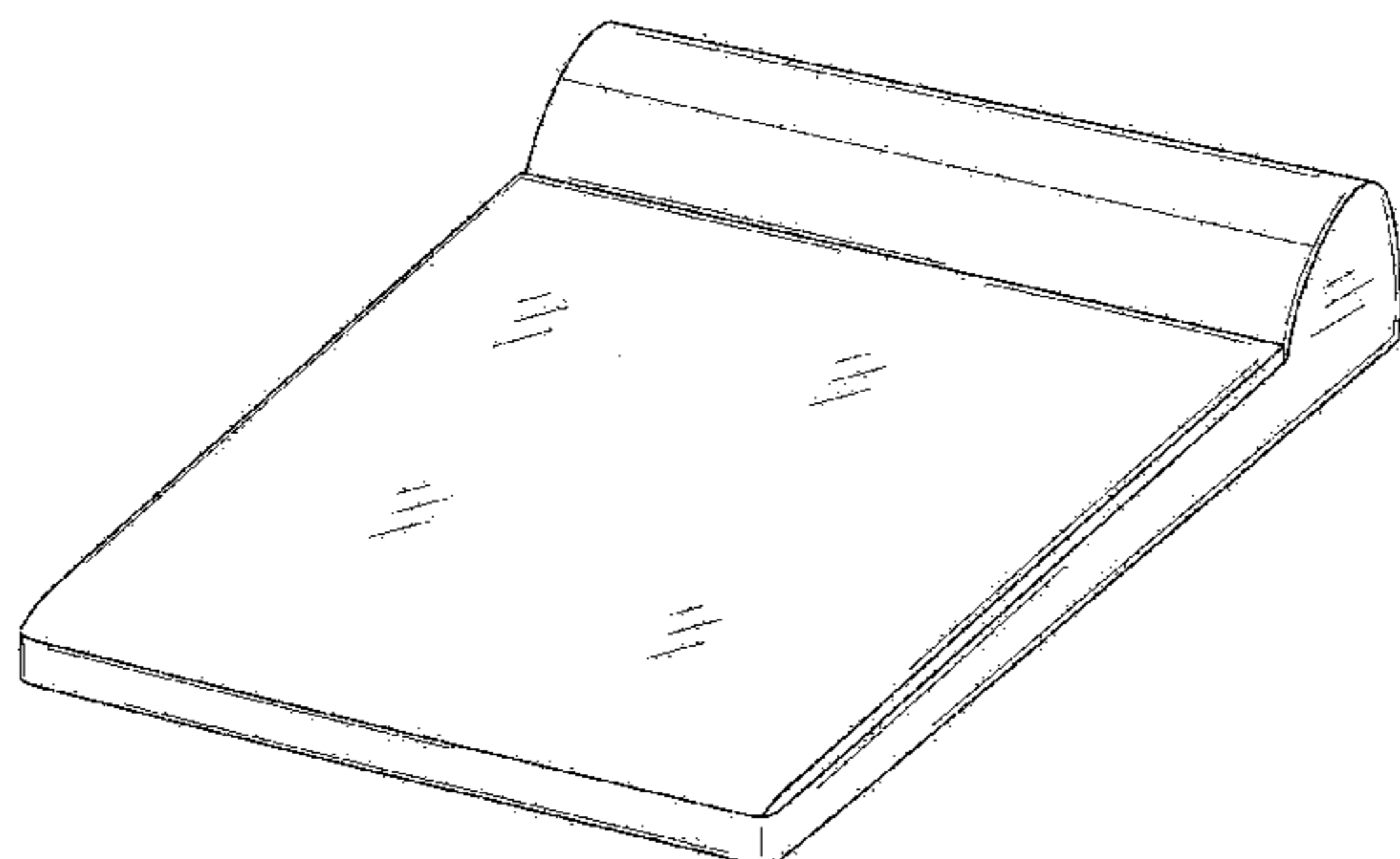
(57) **CLAIM**

The ornamental design for a combination support base and printer for portable computers, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side perspective view of the combination support base and printer for portable computers of the present invention showing the Applicant's new design; FIG. 2 is a front elevation view of the combination support base and printer for portable computers of FIG. 1; FIG. 3 is a back elevation view of the combination support base and printer for portable computers of FIG. 1; FIG. 4 is a top plan view of the combination support base and printer for portable computers of FIG. 1; FIG. 5 is a bottom plan view of the combination support base and printer for portable computers of FIG. 1; FIG. 6 is a right side elevation view of the combination support base and printer for portable computers of FIG. 1; FIG. 7 is a left side elevation view of the combination support base and printer for portable computers of FIG. 1; FIG. 8 is a right side elevation view of the combination support base and printer for portable computers of FIG. 6 showing the lid thereof in its raised position to allow access to the paper tray in the base thereof; FIG. 9 is a right side perspective view of the combination support base and printer for portable computers of FIG. 8; FIG. 10 is a right side perspective view of the combination support base and printer for portable computers of the present invention shown in use with a laptop computer positioned on the support base with paper being ejected from the printer; and, FIG. 11 is a right side perspective view of the combination support base and printer for portable computers of the present invention shown in use with an electronic tablet positioned on the support base with paper being ejected from the printer. The broken line showing the paper guides in the open paper tray of FIG. 9 is for illustrative purposes only and forms no part of the claimed design. The broken line showing the laptop computer and paper of FIG. 10 is for illustrative purposes only and forms no part of the claimed design. The broken line showing the electronic tablet and paper of FIG. 11 is for illustrative purposes only and forms no part of the claimed design.

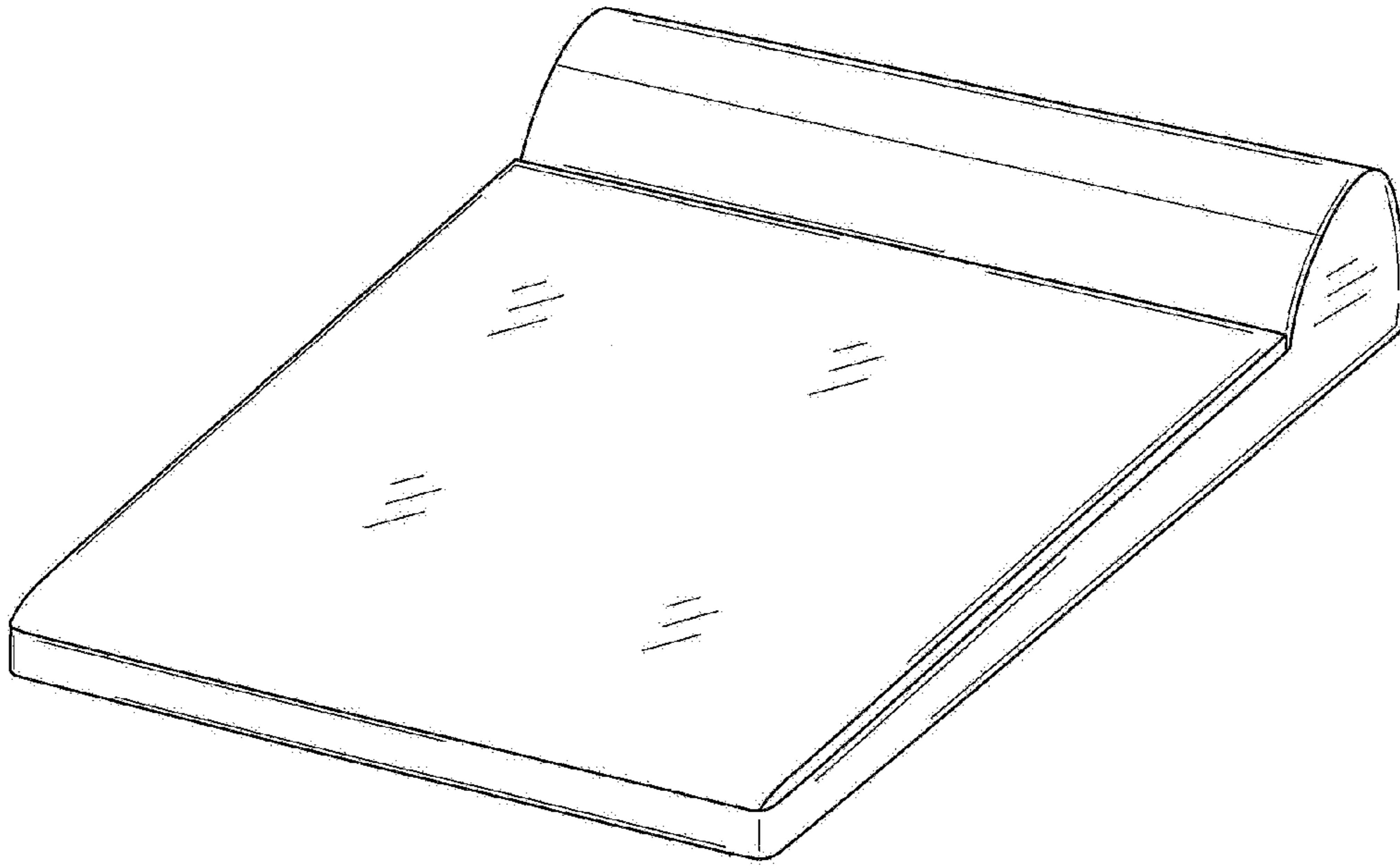

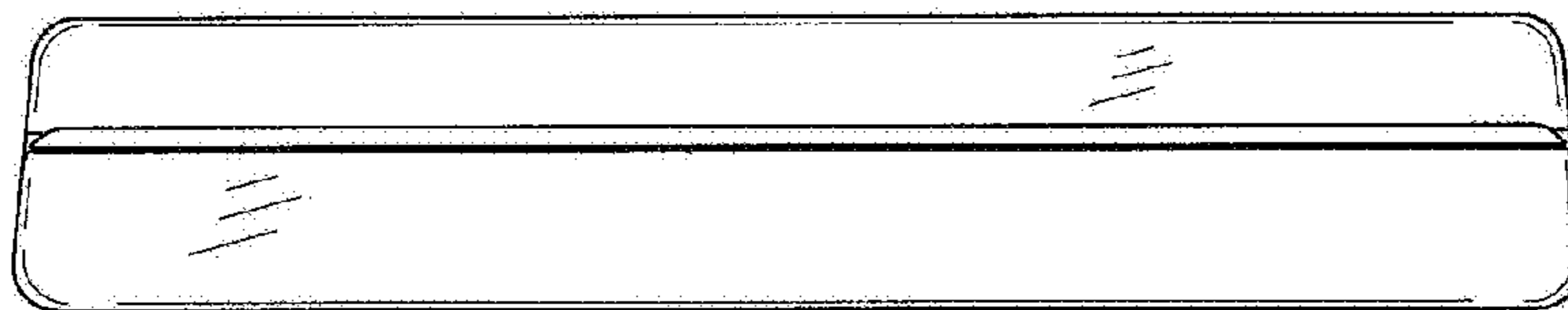

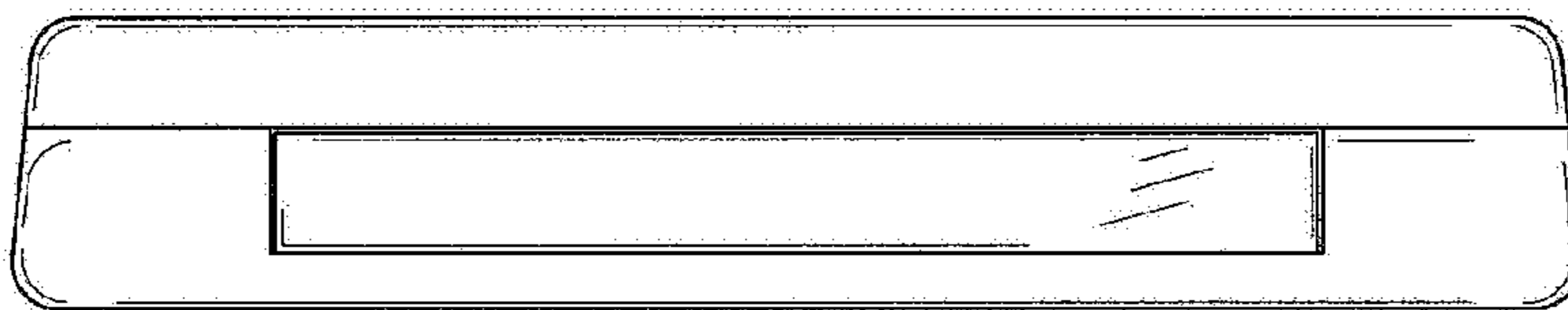

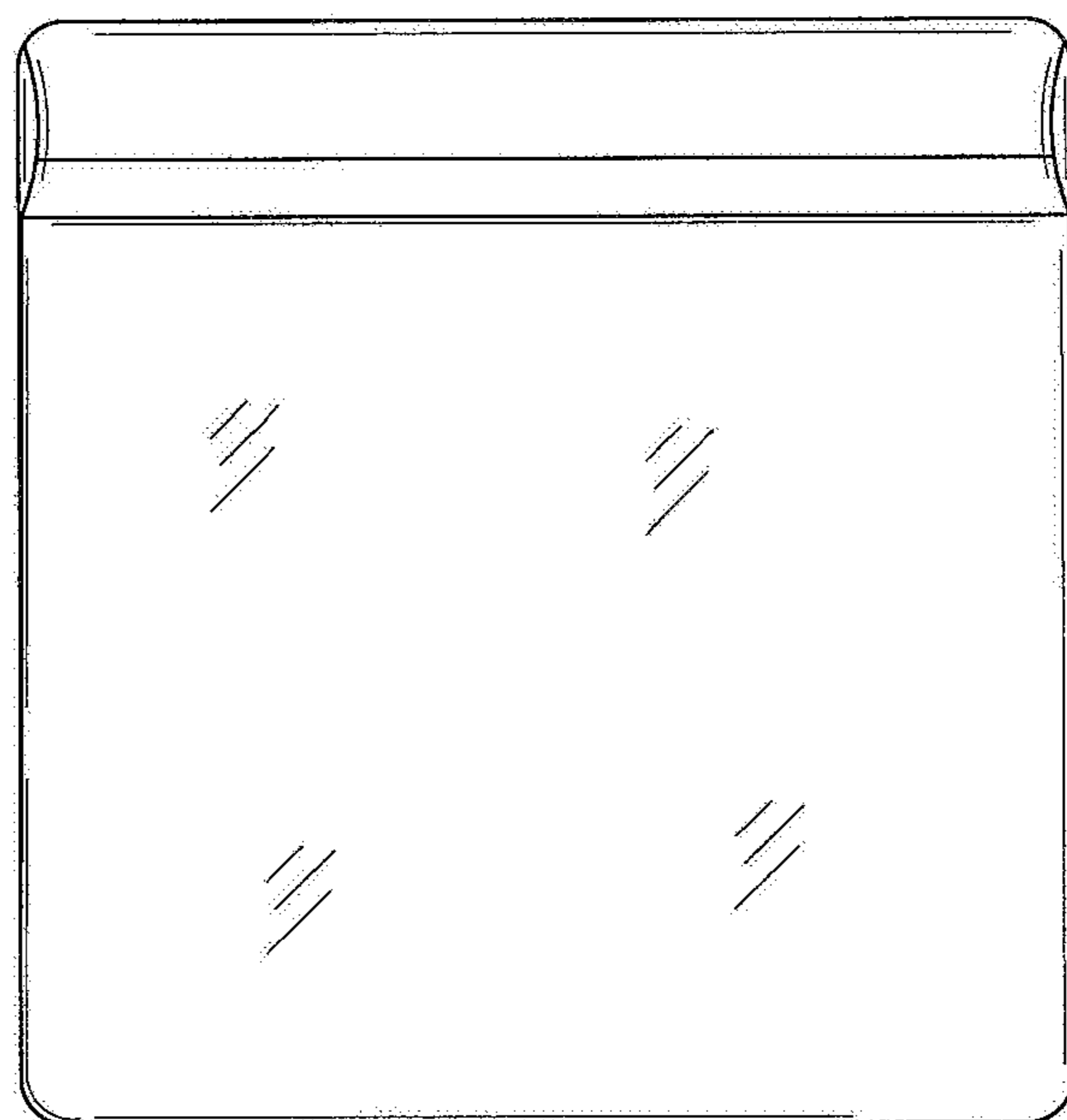

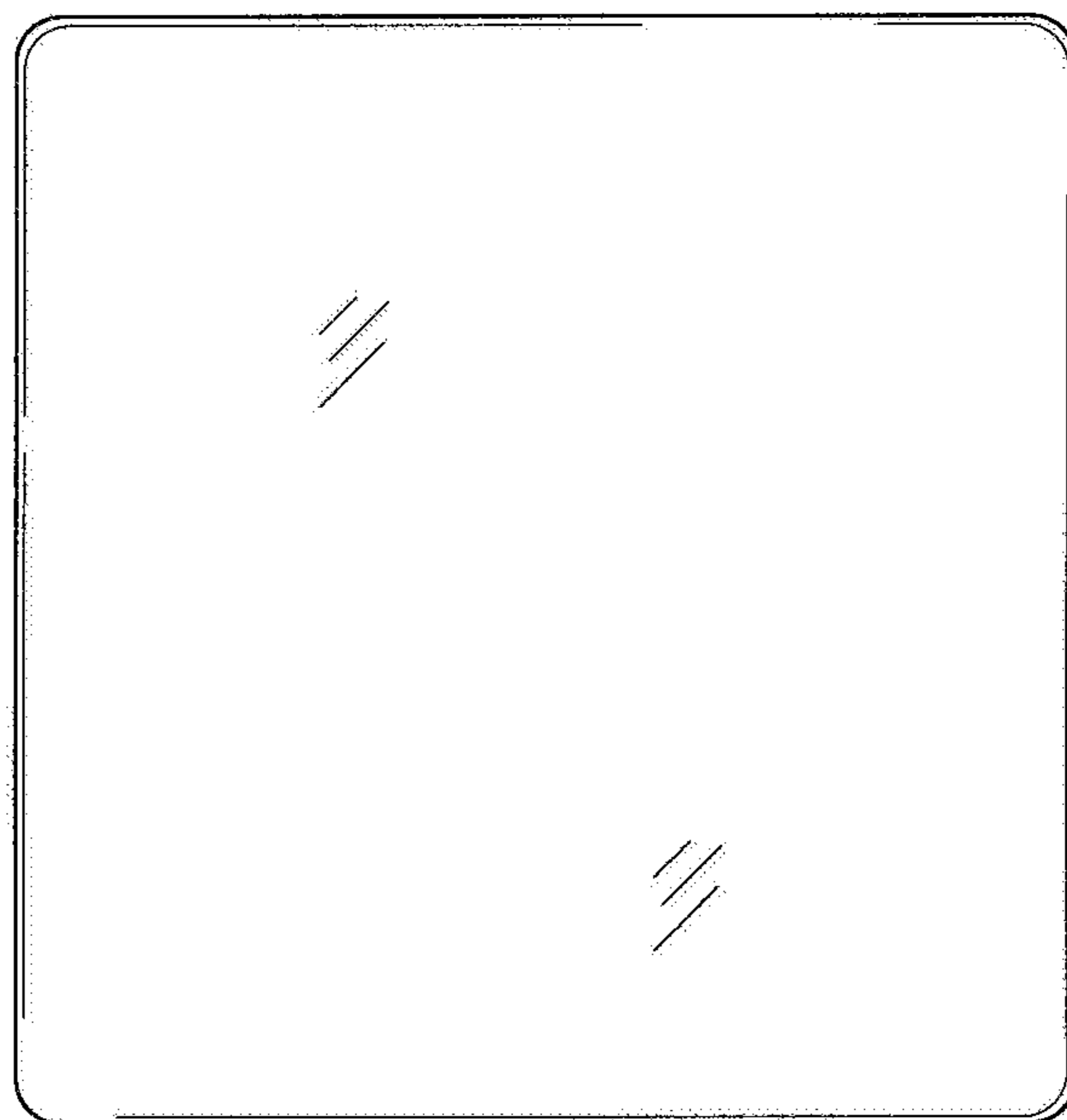

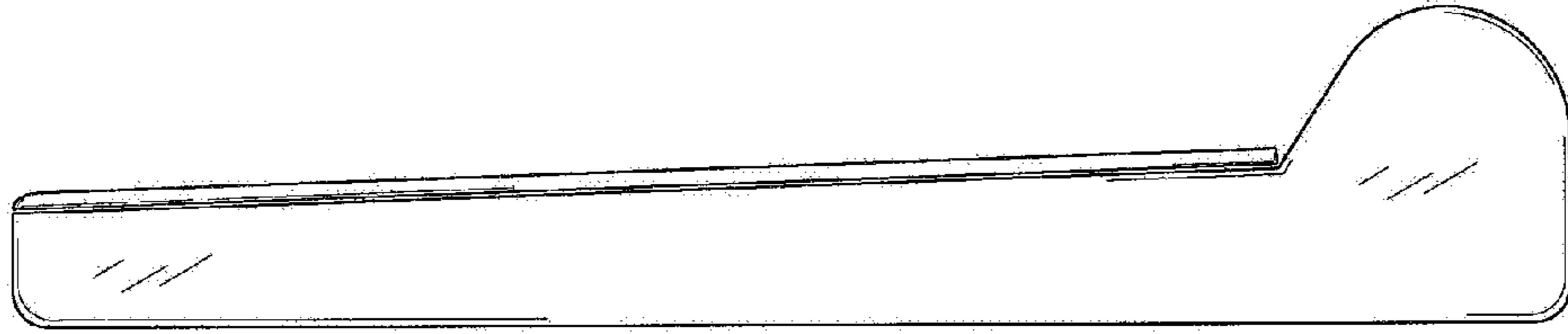

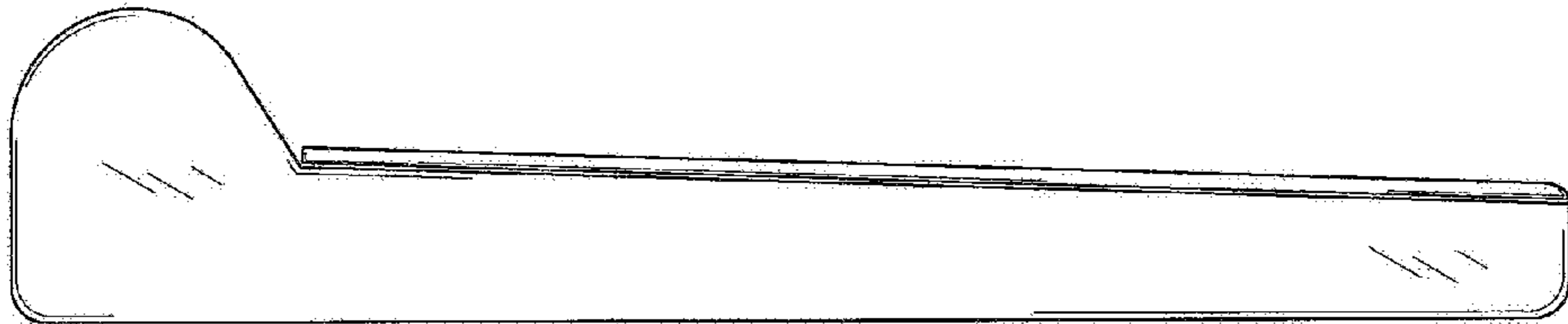

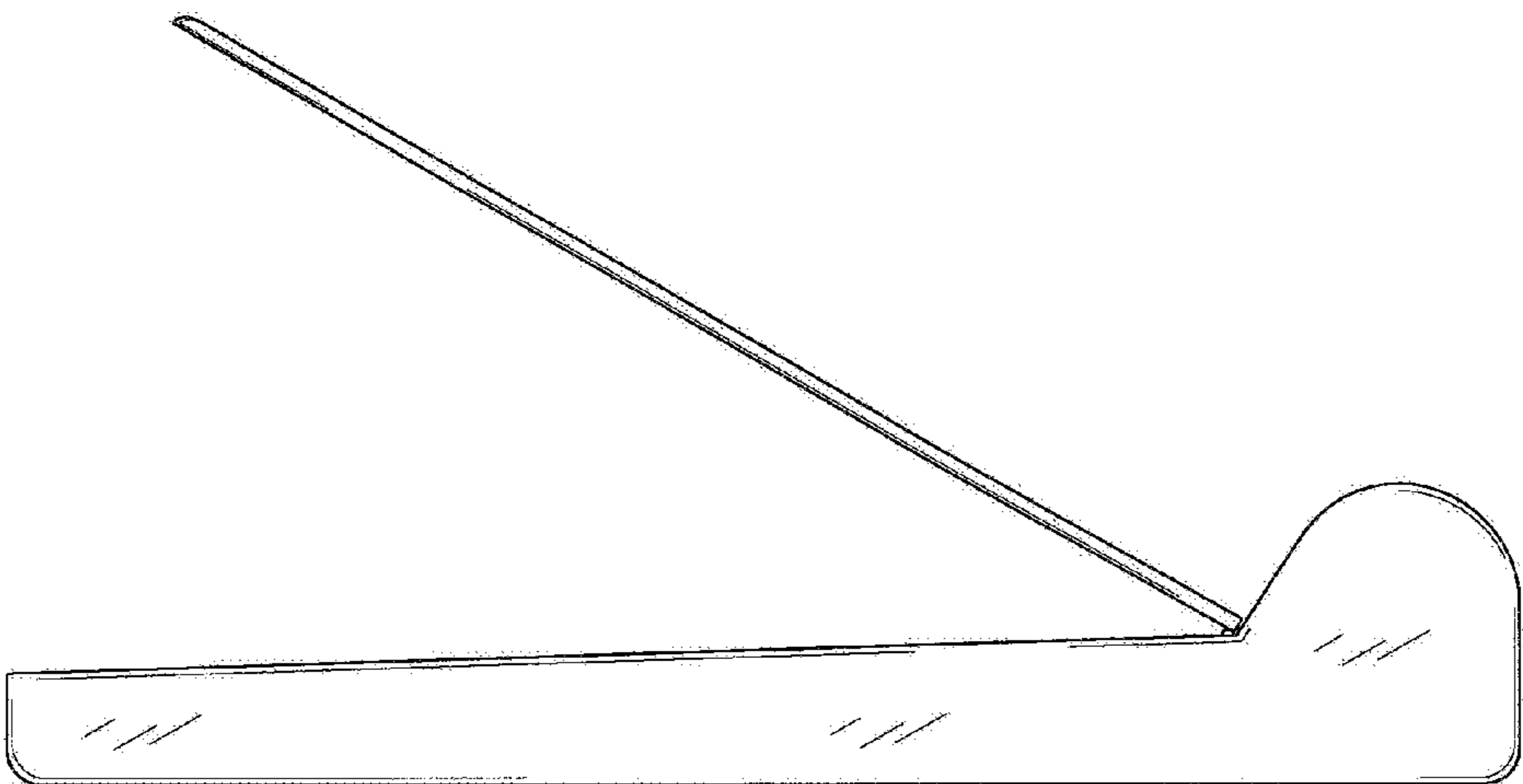

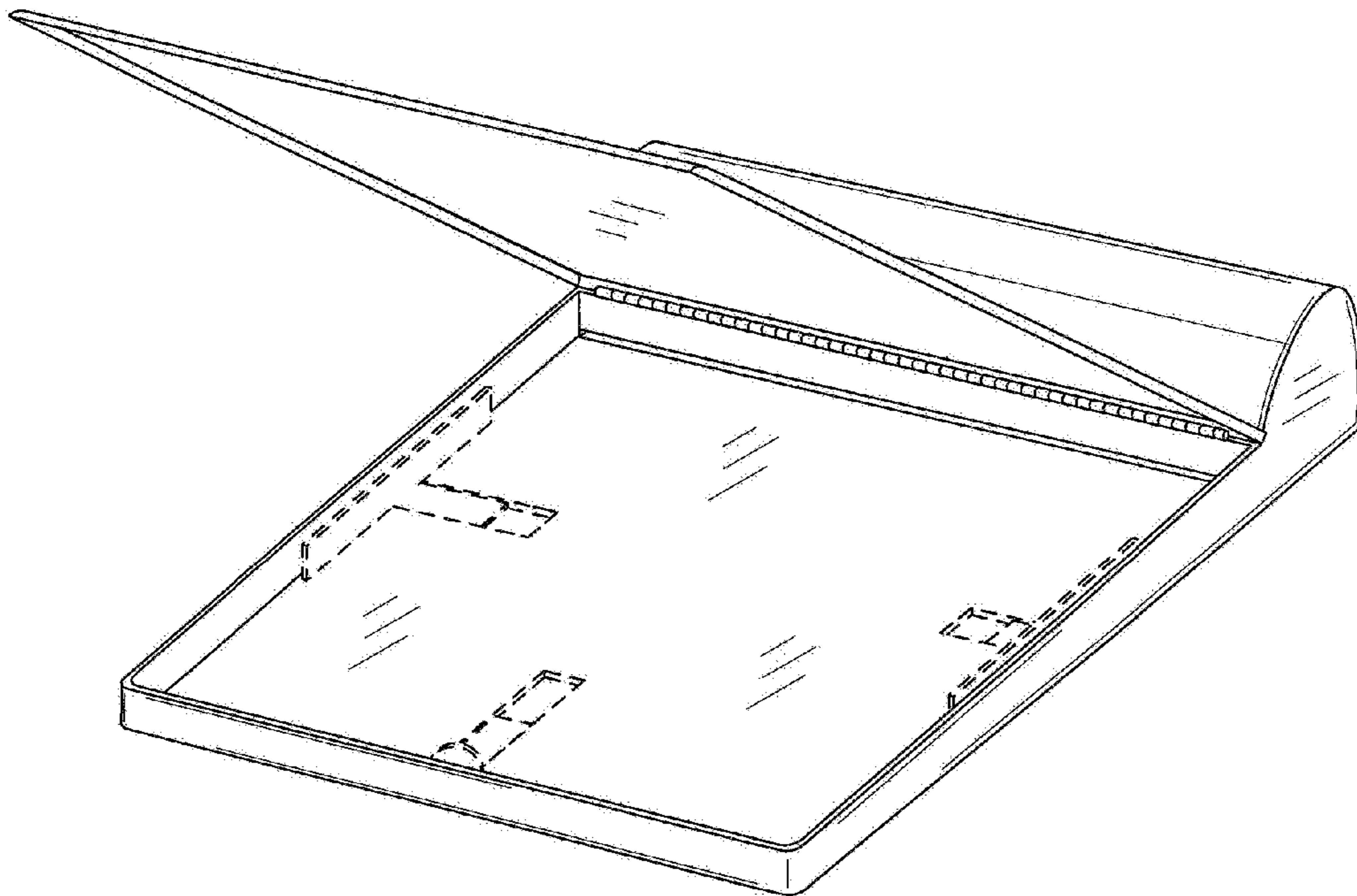
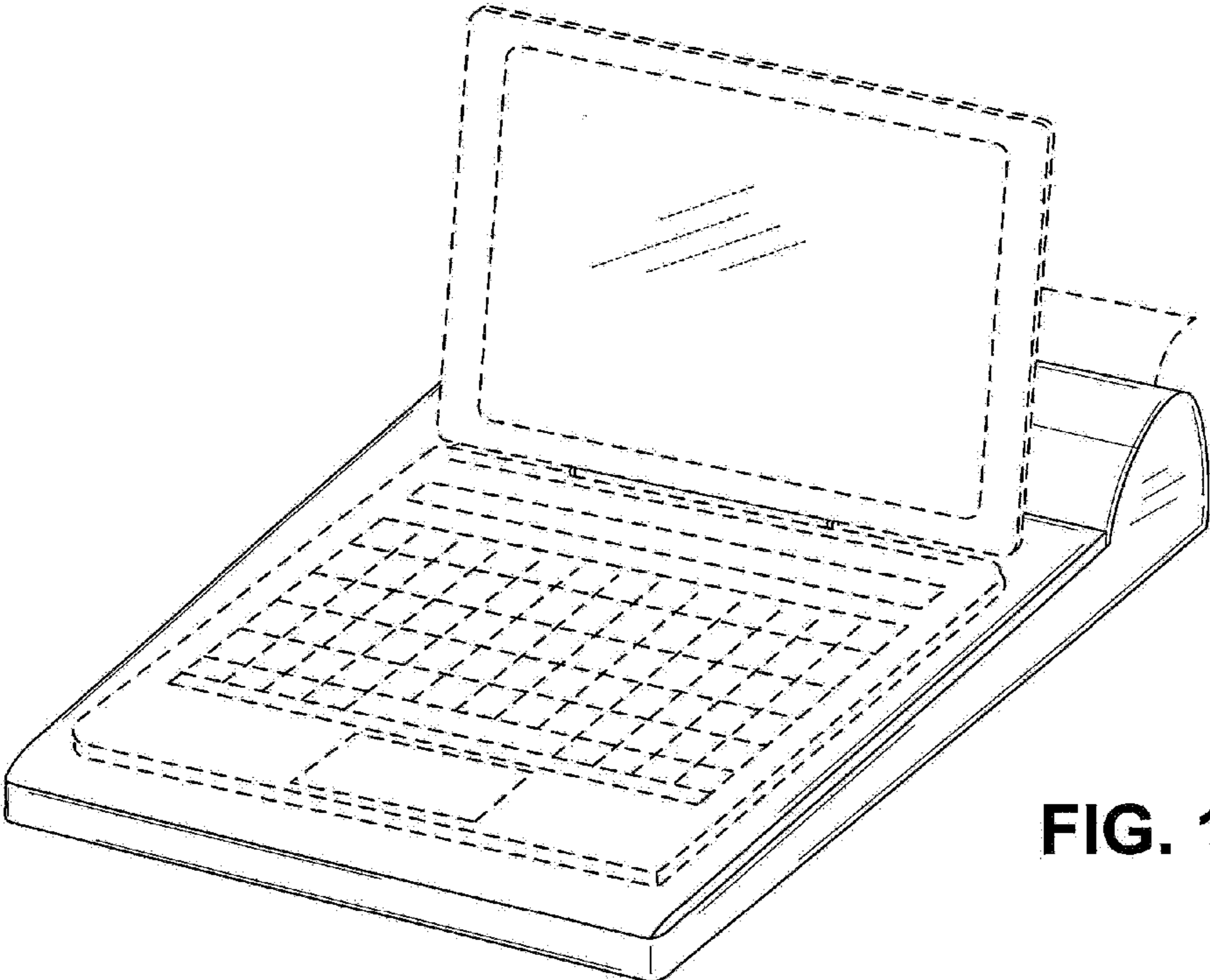
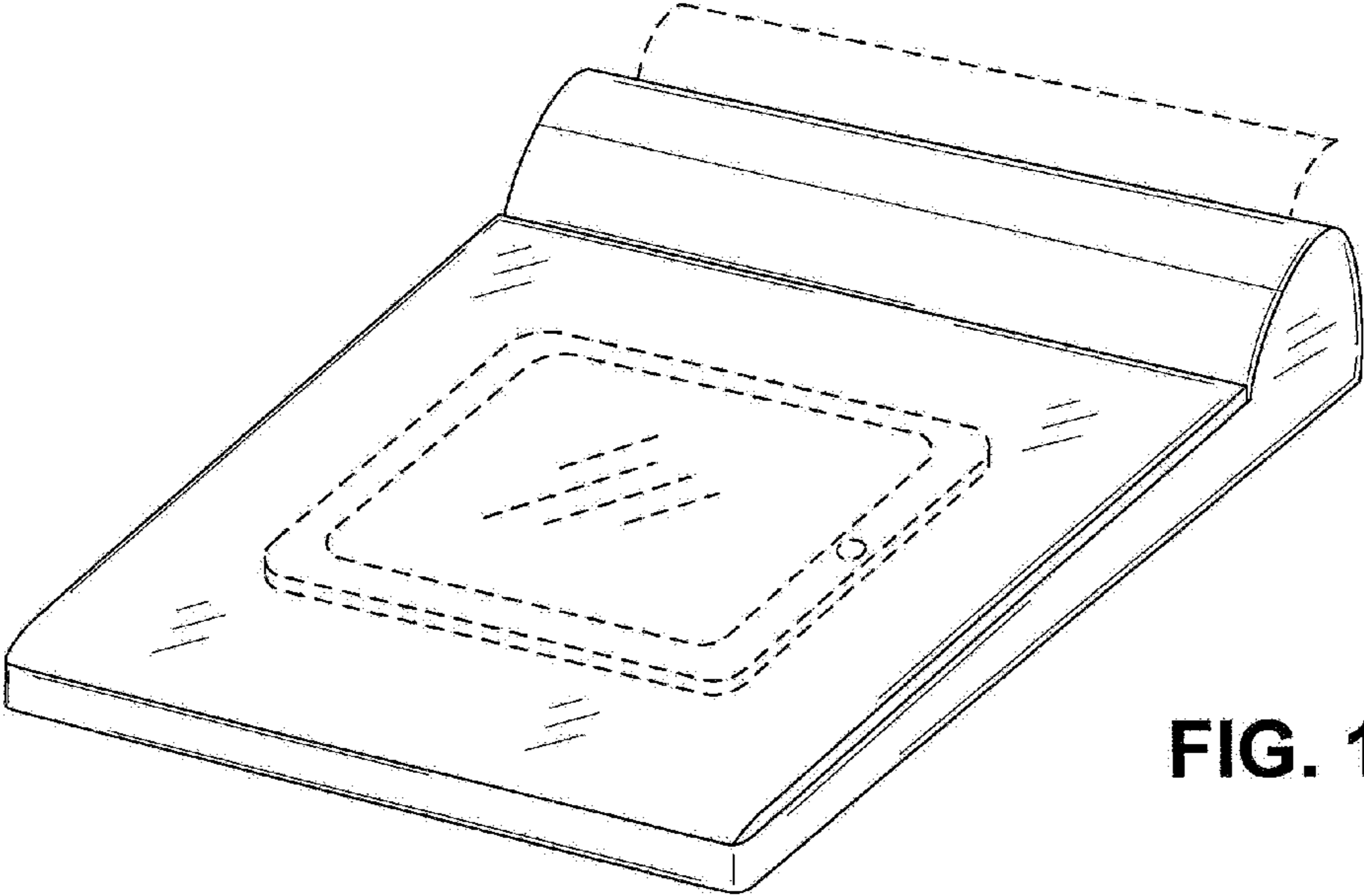
