The ornamental design for a display screen or portion thereof of a human capital management system with graphical user interface, as shown and described.

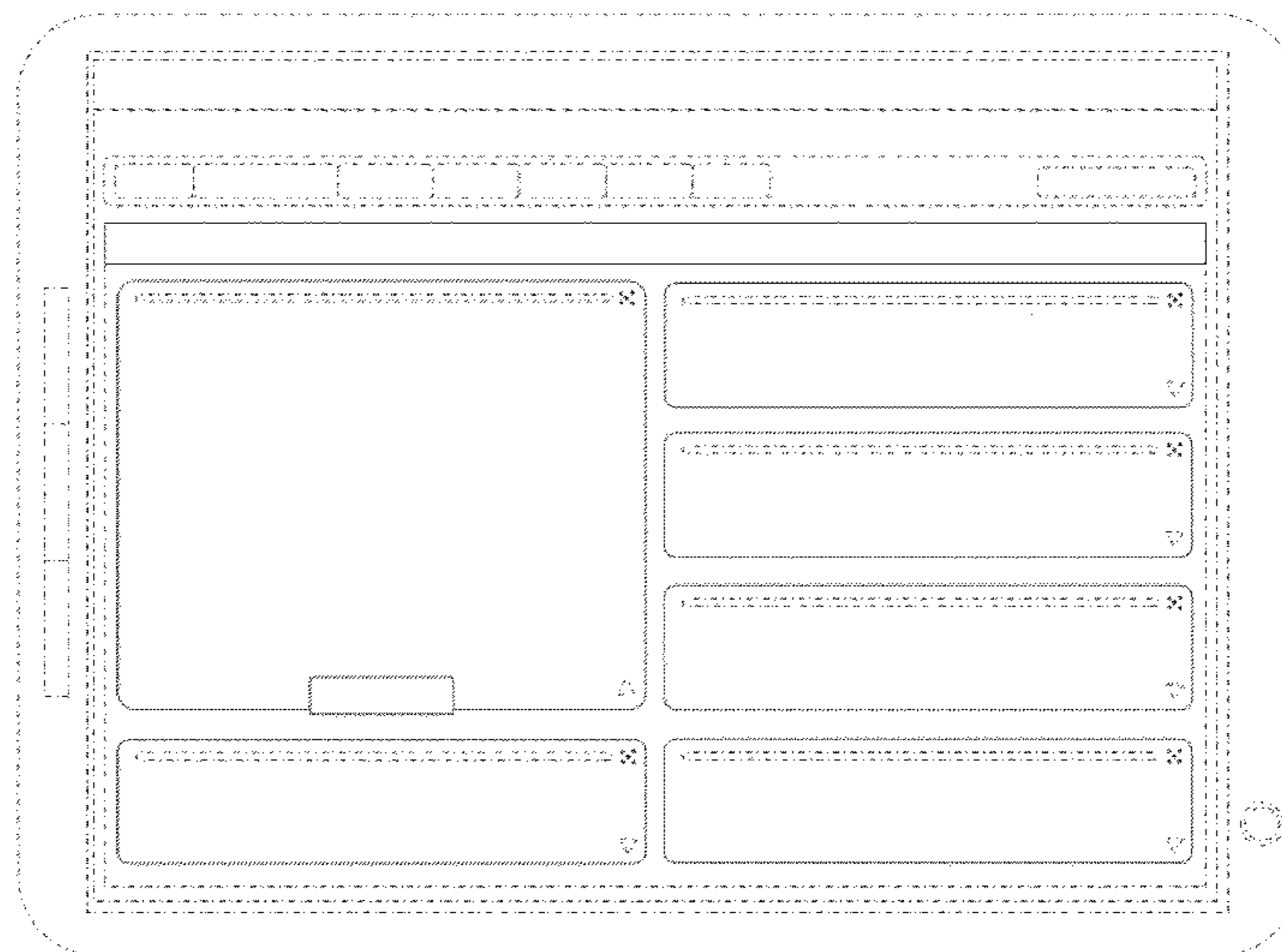
DESCRIPTION

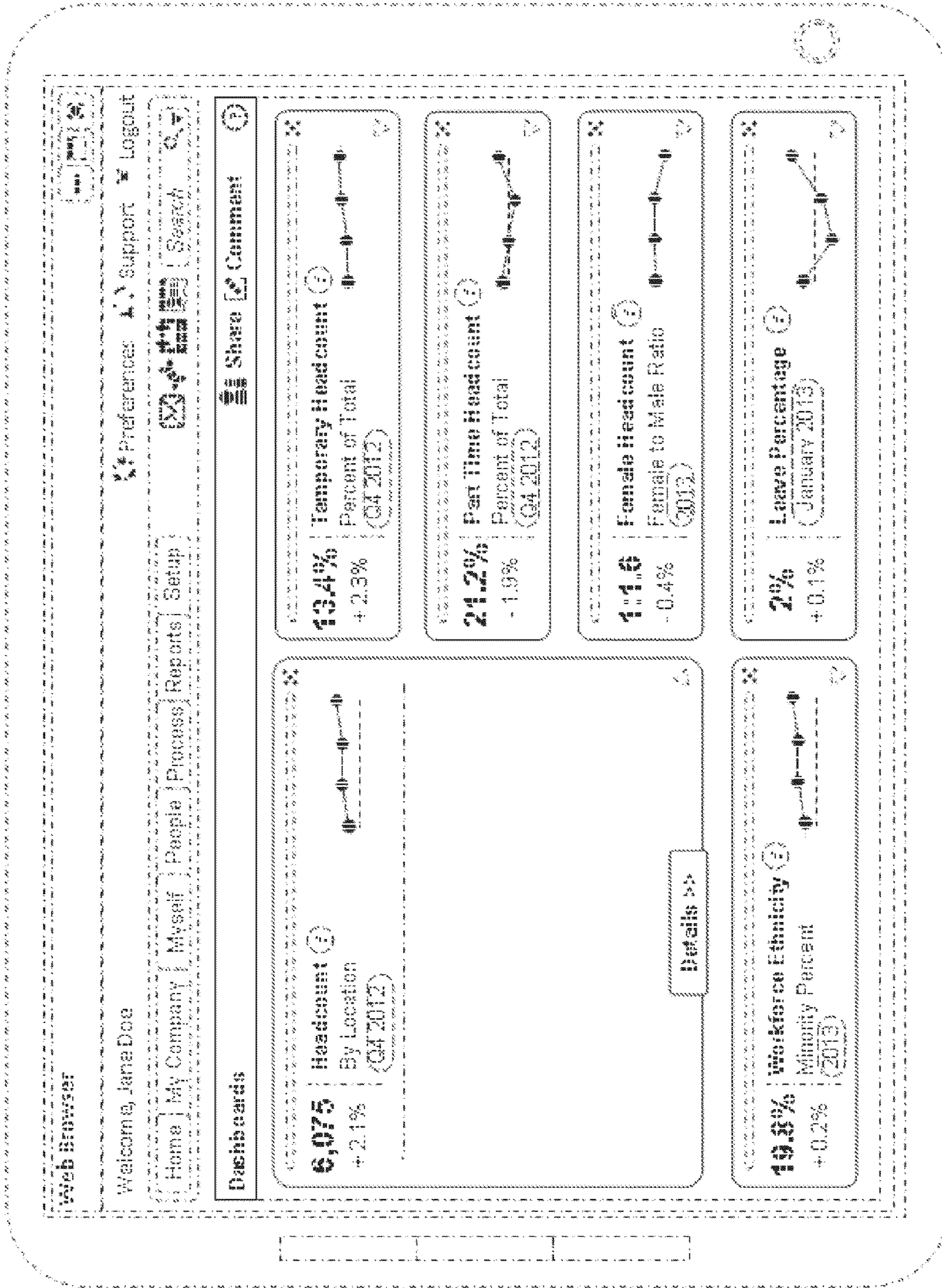

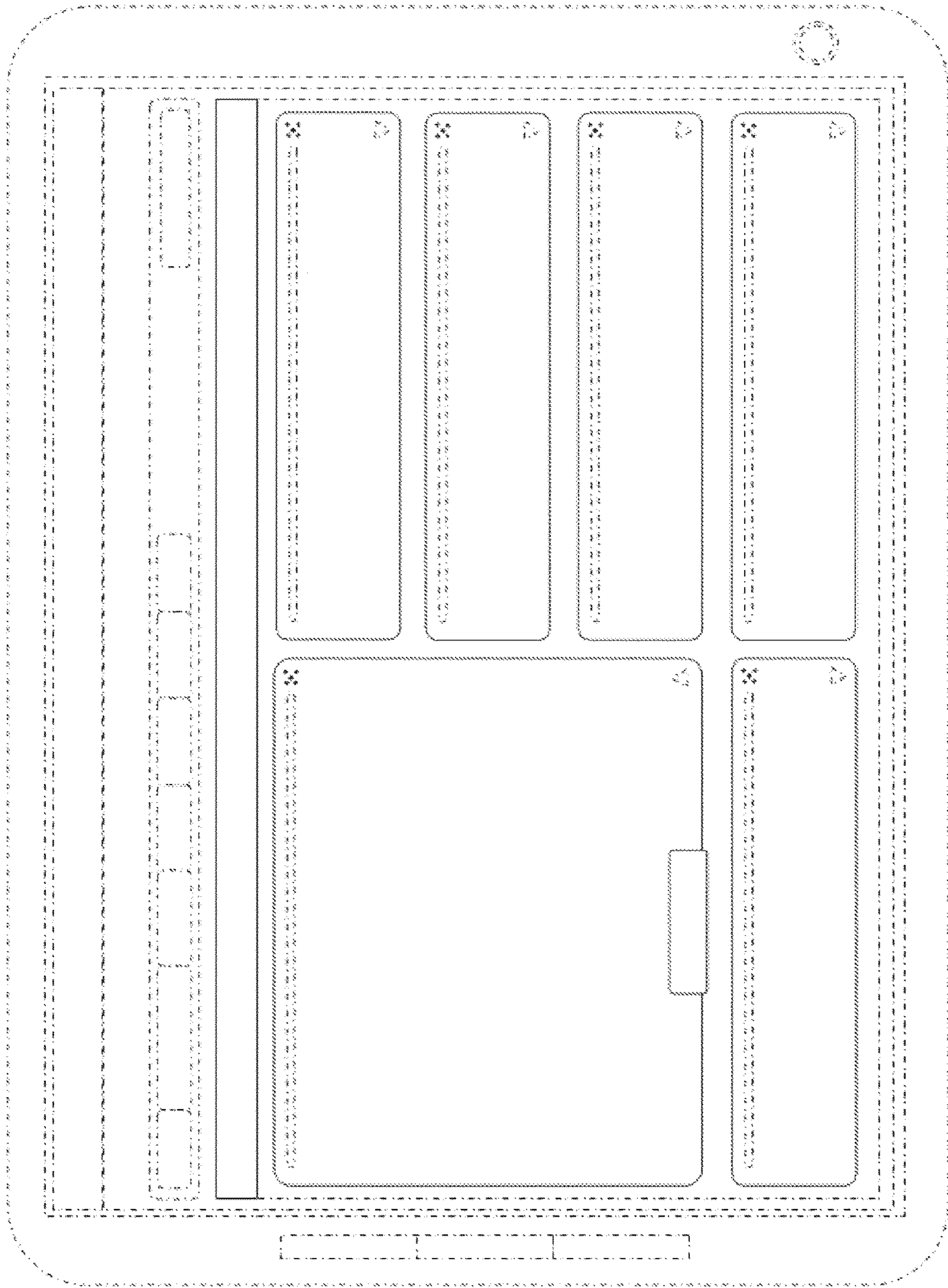

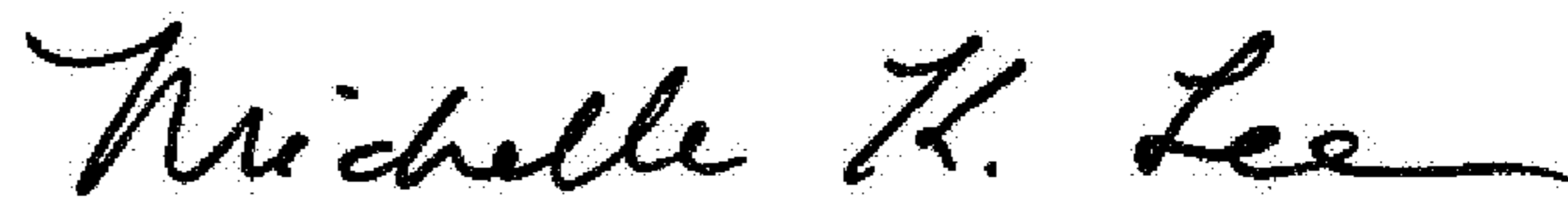
