DESCRIPTION

FIG. 1 is a perspective view of a dental protractor in accordance with the present invention.

FIG. 4 is a right-side view of the dental protractor of FIG. 1.

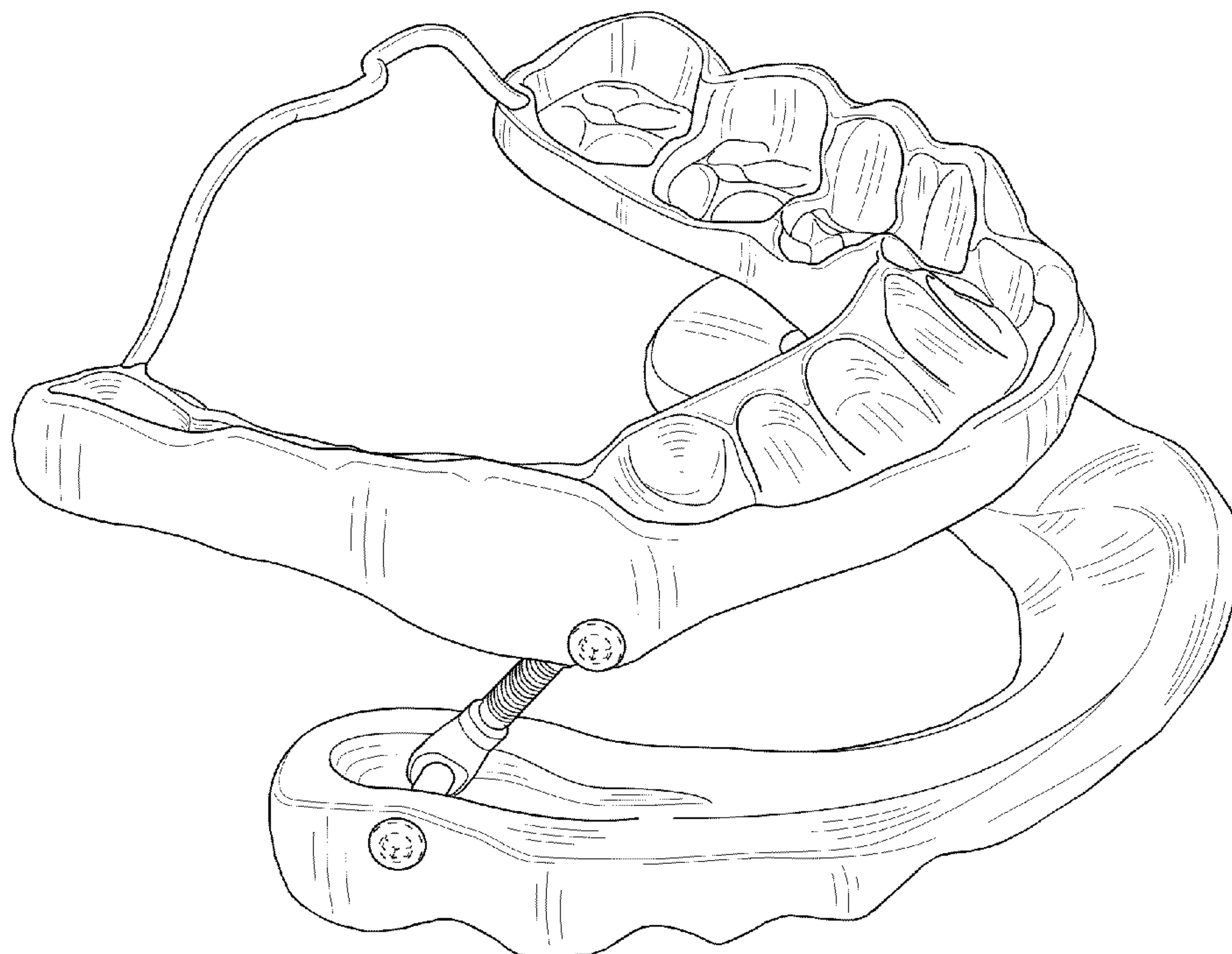
FIG. 5 is a left-side view of the dental protractor of FIG. 1.

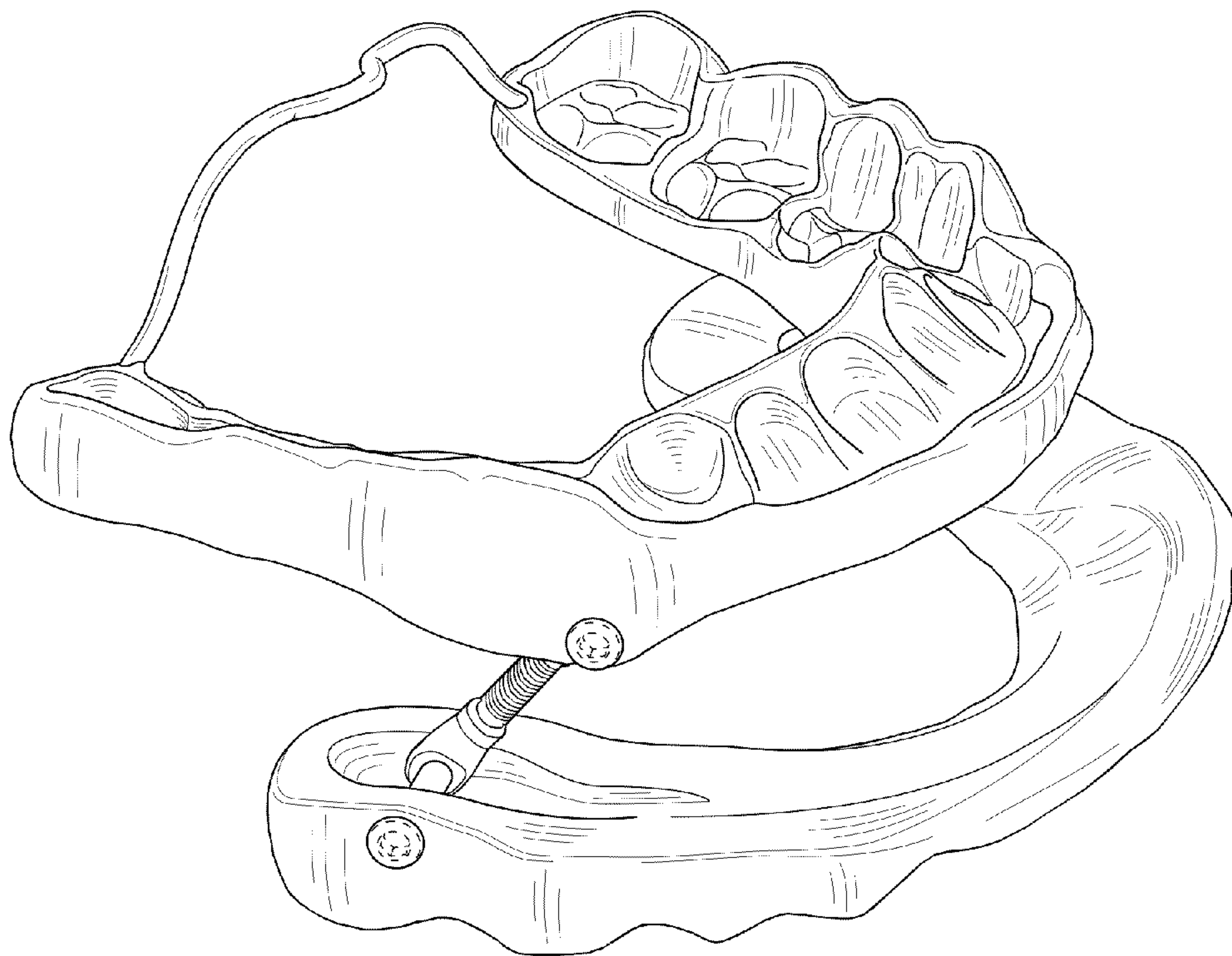

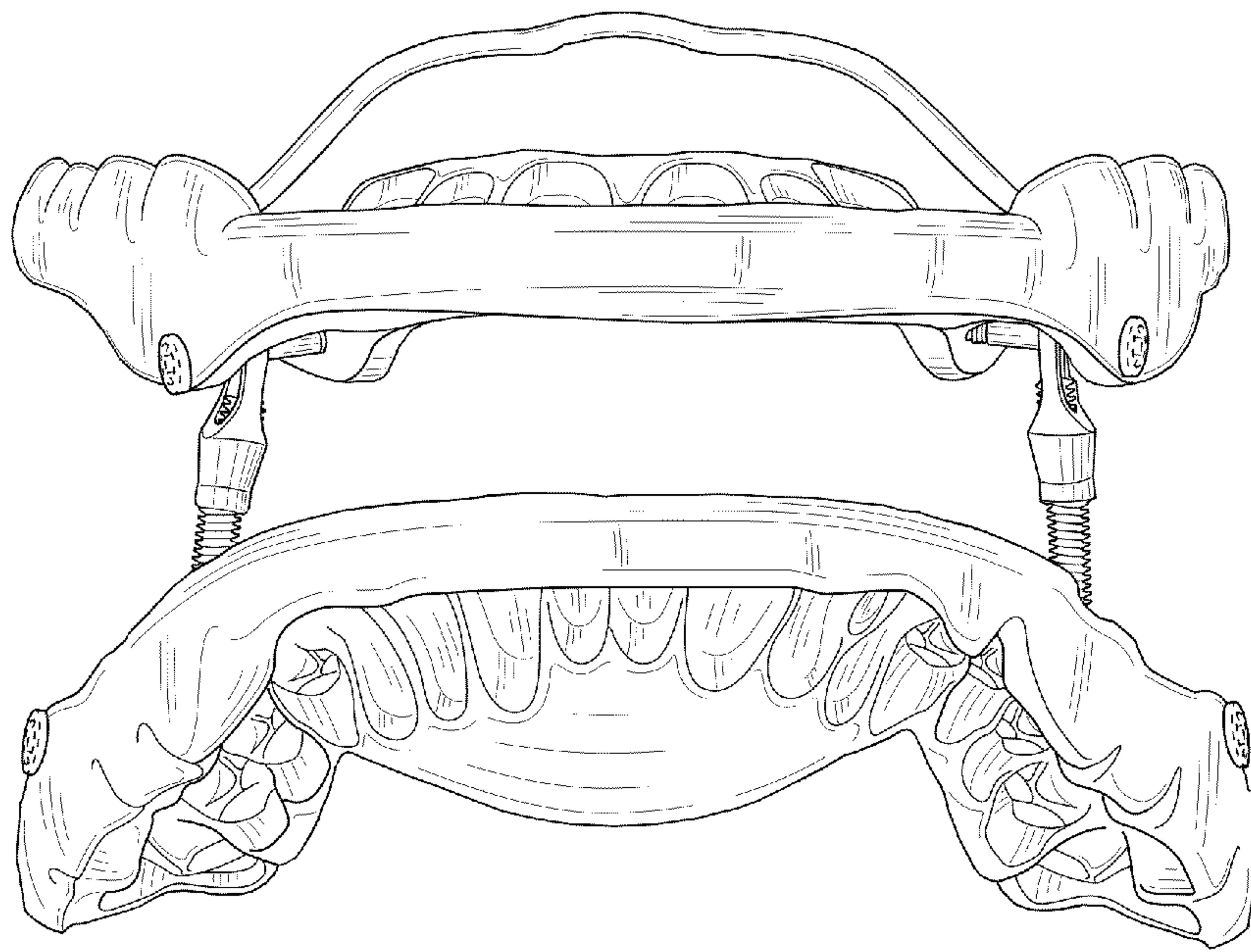

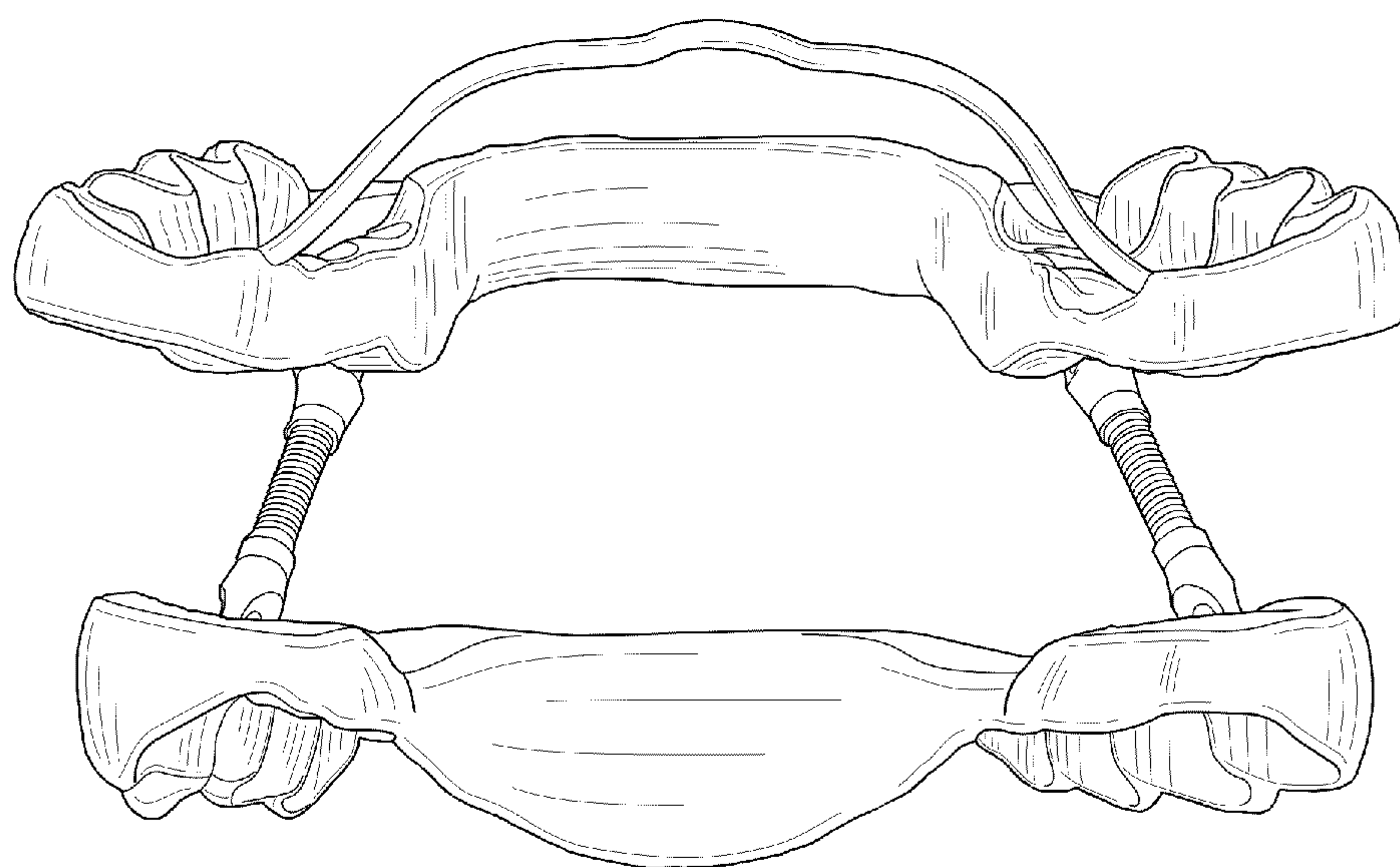

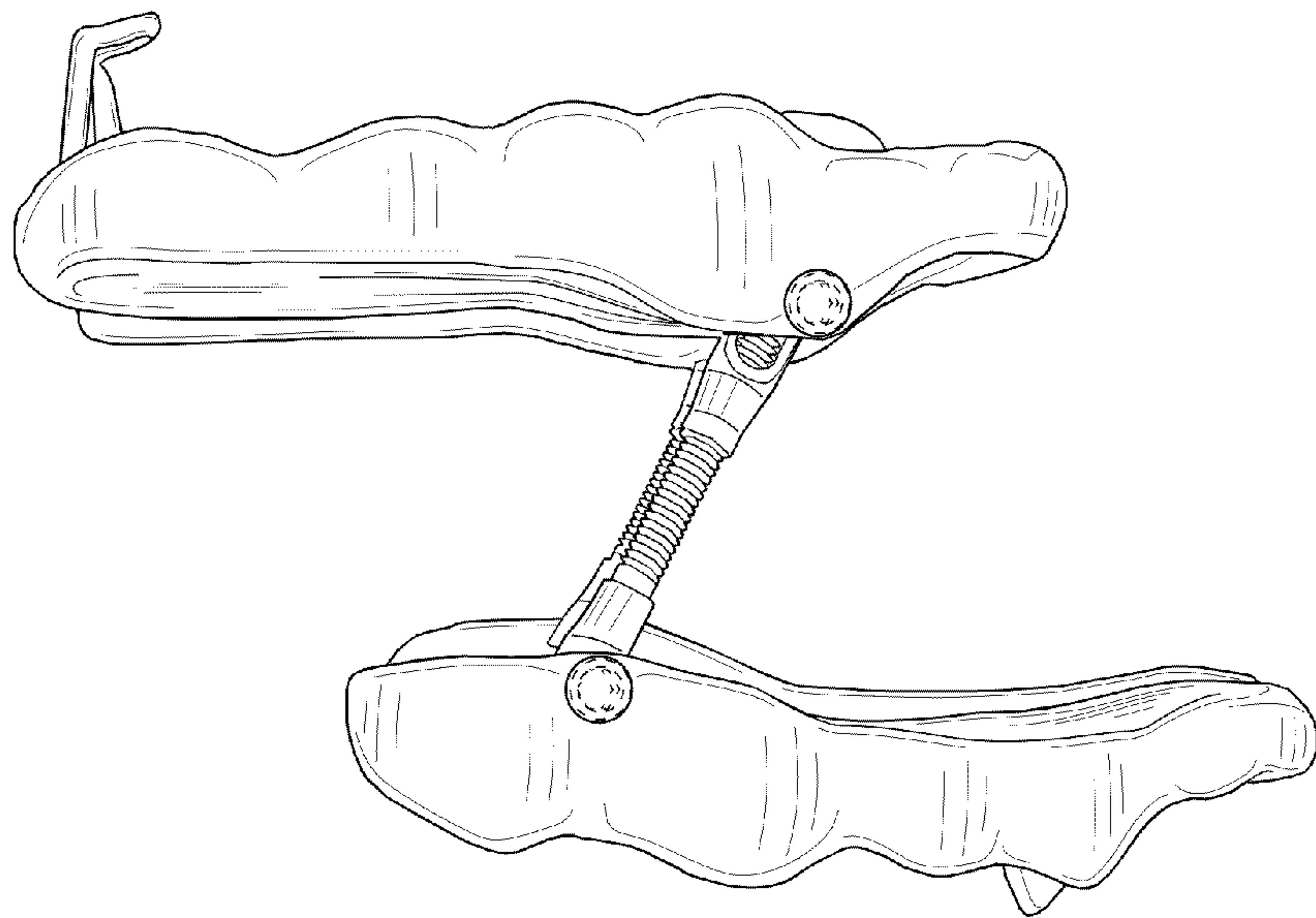

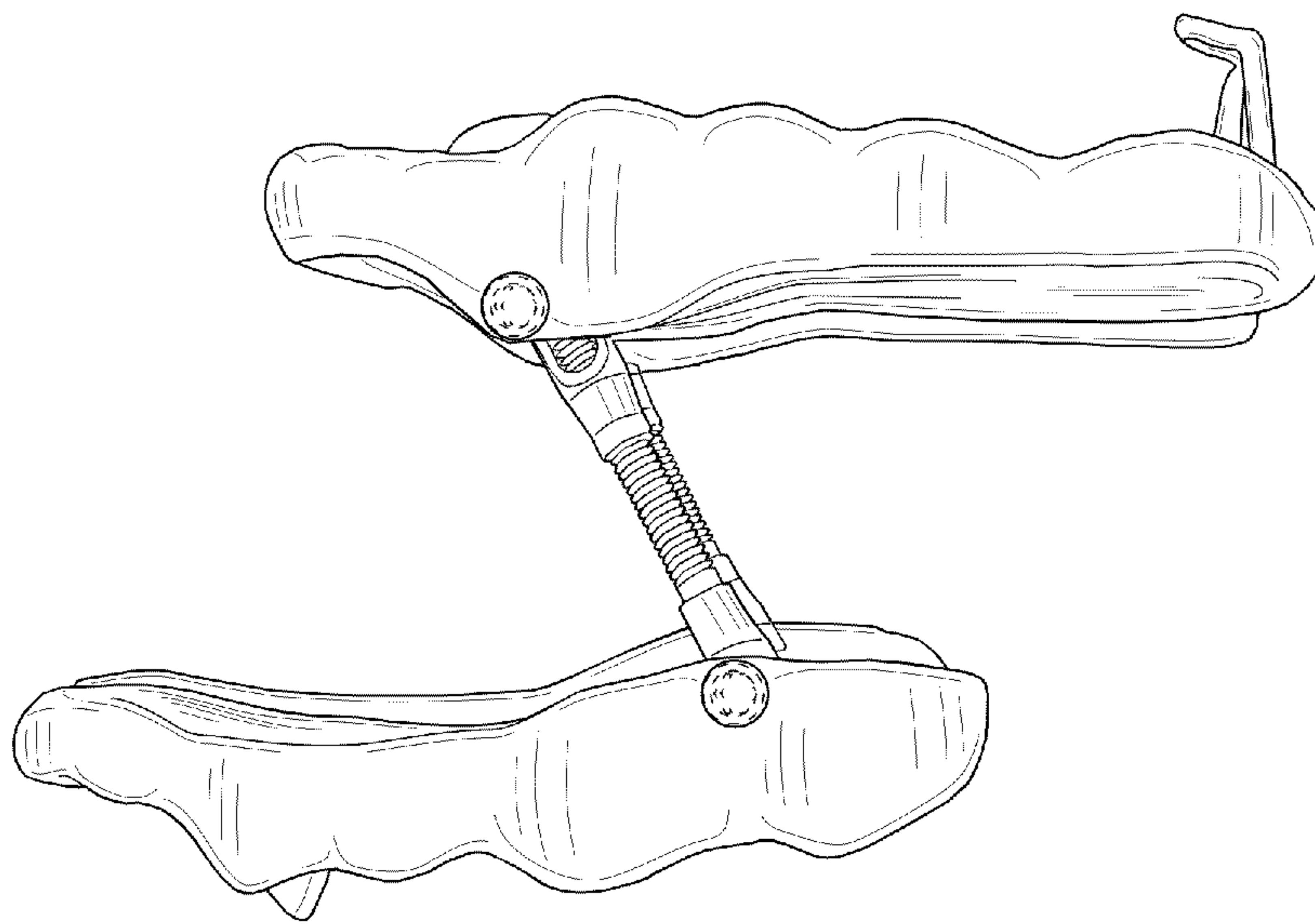

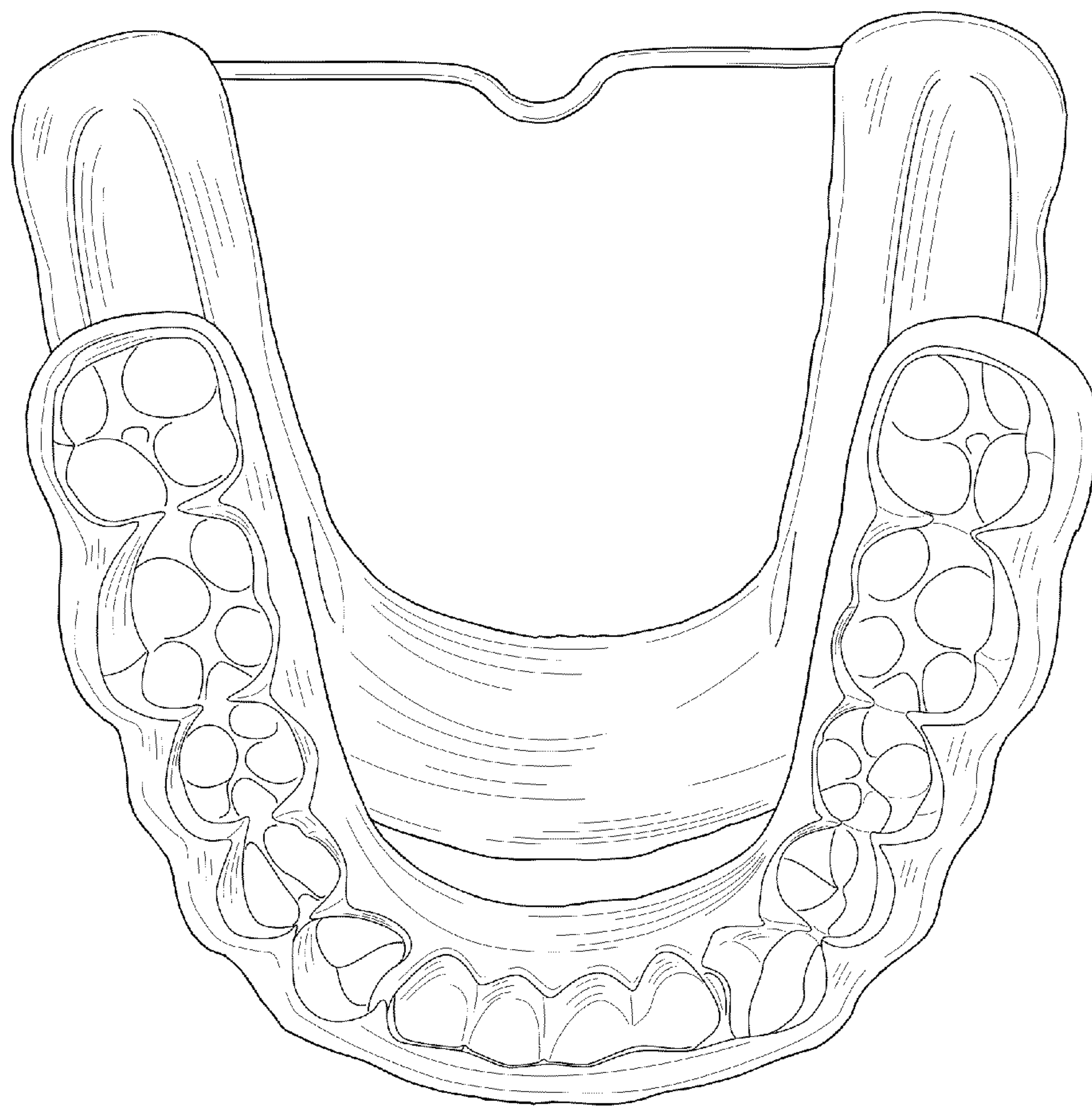

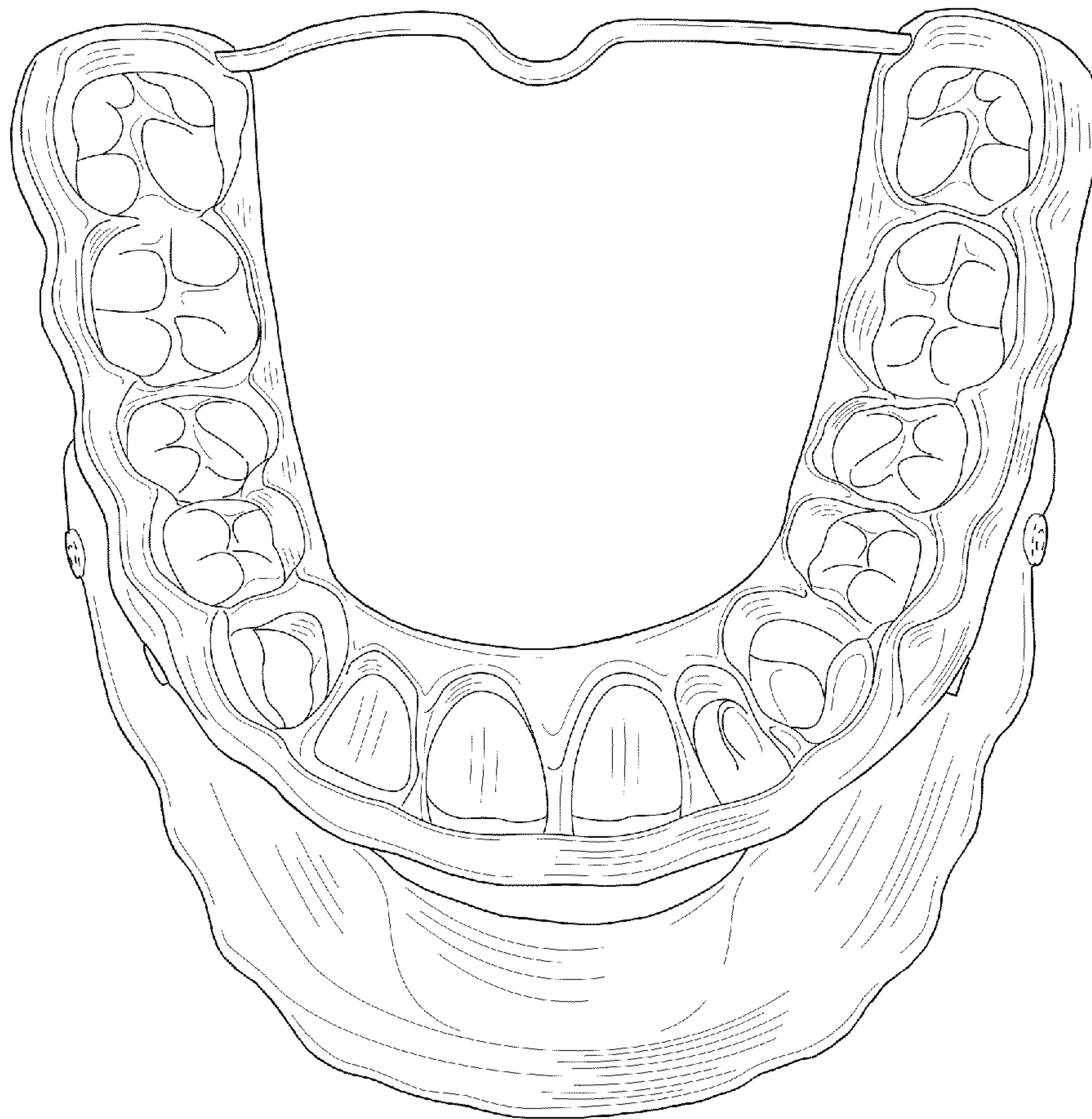
