(57) **CLAIM**

The ornamental design for an engine hood lighting device of an agricultural vehicle, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an engine hood lighting device of an agricultural vehicle showing our new design in use condition, in which the phantom lines illustrate portions of an engine hood assembly that forms no part of the claimed design;

FIG. 2 is a front view thereof;

FIG. 3 is a back view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is an enlarged perspective view of one side of the engine hood lighting device of an agricultural vehicle shown separate from the hood thereof, in which the phantom lines illustrate portions of the engine hood lighting device of an agricultural vehicle that forms no part of the claimed design;

FIG. 9 is a top view thereof;

FIG. 10 is a bottom view thereof;

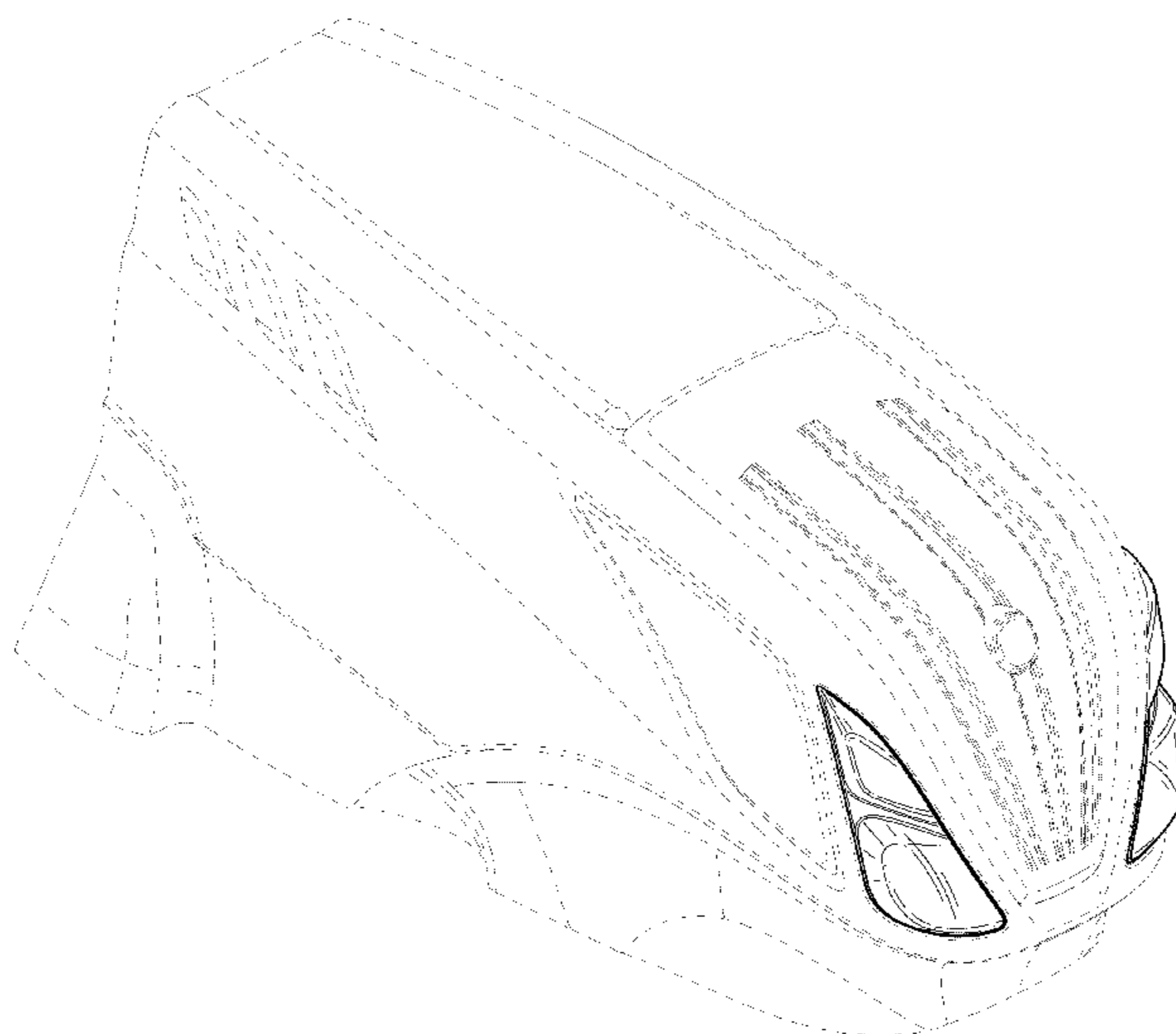
FIG. 11 is a left side elevation view thereof;

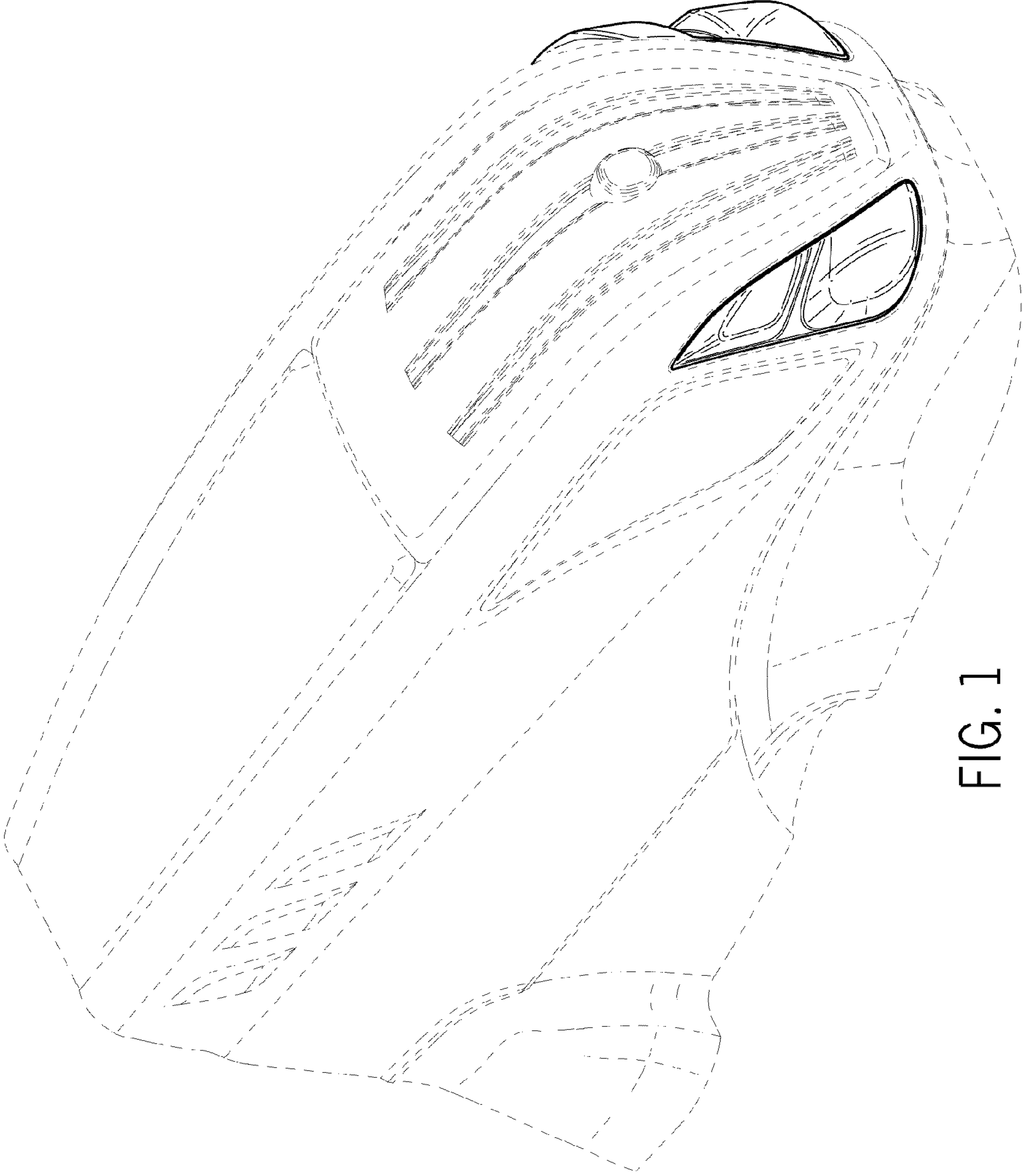

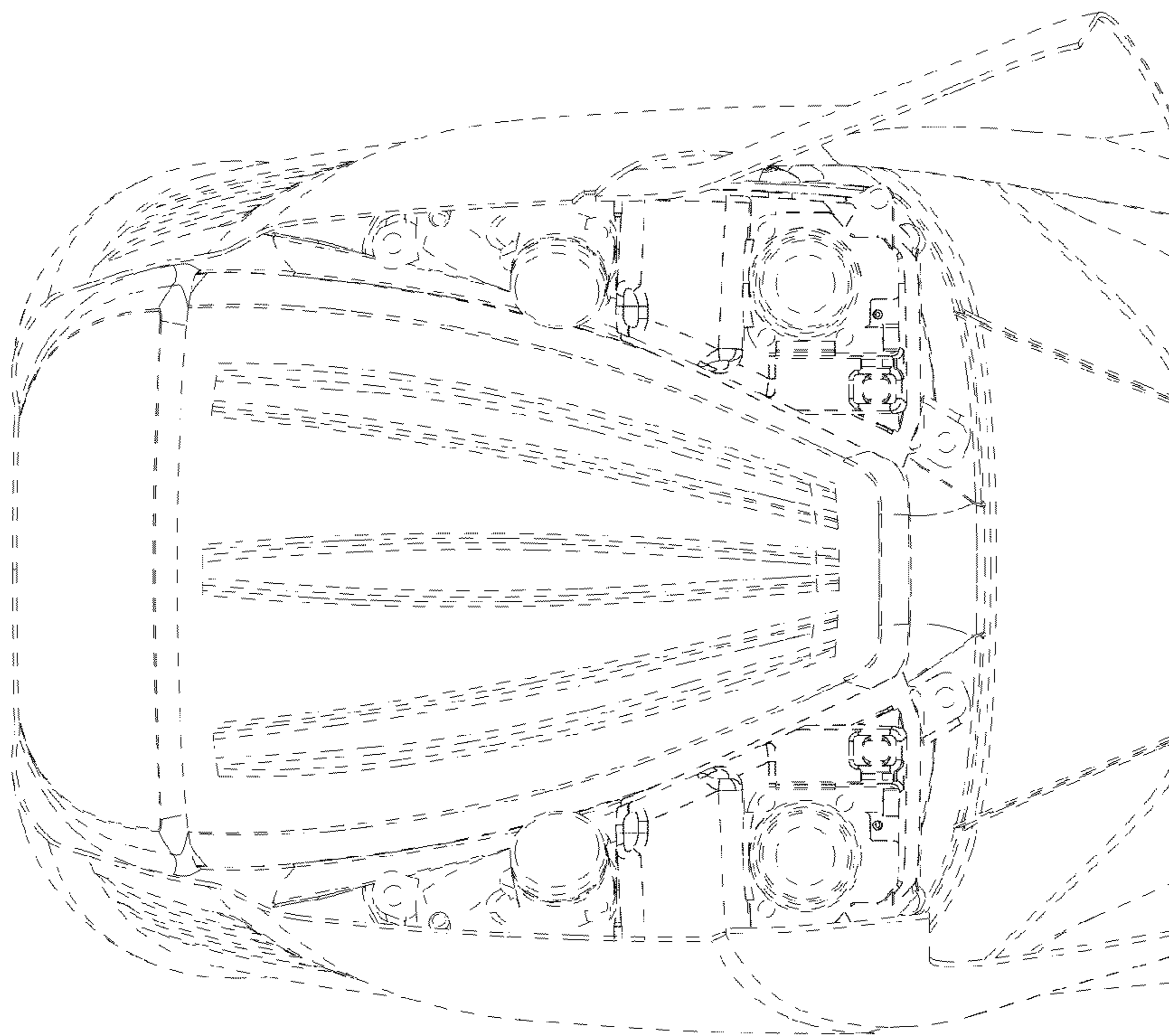

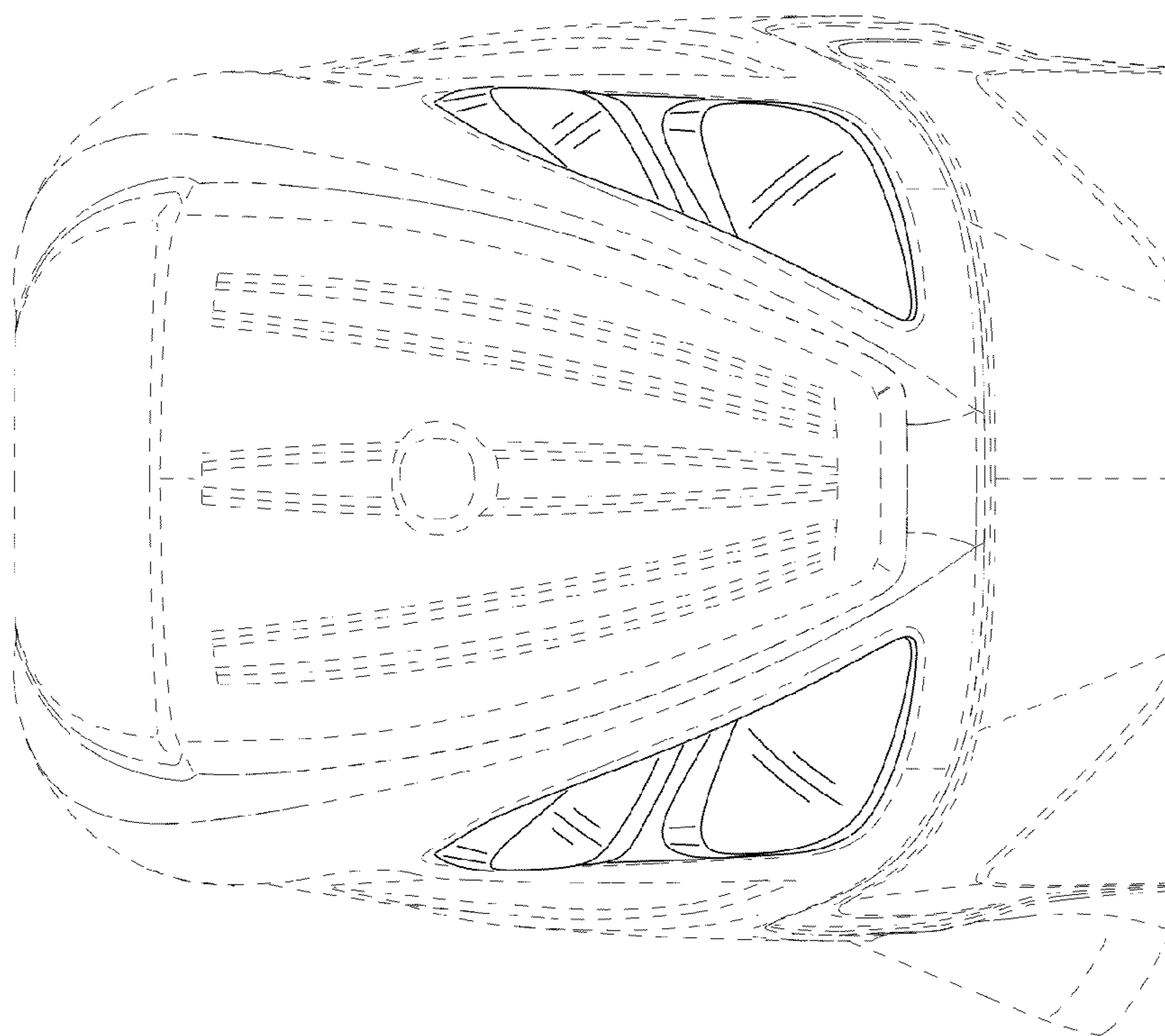

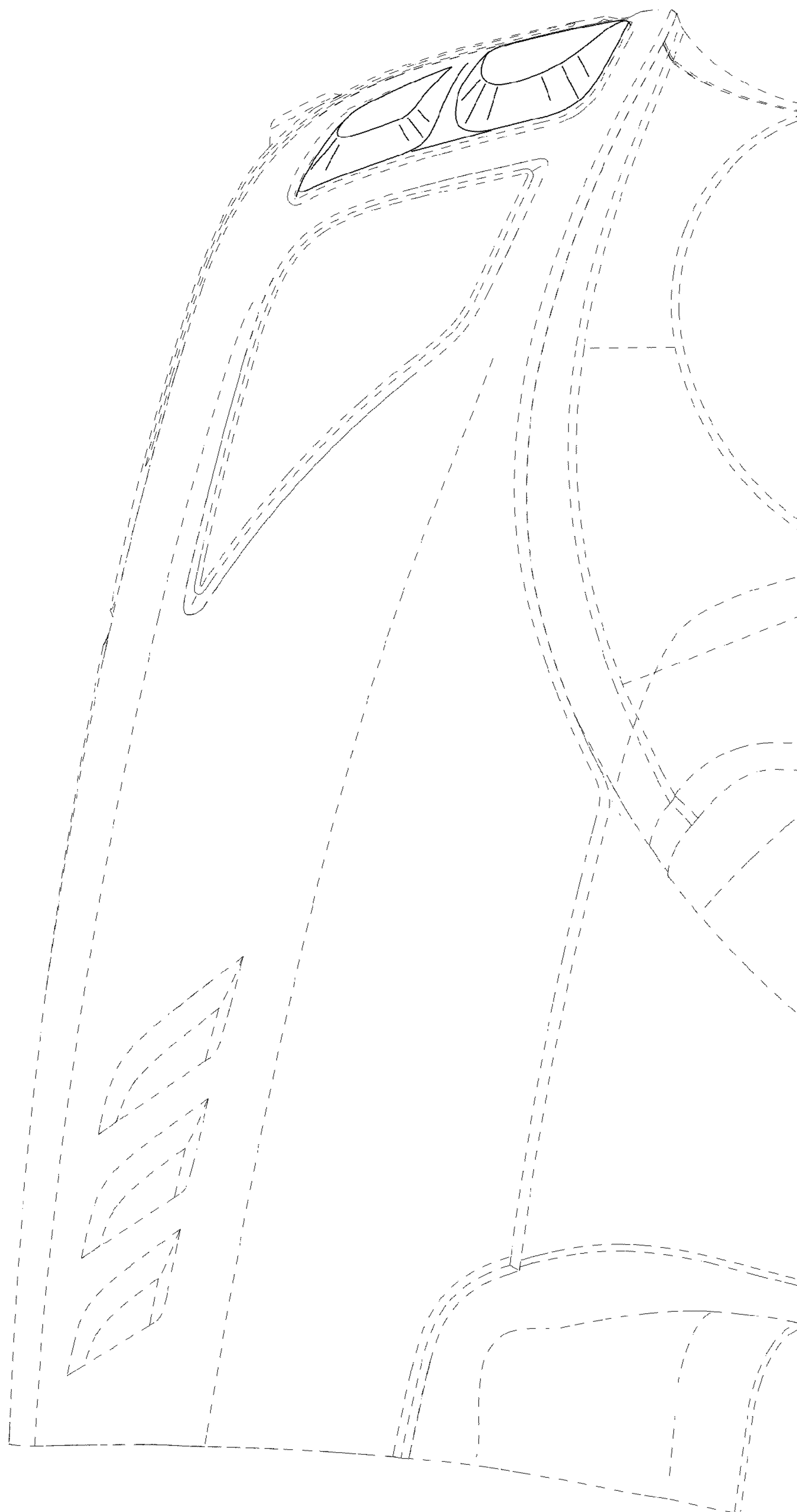

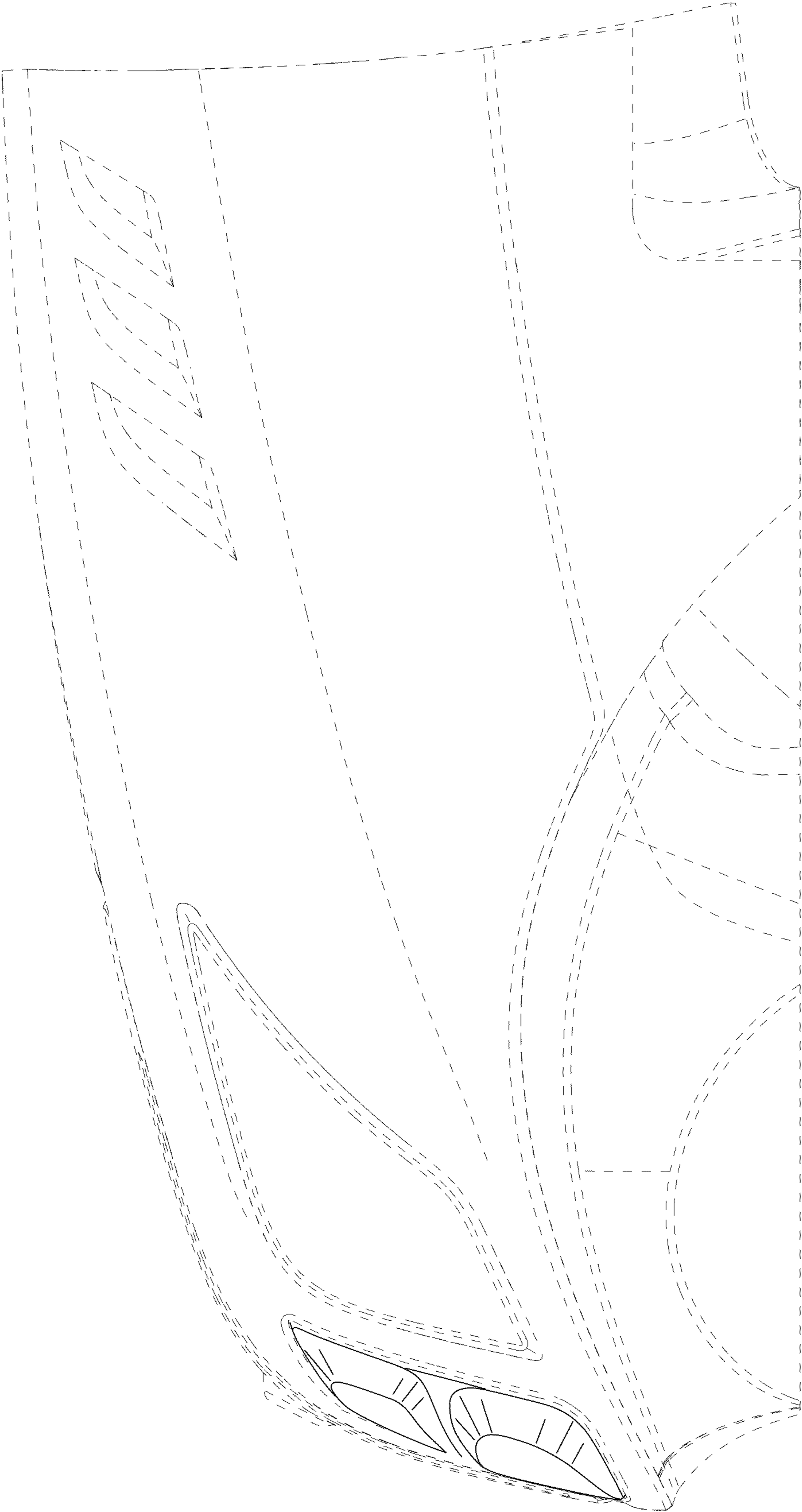

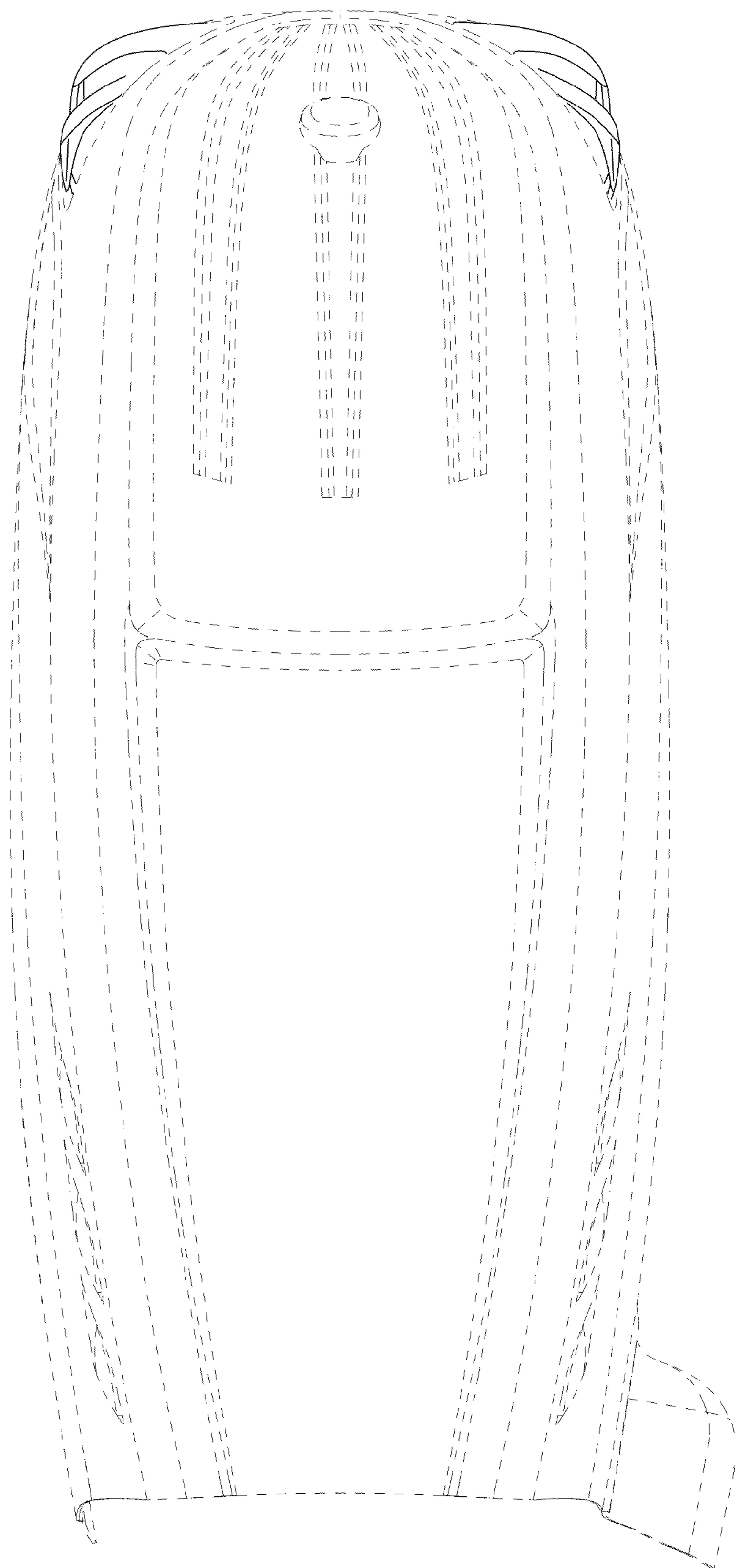

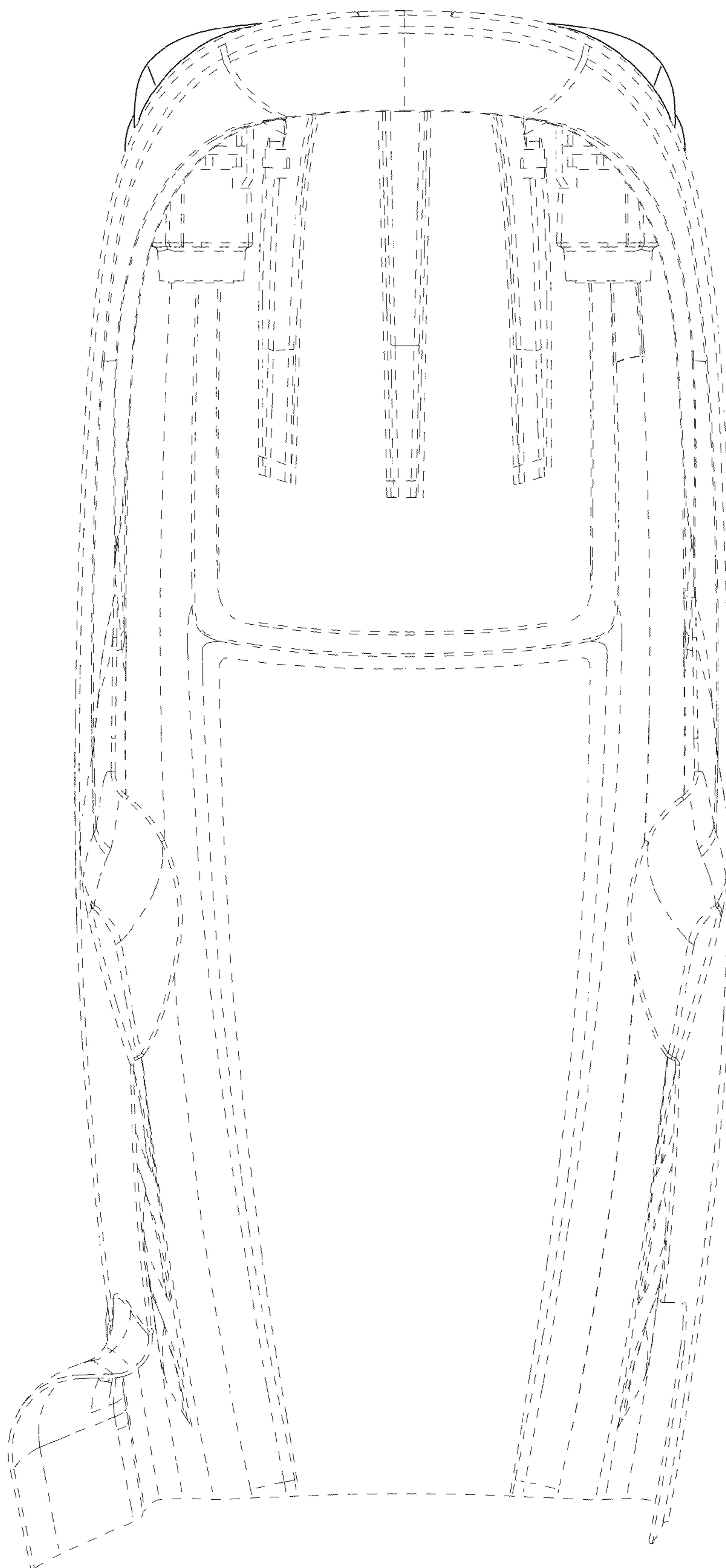

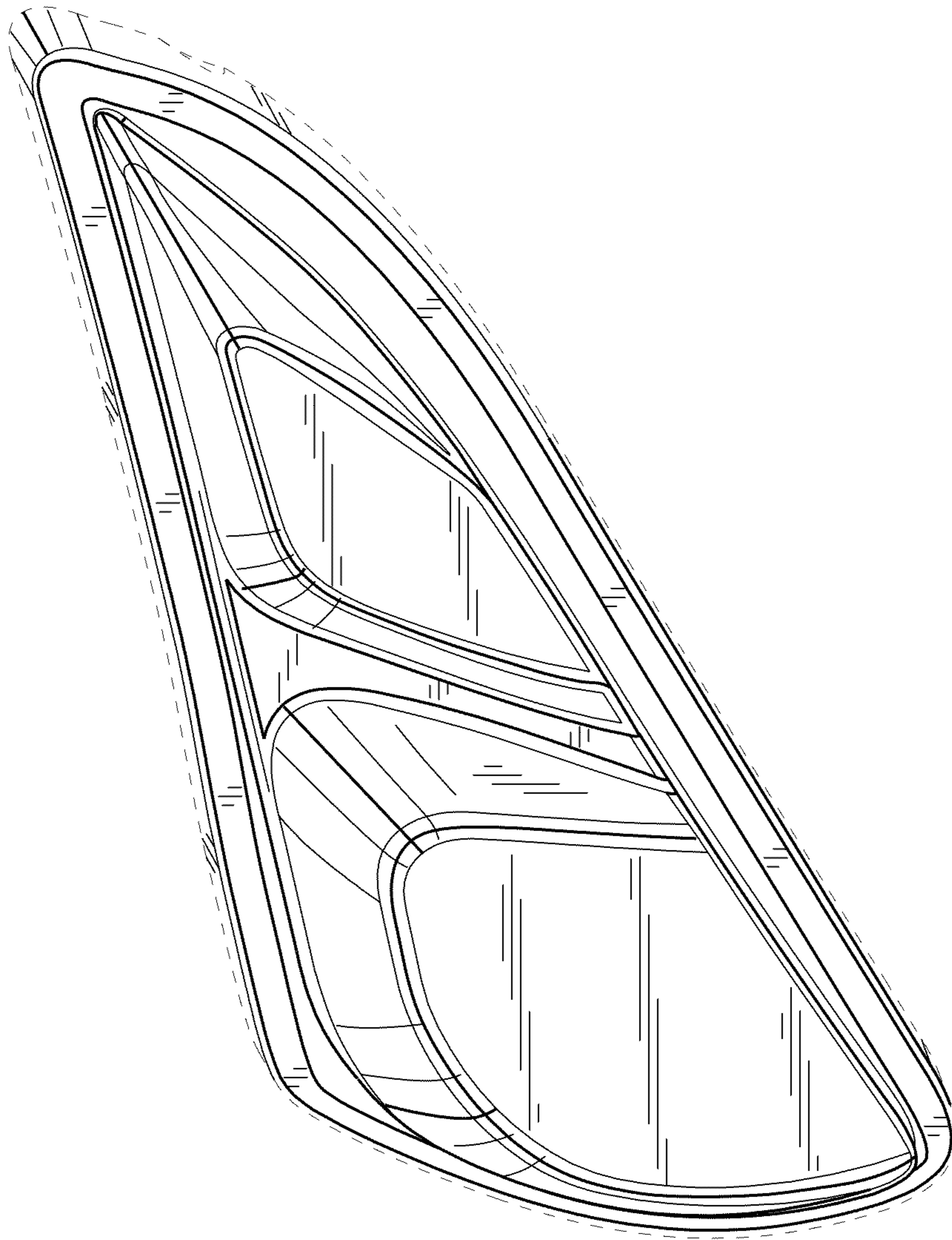

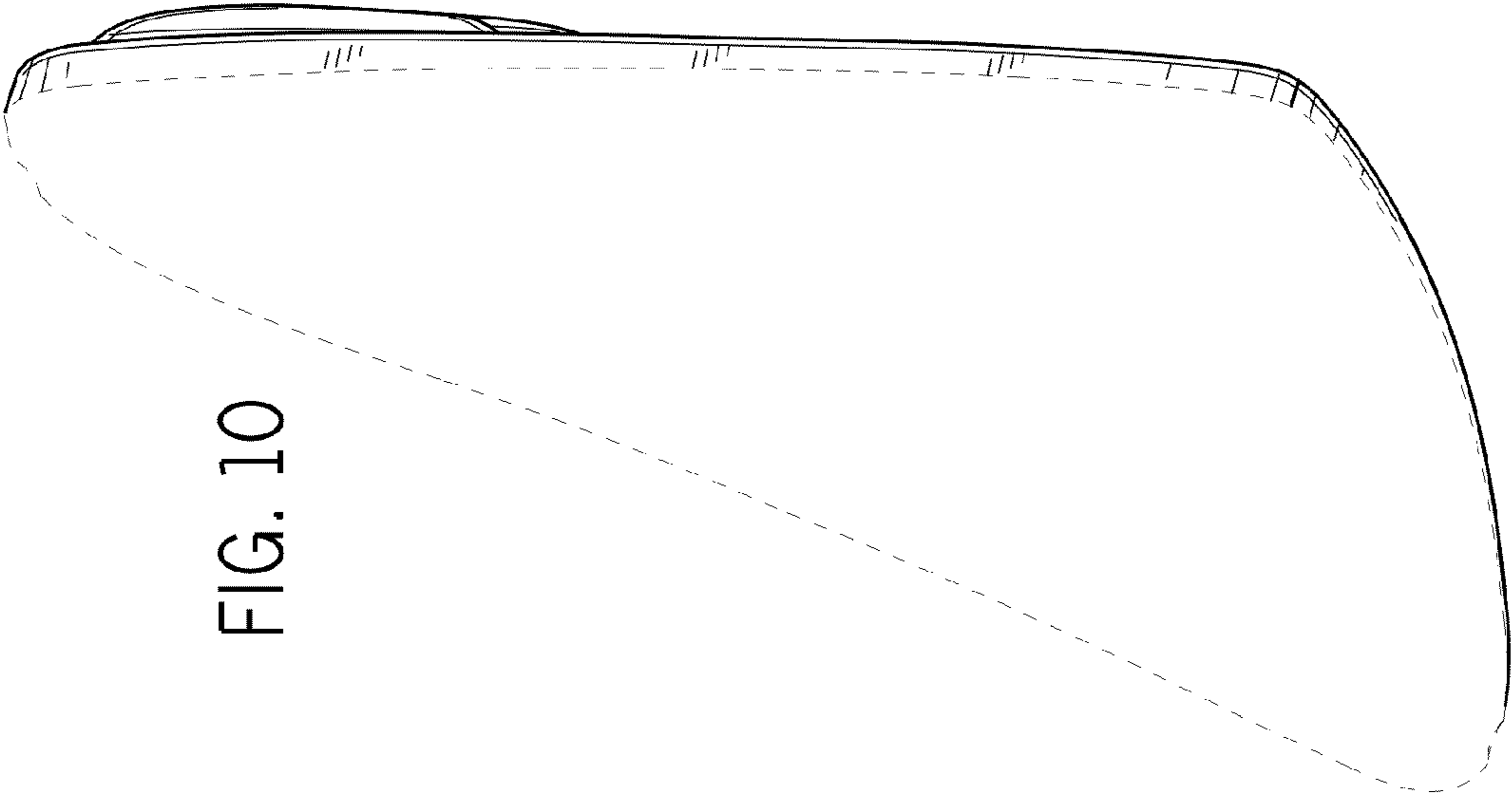

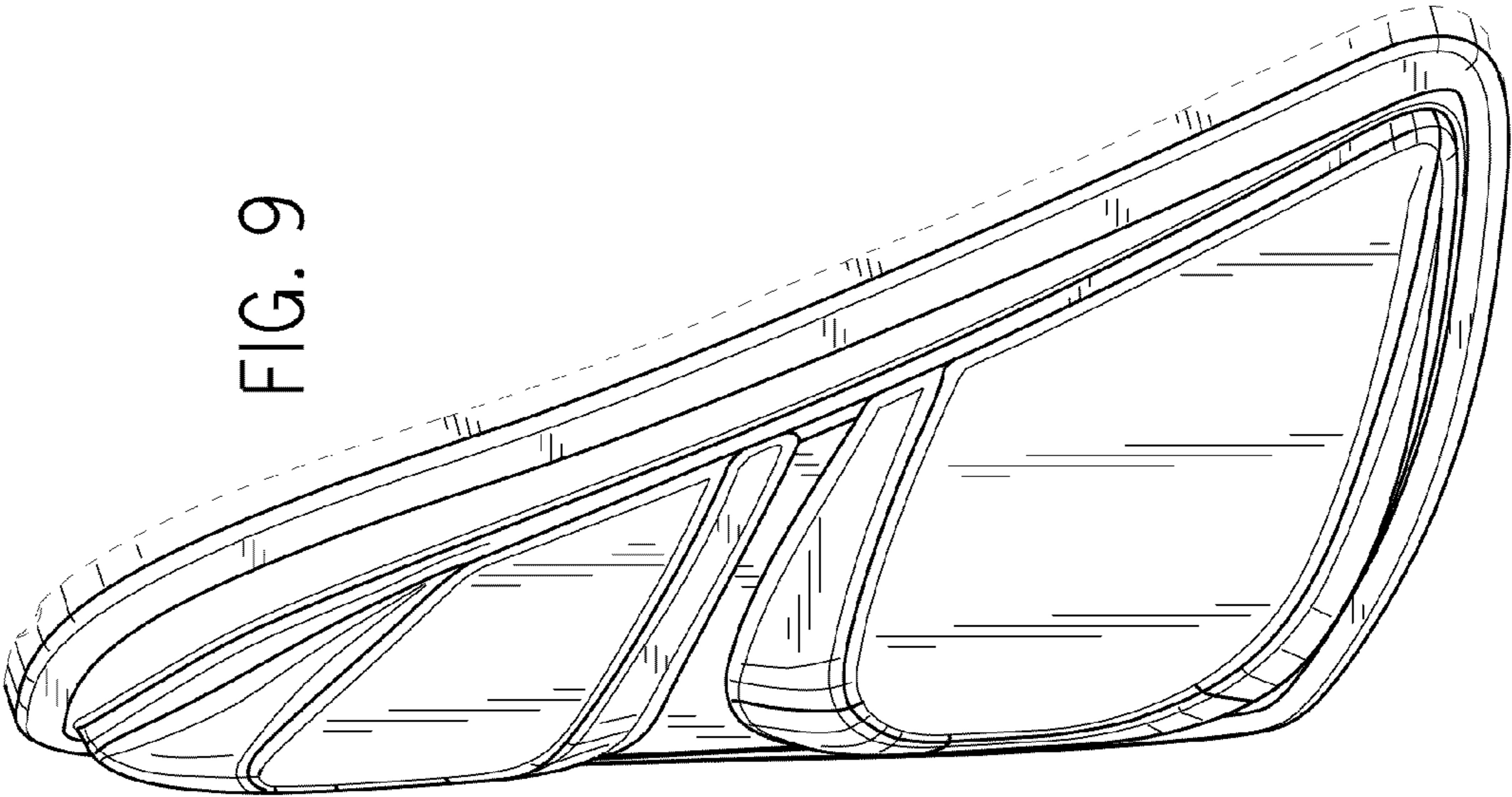

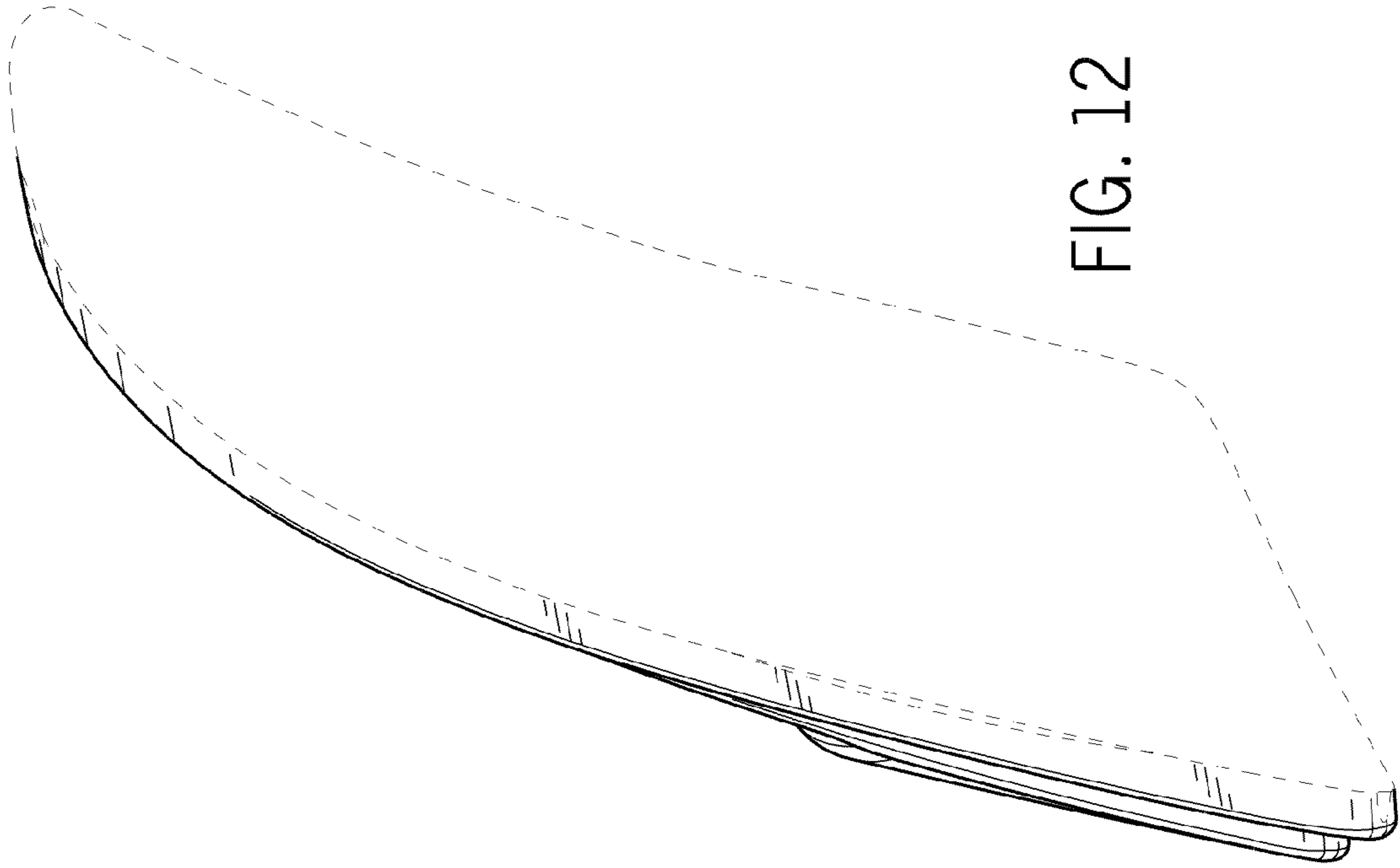

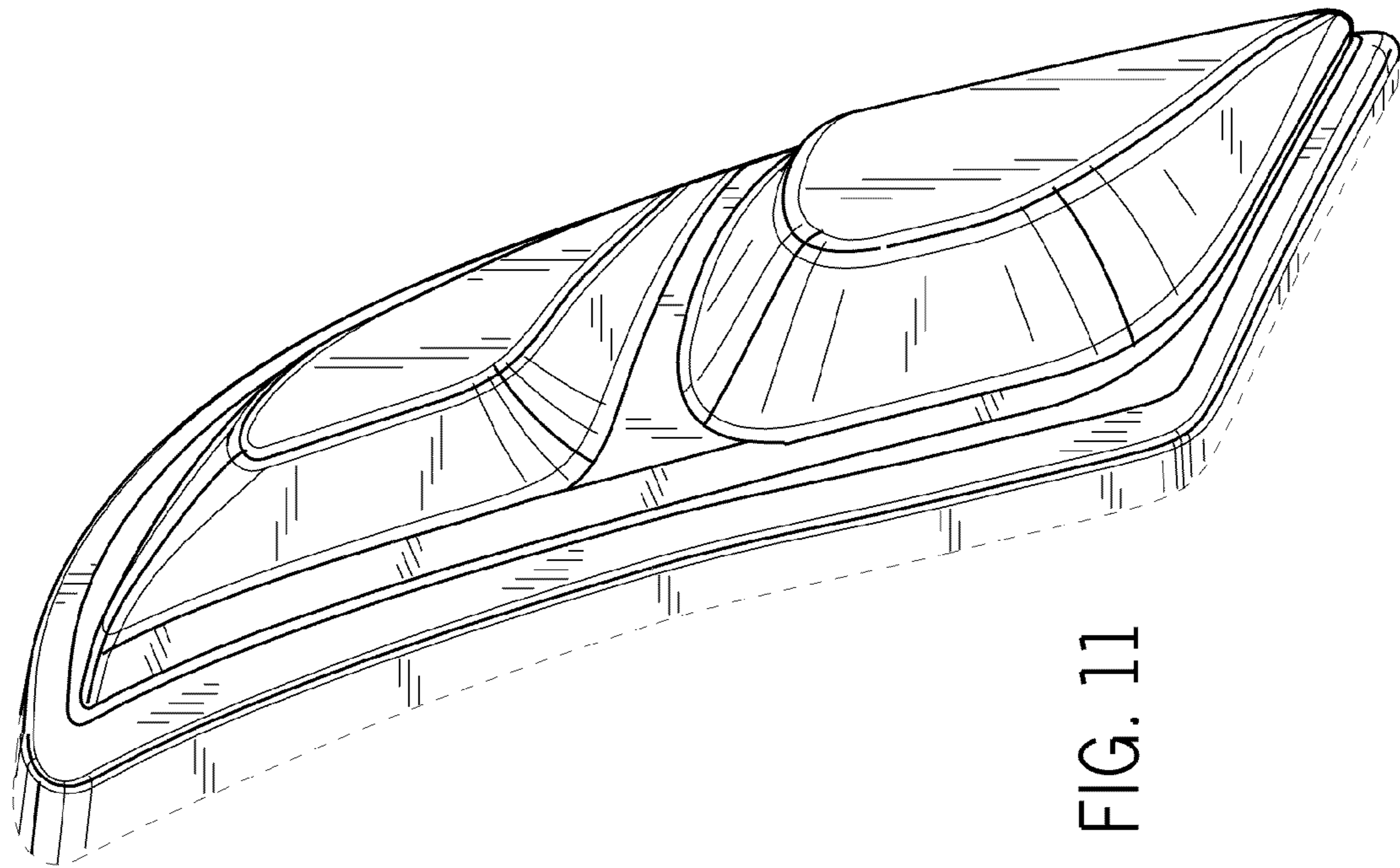

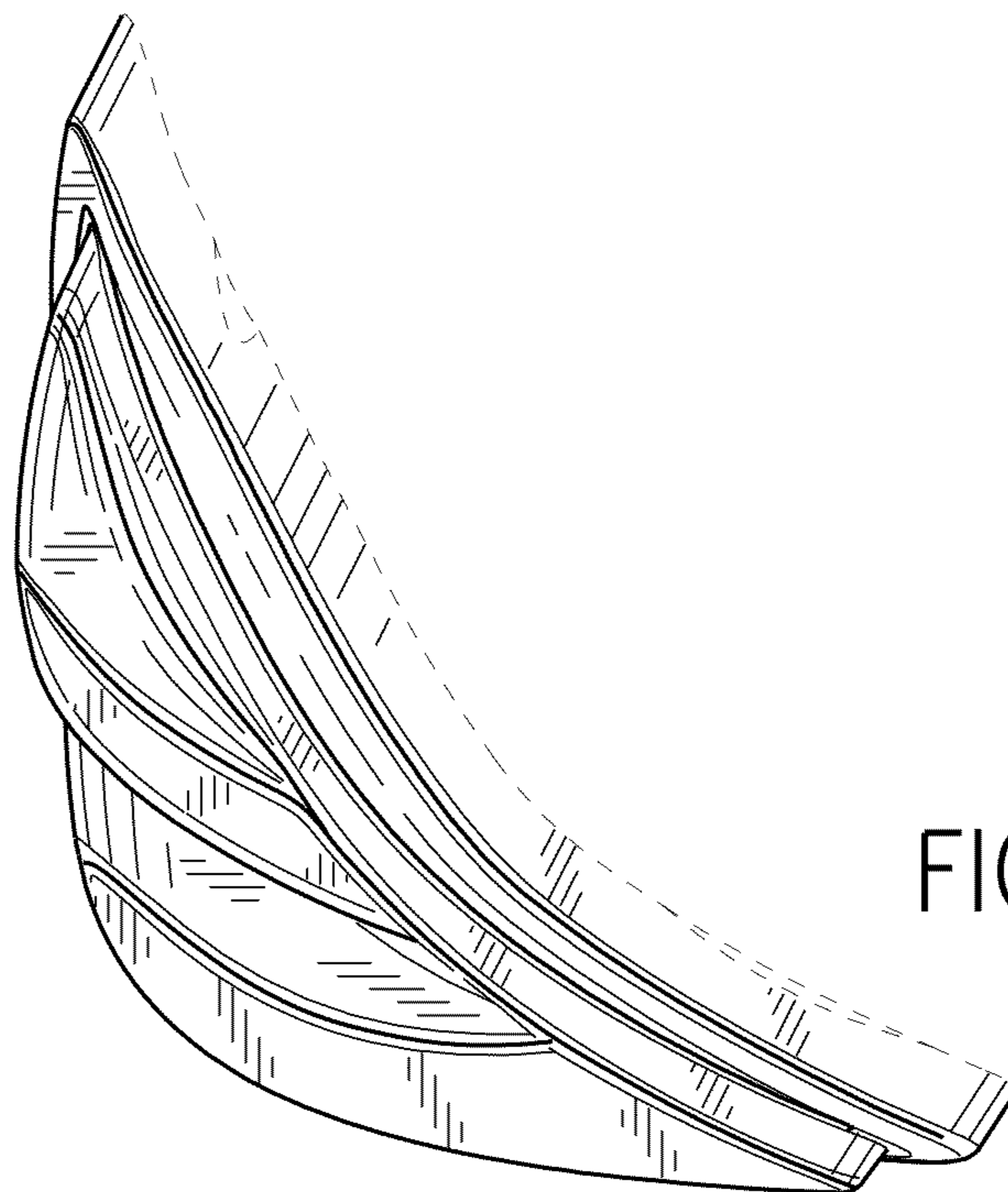

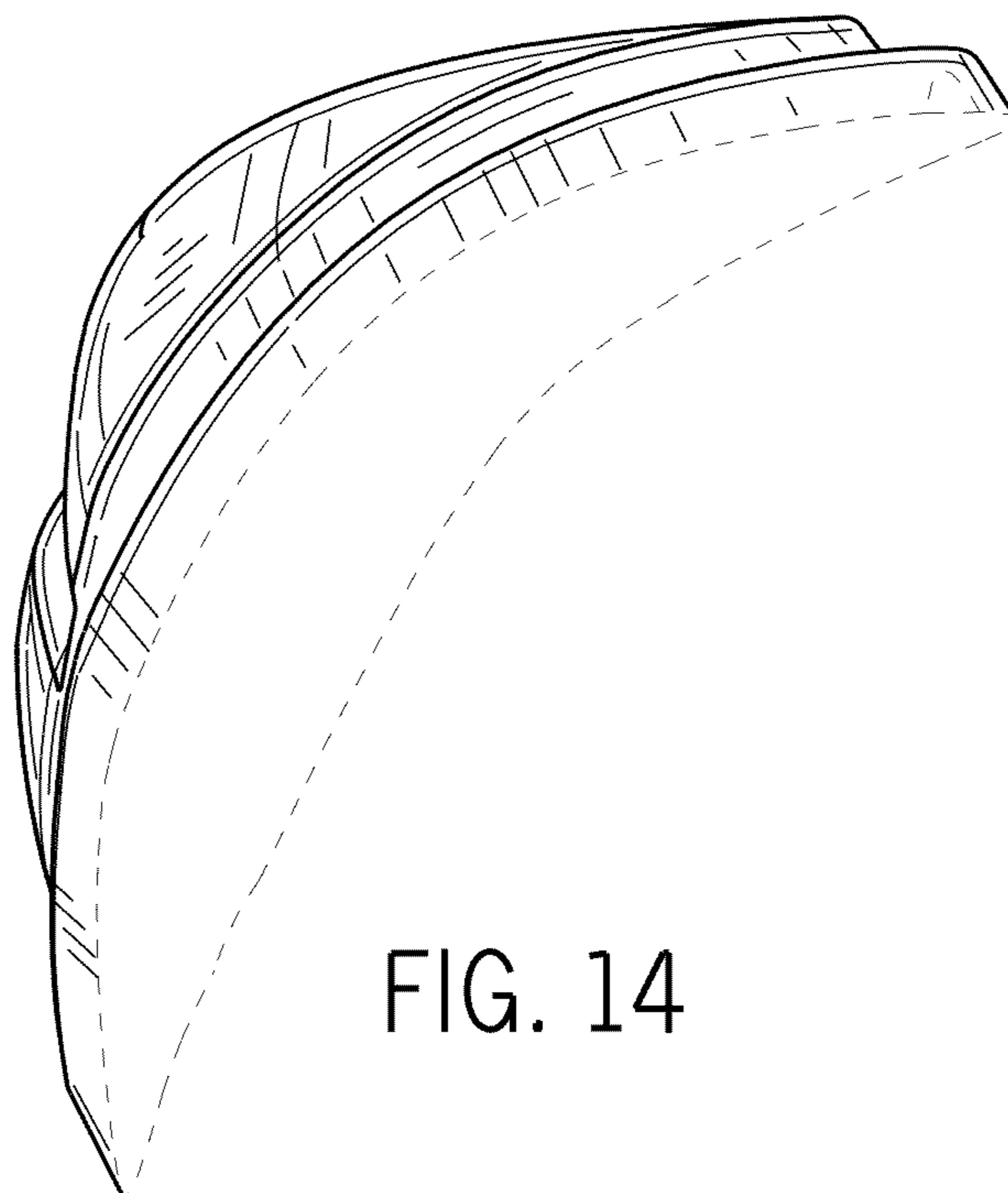
