The ornamental design for a “electronic cigarette case,” as shown and described.

DESCRIPTION

FIG. 15 is a left side elevational view of FIG. 10;

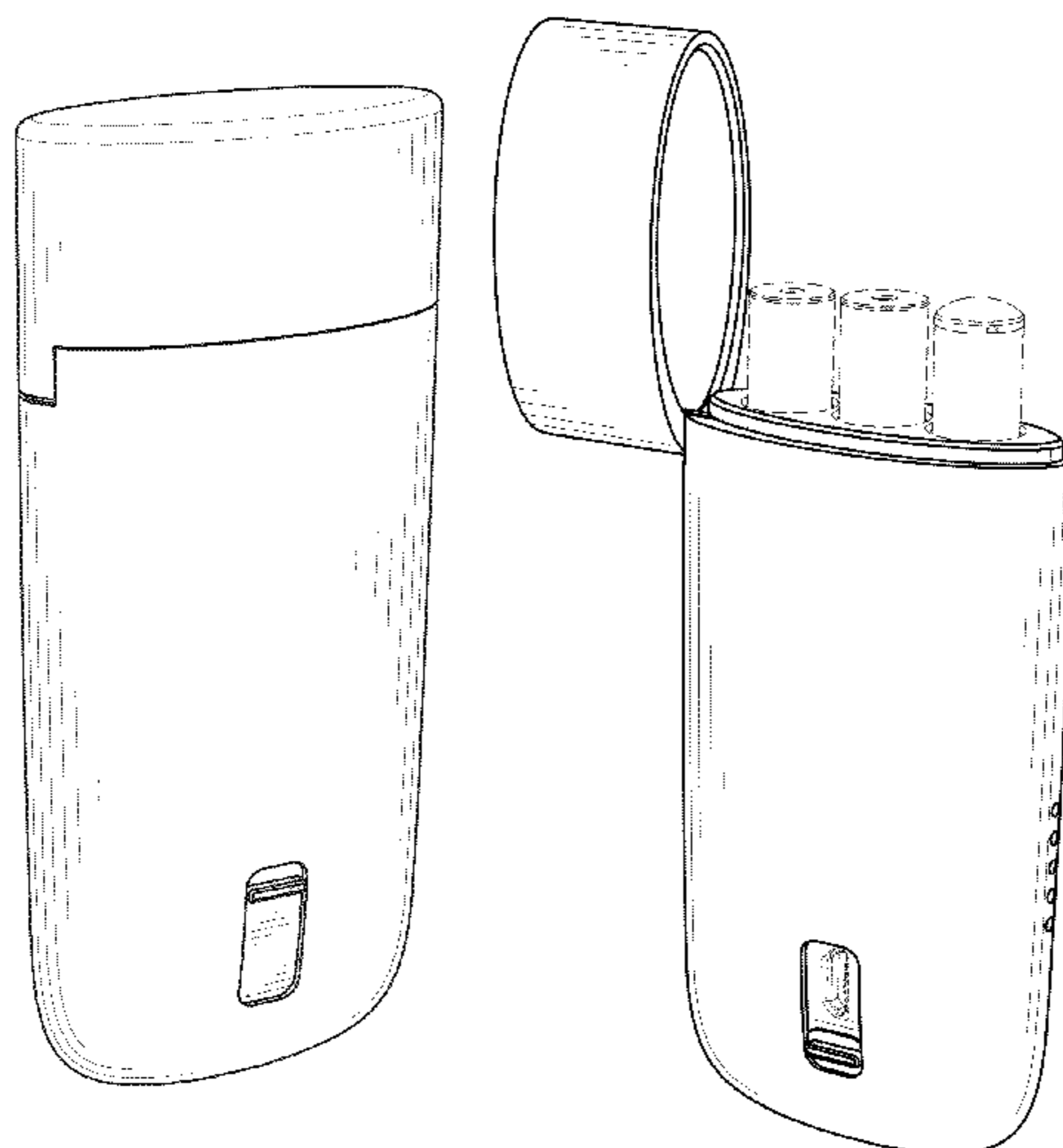
FIG. 16 is a top plan view of FIG. 10;

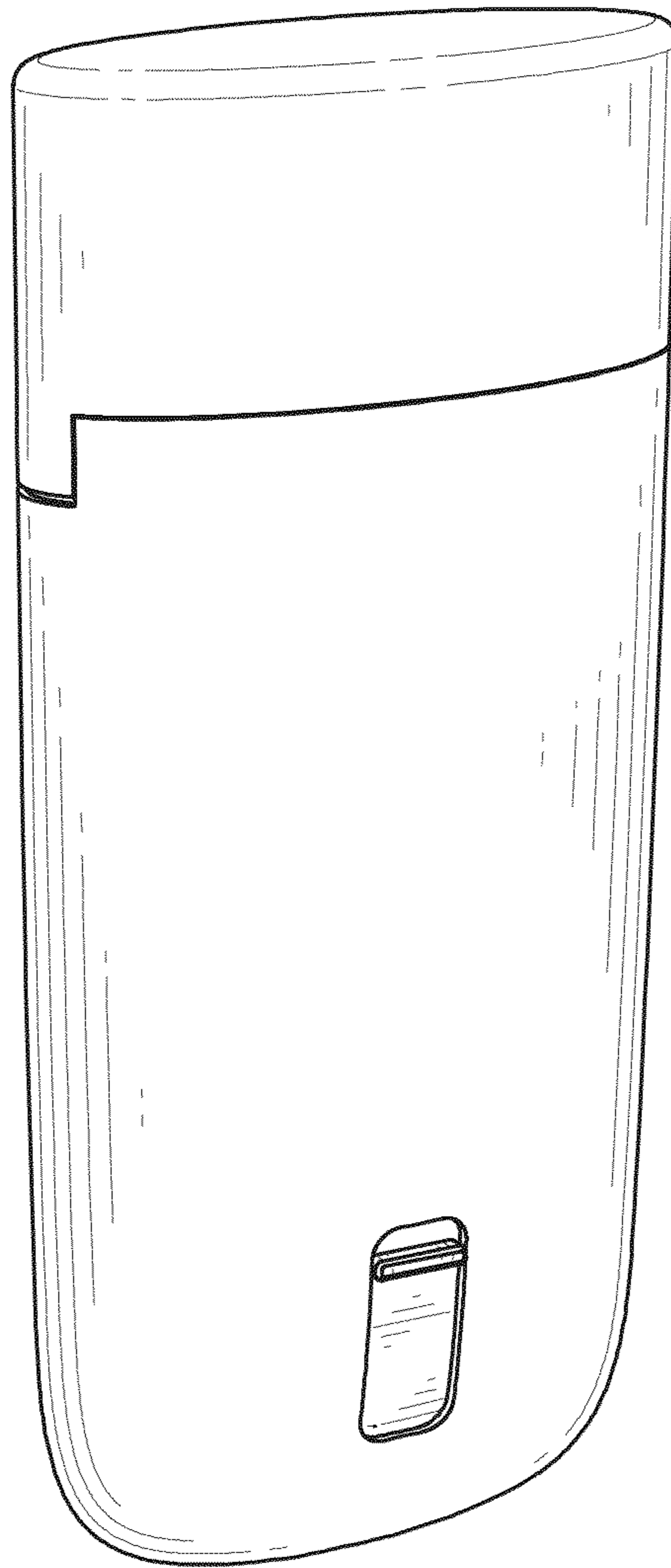

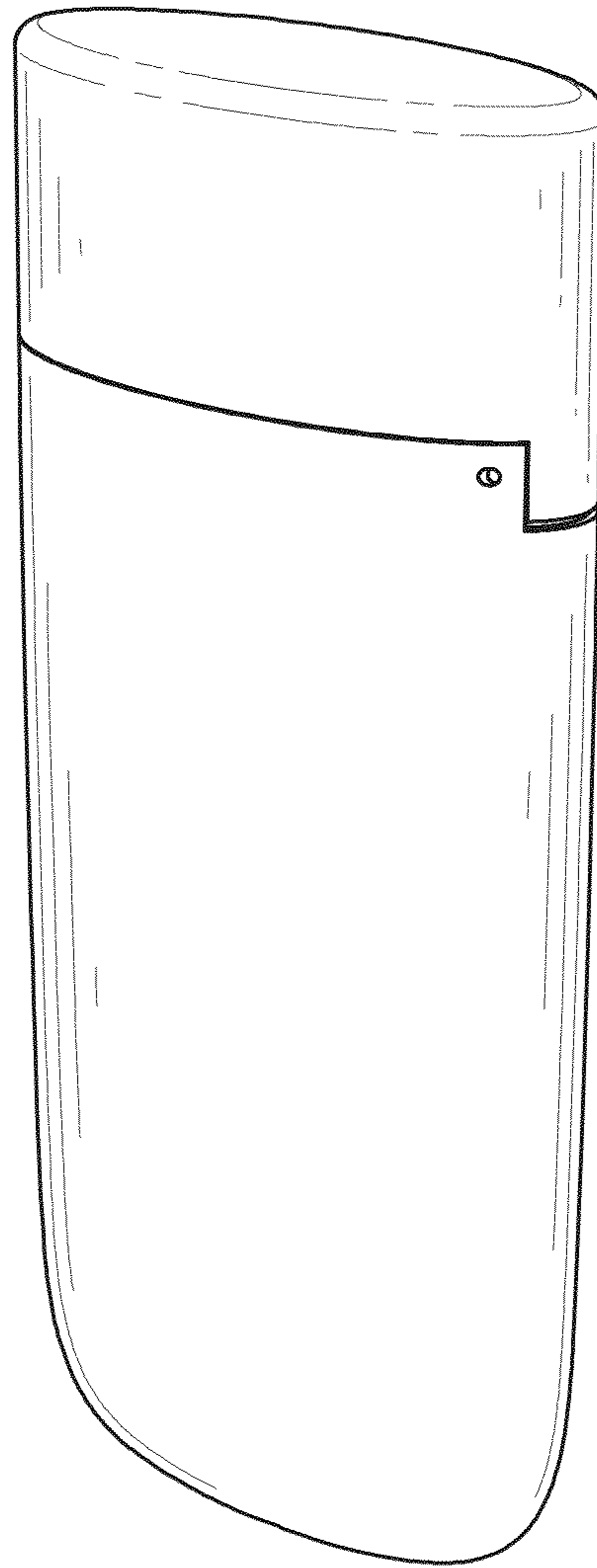

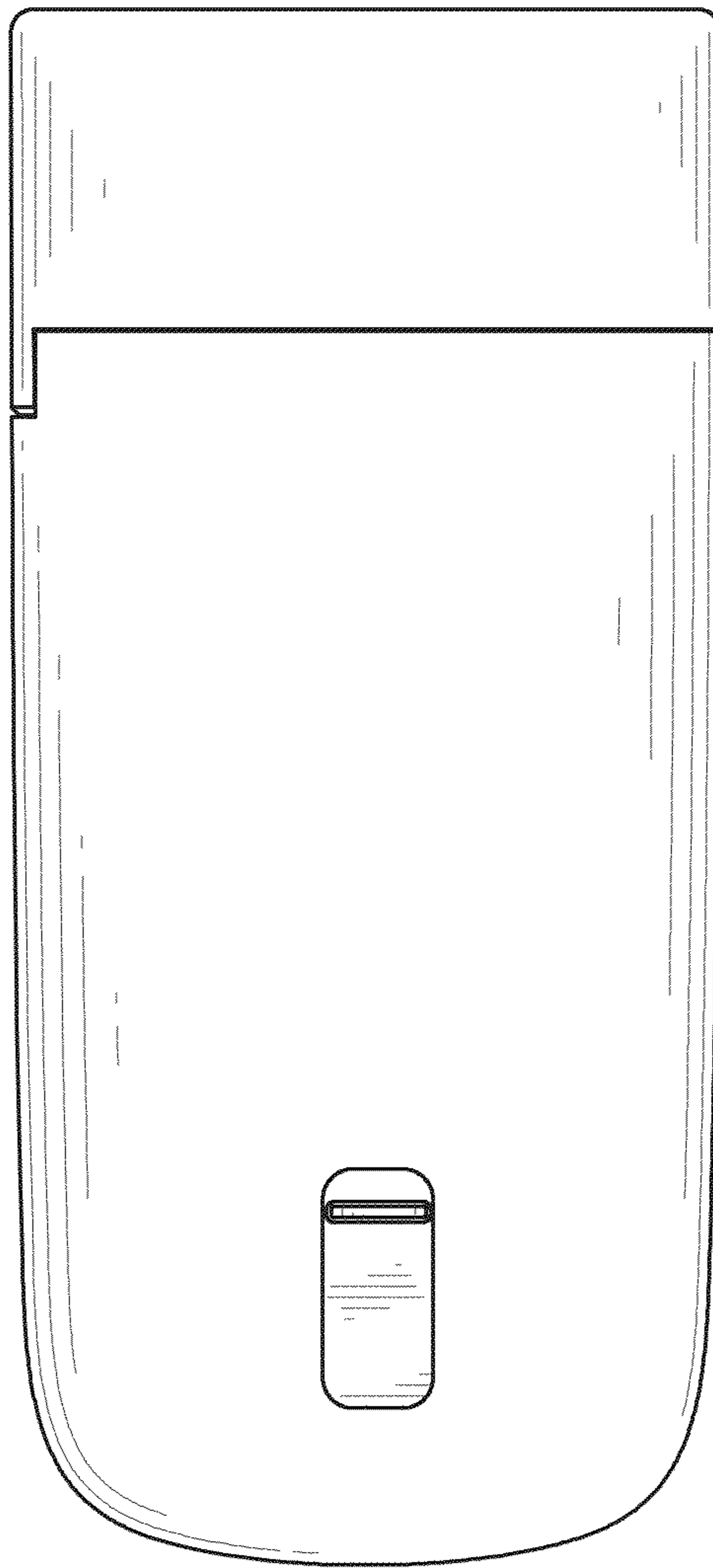

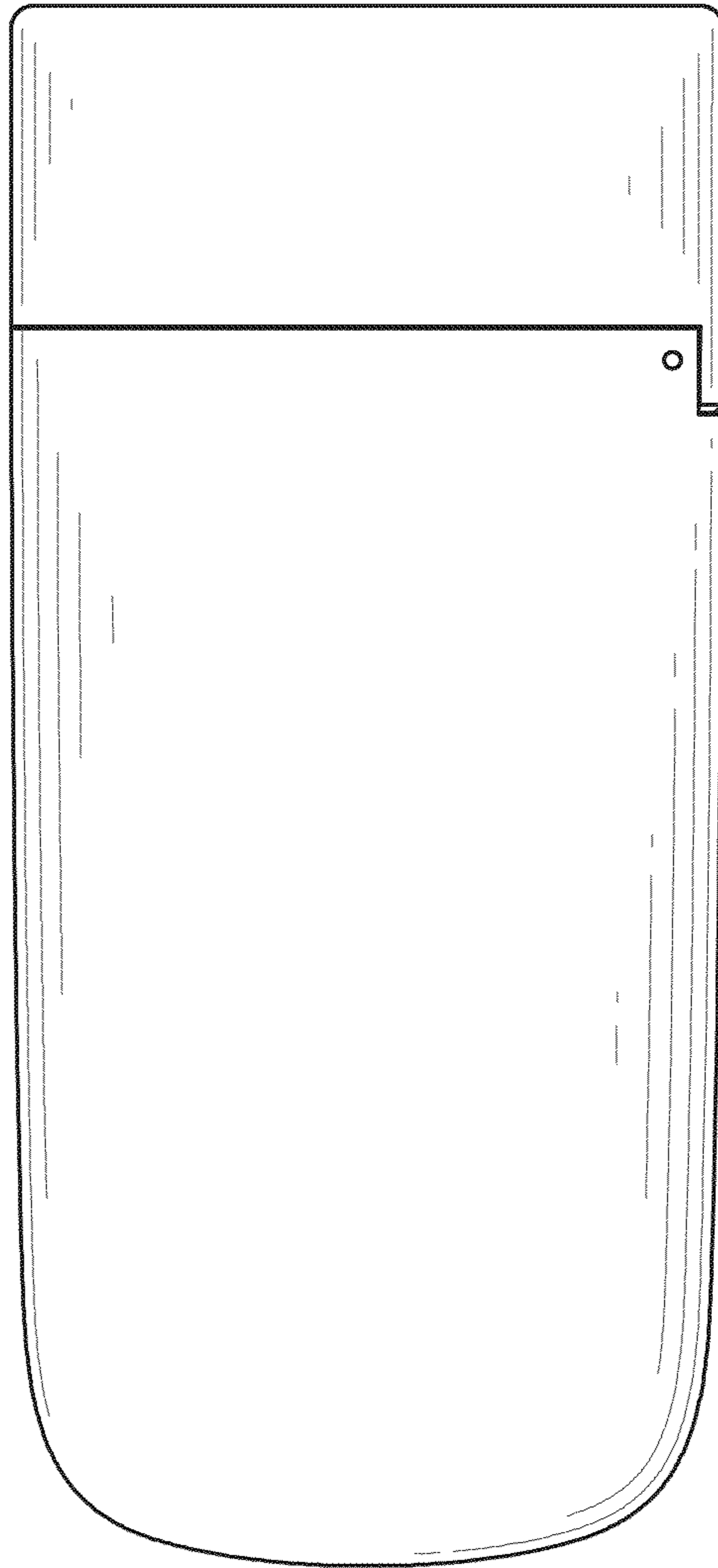

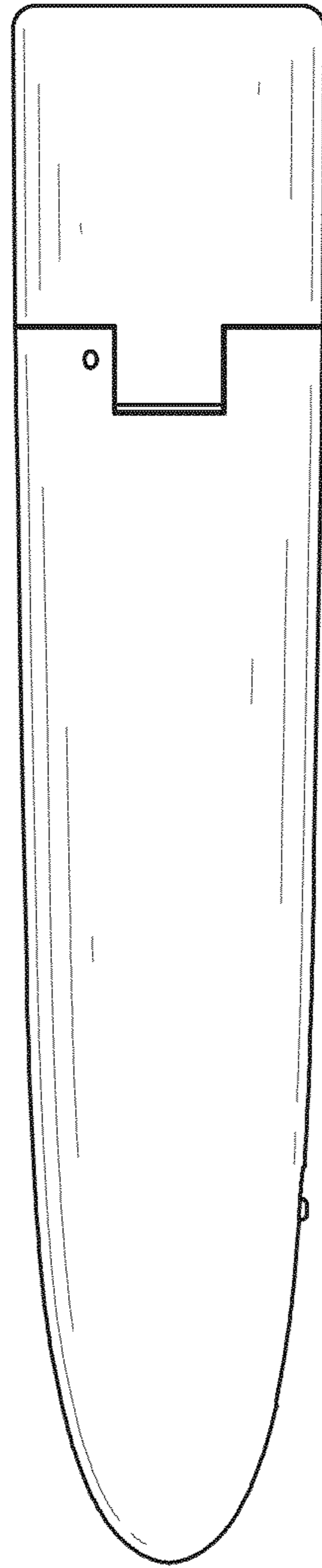

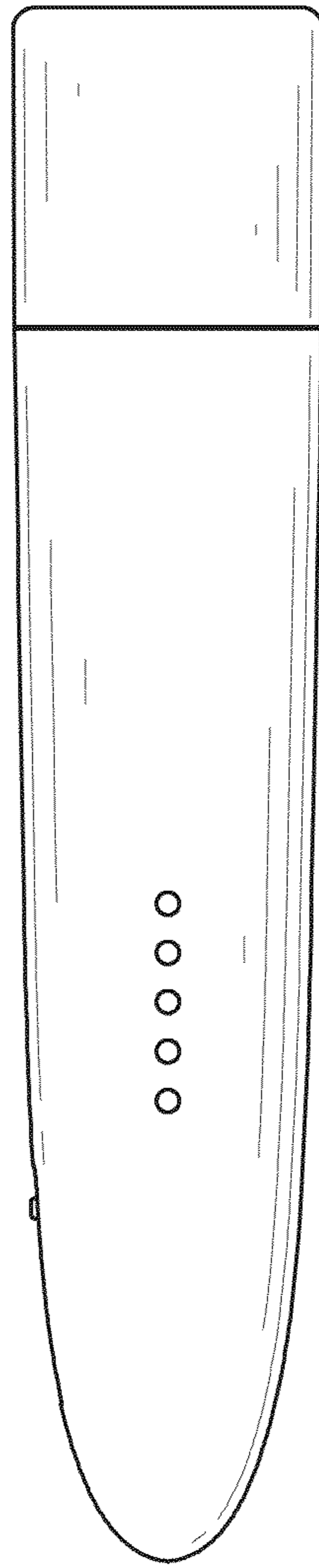

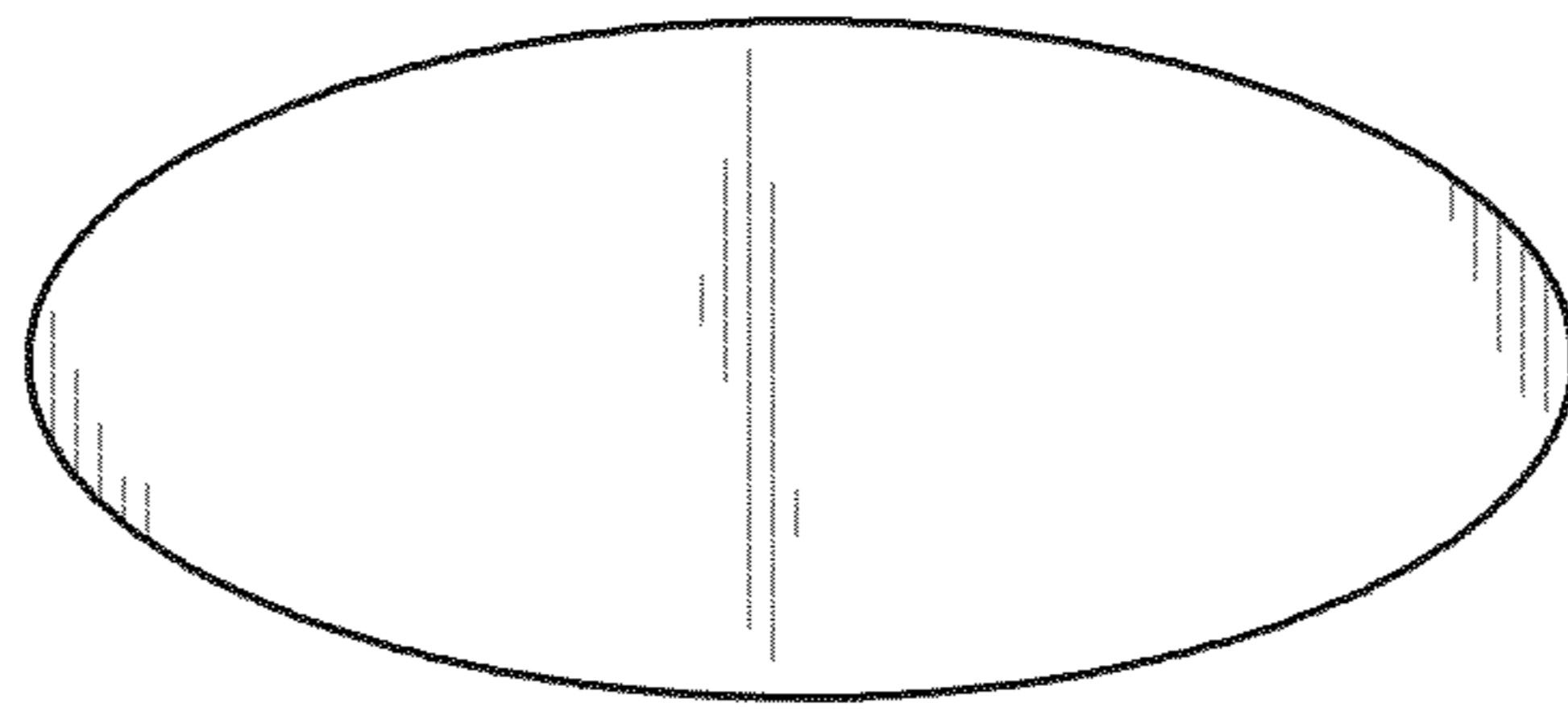

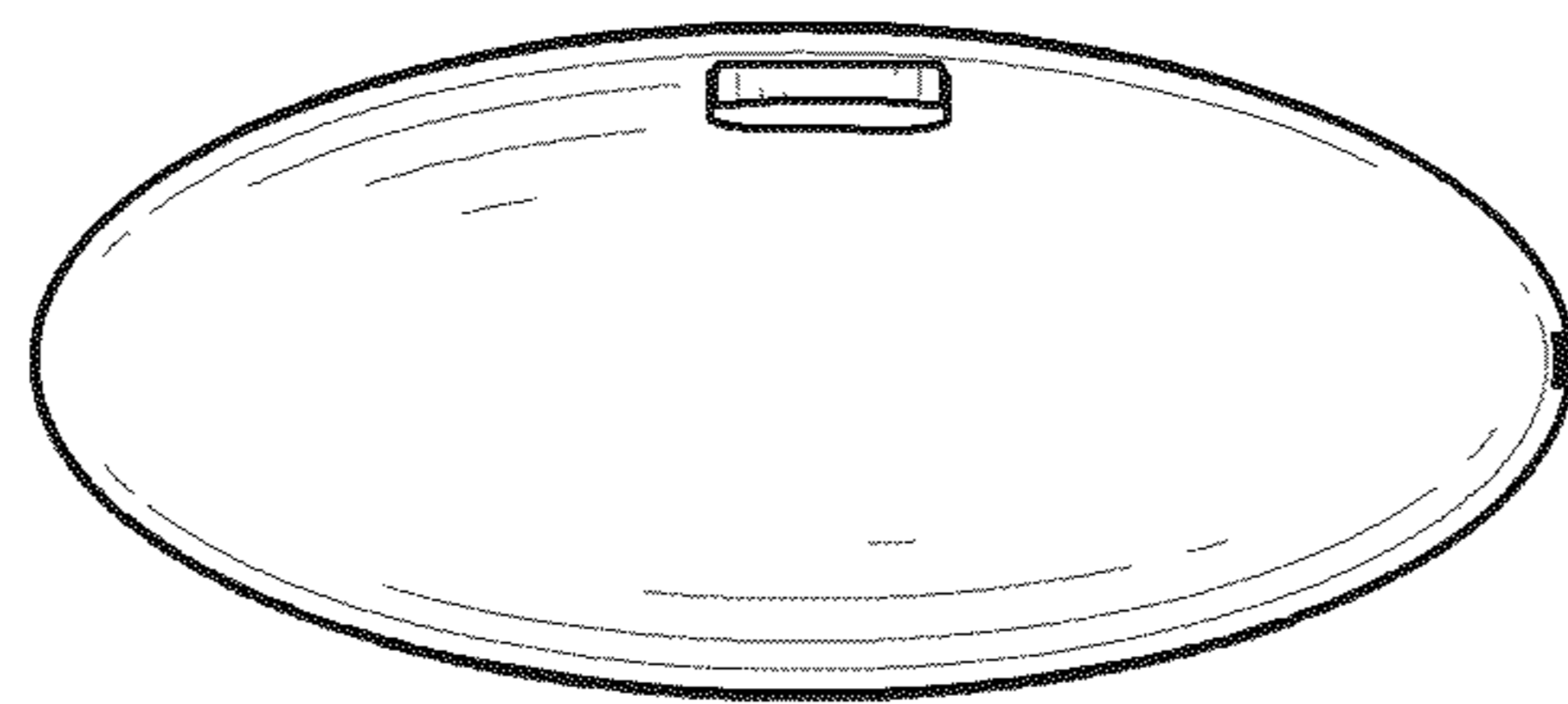

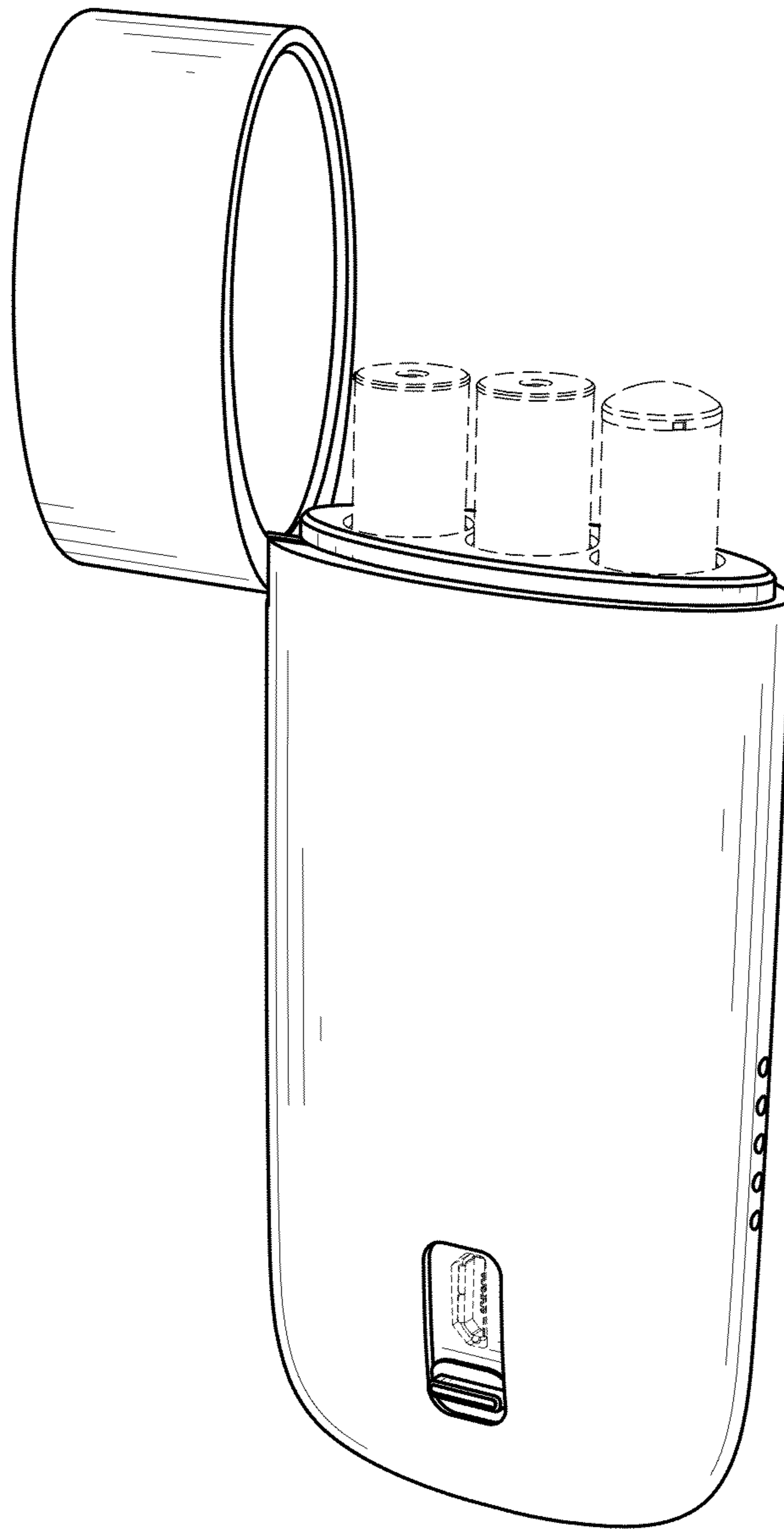

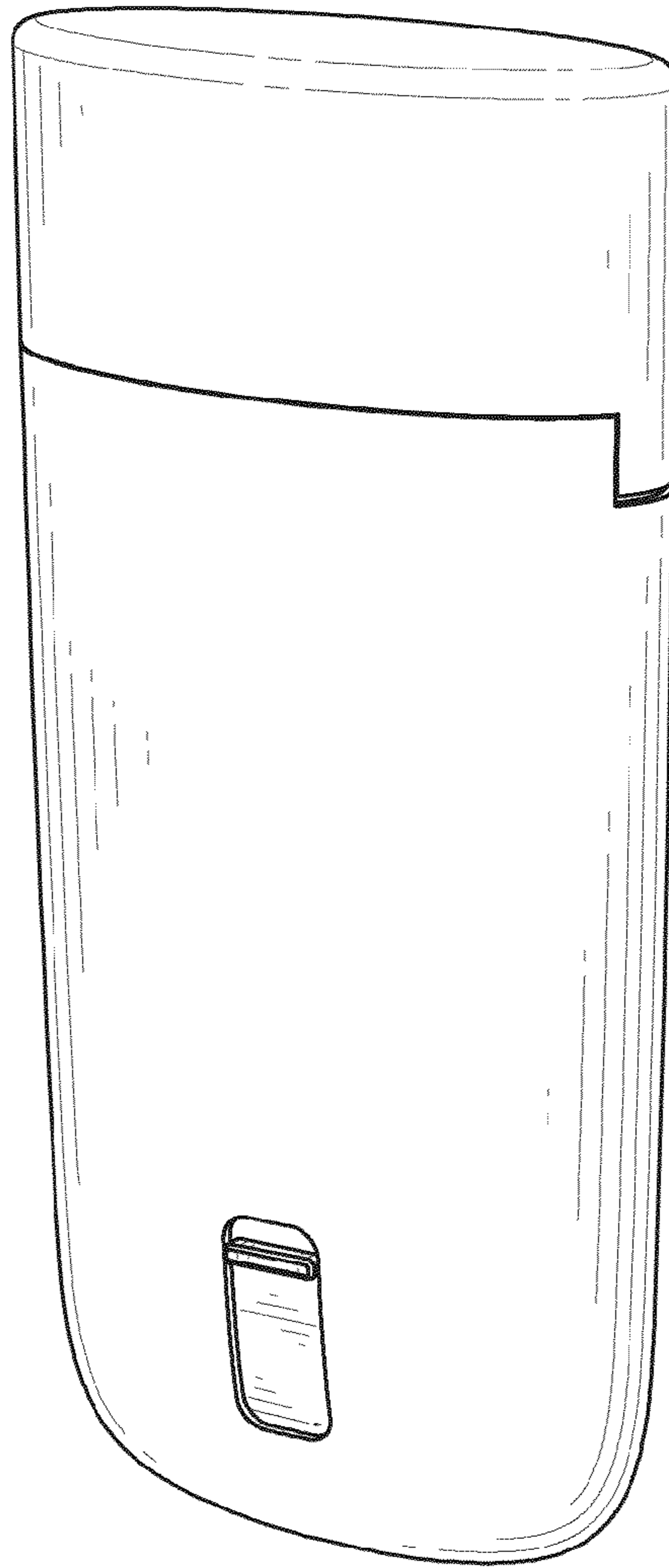

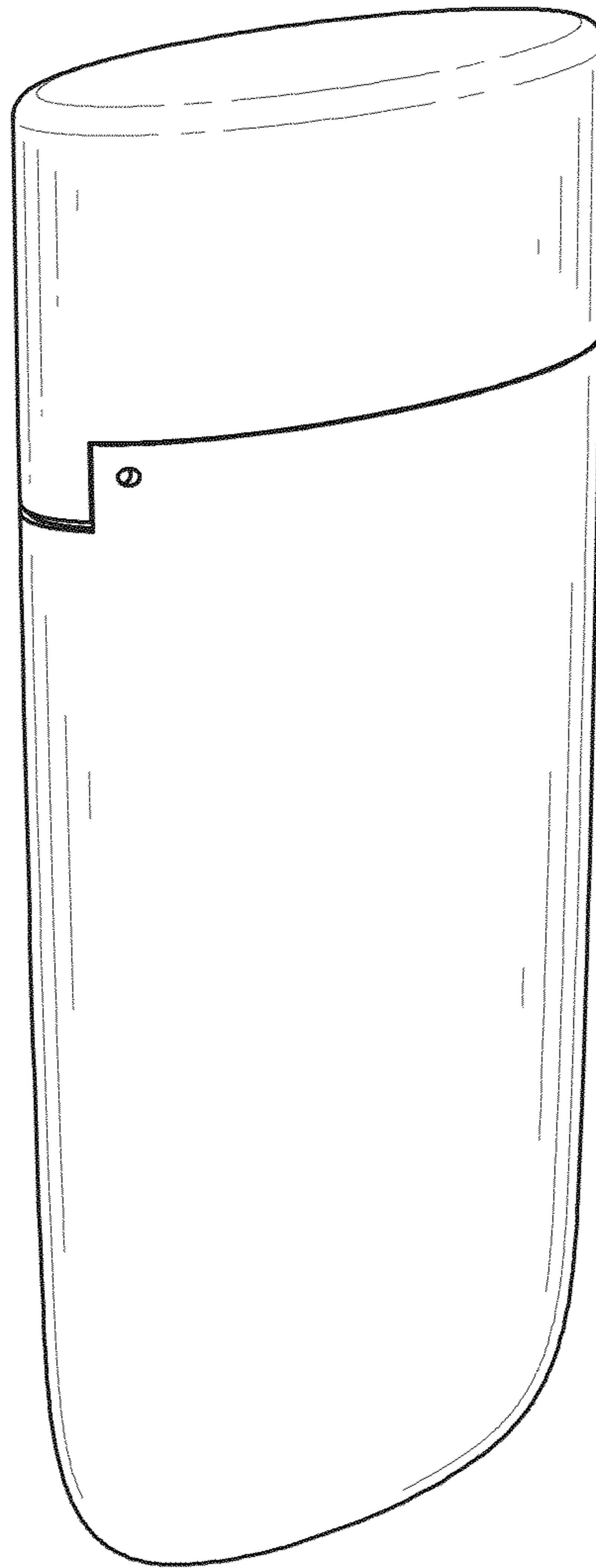

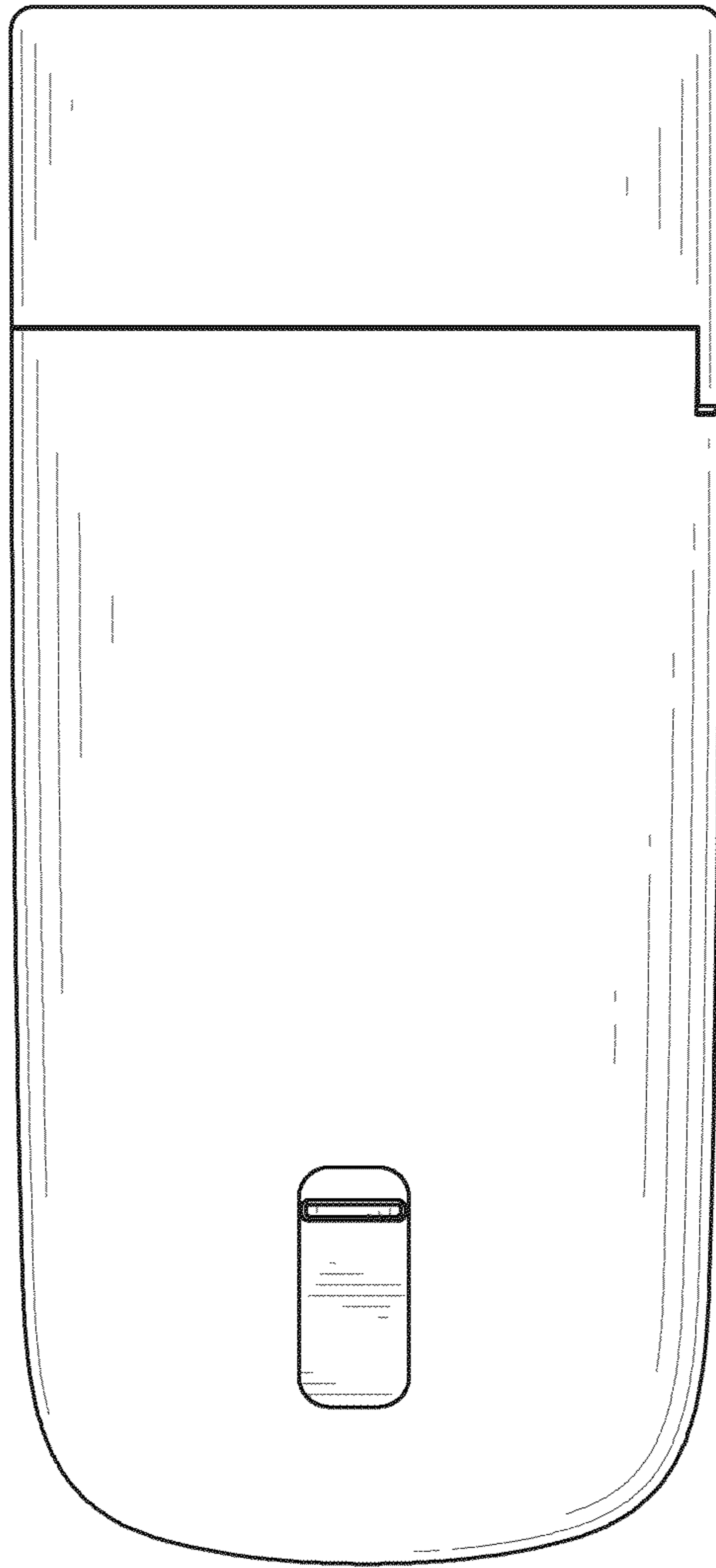

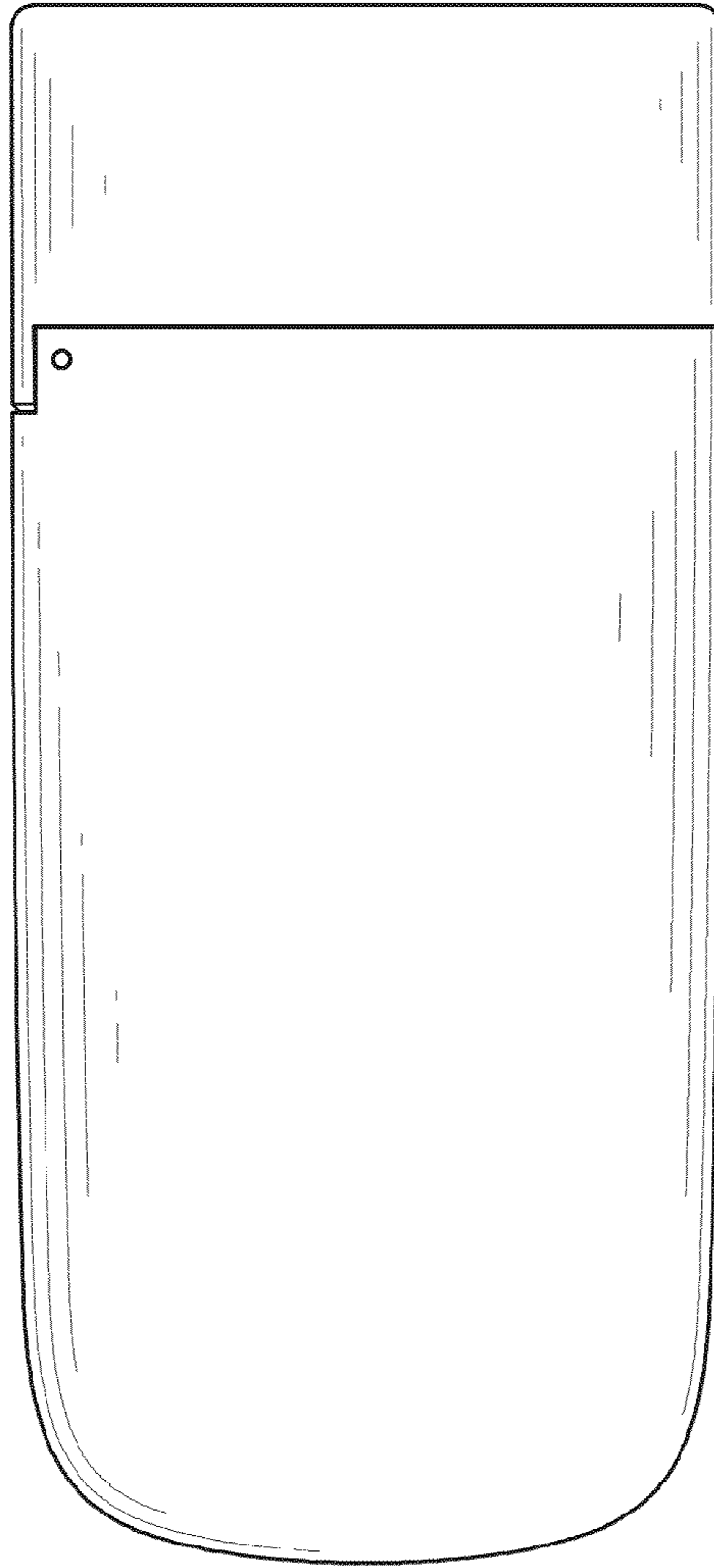

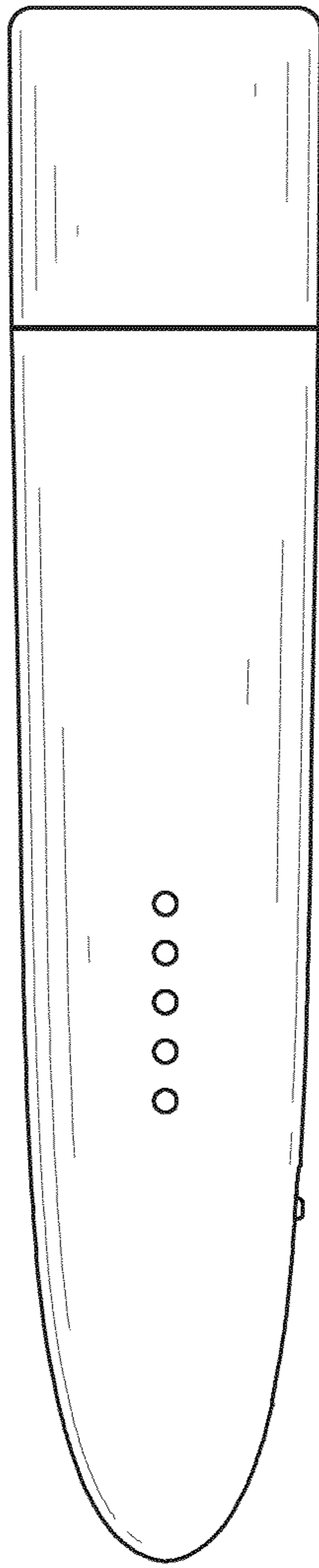

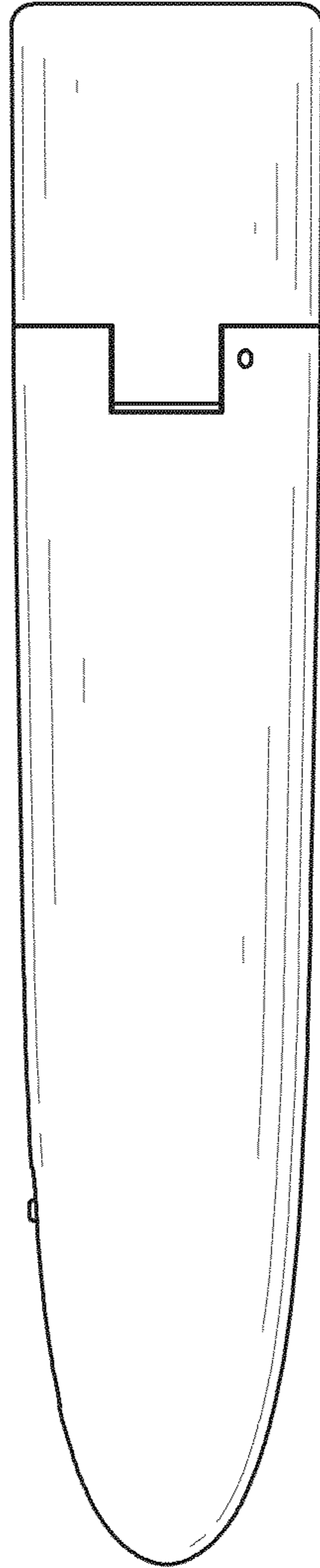

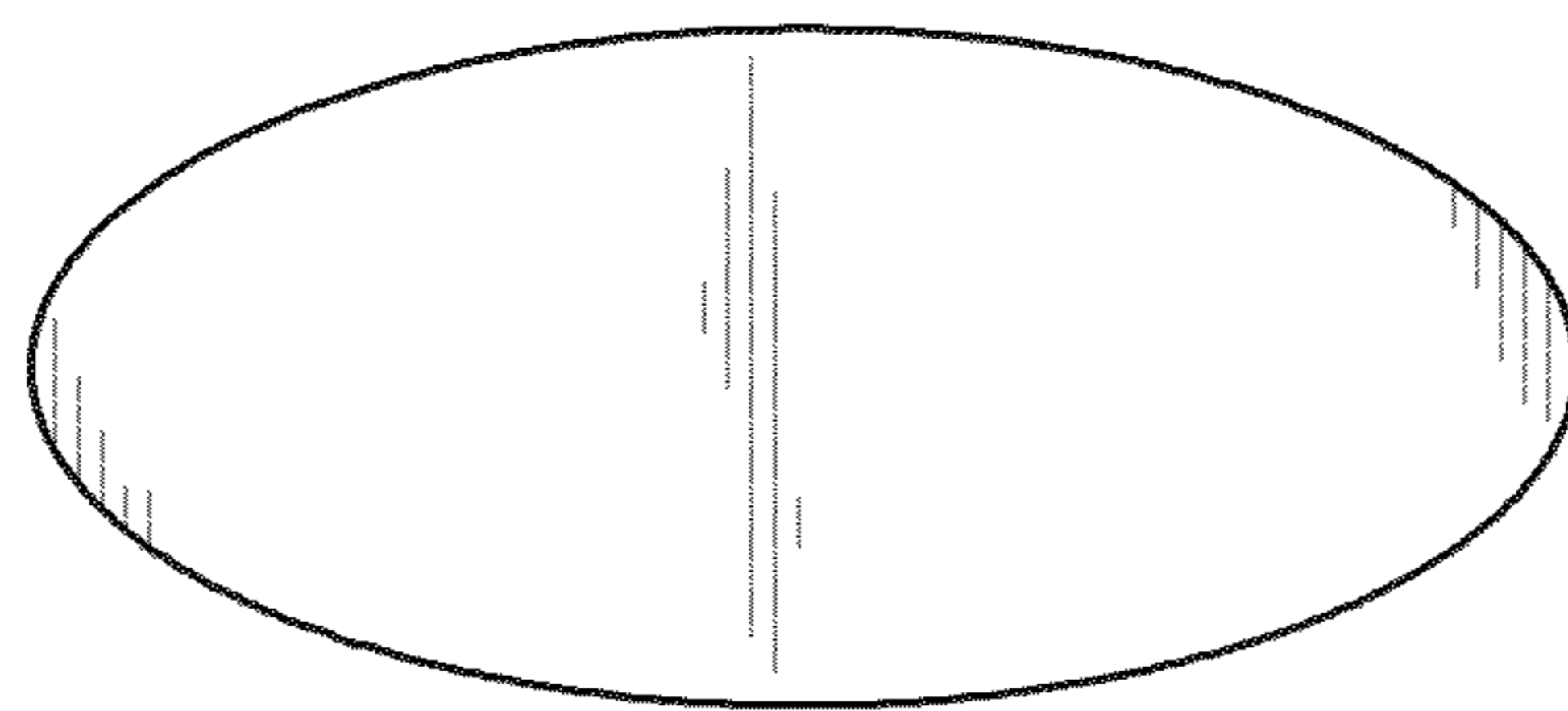

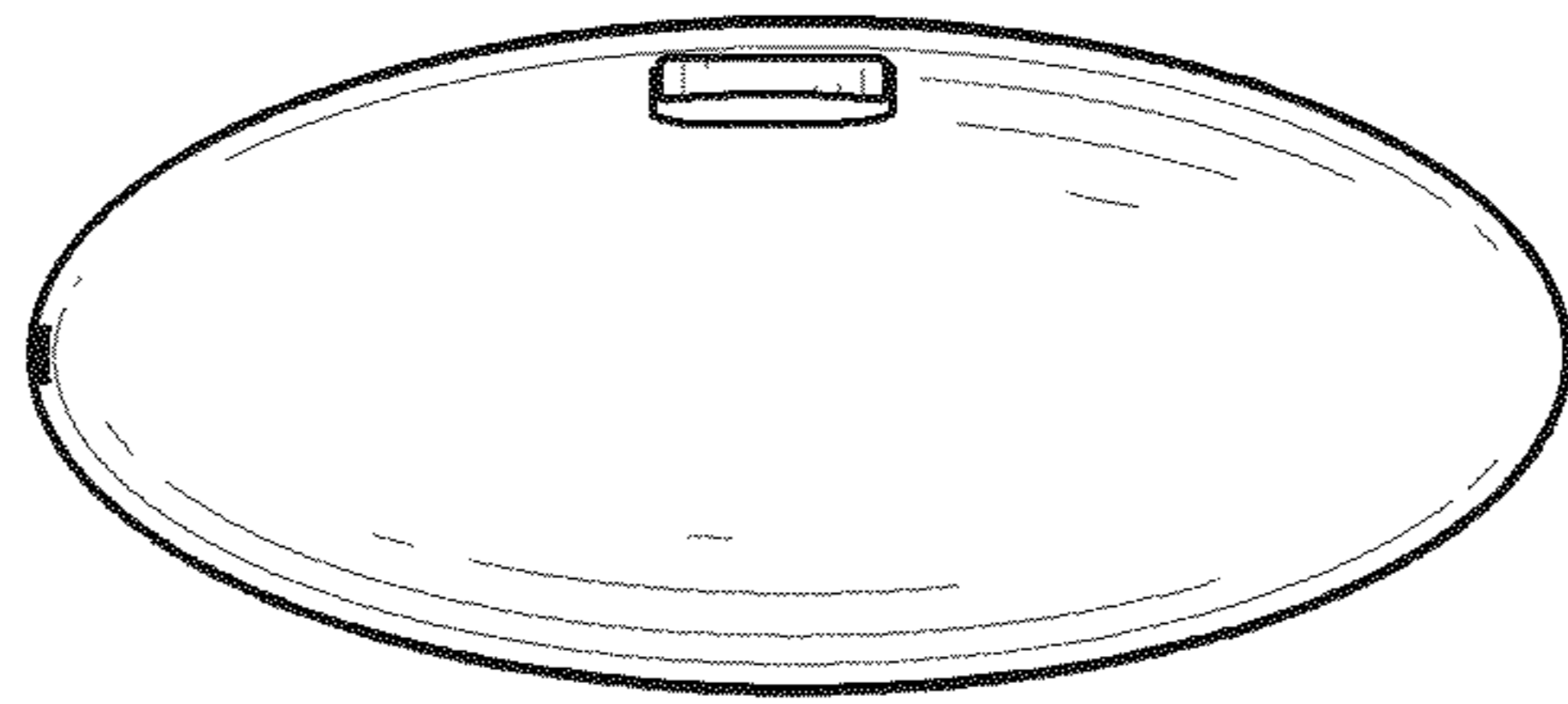

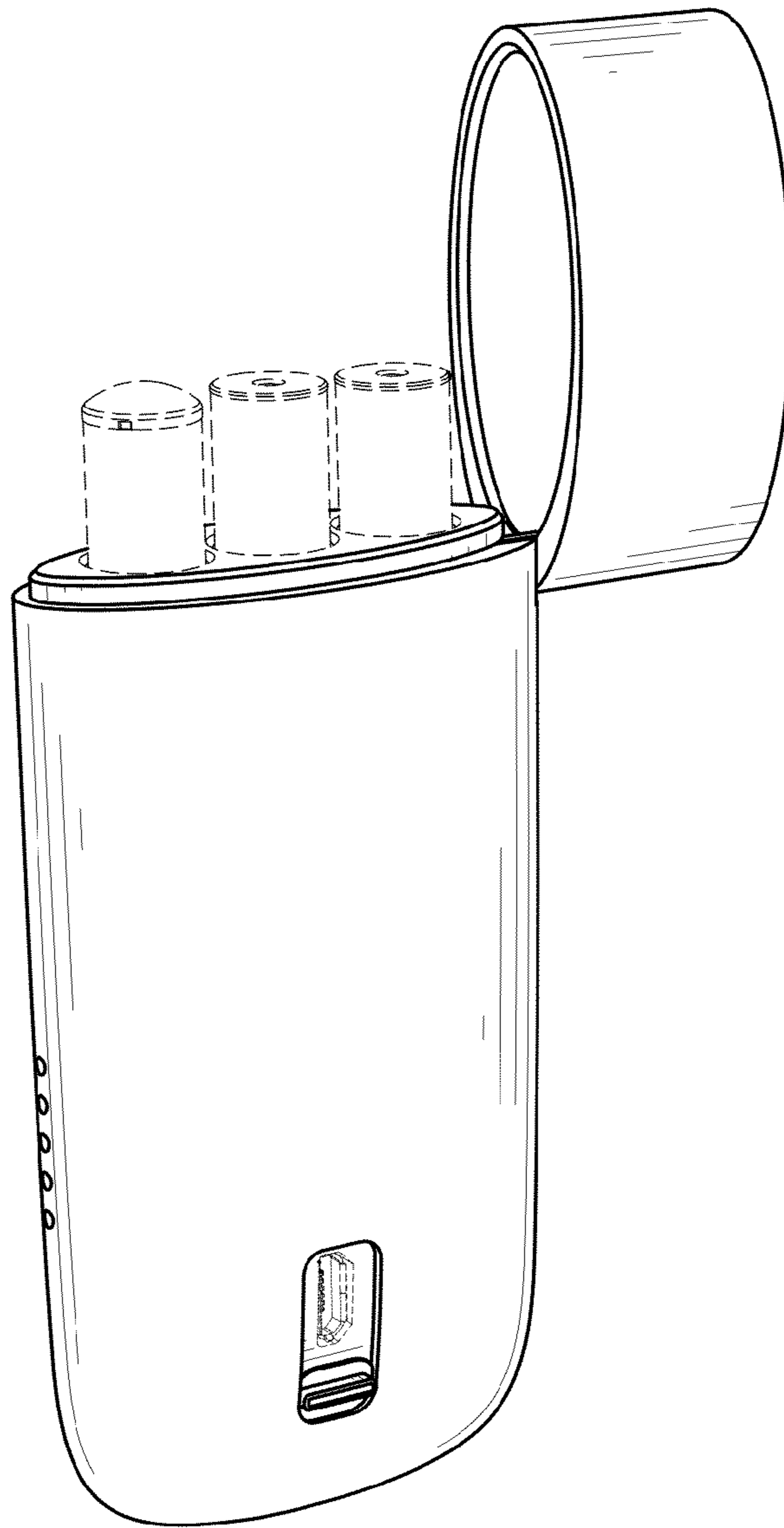
