DESCRIPTION

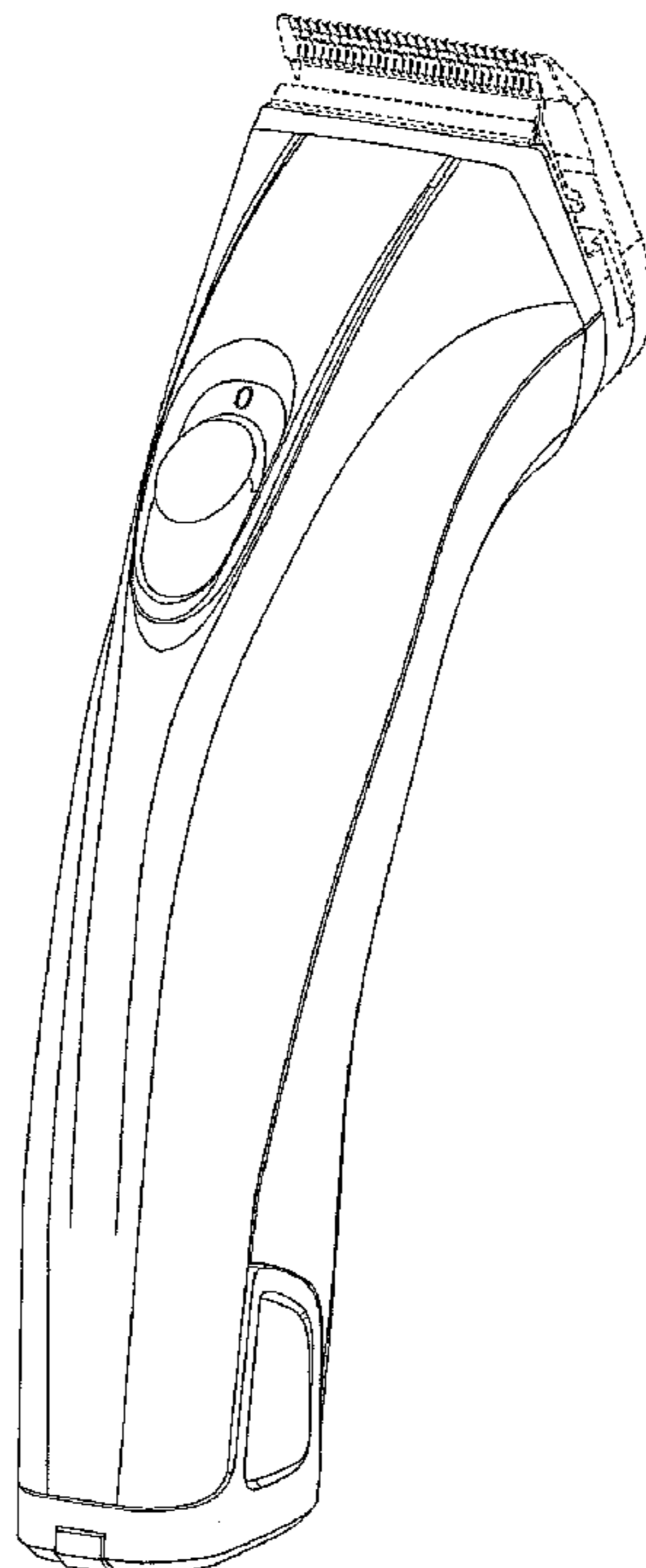
FIG. 1 is a perspective view showing a new design for a hair clipper.

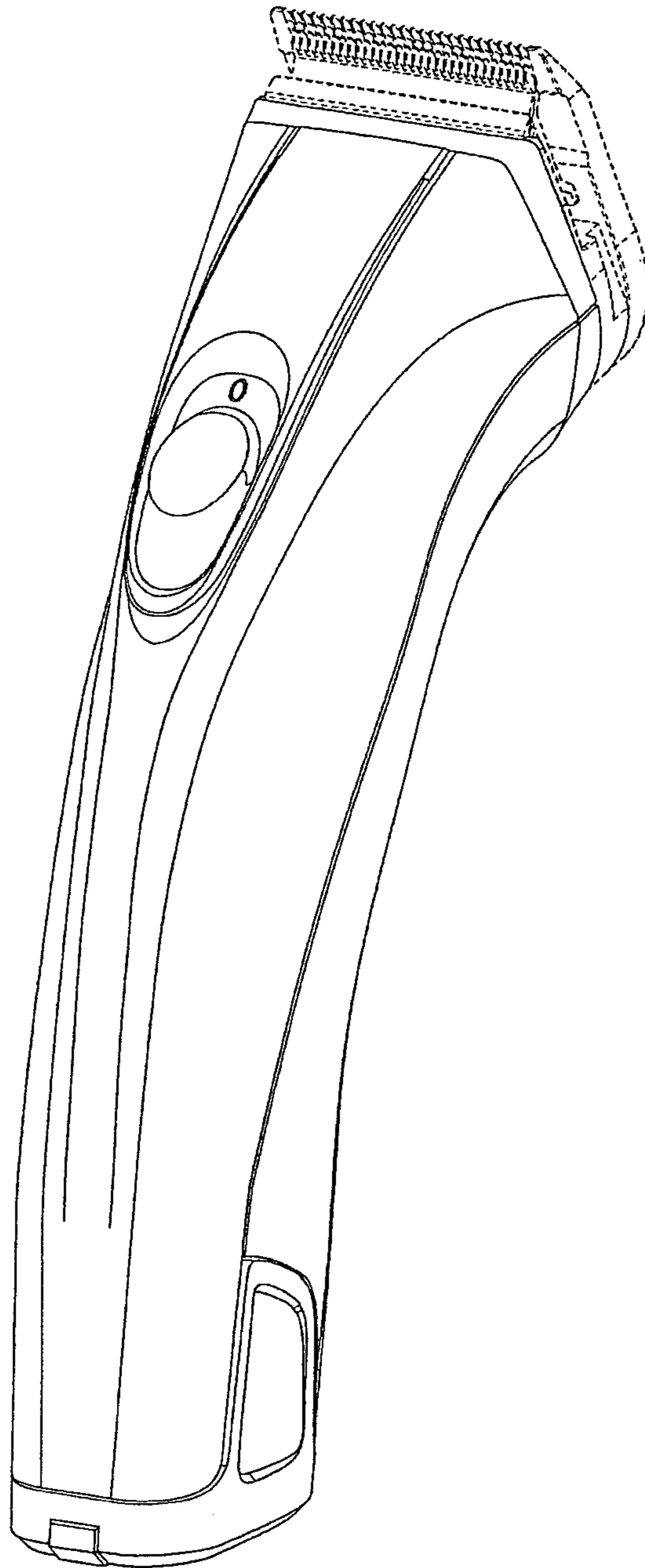

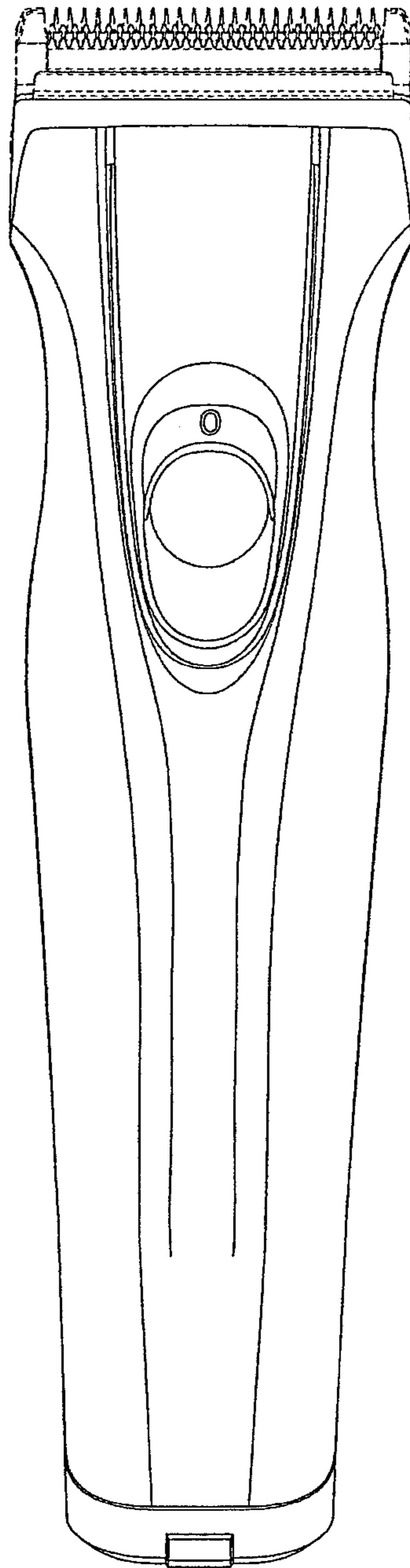

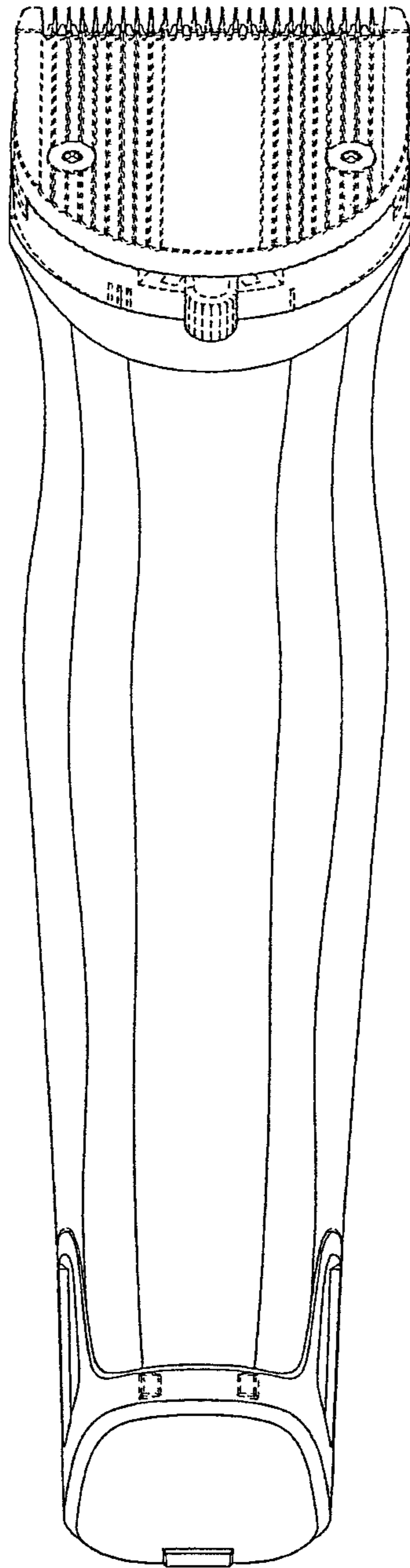

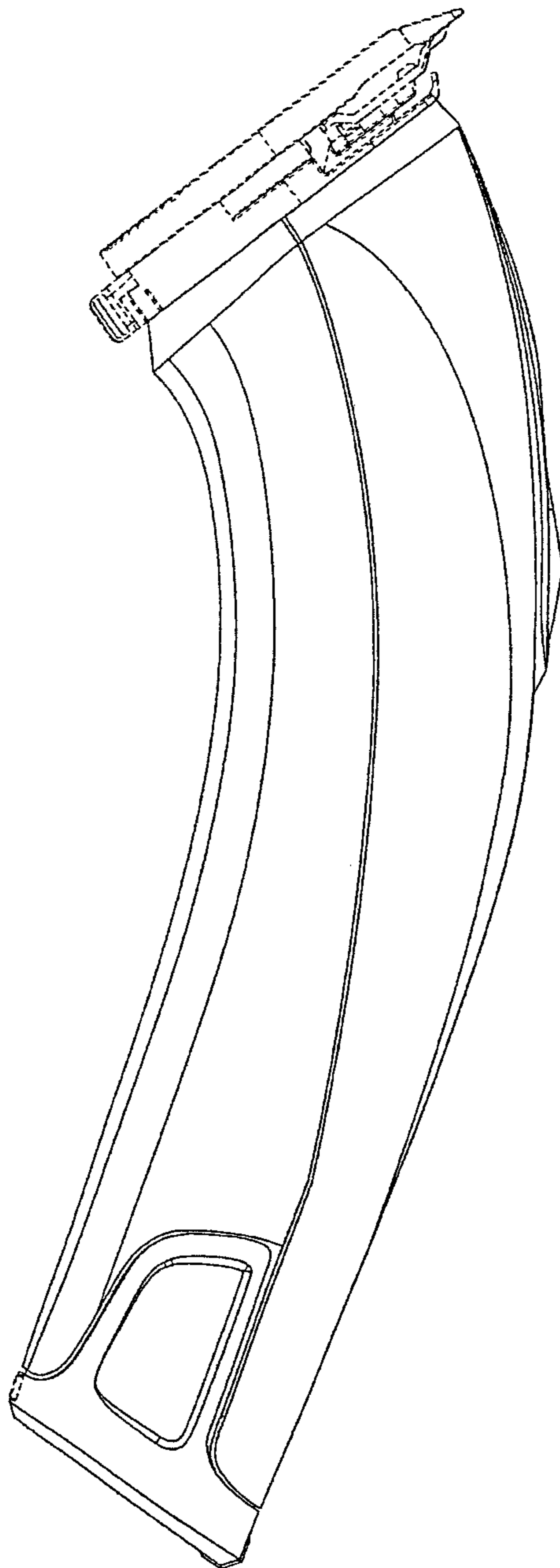

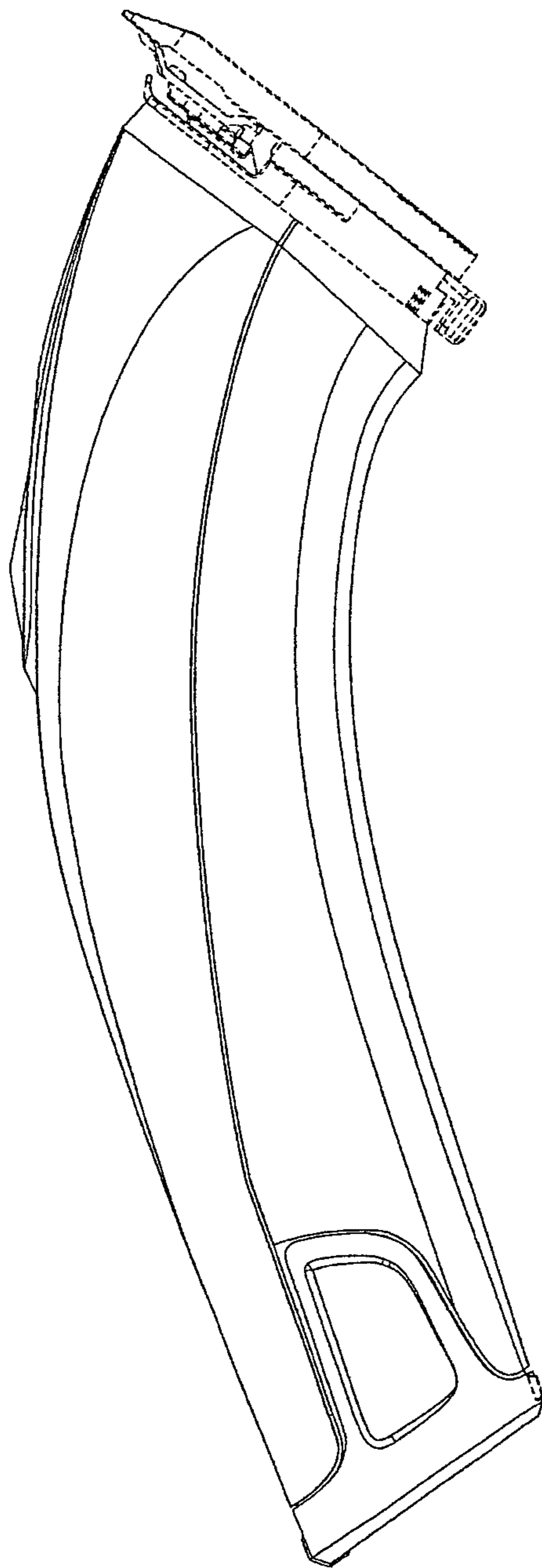

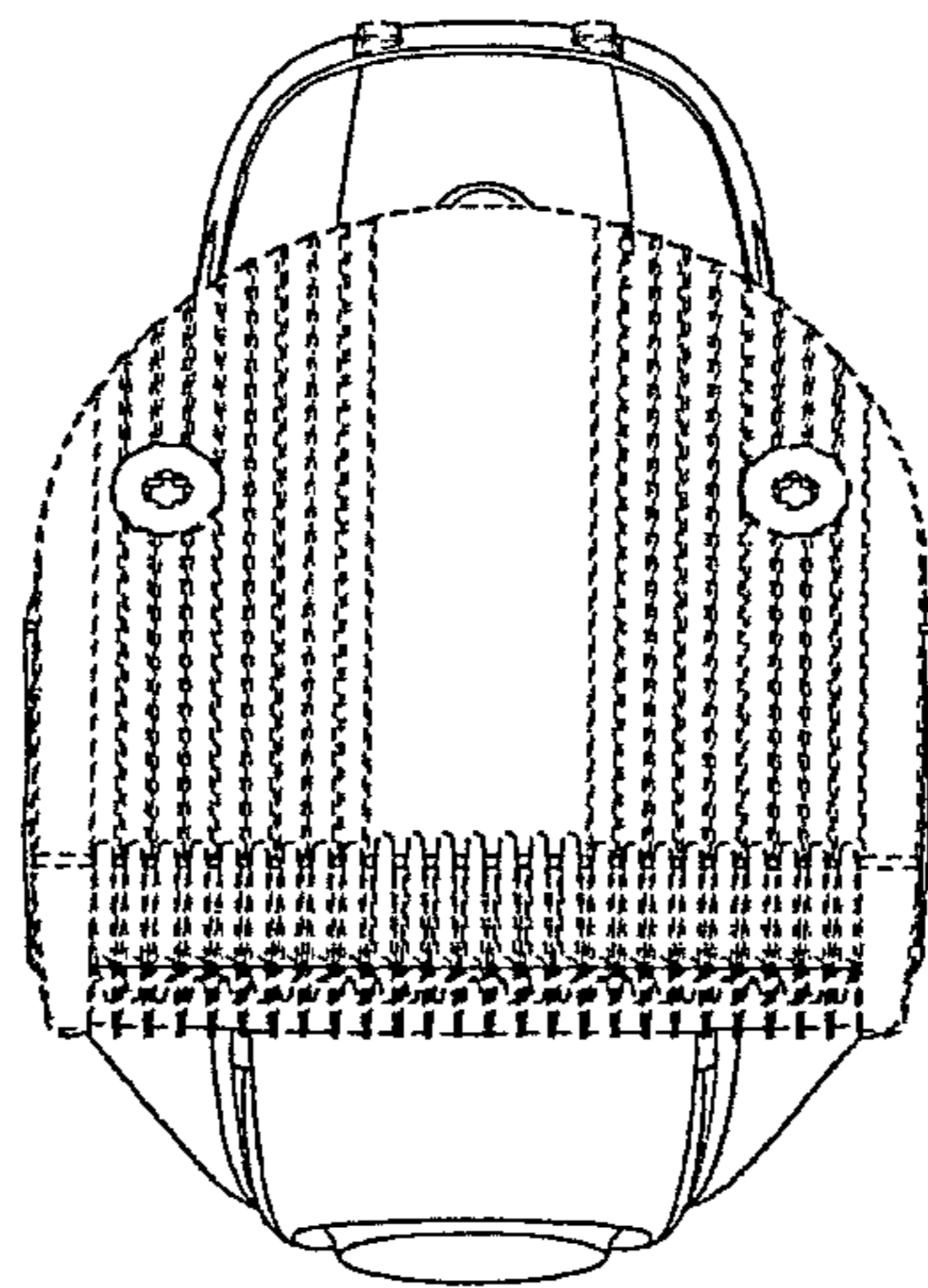

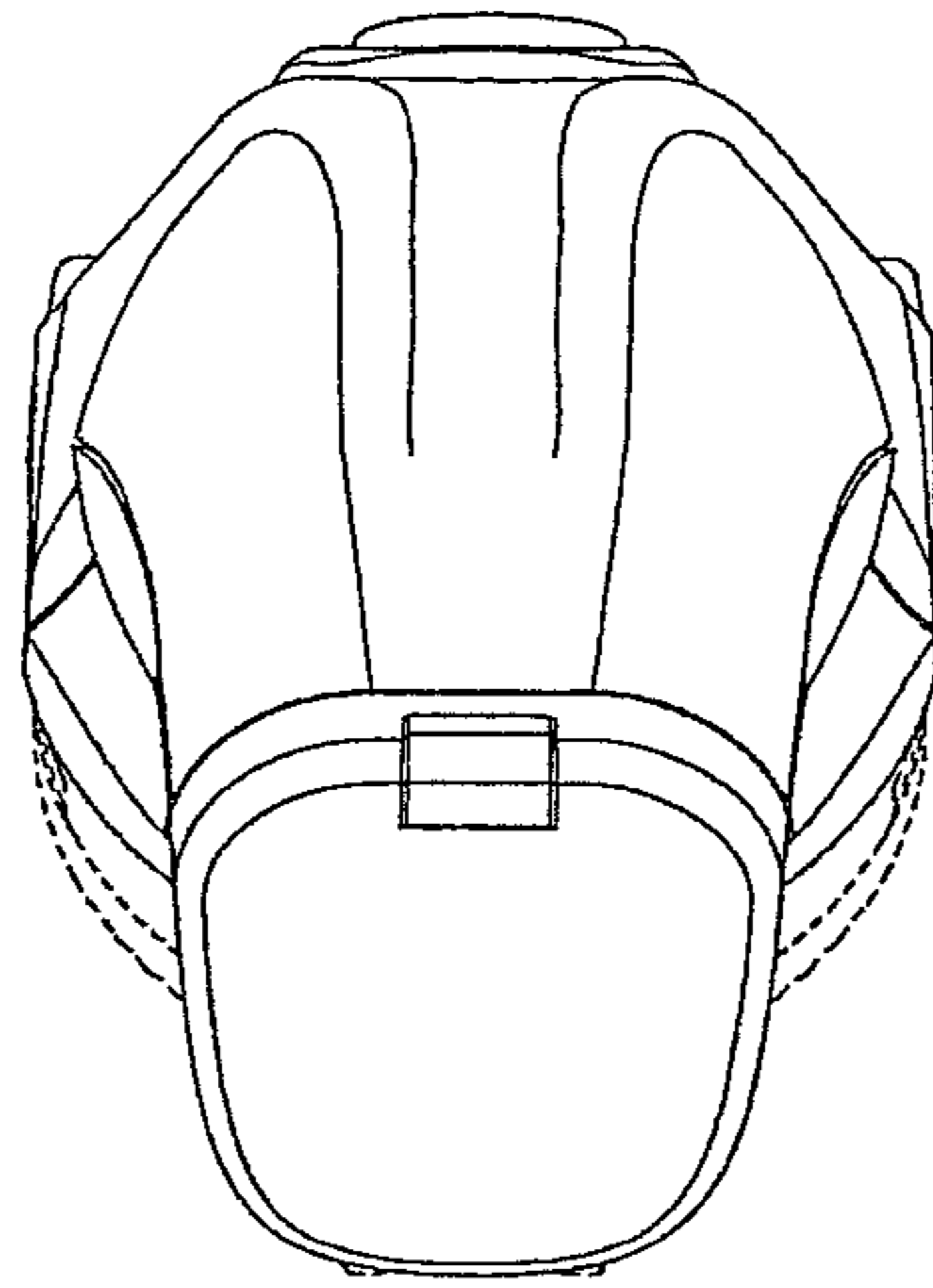
