DESCRIPTION

FIG. 4 is a bottom view of the floor jack as shown in FIG. 1;

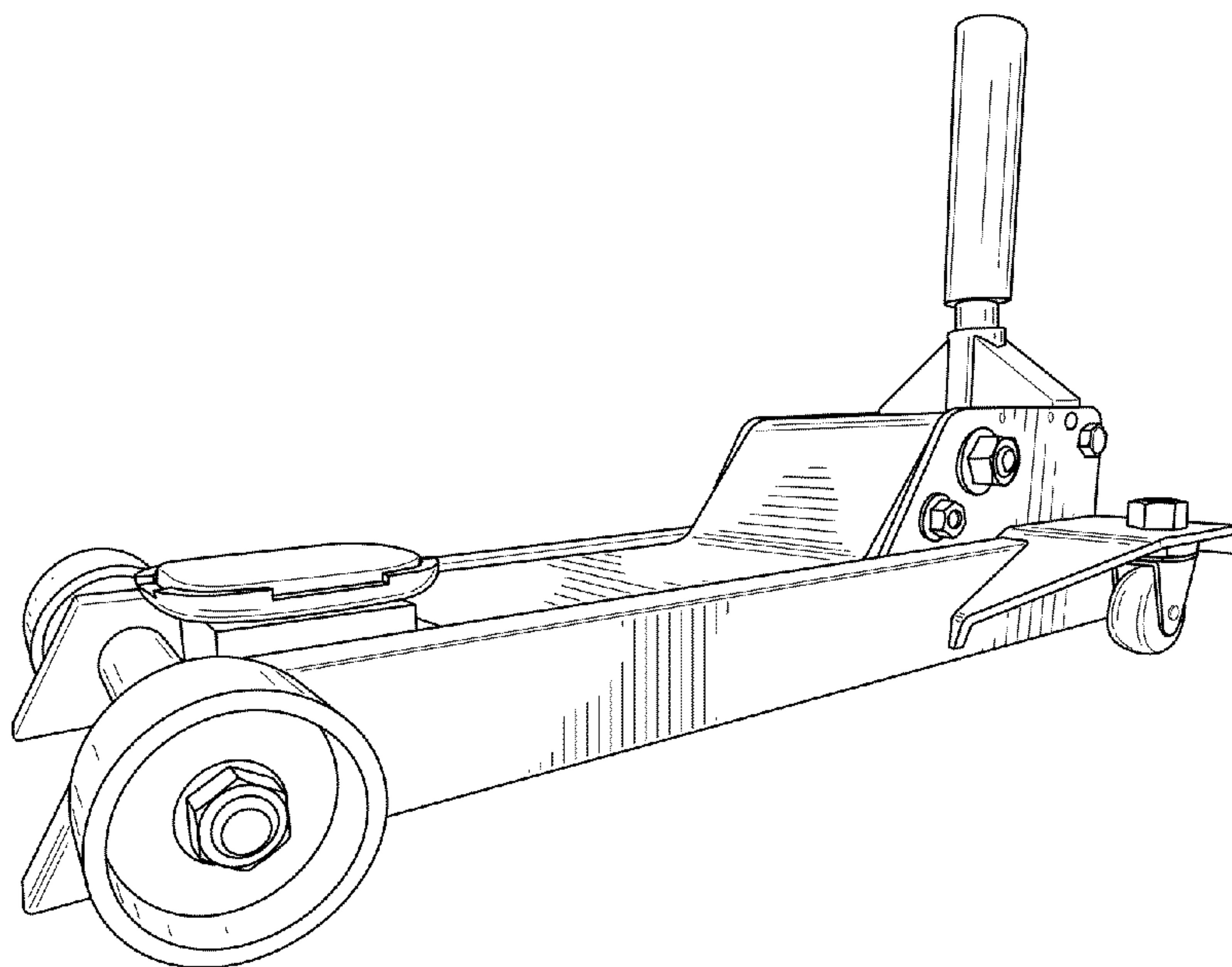
FIG. 5 is a front view of the floor jack as shown in FIG. 1;

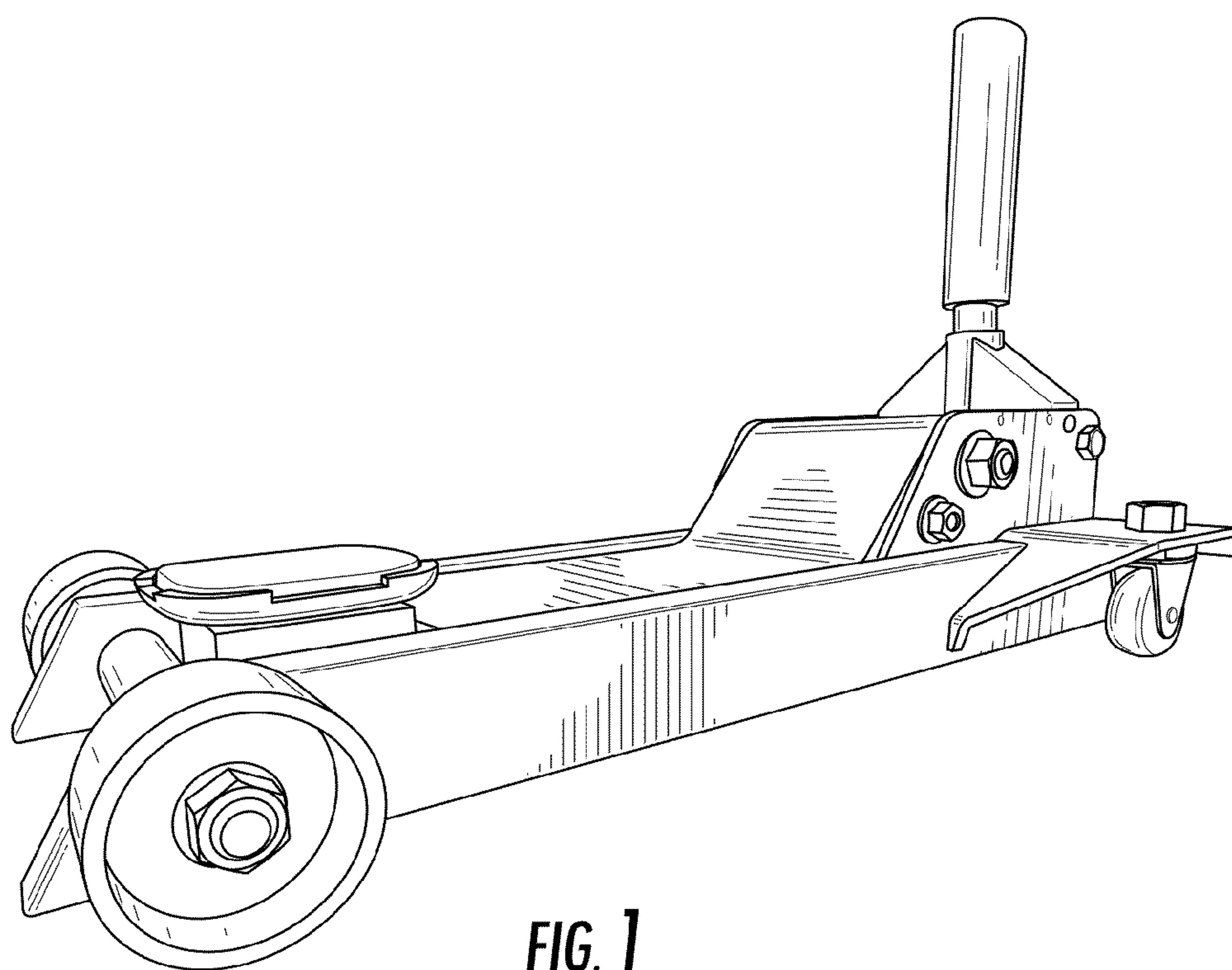

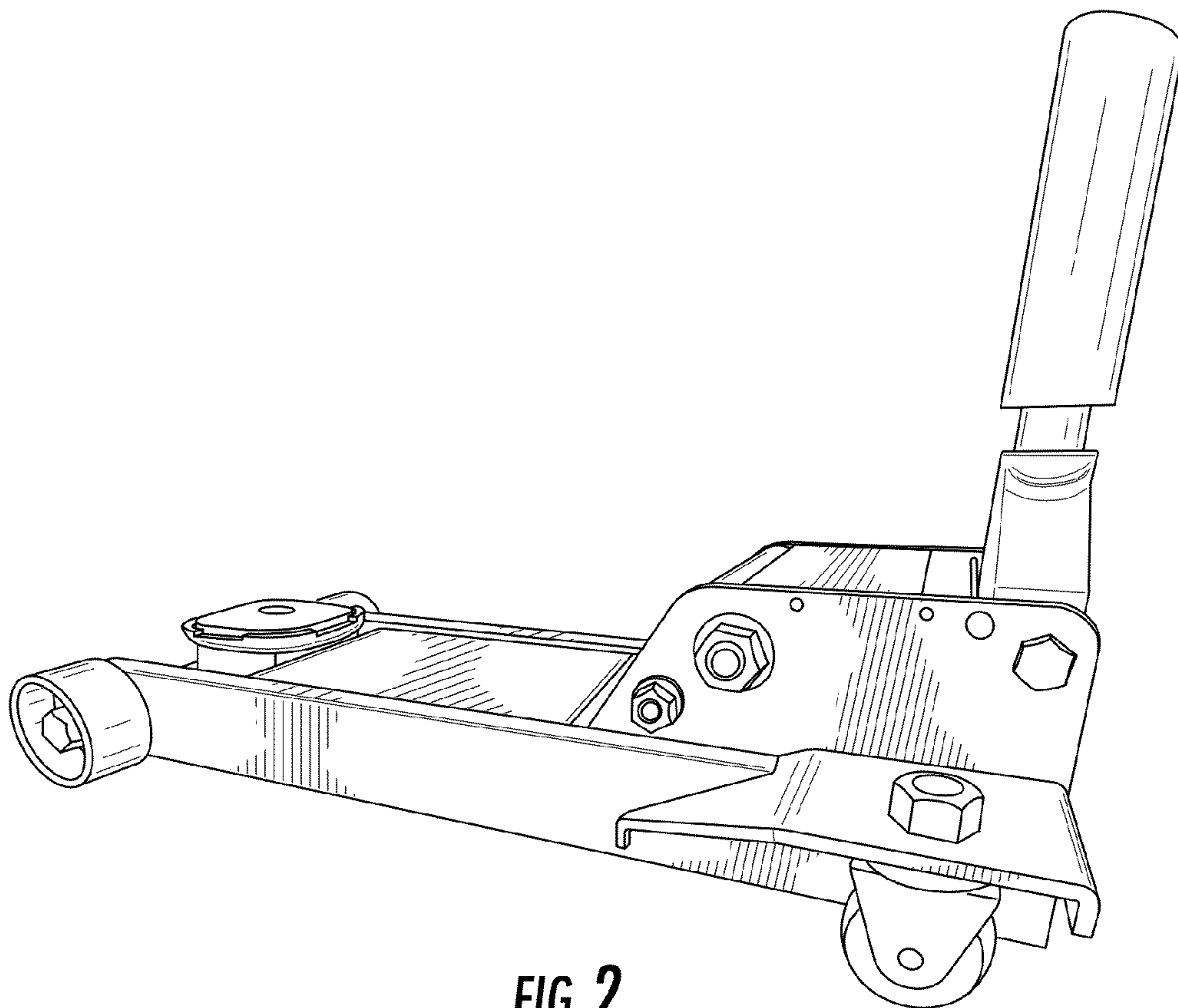

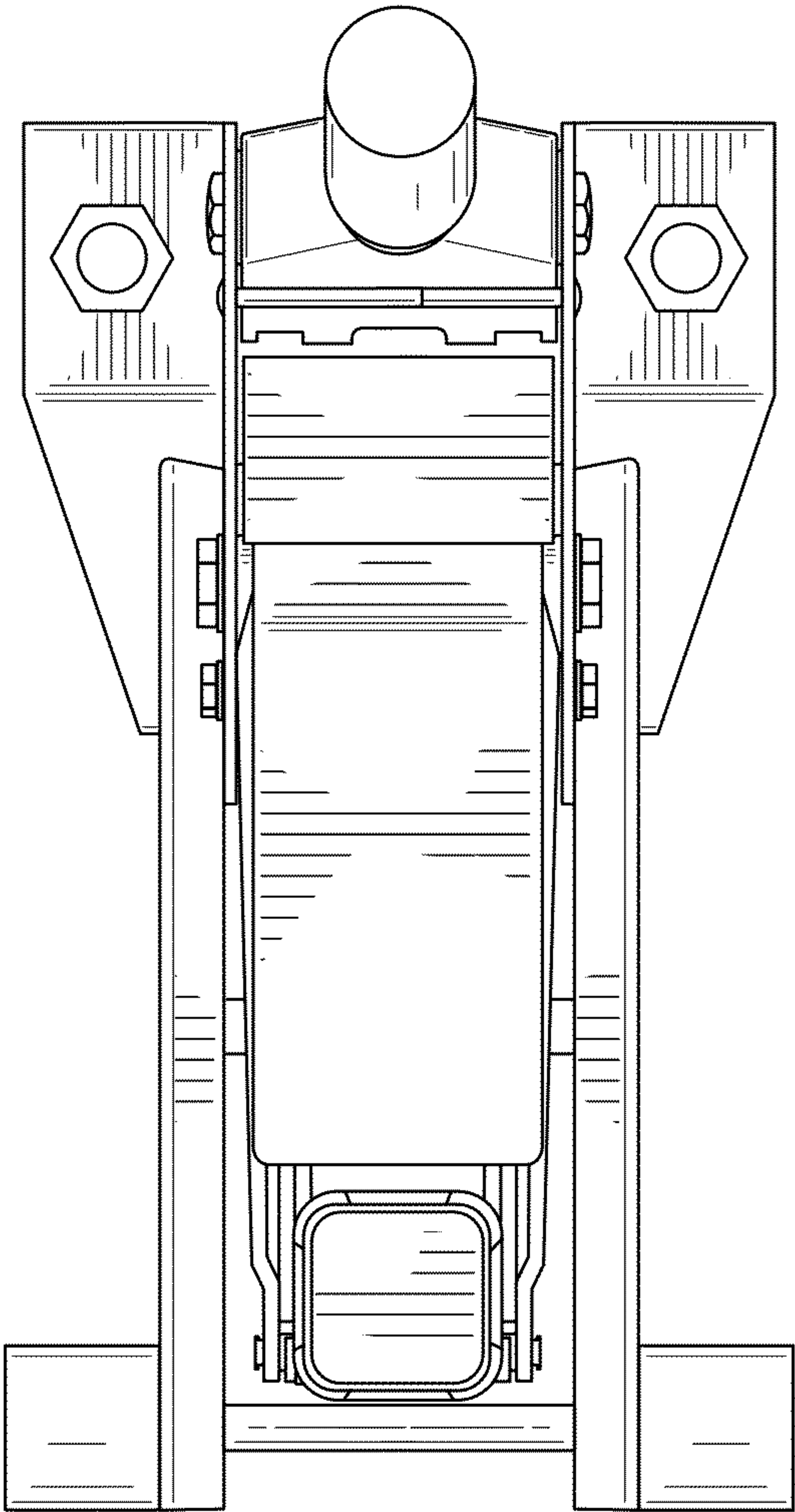

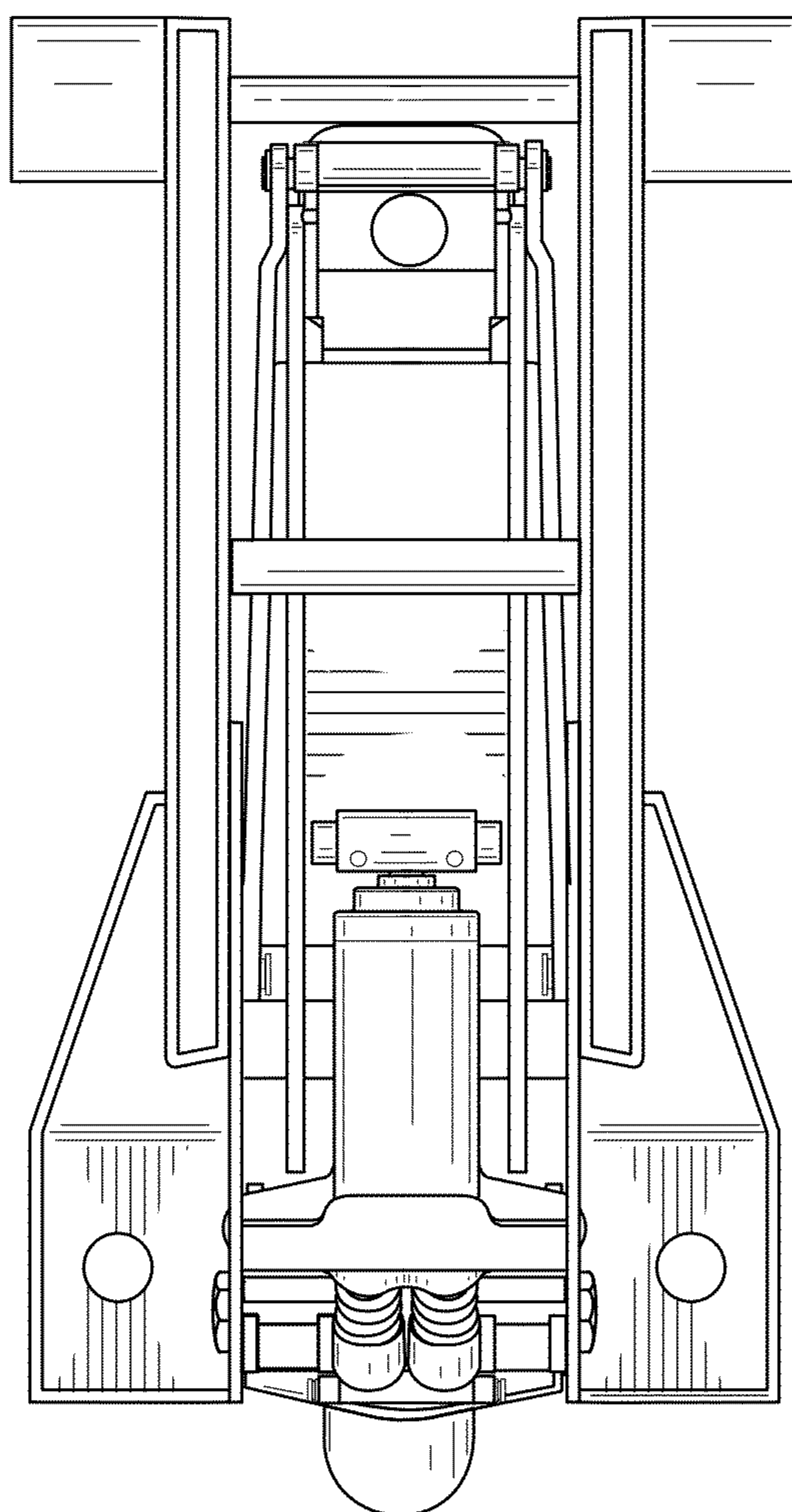

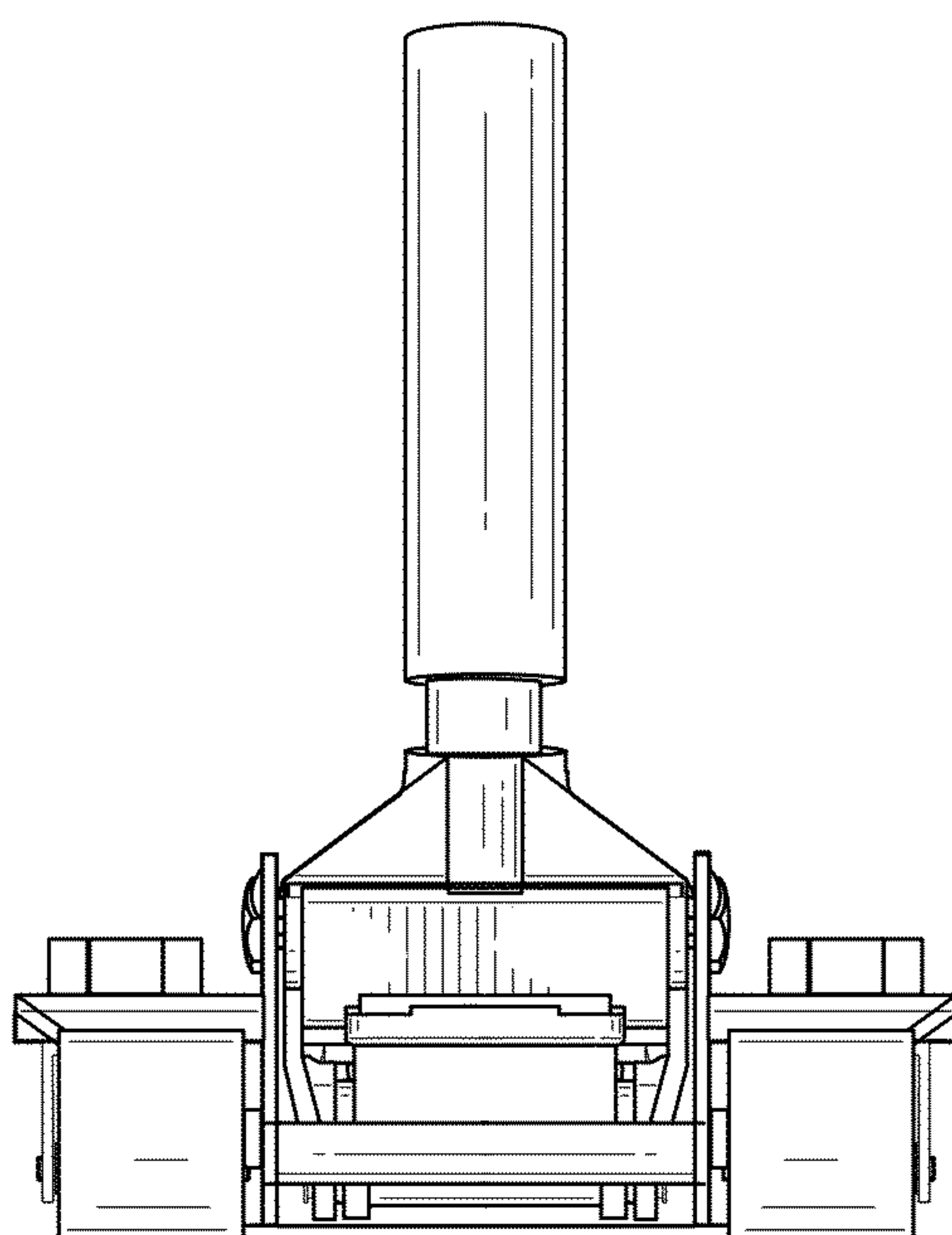

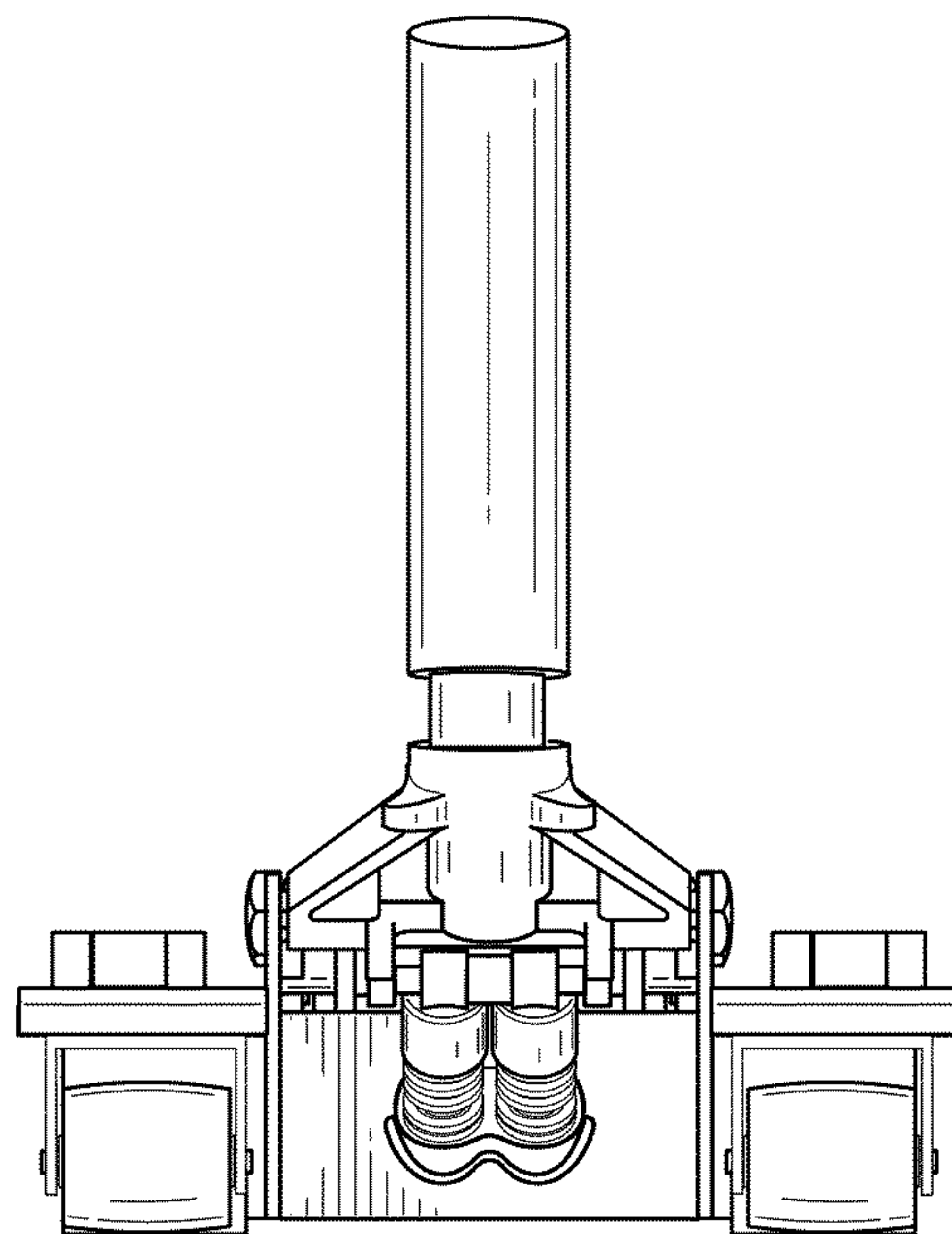

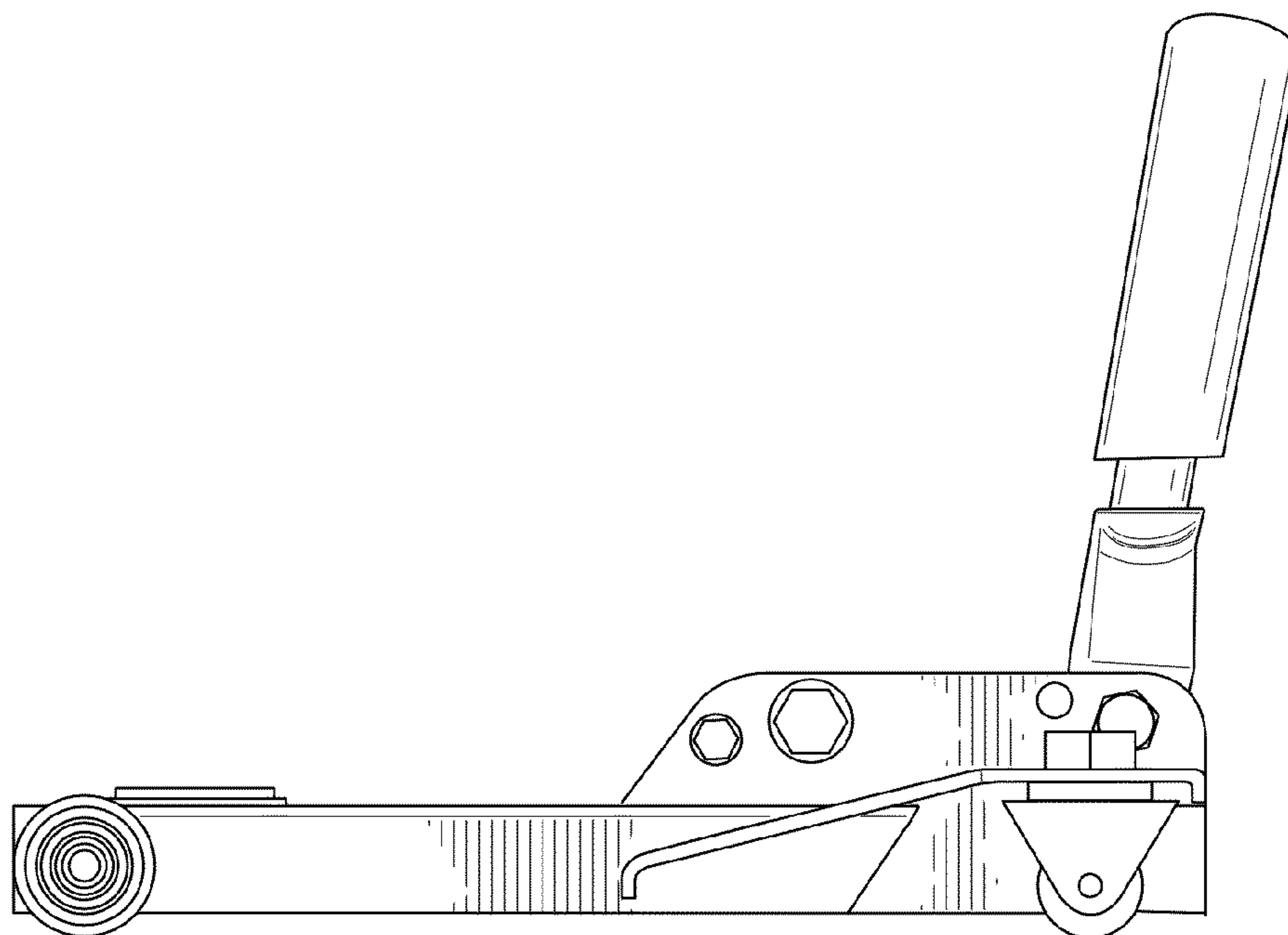

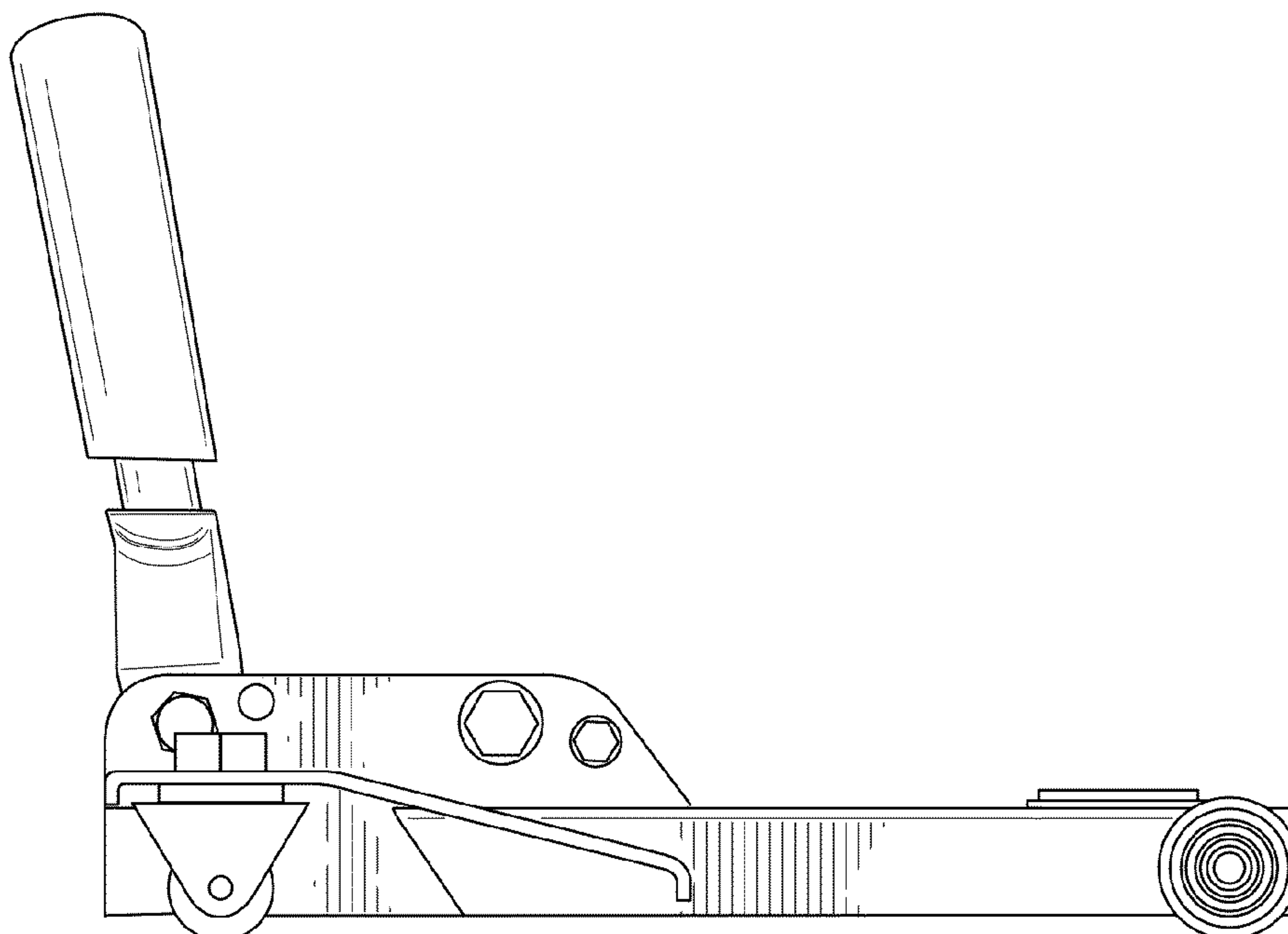
