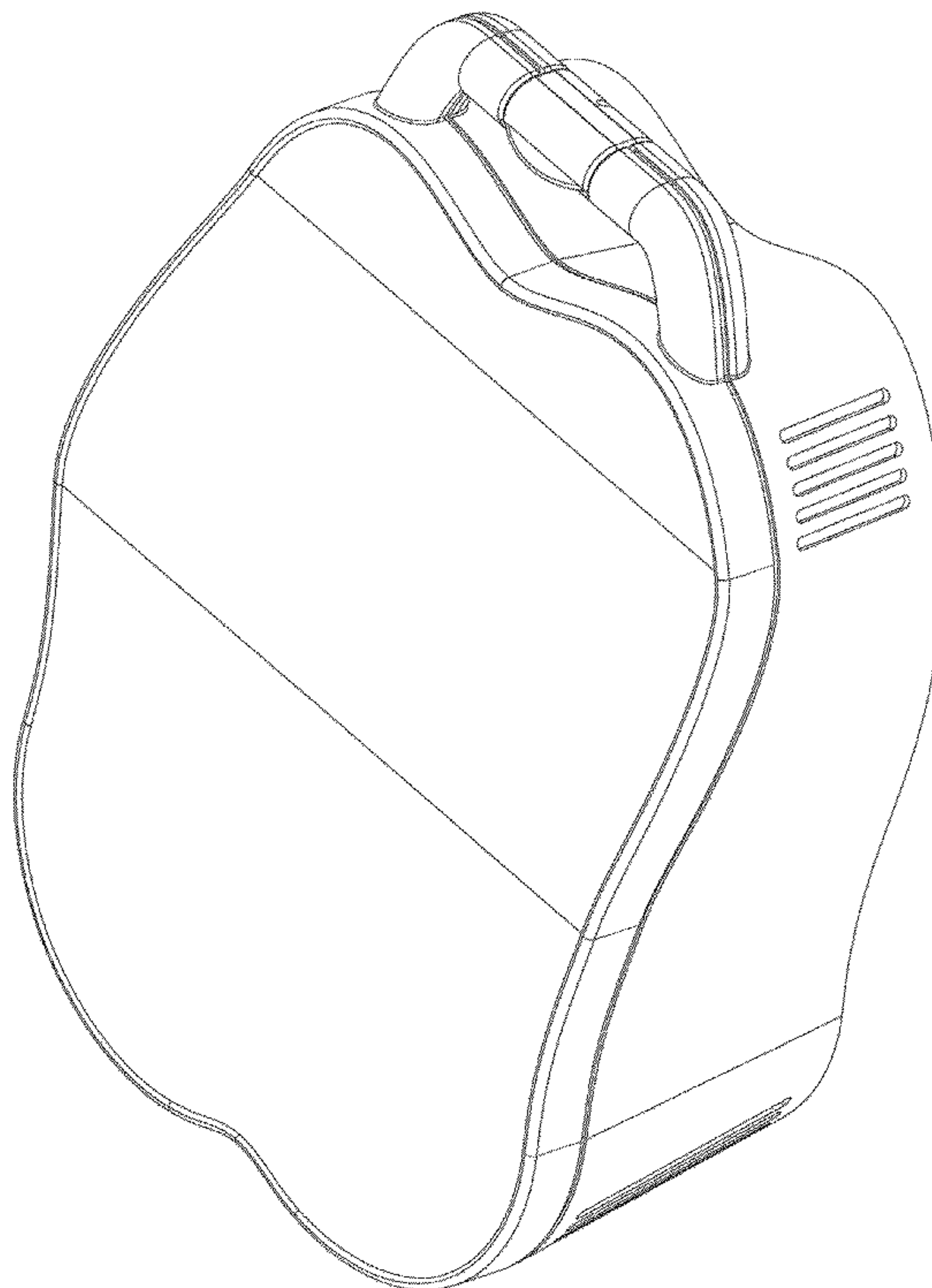

FIG. 1 is a right side front perspective view of a shoe box with handgrip showing my new design;  
 FIG. 2 is a left side perspective view of the shoe box shown in FIG. 1;  
 FIG. 3 is a front elevational view of the shoe box shown in FIG. 1;  
 FIG. 4 is a right side perspective of the shoe box shown in FIG. 1;  
 FIG. 5 is a right side view of the box shown in FIG. 1;  
 FIG. 6 is a top plan view of the shoe box shown in FIG. 1;  
 FIG. 7 is a bottom plan view of the shoe box shown in FIG. 1;  
 and,  
 FIG. 8 is rear elevational view of the shoe box shown in FIG. 1.  
 The broken line showing of the sets of vertical slits shown at the top and bottom of the shoe box, the two hinges at the bottom, and the portion of the handle form no part of the claimed design.

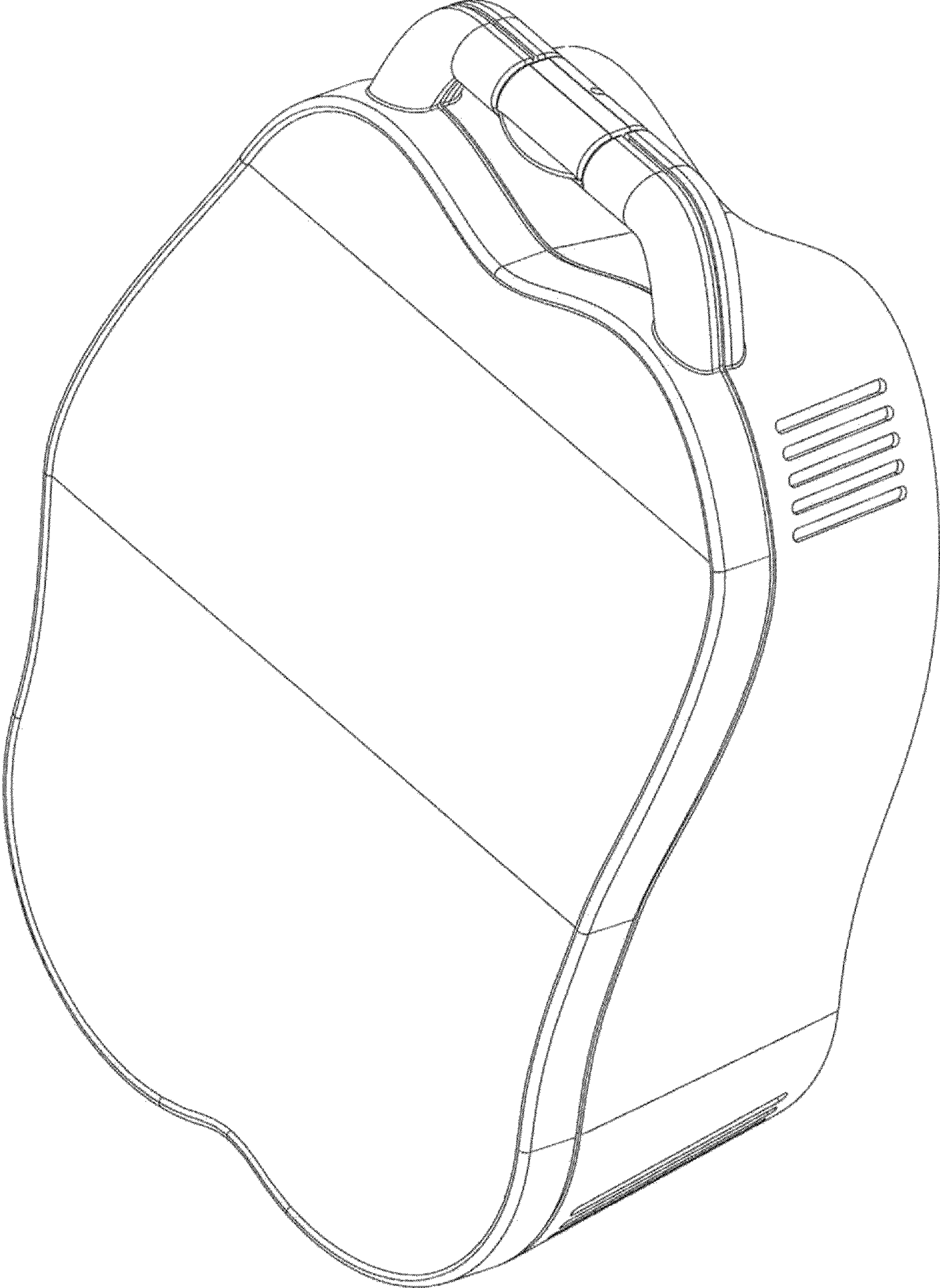

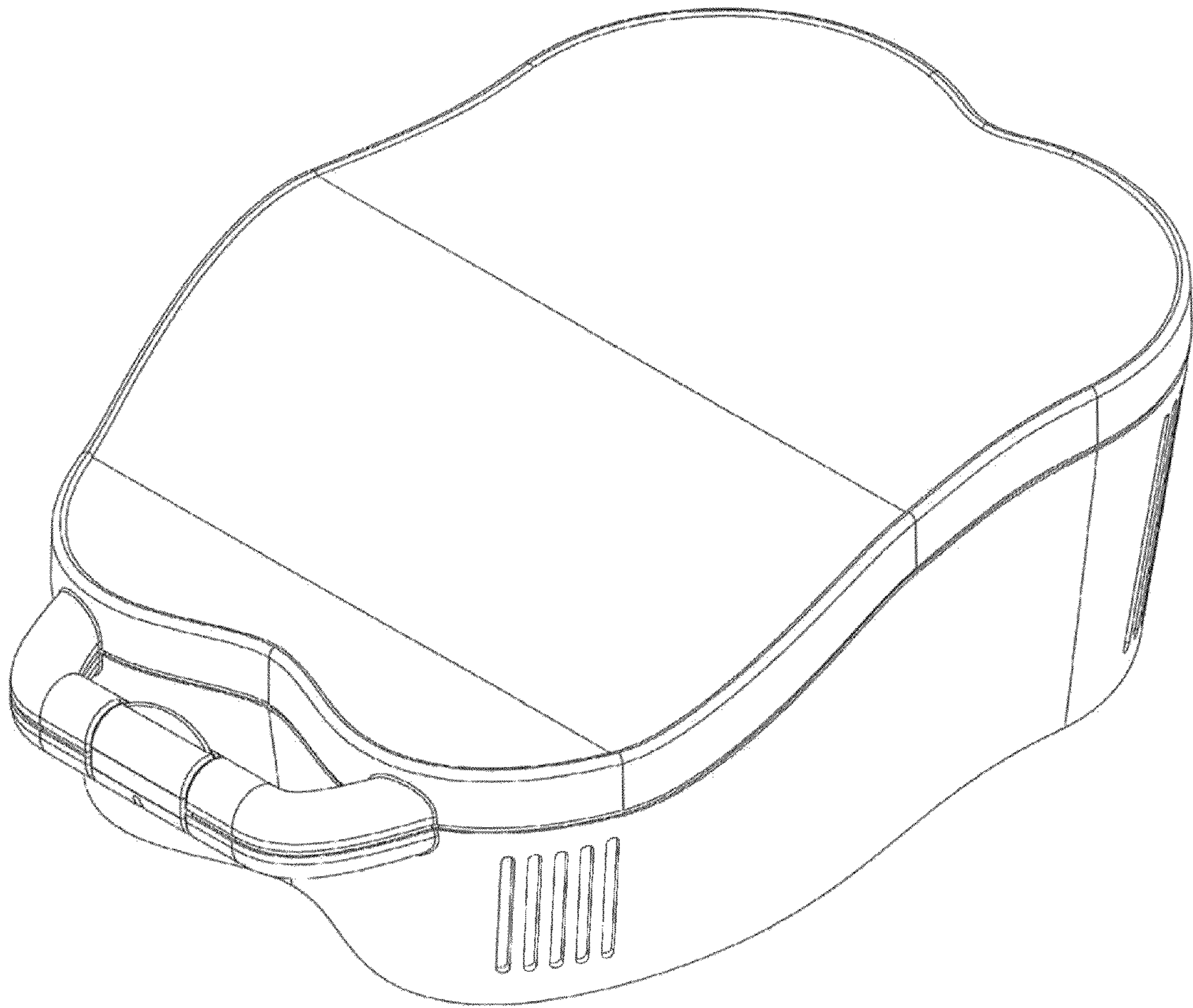

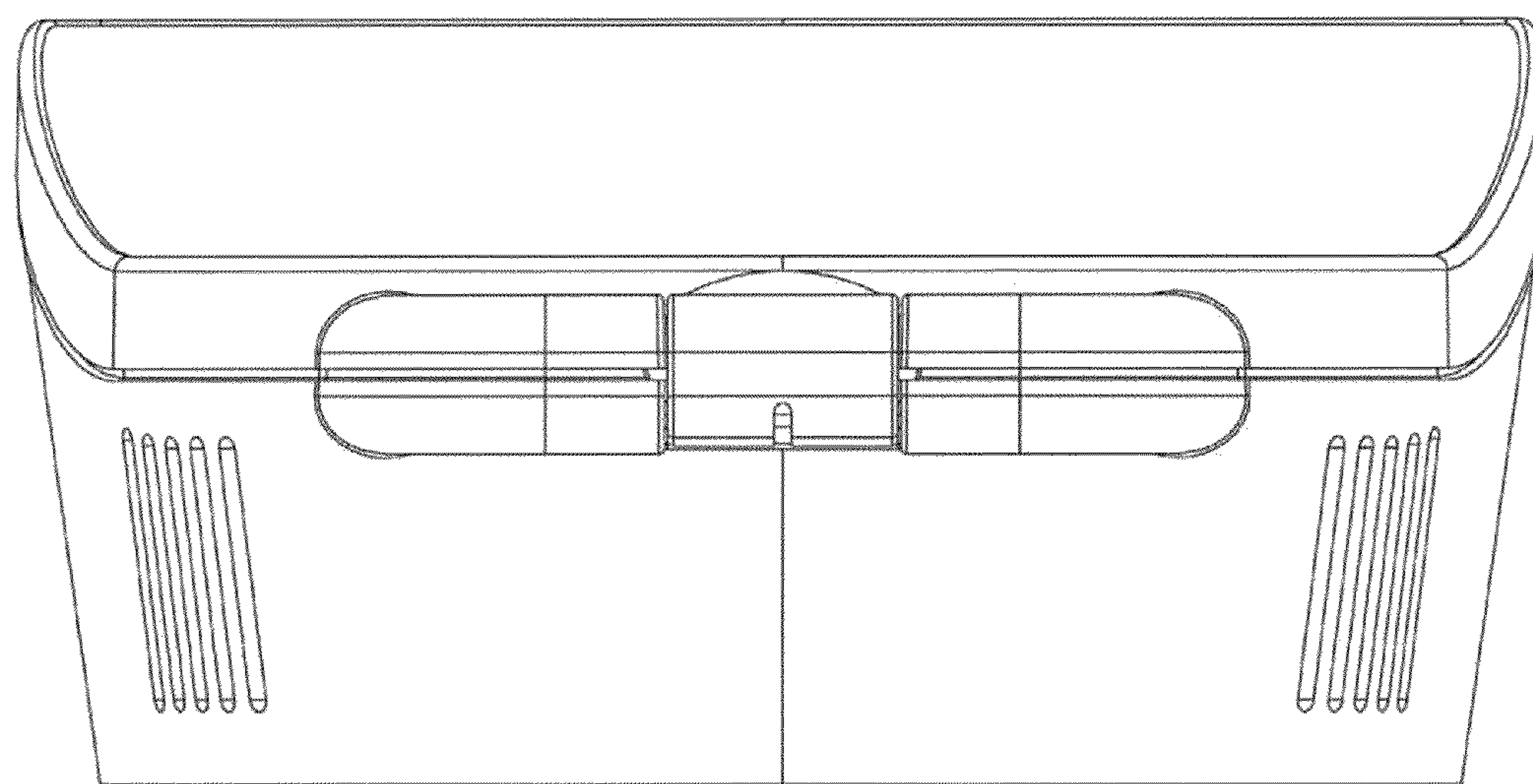

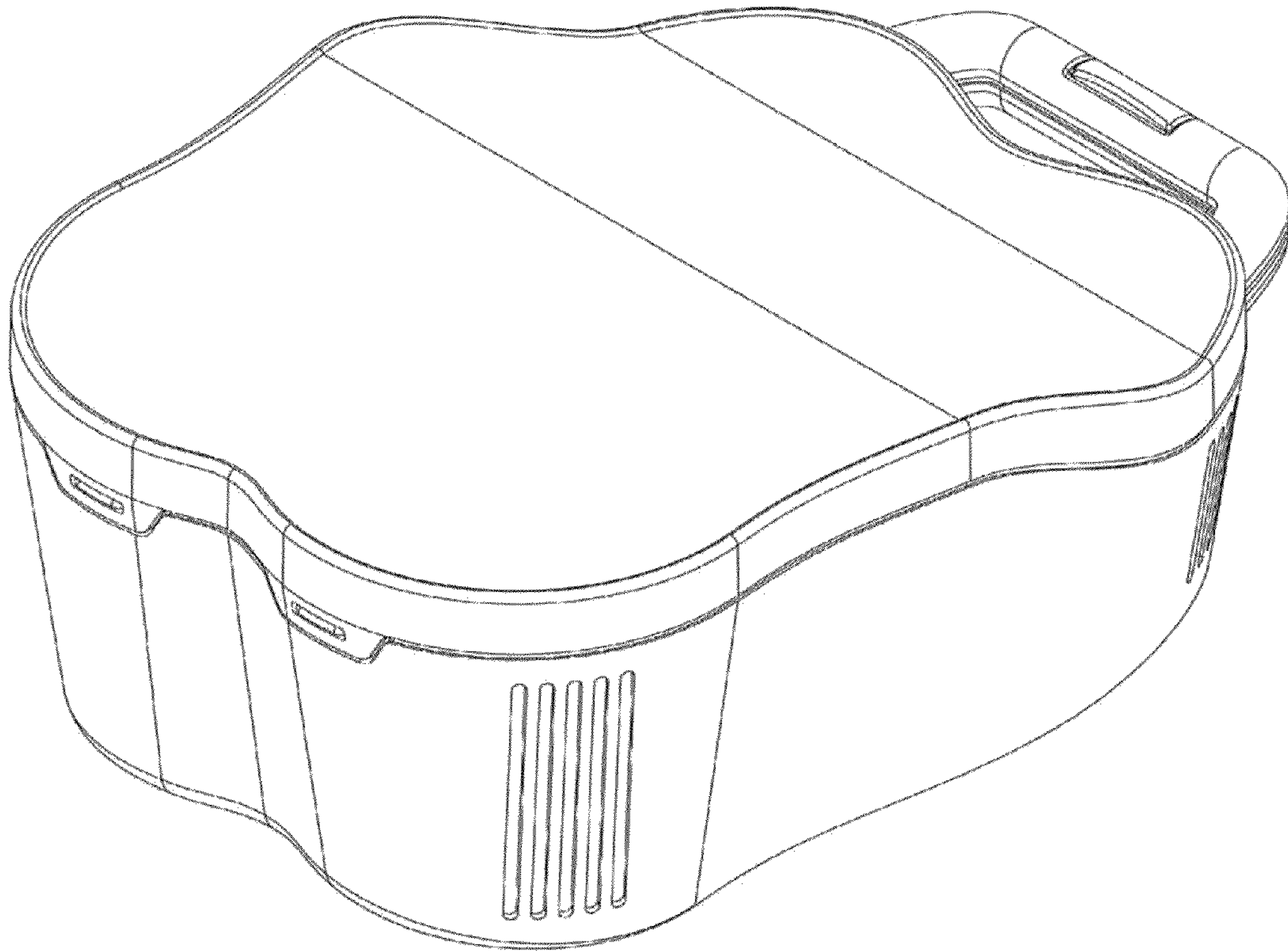

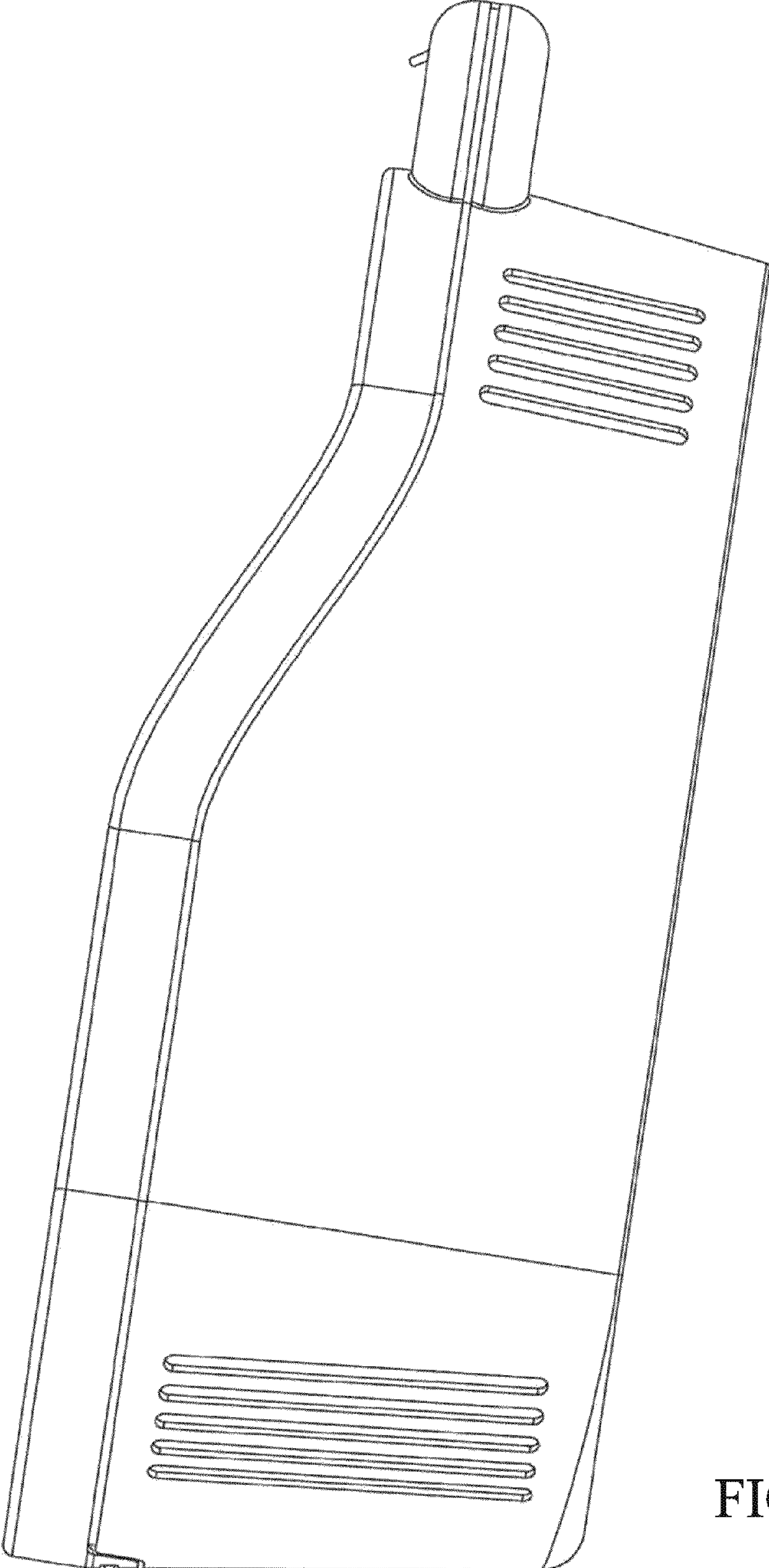

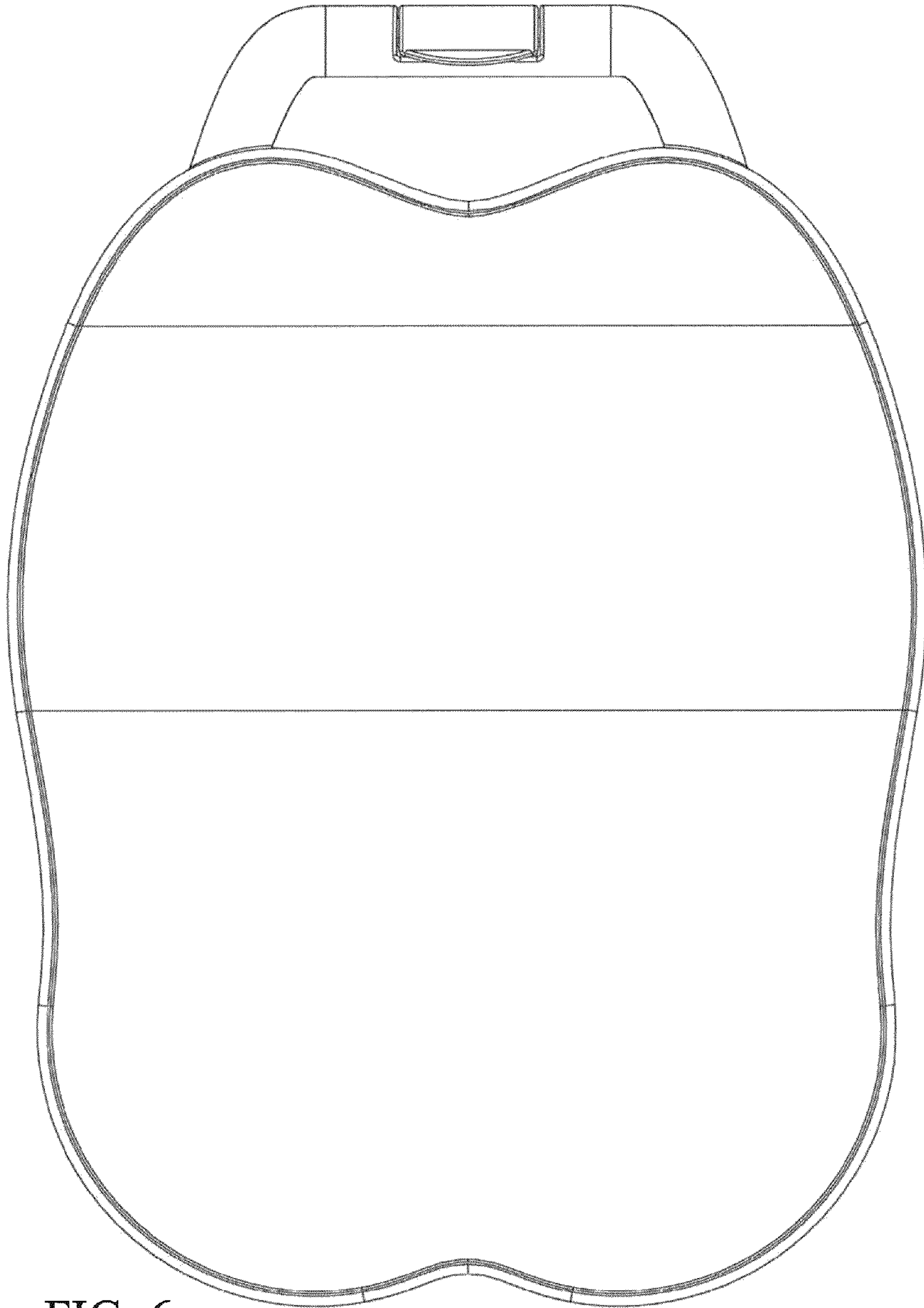

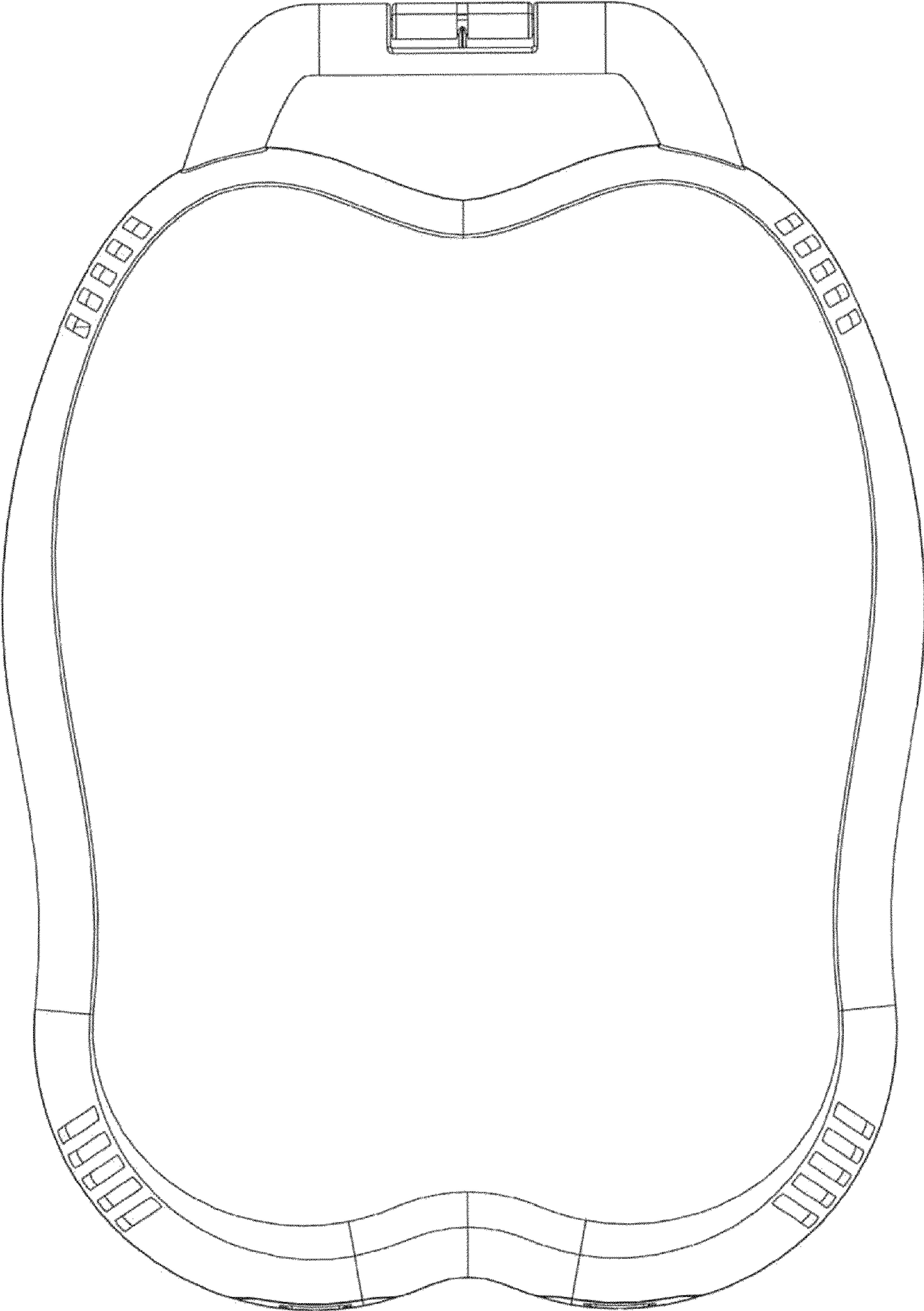

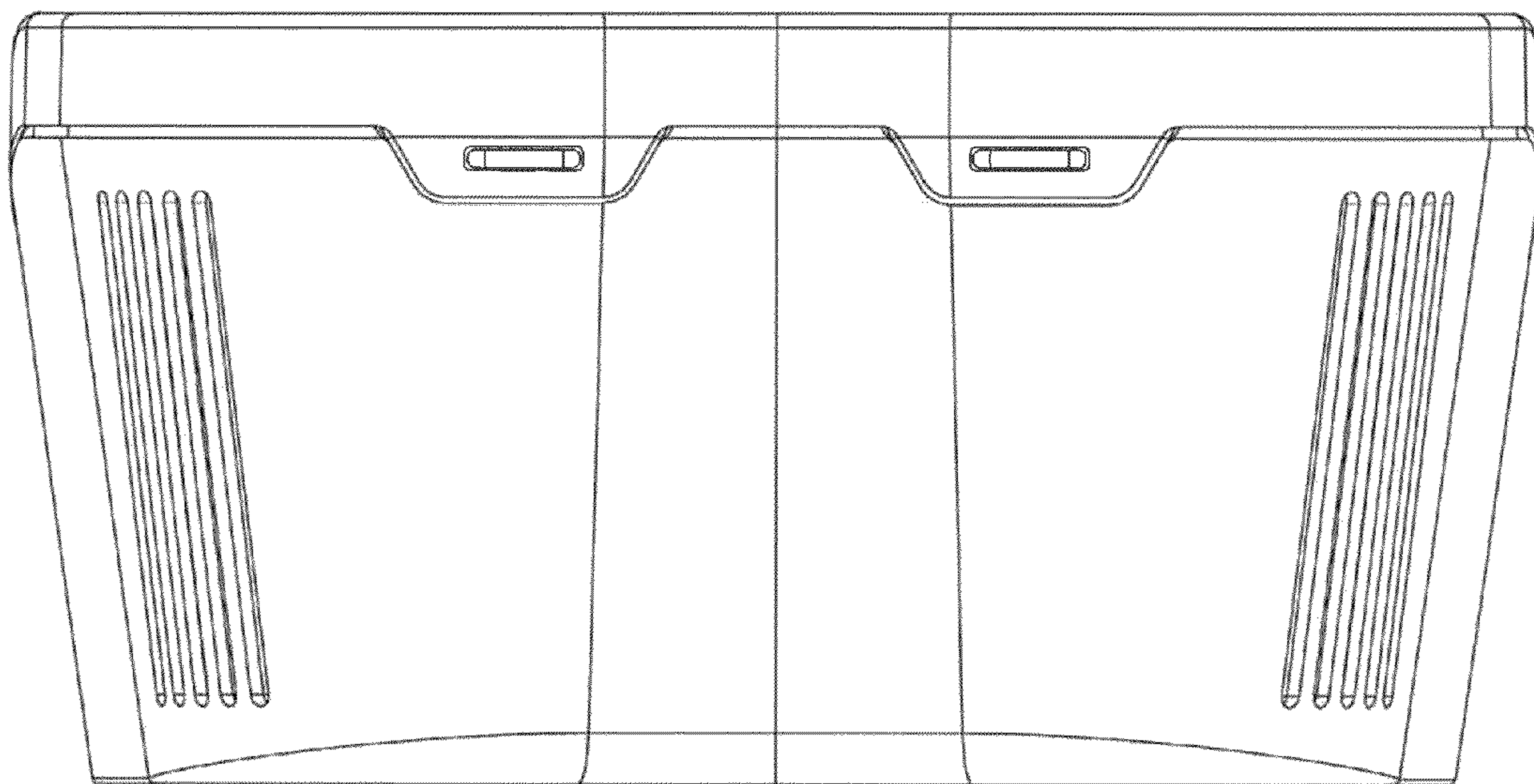
