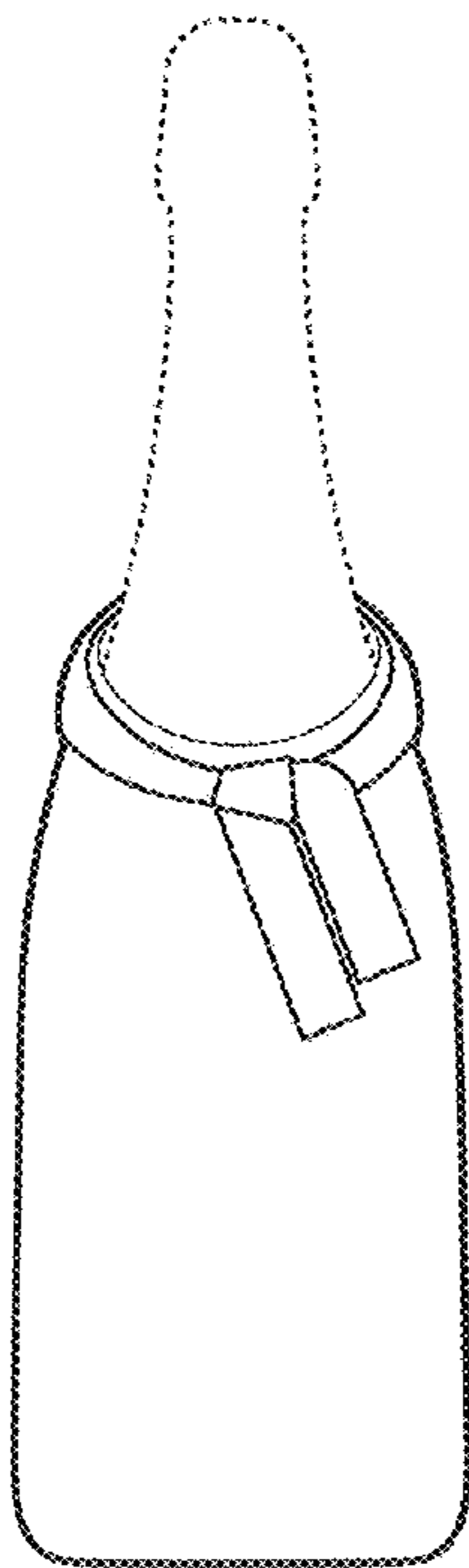
The ornamental design for a bottle cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view the bottle cover;  
 FIG. 2 is a left side view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a top view of the bottle cover; and,  
 FIG. 5 is a bottom view of the bottle cover.  
 Those portions of the figures shown in dashed lines are not intended to be part of the design, but rather, are intended to represent the bottle being covered.  
 The cover itself is used to insulate a glass bottle.

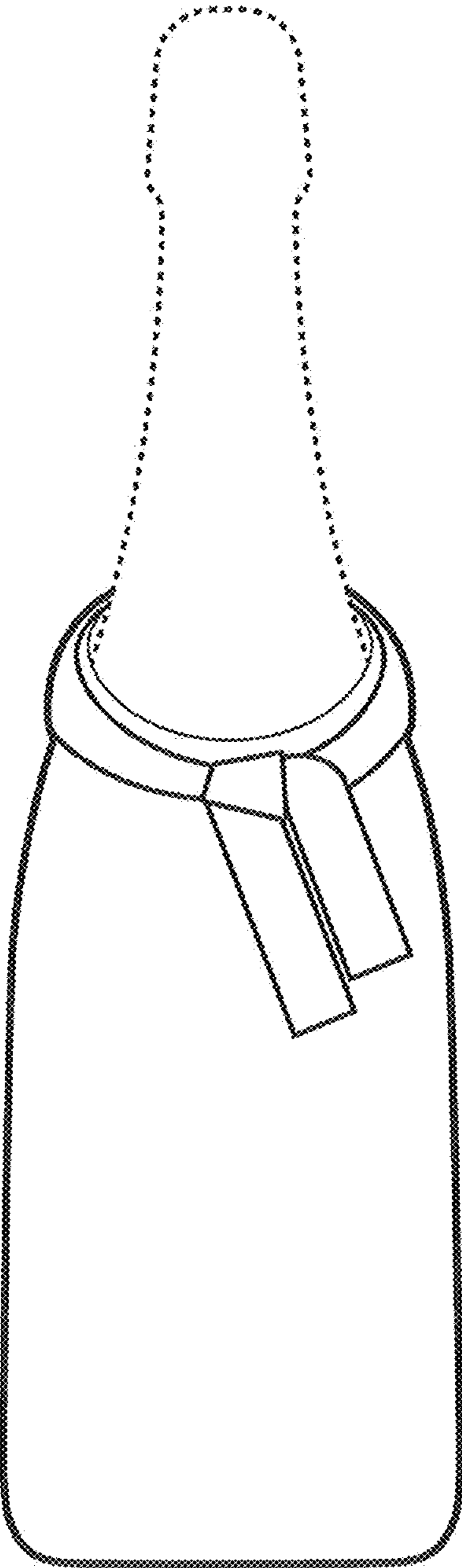

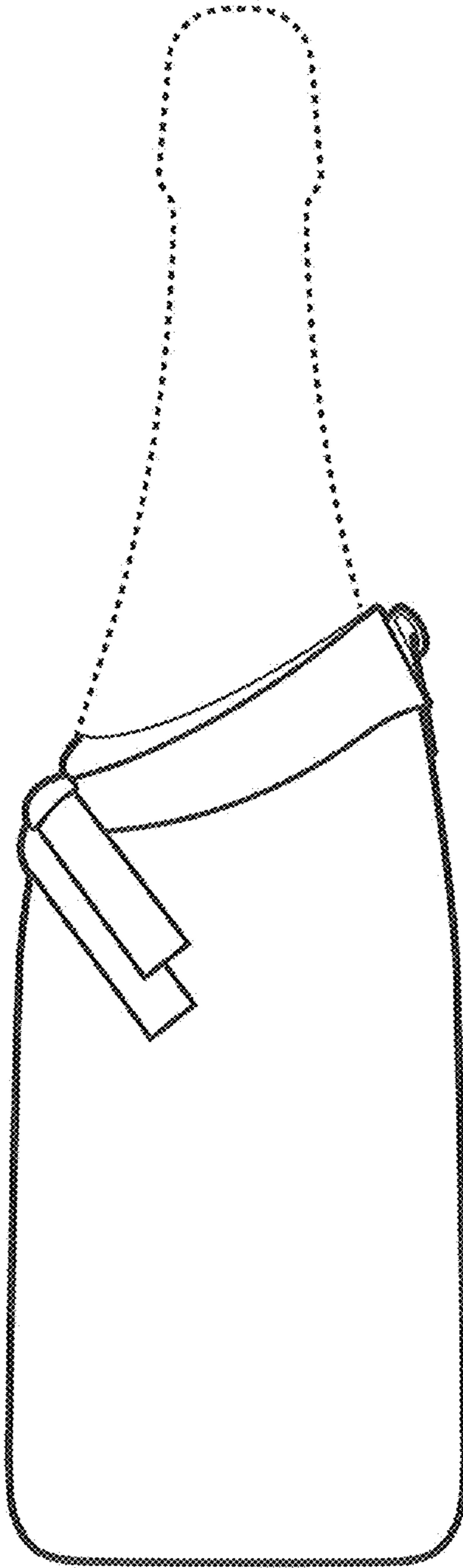

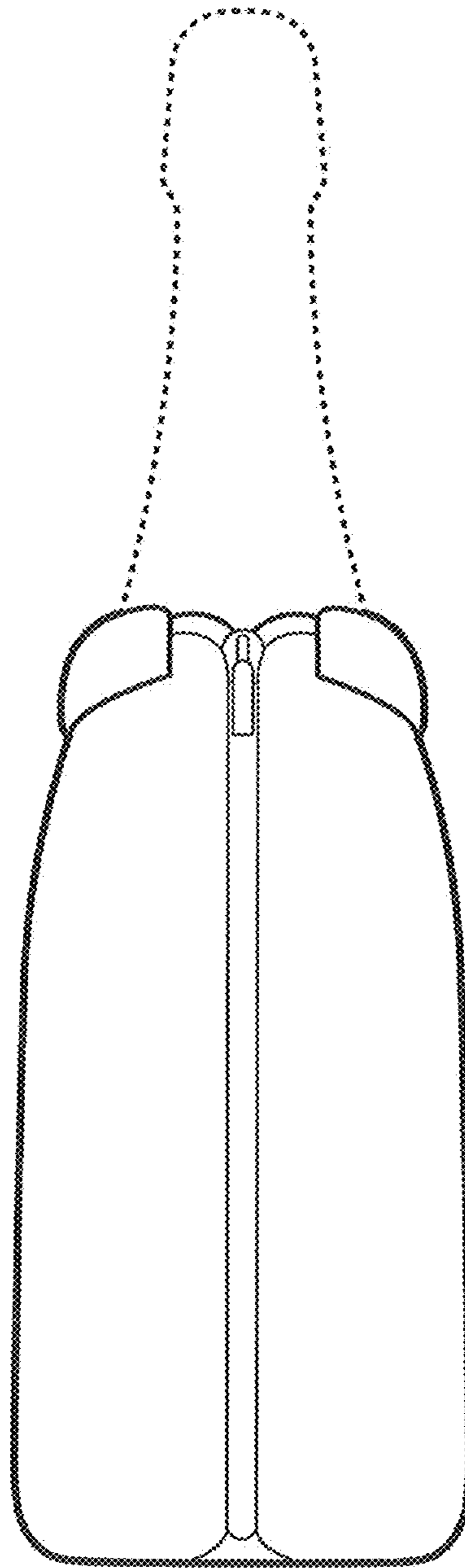

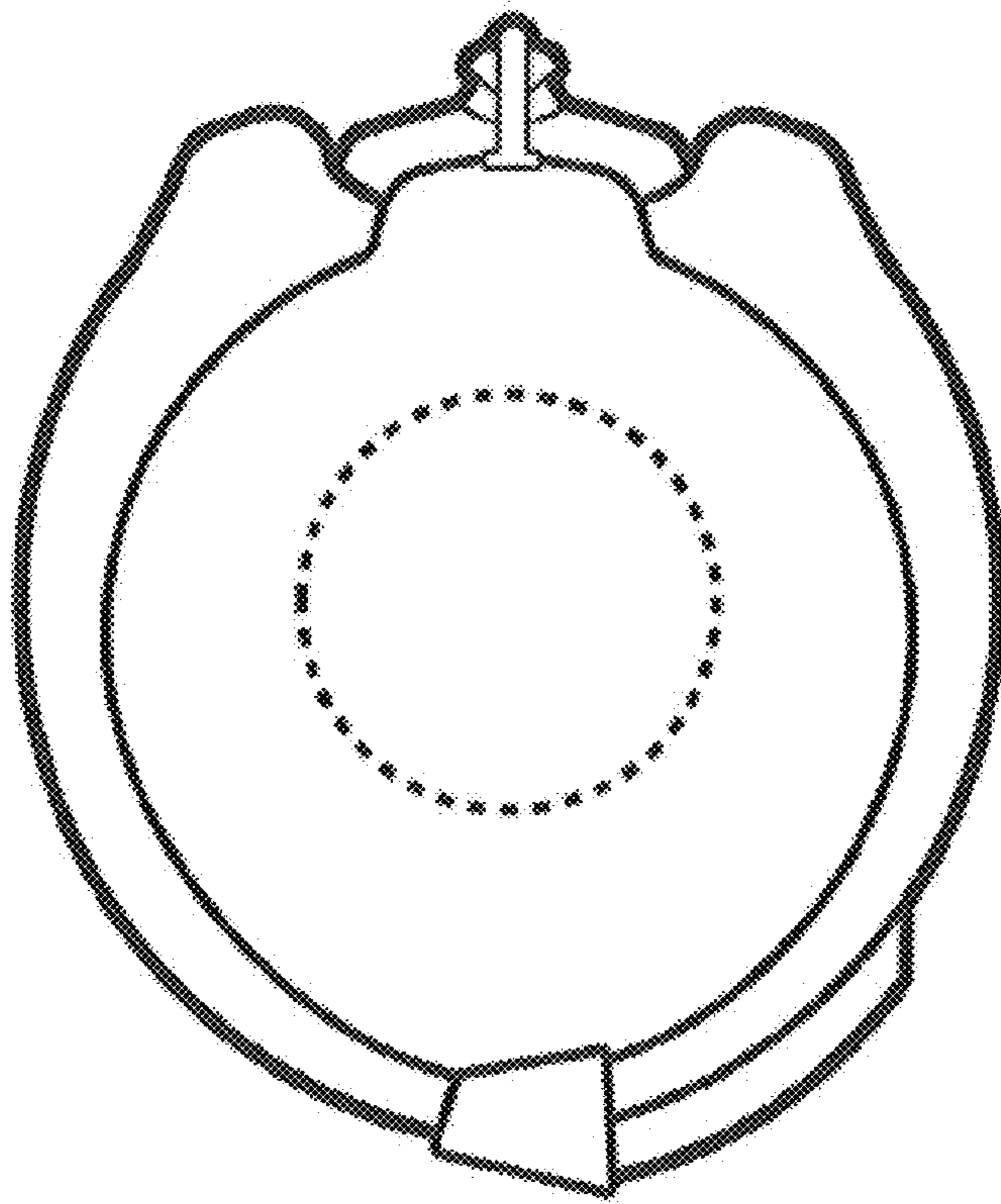

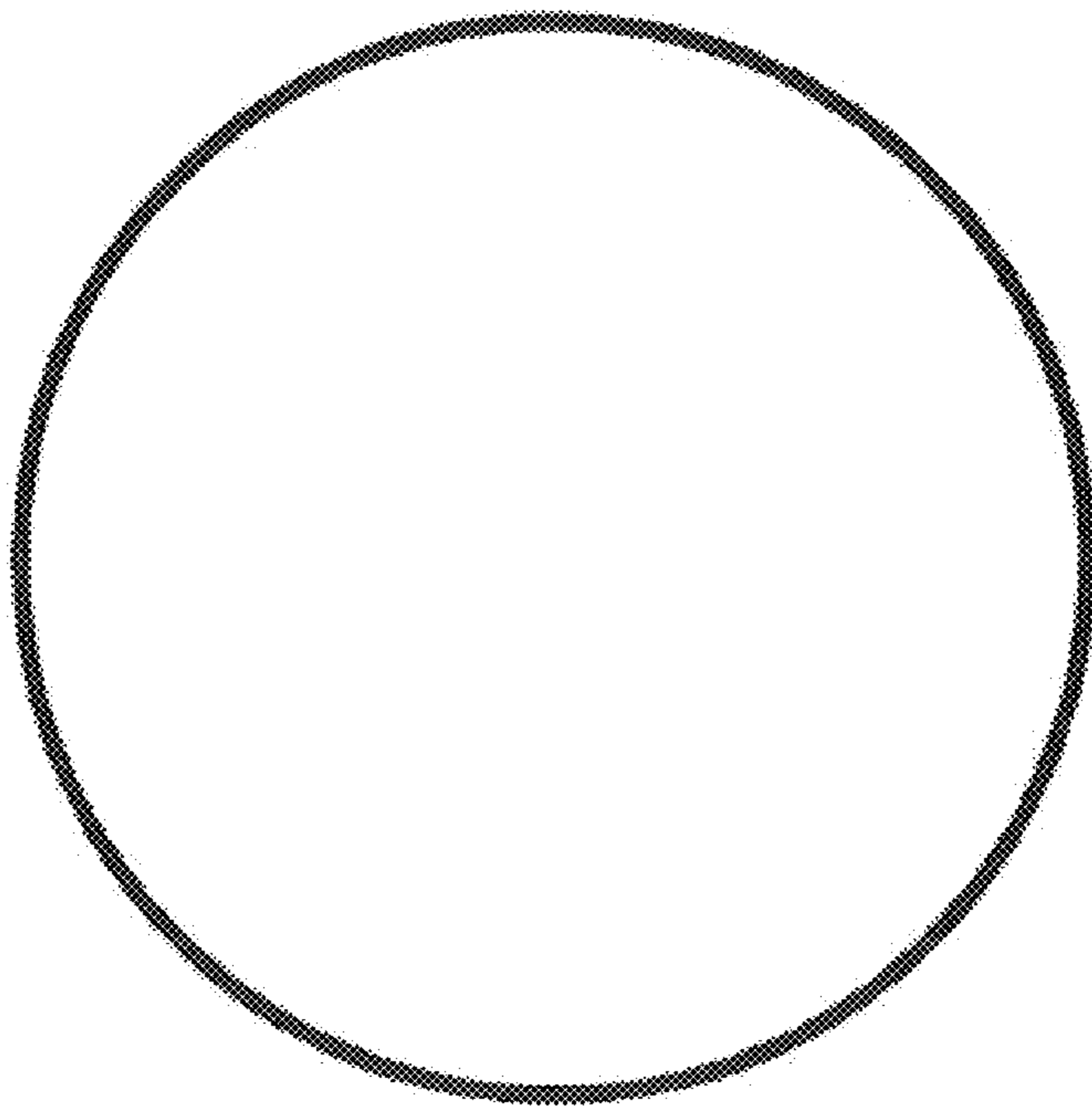
