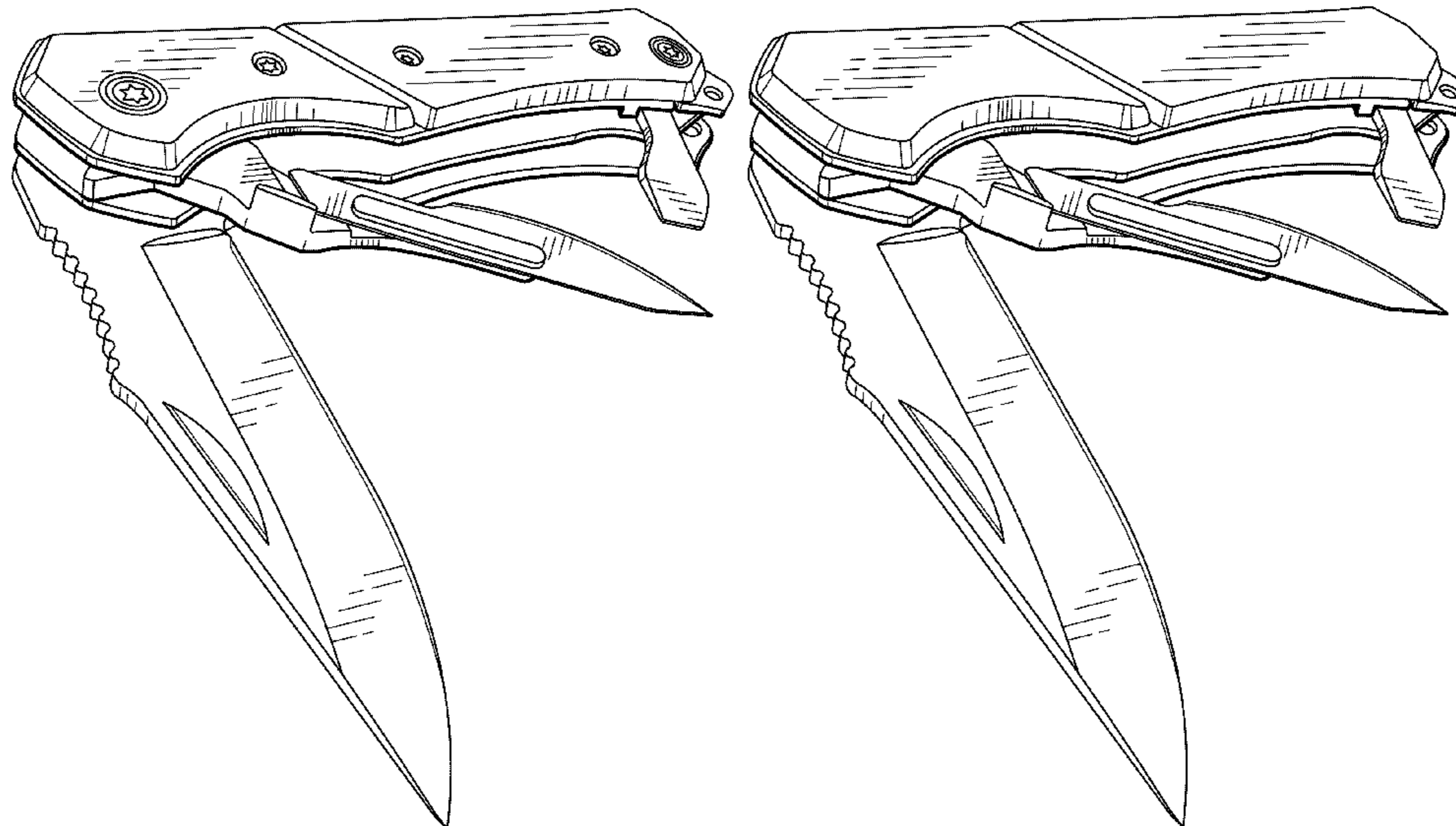
(57) **CLAIM**

I claim the ornamental design for the hunter's knife, as shown.

**DESCRIPTION**

FIG. 1 is a front elevation view of an exemplary embodiment of a hunter's knife;  
 FIG. 2 is a perspective view of the exemplary embodiment of the hunter's knife partially opened;  
 FIG. 3 is a front elevation view of the exemplary embodiment of the hunter's knife with a main blade fully opened;  
 FIG. 4 is a front elevation view of the exemplary embodiment of the hunter's knife with a secondary blade fully opened;  
 FIG. 5 is an upper perspective view of the exemplary embodiment of the hunter's knife with a tertiary blade fully opened;  
 FIG. 6 is a front elevation view of an alternative embodiment of a hunter's knife;  
 FIG. 7 is a perspective view of the alternative embodiment of the hunter's knife partially opened;  
 FIG. 8 is a front elevation view of the alternative embodiment of the hunter's knife with a main blade fully opened;  
 FIG. 9 is a front elevation view of the alternative embodiment of the hunter's knife with a secondary blade fully opened;  
 and,  
 FIG. 10 is an upper perspective view of the alternative embodiment of the hunter's knife with a tertiary blade fully opened.

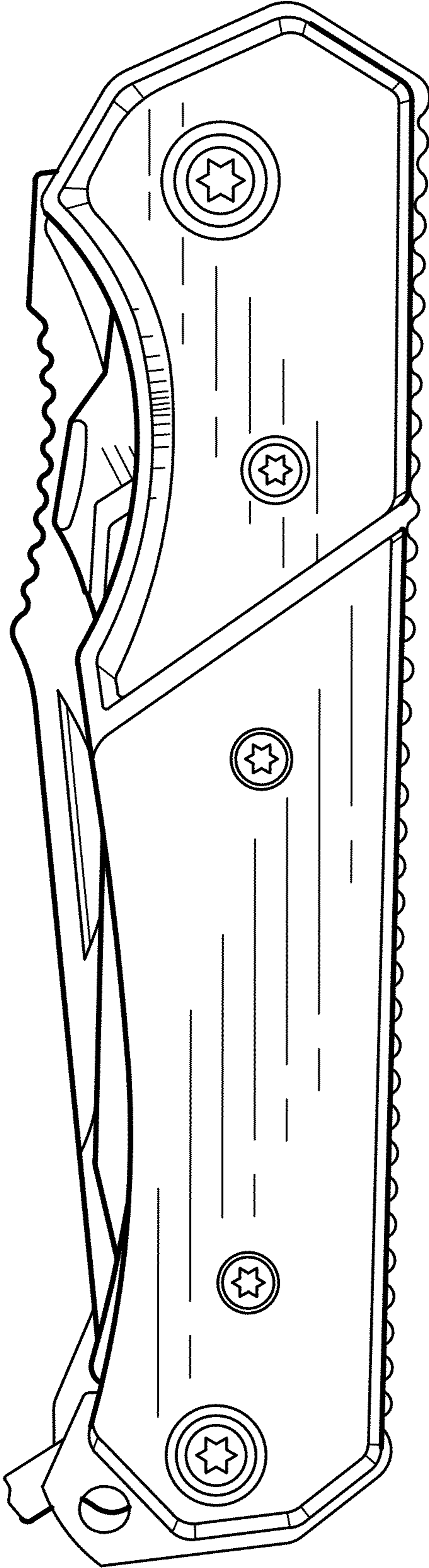

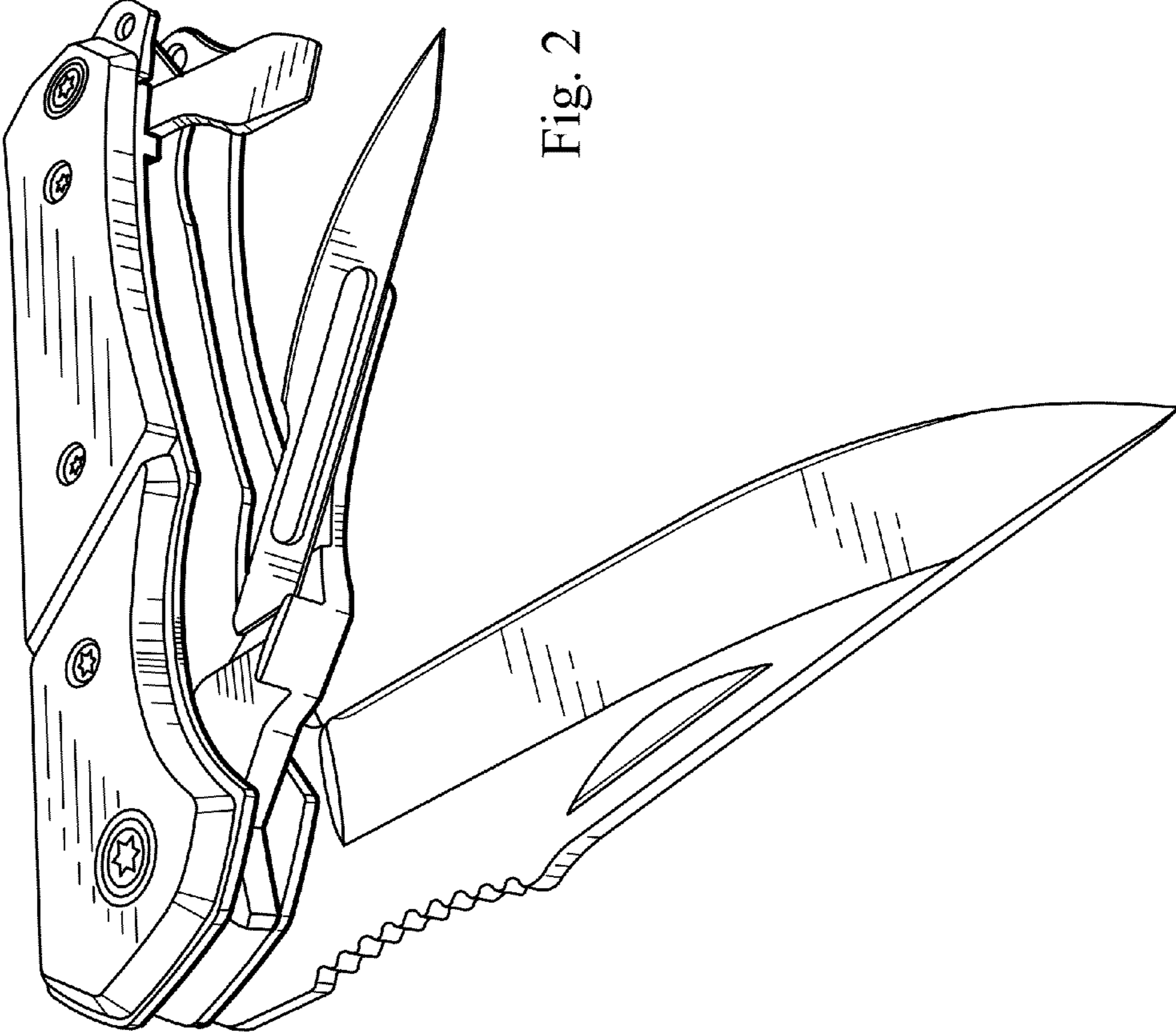

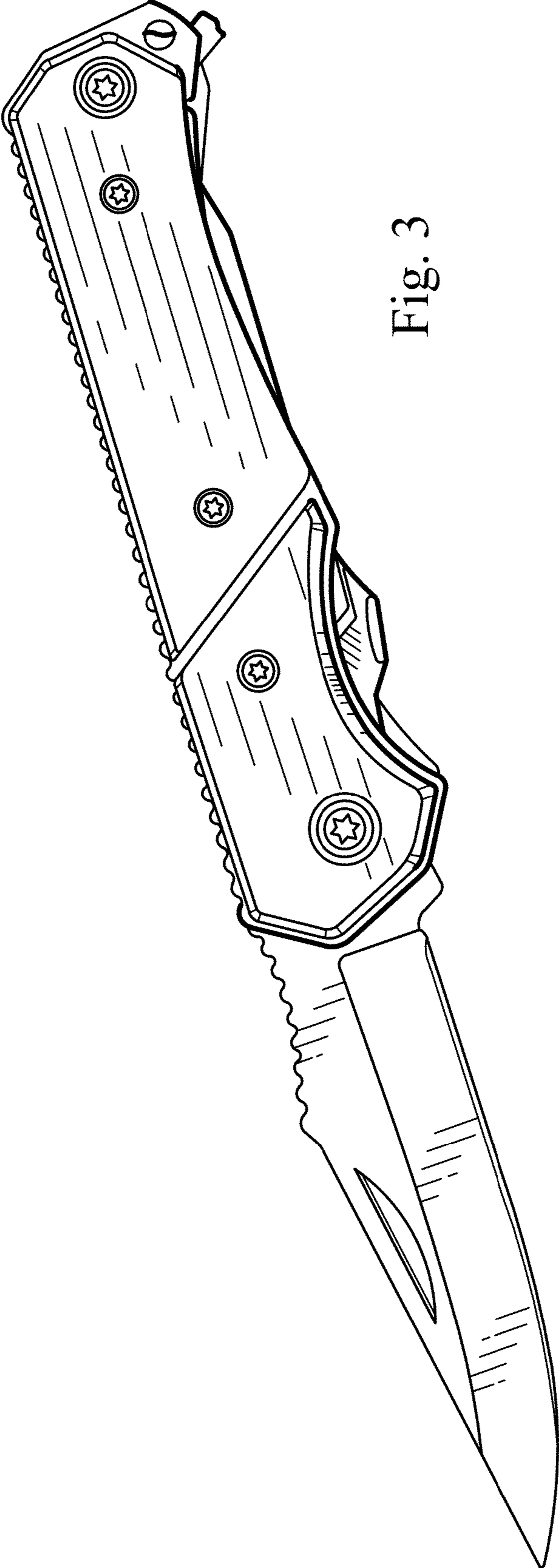

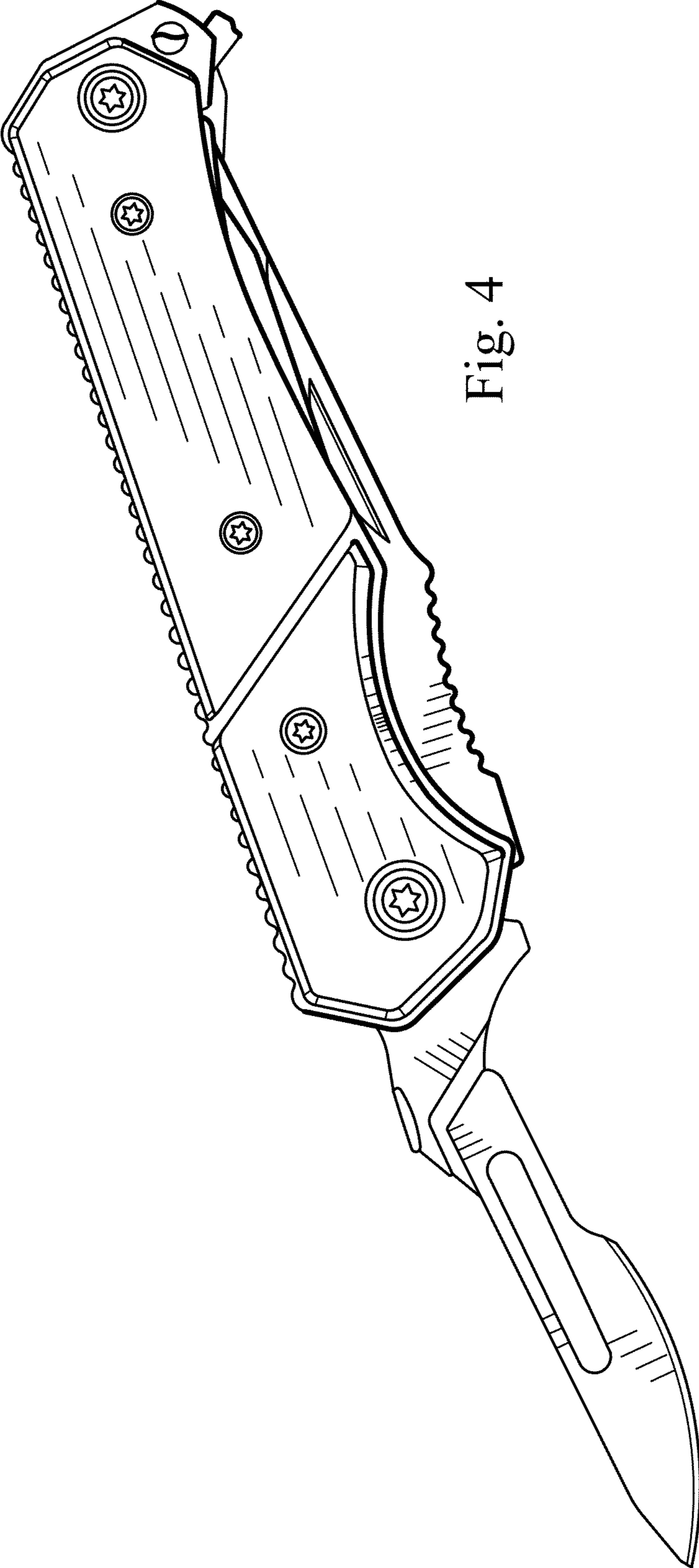

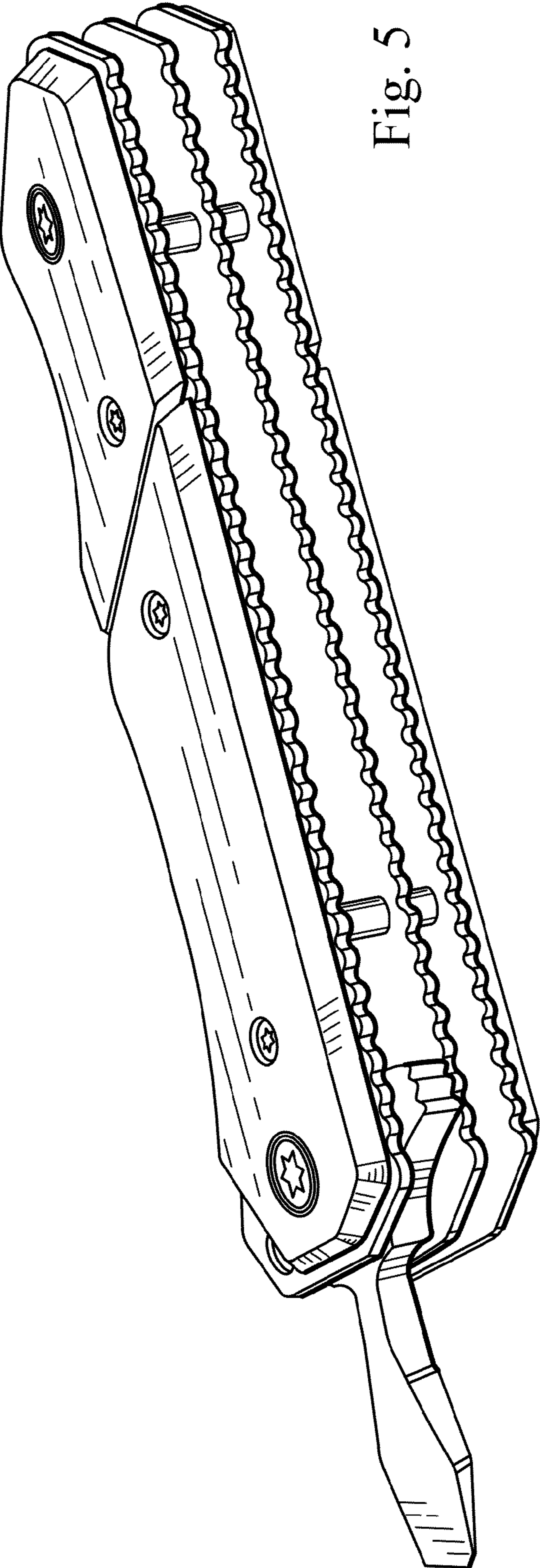

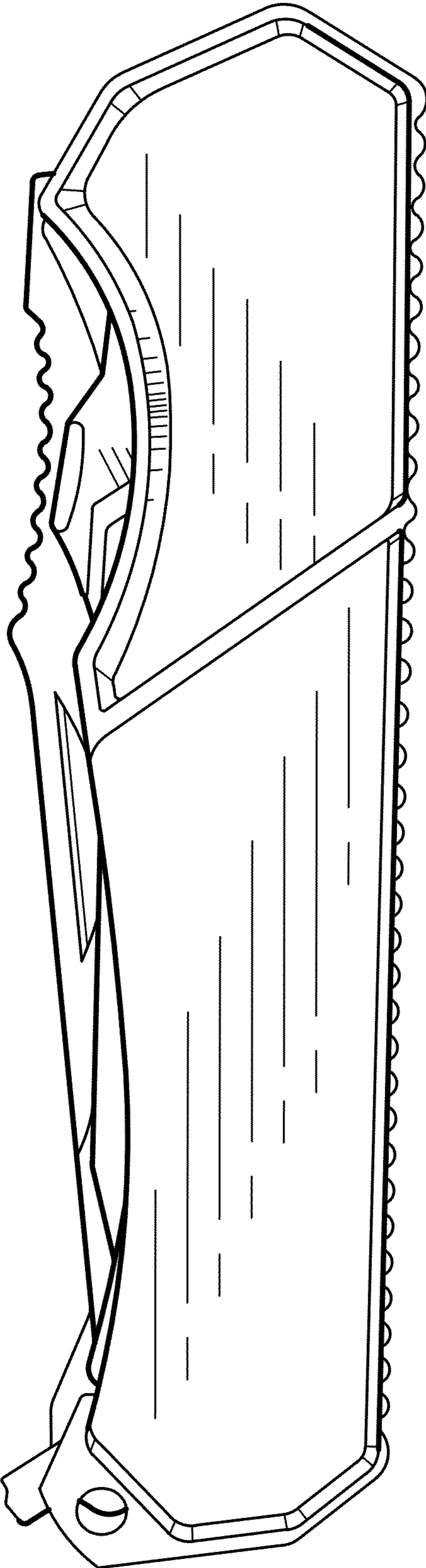

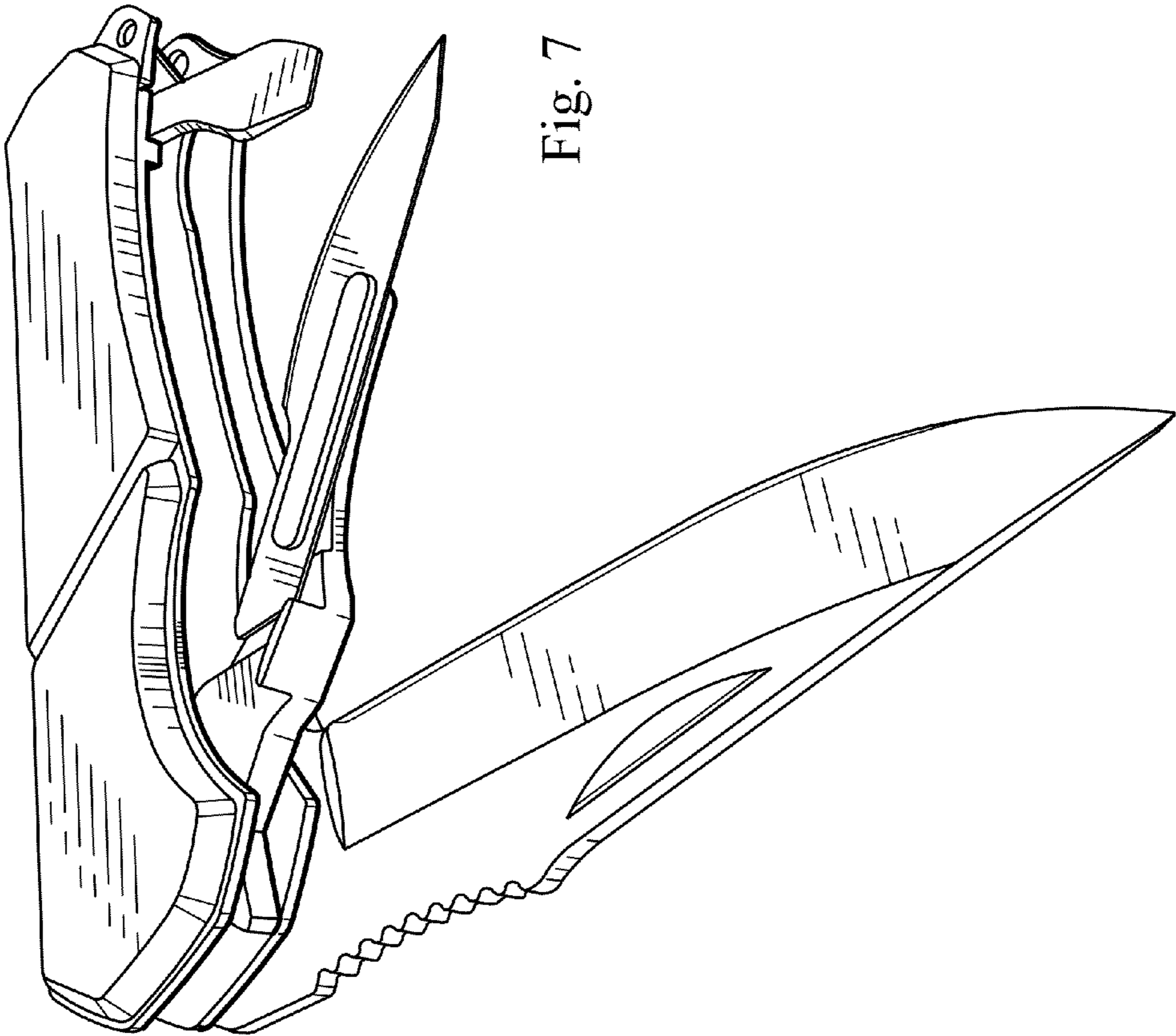

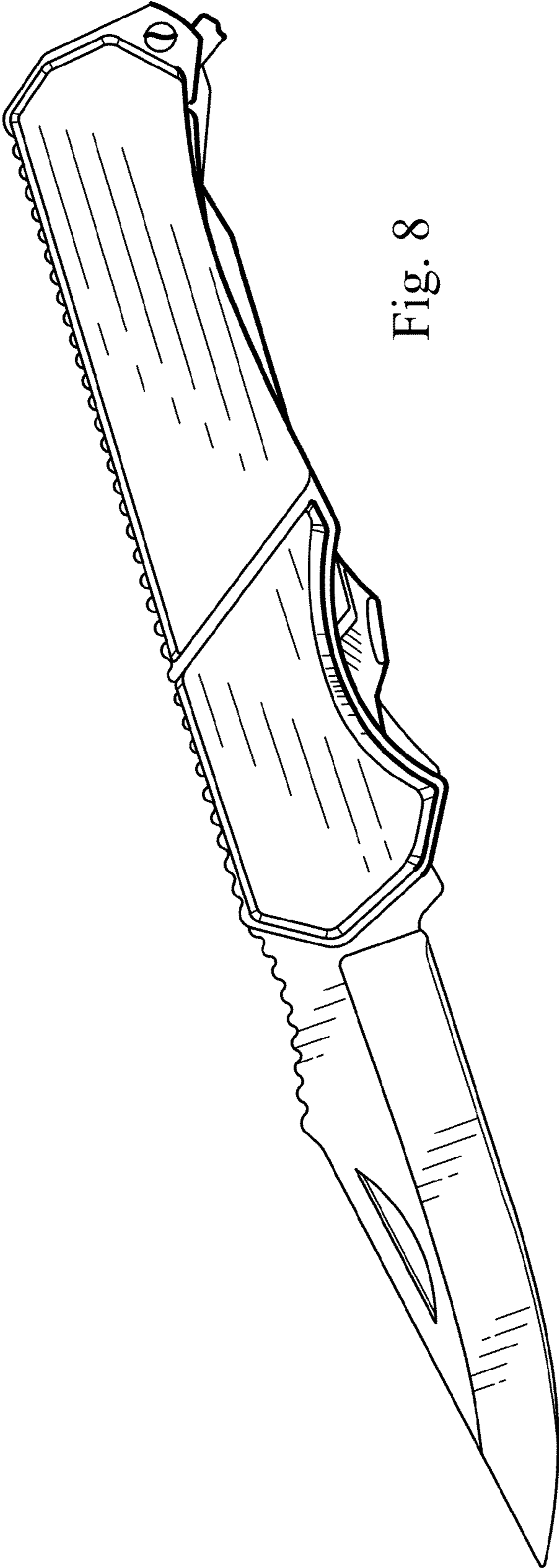

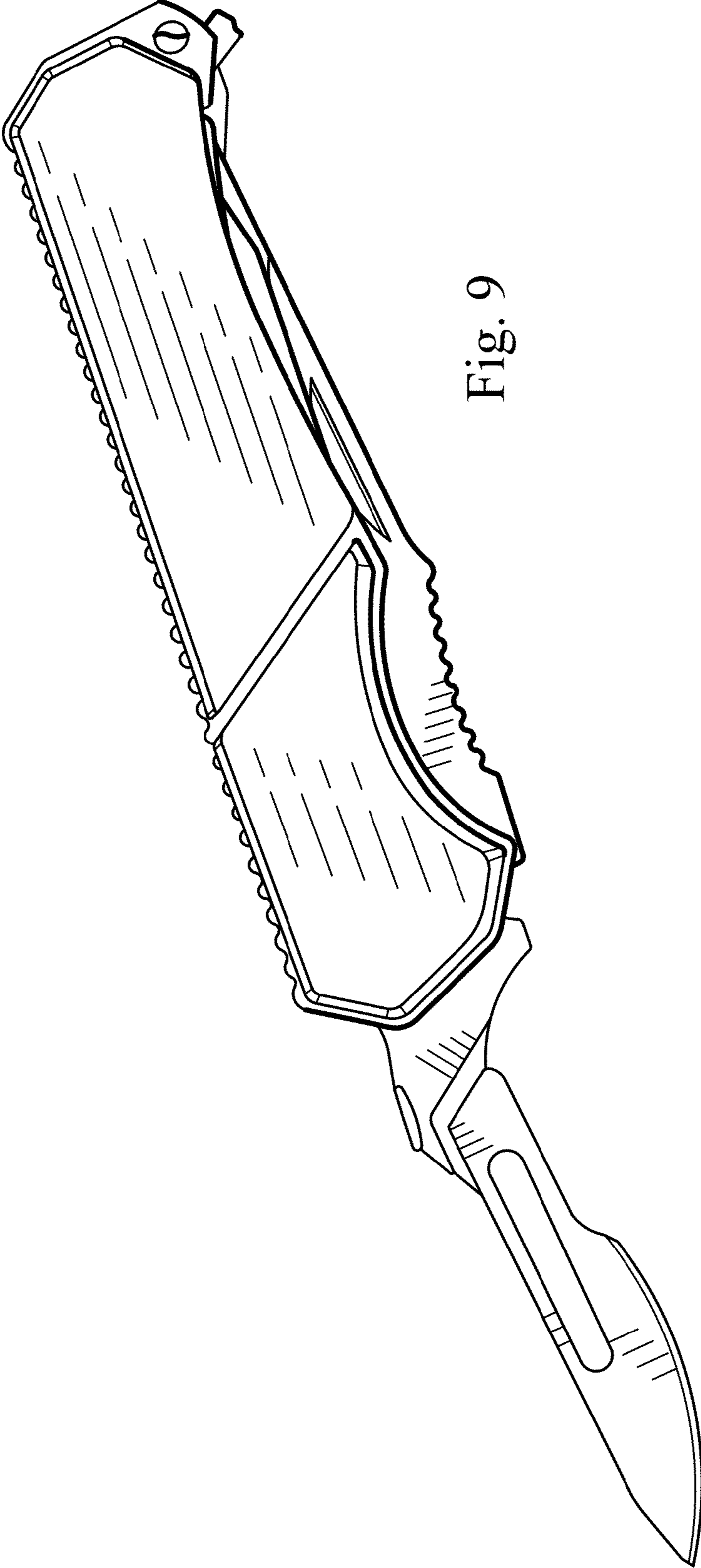

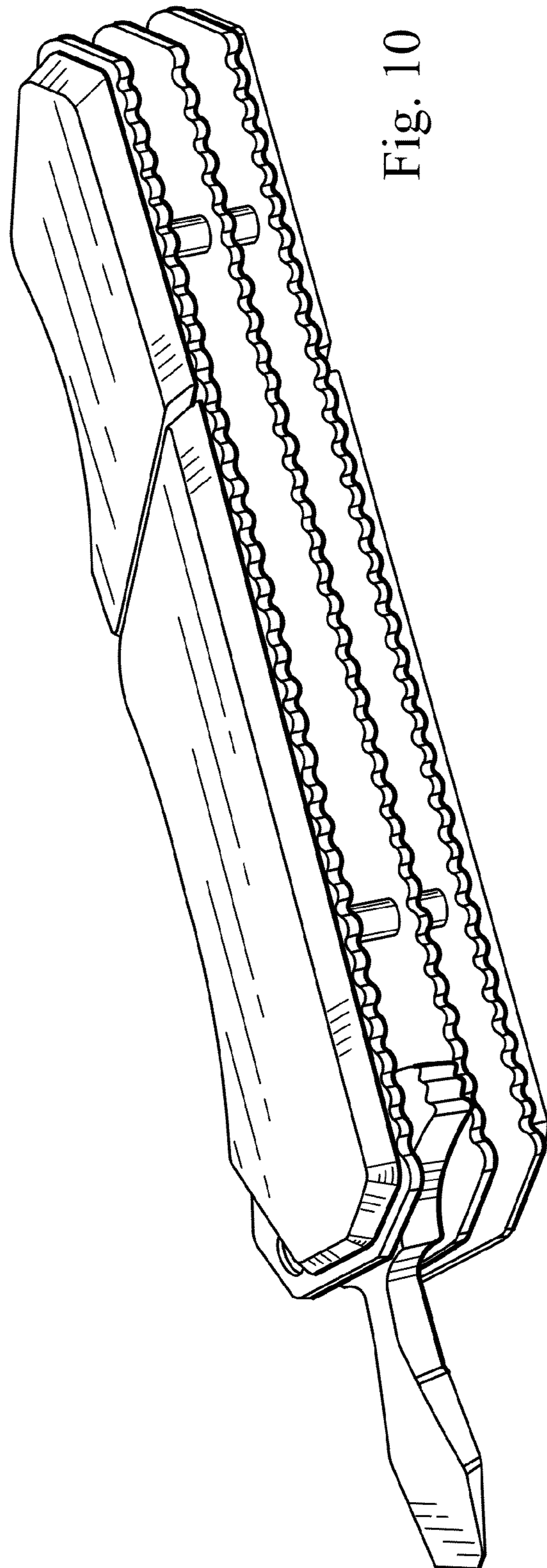
