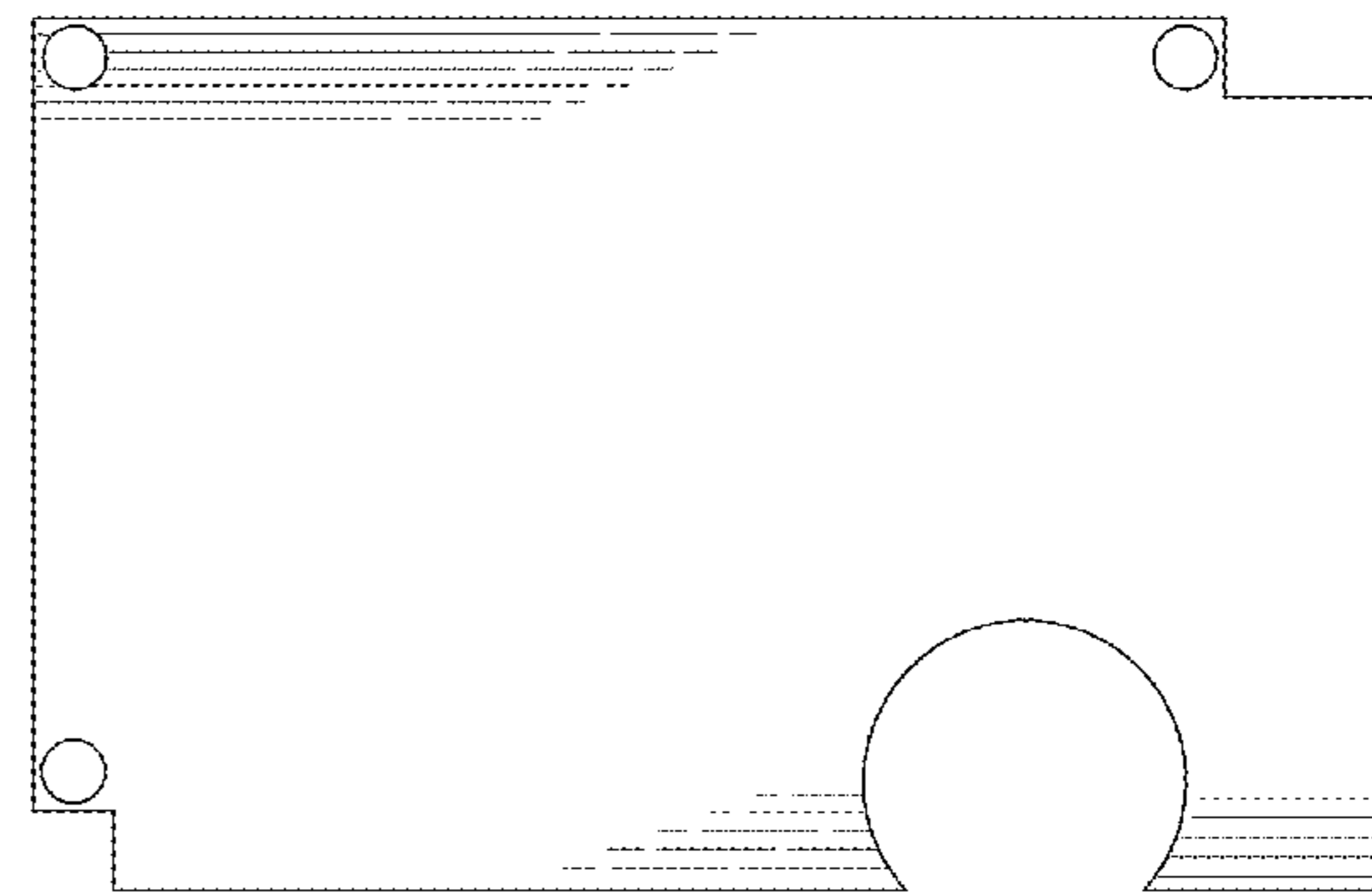
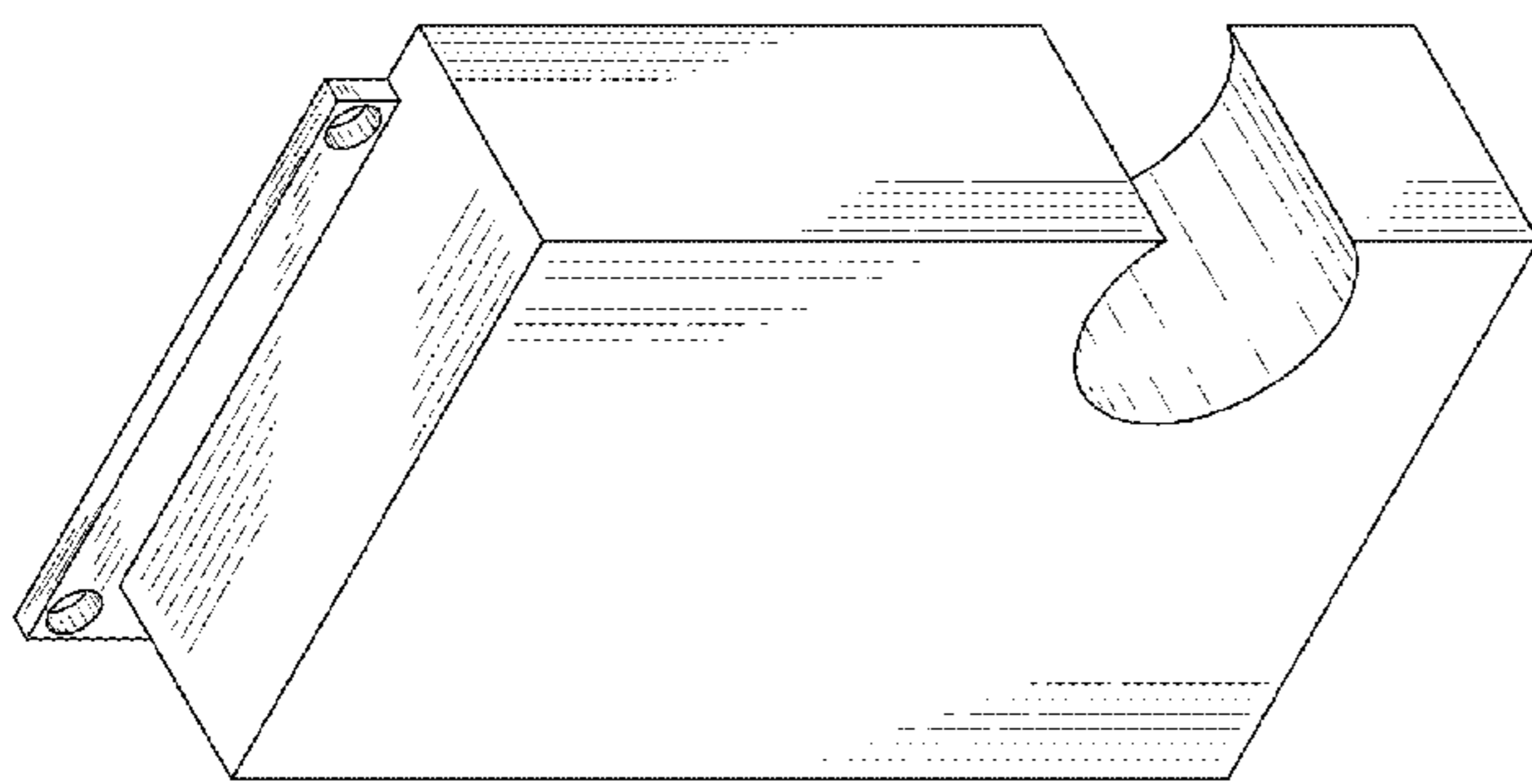
(57) **CLAIM**

The ornamental design for an eclipse cabinet pull, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an eclipse cabinet pull;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view thereof as installed in a door,
drawer, or similar structure.
The broken line showing of a door in FIG. 8 is included for the
purpose of showing environmental structure and forms no
part of the claimed design.

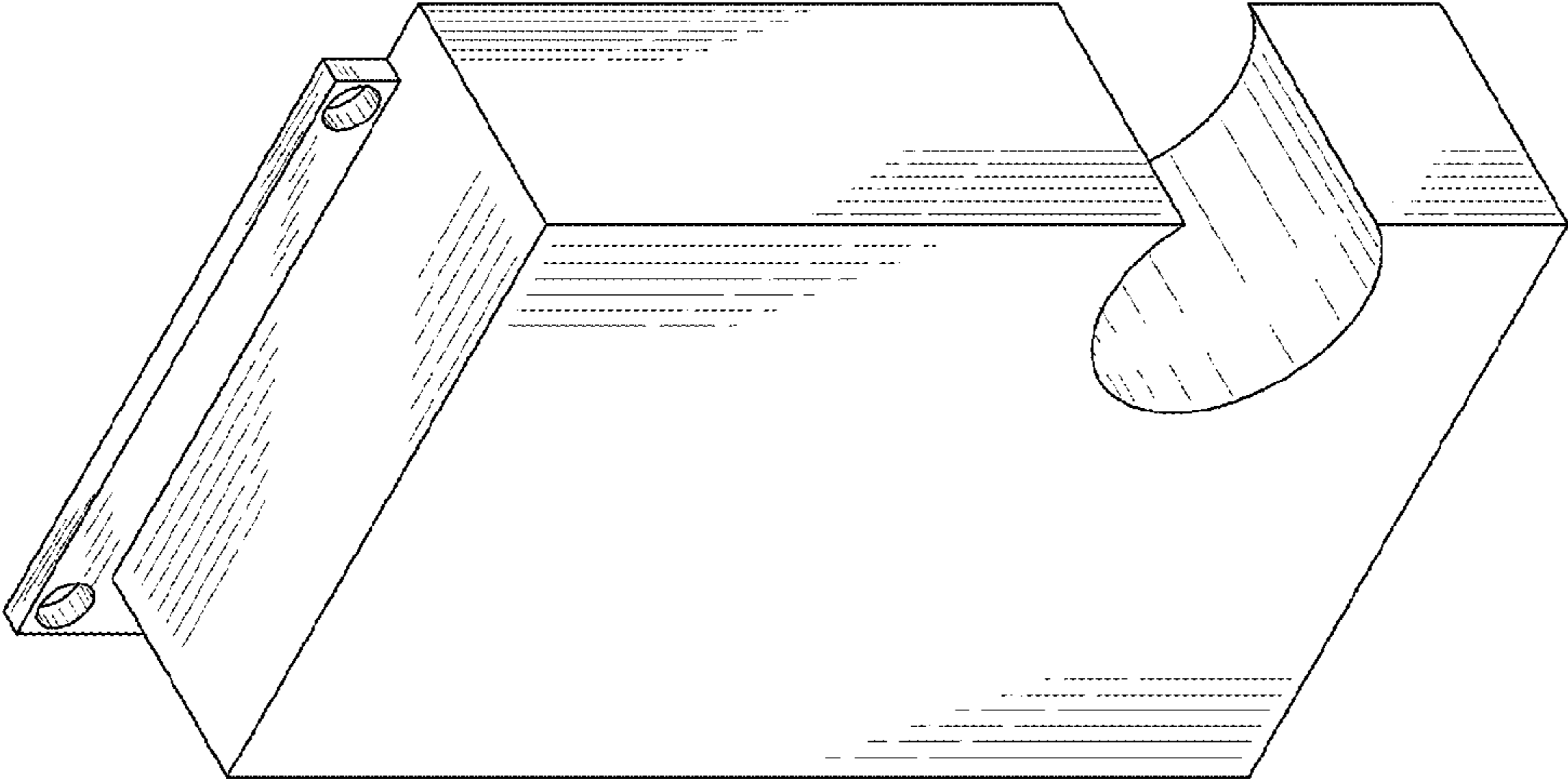

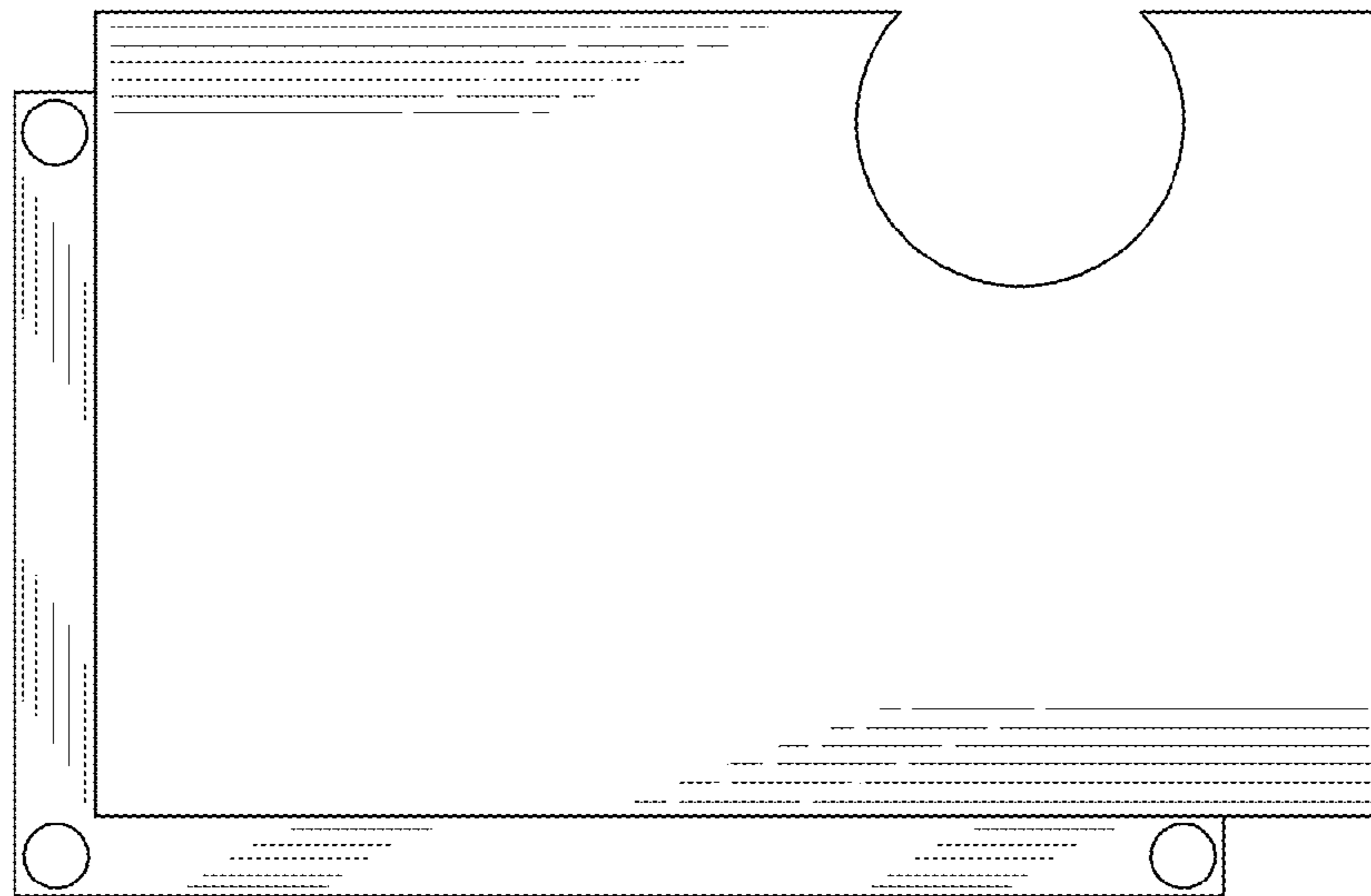

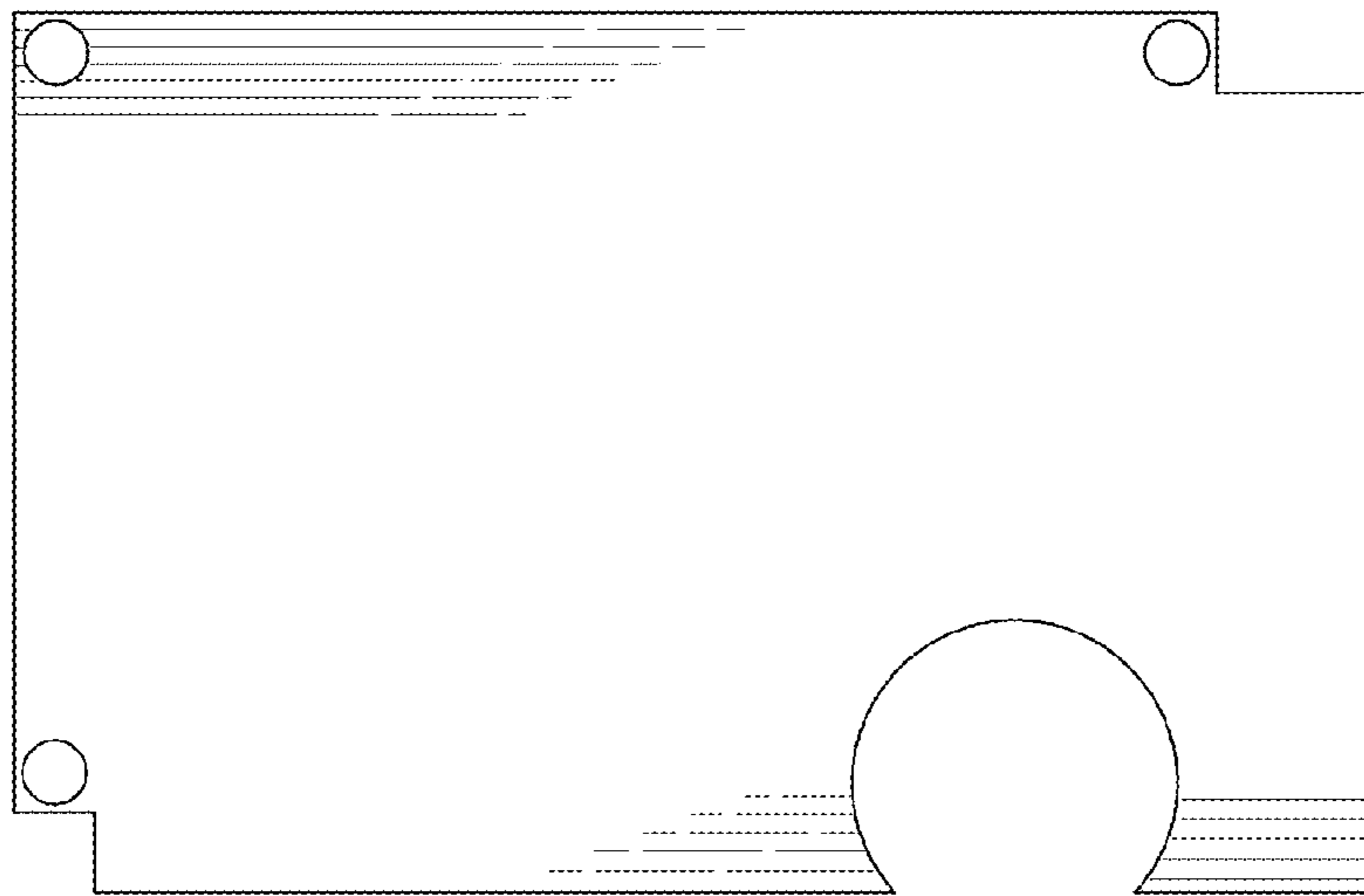

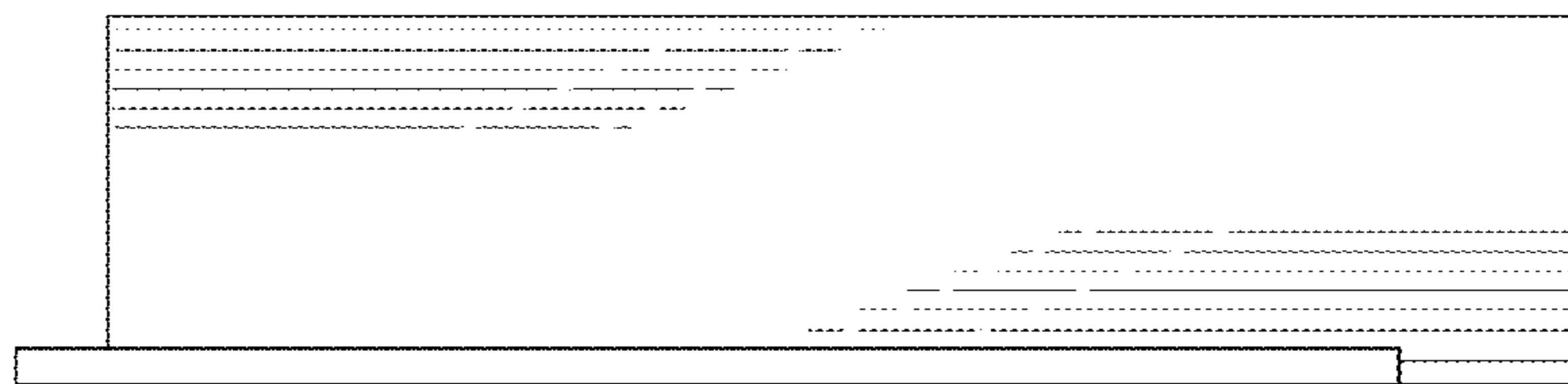

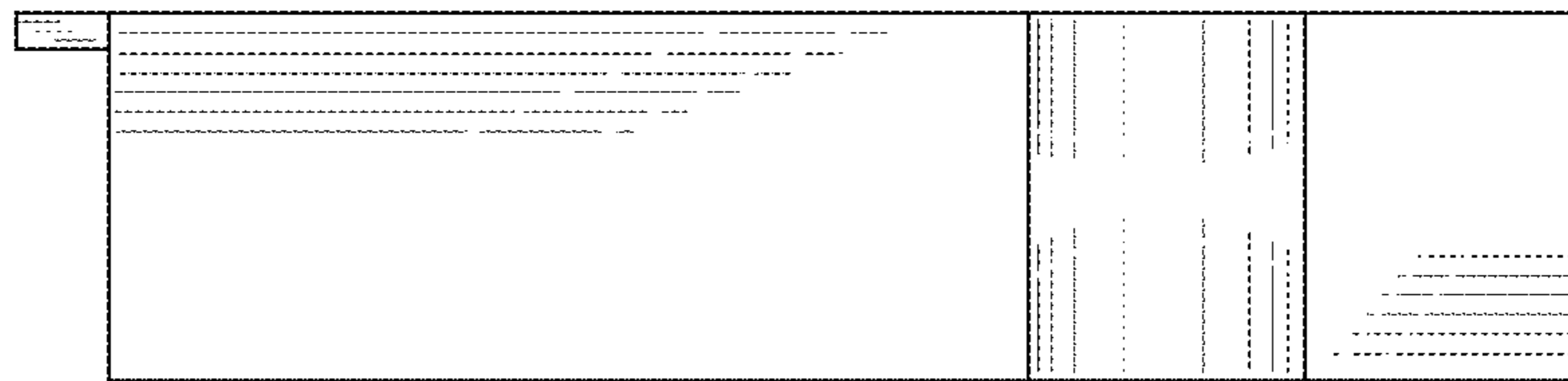

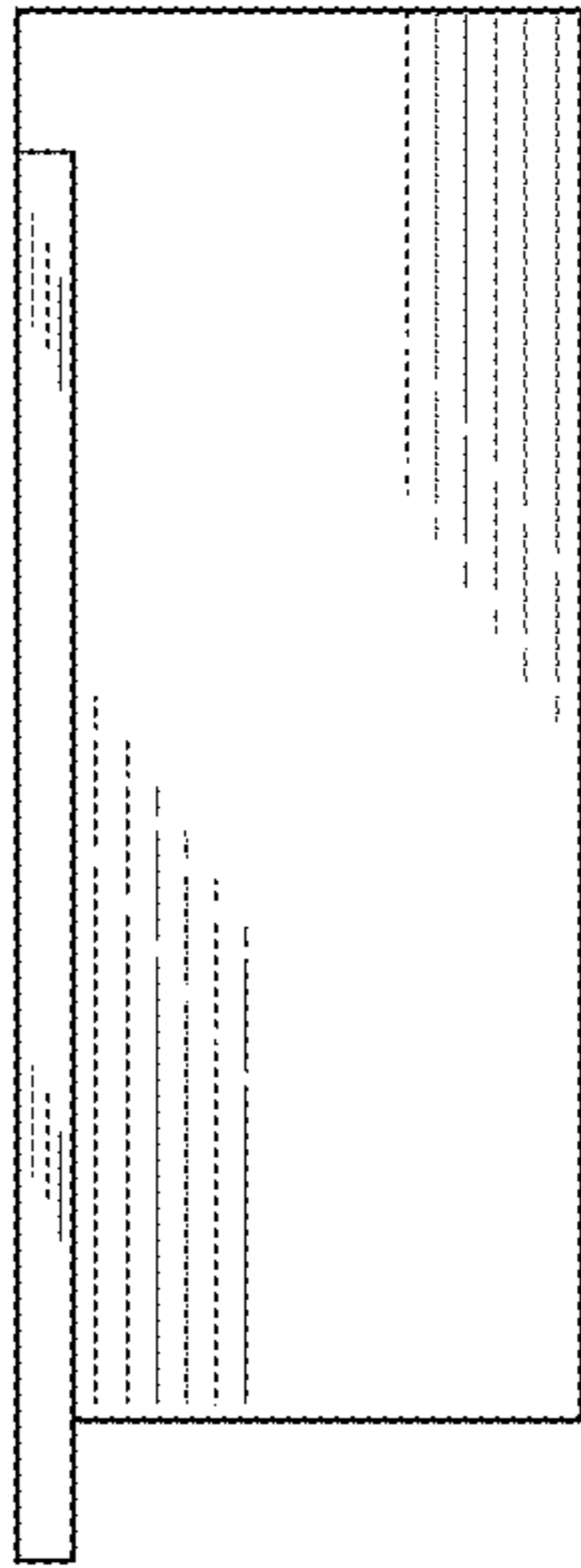

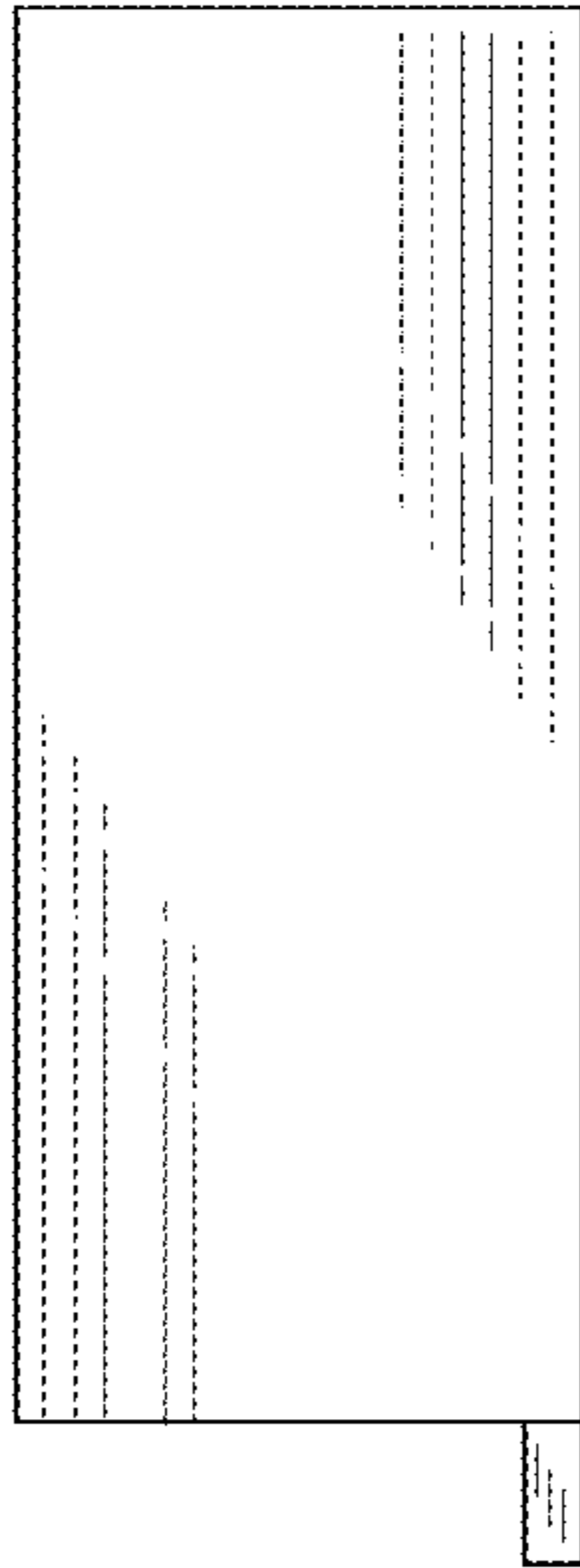

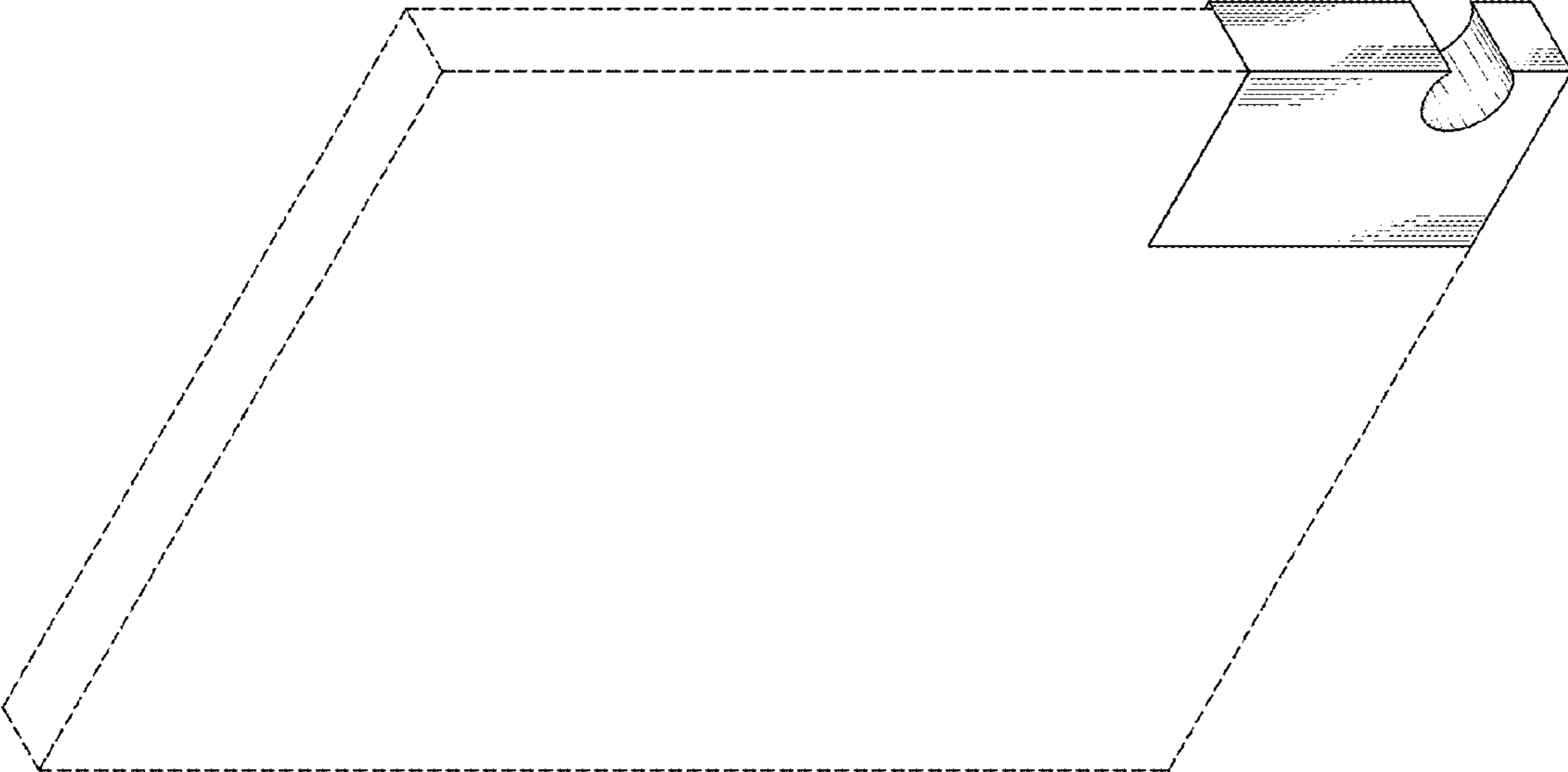
