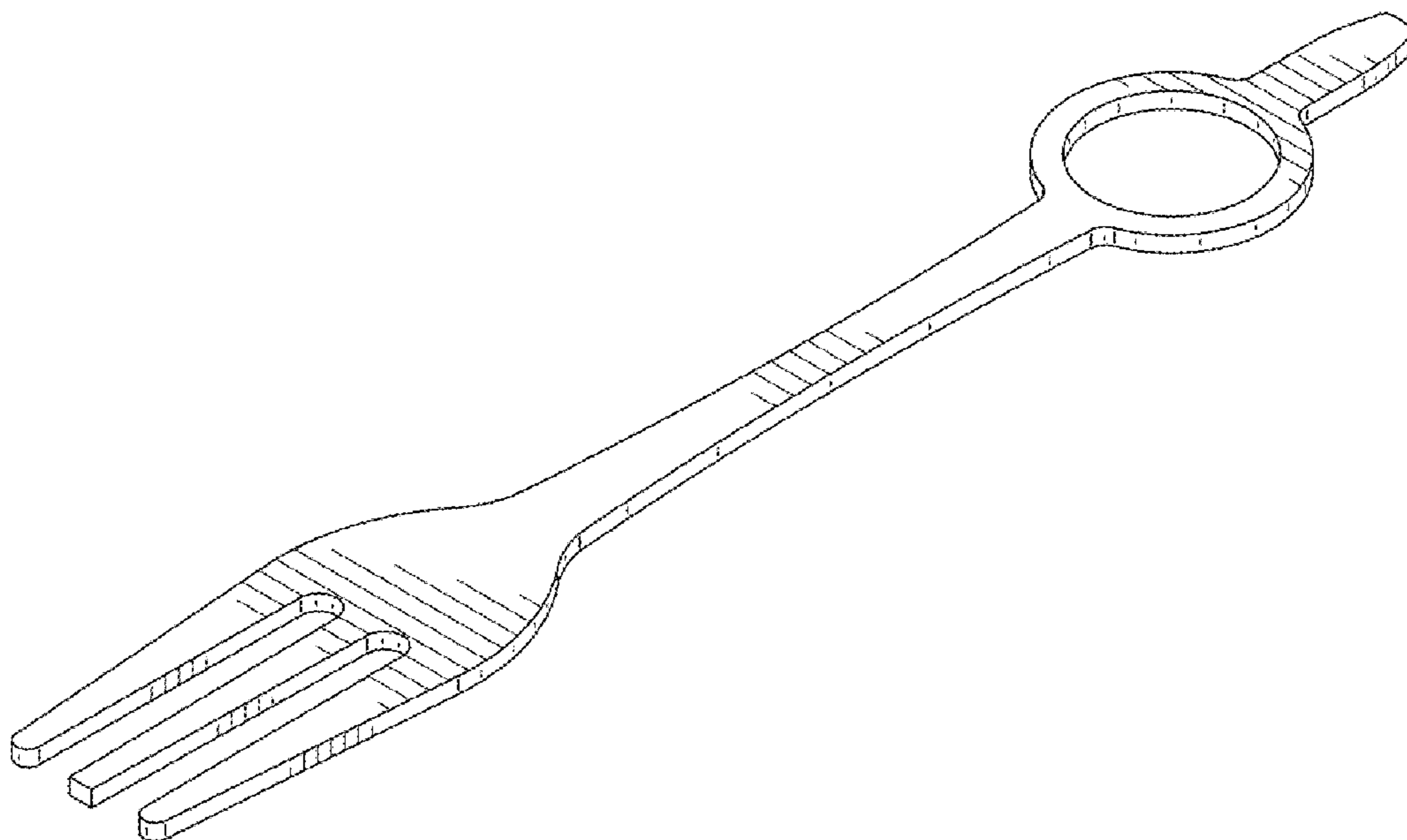

(57) **CLAIM**
The ornamental design for a watch hand, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a watch hand showing my new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a side view thereof;
FIG. 4 is a top/bottom view thereof;
FIG. 5 is a front view thereof (looking at the tines of the fork);
FIG. 6 is a rear view thereof;
FIG. 7 is an environmental perspective view thereof; and,
FIG. 8 is a second environmental perspective view thereof.
The portions of the figures shown in broken lines form no part of the claimed design.

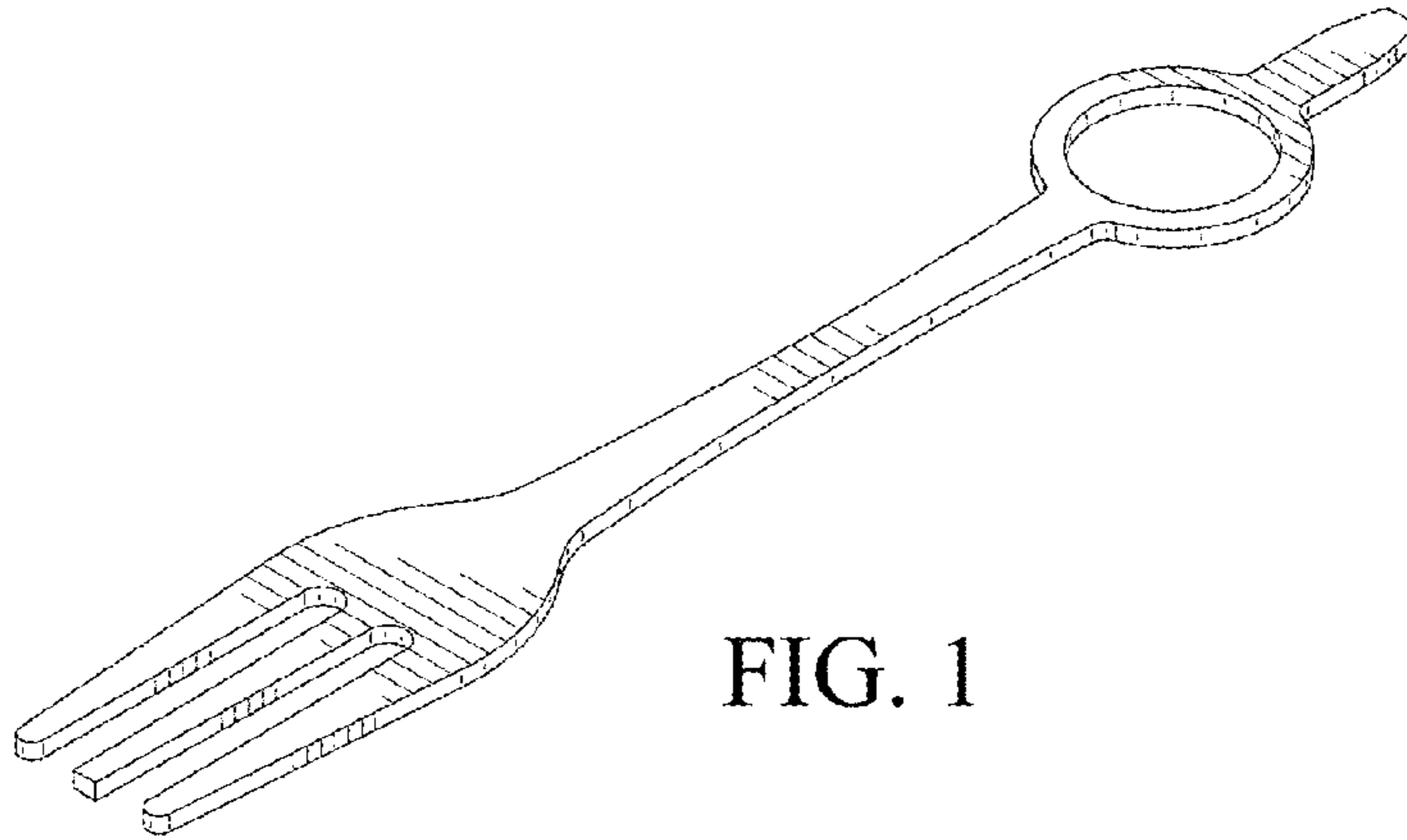

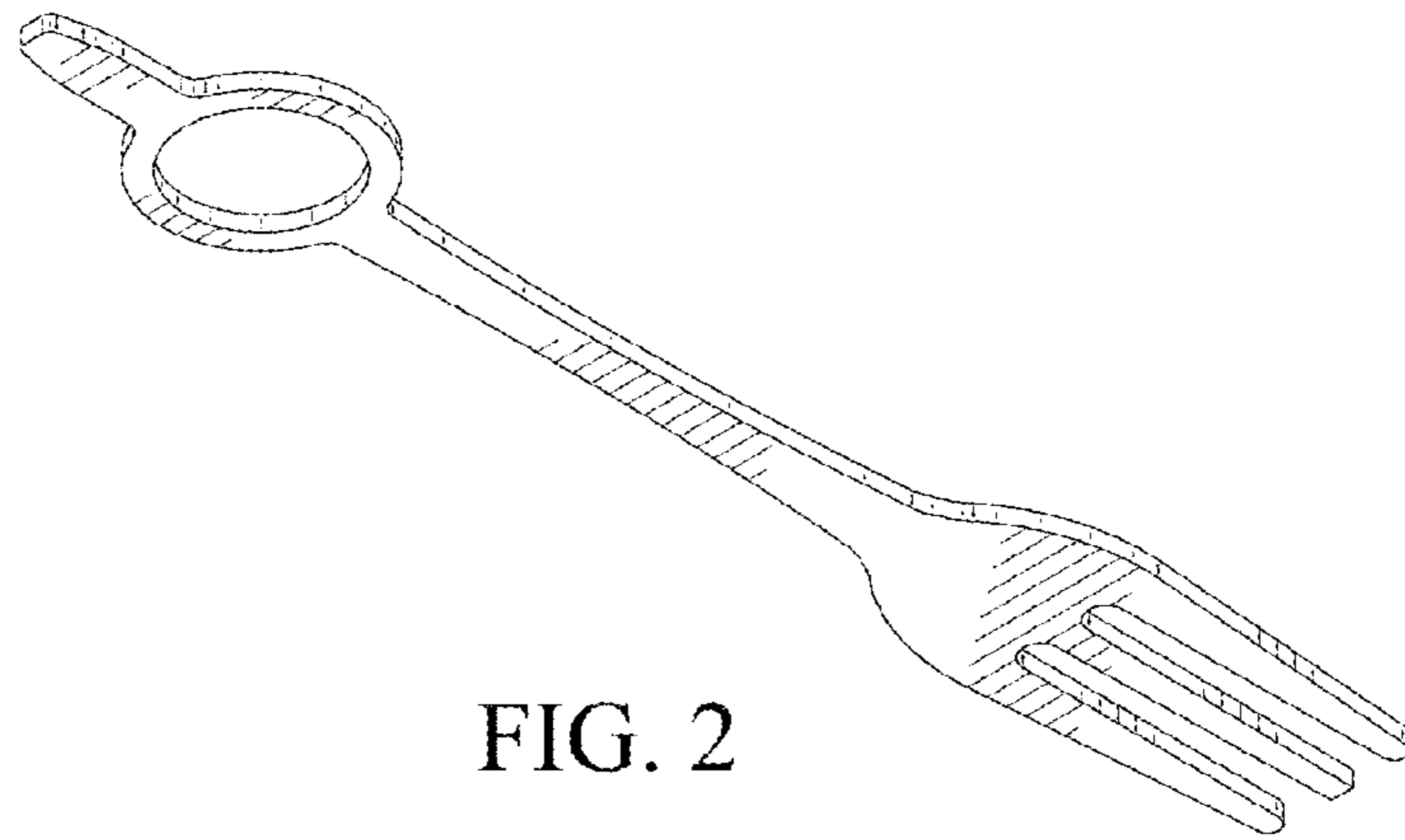

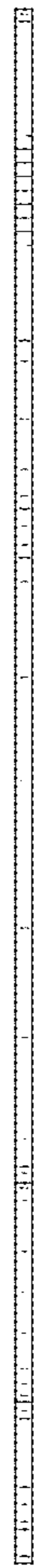

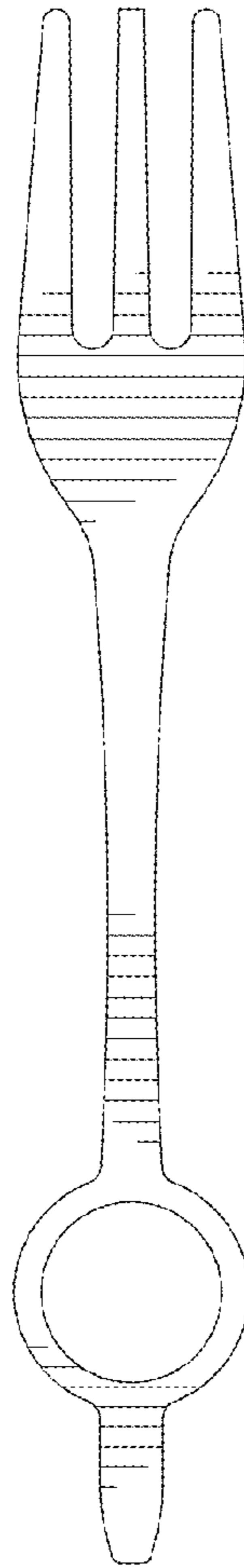

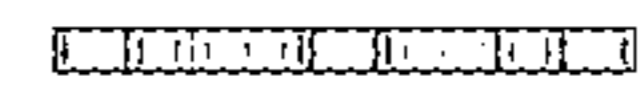

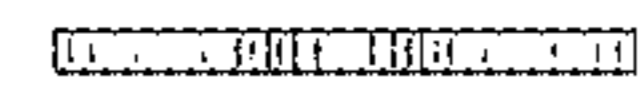

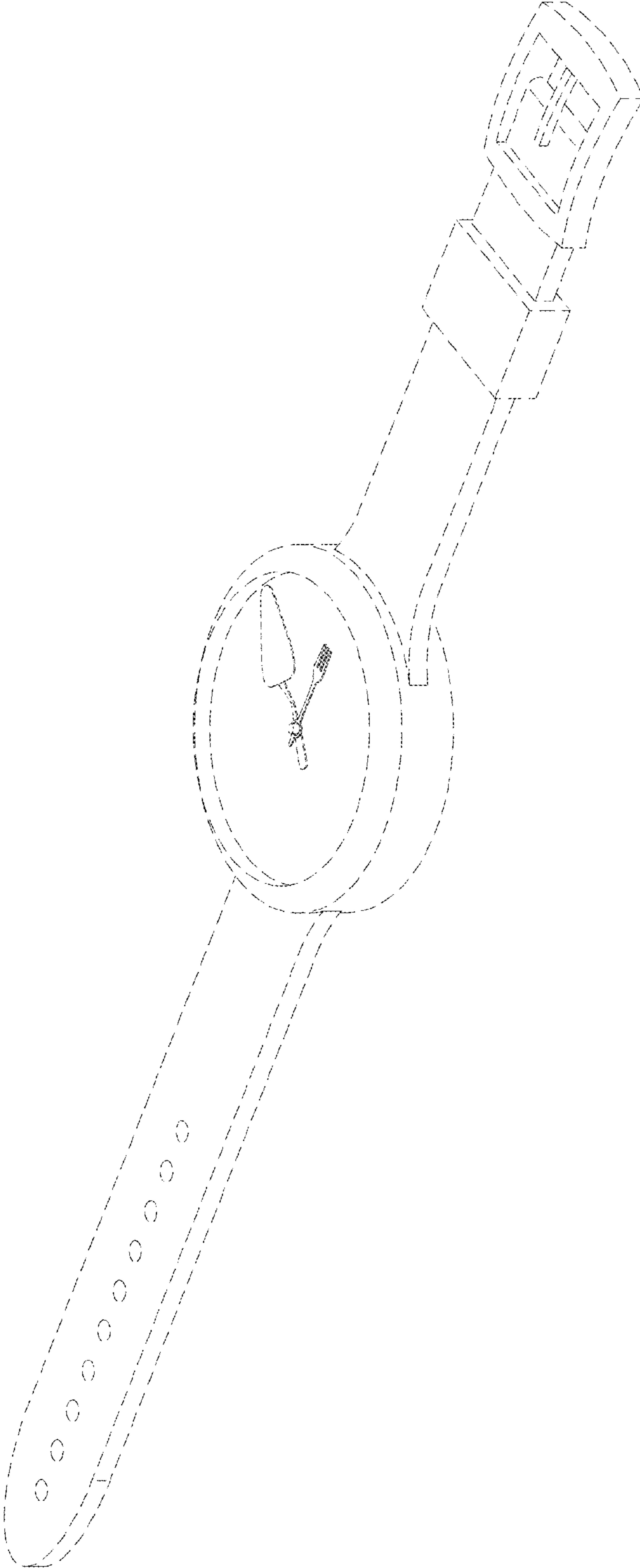

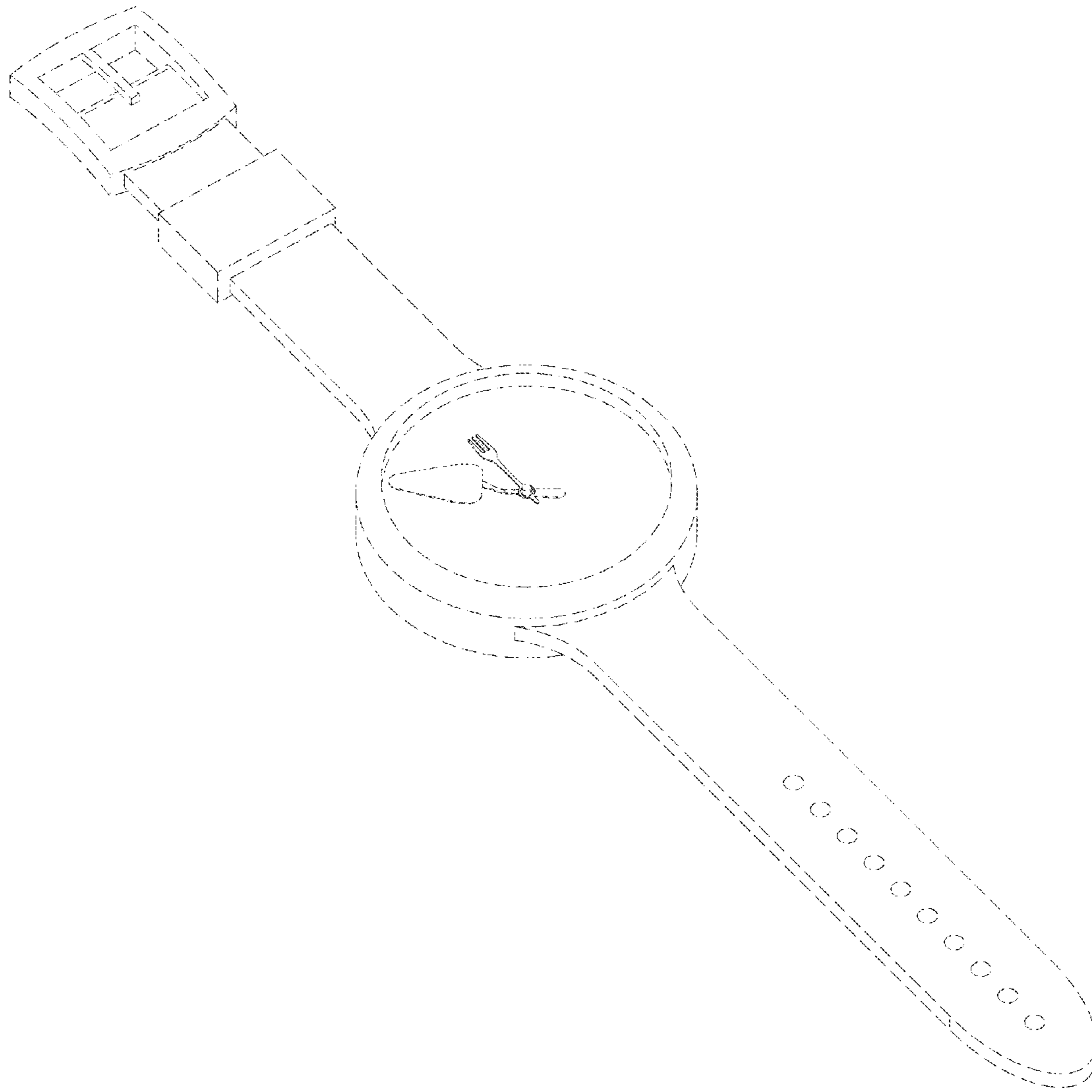
