(57) **CLAIM**

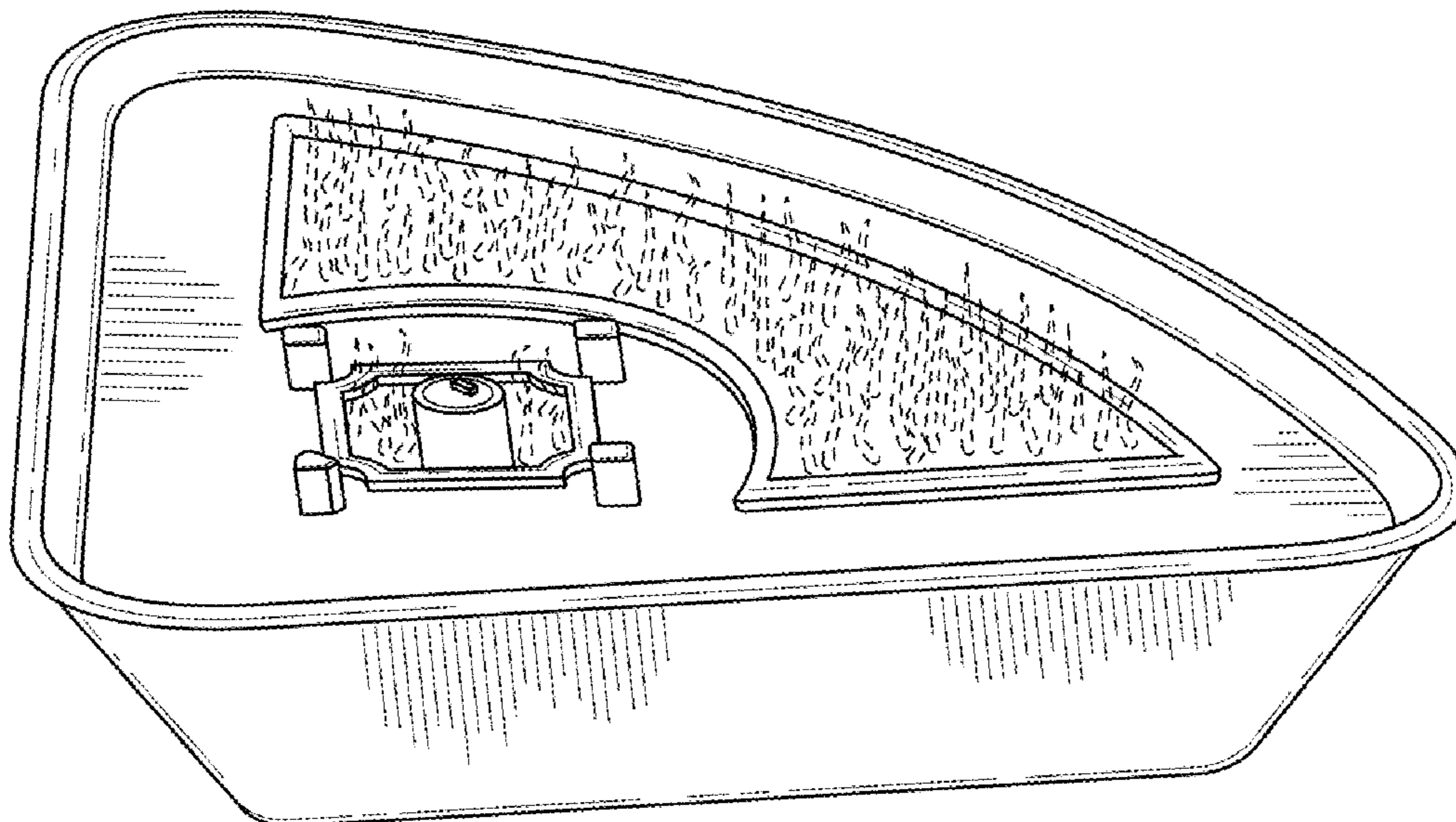
The ornamental design for a baseball field planter, as shown

DESCRIPTION

FIG. 1 is a top and side perspective view of a baseball field
planter showing my new design;
FIG. 2 is a left side elevation view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a front side elevational view;
FIG. 5 is a back side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view.

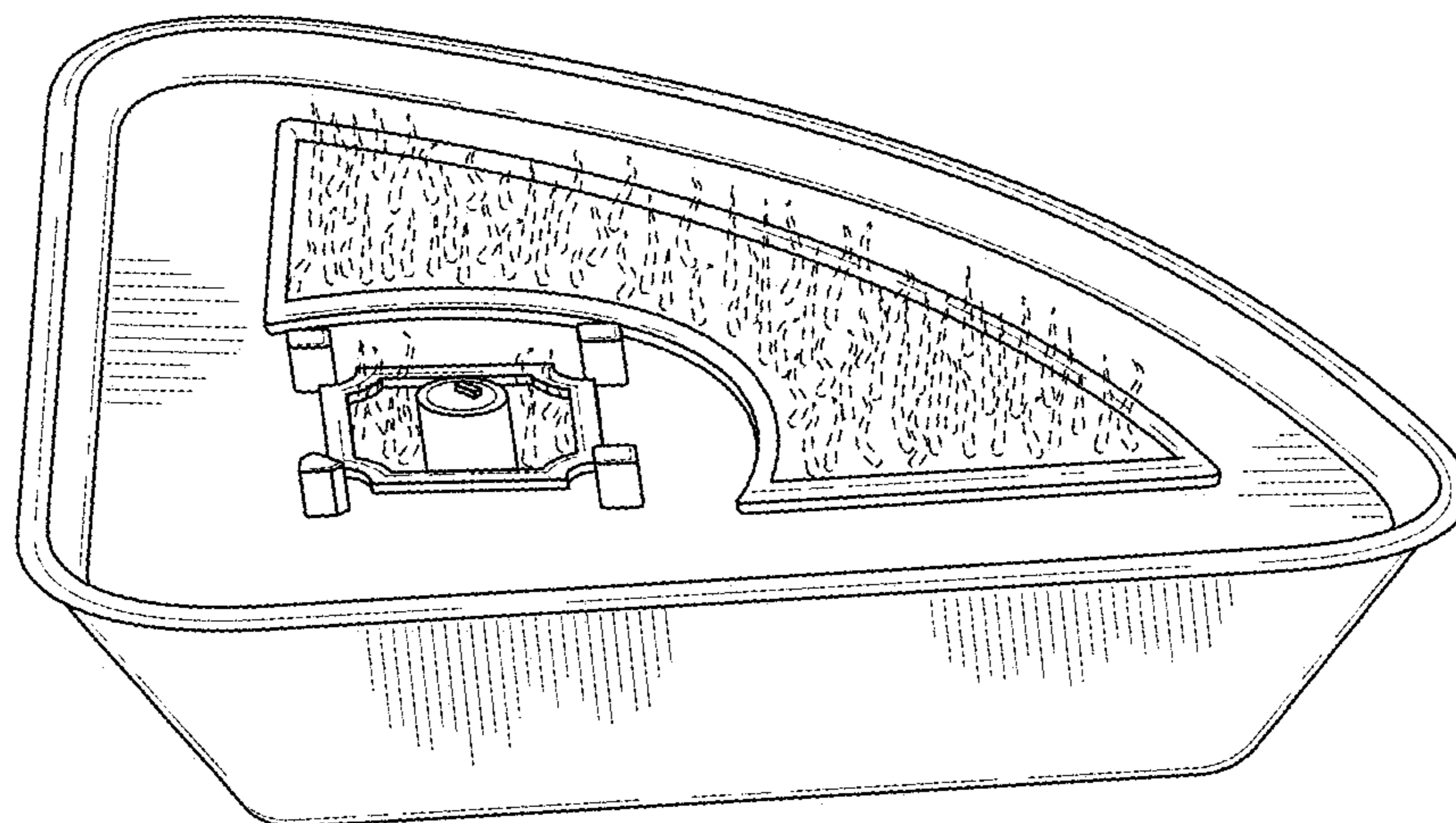

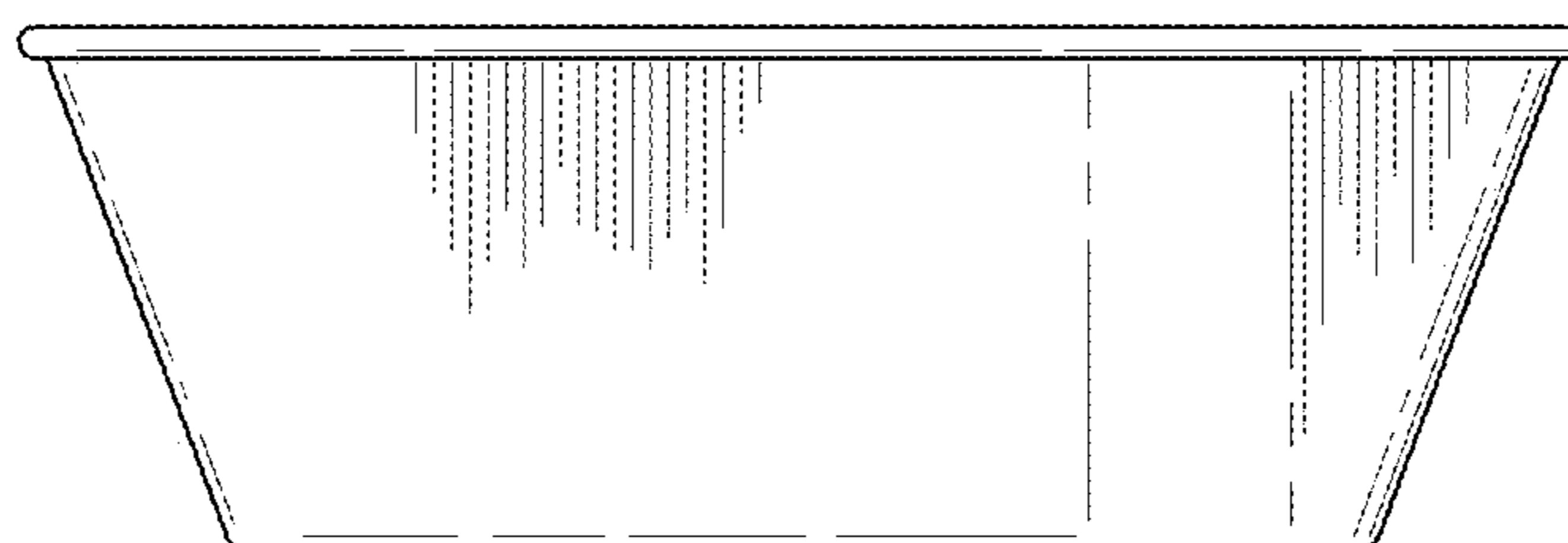

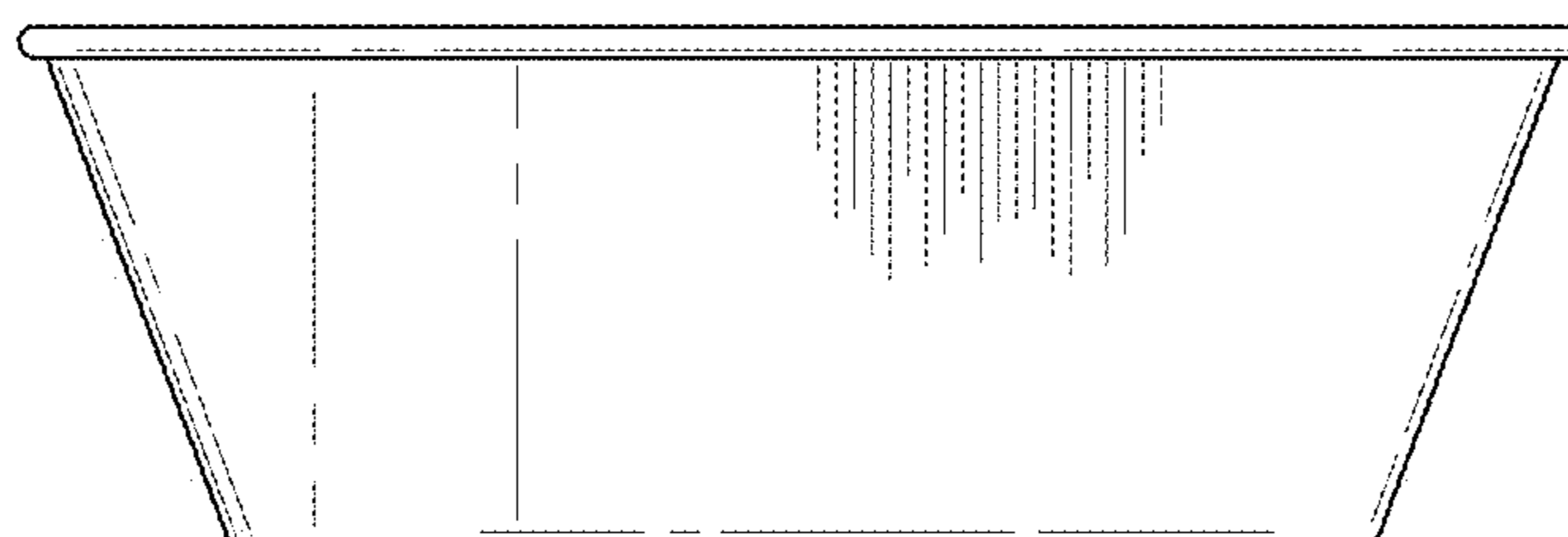

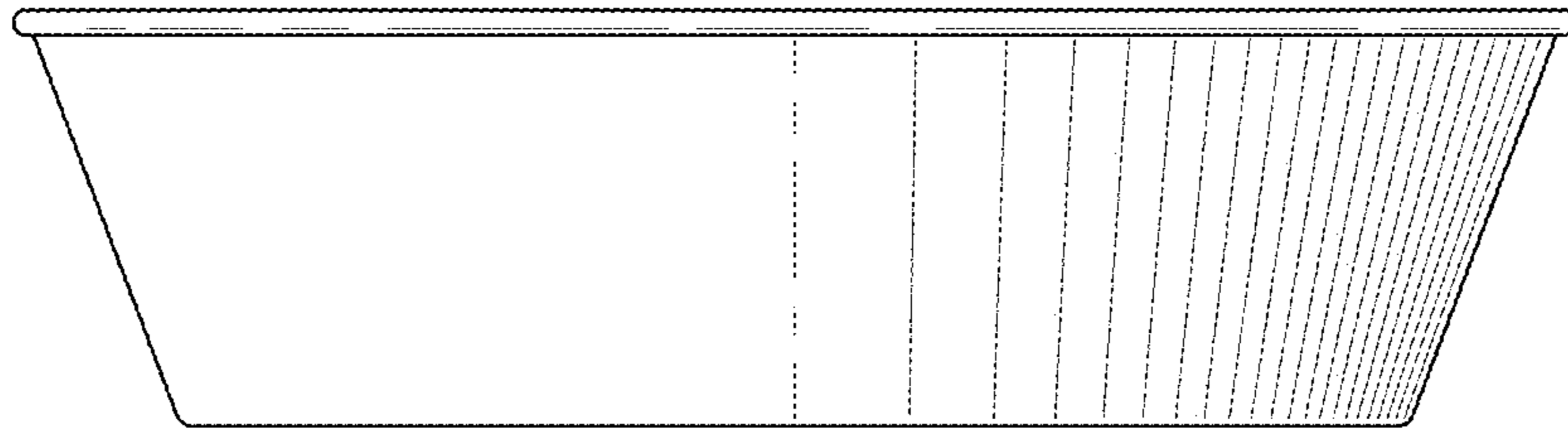

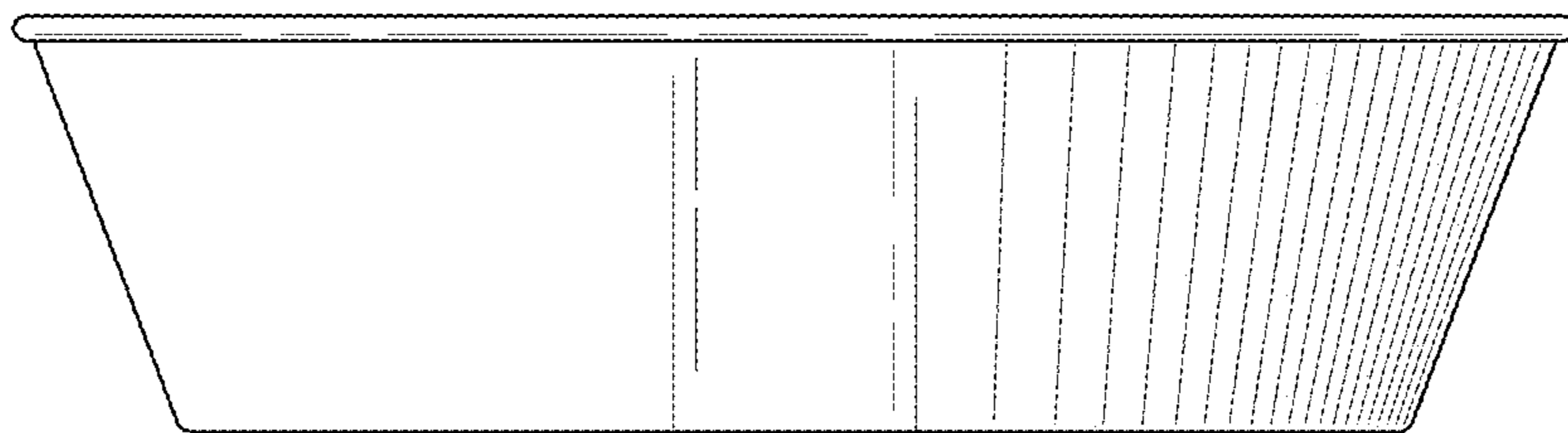

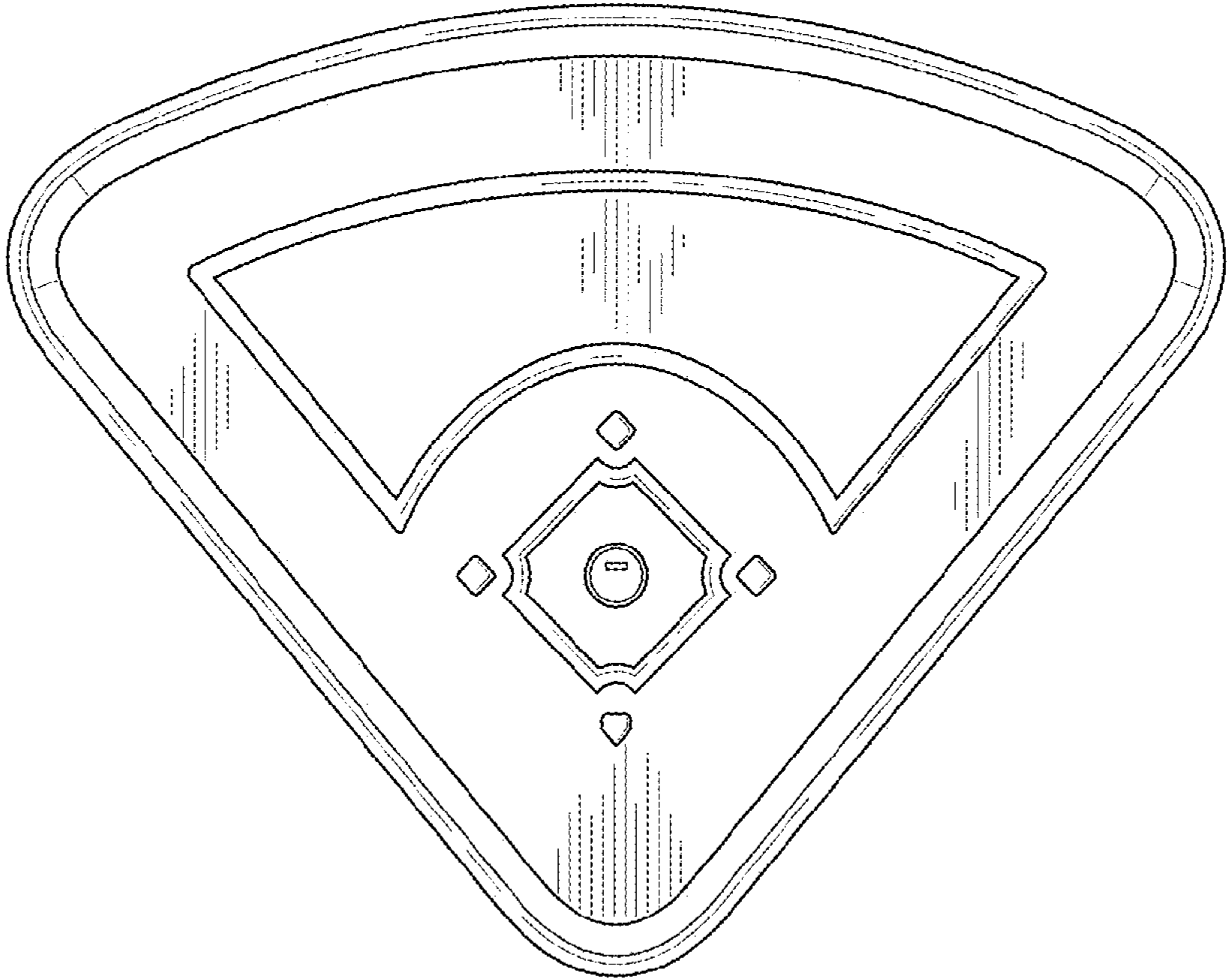

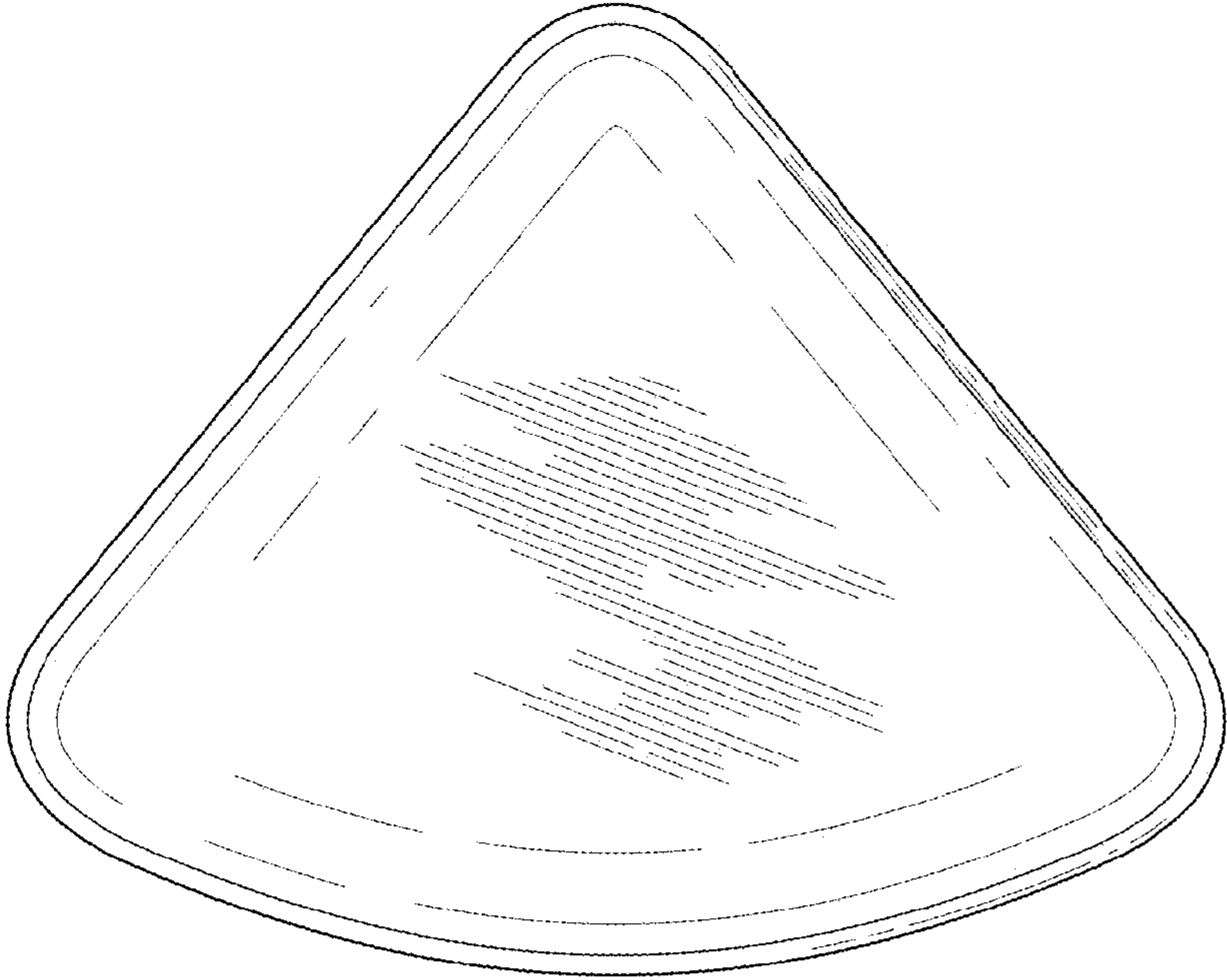
