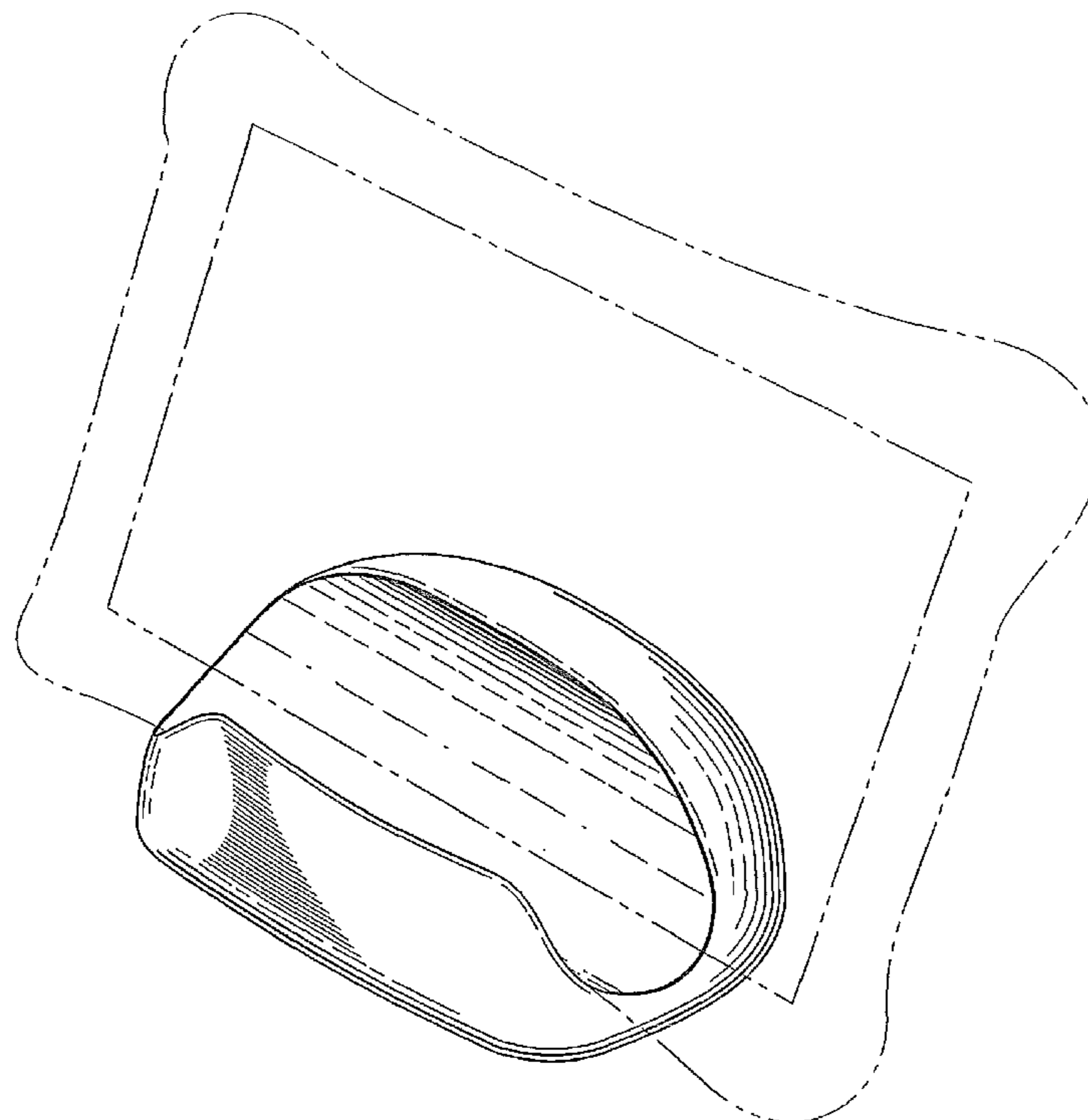
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, ride side, perspective view of the present invention;
FIG. 2 is front elevation view of the present invention;
FIG. 3 is a rear elevation view of the present invention;
FIG. 4 is a left side elevation view, the right side elevation view being a mirror image of the present invention;
FIG. 5 is a top plan view of the present invention; and,

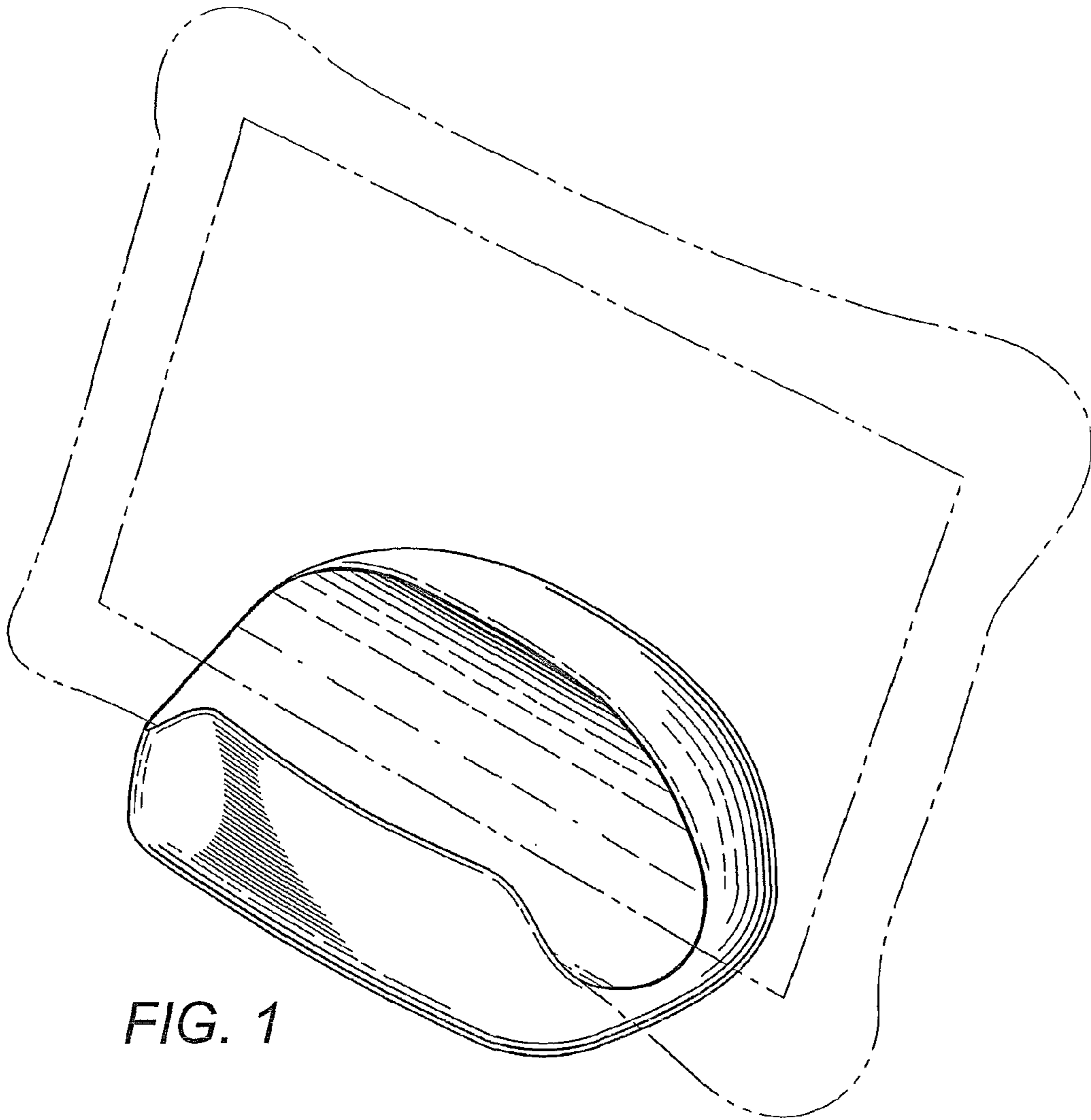

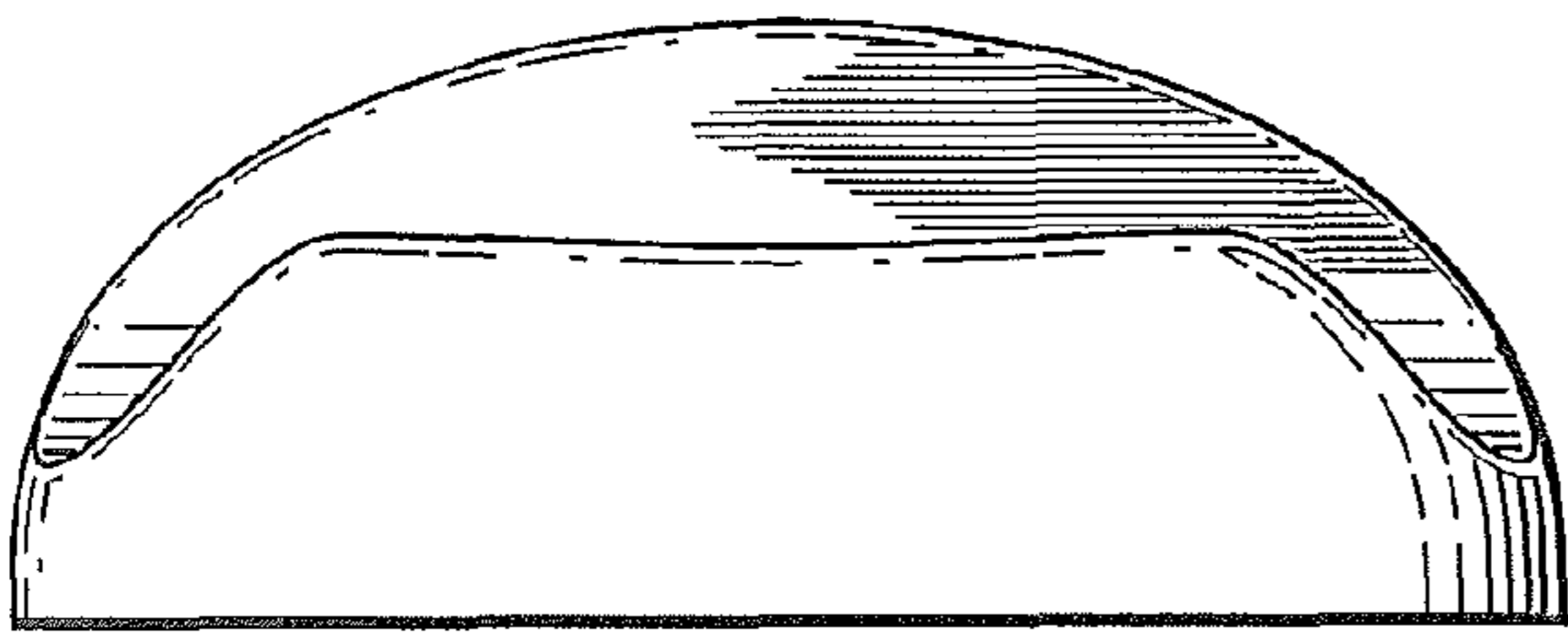
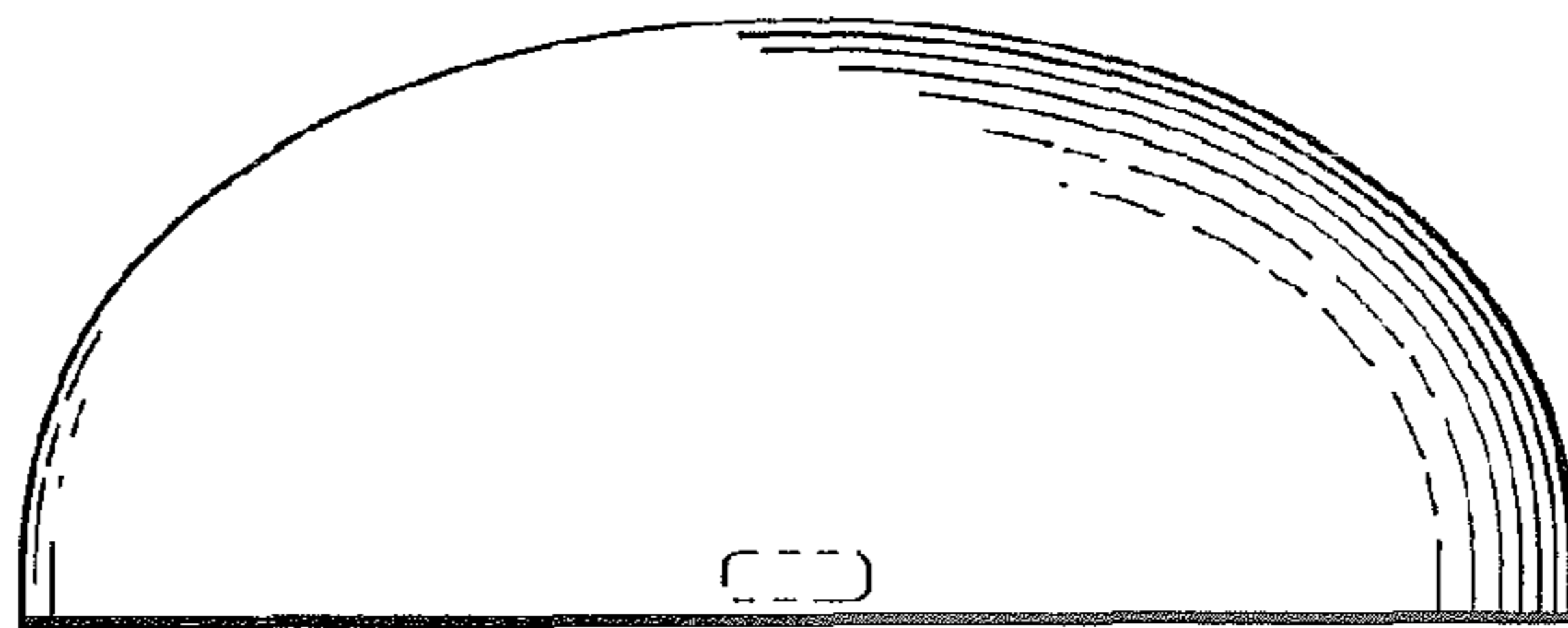

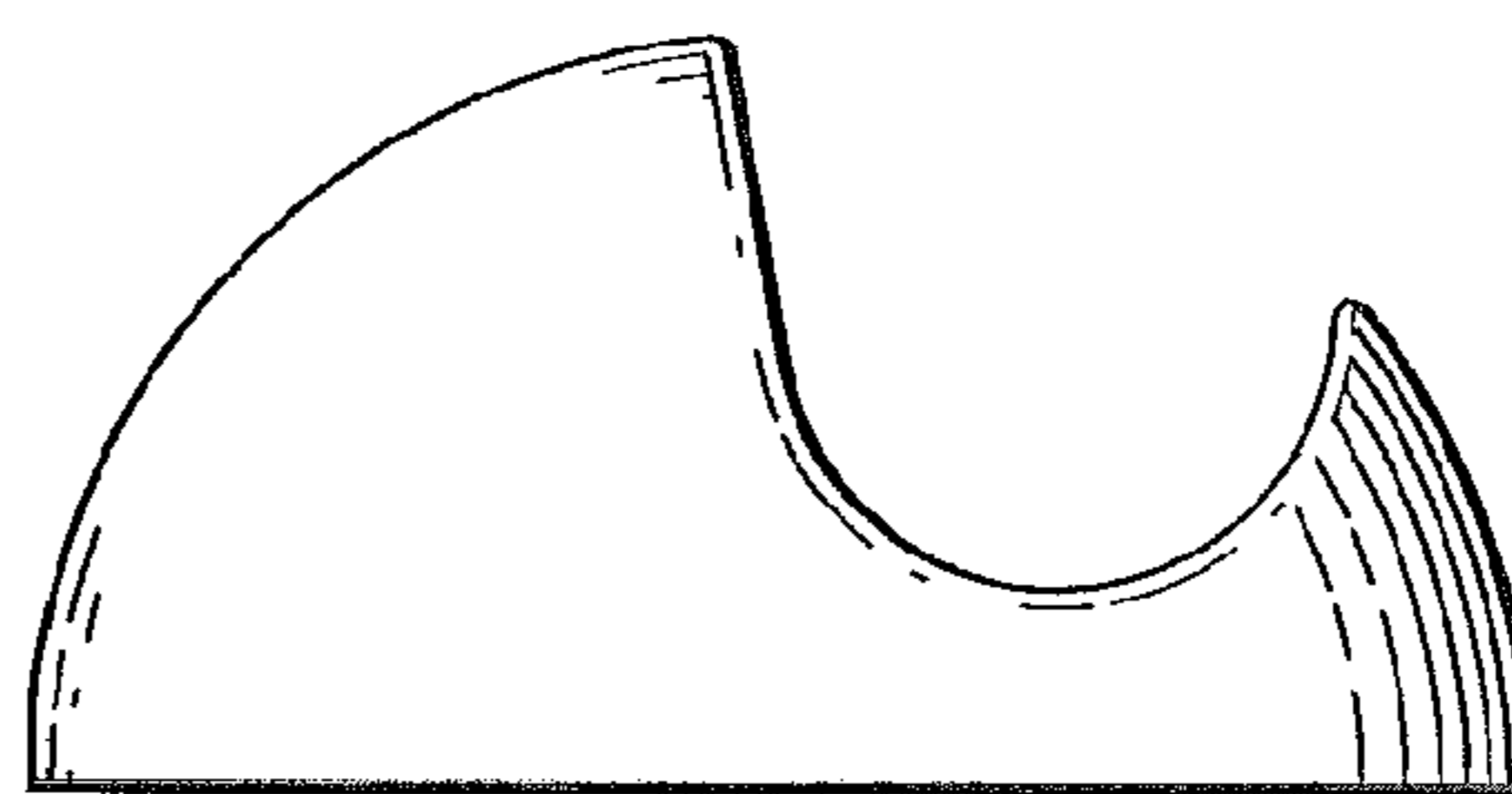

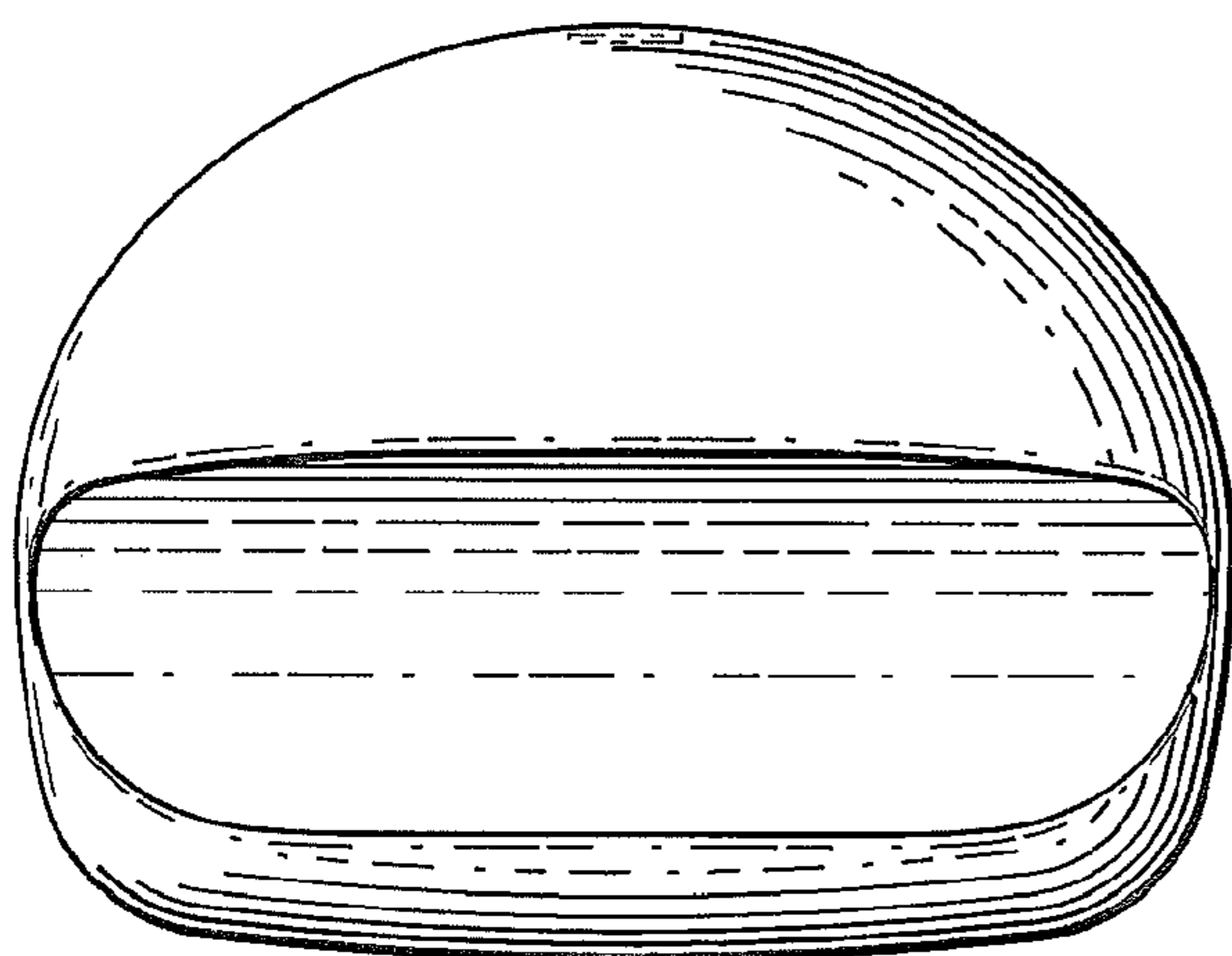
