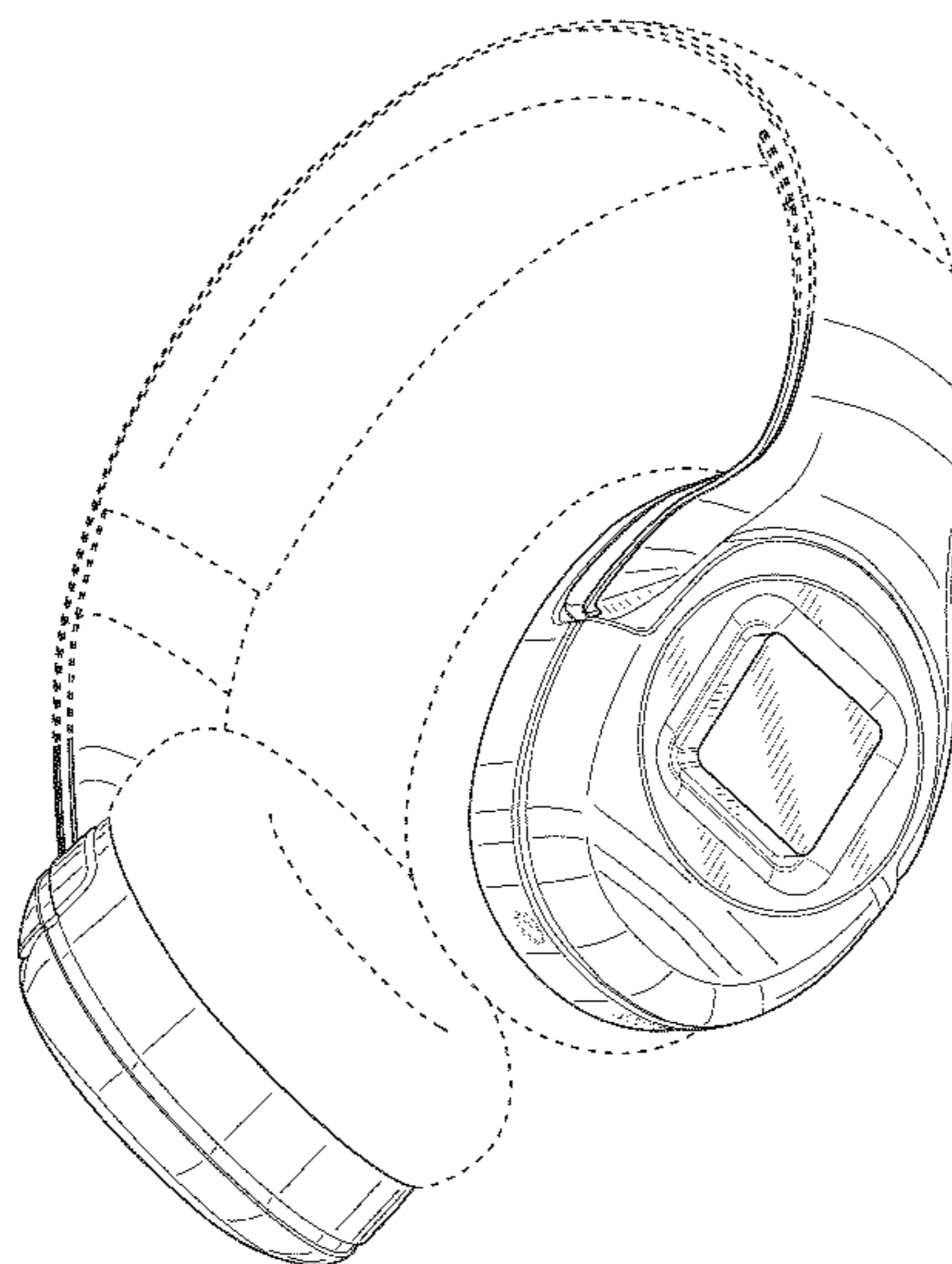

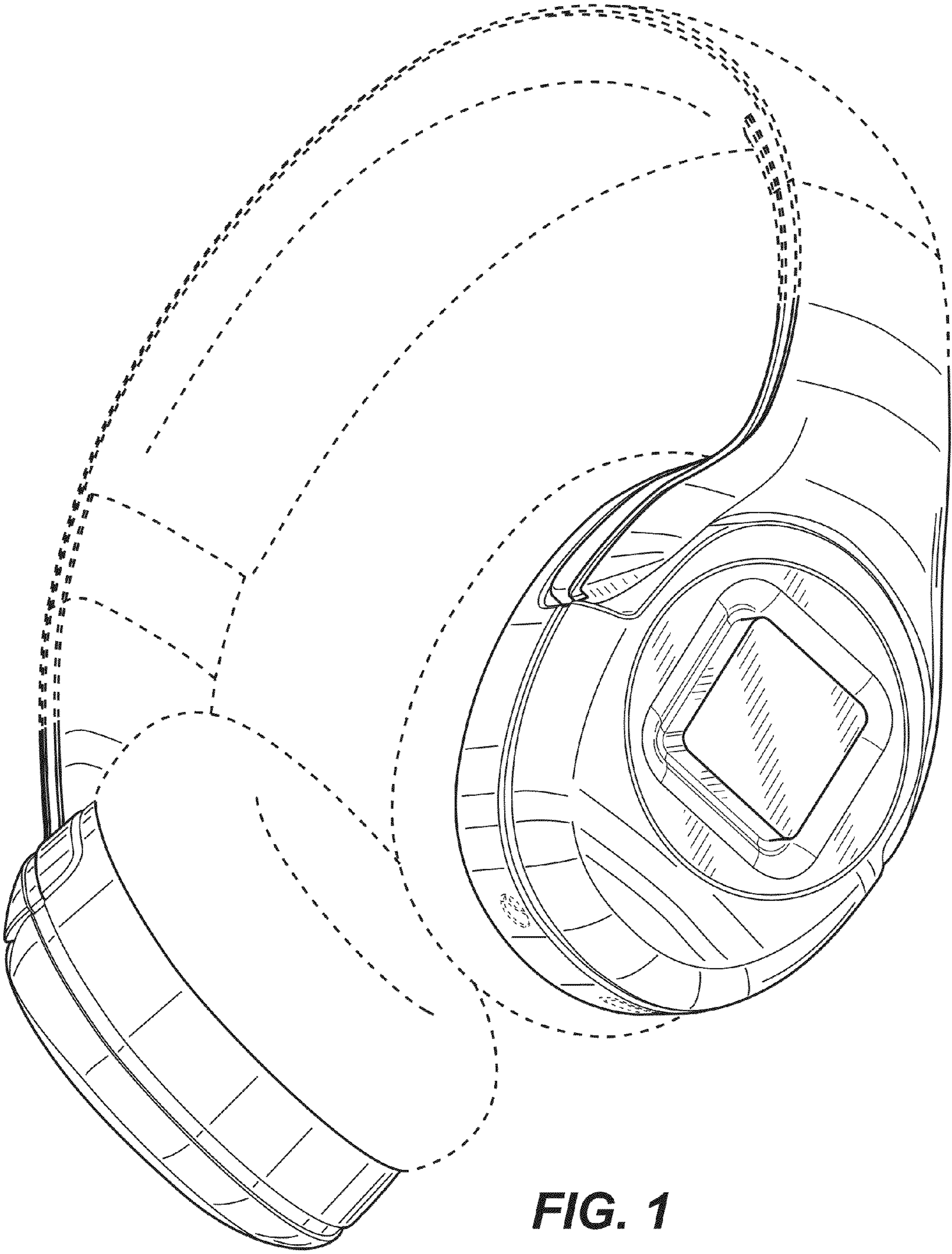
The ornamental design for headphones, as shown and described.

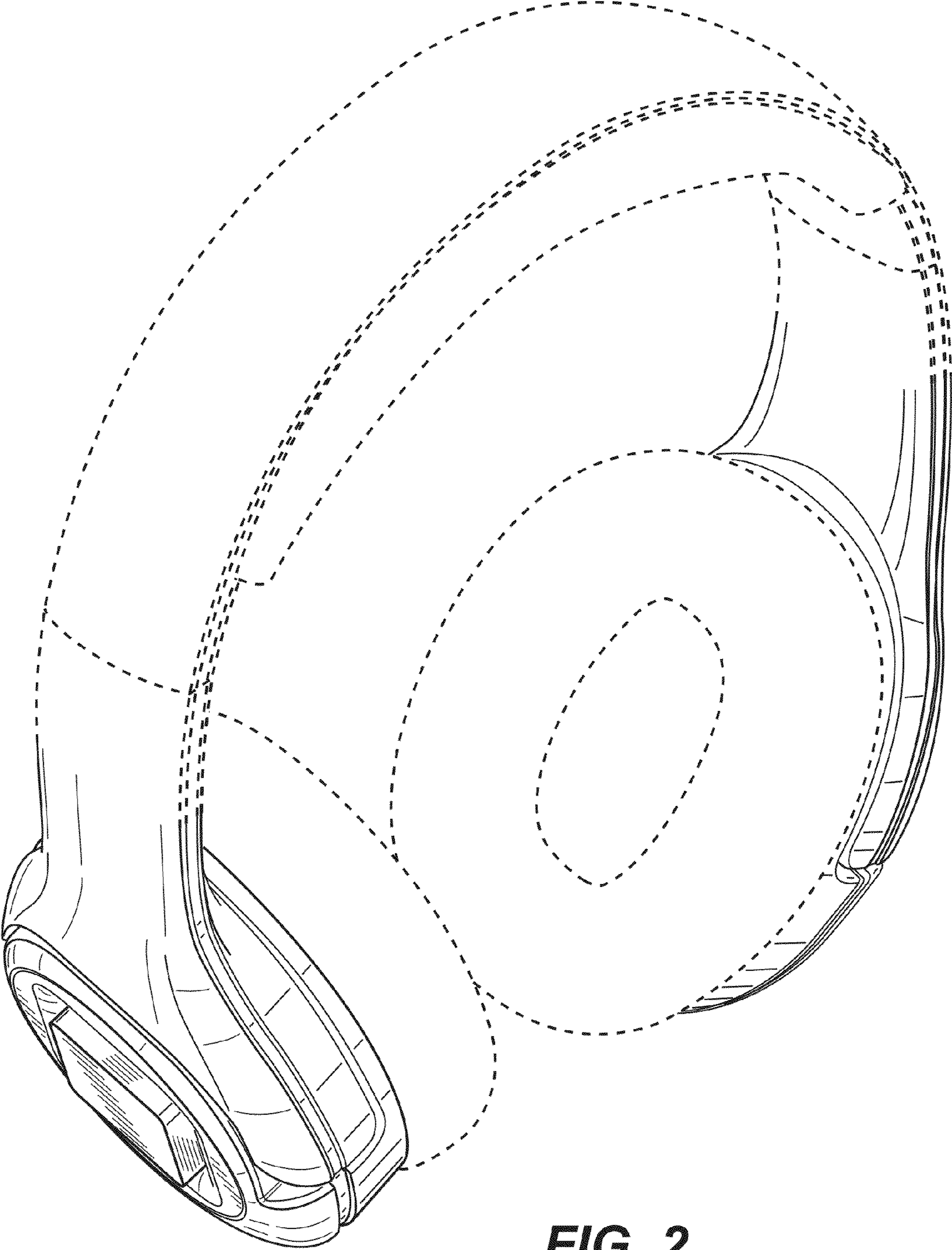
**DESCRIPTION**

FIG. 1 is a perspective view of headphones showing a new design;  
FIG. 2 is a second perspective view of the headphones shown in FIG. 1;  
FIG. 3 is a front view of the headphones shown in FIG. 1;  
FIG. 4 is a back view of the headphones shown in FIG. 1;  
FIG. 5 is a side view of the headphones shown in FIG. 1, the opposite side view being mirror symmetrical;  
FIG. 6 is a bottom view of the headphones shown in FIG. 1; and,  
FIG. 7 is a top view of the headphones shown in FIG. 1.

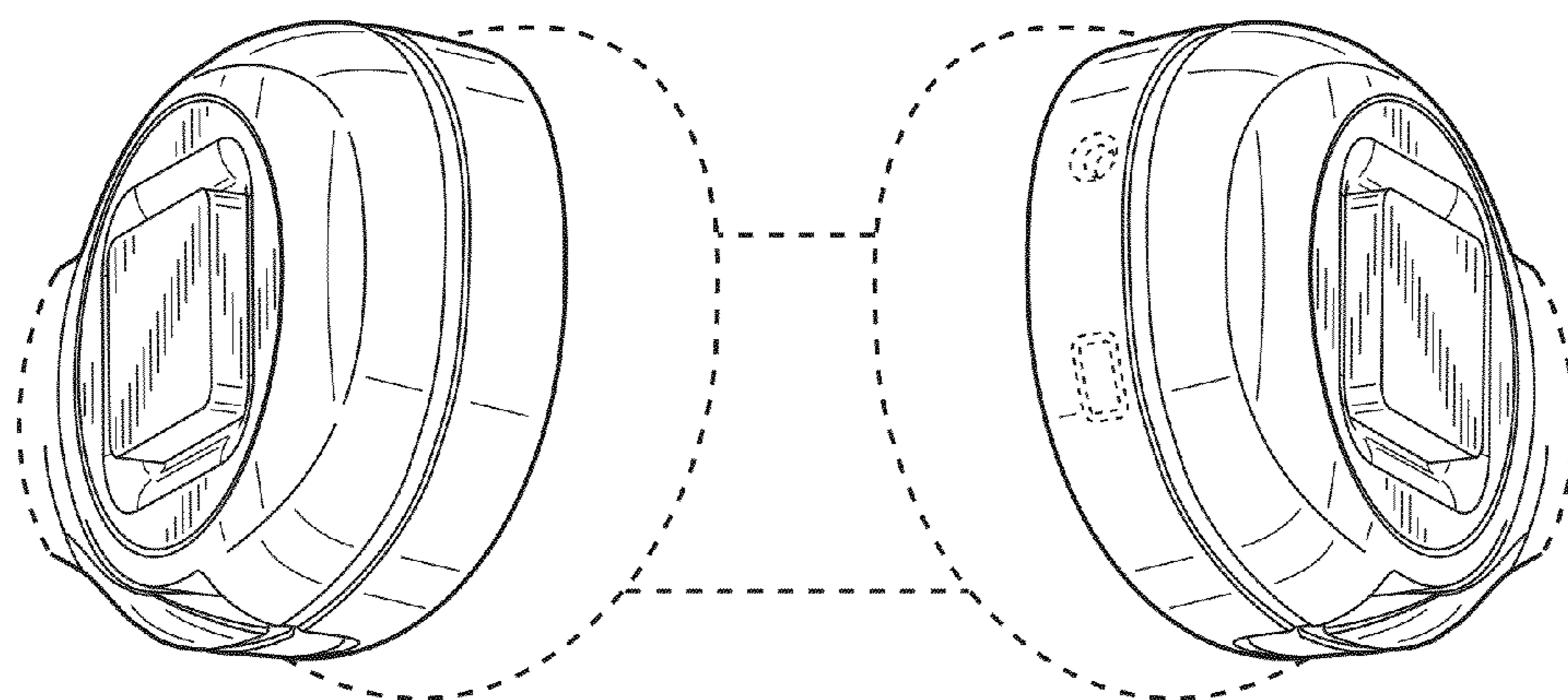
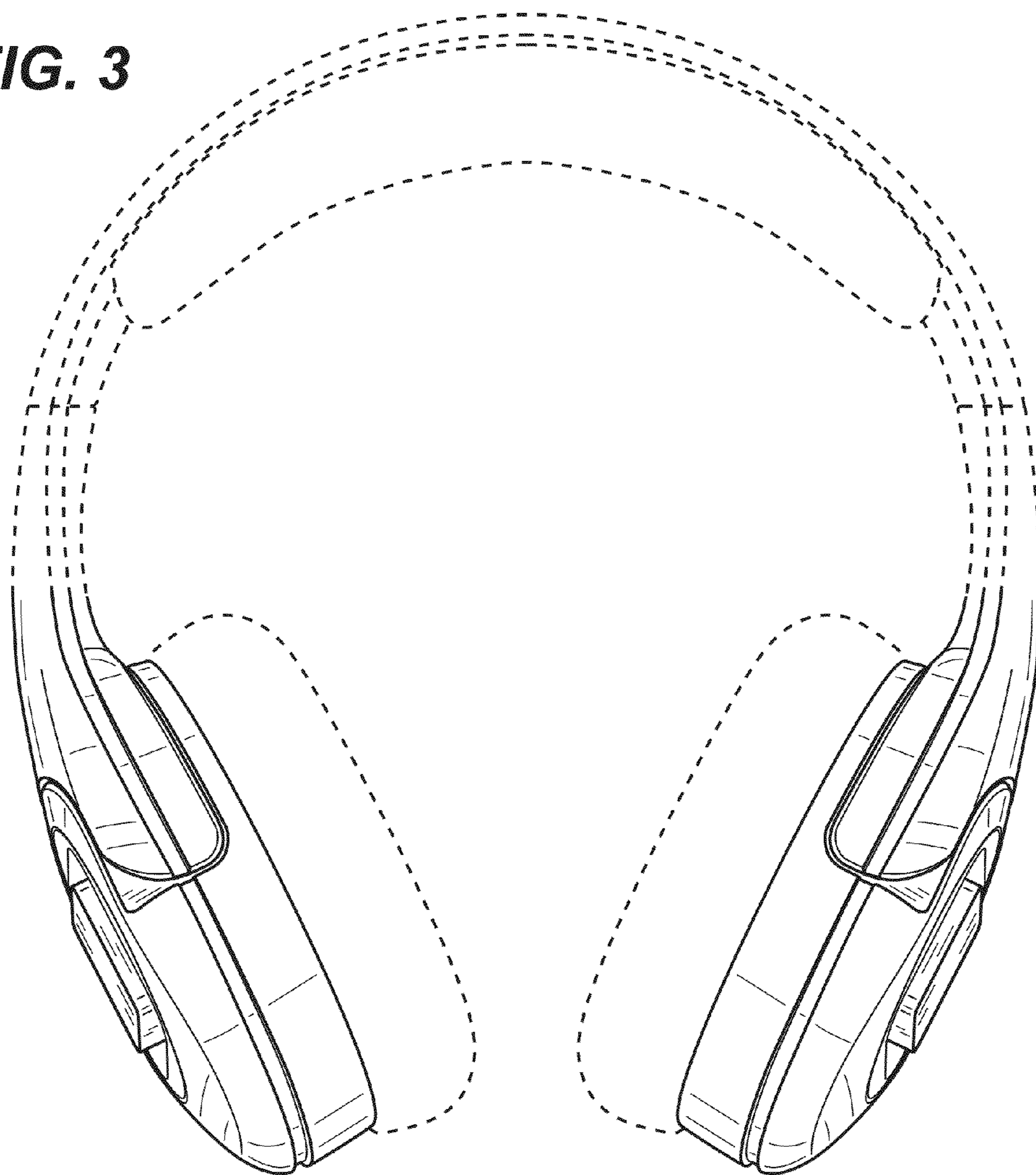






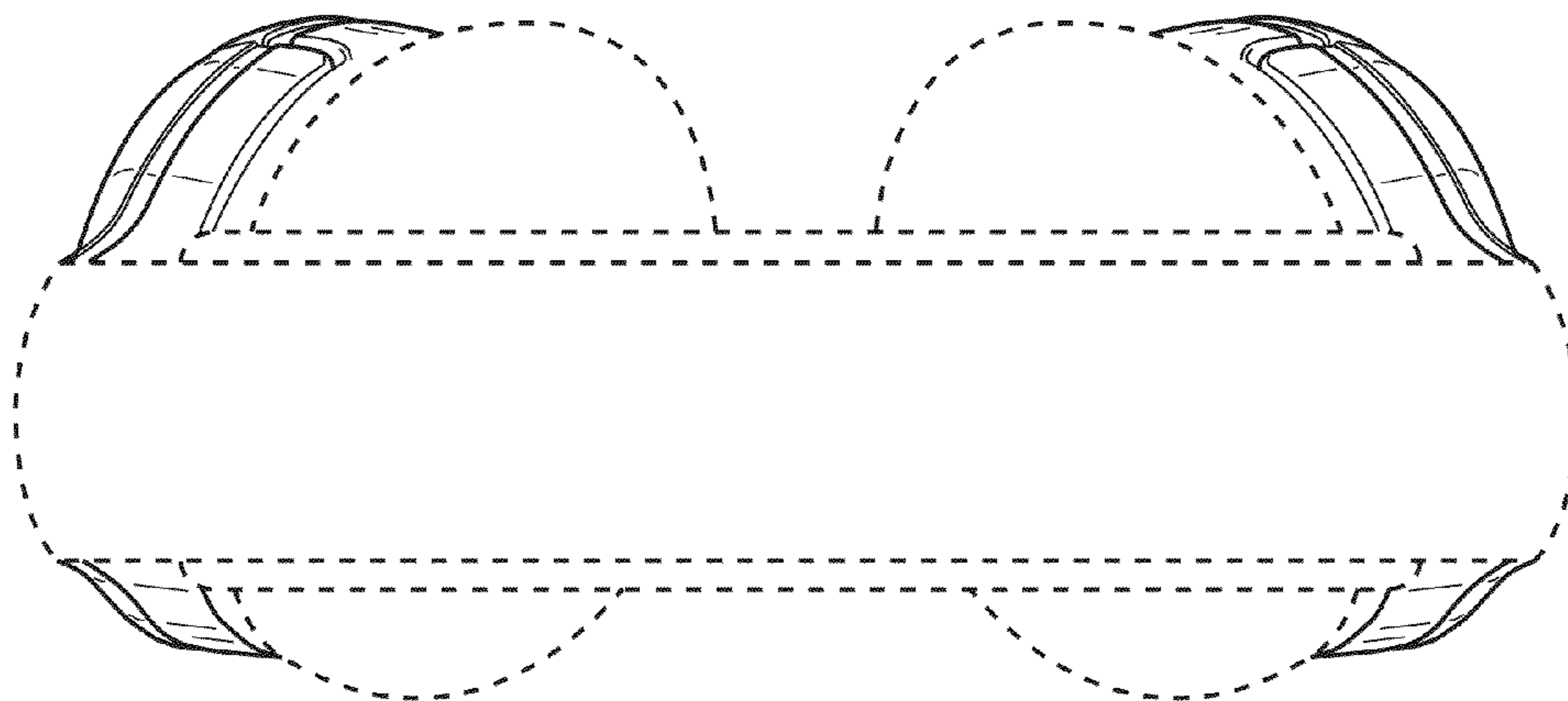
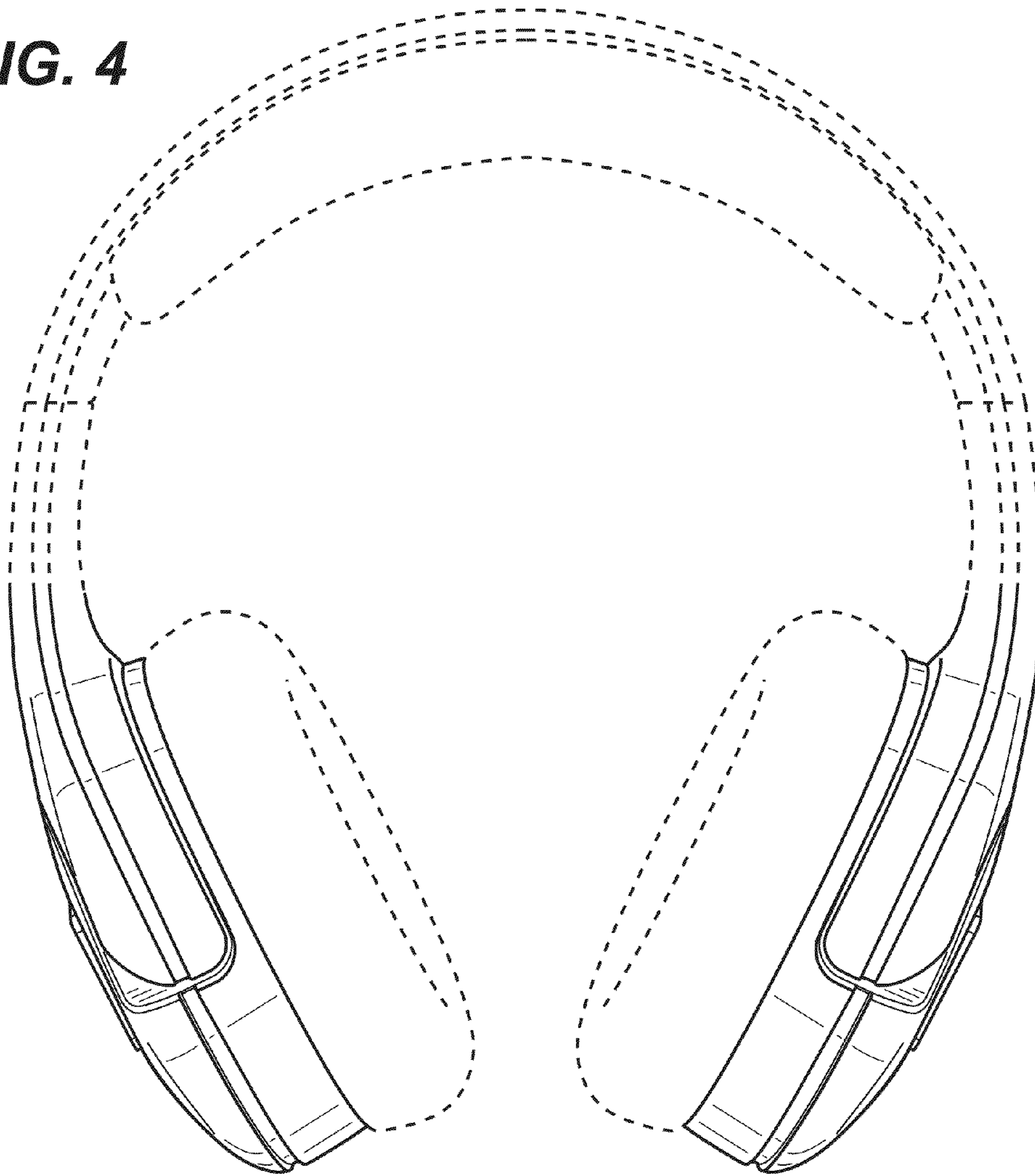

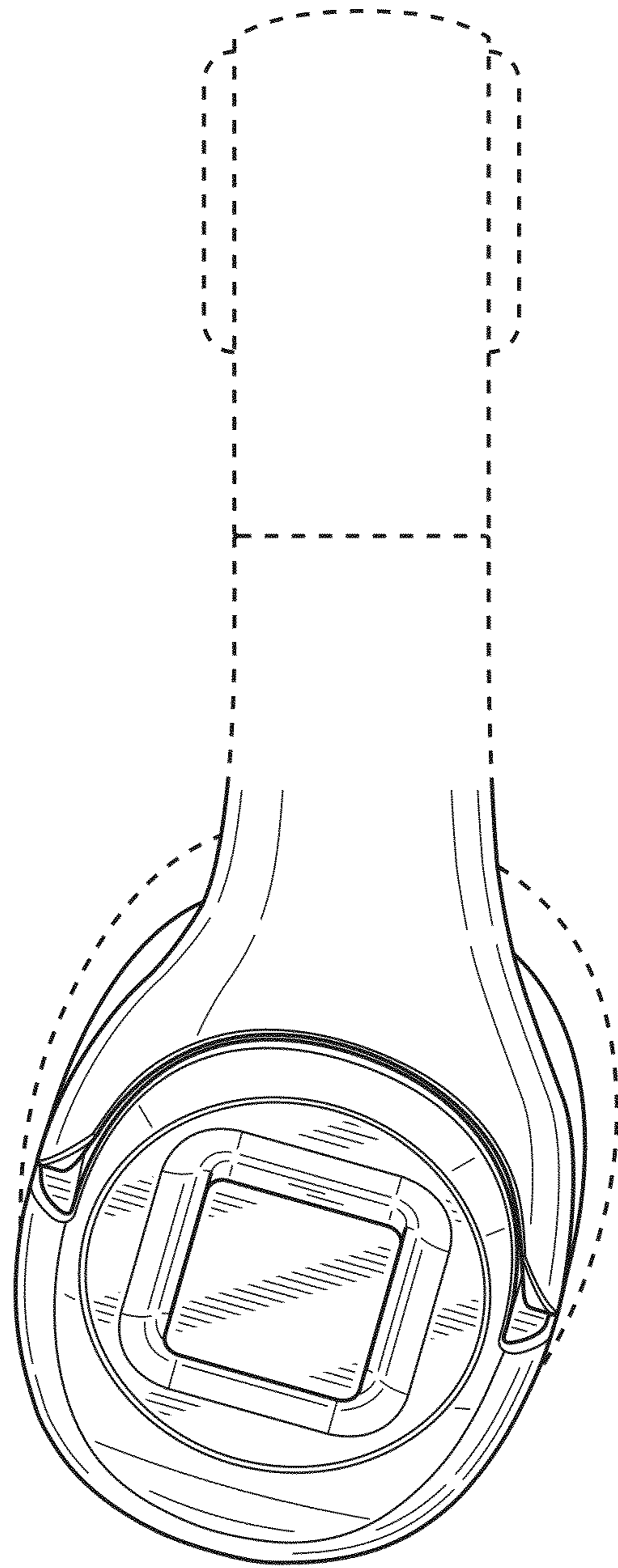
