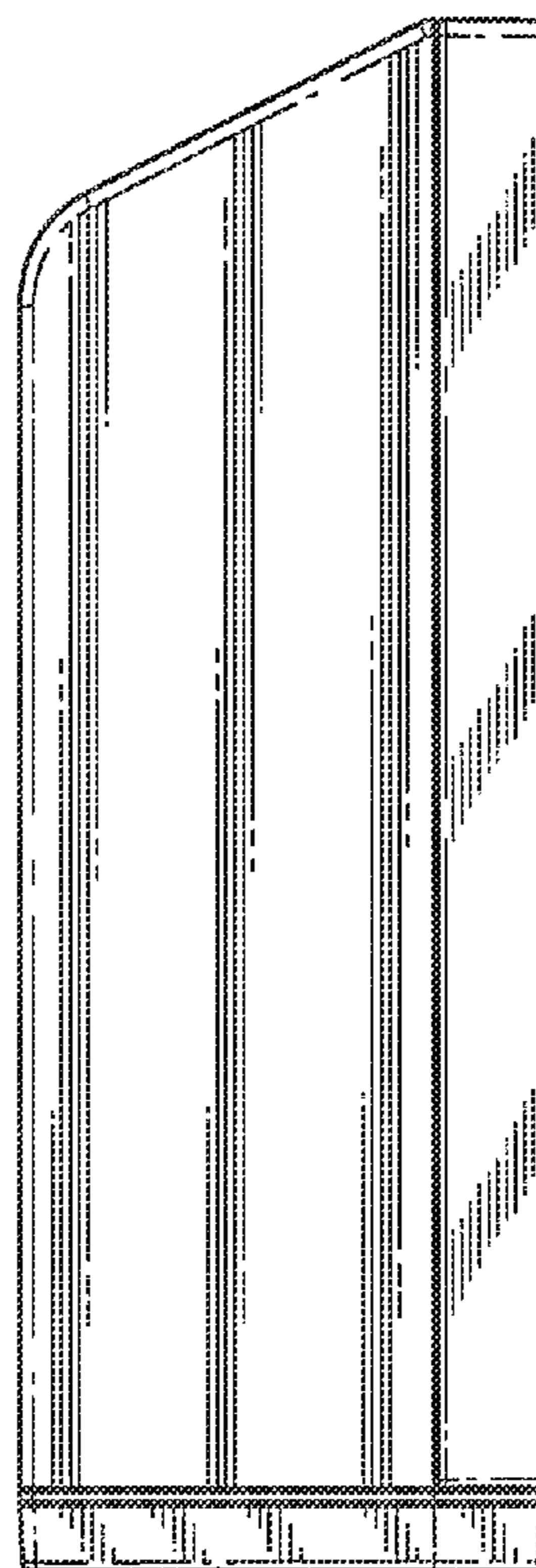
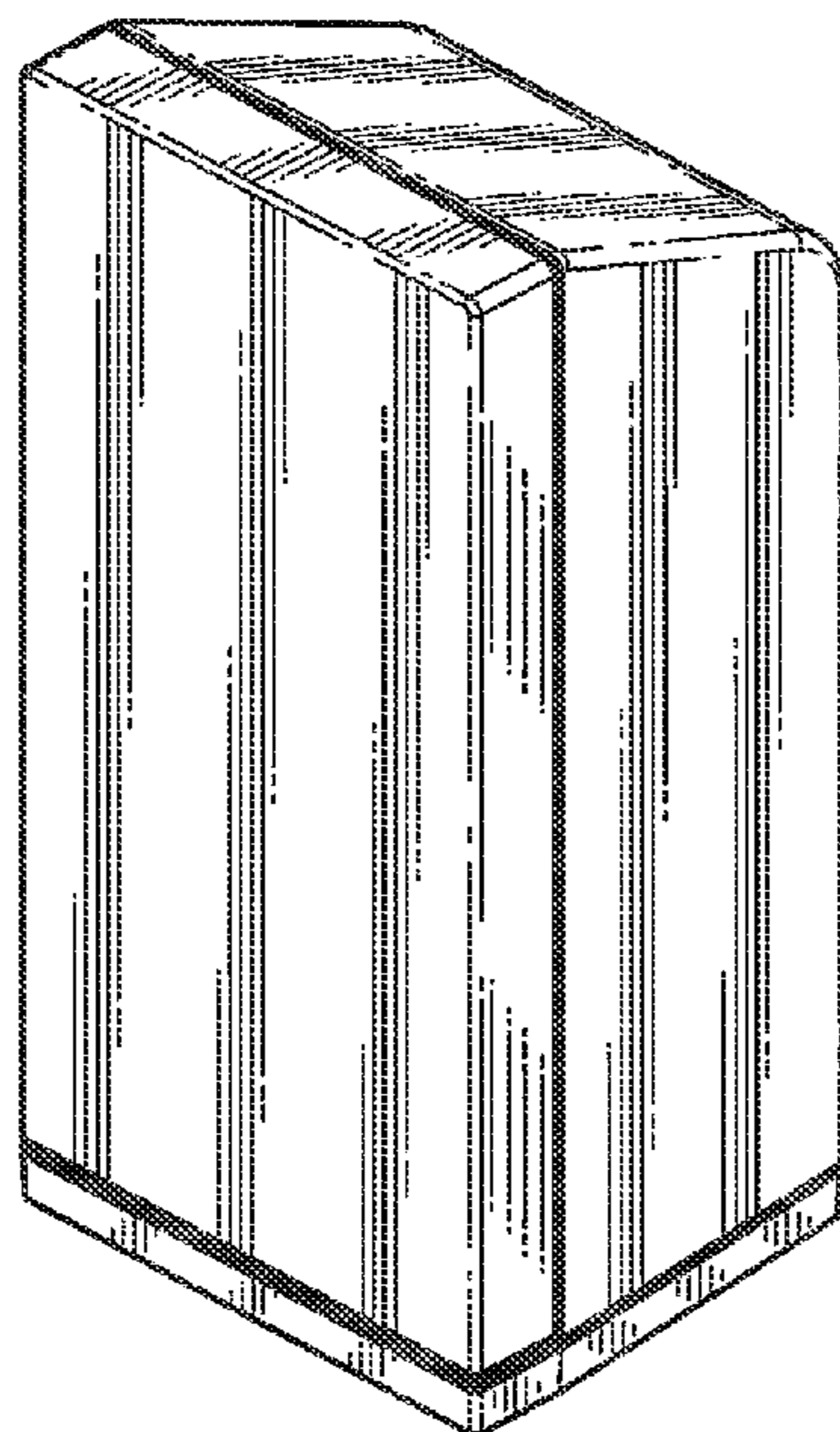
(57) **CLAIM**

I claim the ornamental design for a speaker, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the speaker;  
FIG. 2 is a front-on view of the speaker;

FIG. 4 shows a first side-on view of the speaker;

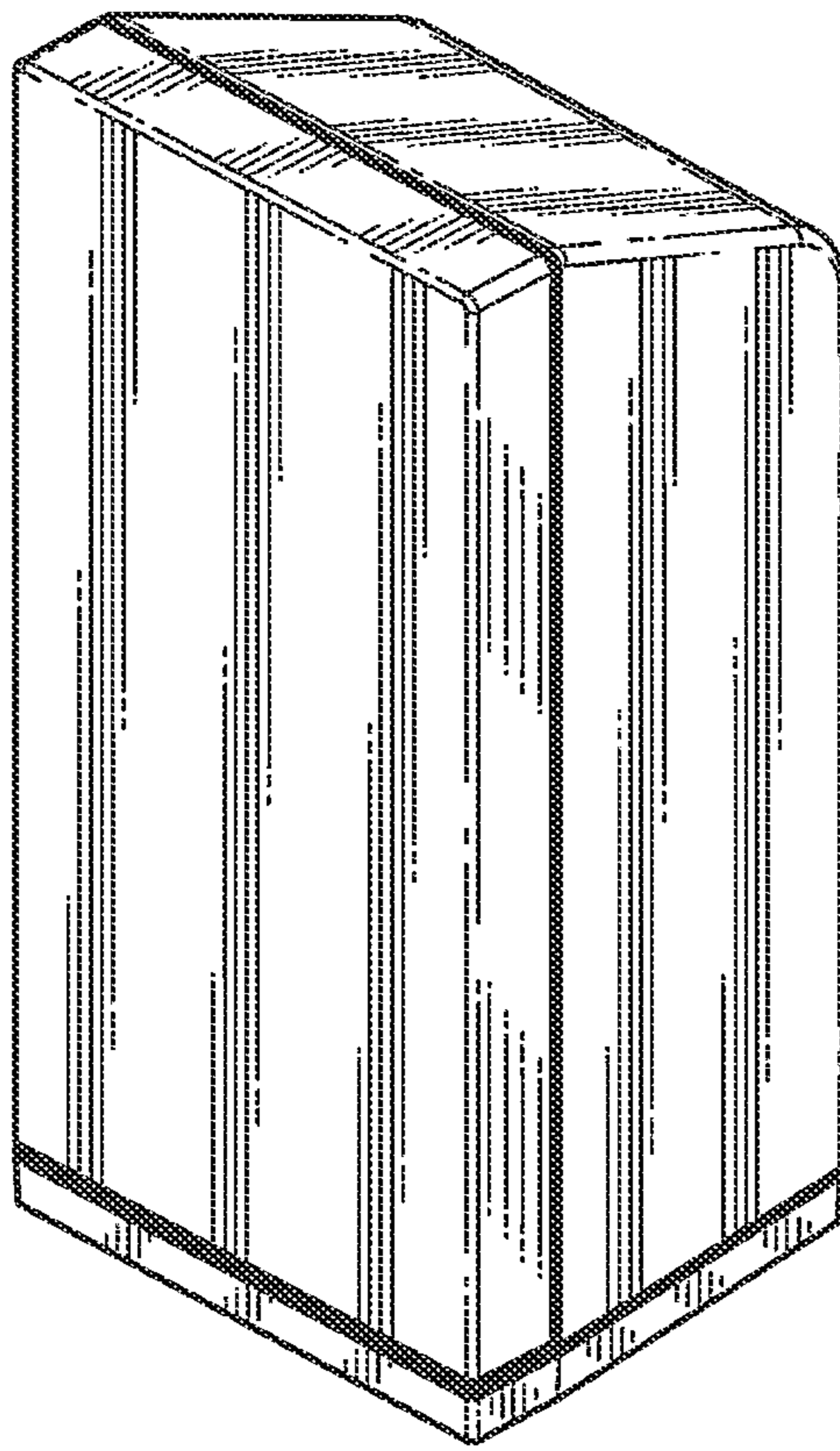

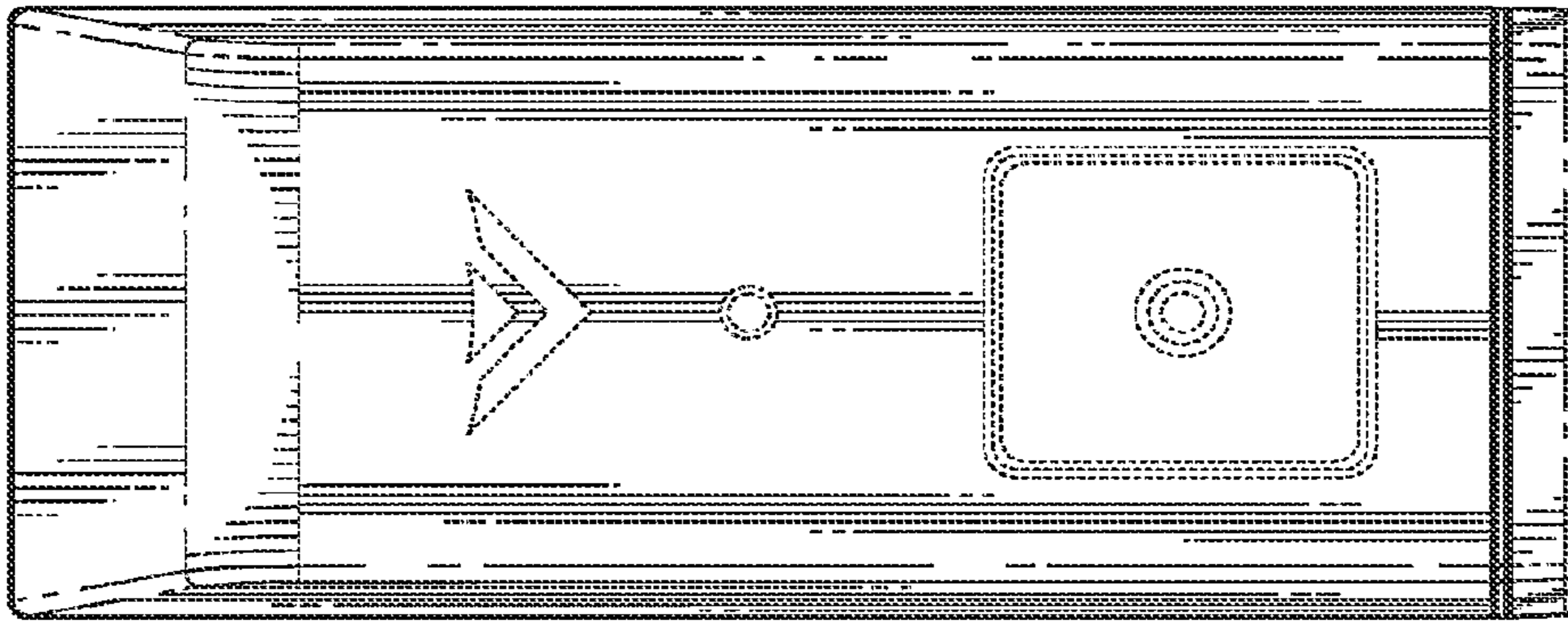

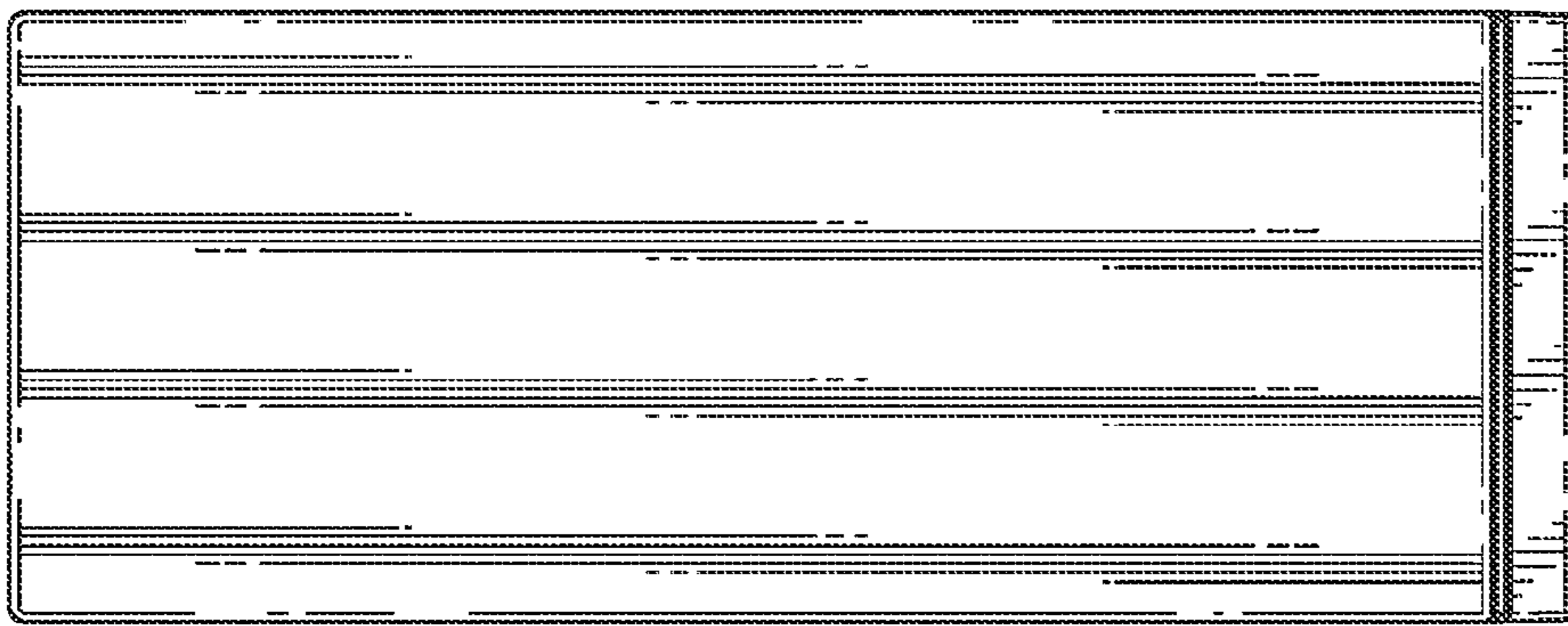

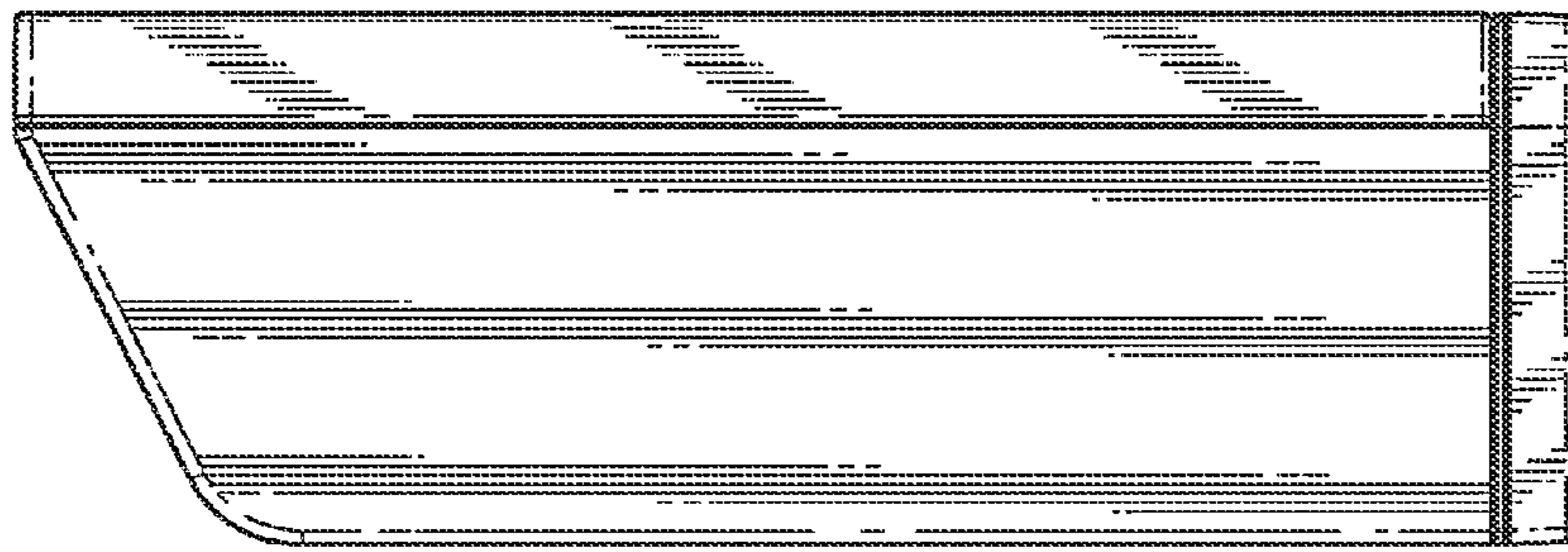

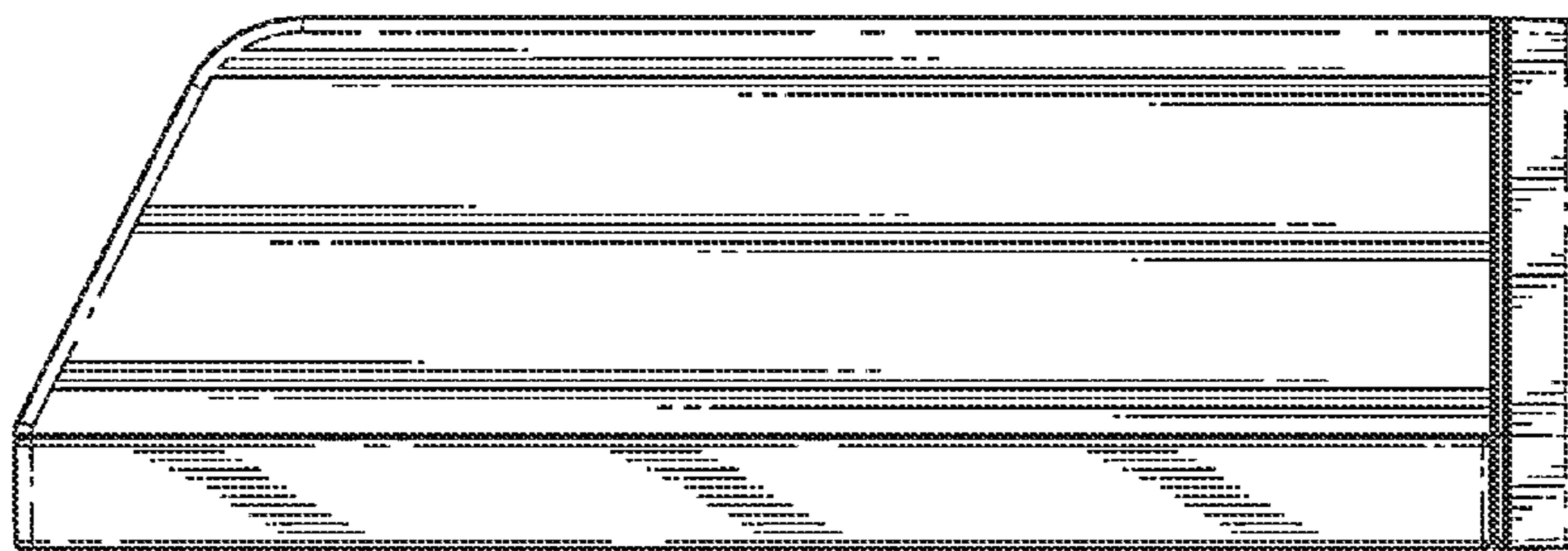

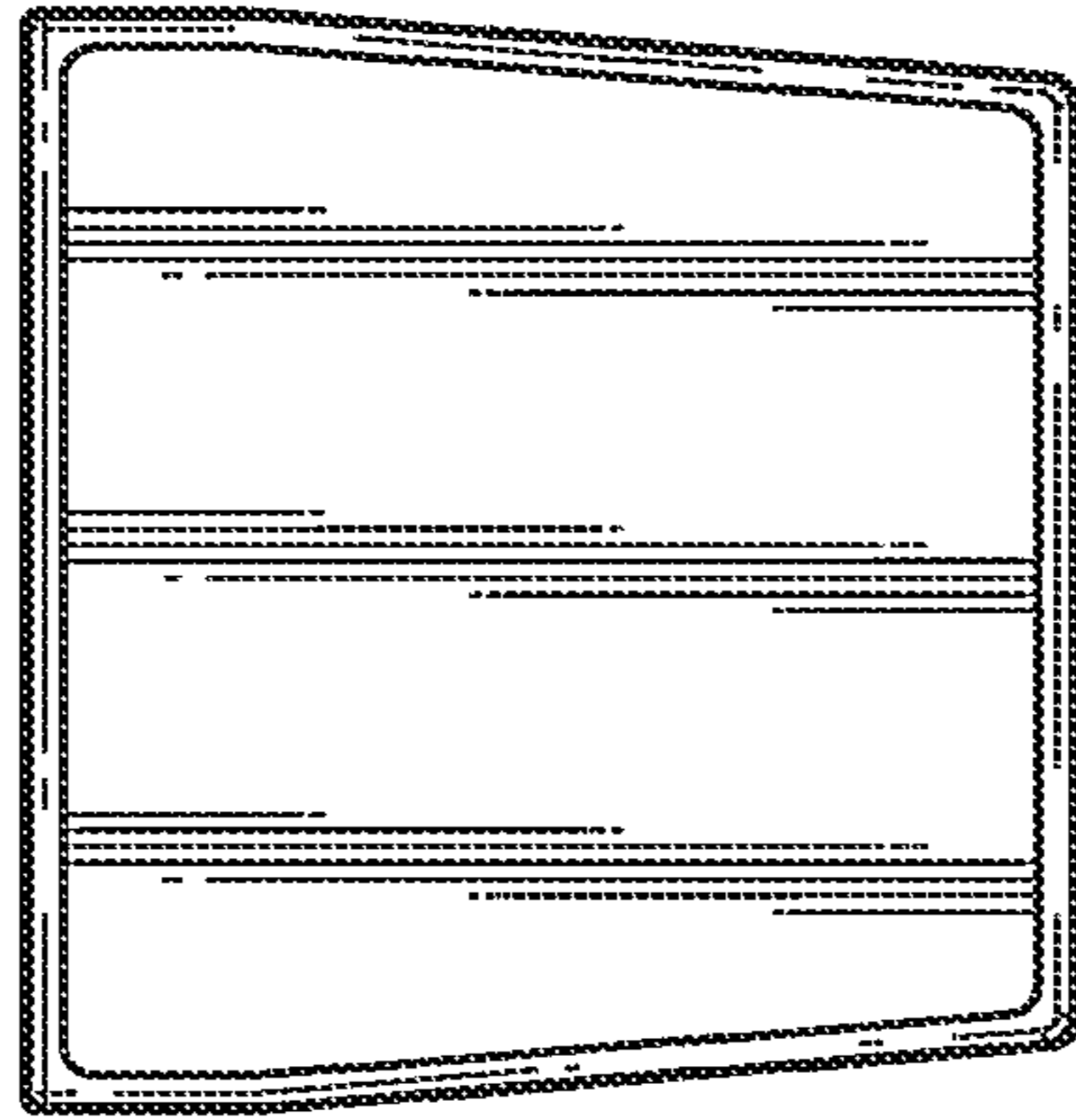

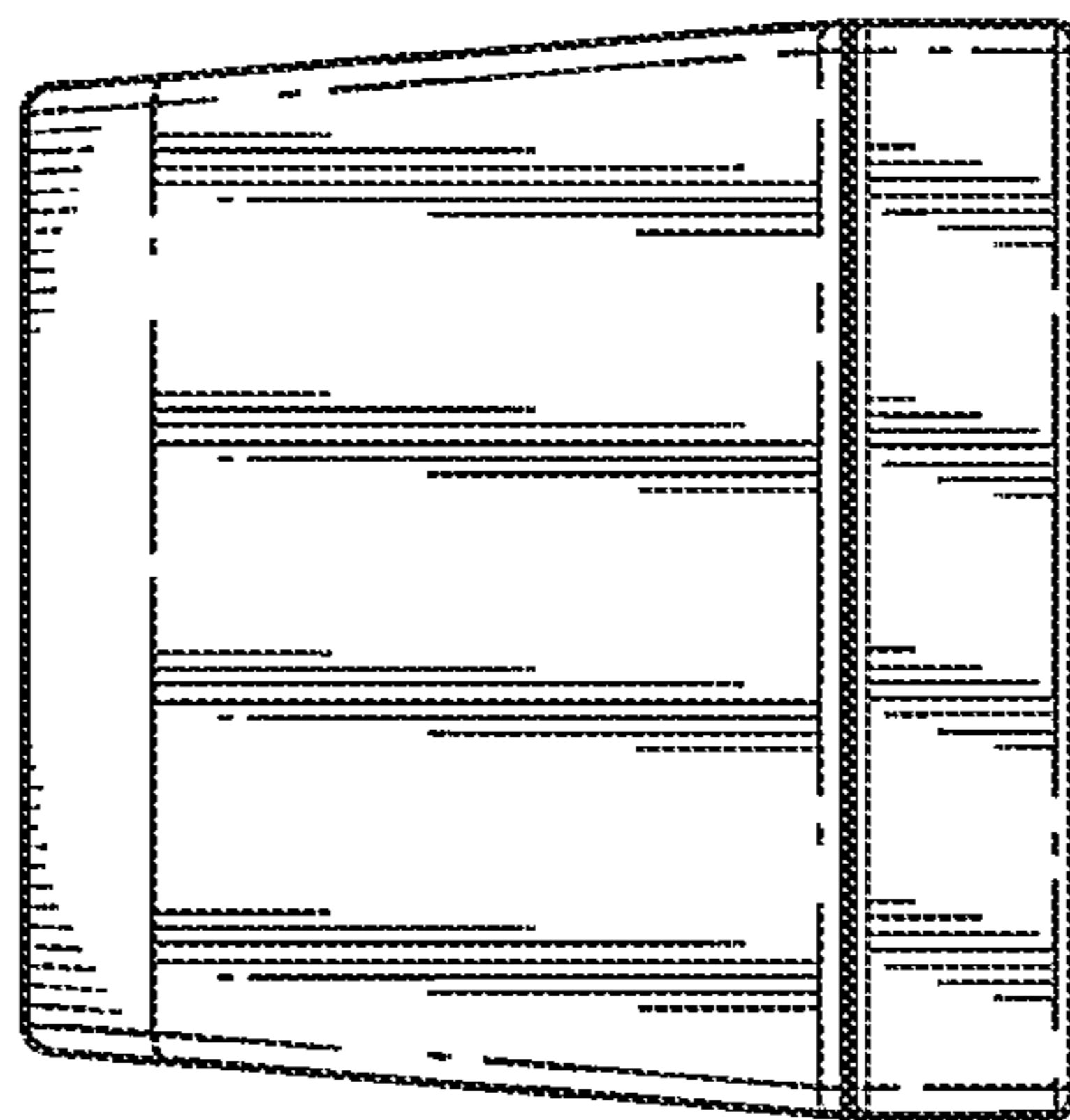
